The ornamental design for a convection heater, as shown and described.

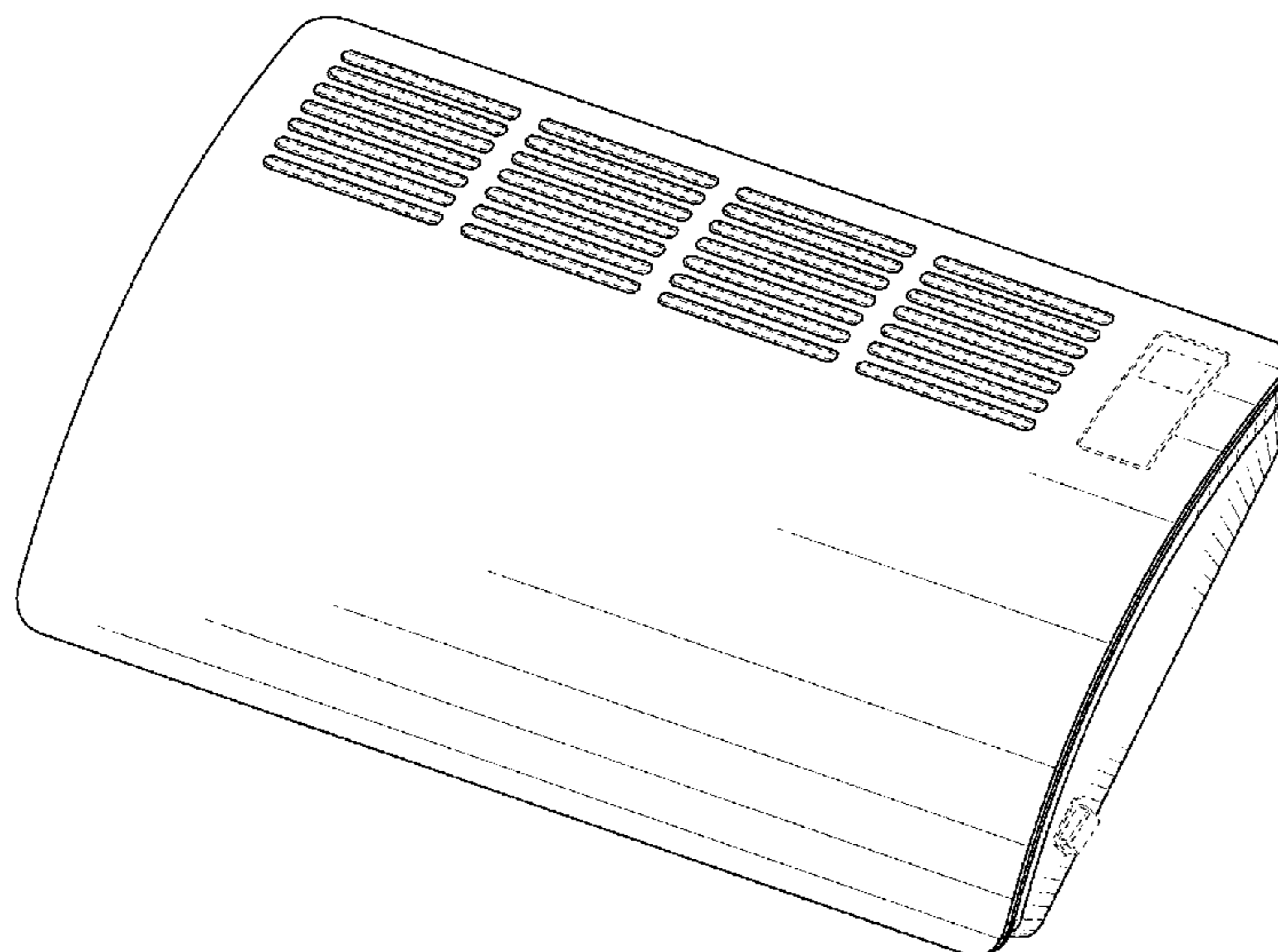
DESCRIPTION

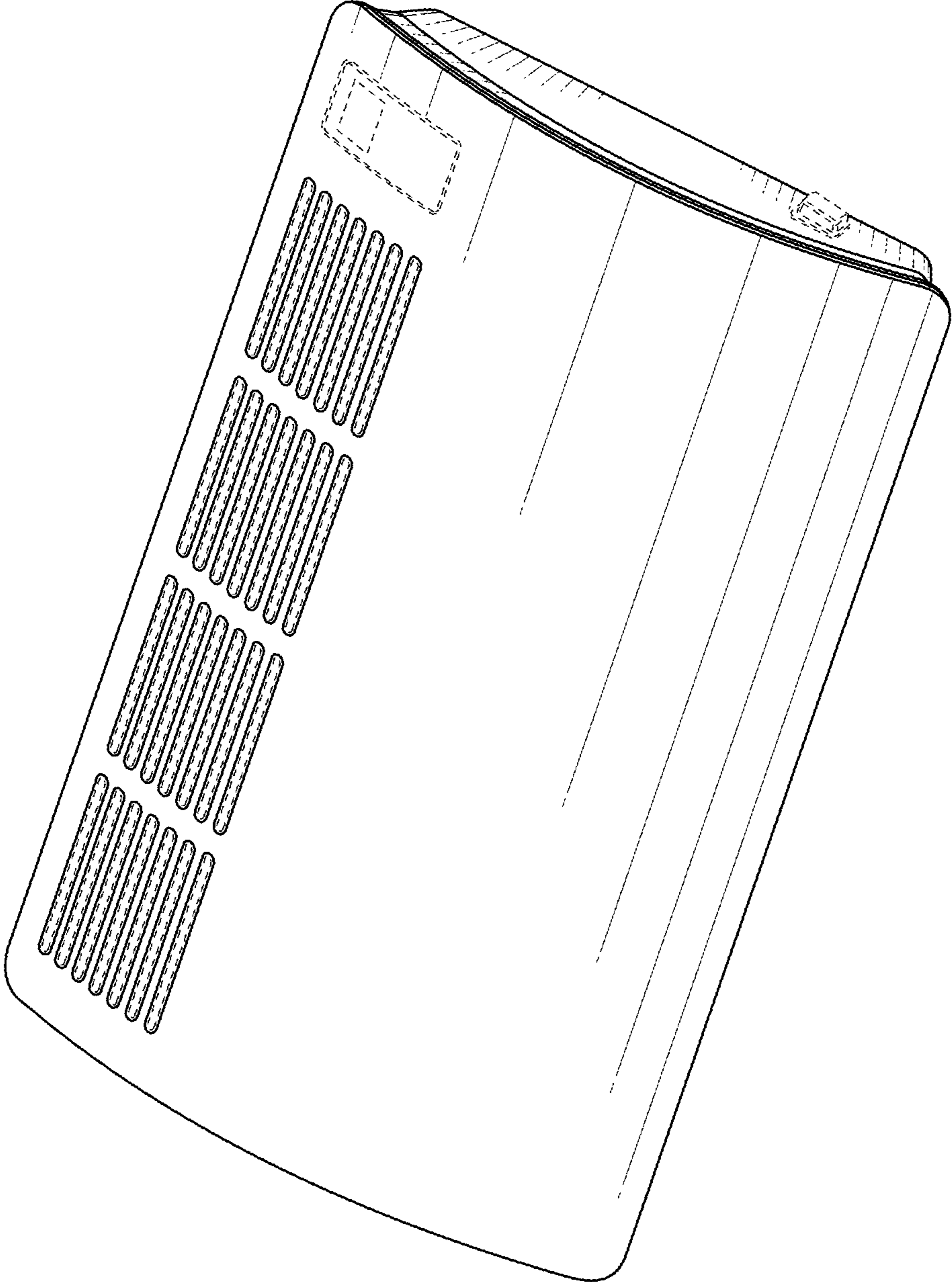

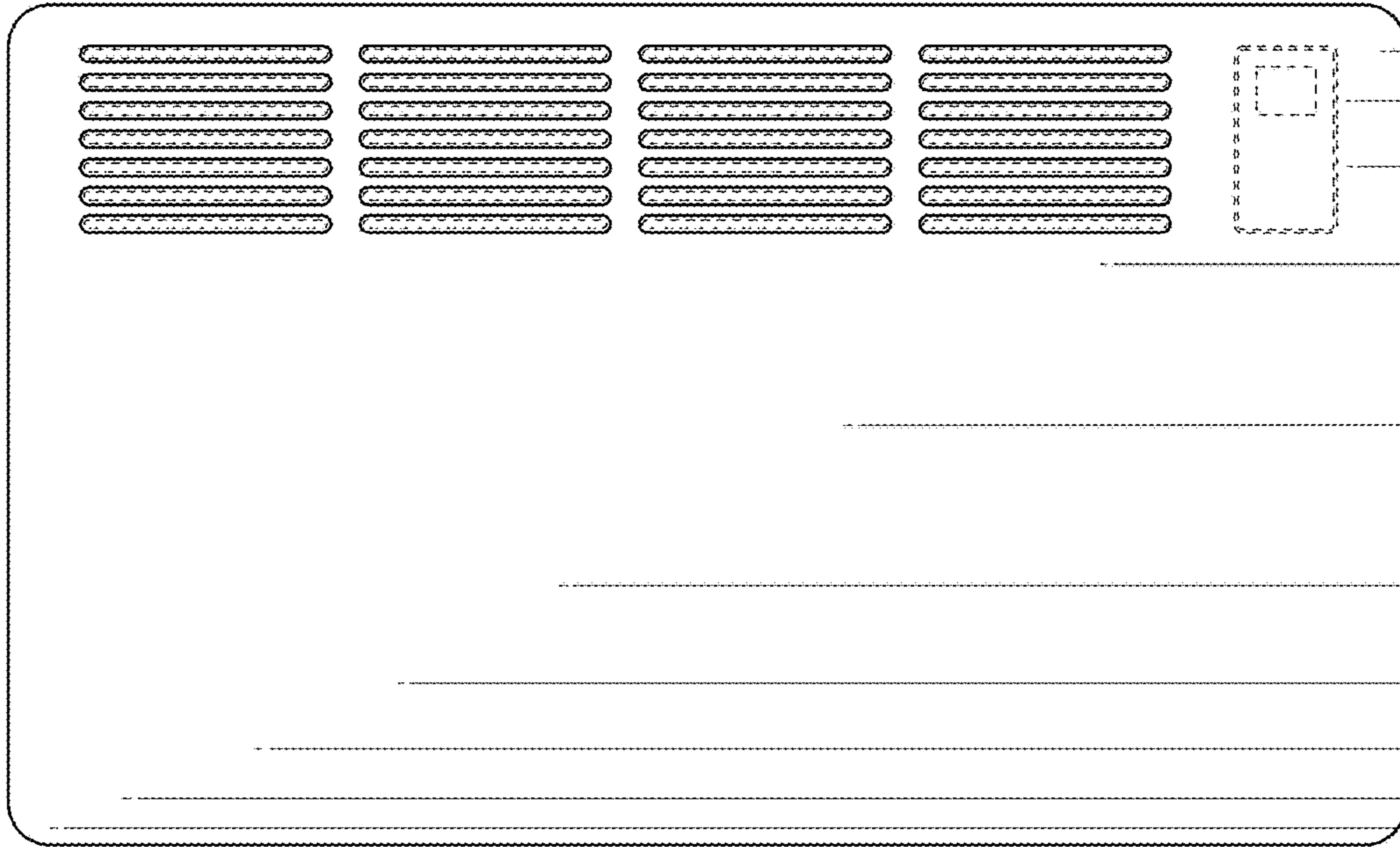

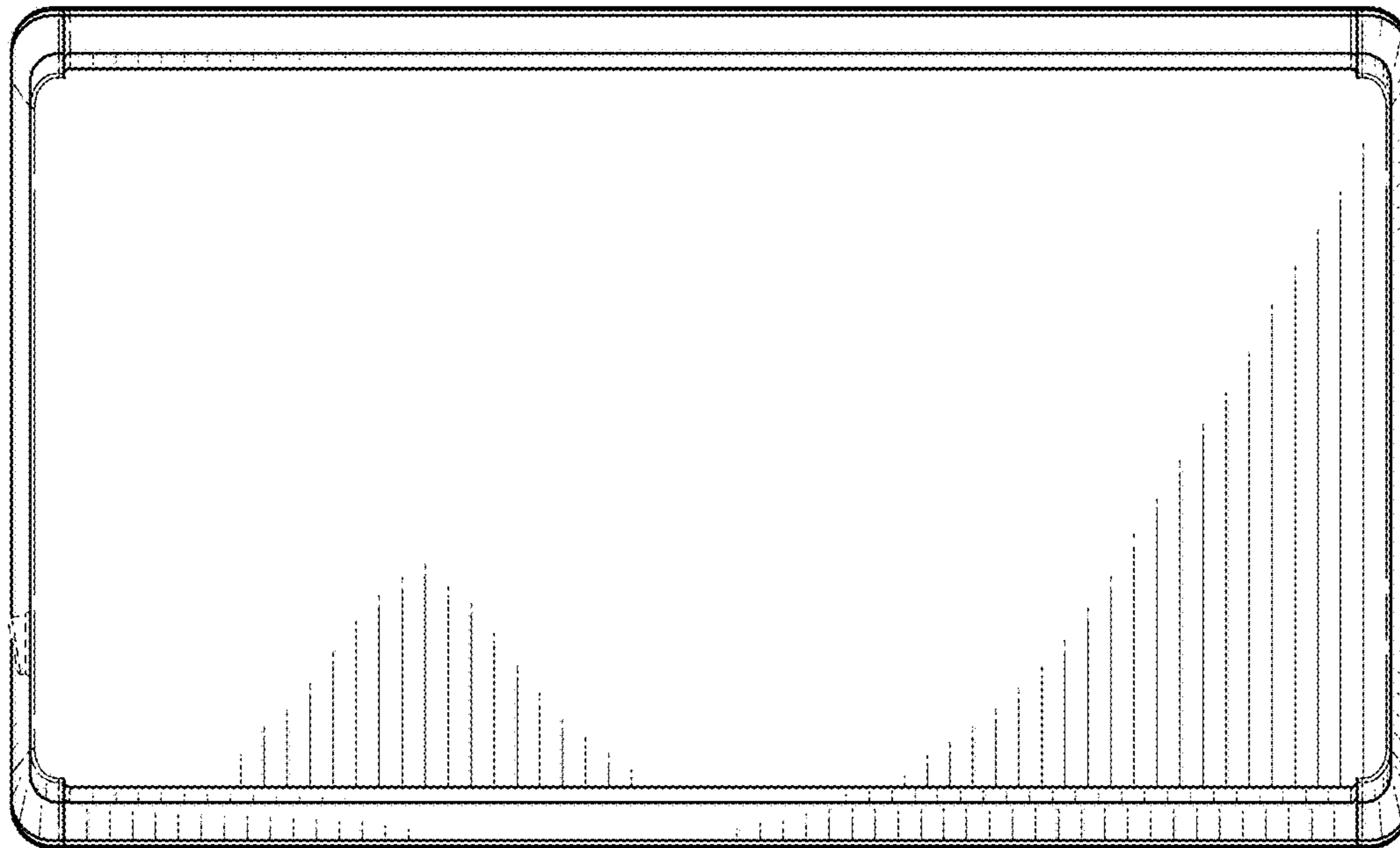

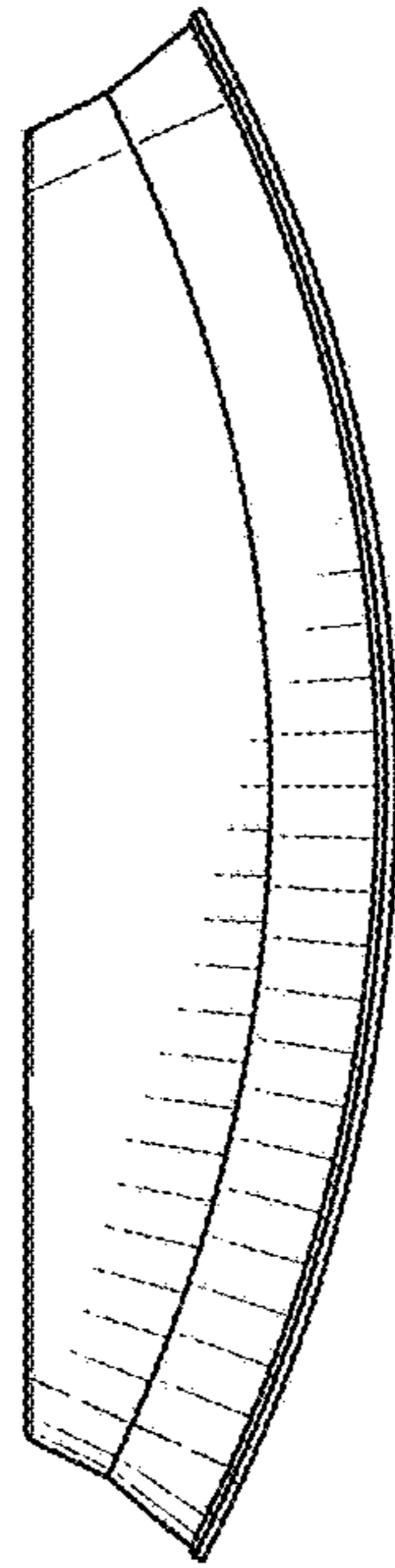

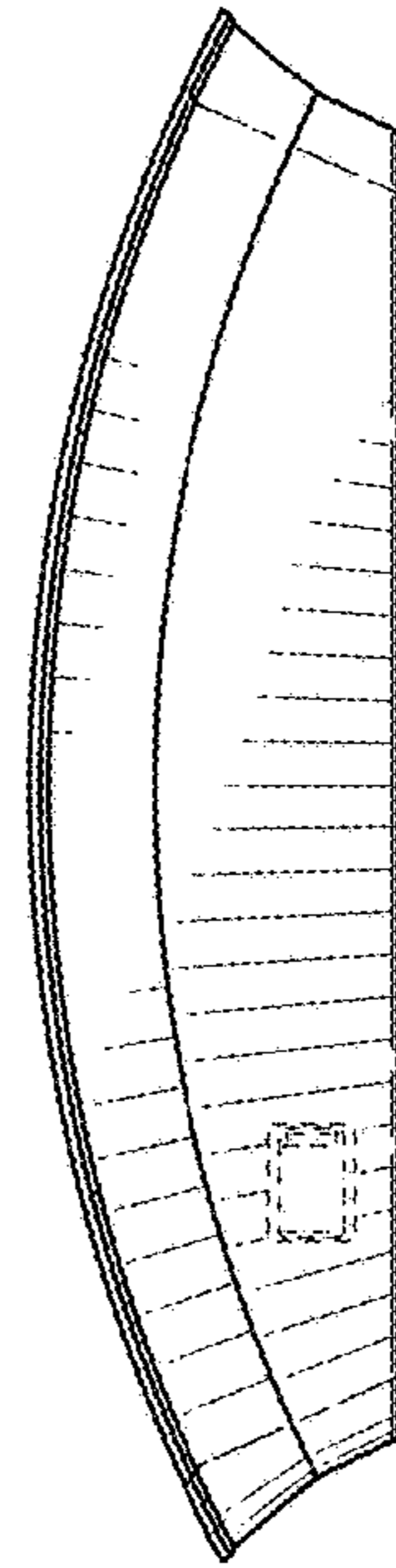

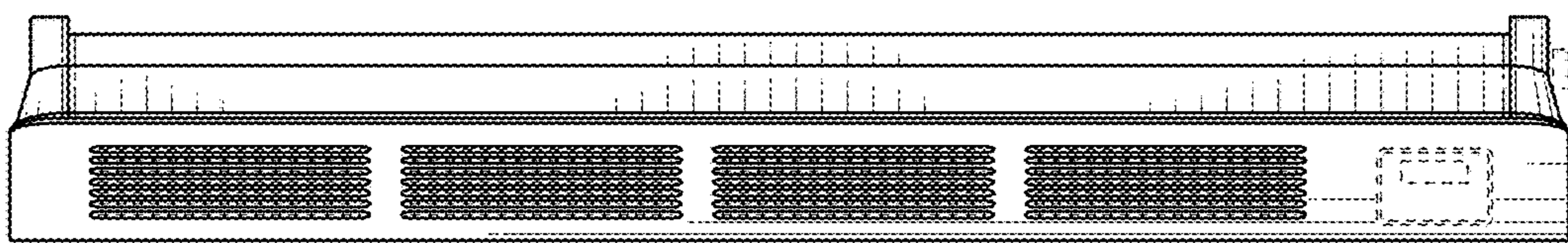

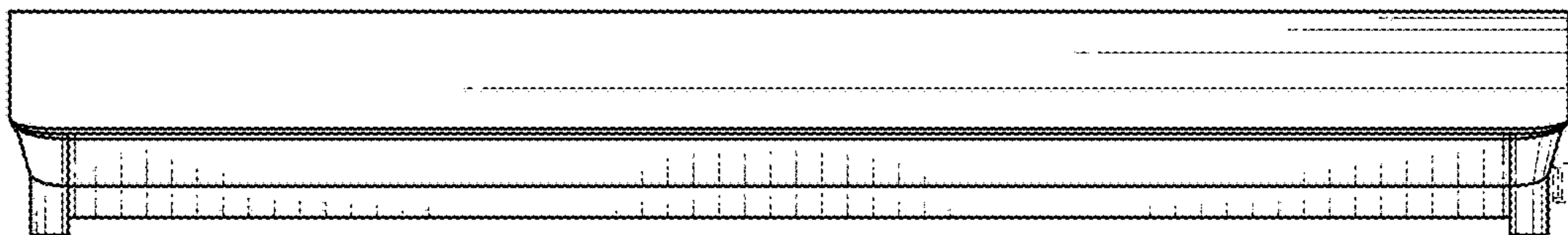
