FIG. 3 is a left side elevational view of the analysis unit of FIG. 1;

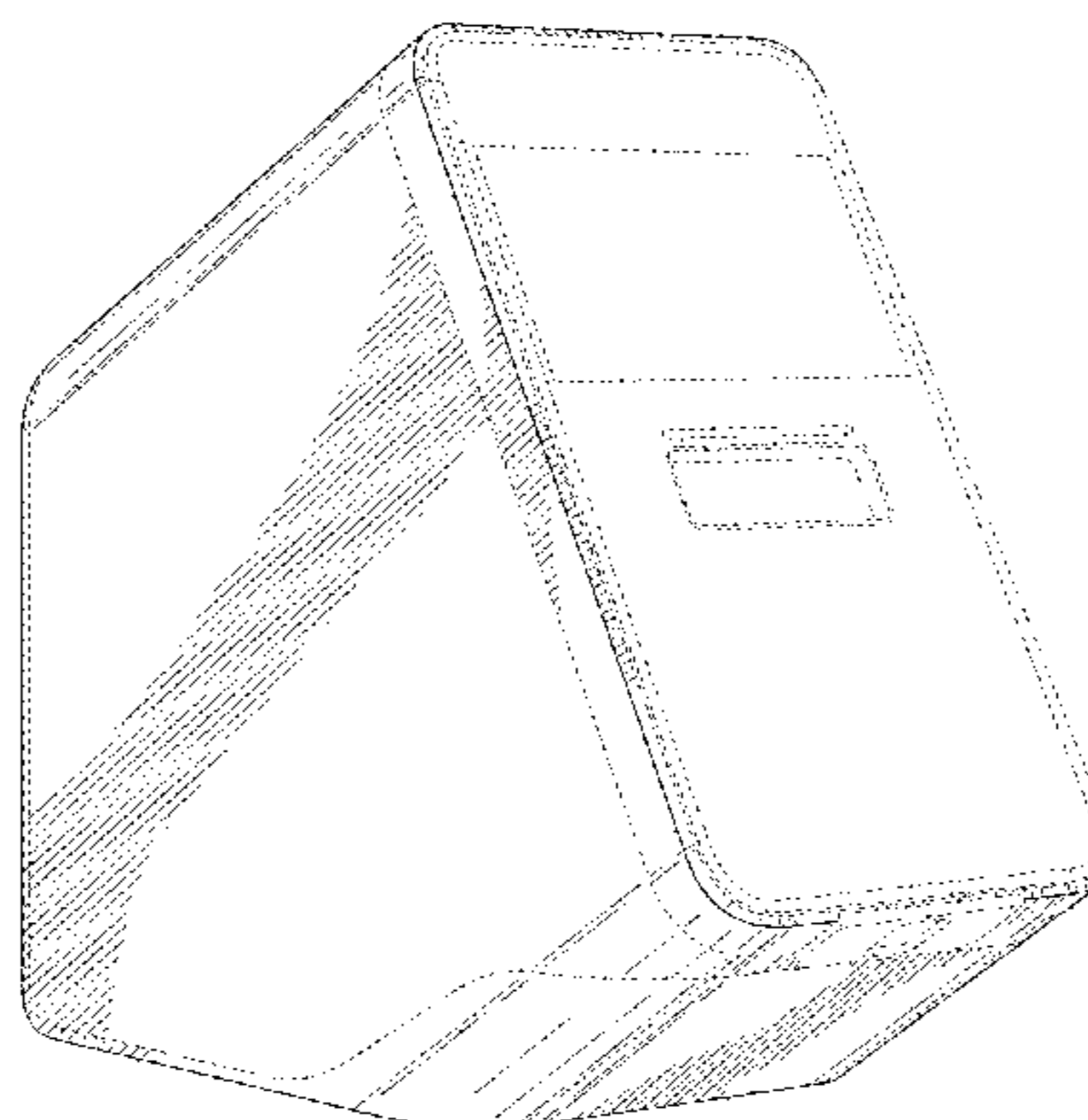
FIG. 4 is a front elevational view of the analysis unit of FIG. 1;

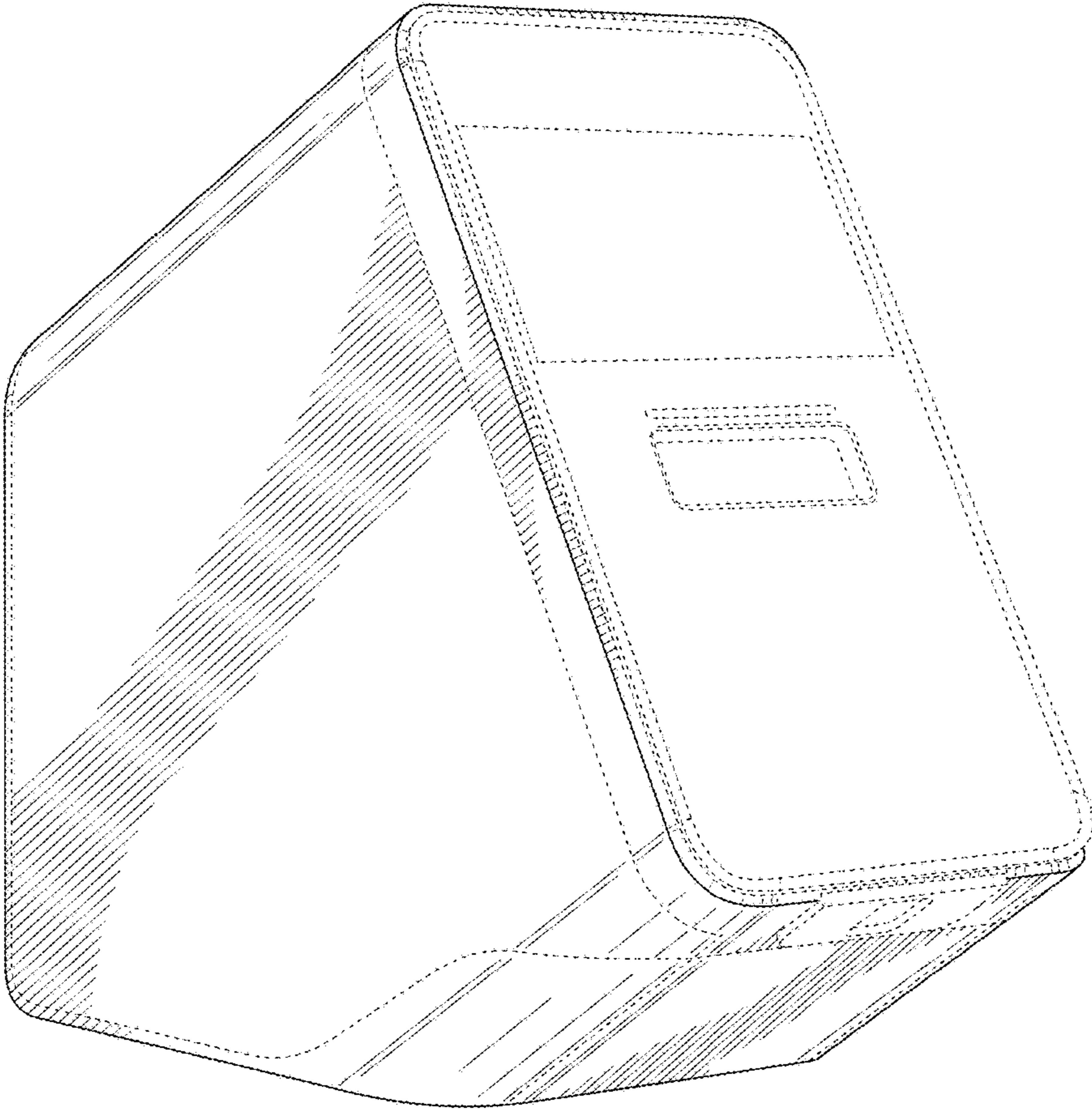

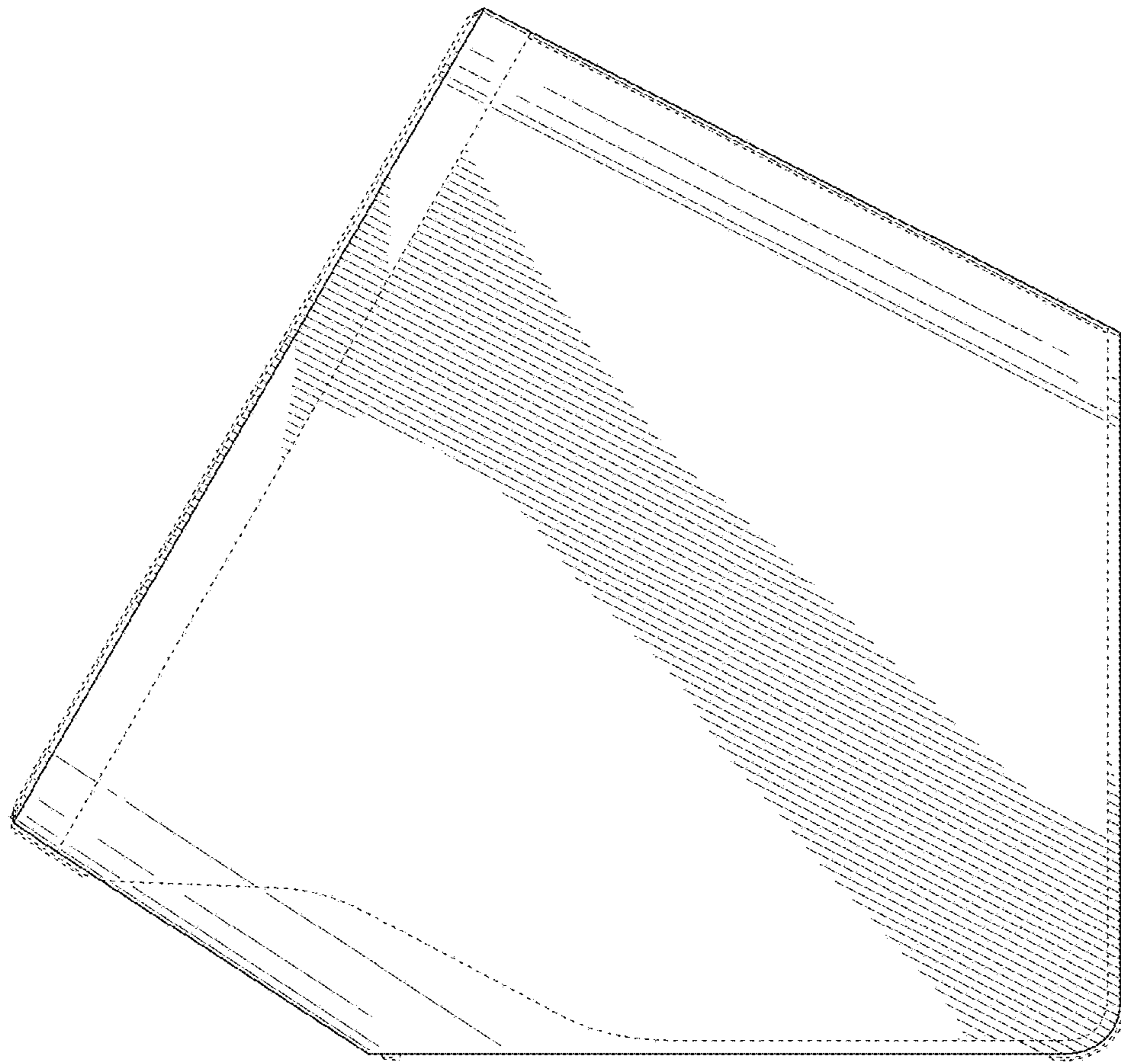

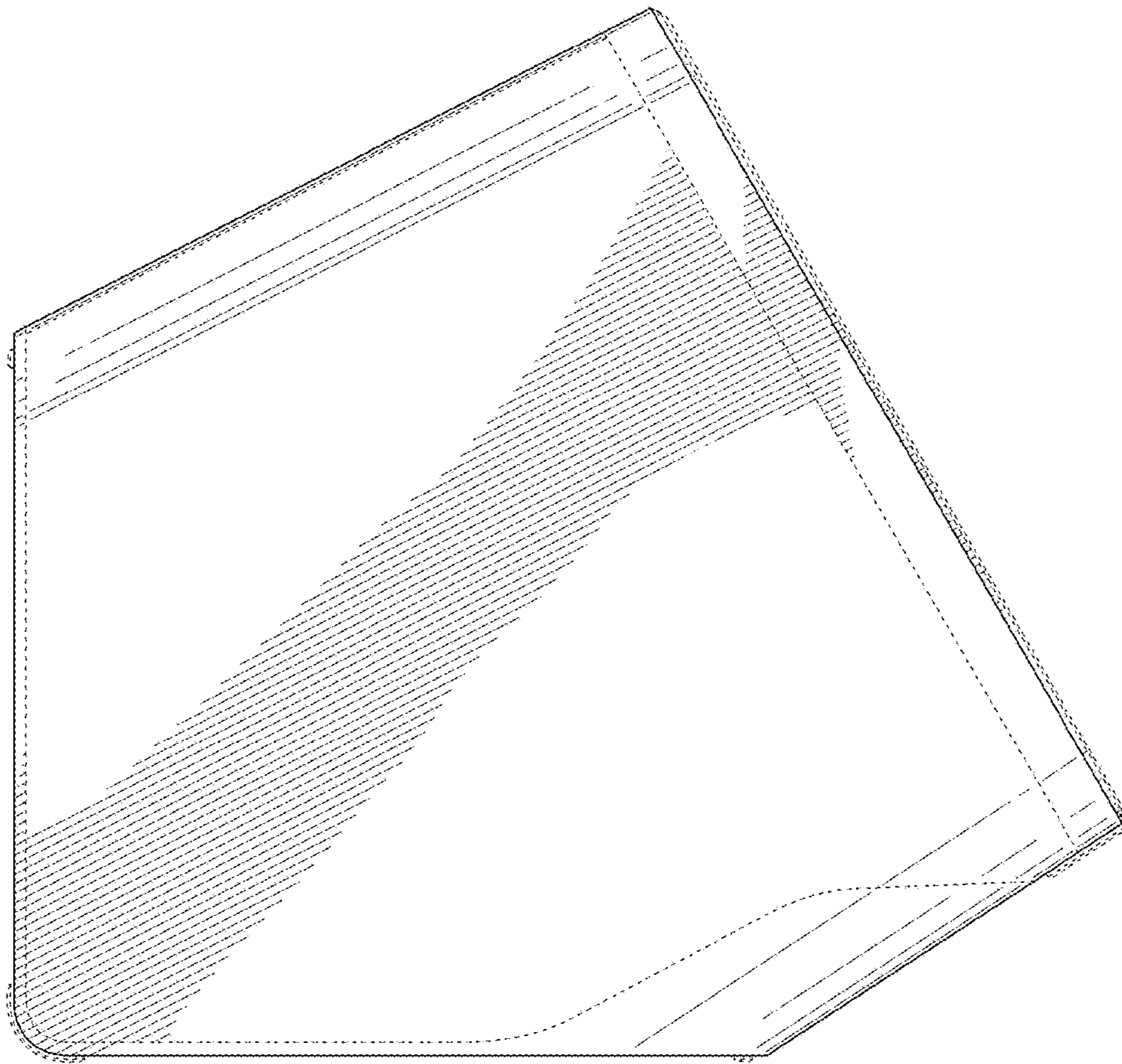

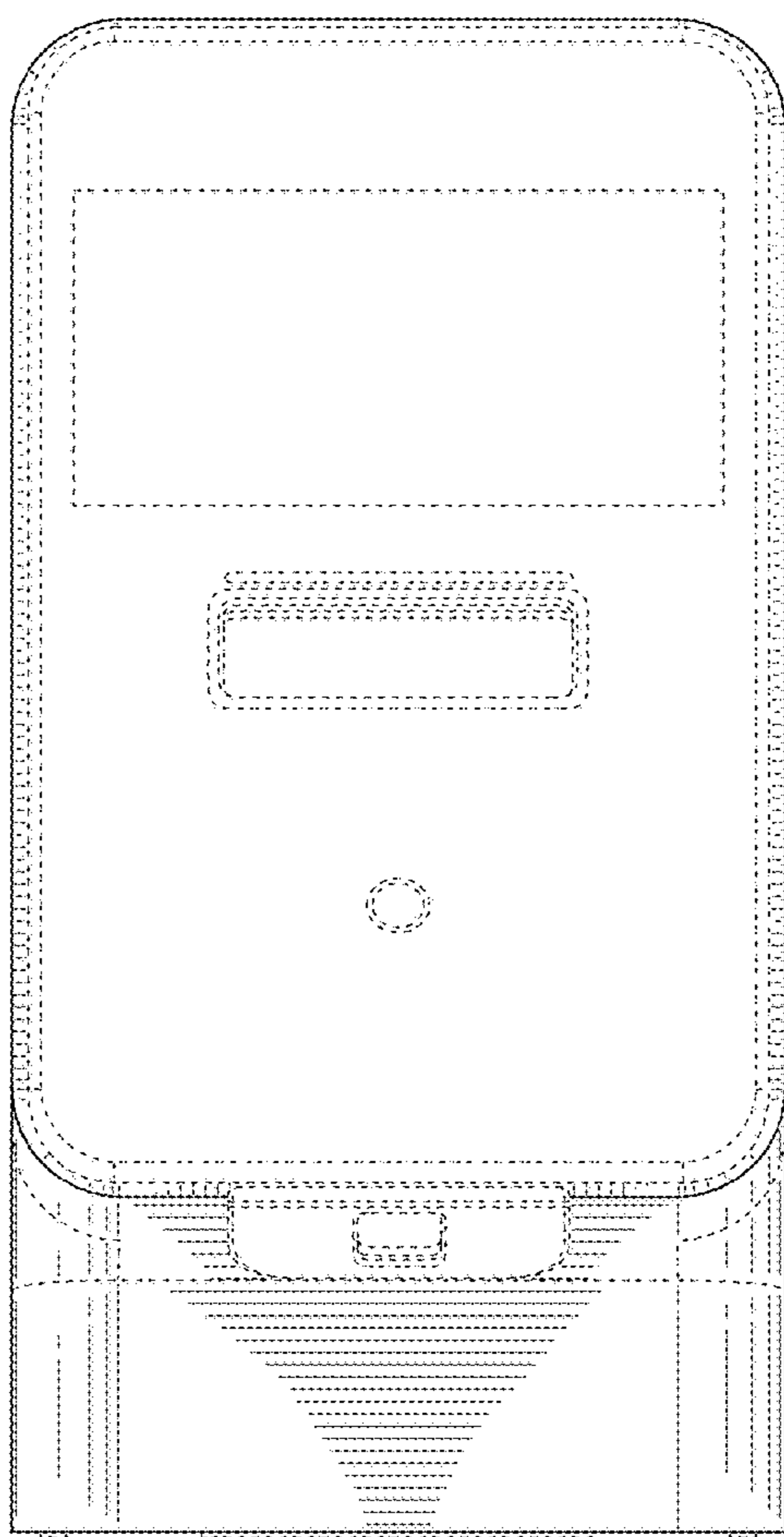

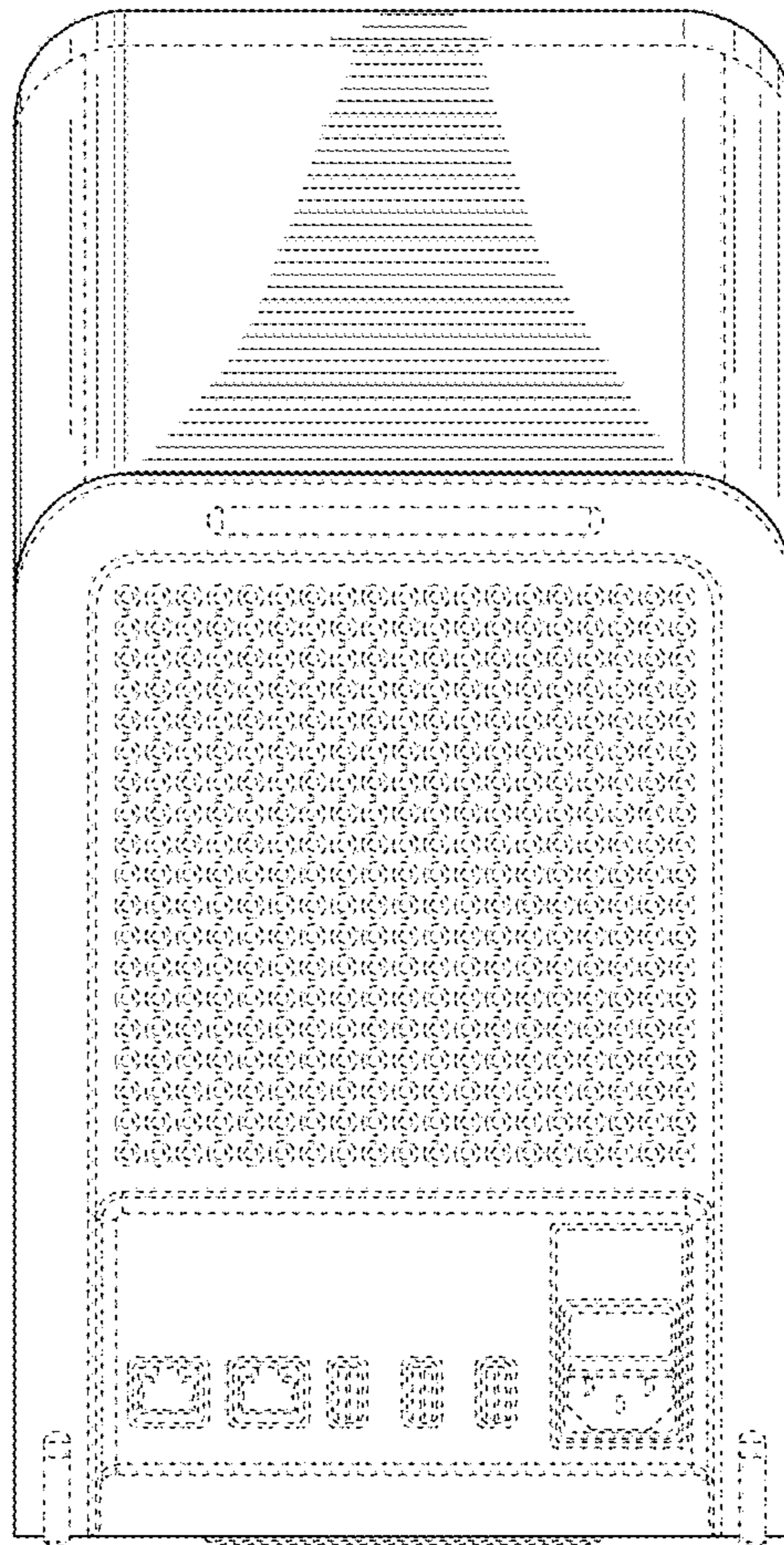

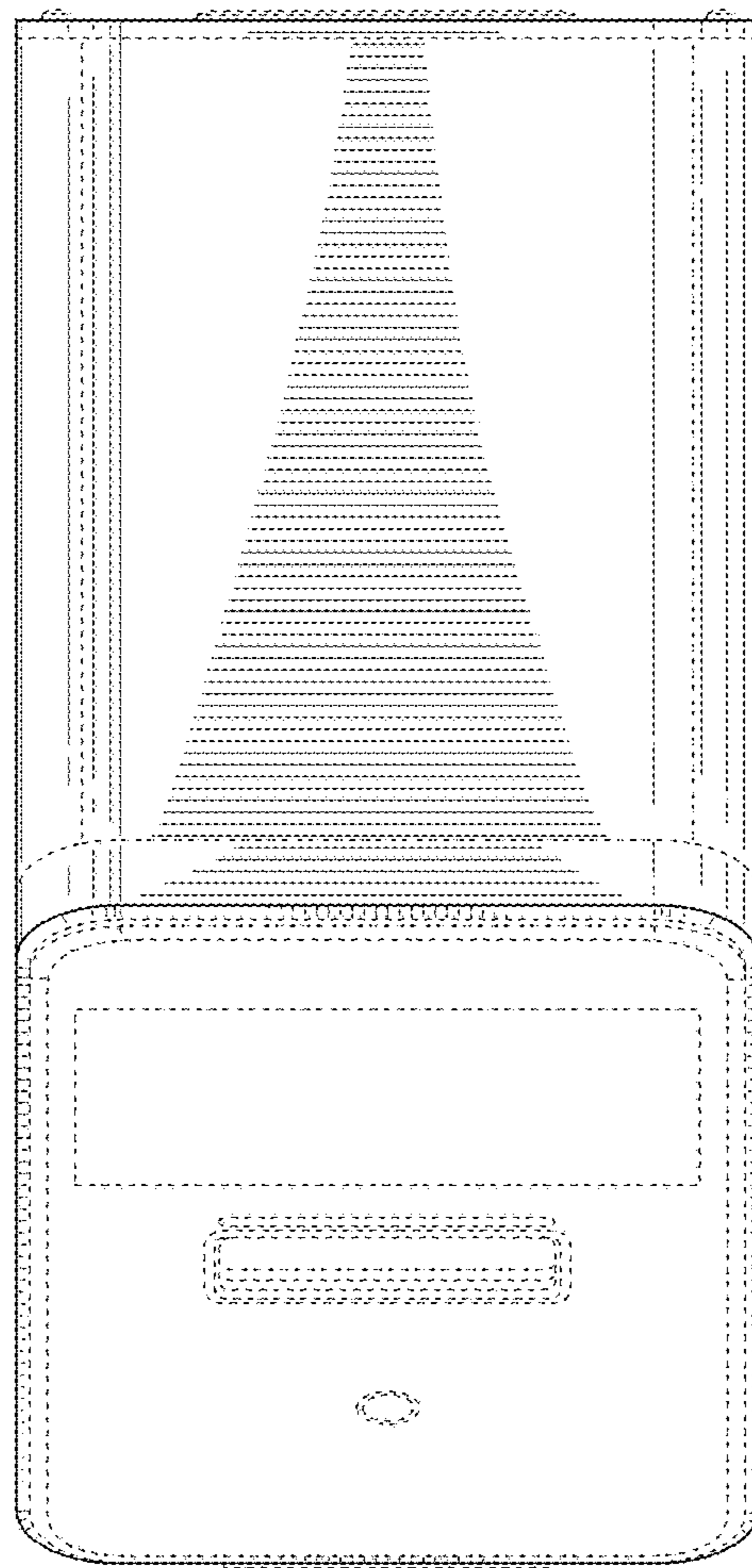

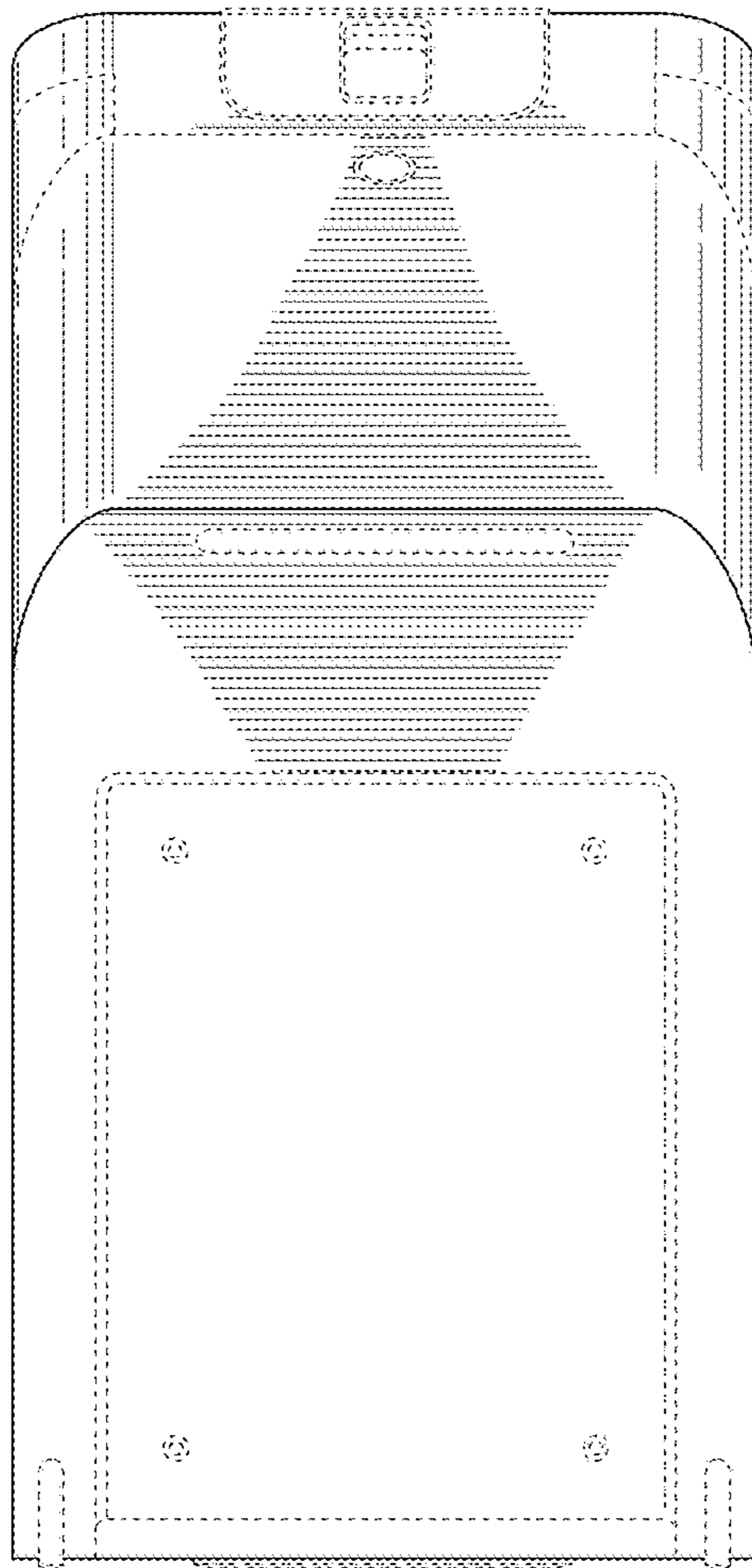
