DESCRIPTION

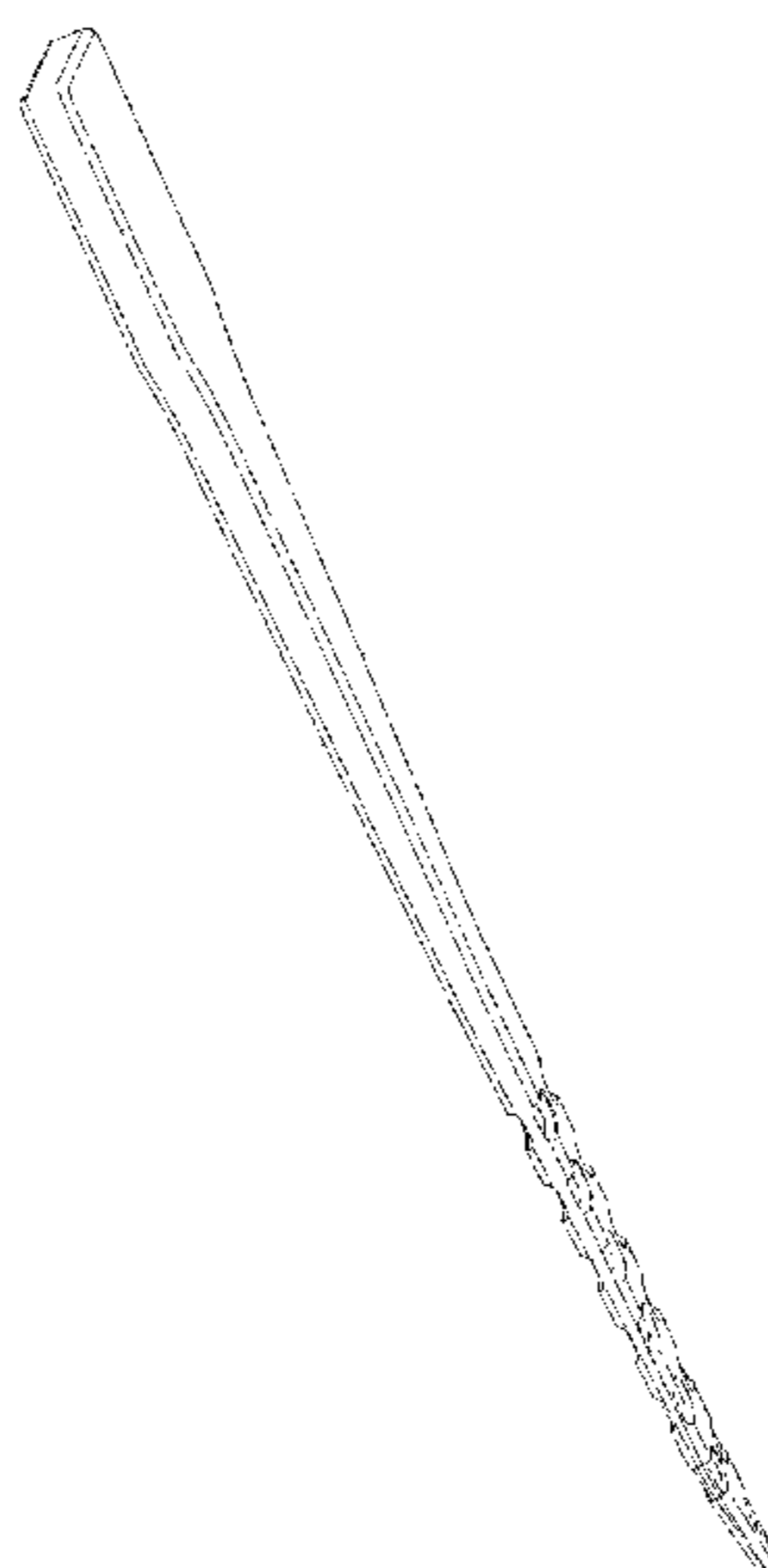
FIGS. 1 and 2 are perspective views the of interdental pick of my new design.

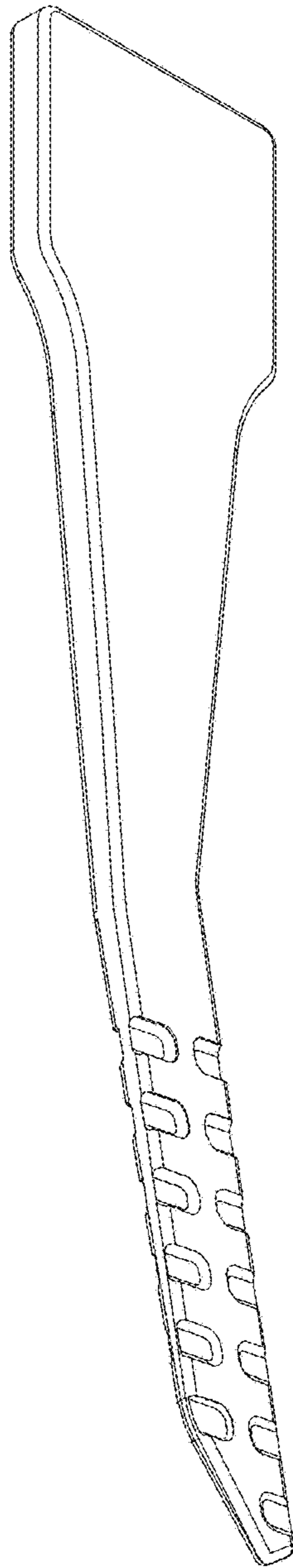

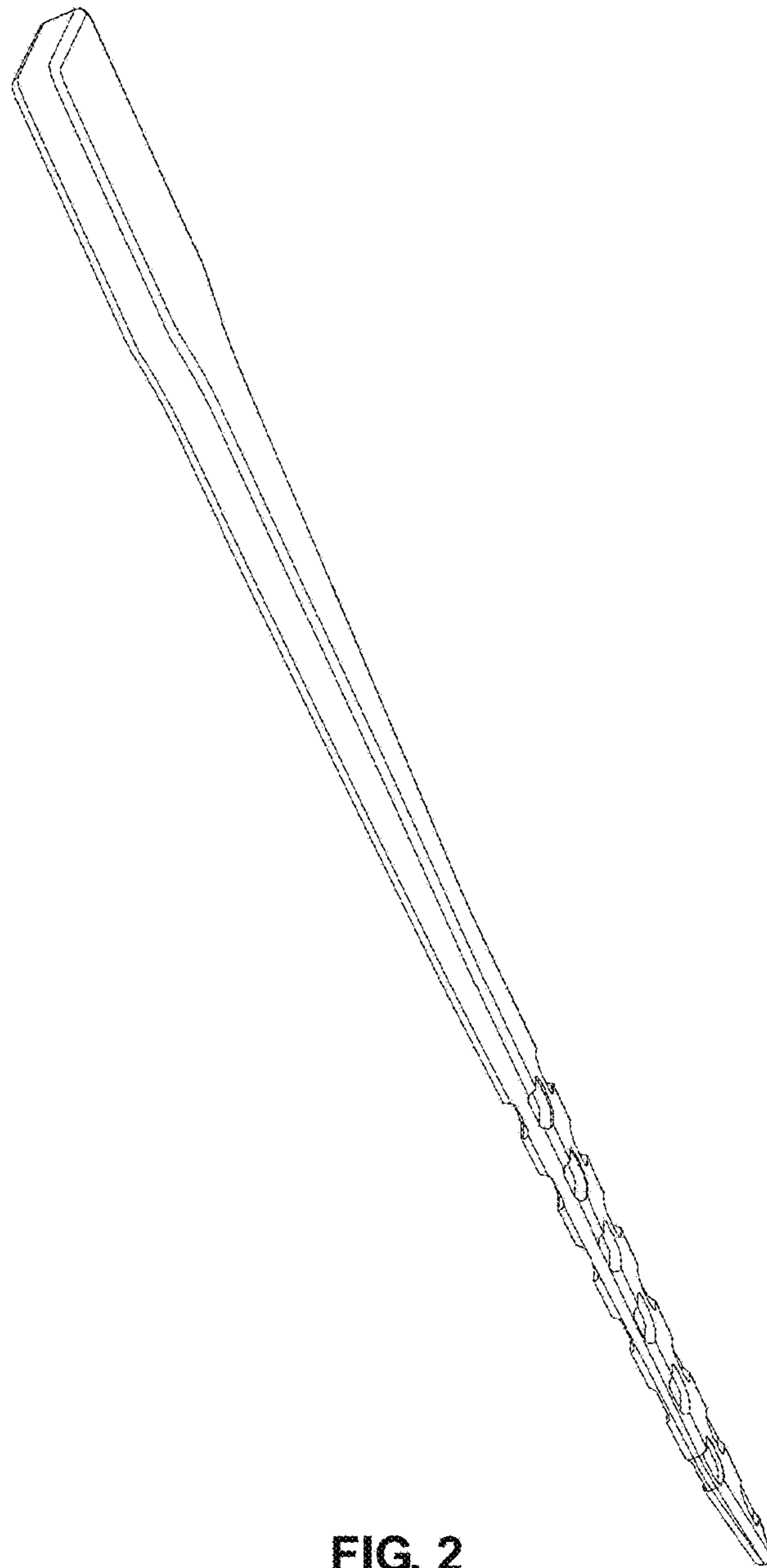

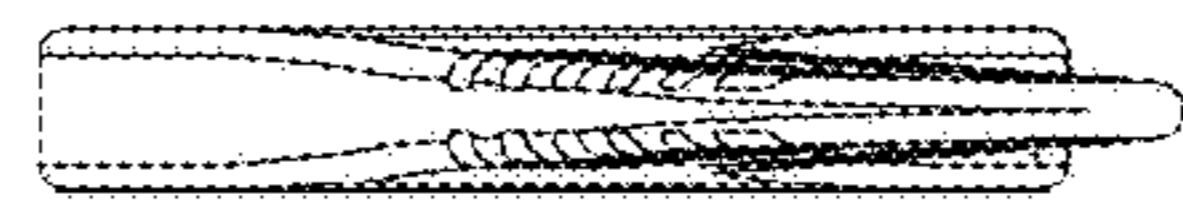

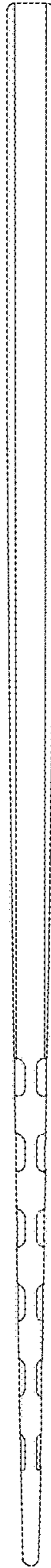

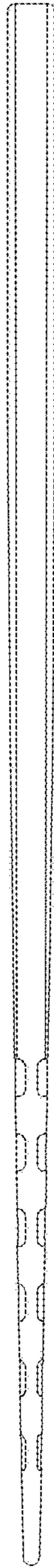
