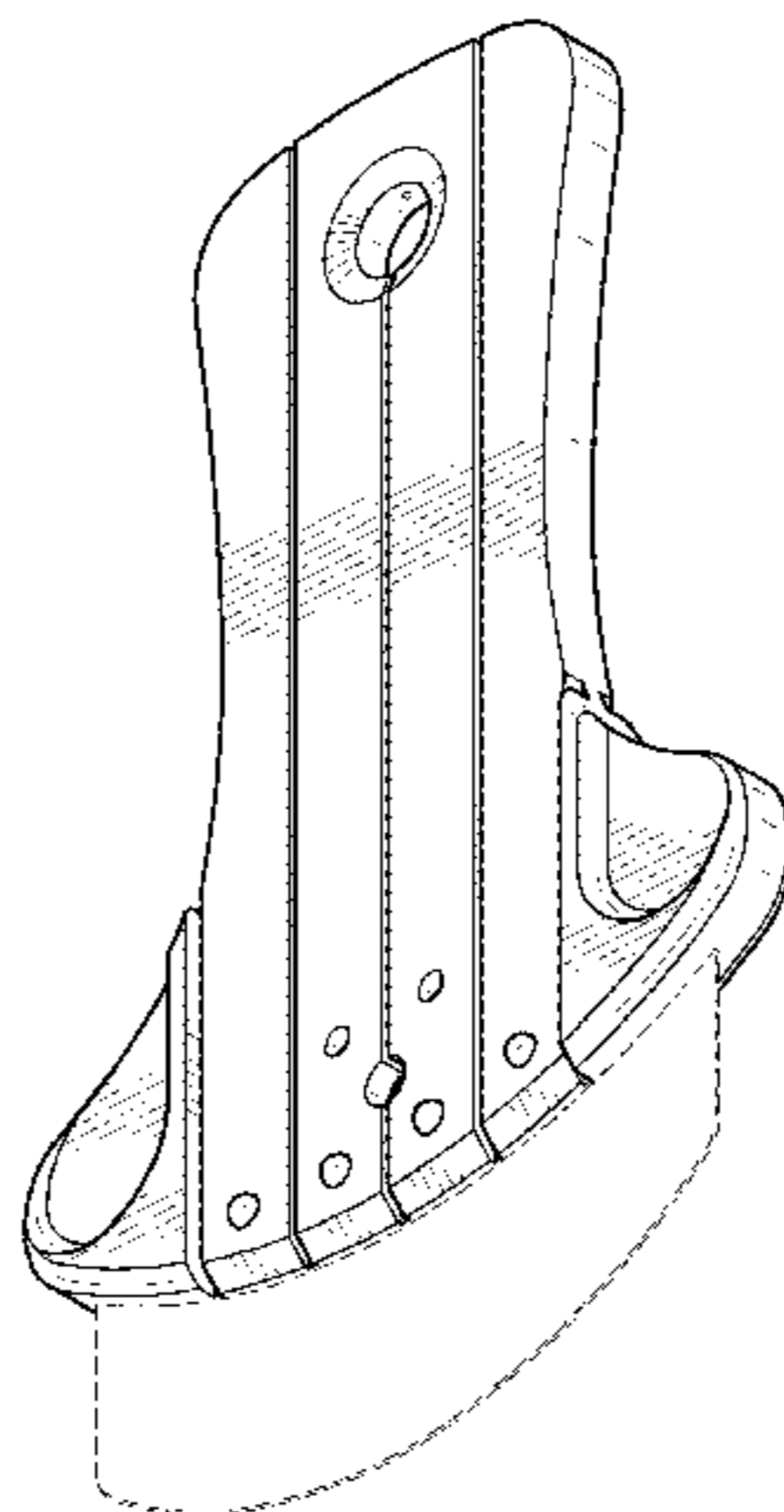
(57) **CLAIM**

The ornamental design for a scraper, as shown and
described.

DESCRIPTION

FIG. 1 is a front view thereof, a rear view being identical
thereto;
FIG. 2 is a top view thereof;
FIG. 3 is a bottom view thereof;
FIG. 4 is a right view thereof, a left side view being identical
thereto; and,
FIG. 5 is a front, right perspective view thereof.
With reference to FIGS. 1 and 5, the broken lines illustrated
in drawings show a blade for the scraper and are for
illustrative purposes only and form no part of the claimed
design.

The scraper contains four raised projections or bumps (see FIGS. 1-3 and 5) and two similarly sized holes (see FIGS. 1 and 5).

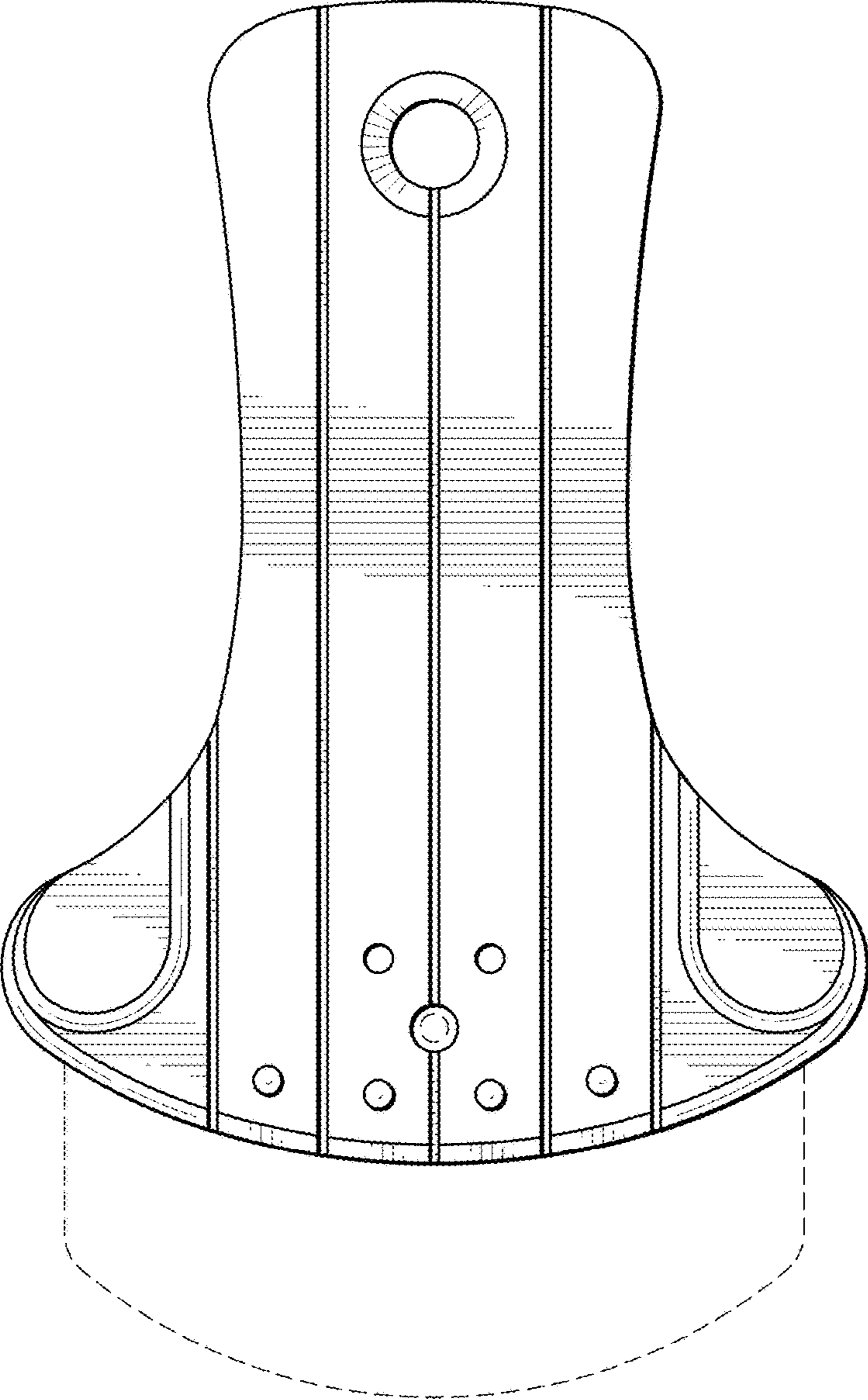

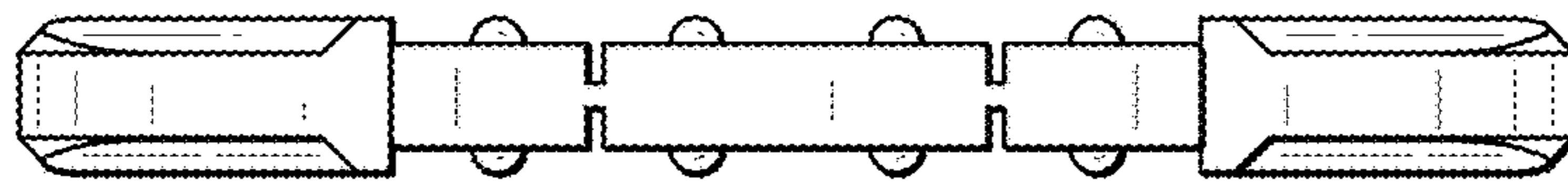

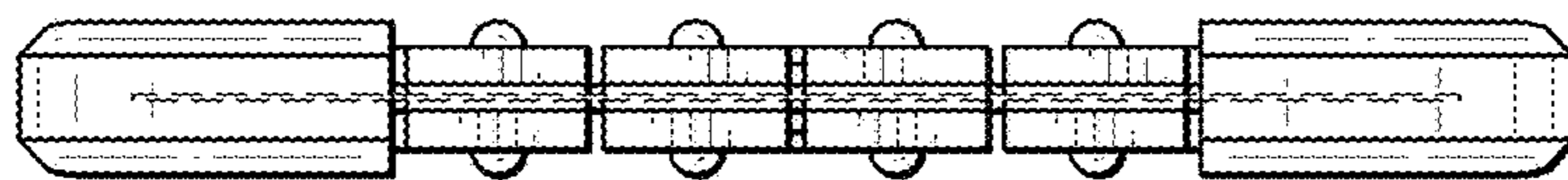

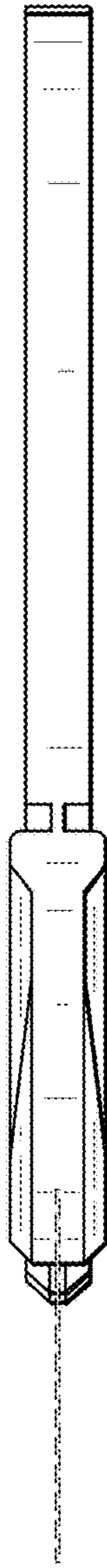

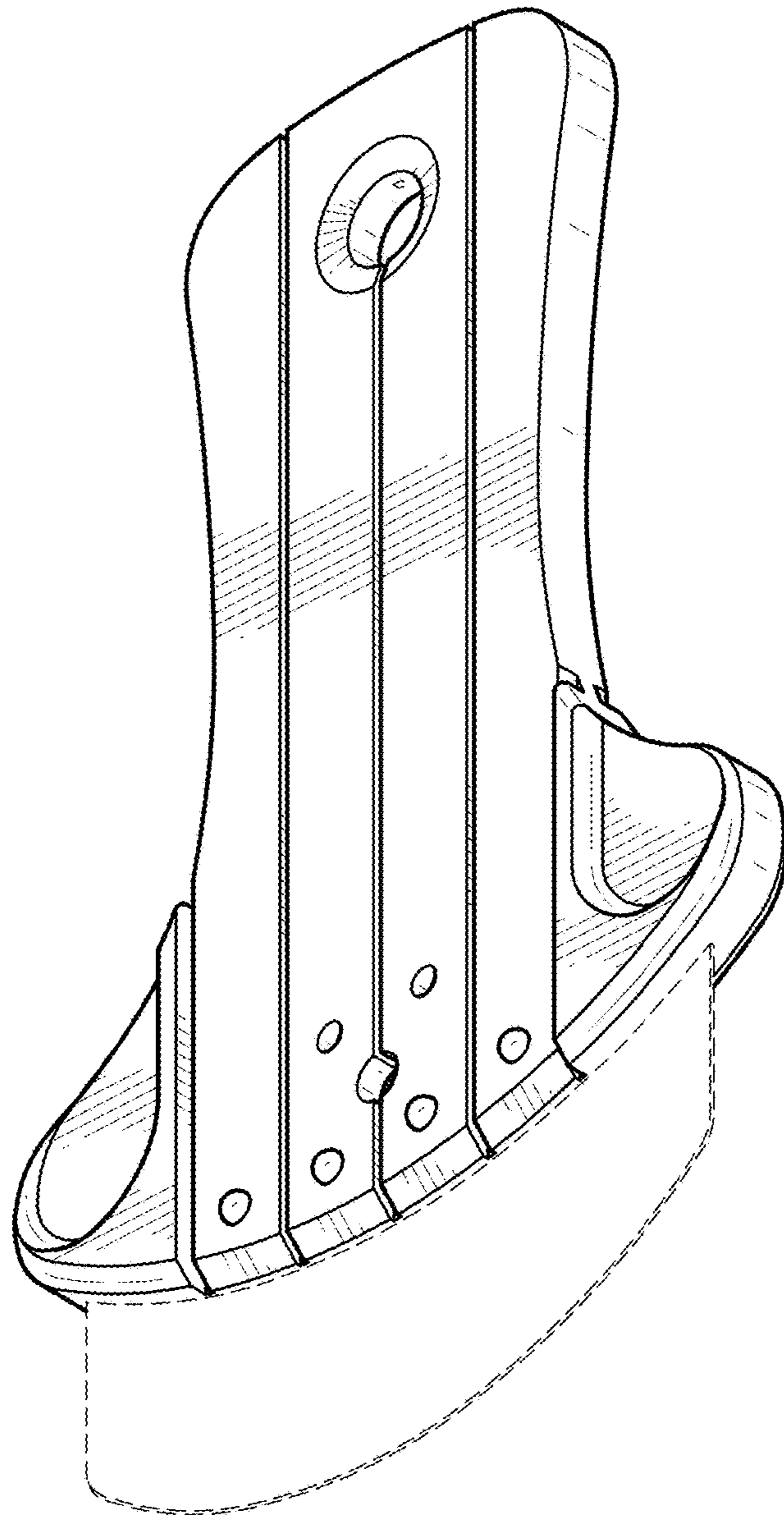
