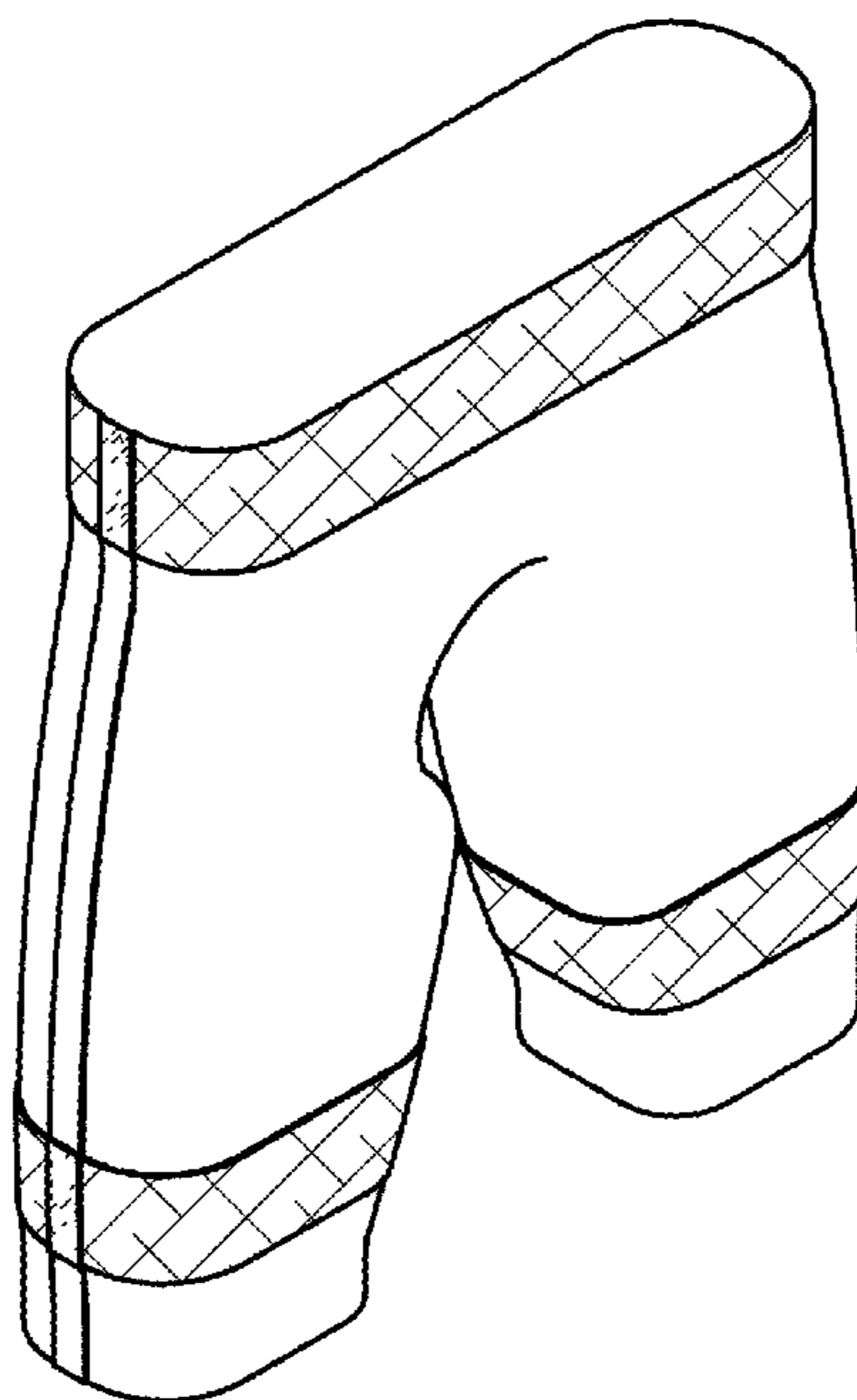
(57) **CLAIM**

The ornamental design for the post operative surgical dressing garment, as shown and described.

DESCRIPTION

FIG. 1 is a top left side perspective view of a postoperative surgical dressing garment showing our new design; FIG. 2 is a left side elevational view of our design; FIG. 3 is a front elevational view of our design; FIG. 4 is a right side view of our design; FIG. 5 is a front left side perspective view of our design illustrating the resealable pants leg in a partially opened position; FIG. 6 is a top elevational view of our design; FIG. 7 is a bottom elevational view of our design; FIG. 8 is a rear elevational view of our design illustrating the ice pockets; FIG. 9 is a top front right side perspective view of our design; and, FIG. 10 is a right side elevational view of our design.

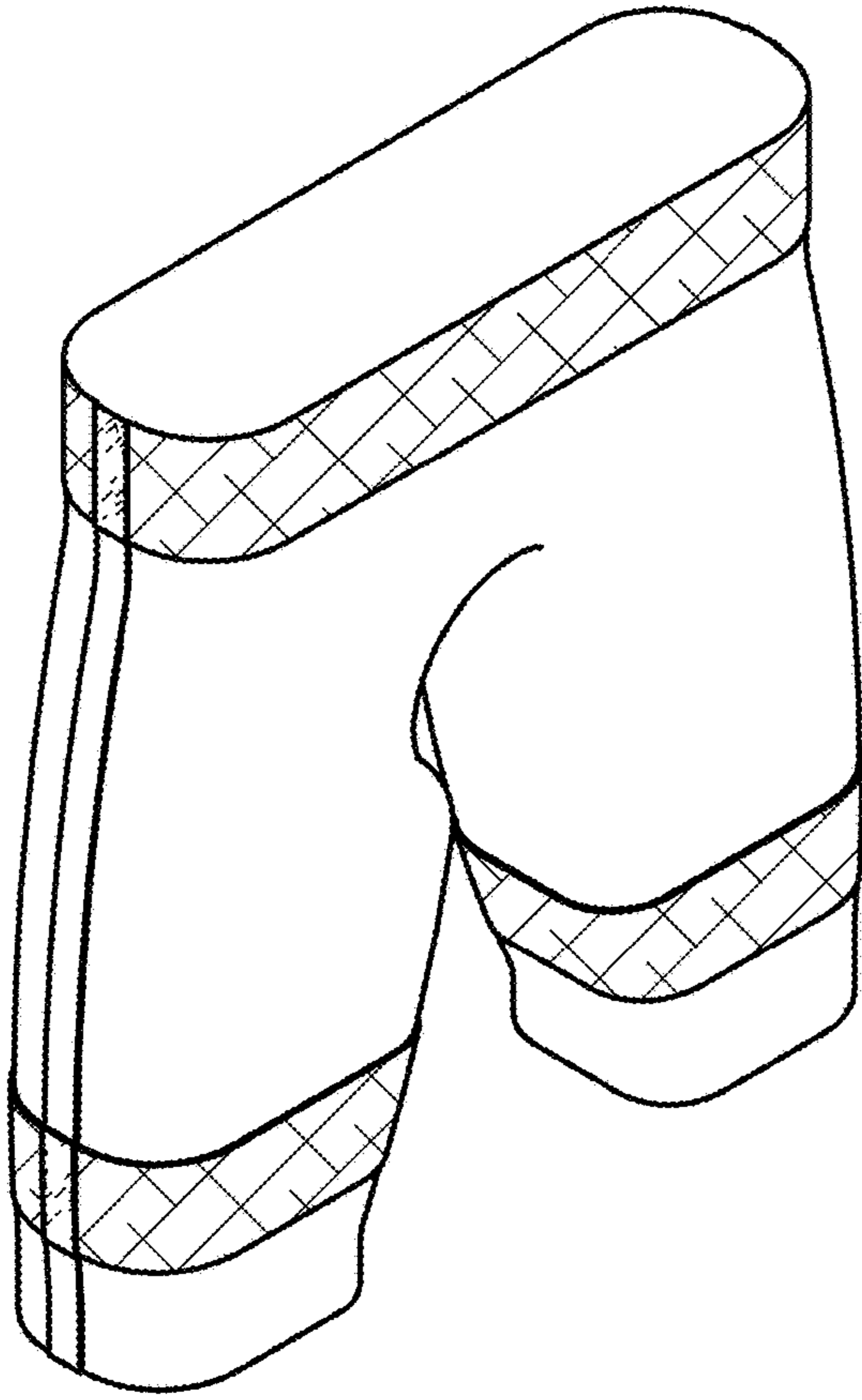

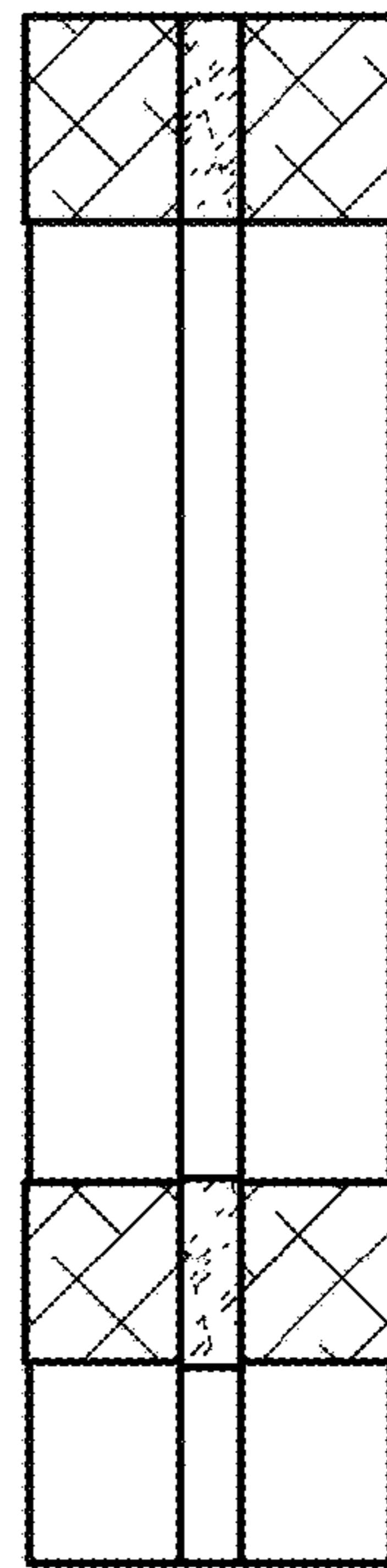

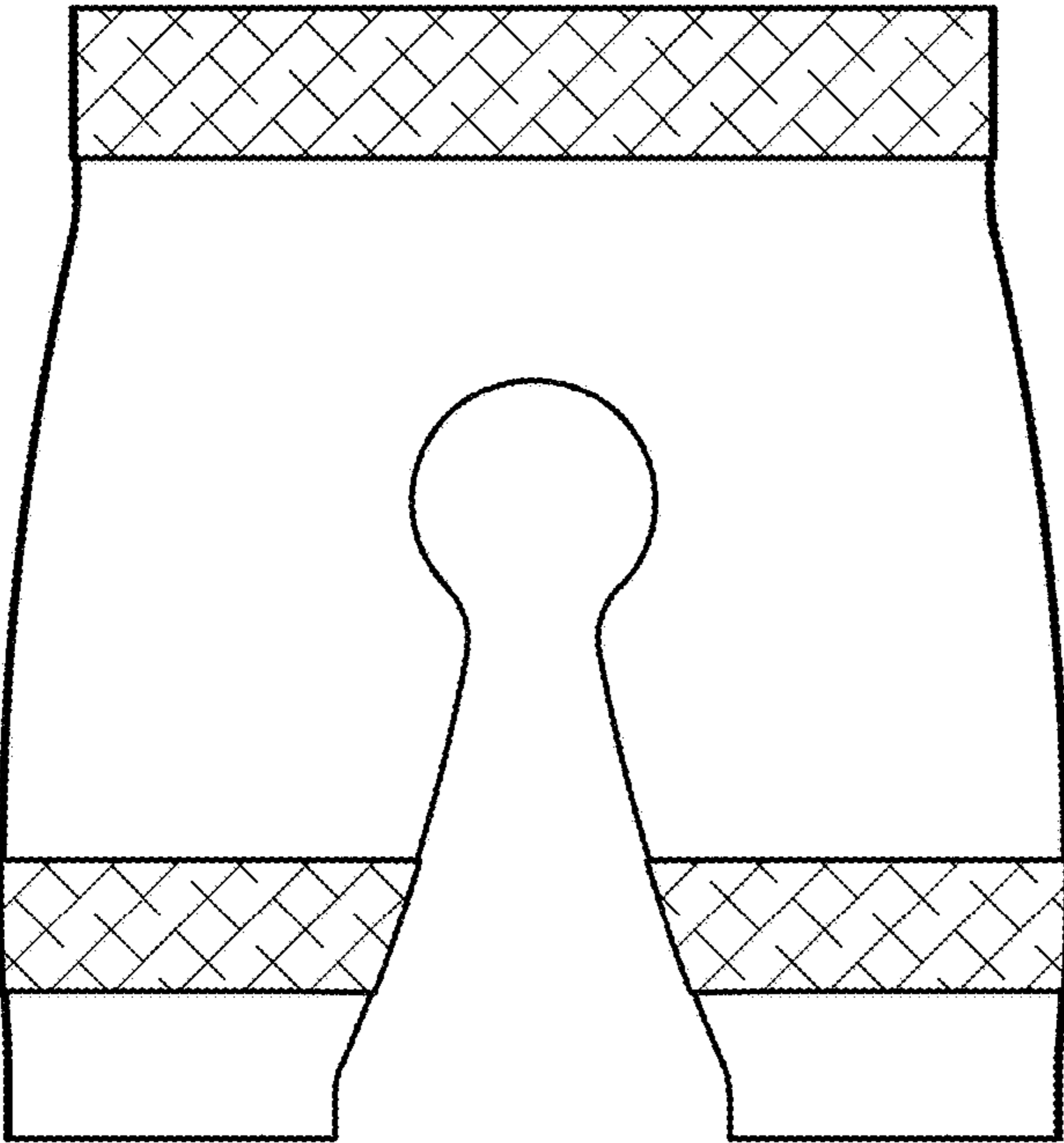

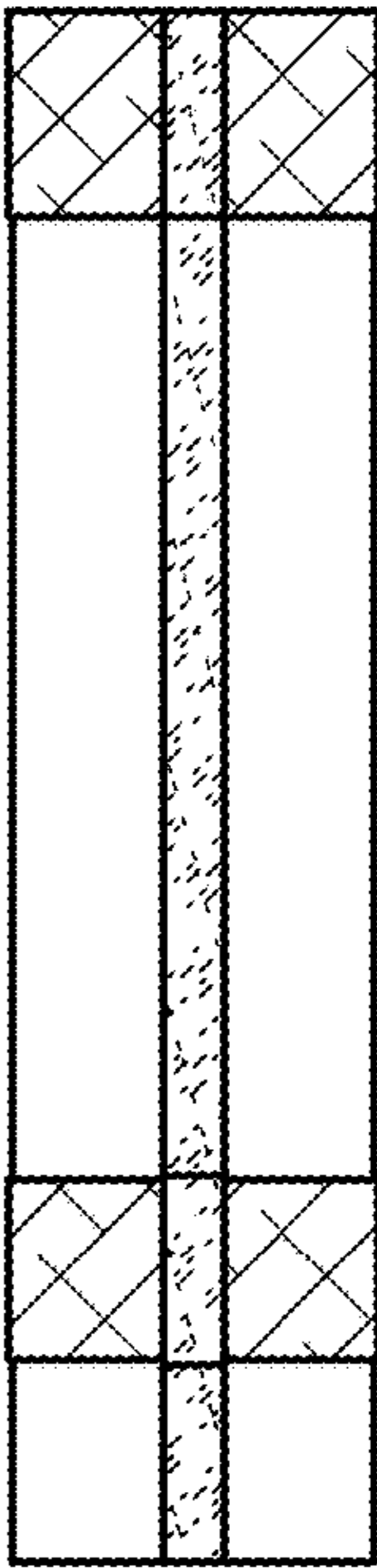

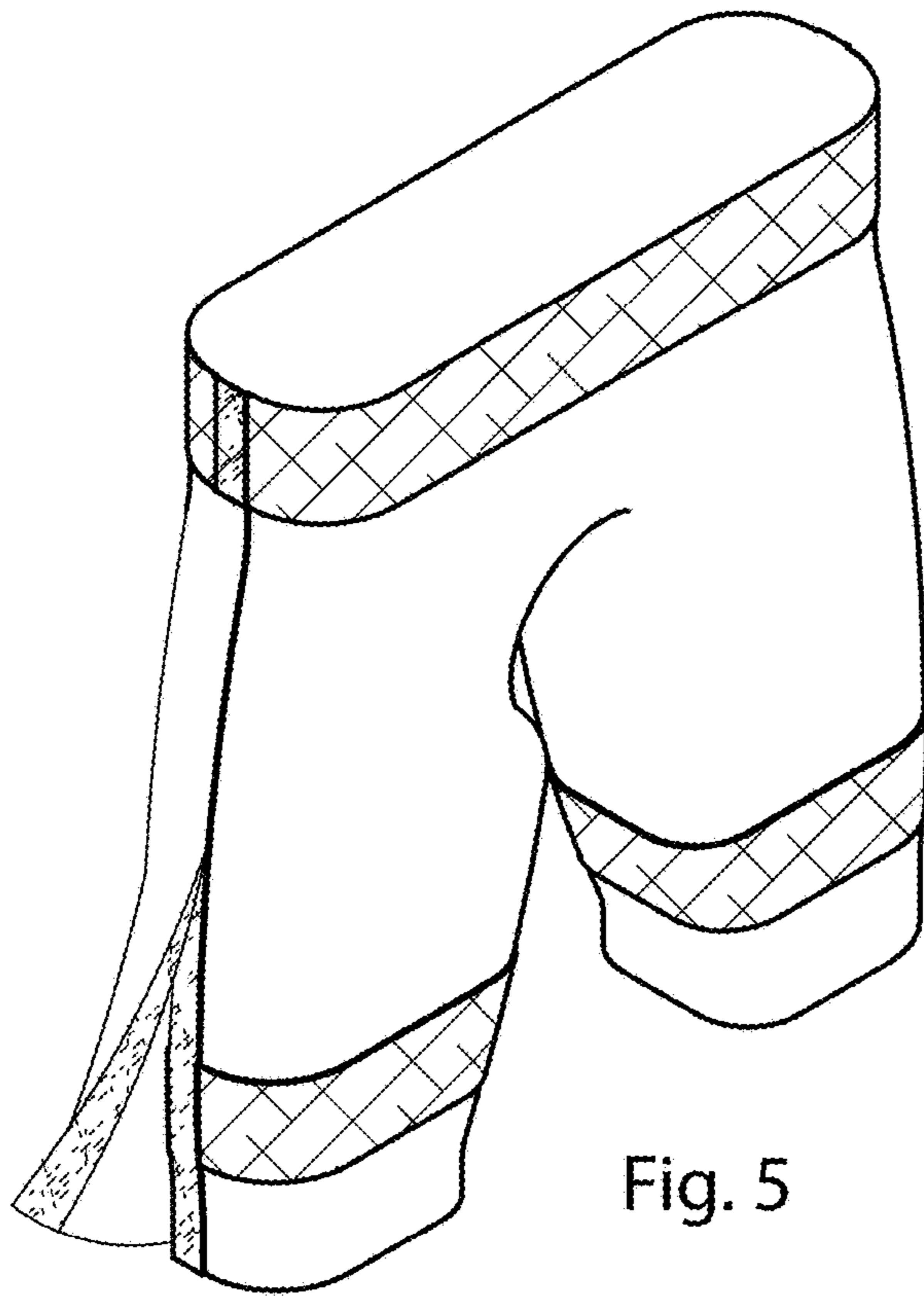

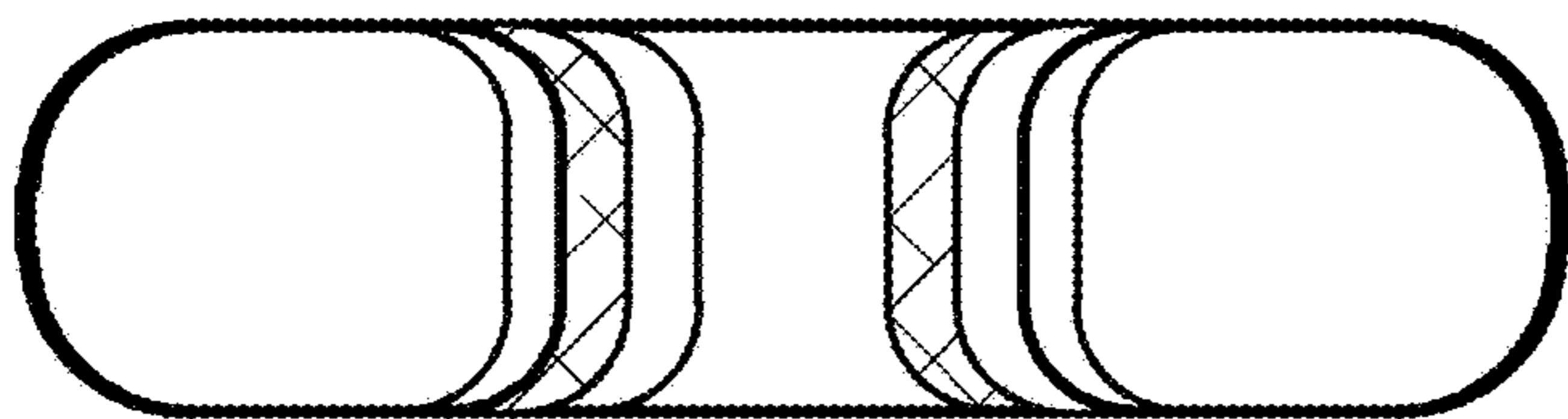

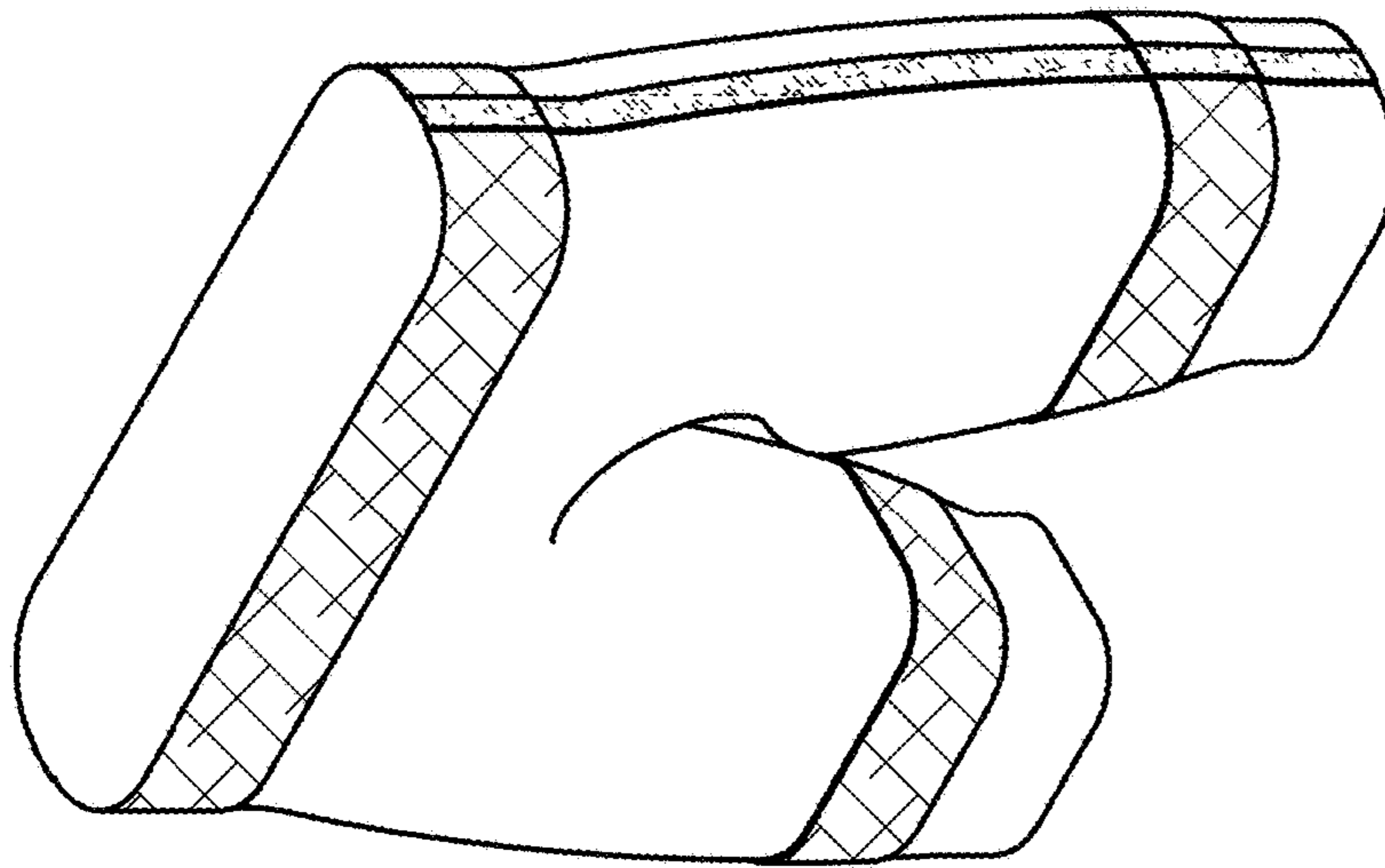

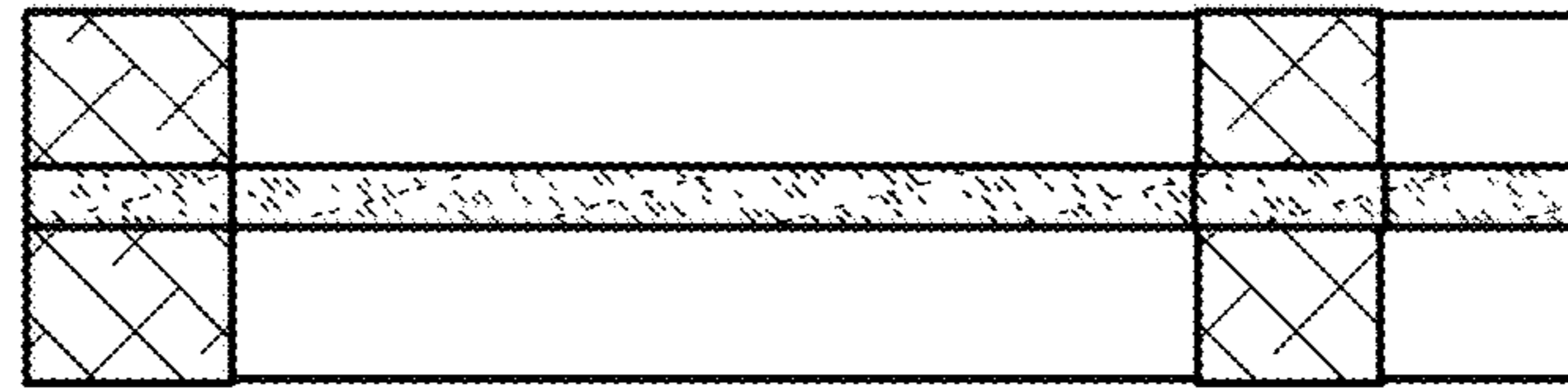

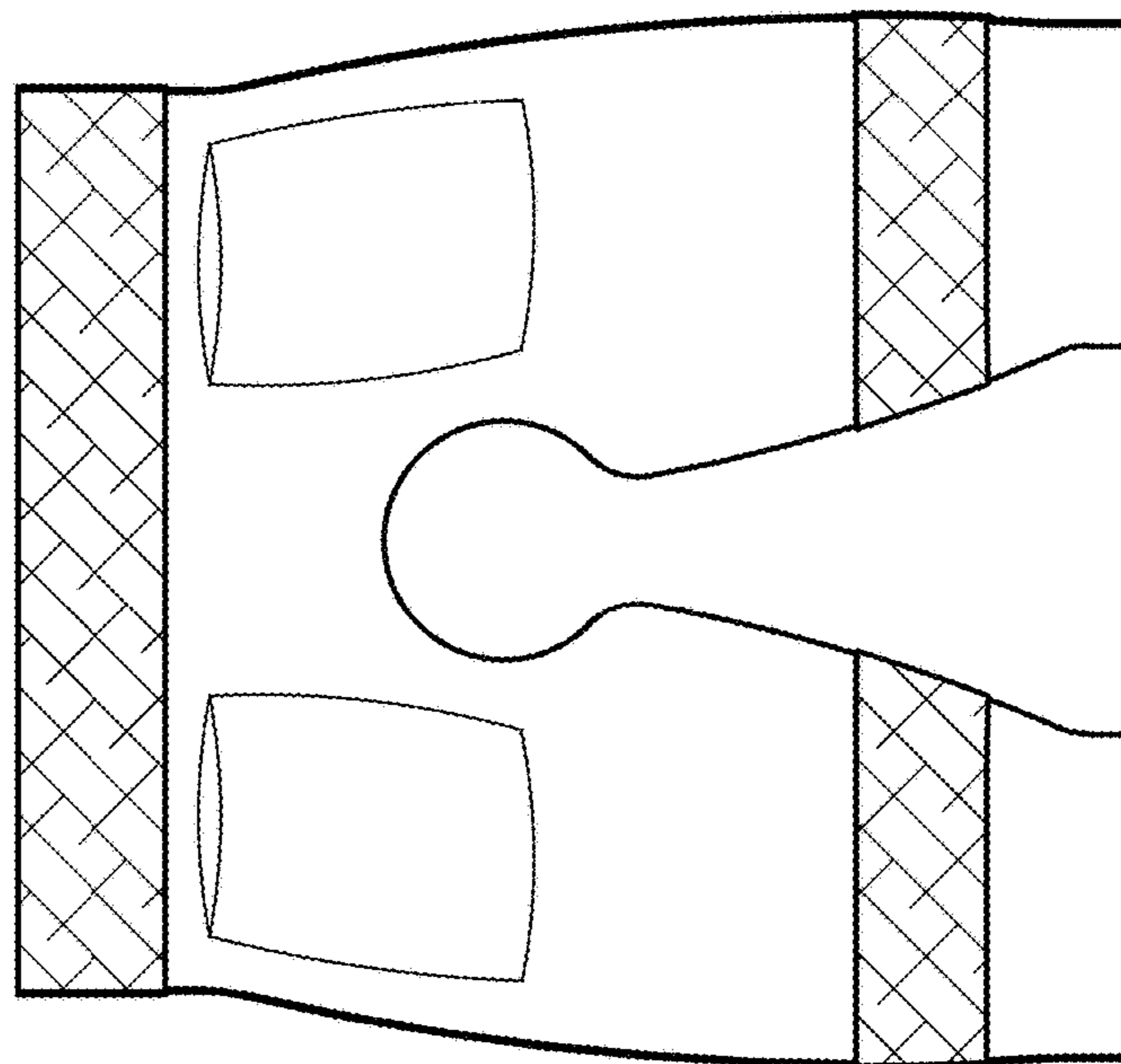
