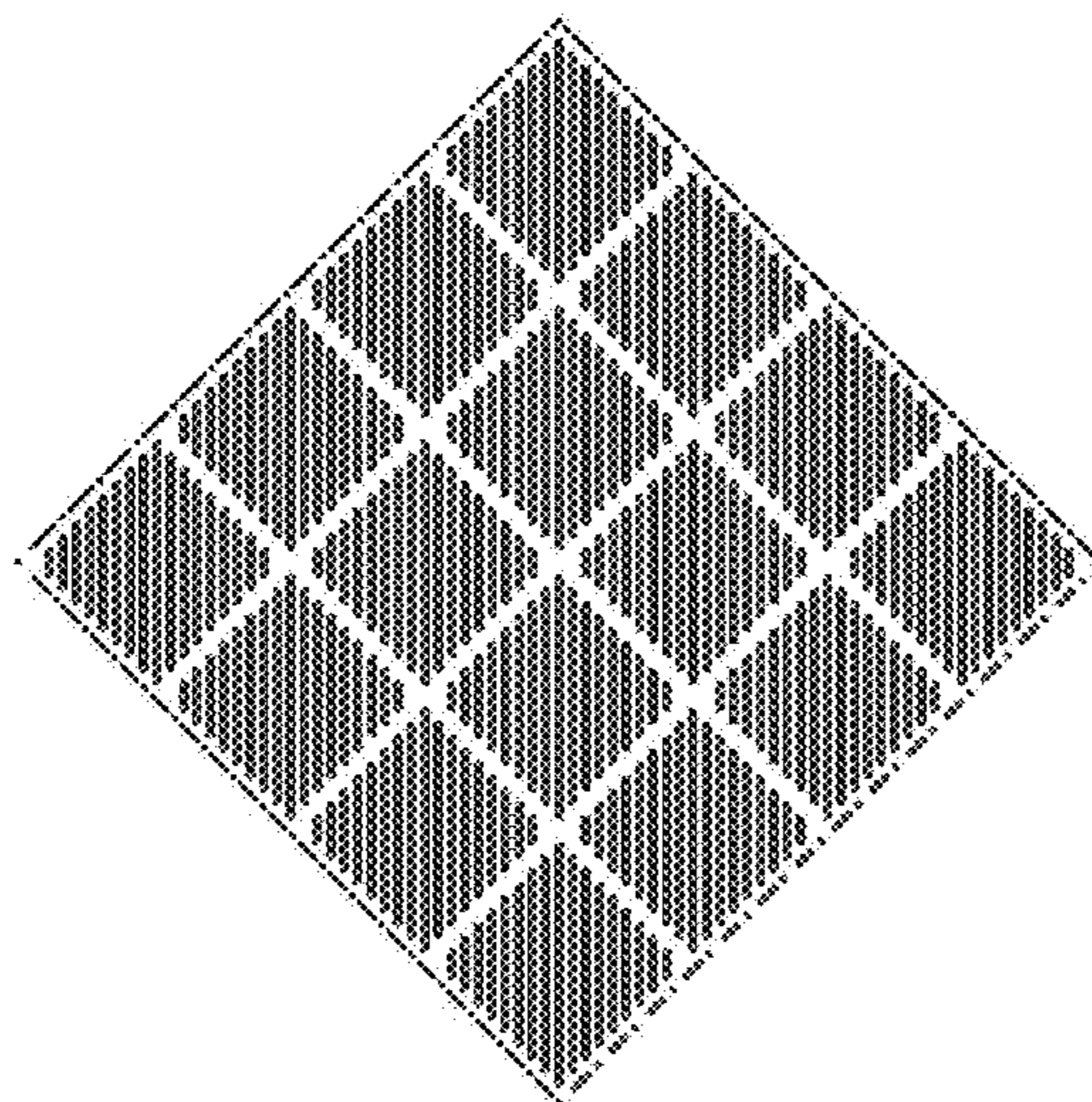
The ornamental design for a film with pattern, as shown and described.
