(57) **CLAIM**

The ornamental design for a chair with armrests, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a chair with armrests showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a left side elevational view thereof, the right side being a mirror image;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a top view thereof;  
FIG. 6 is a bottom view thereof;  
FIG. 7 is a front detail view of the lattice in the back of the chair; and,  
FIG. 8 is a rear detail view of the lattice of FIG. 7.

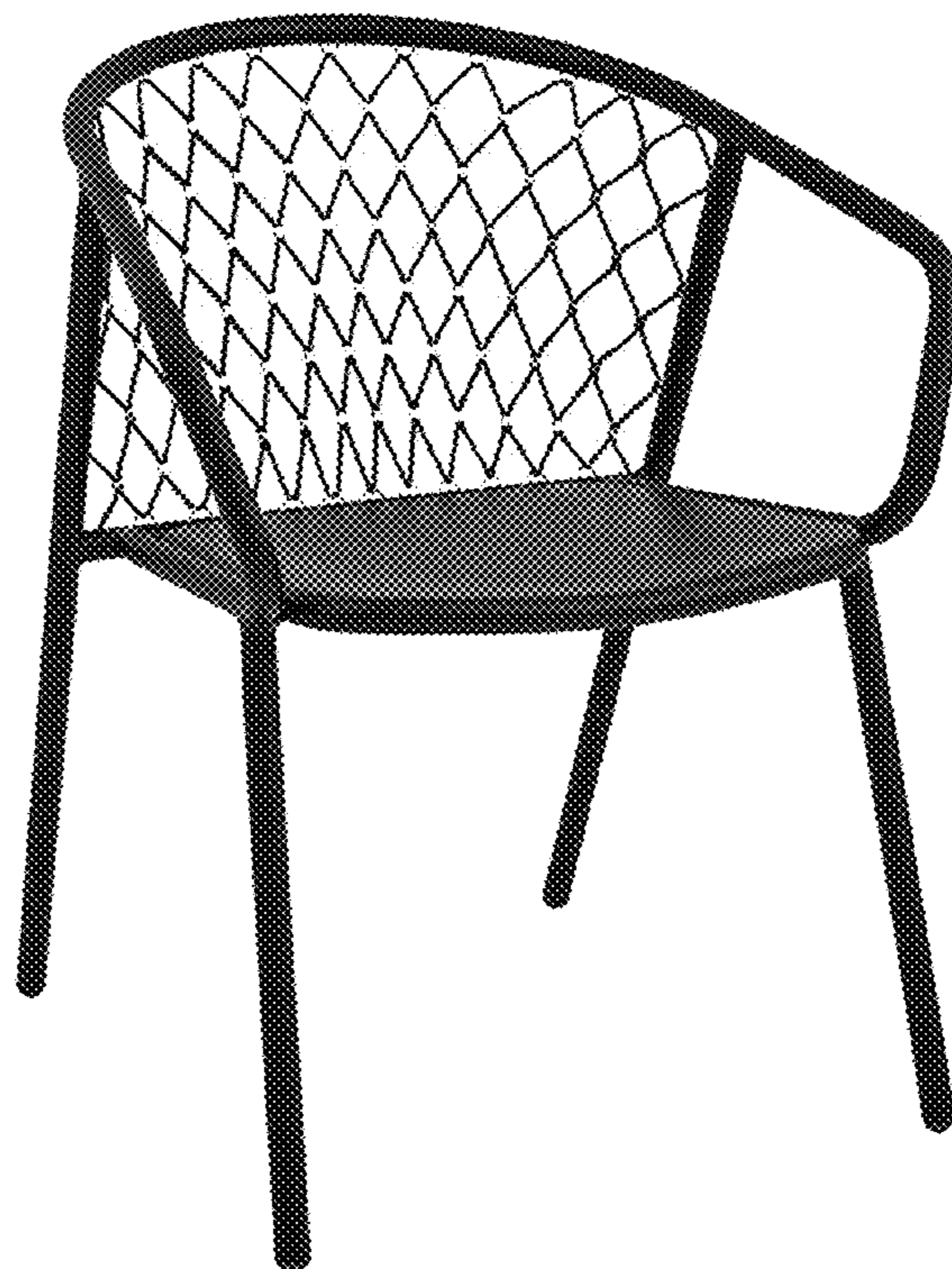

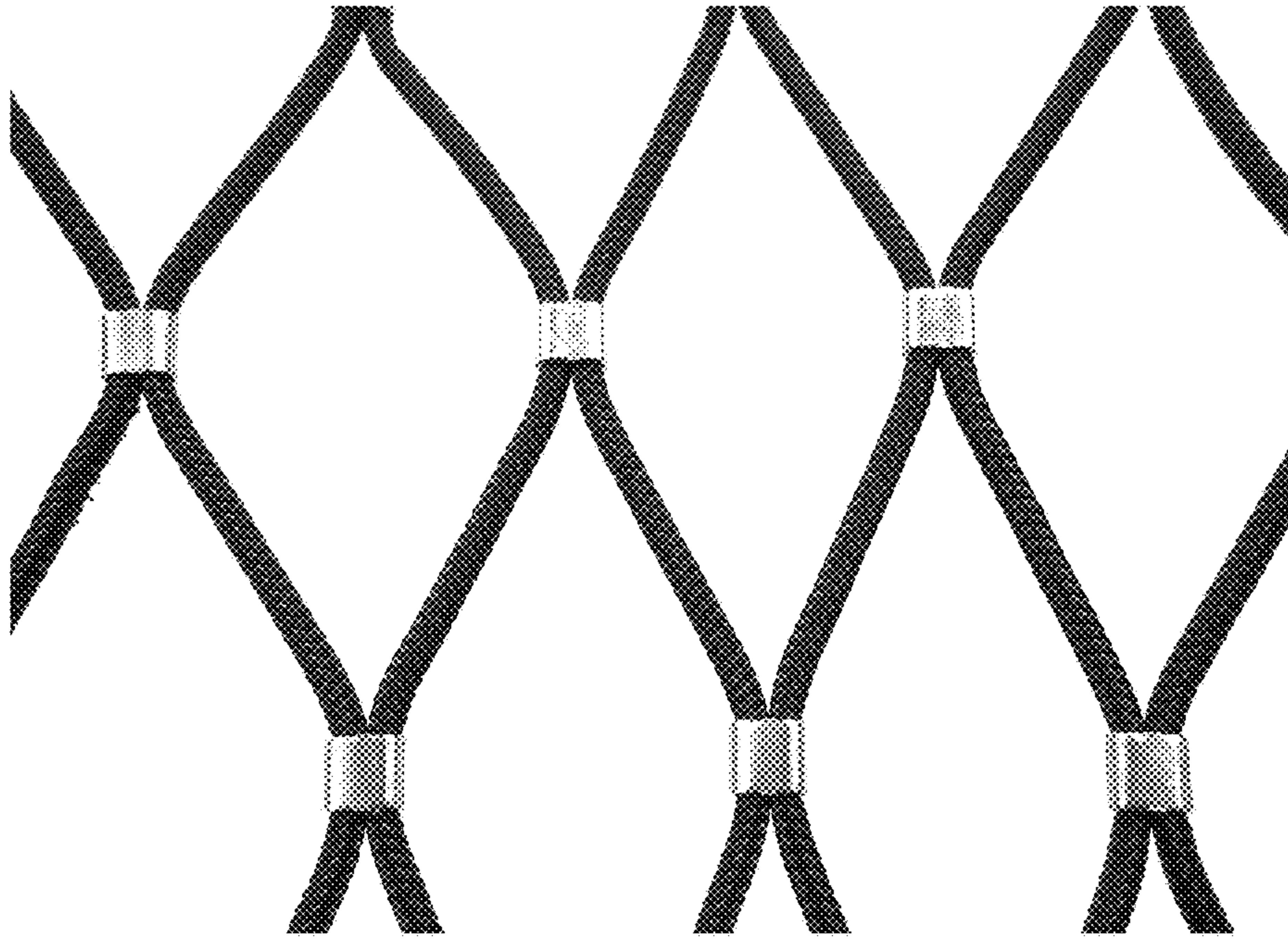

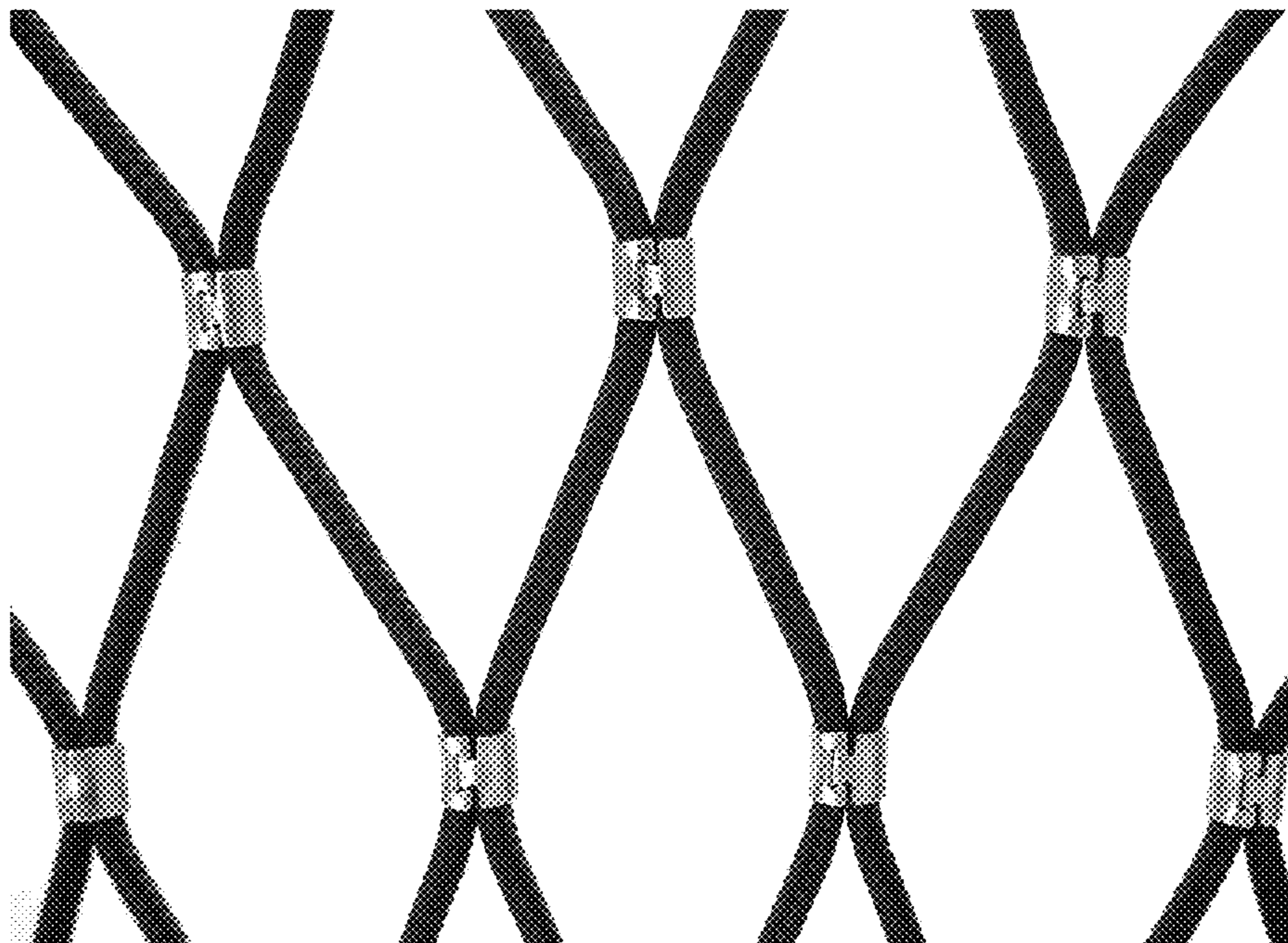
