The ornamental design for a seat cushion, as shown and described.

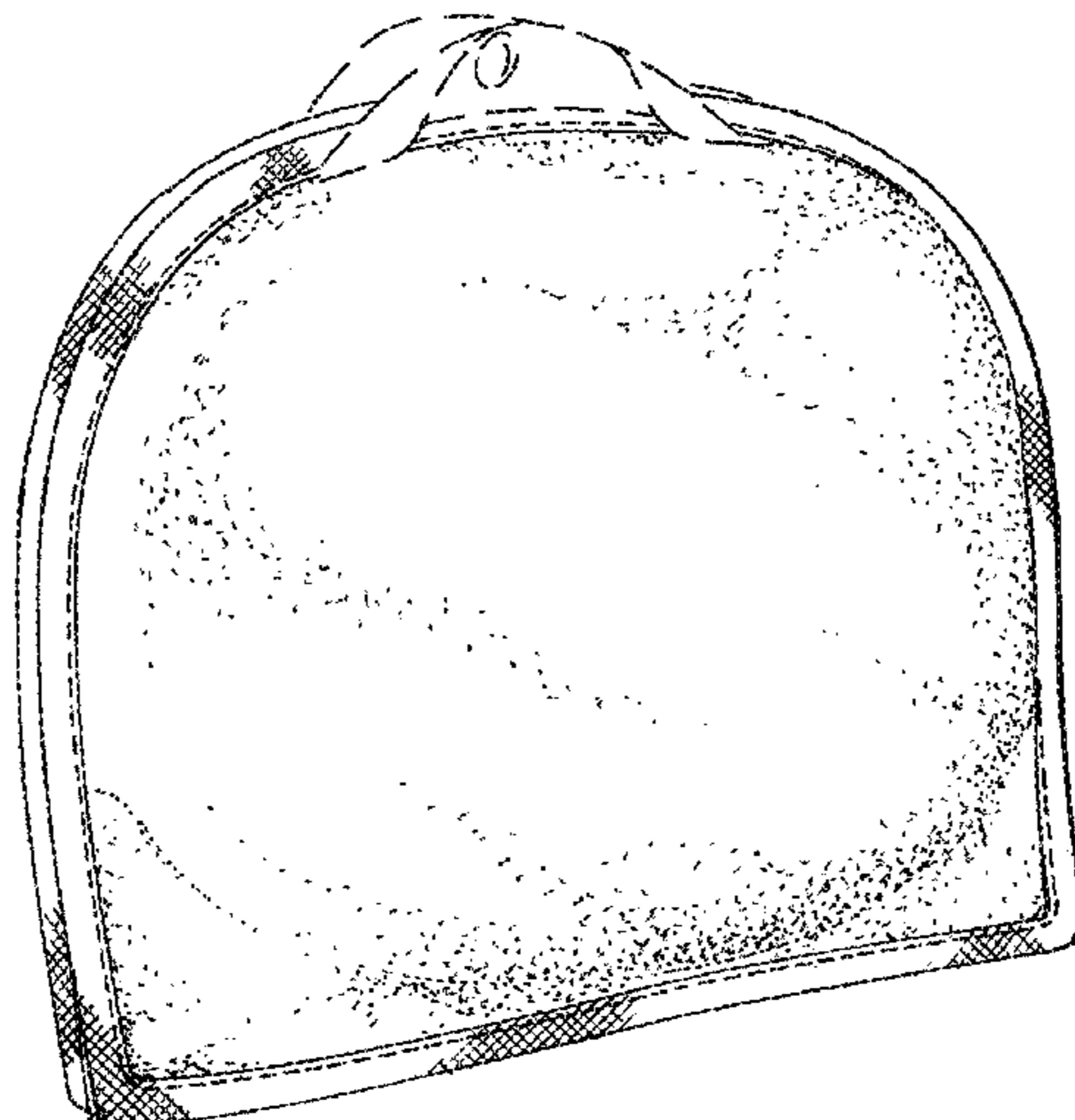
**DESCRIPTION**

FIG. 1 is a perspective view of a seat cushion of my design in a closed position;

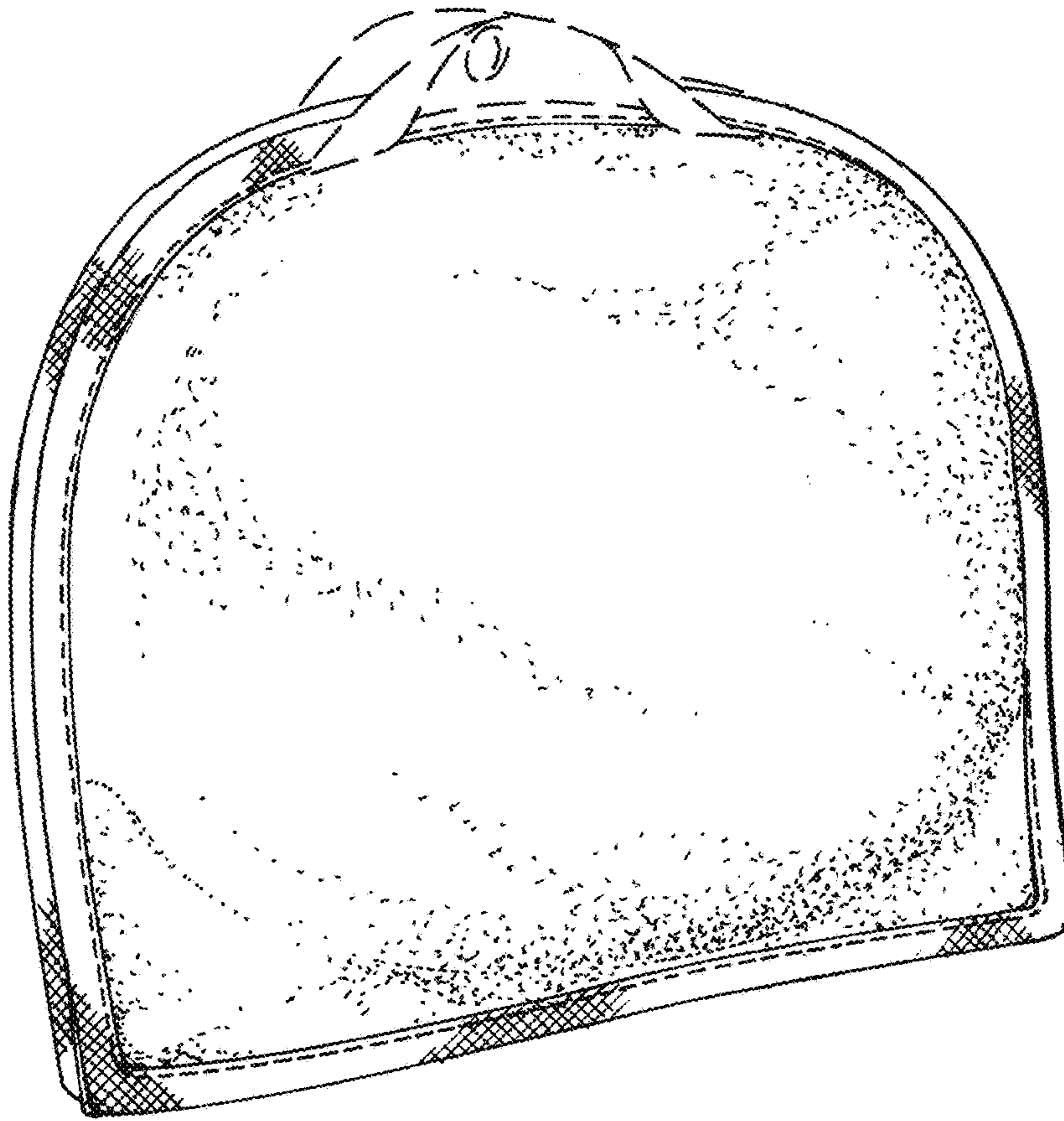

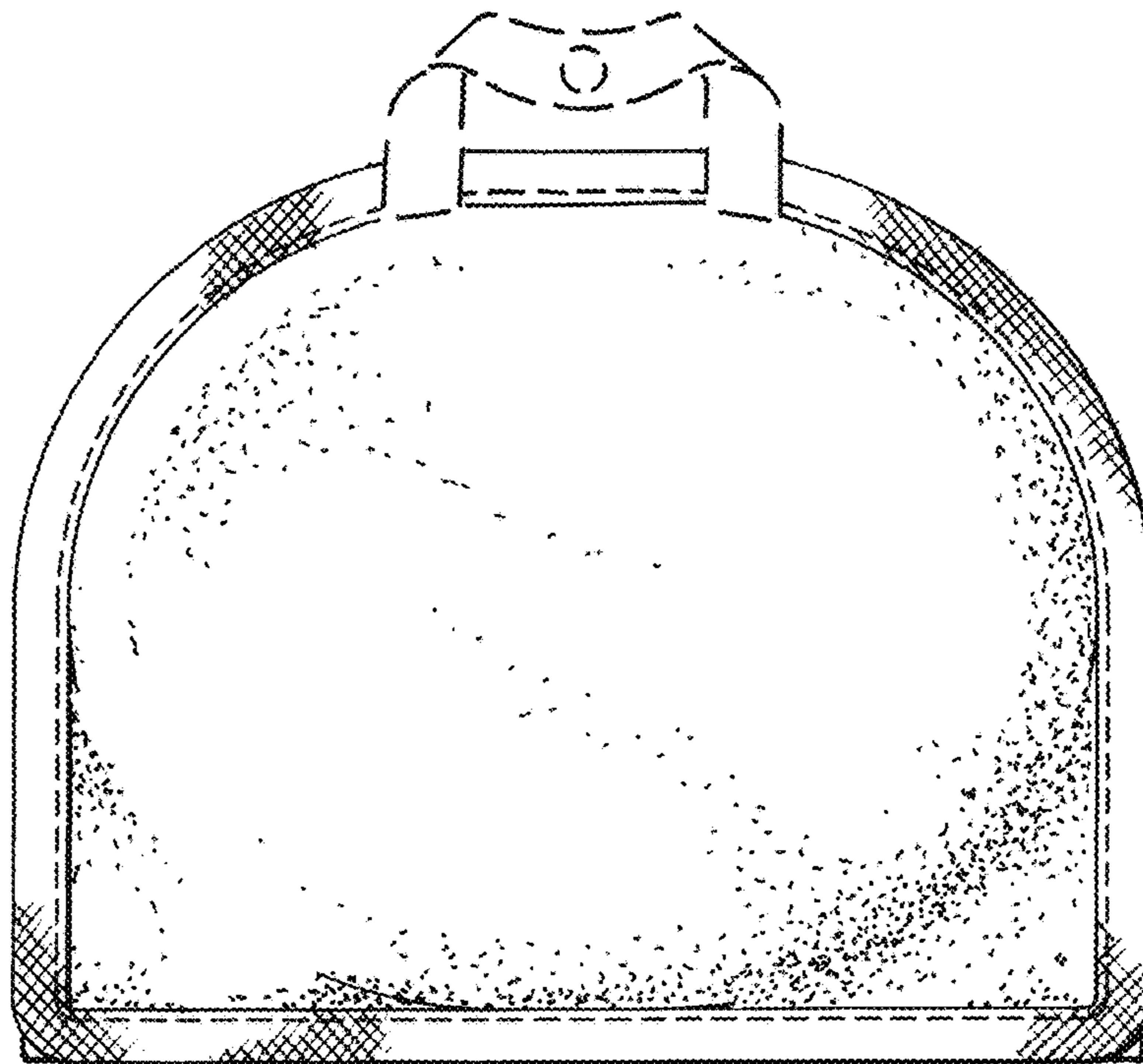

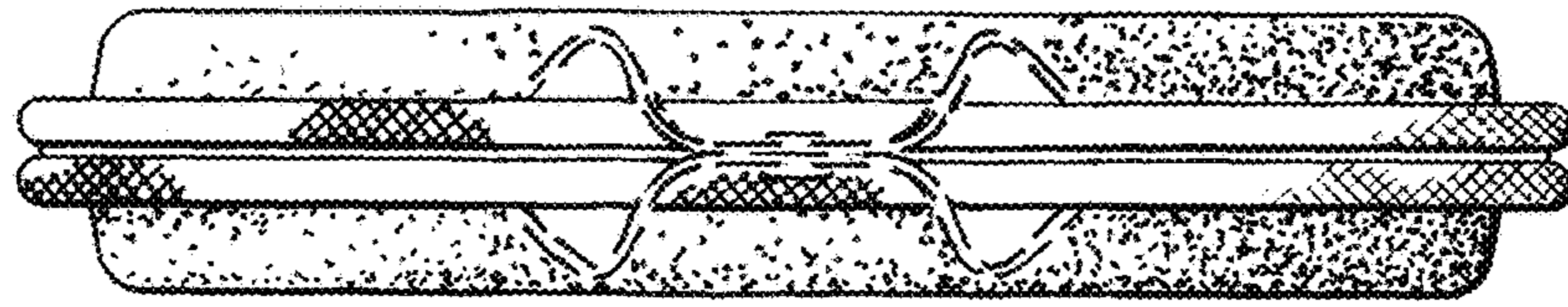

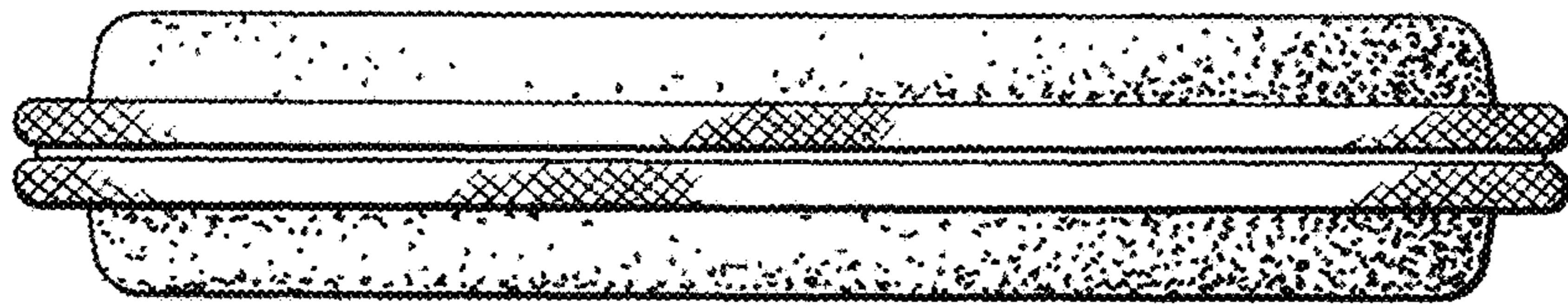

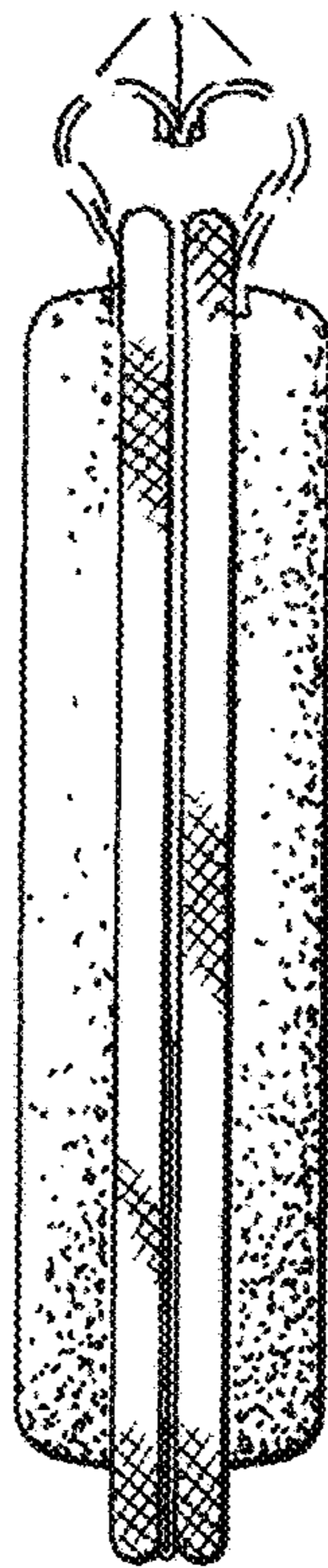

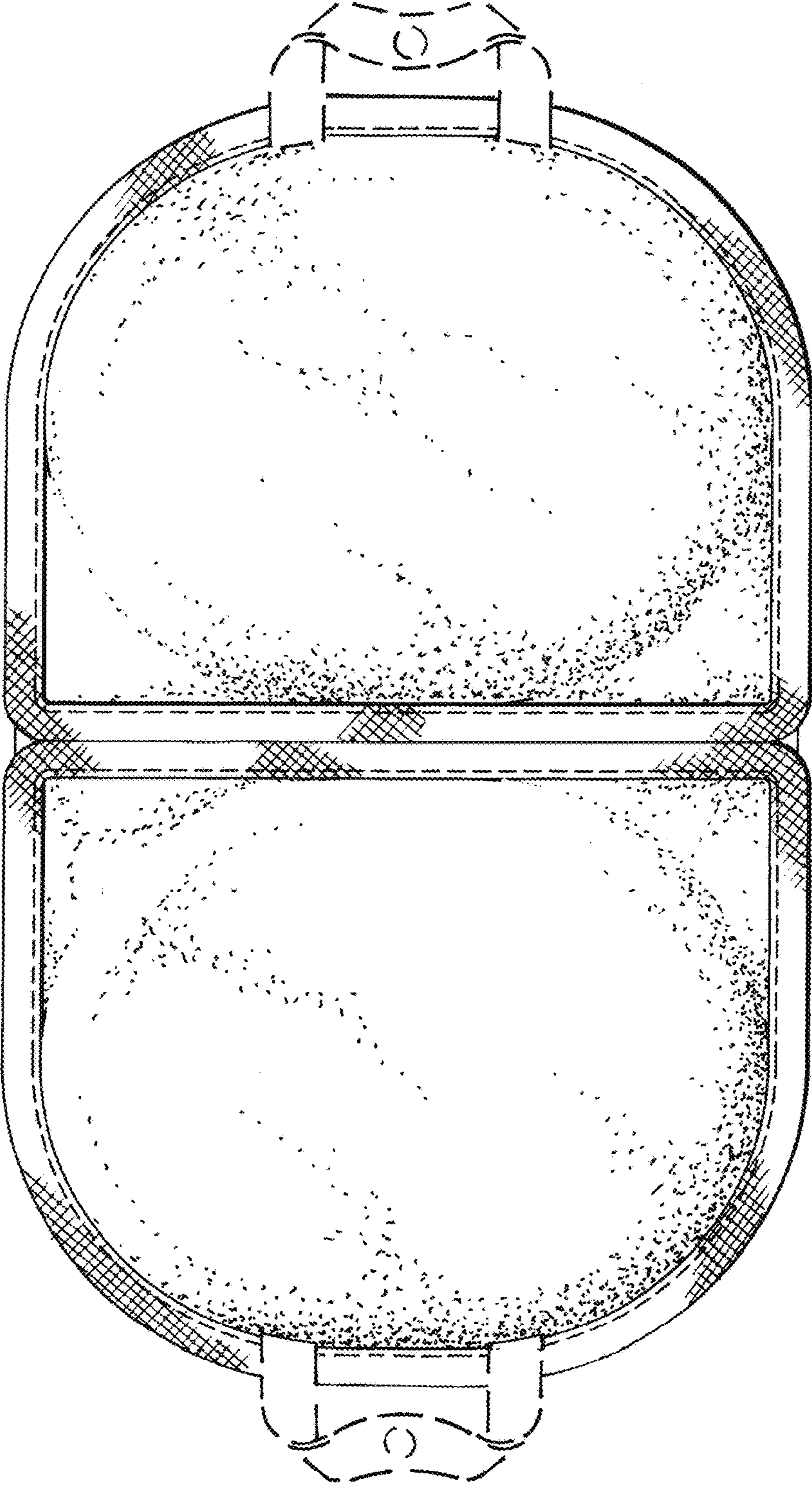

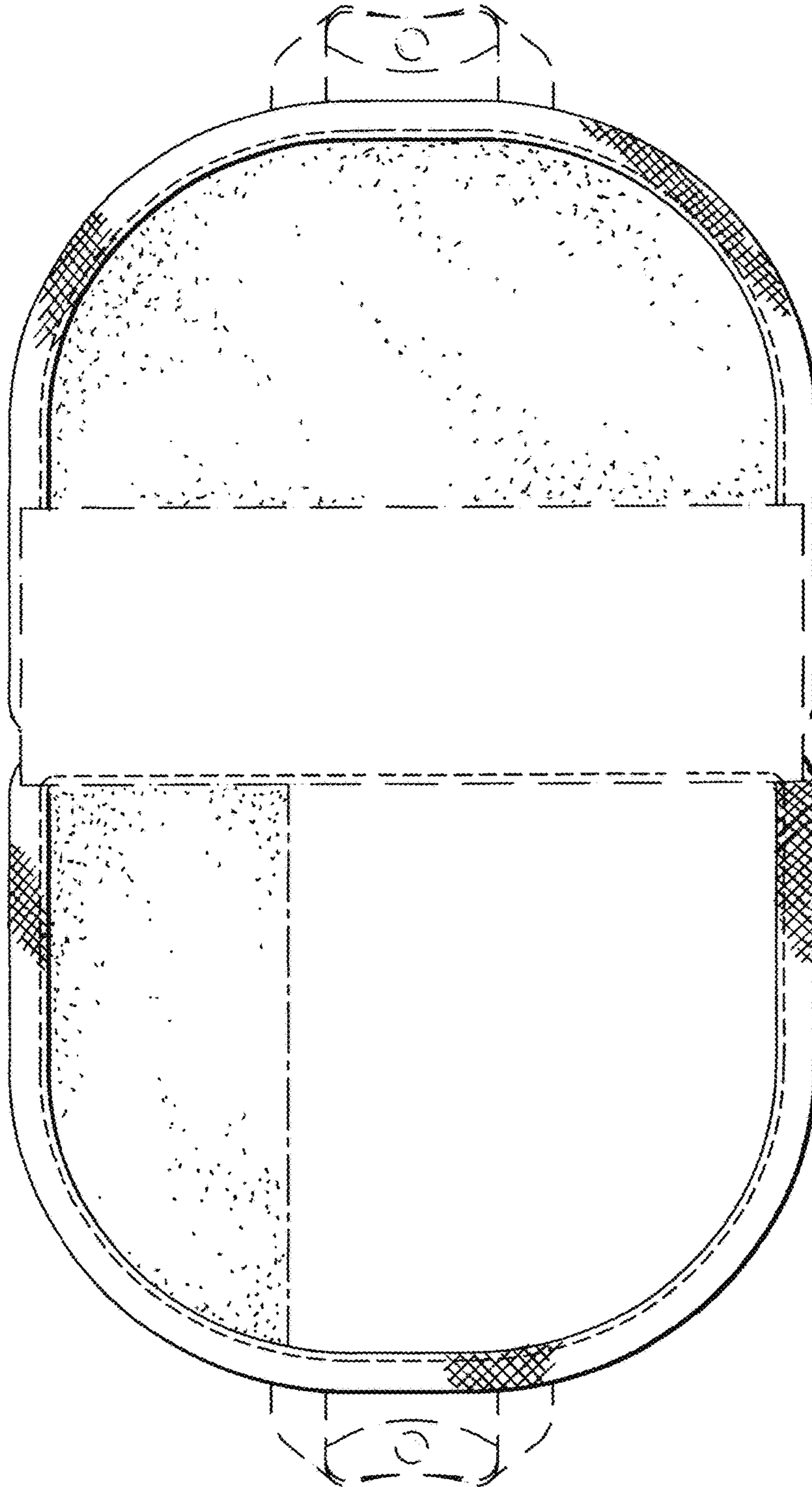

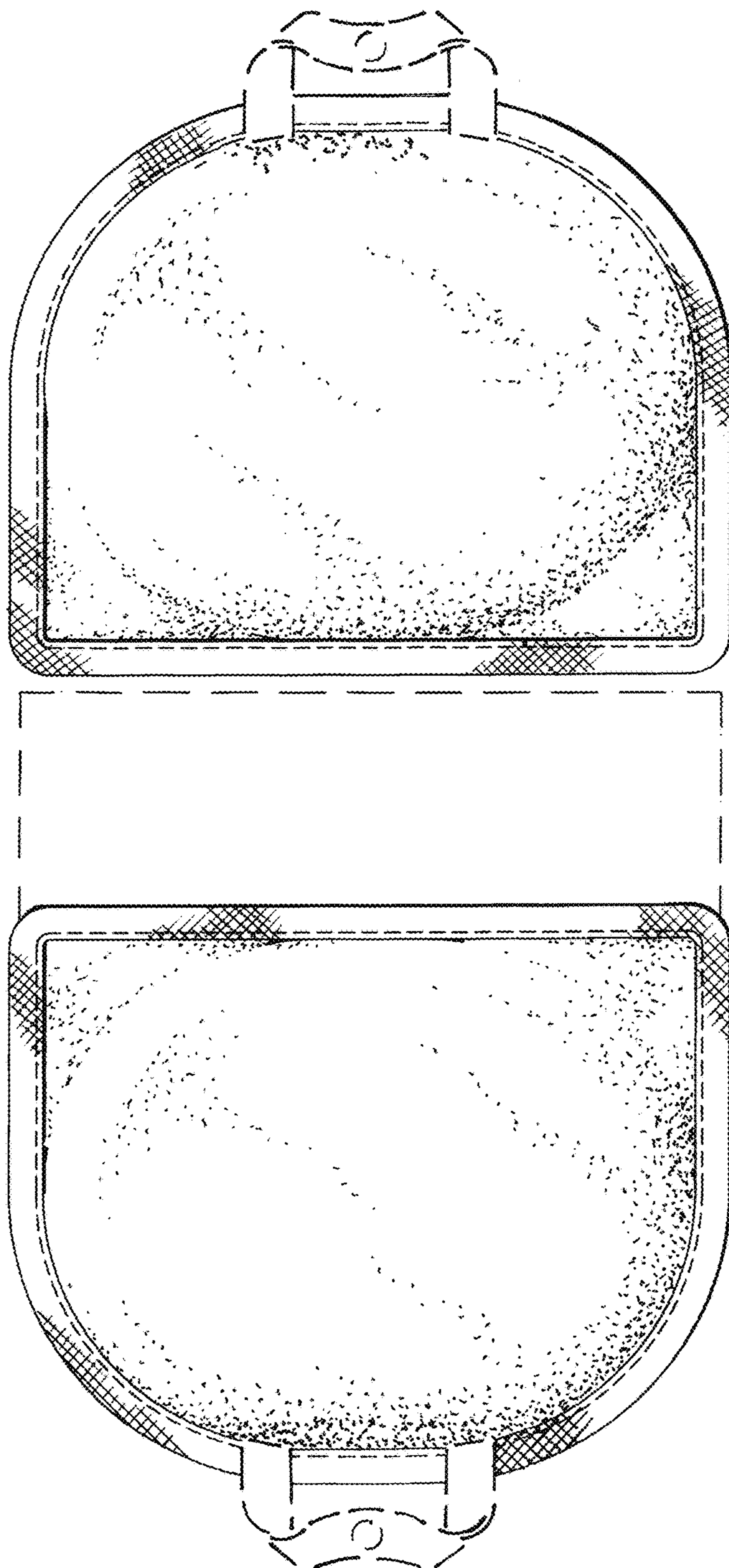

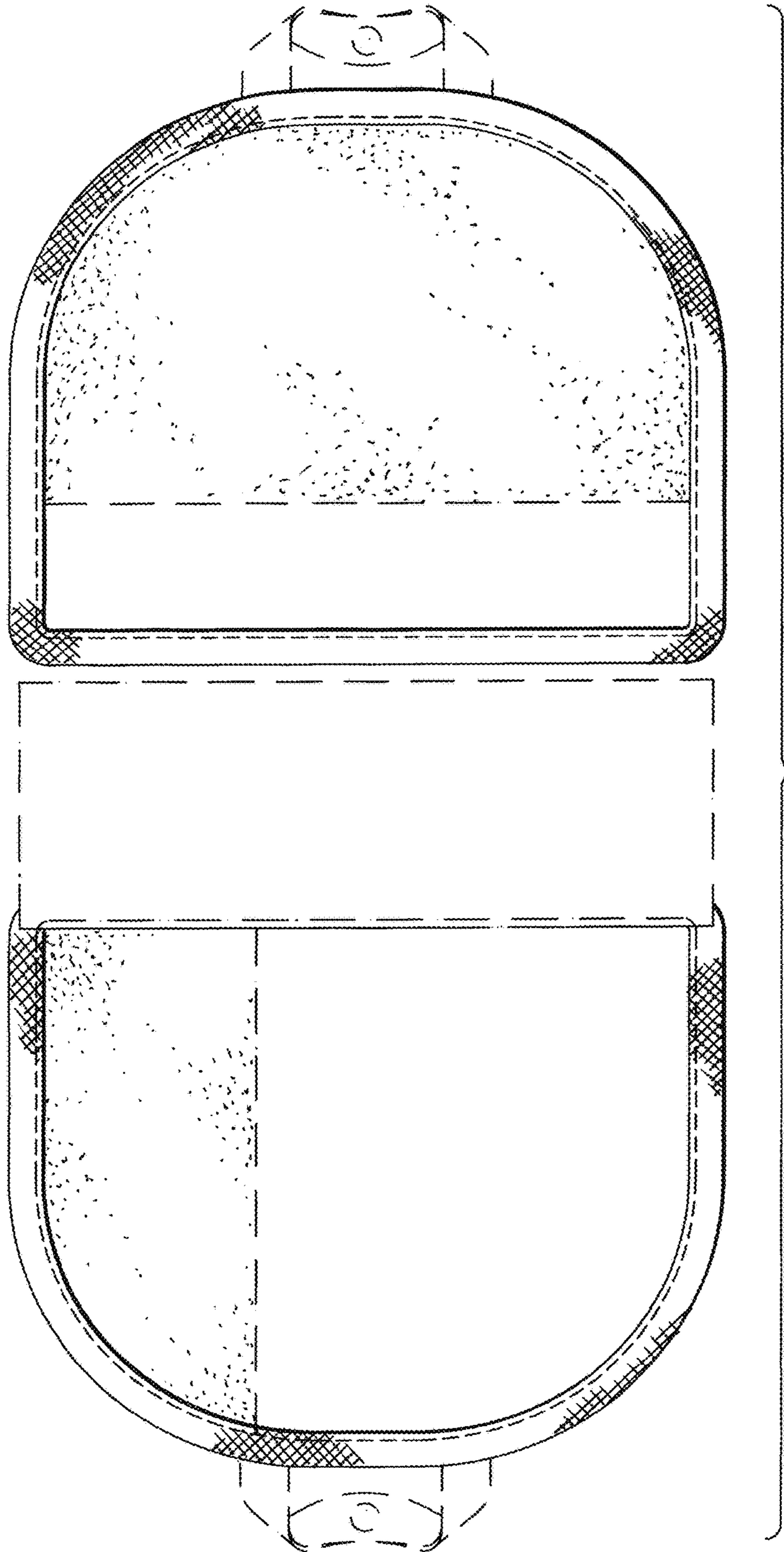

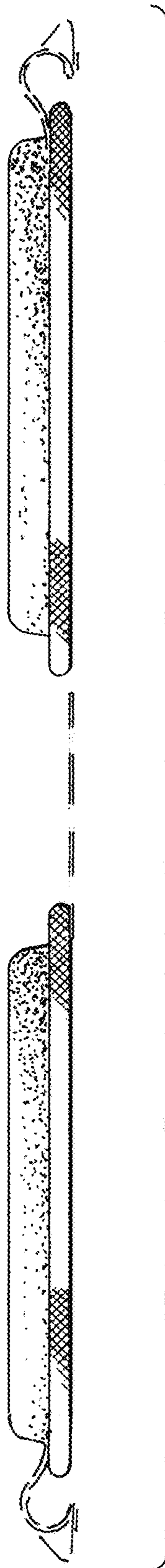
