**DESCRIPTION**

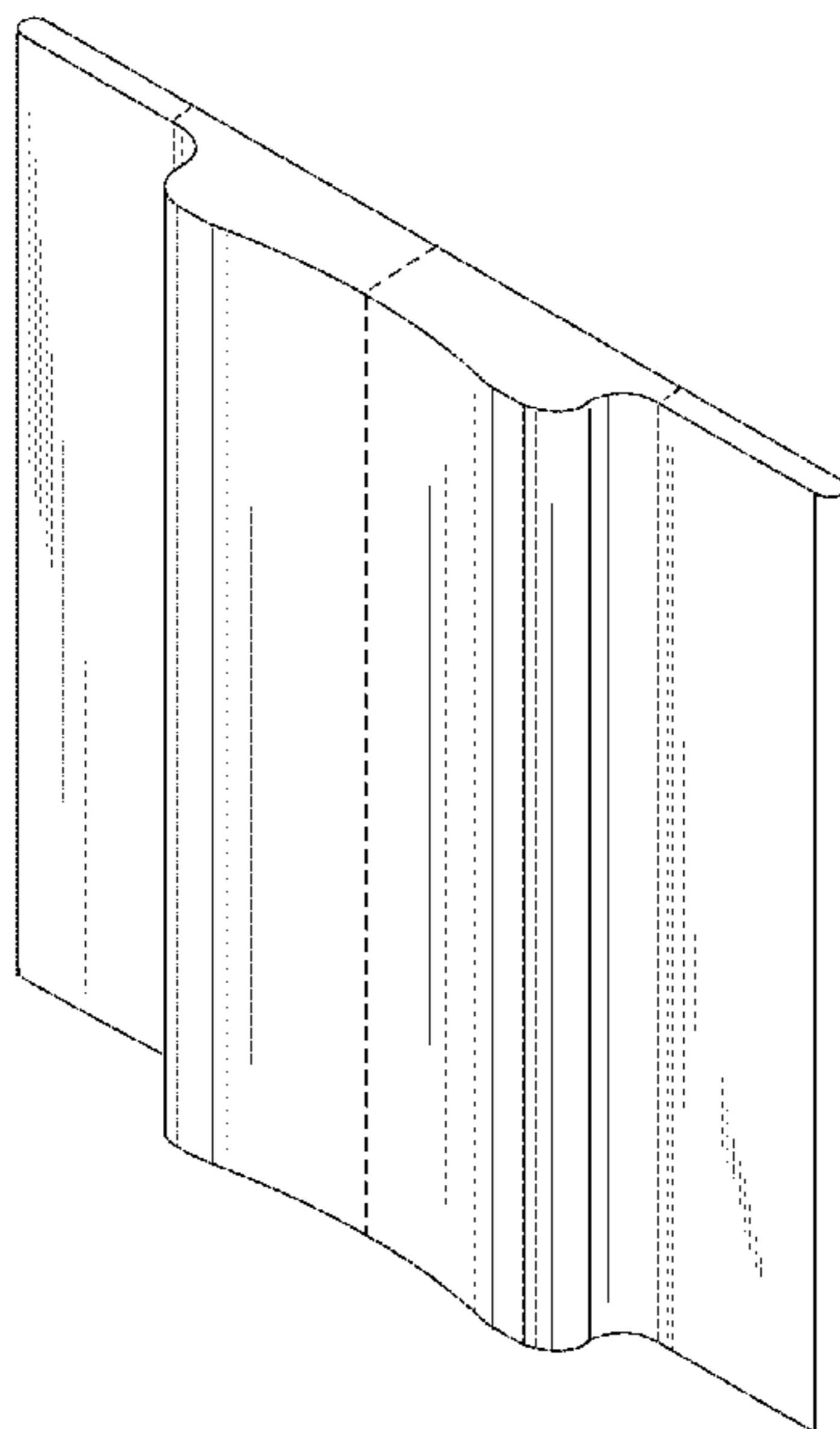
FIG. 1 is a perspective view of our new design.

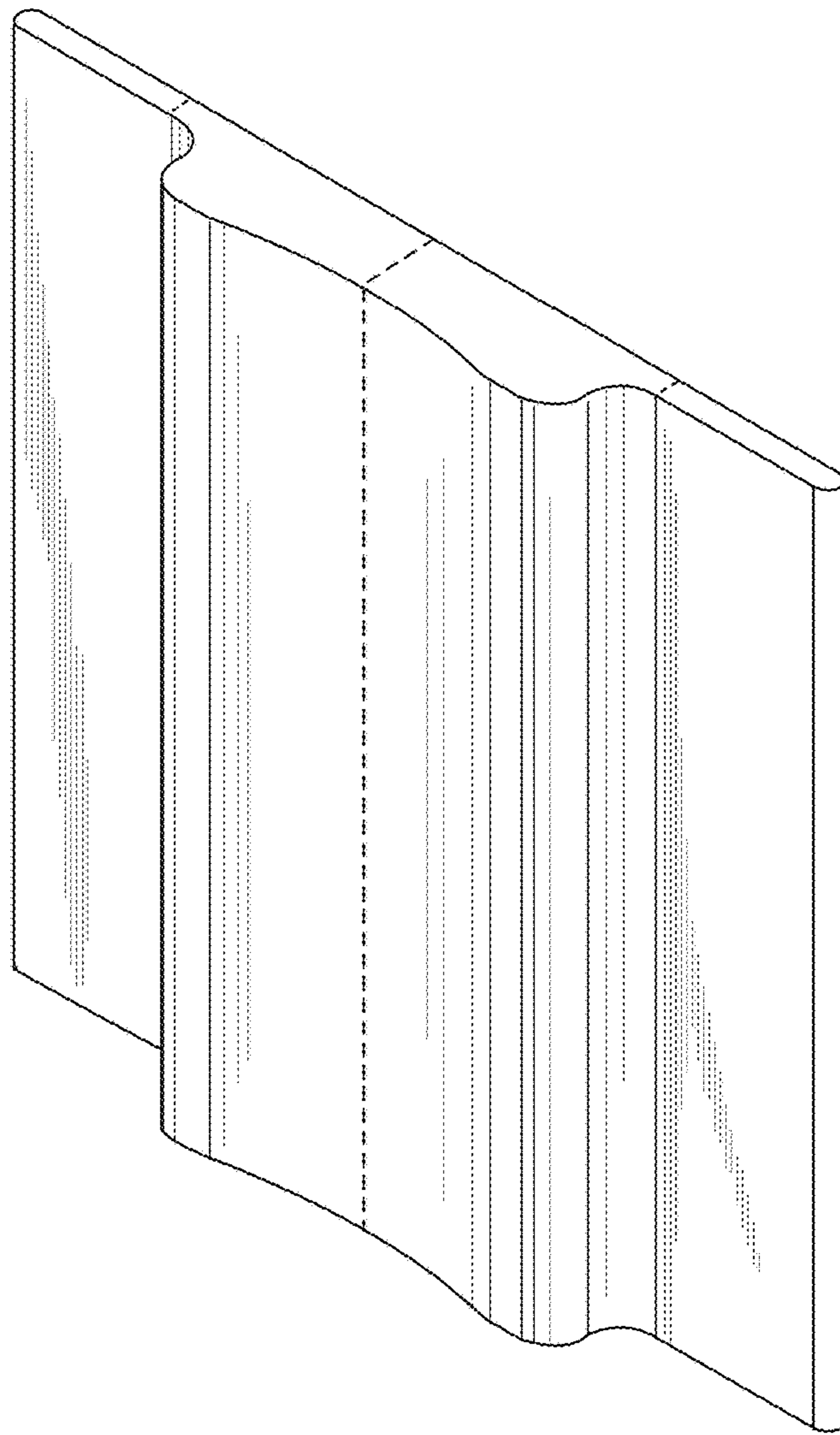

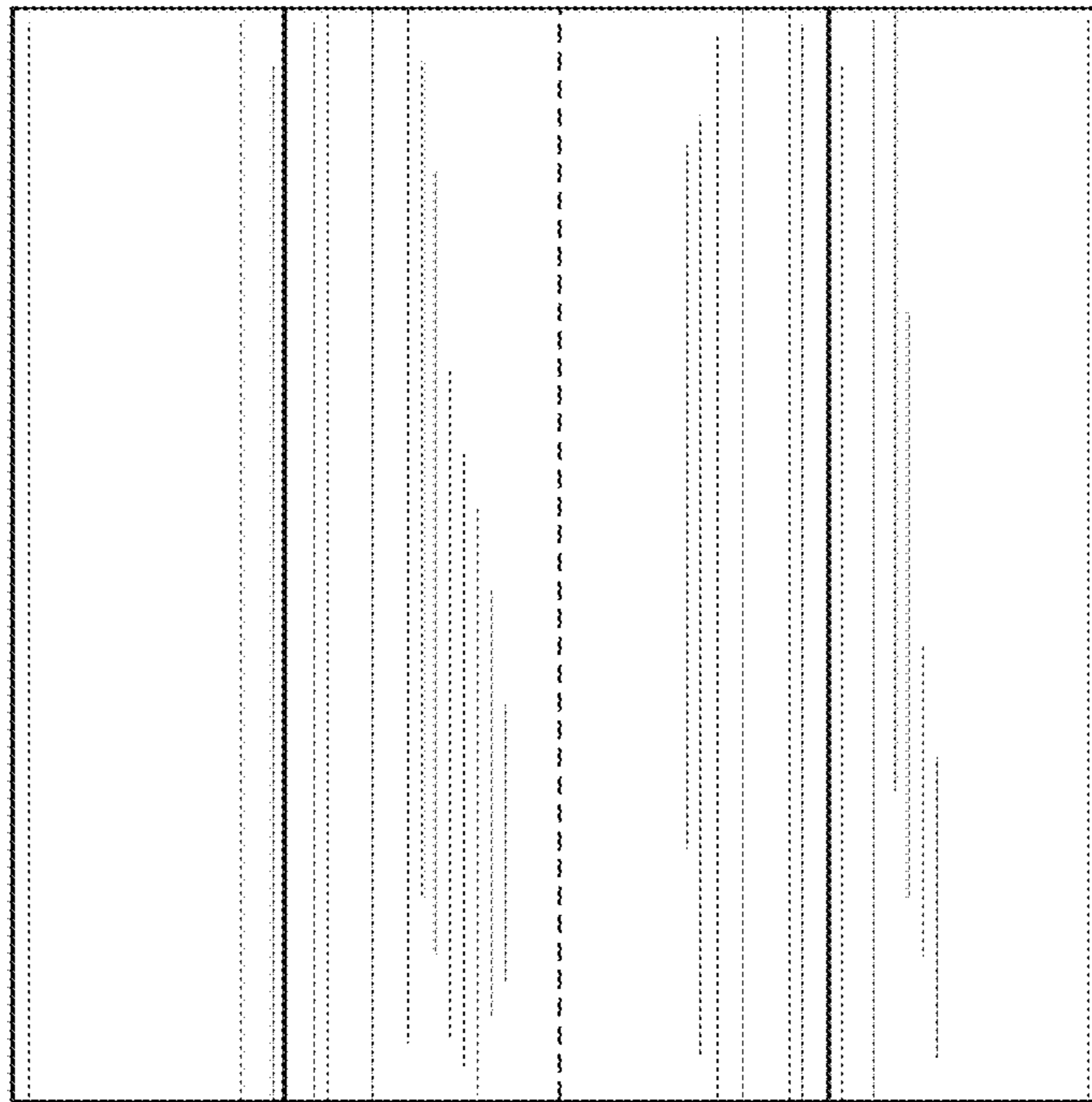
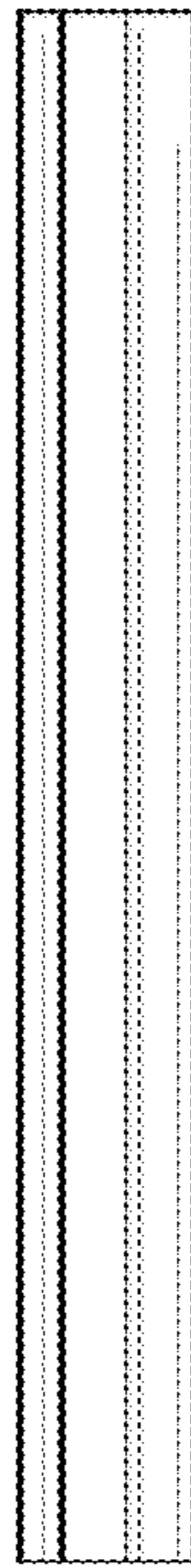

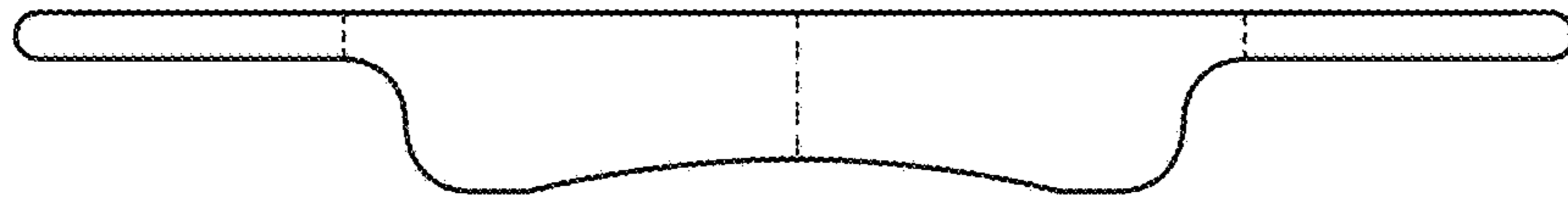

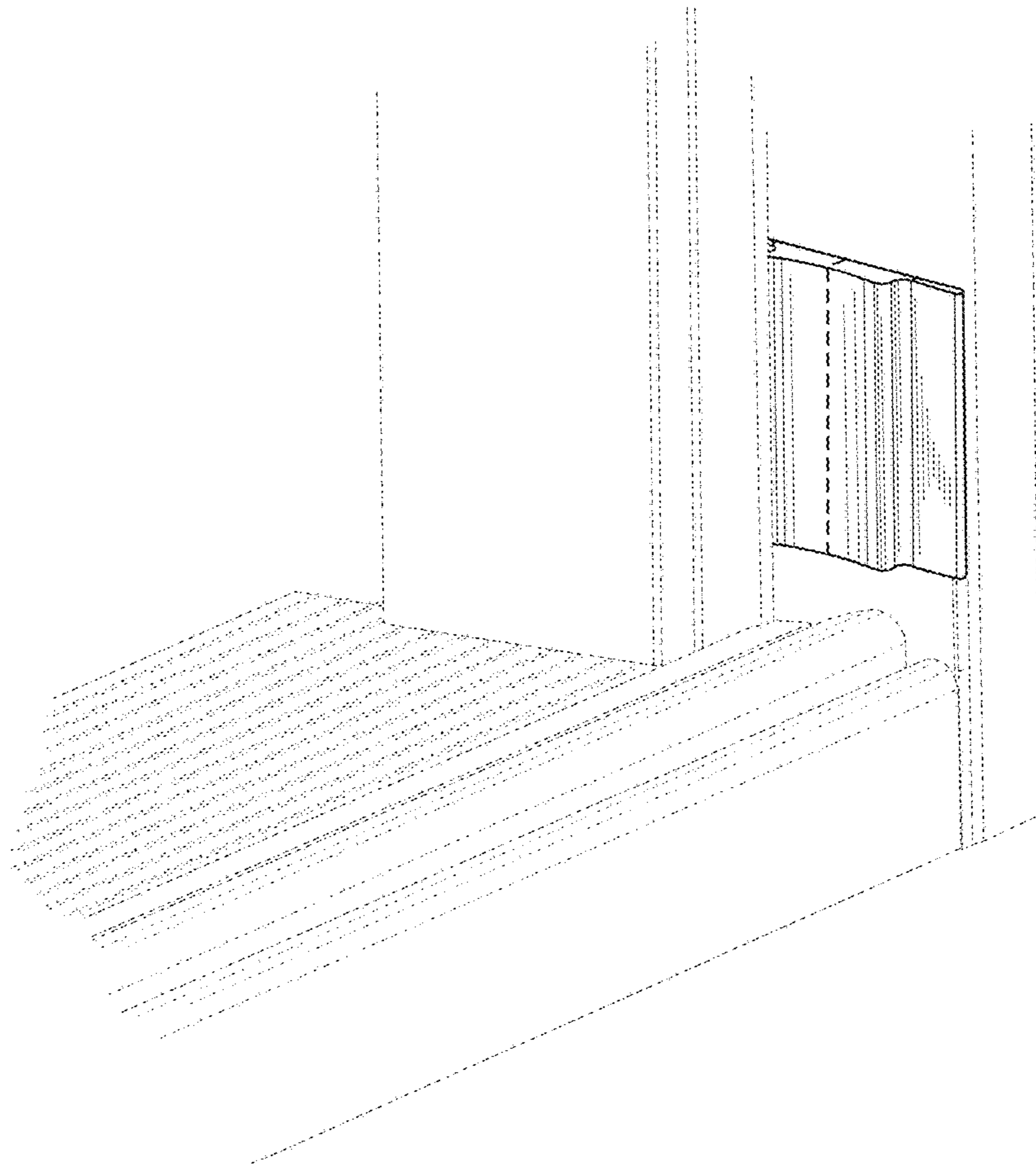
