DESCRIPTION

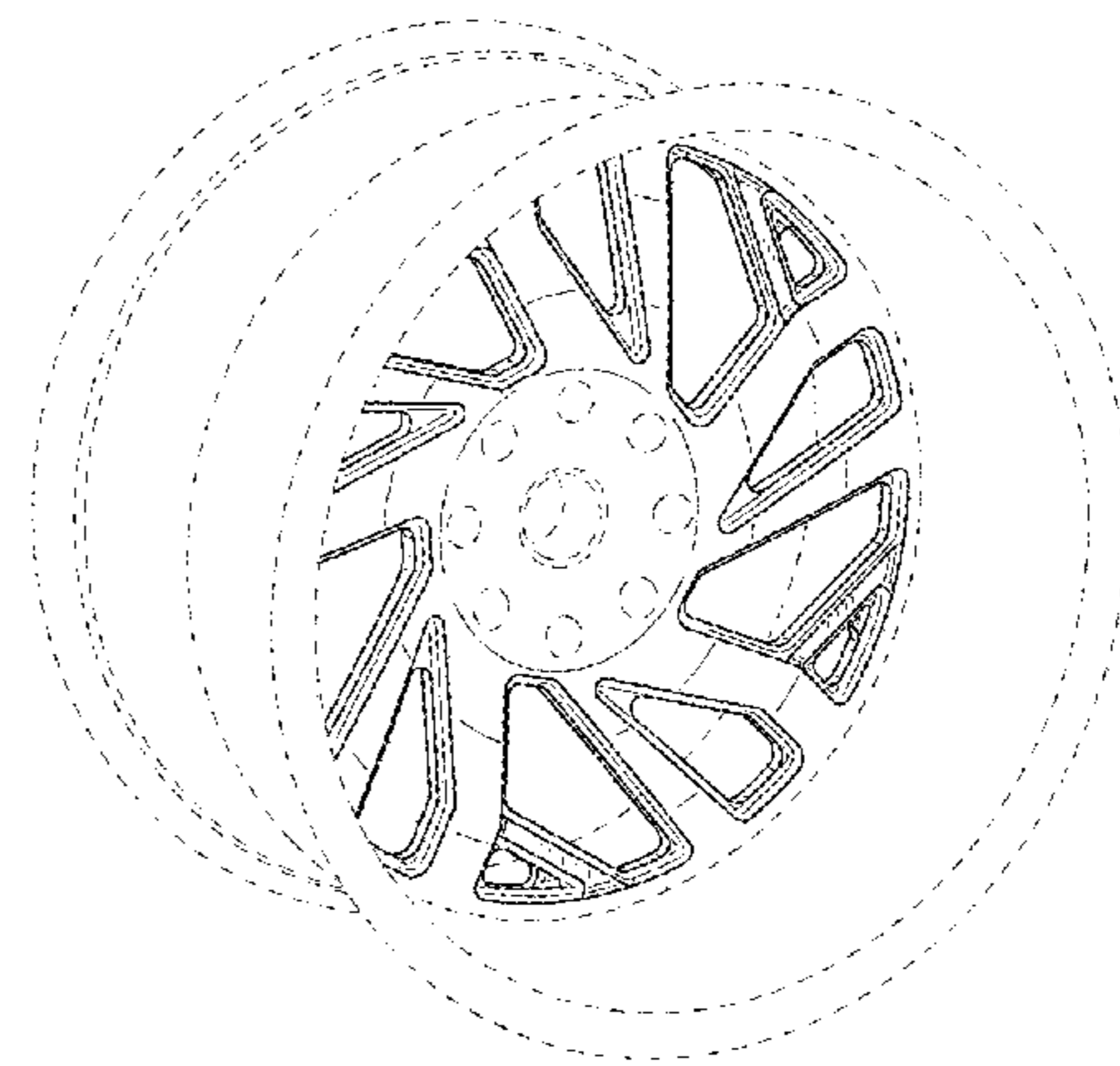
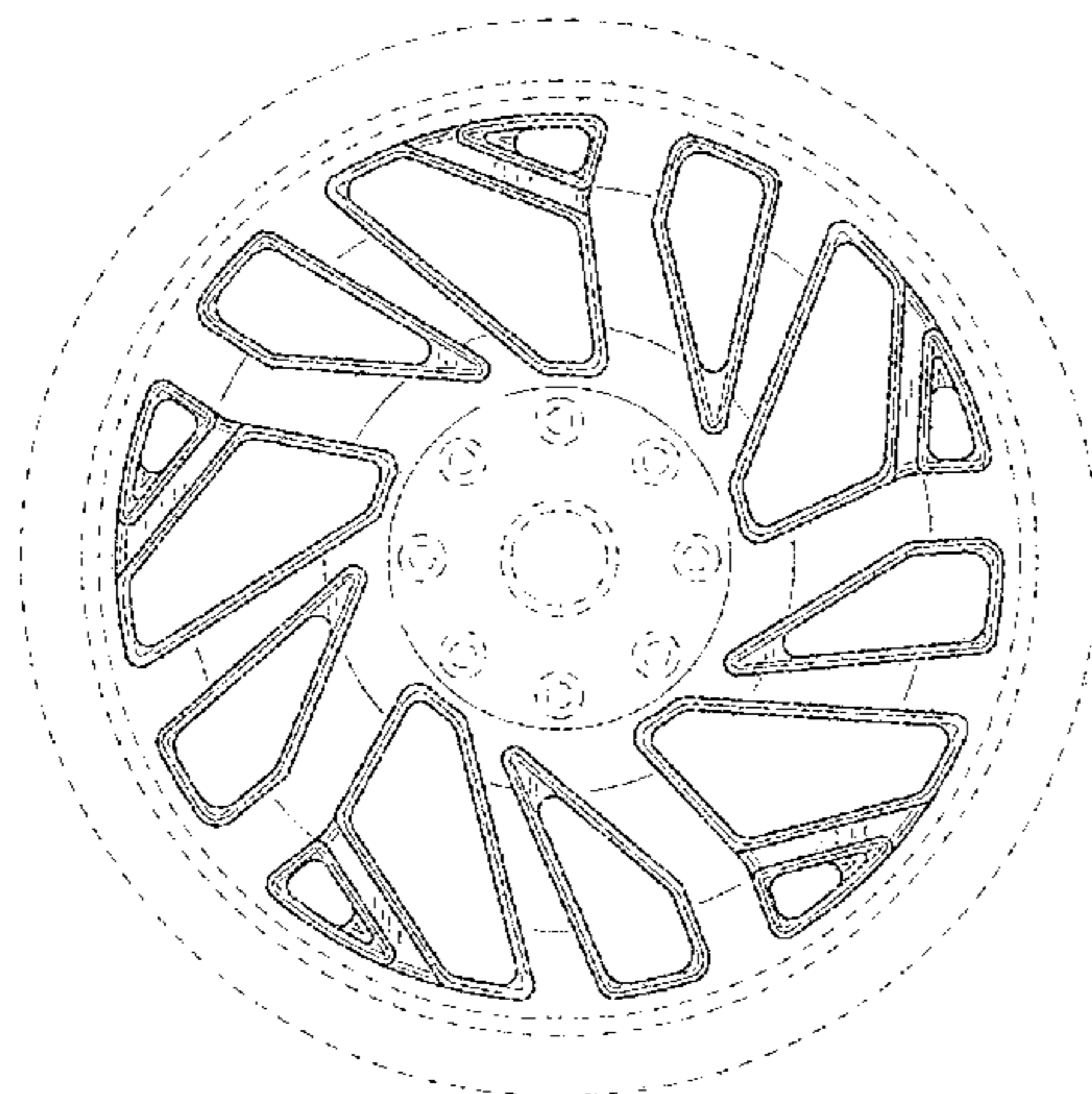
FIG. 1 is a front view of a vehicle wheel showing our new design;

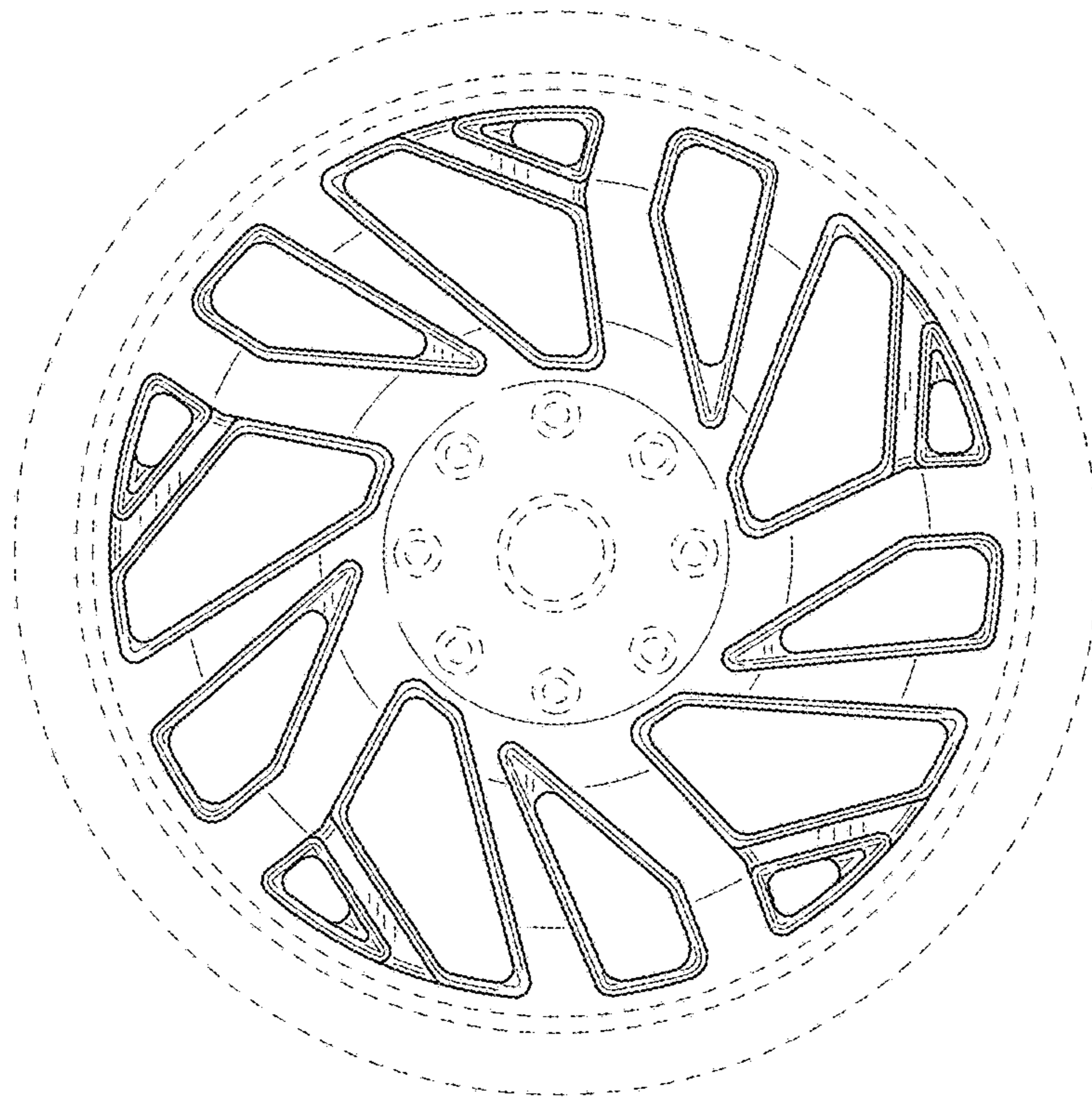

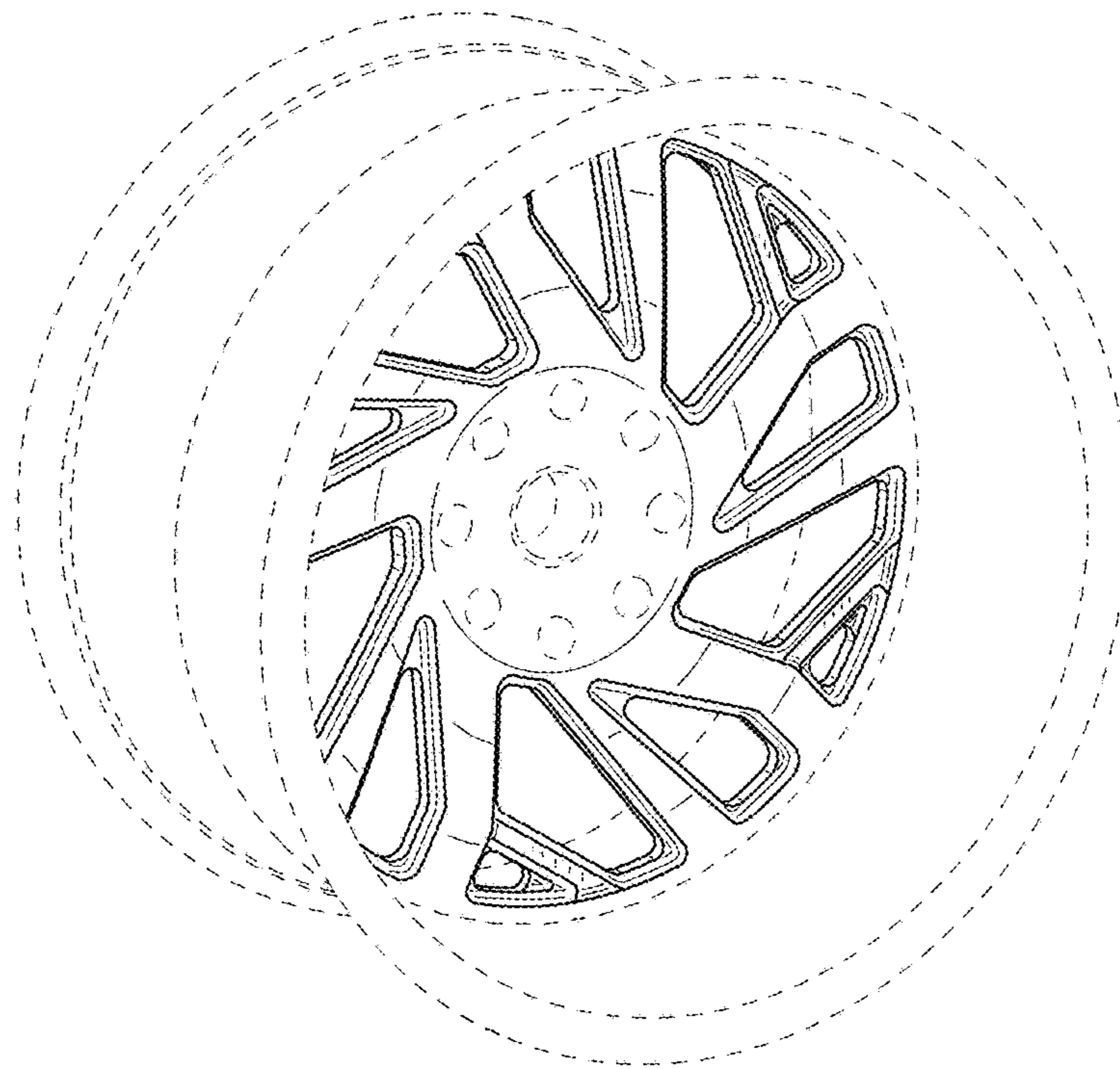

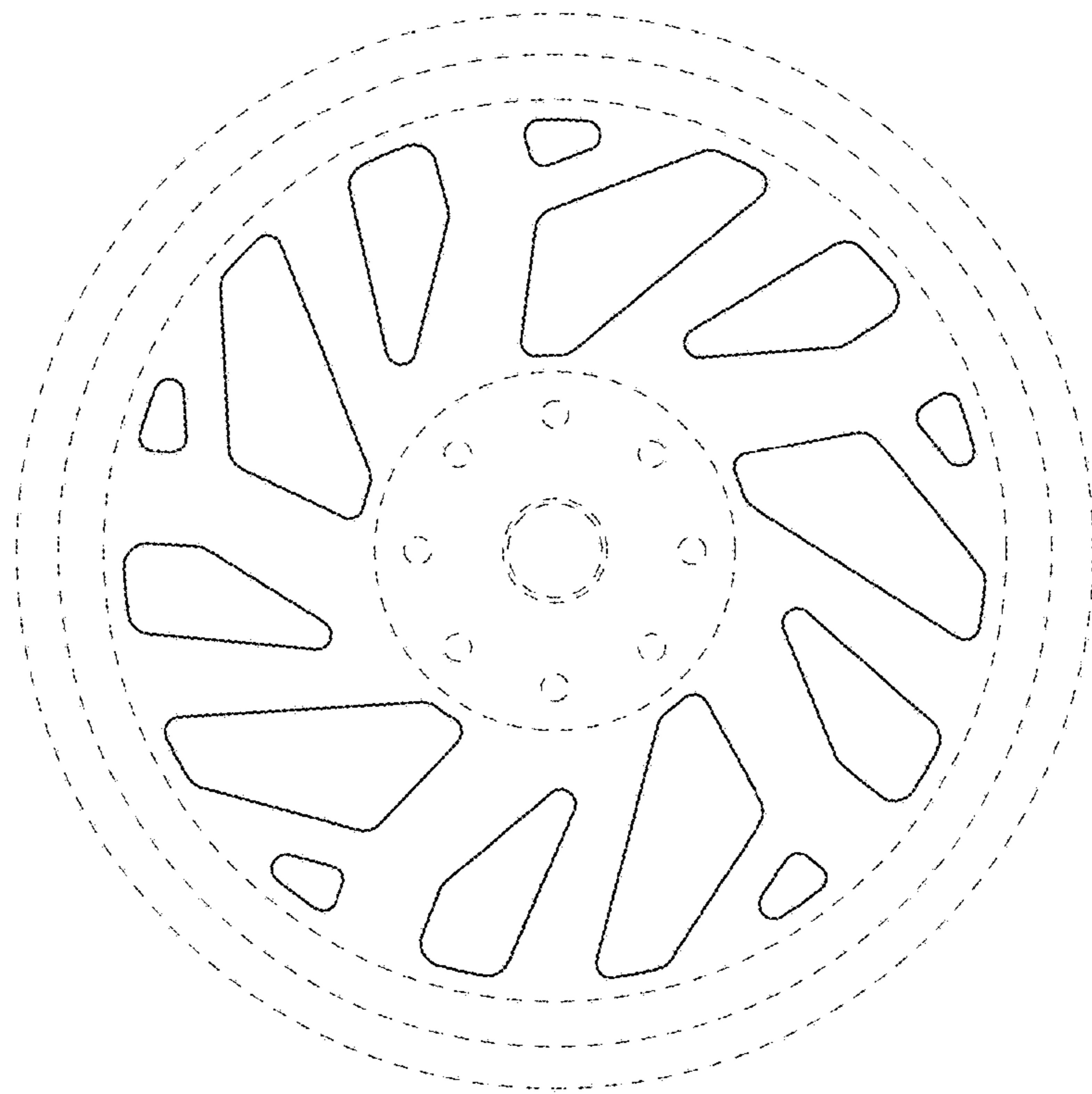
