The ornamental design for a display screen with animated icon, as shown and described.

DESCRIPTION

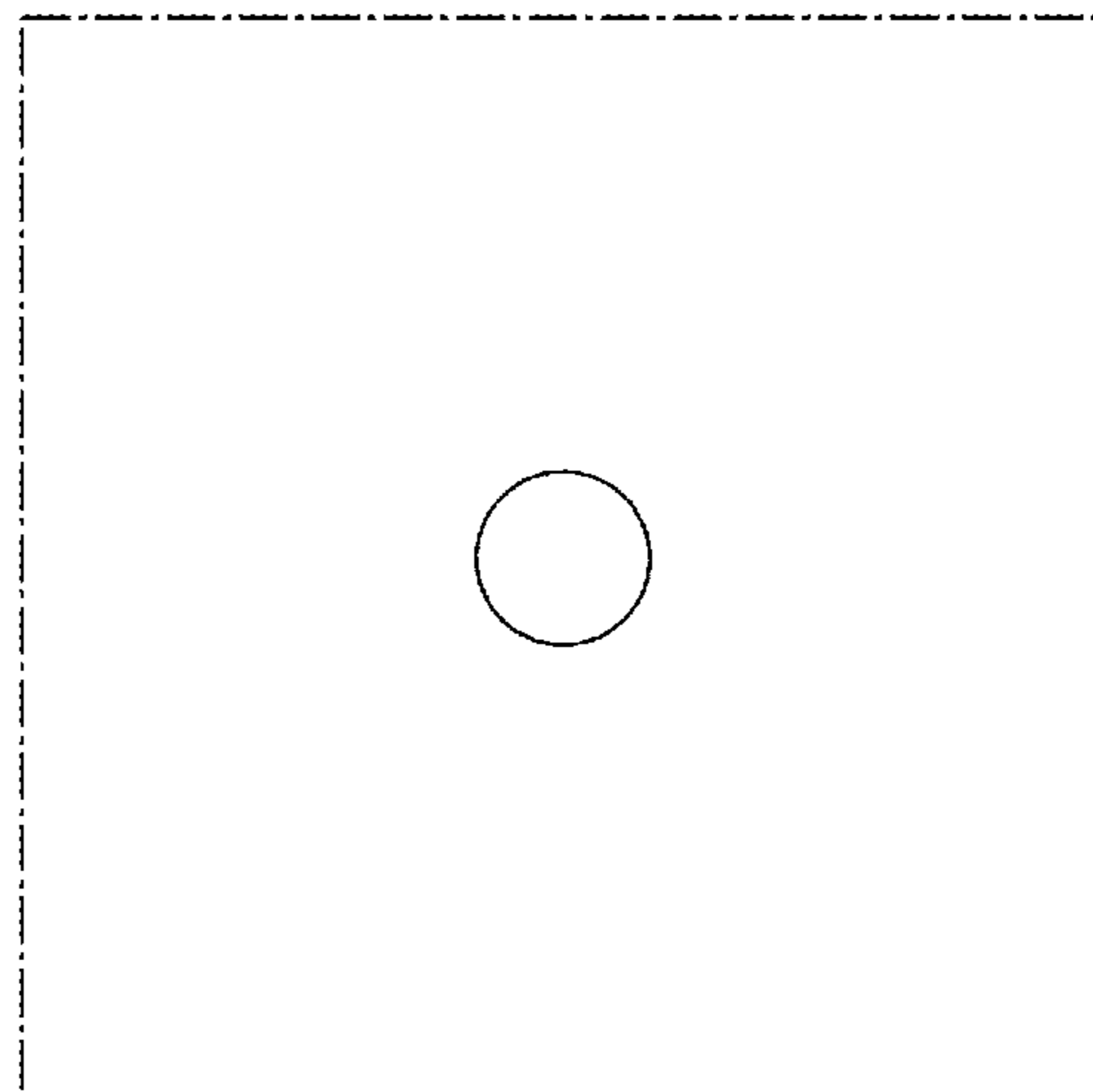
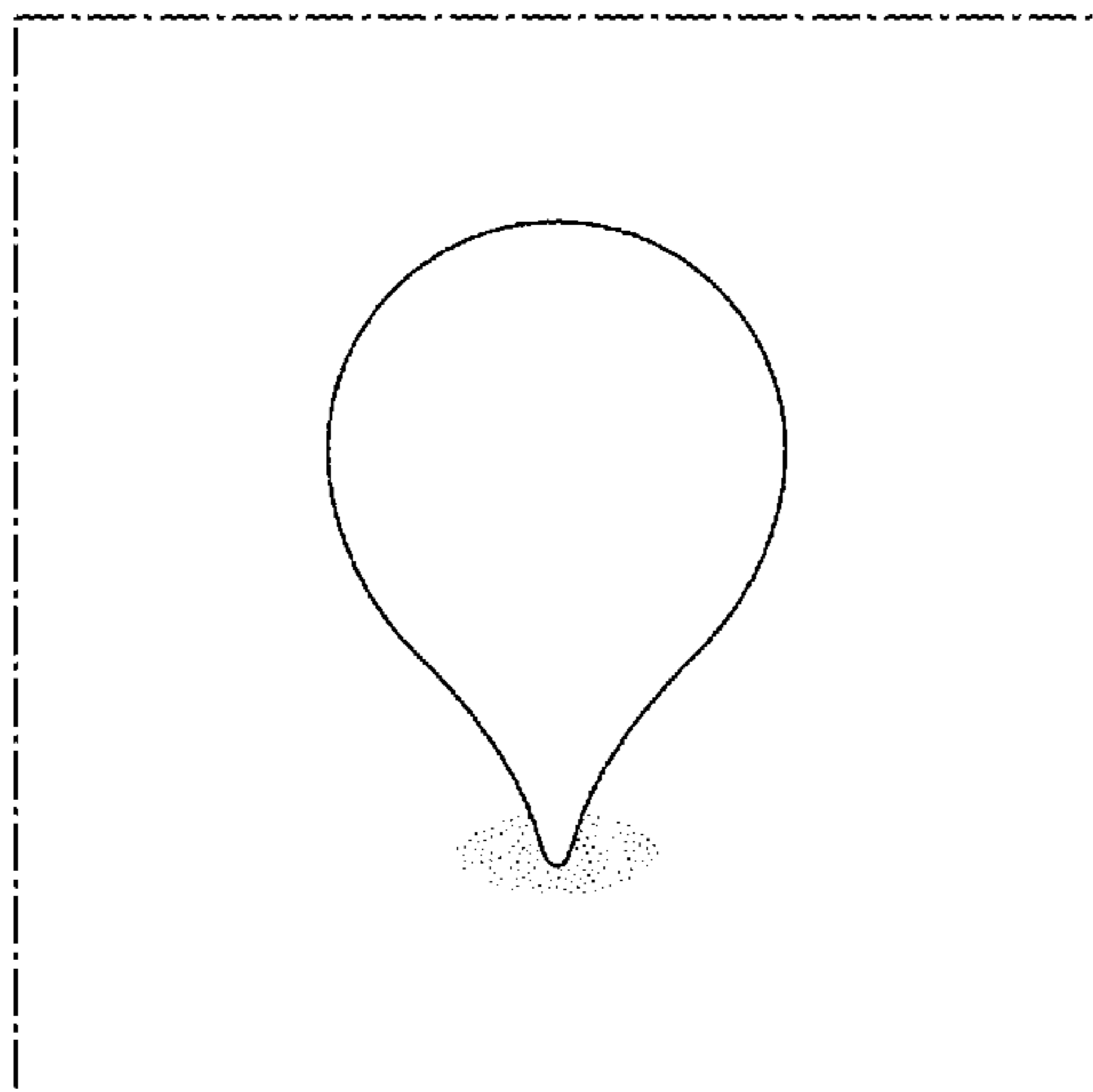
FIG. 1 is a front view of a first image in a sequence of a display screen with animated icon, showing our new design; and,

FIG. 2 is a front view of a second image in a sequence thereof.

The appearance of the animated icon sequentially transitions between the images shown in FIGS. 1-2. The process or period in which one image transitions to another image forms no part of the claimed design.

The broken lines of uneven length show the display screen and form no part of the claimed design.

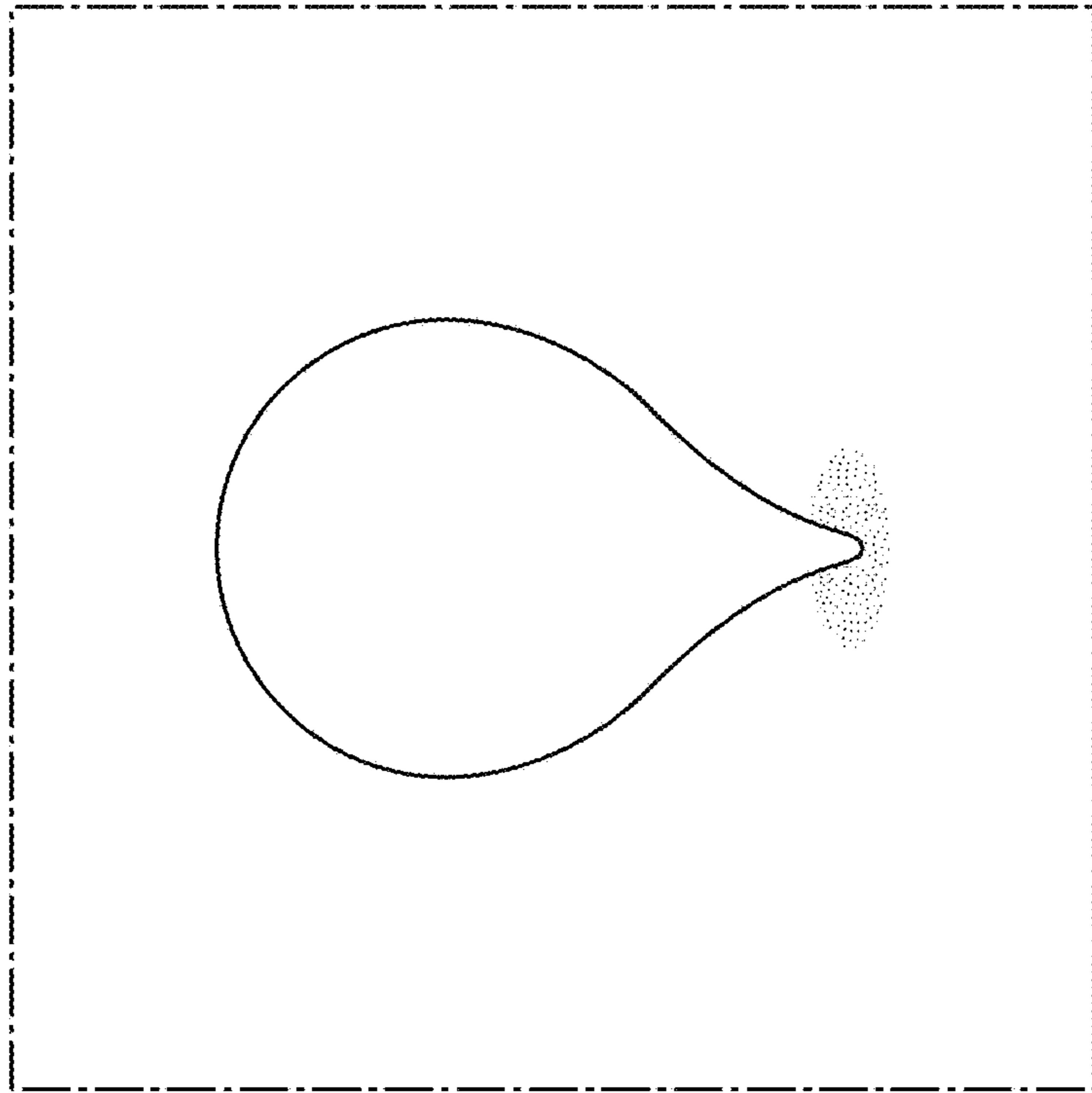

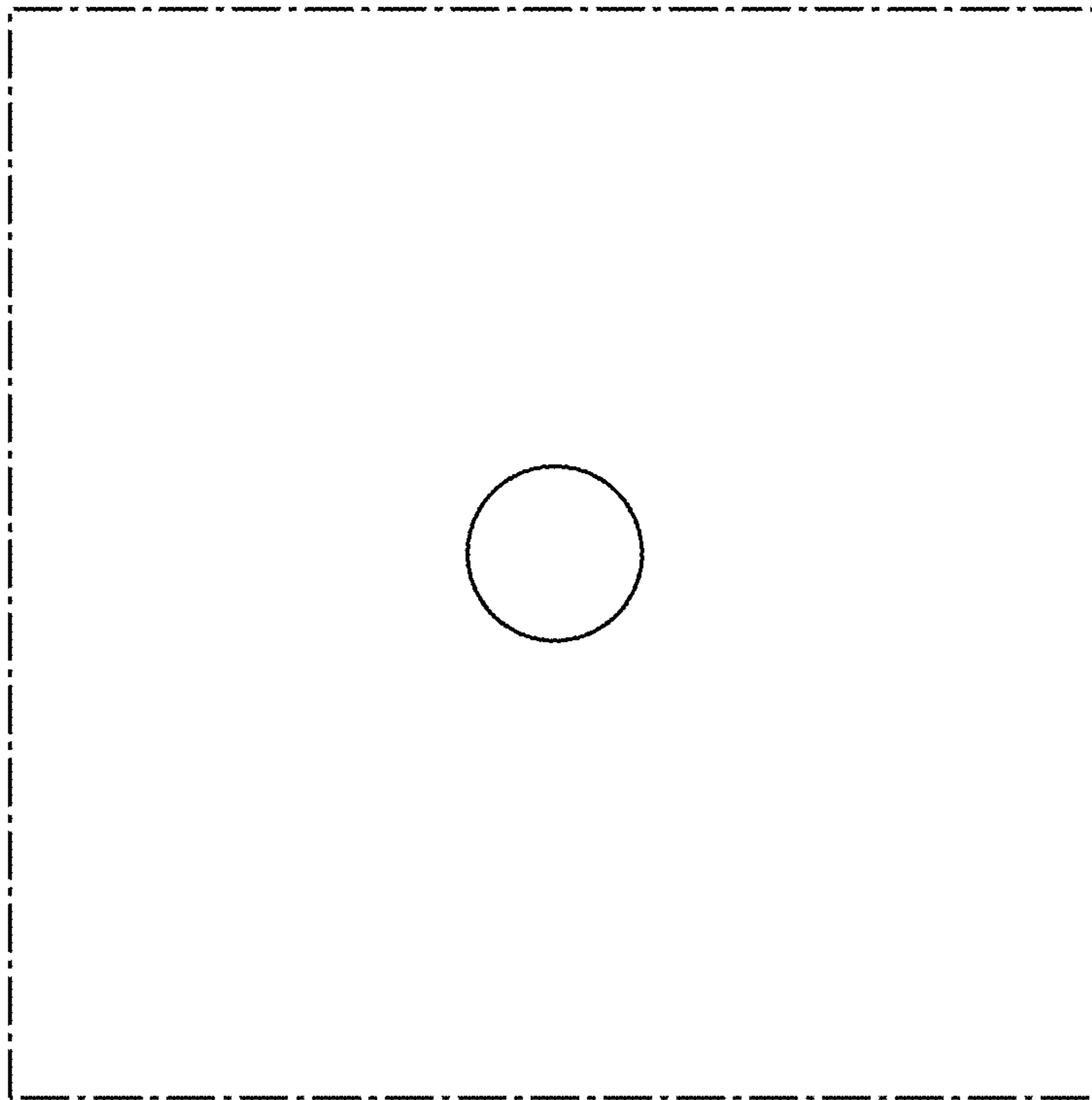
