The ornamental design for a hand exercise device, as shown and described.

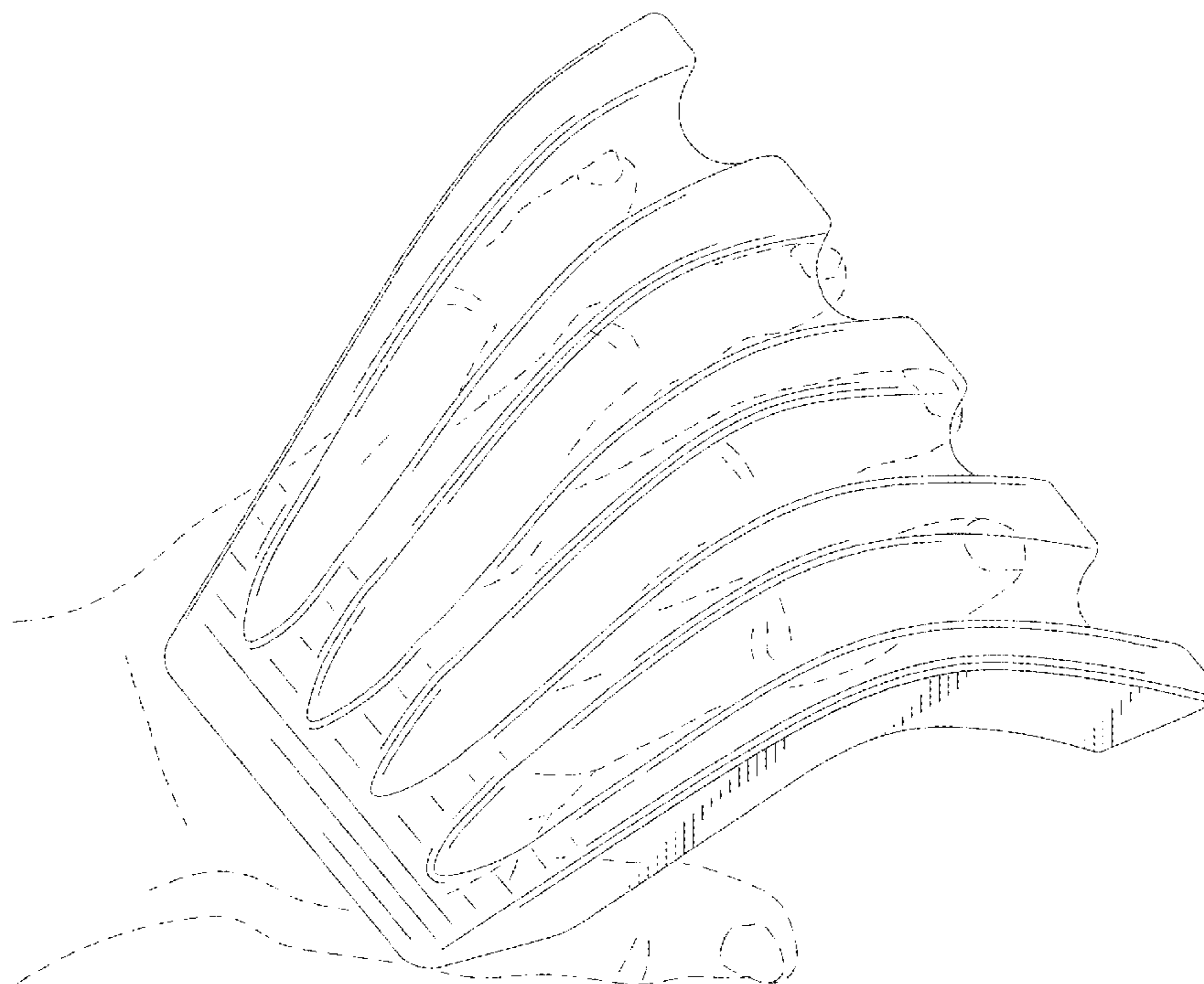
DESCRIPTION

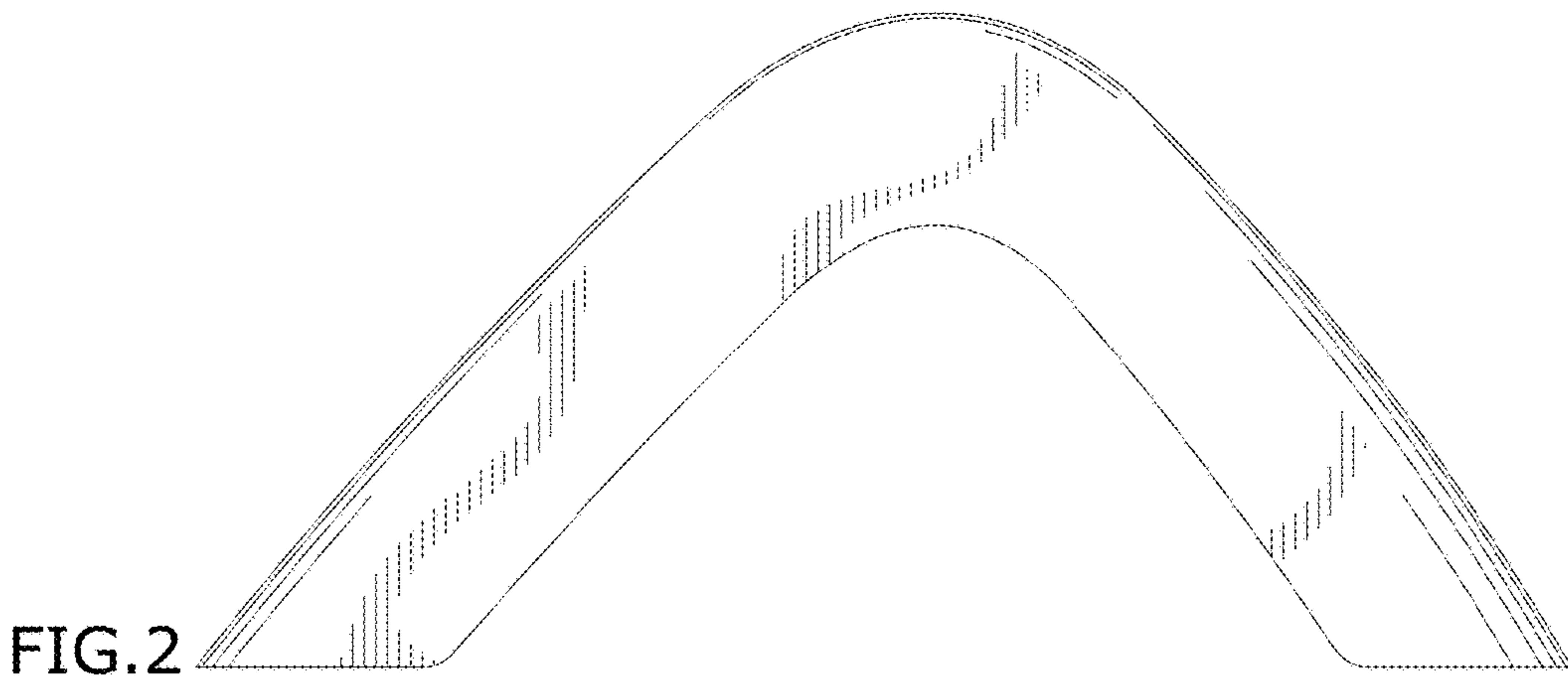
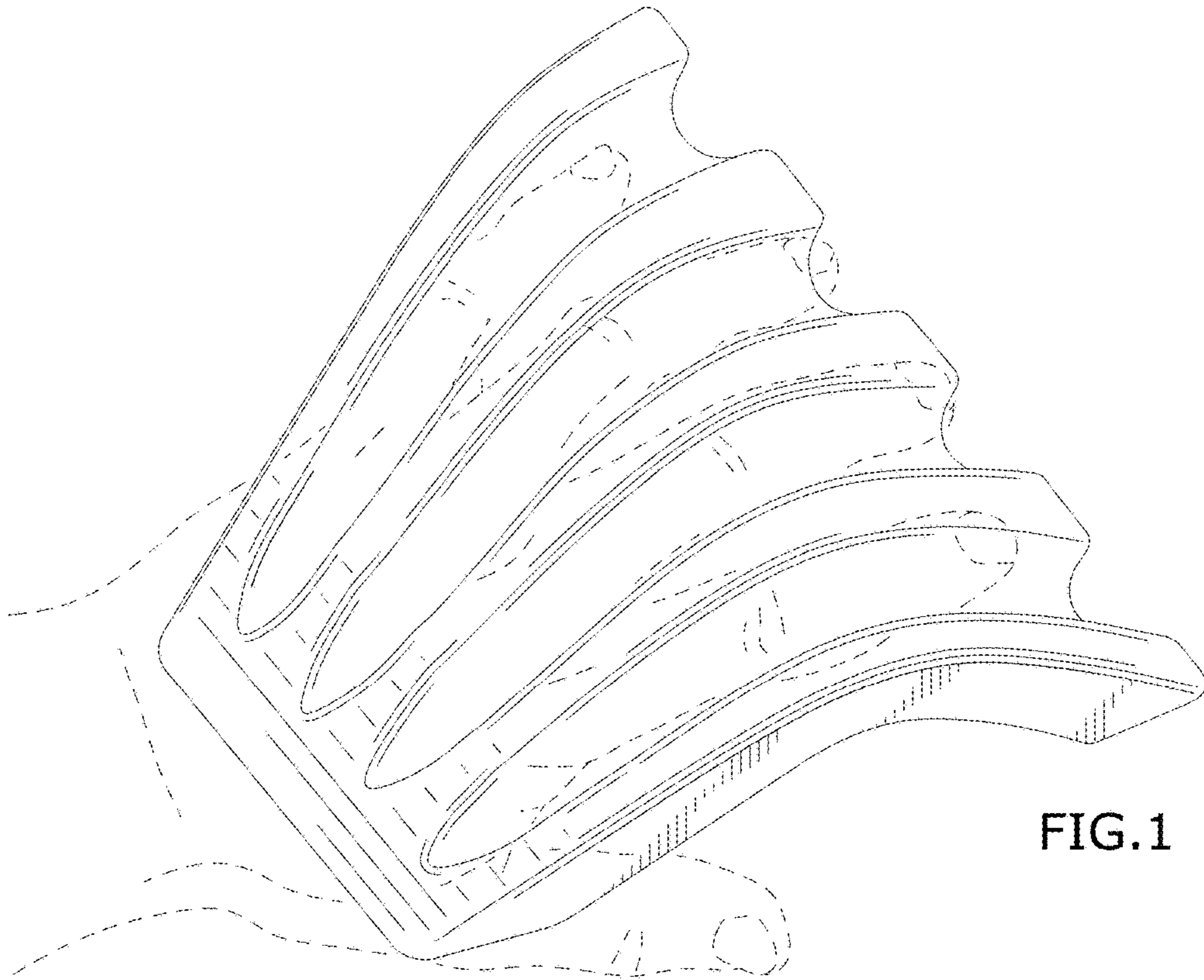
FIG. 1 is a perspective view of the hand exercise device showing my new design in use;

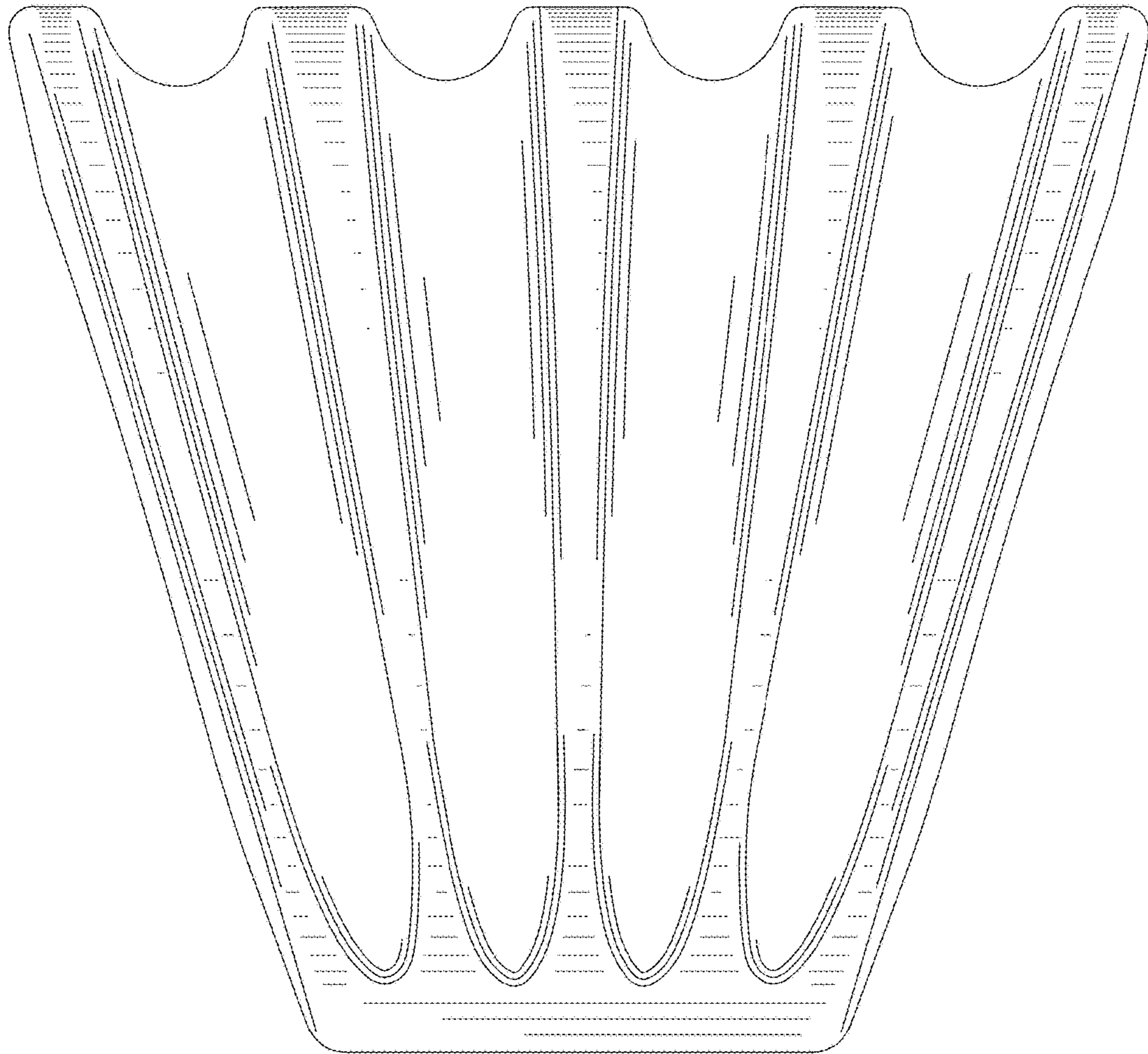

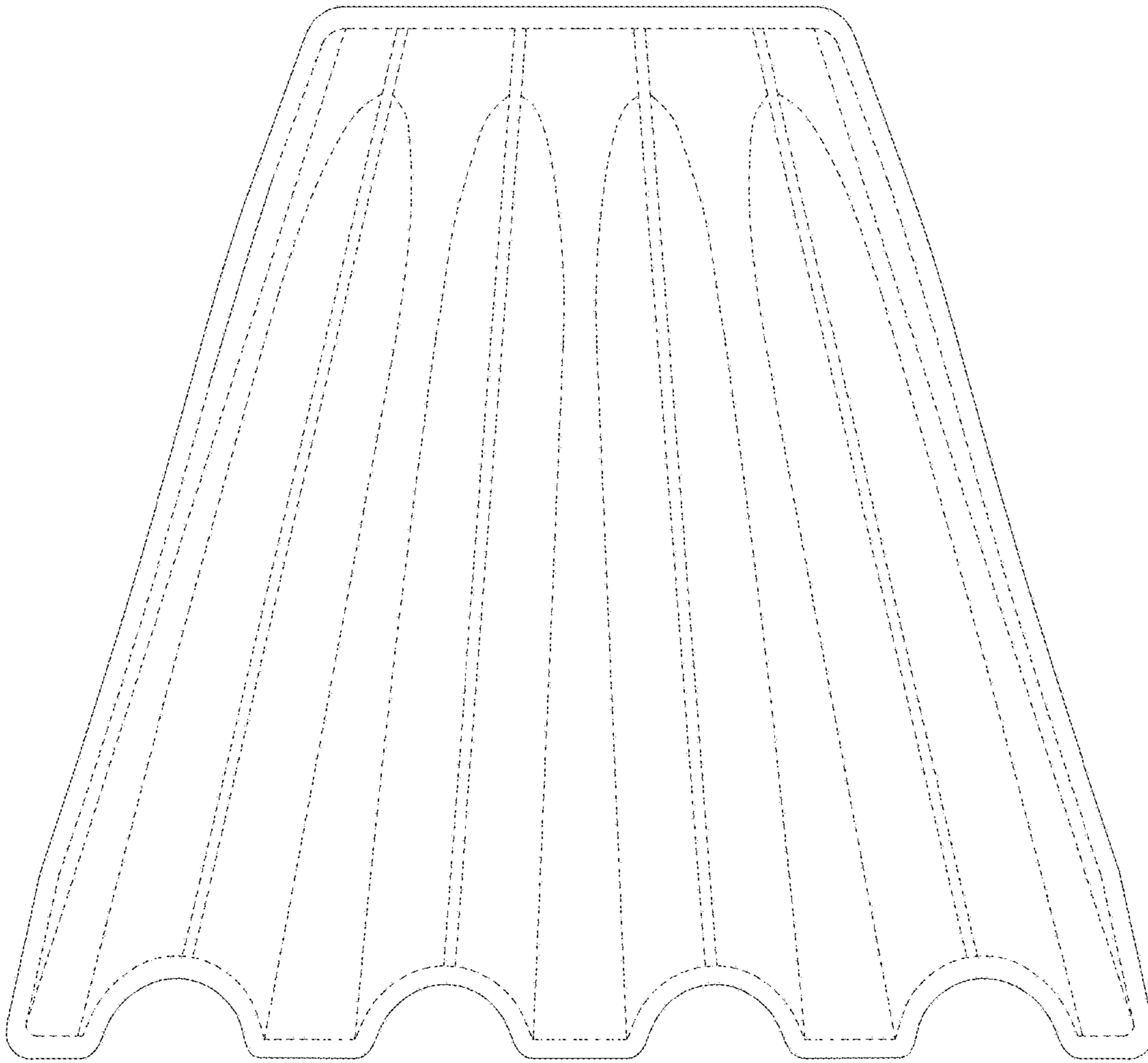

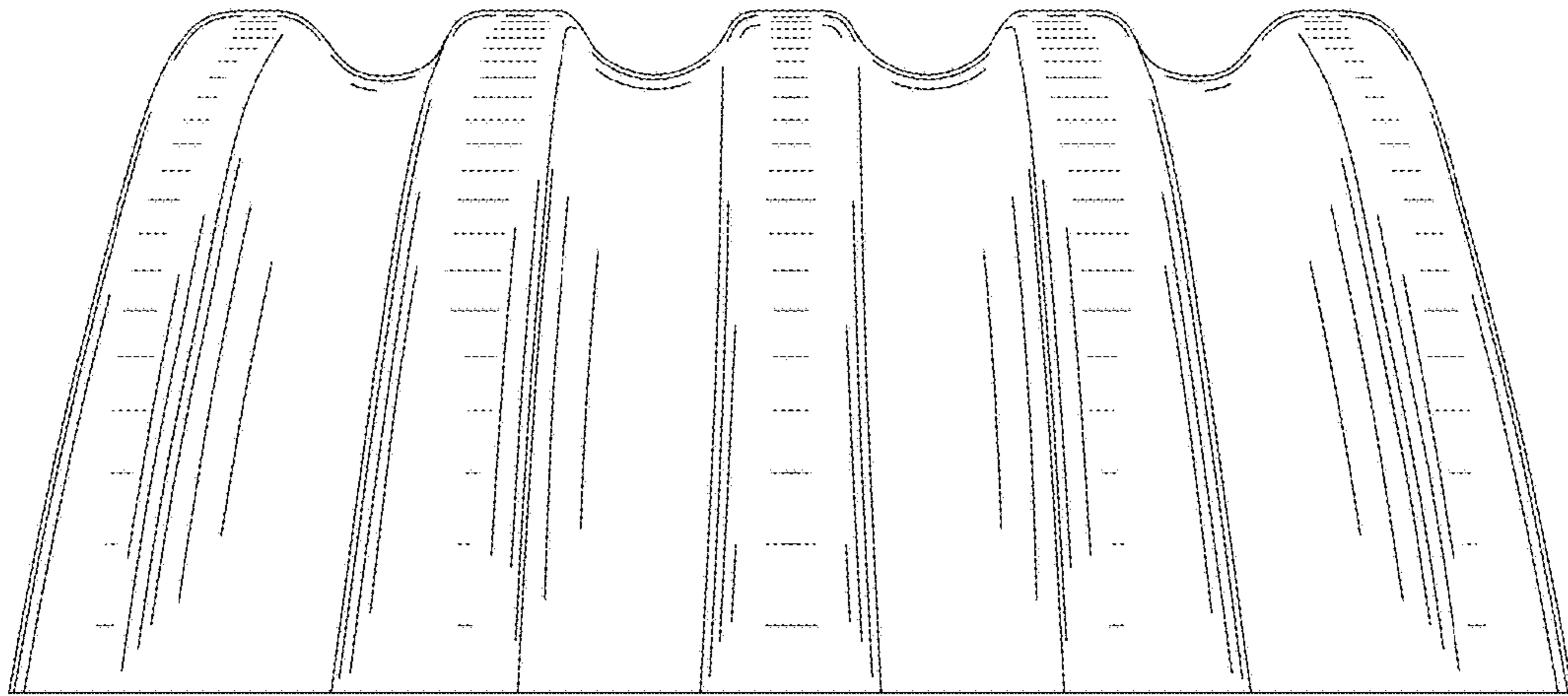

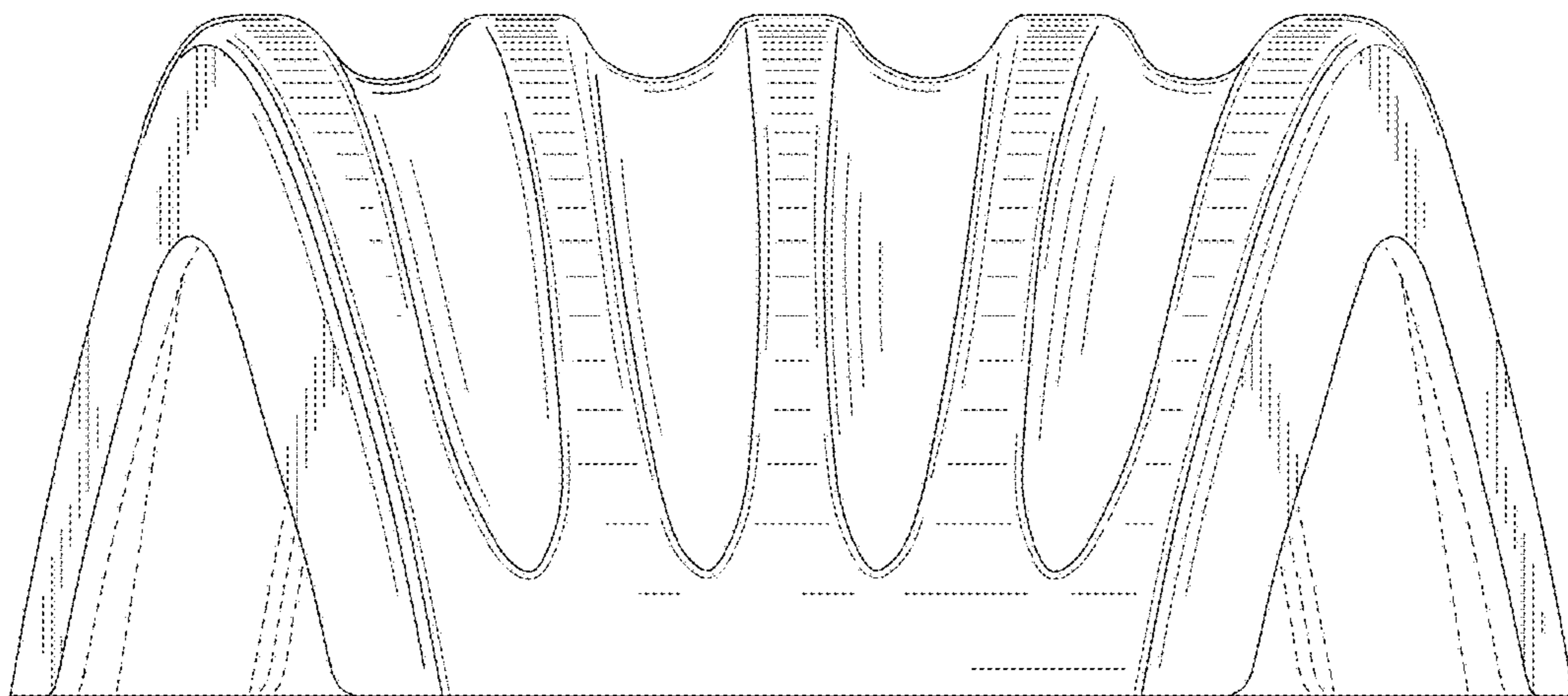
