DESCRIPTION

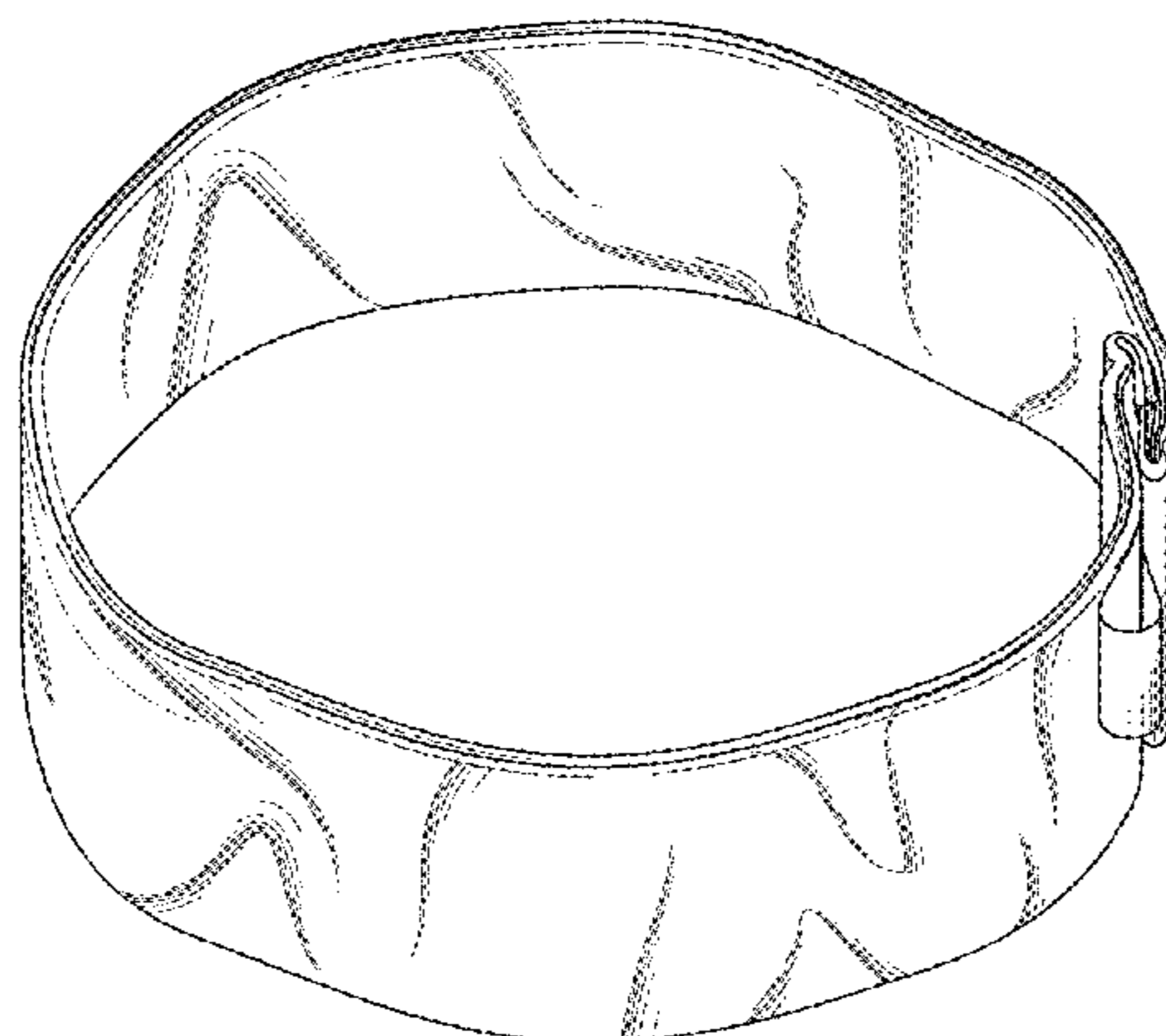
FIG. 1 is a perspective view of an exercise band showing our new design;

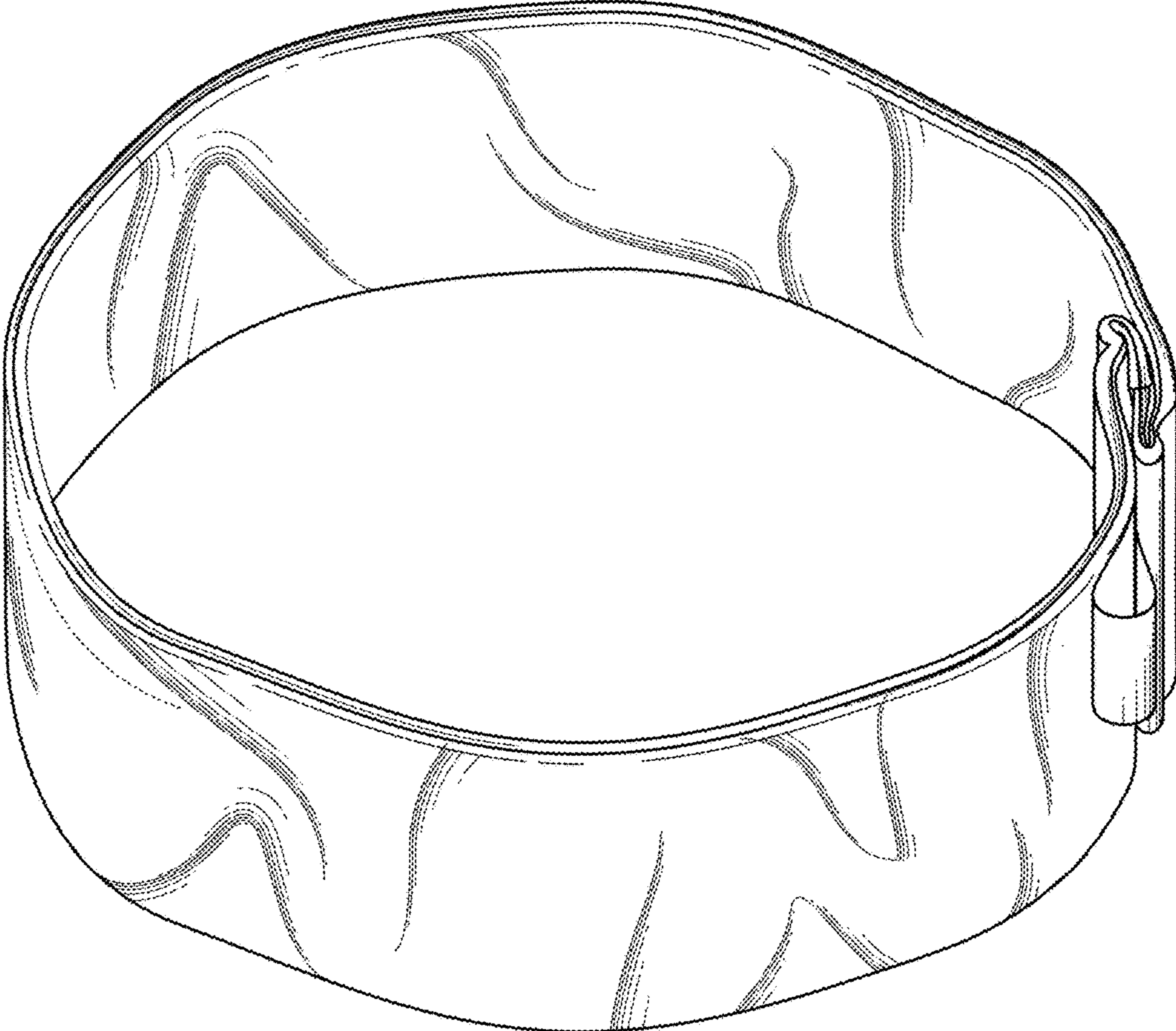

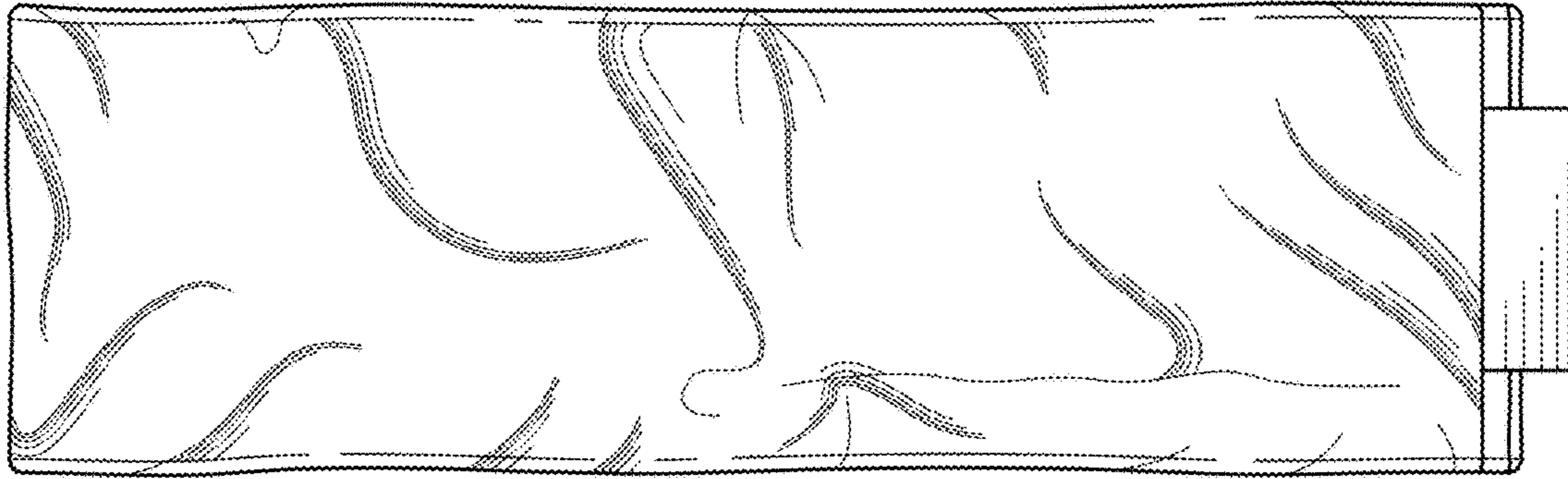

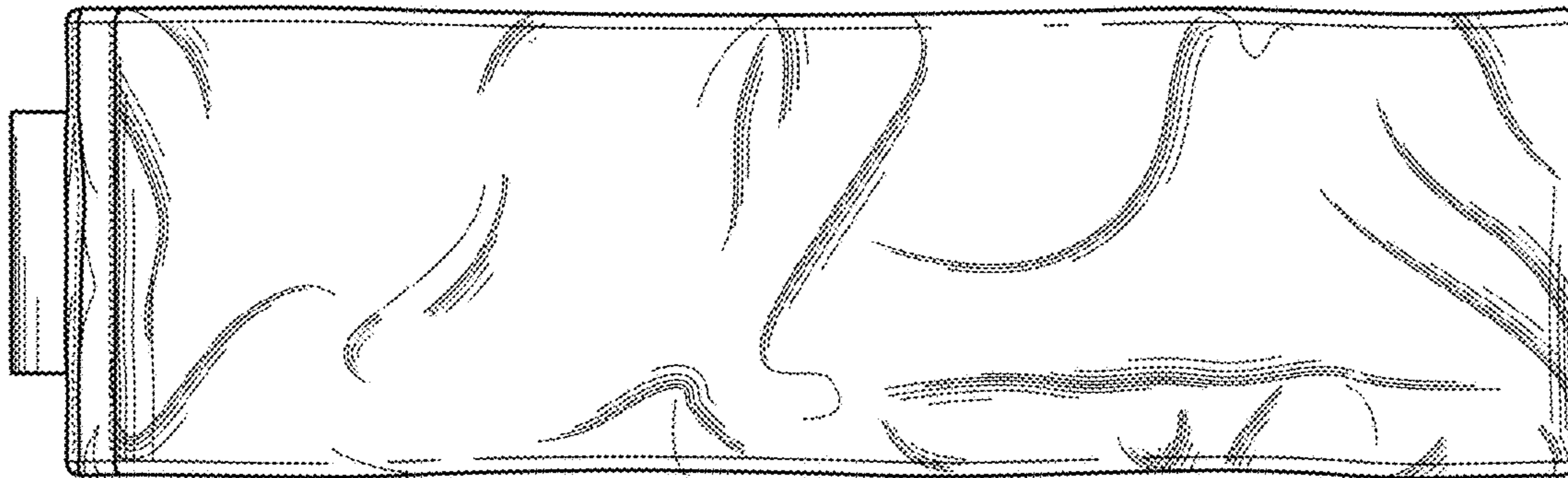

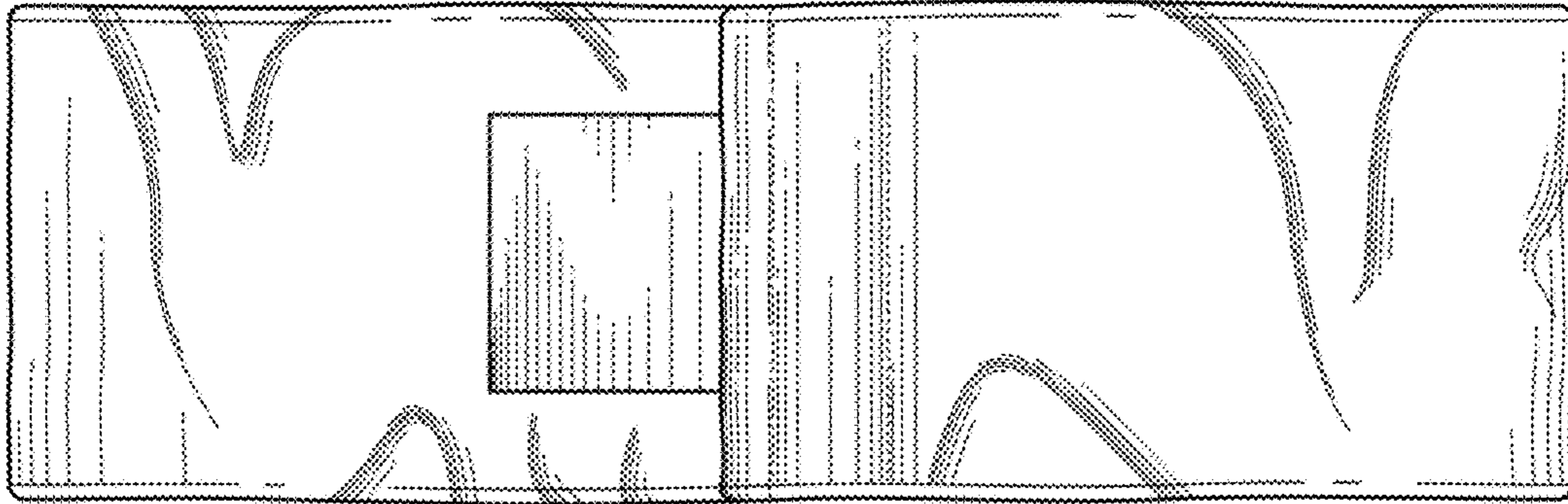

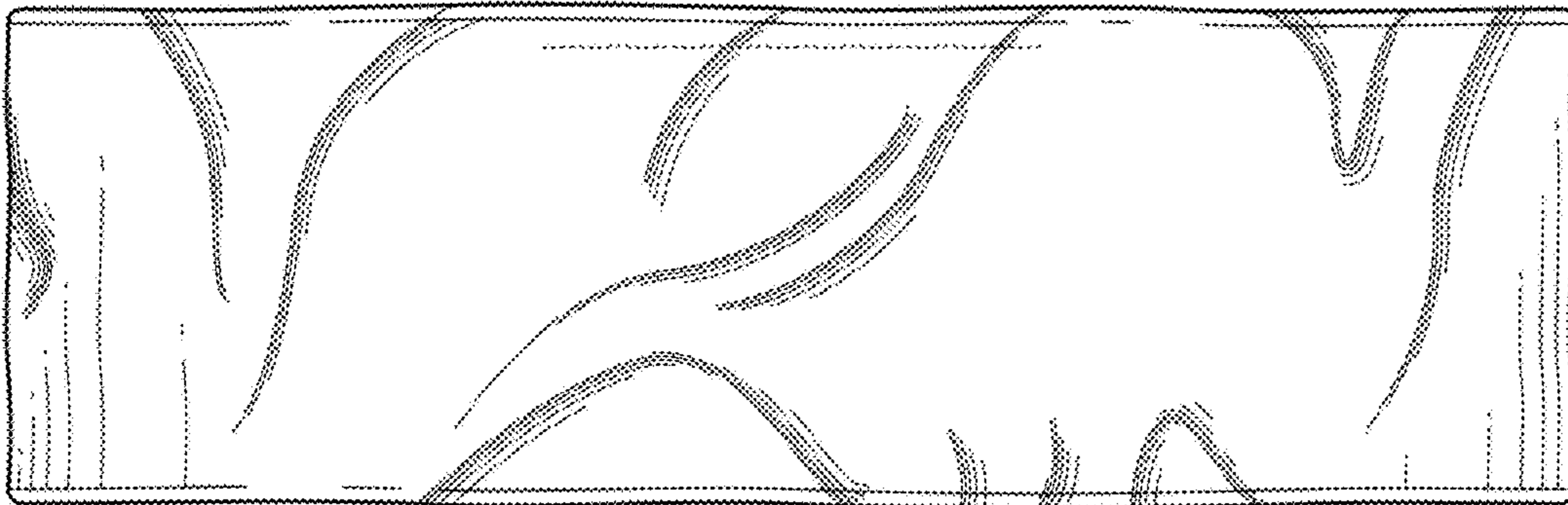

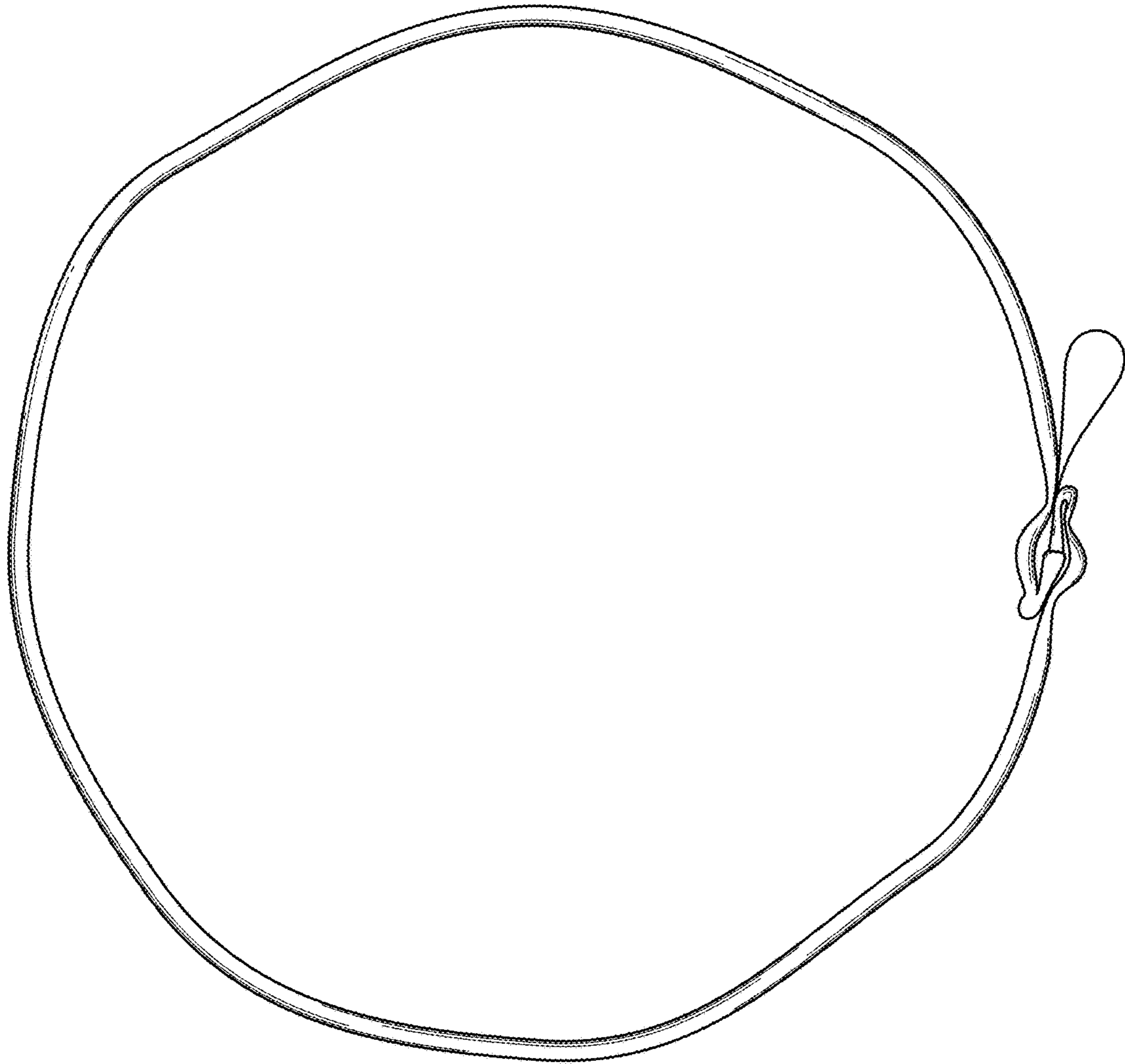
