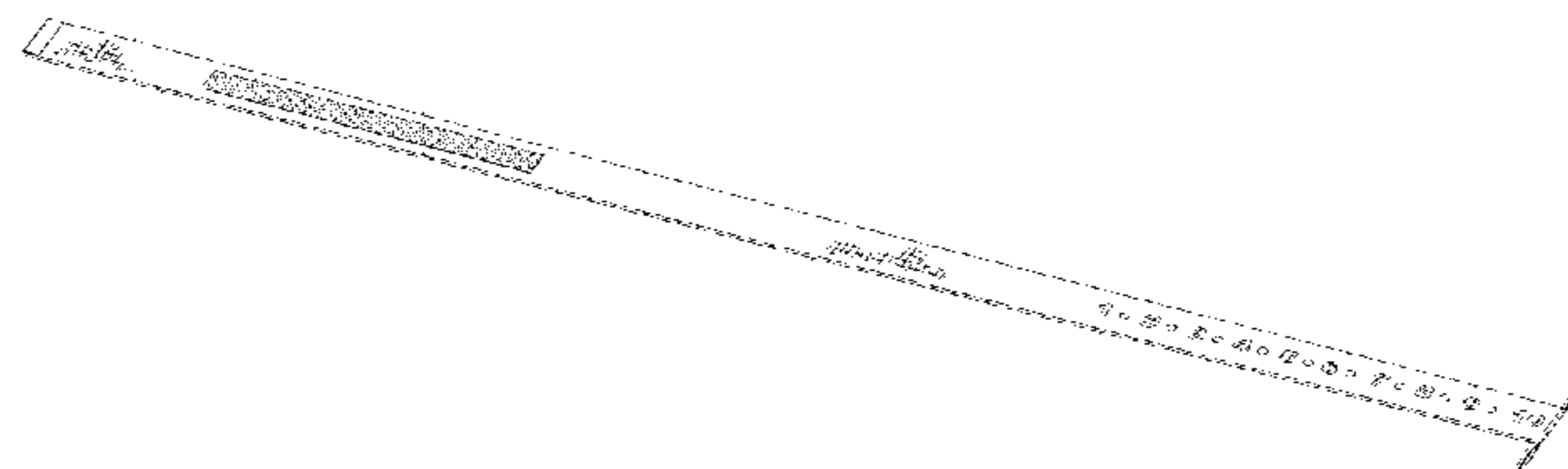
(57) **CLAIM**

The ornamental design for an exercise strap, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the exercise strap showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a front elevation view thereof;  
FIG. 5 is a rear elevation view thereof;  
FIG. 6 is a right side elevation view thereof; and,  
FIG. 7 is a left side elevation view thereof.  
The stipple shading in FIGS. 1 and 3 represents the loop portion of a hook and loop fastener system.

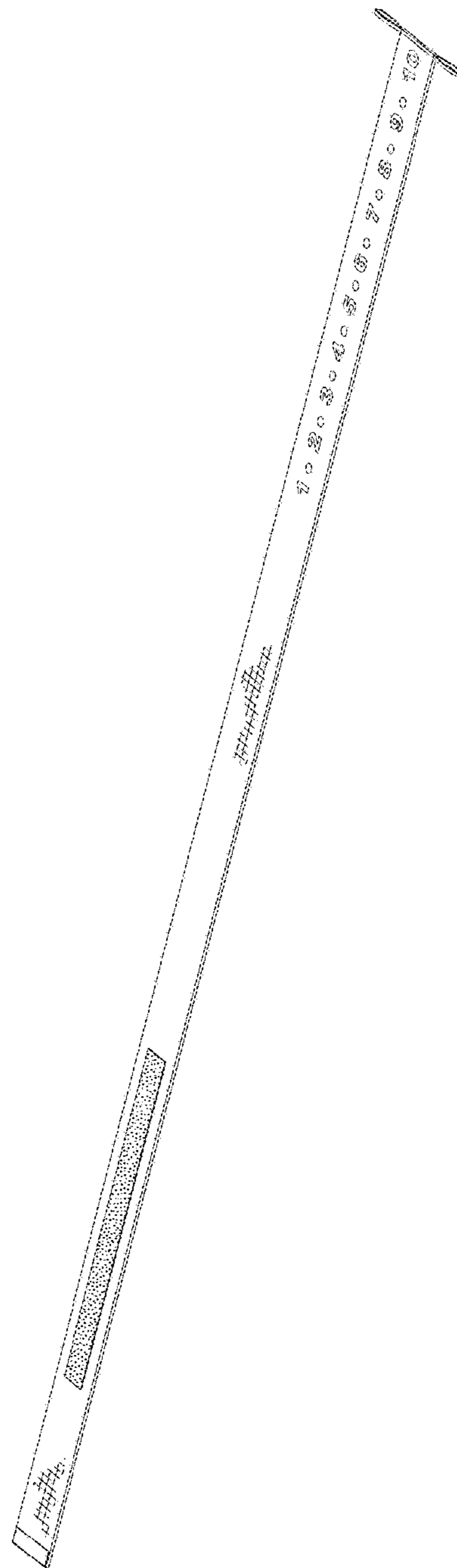
