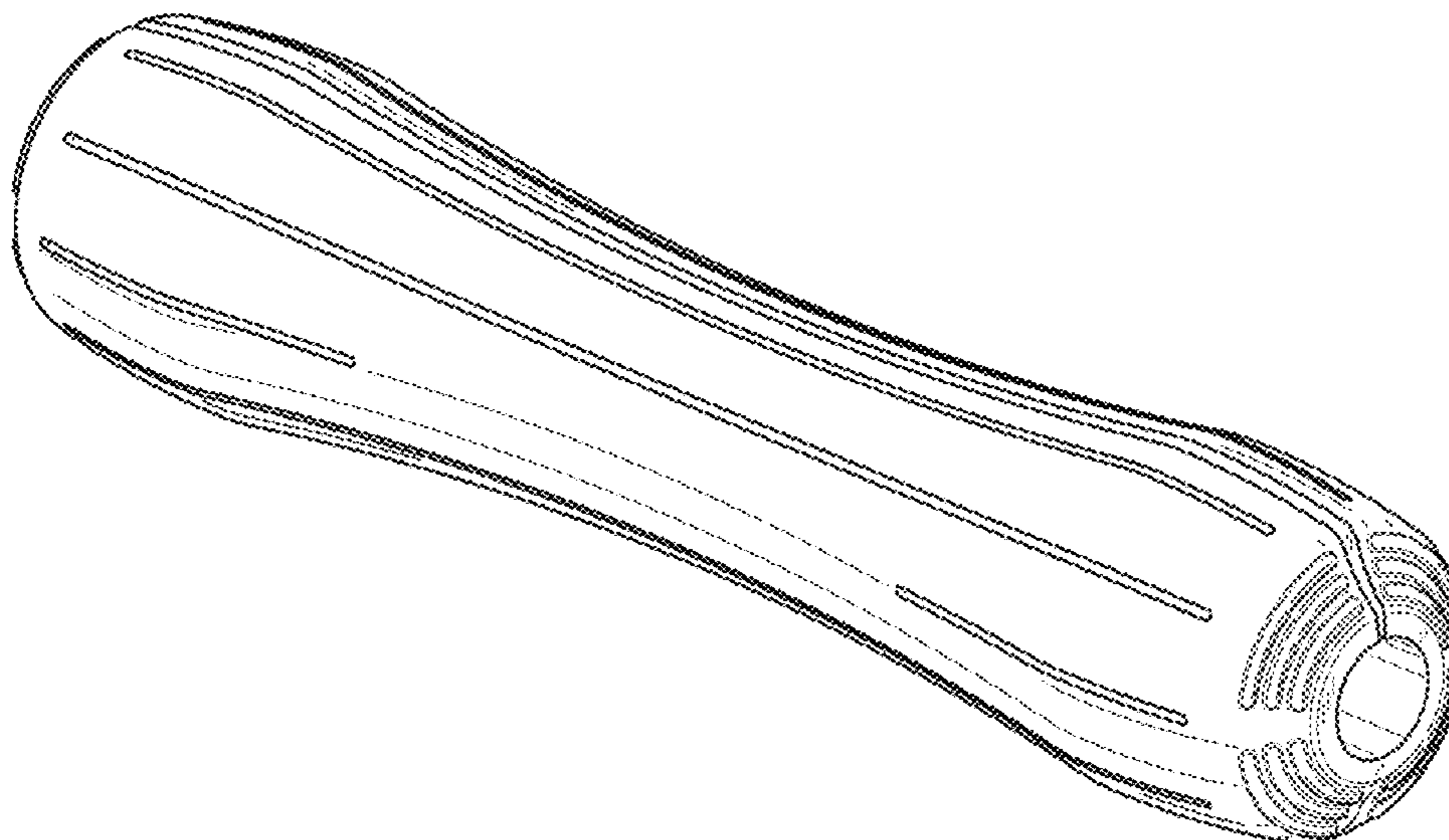
(57) **CLAIM**

The ornamental design for a barbell pad, as shown and described.

**DESCRIPTION**

FIG. 1 is a right front isometric view of a barbell pad incorporating our new design;  
 FIG. 2 is a right end elevational view of thereof, the left end being a mirror image of the right end;  
 FIG. 3 is a front elevational view thereof;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a rear elevational view thereof; and,  
 FIG. 6 is a bottom plan view thereof.

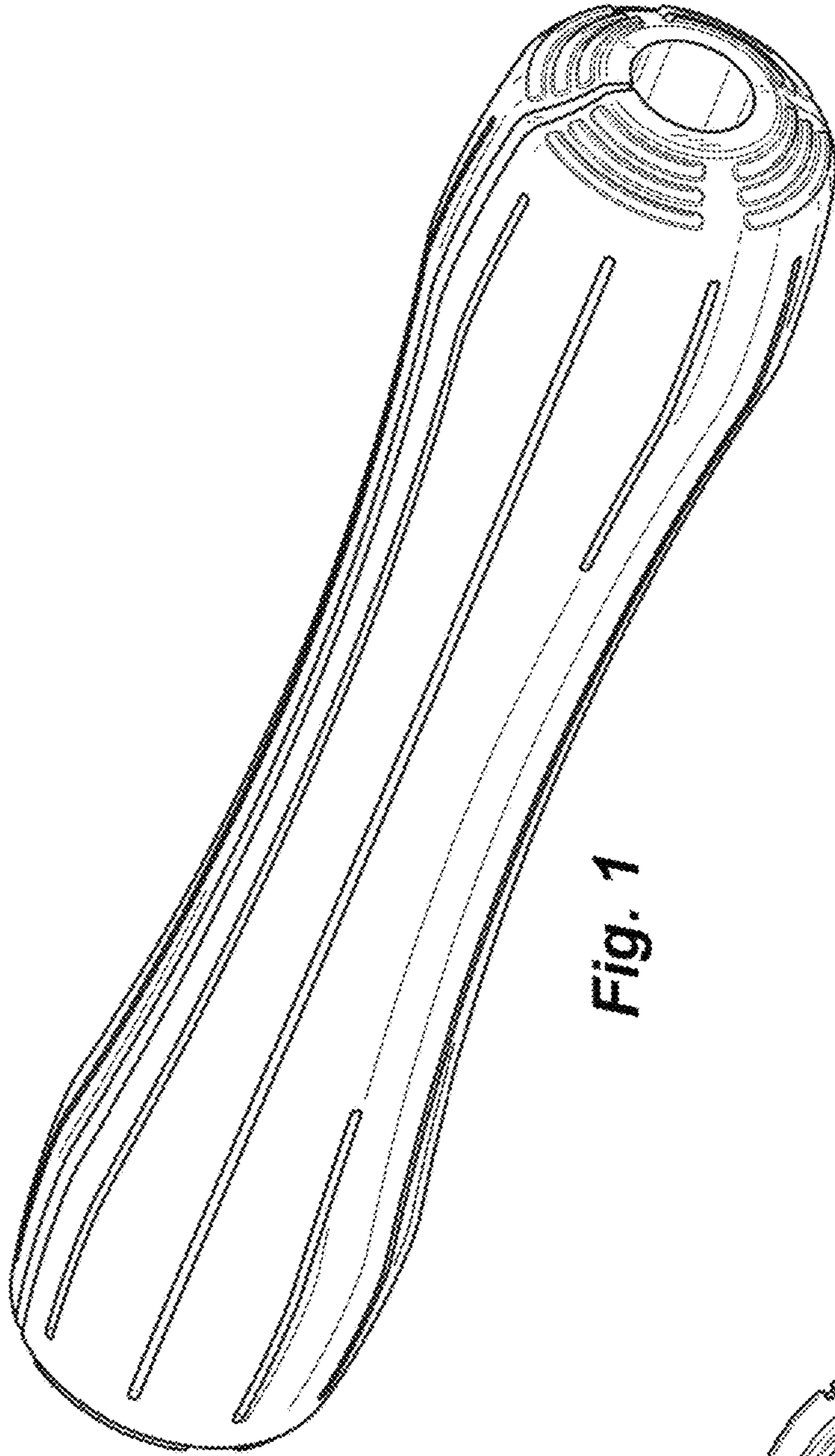

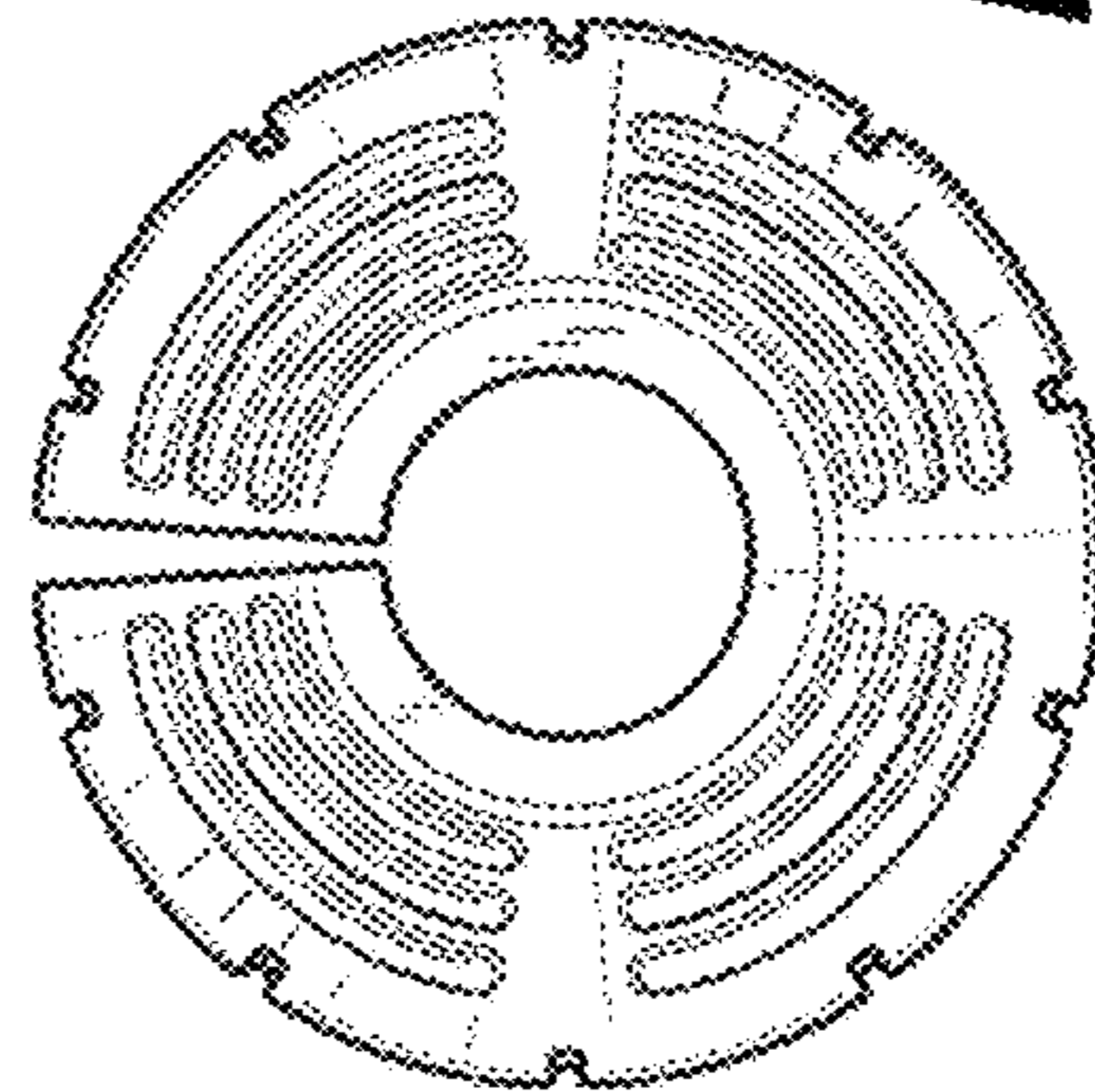

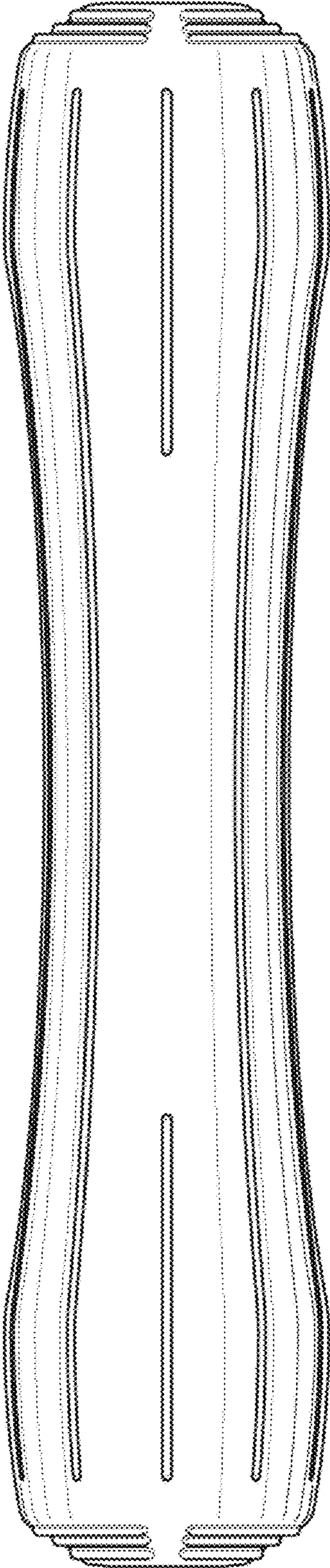

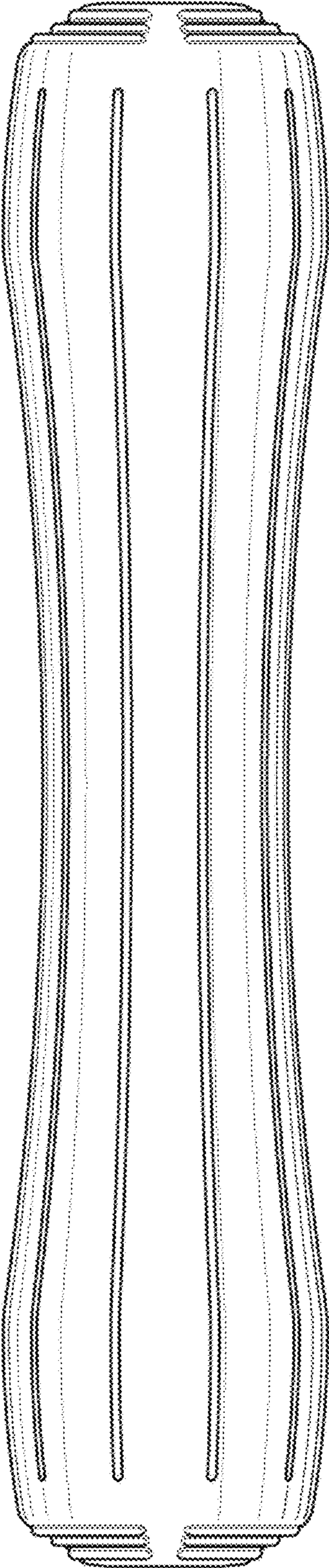
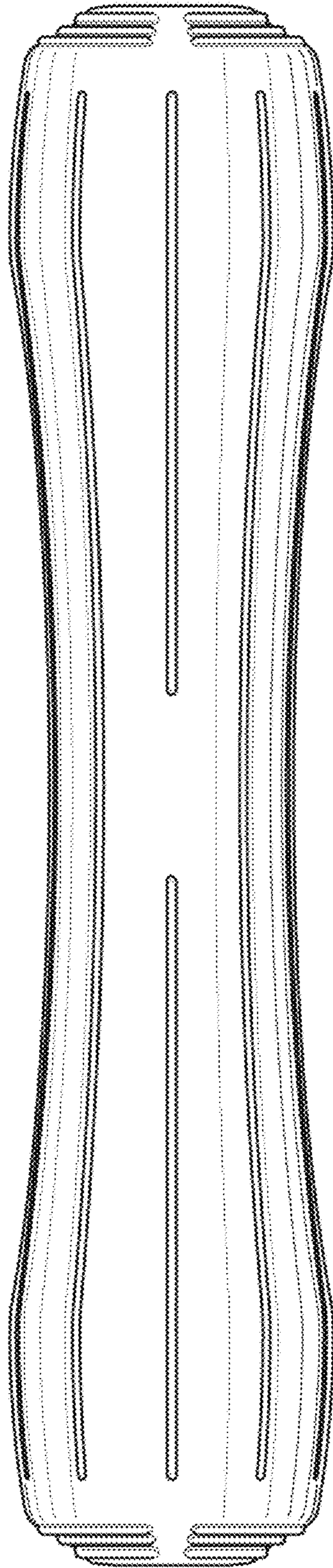
