(57) **CLAIM**

The ornamental design for a trampoline with a skirt, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a trampoline with a skirt showing the new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof;
 FIG. 4 is a front elevation view thereof;
 FIG. 5 is a rear elevation view thereof;
 FIG. 6 is a right elevation view thereof; and,
 FIG. 7 is a left elevation view thereof.

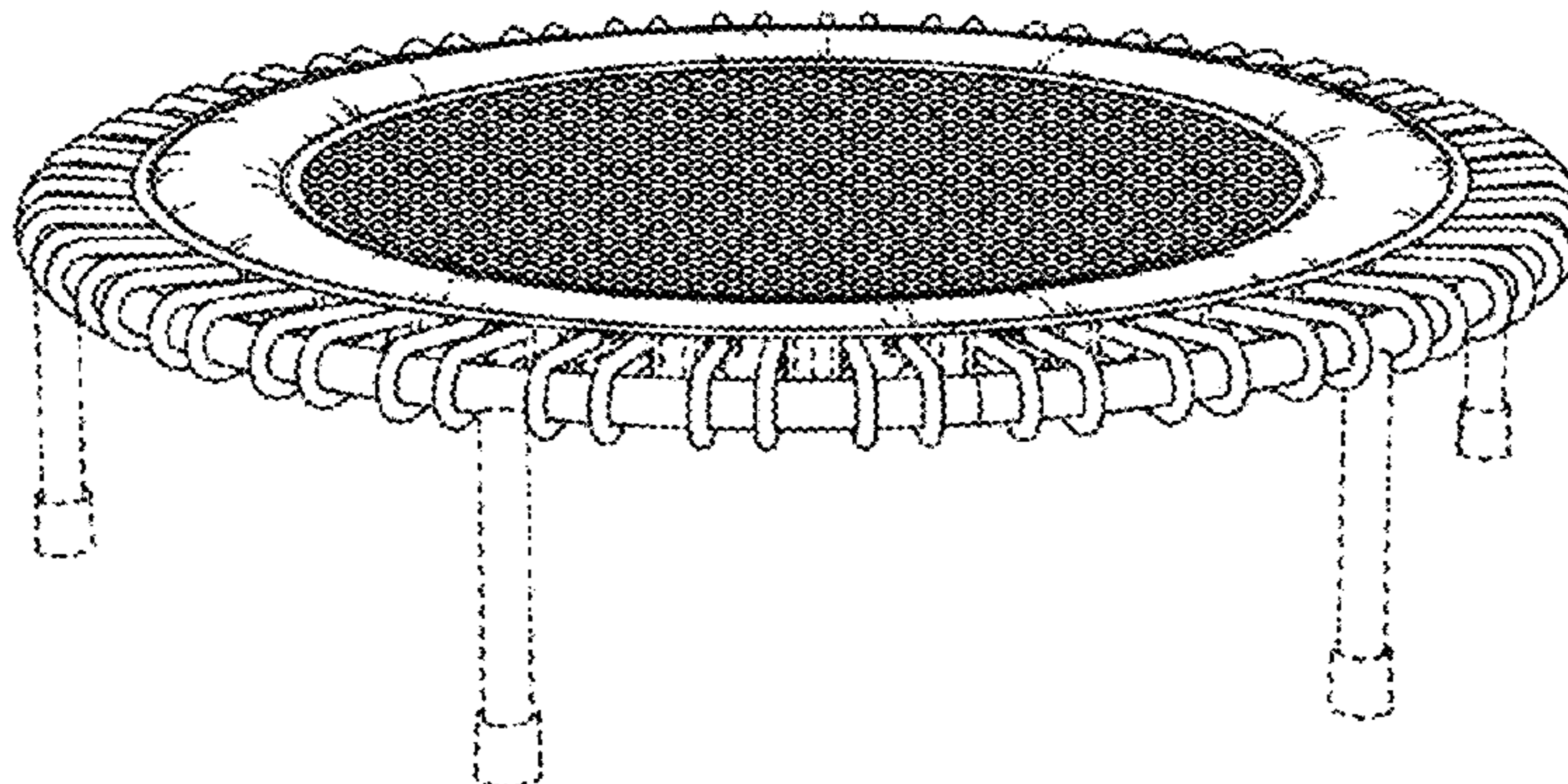
The broken lines in the drawings represent unclaimed environmental subject matter and form no part of the claim. In FIGS. 1-3, the intermittent lines extending along the circular perimeter of the jumping mat represent stitching and are part of the claimed design. In FIG. 3, the circular band bordering the jumping mat is flat and planar.

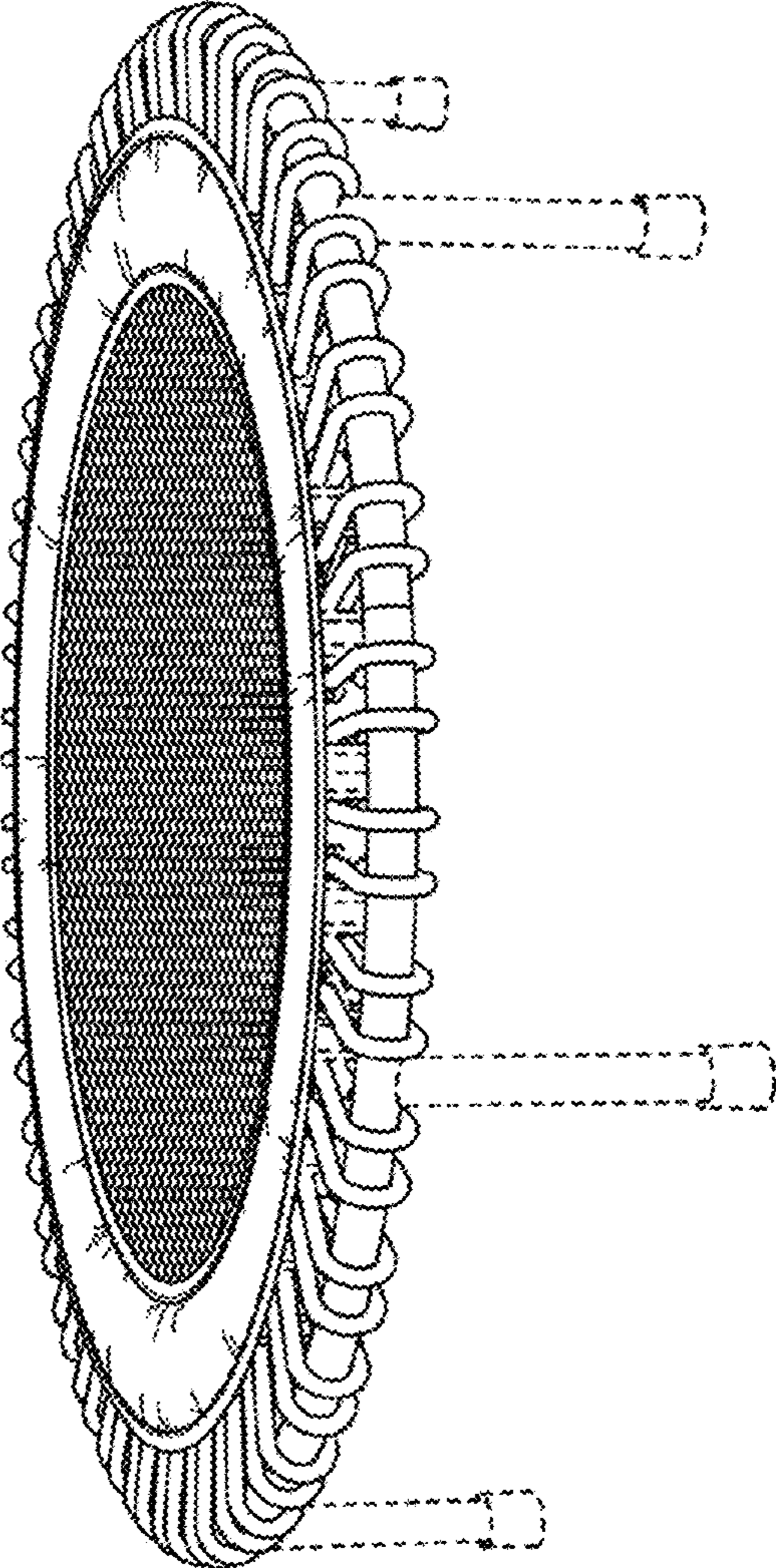

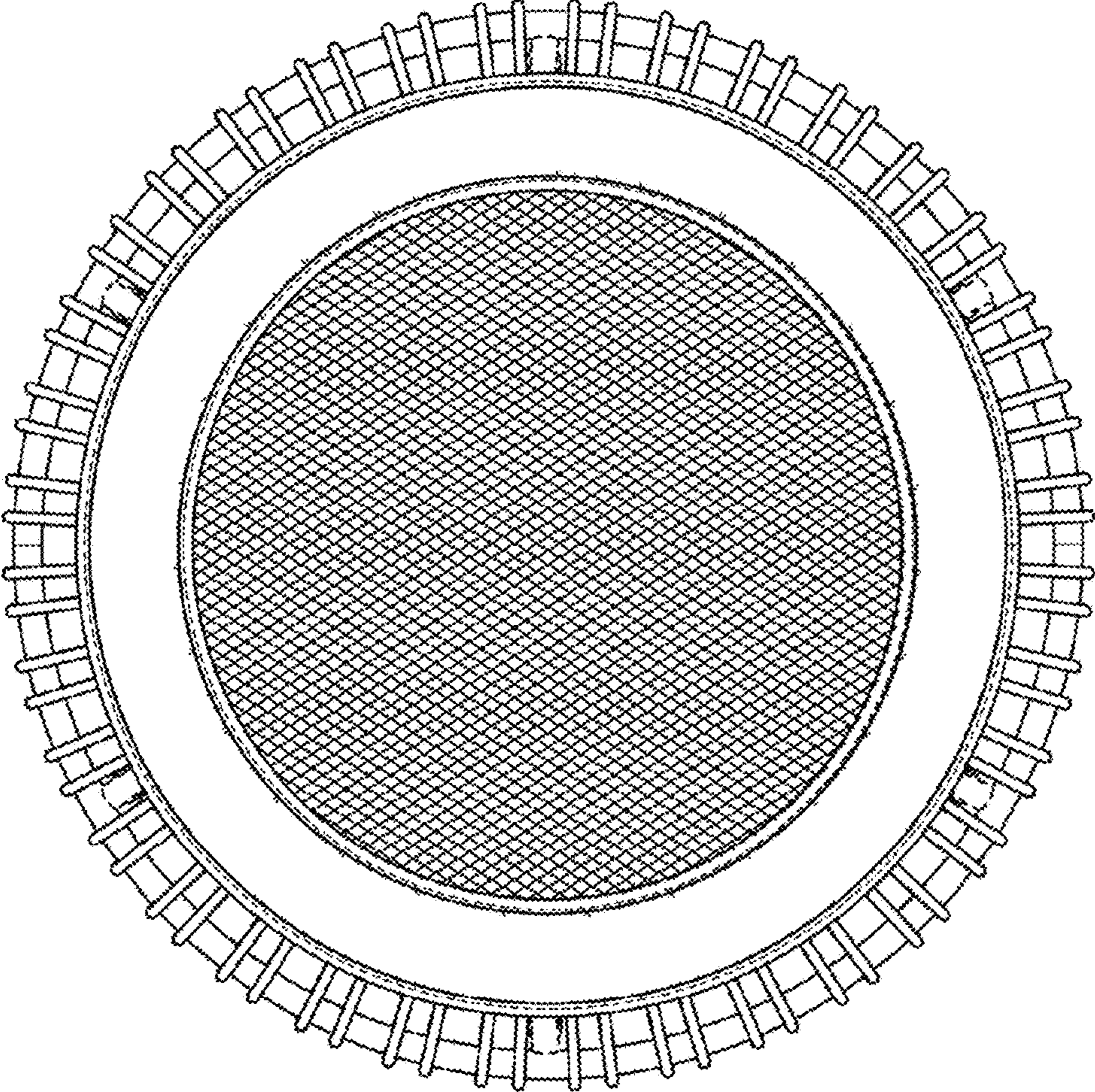

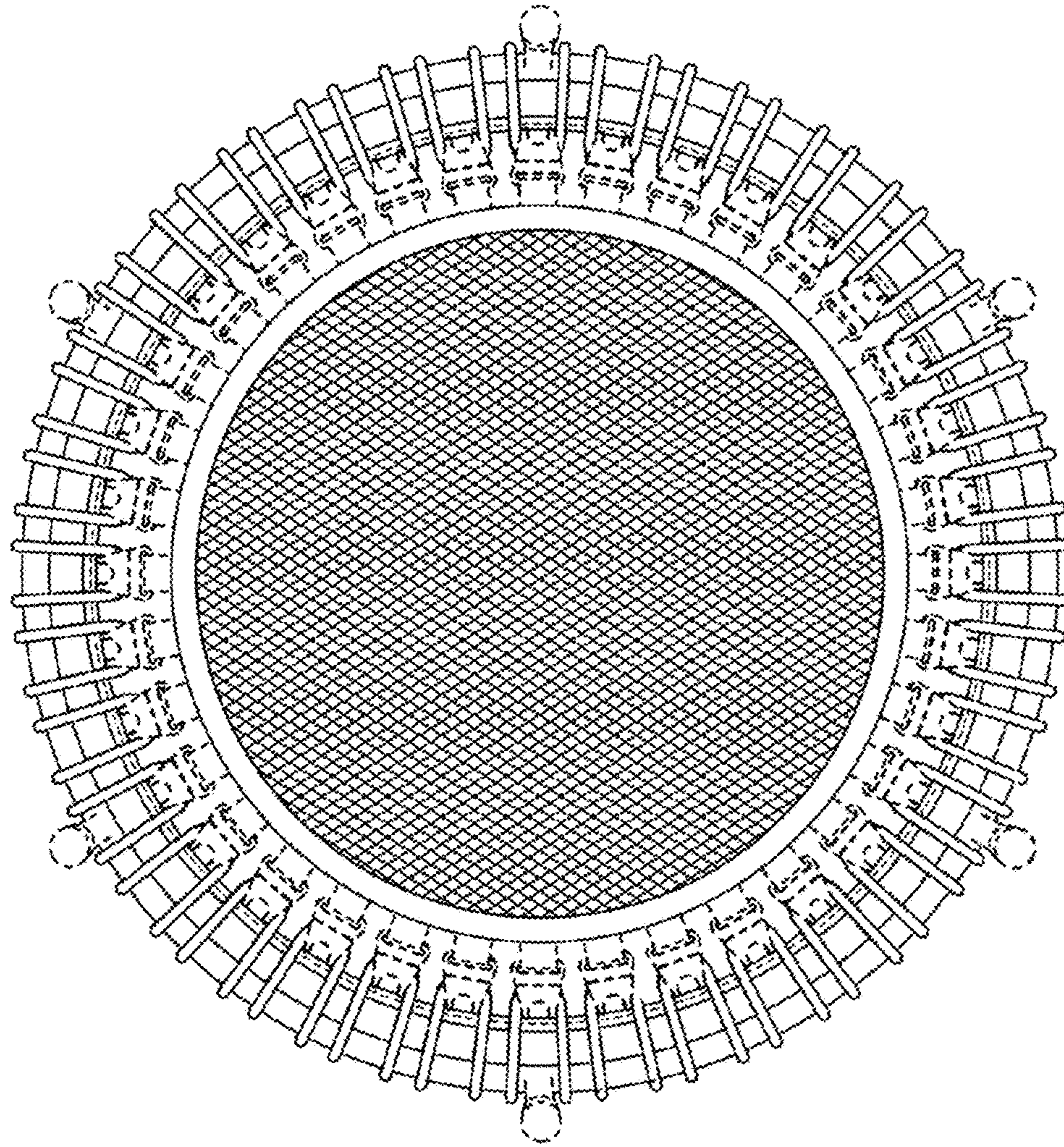

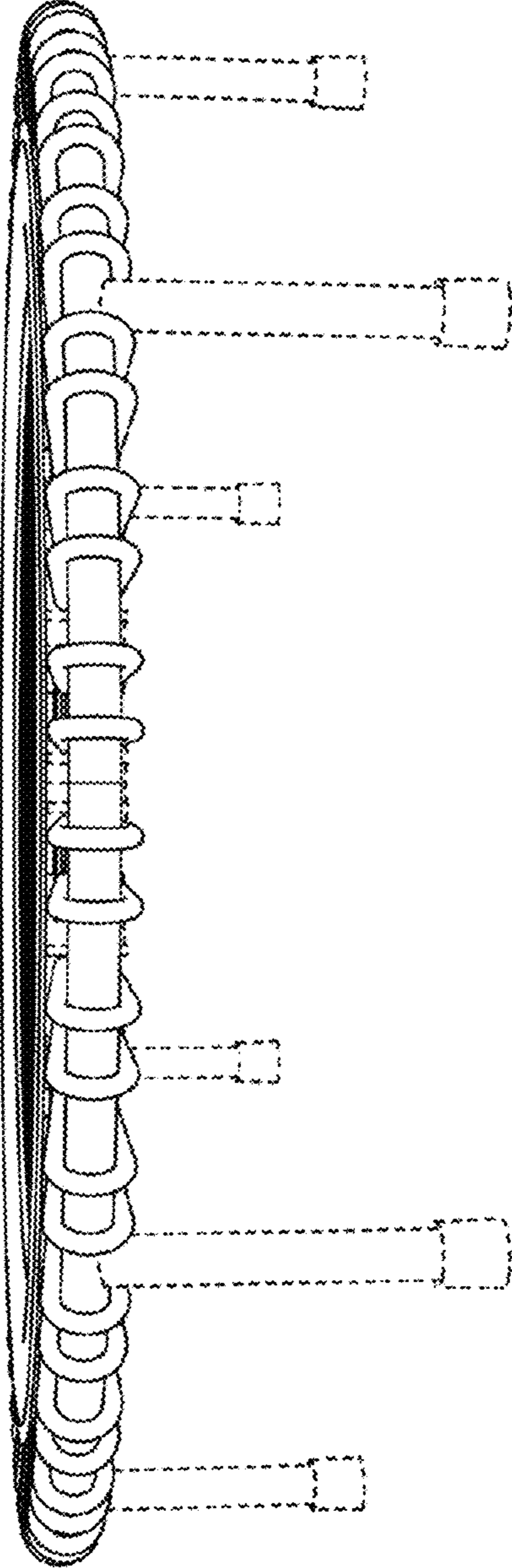

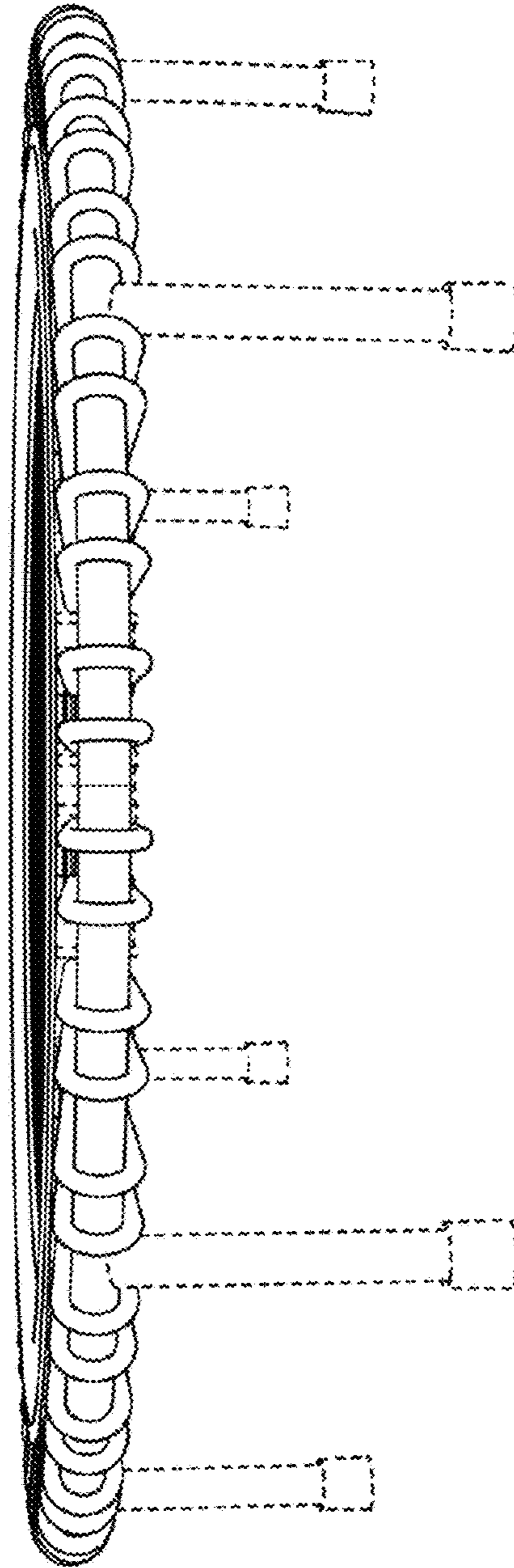

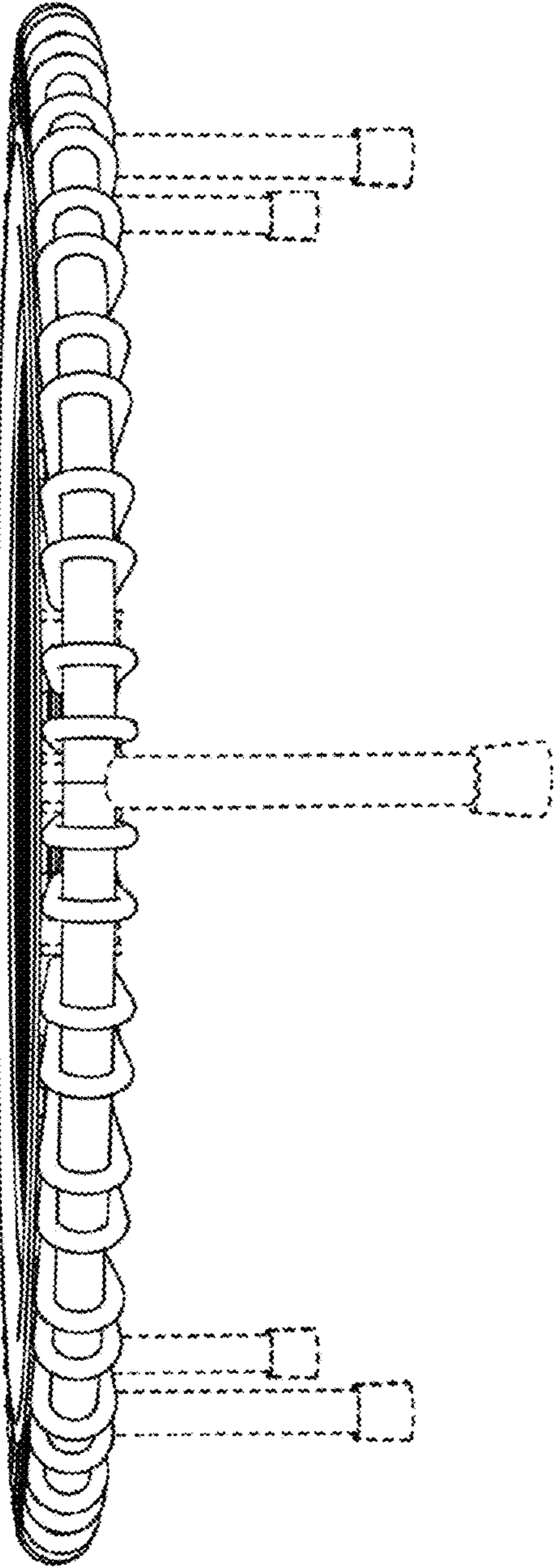
