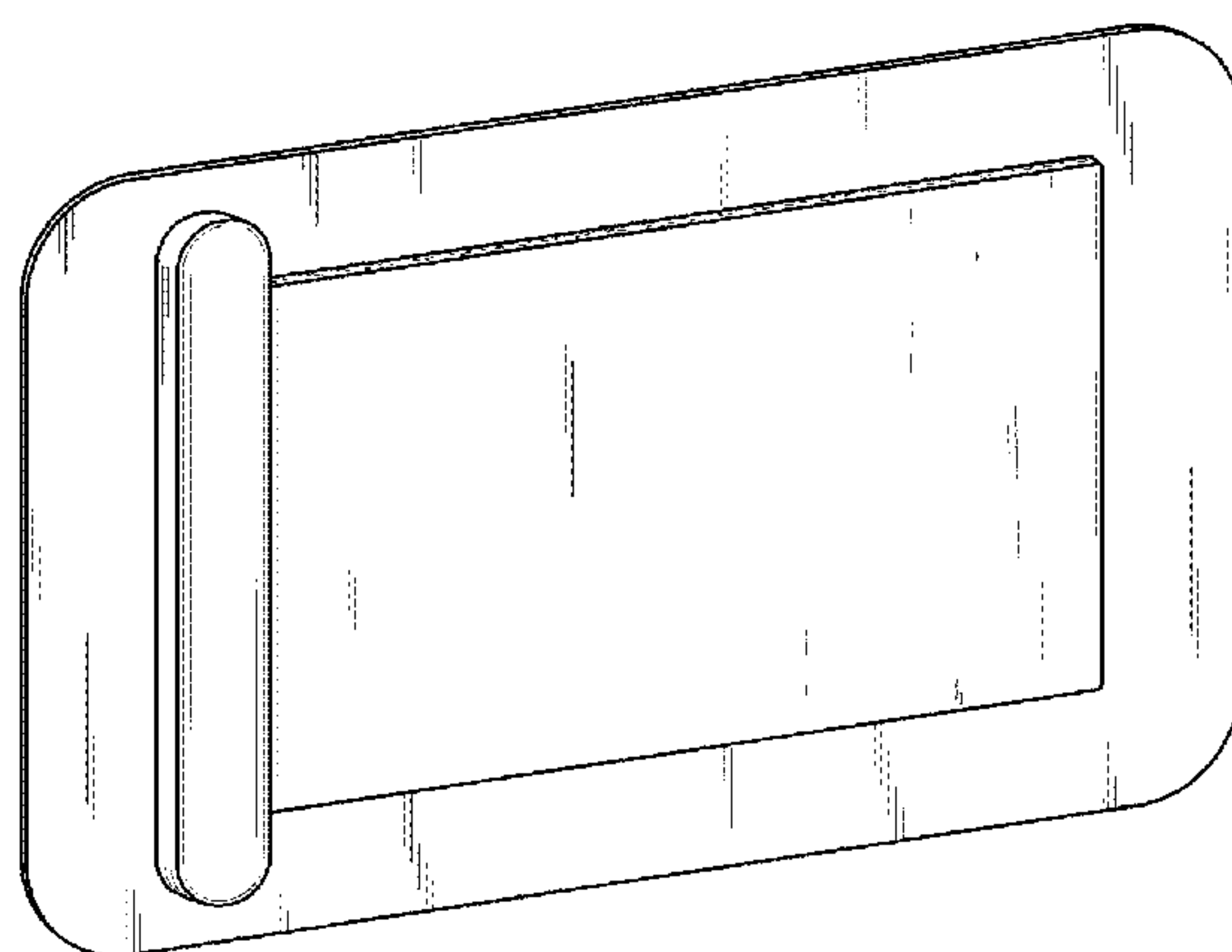
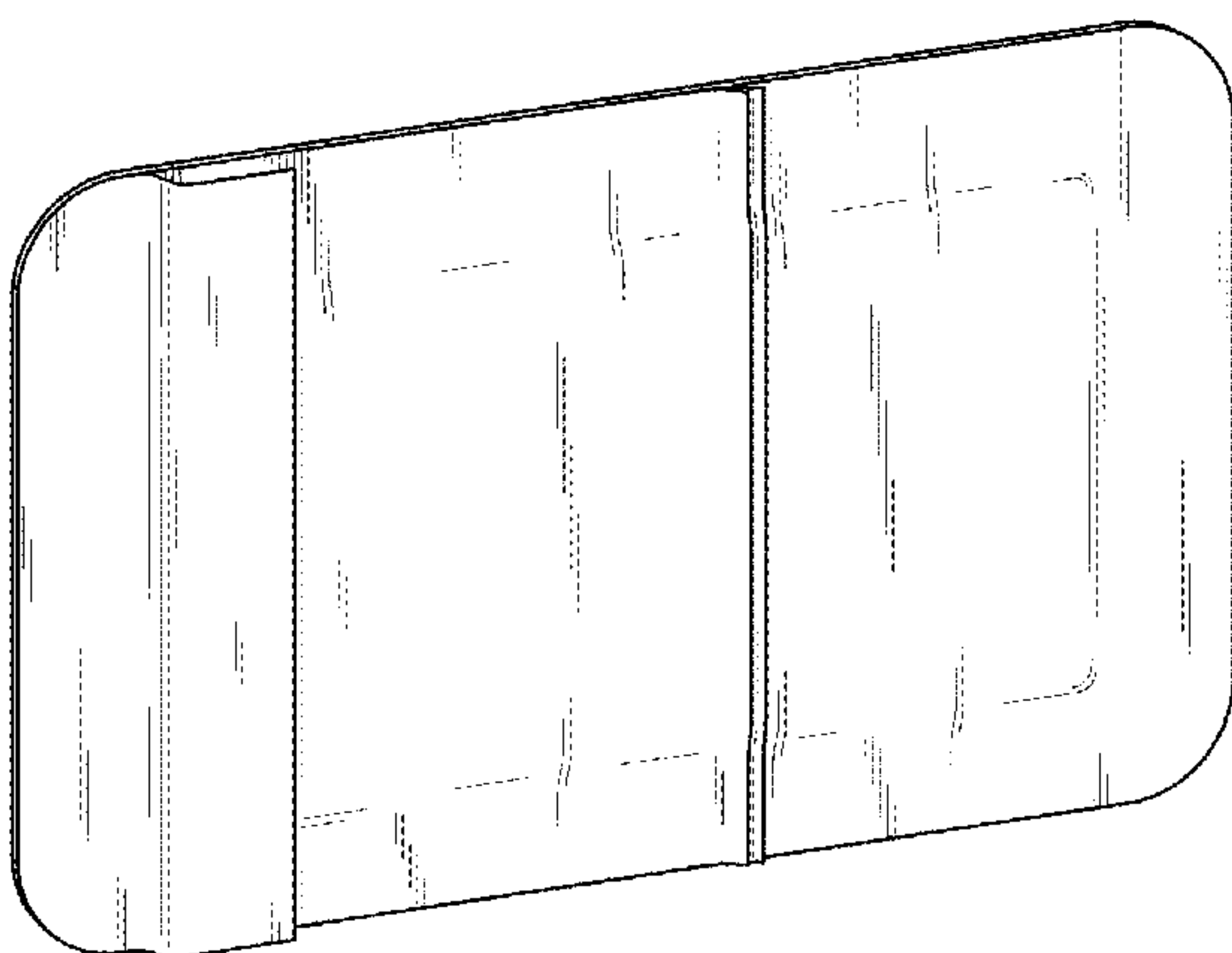
(57) **CLAIM**

The ornamental design for a combined multipurpose adhesive bandage and splint device, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an ornamental design for a combined multipurpose adhesive bandage and splint device with three peel-off protective films; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a left side elevation view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom view thereof; FIG. 9 is a front perspective view thereof, with one peel-off protective film removed; FIG. 10 is a front perspective view thereof, with two peel-off protective films removed; FIG. 11 is a front perspective view thereof, with three peel-off protective films removed, exposing a splint; FIG. 12 is a front elevation view thereof, with the three peel-off protective films removed; FIG. 13 is a right side elevation view thereof, with the three peel-off protective films removed; FIG. 14 is a left side elevation view thereof, with the three peel-off protective films removed; FIG. 15 is a top plan view thereof, with the three peel-off protective films removed; FIG. 16 is a bottom view thereof, with the three peel-off protective films removed; FIG. 17 is a perspective view of the multipurpose adhesive bandage and splint device placed over a wounded area of an extended elbow of an arm of a user; FIG. 18 is a perspective view of the multipurpose adhesive bandage and splint device wrapped around the wounded area of the extended elbow of the arm of the user; and, FIG. 19 is a perspective view of the multipurpose adhesive bandage and splint device wrapped around a wounded area of a finger of a hand of the user.

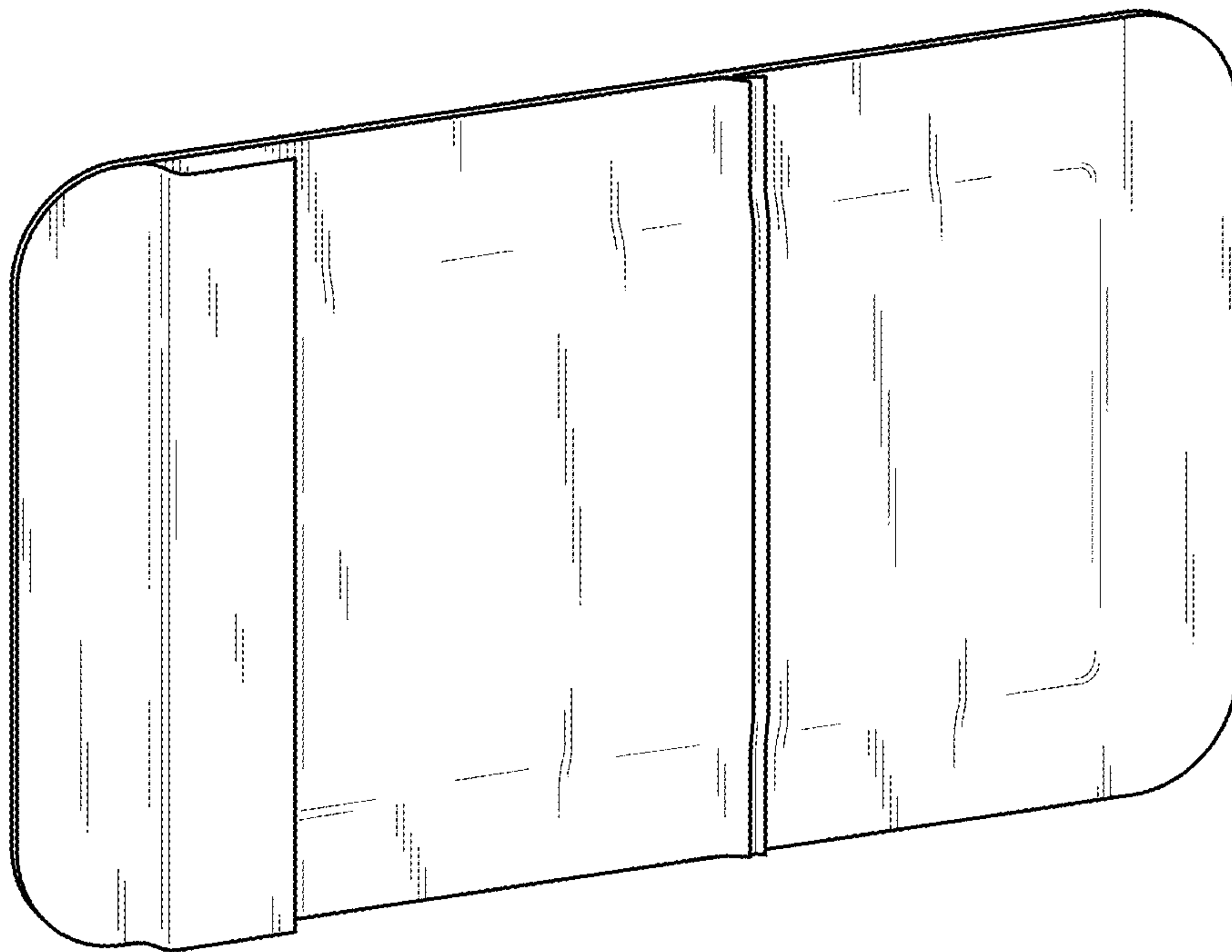

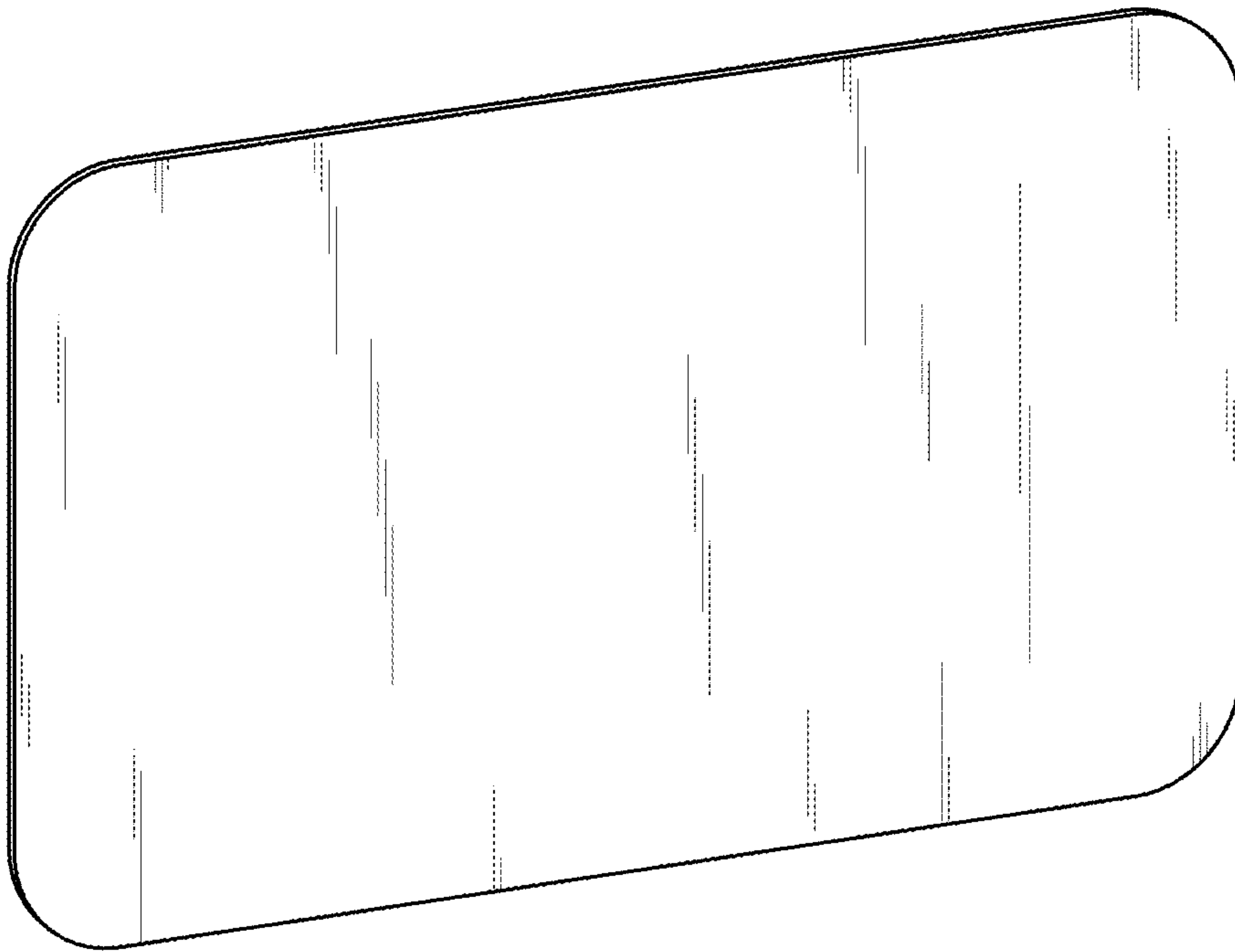

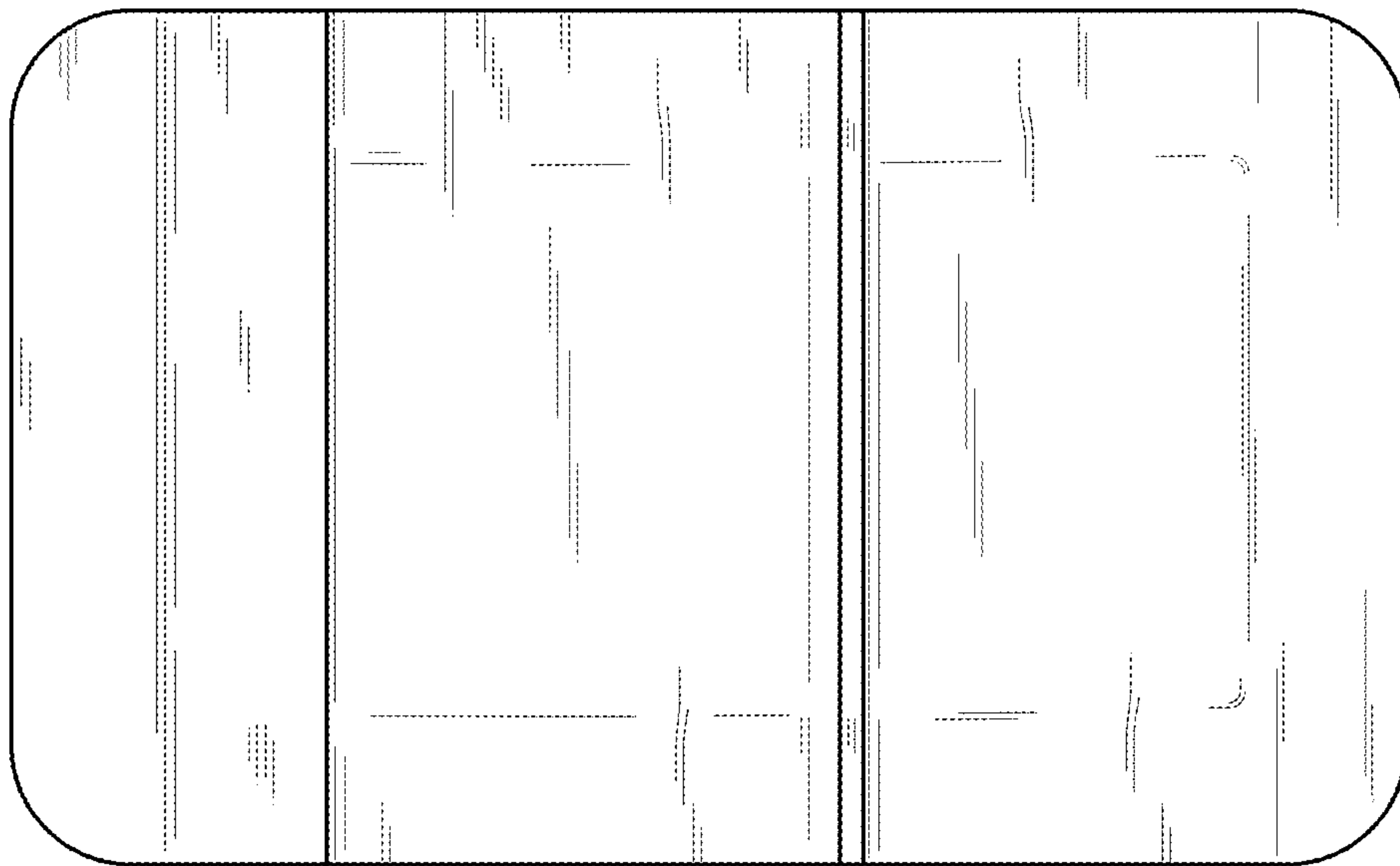

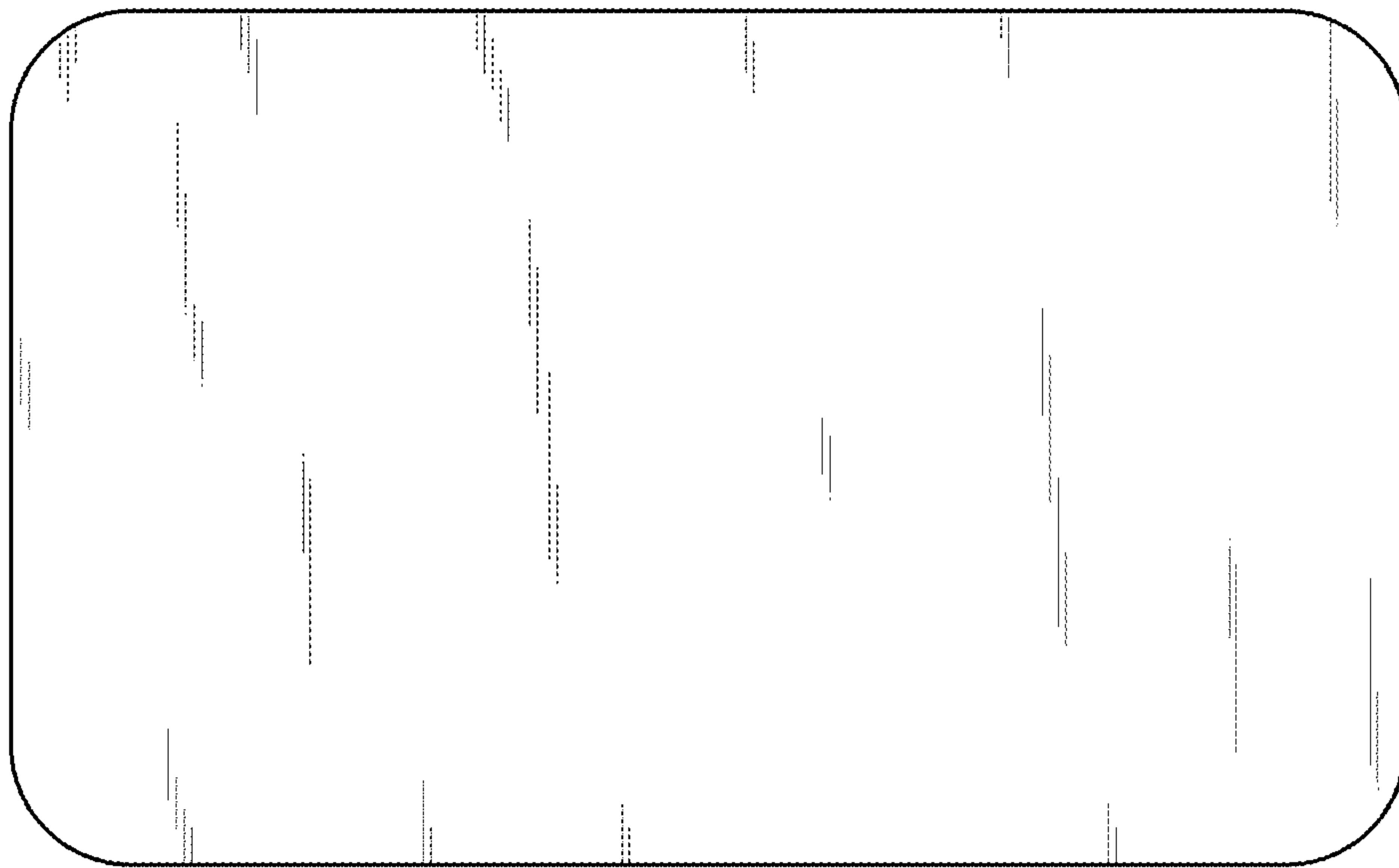

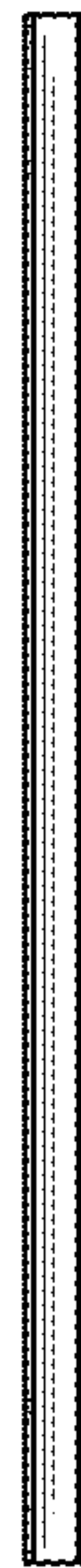

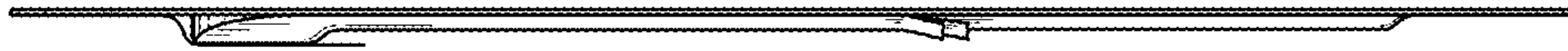

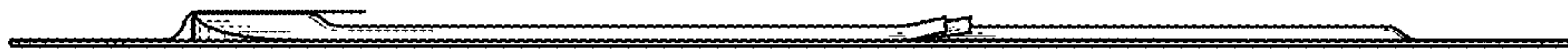

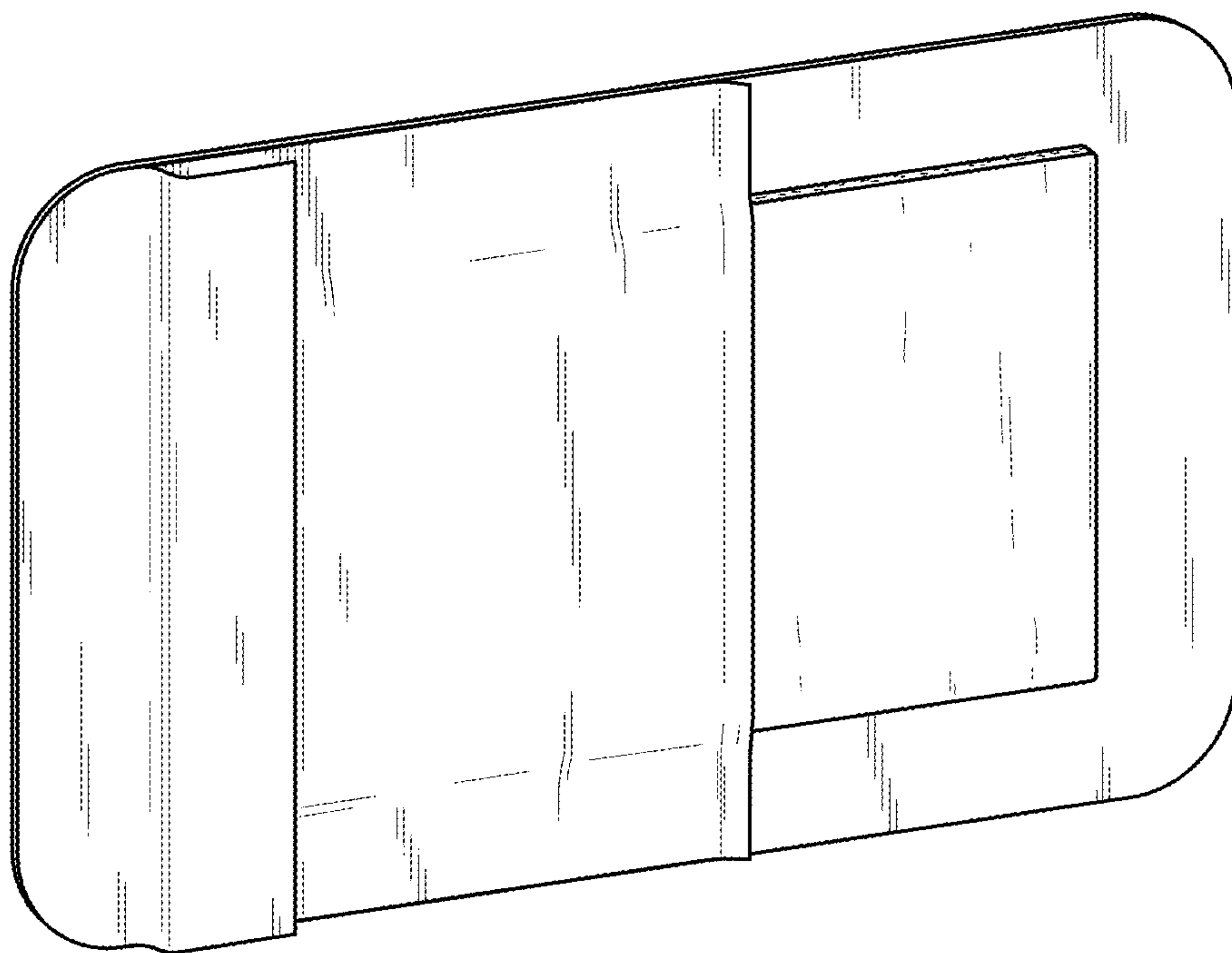

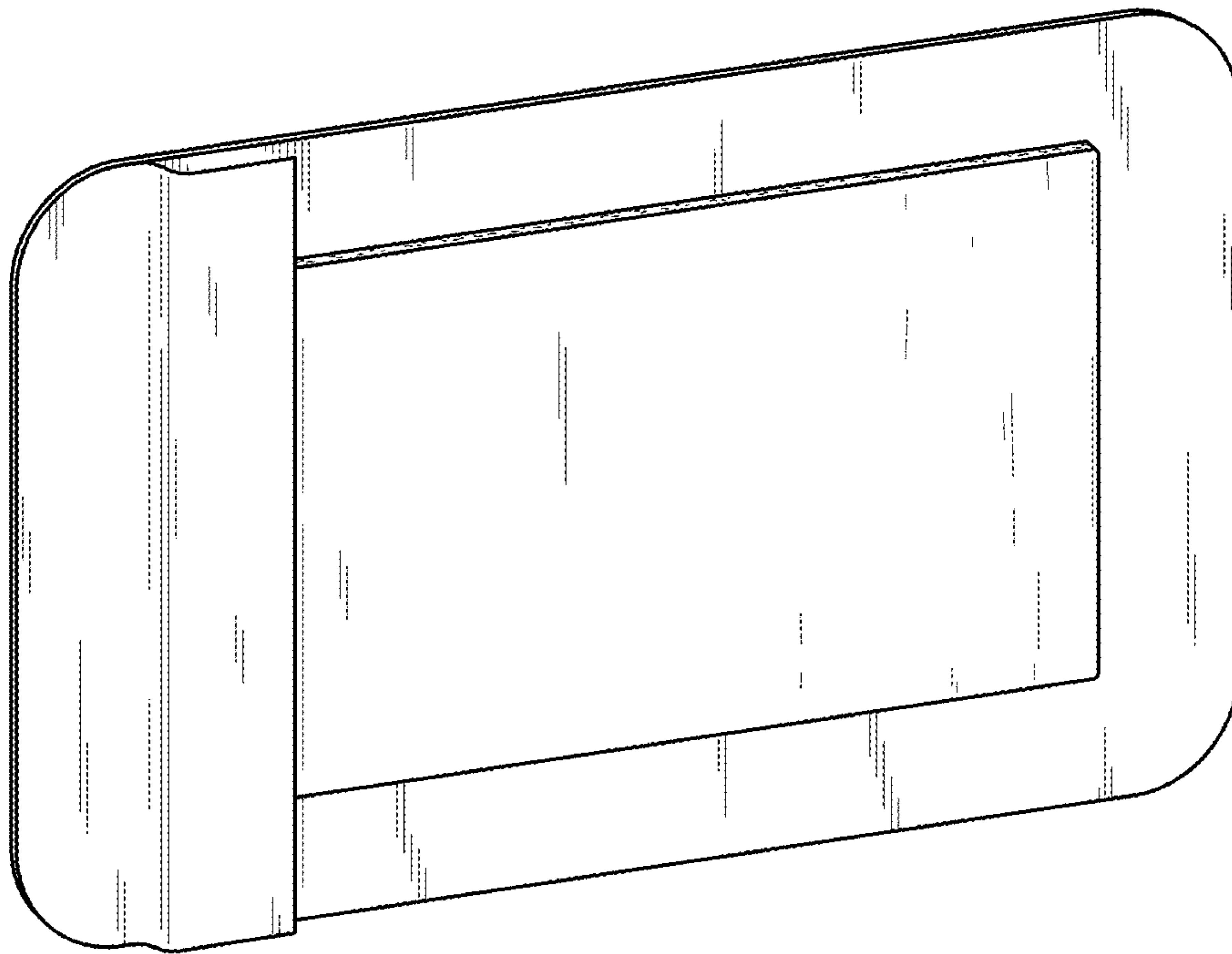

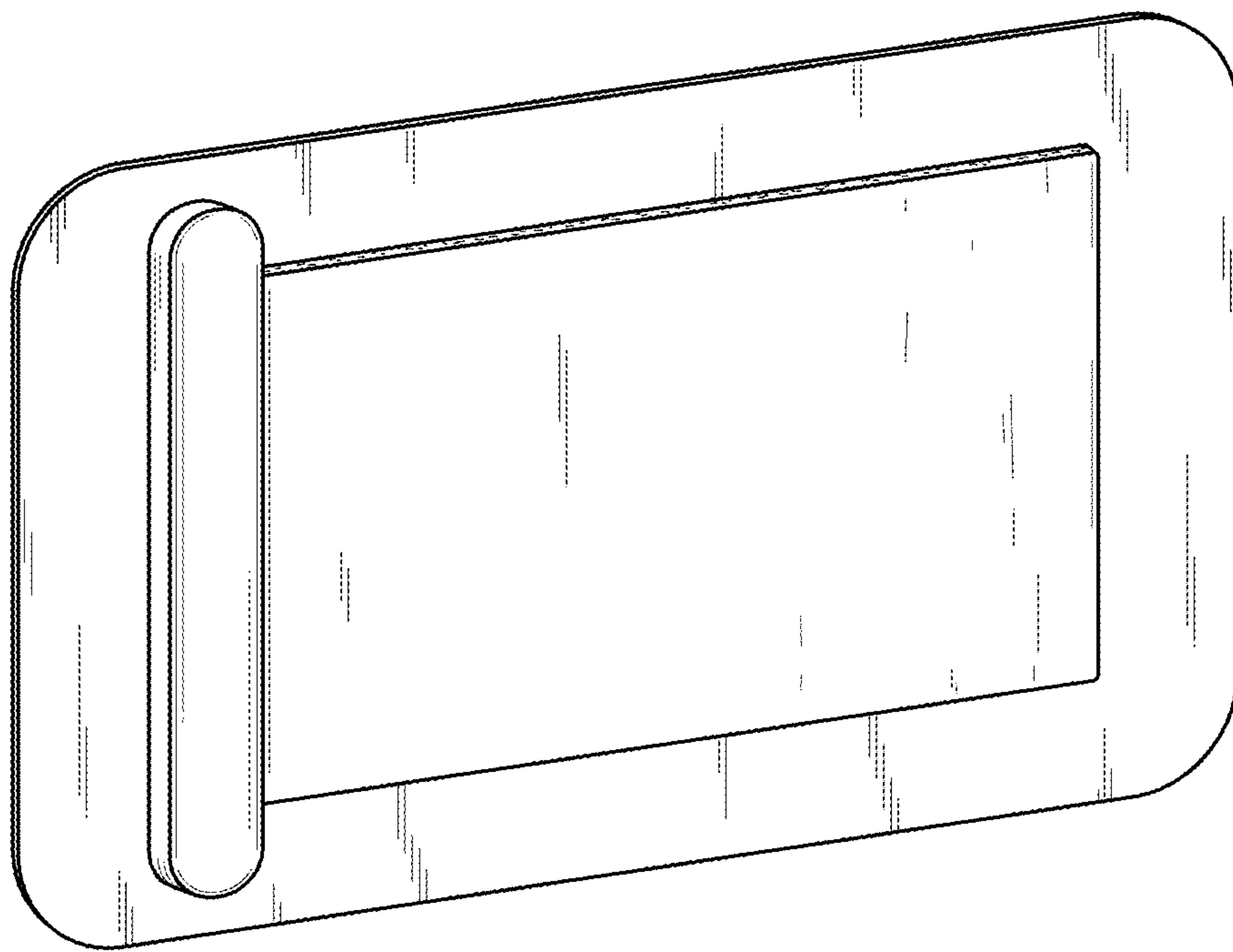

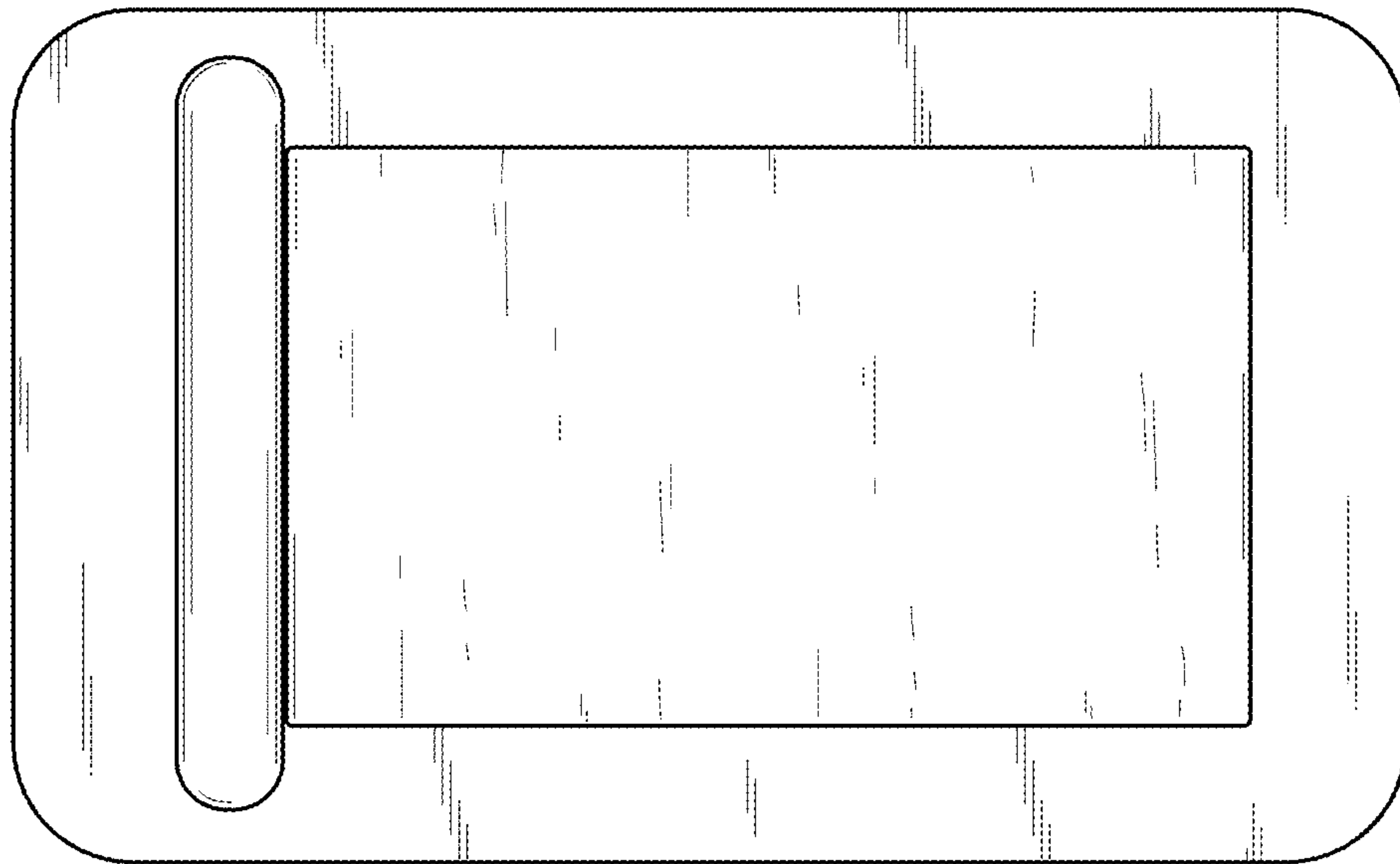

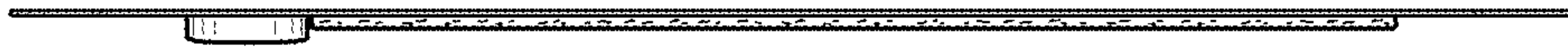

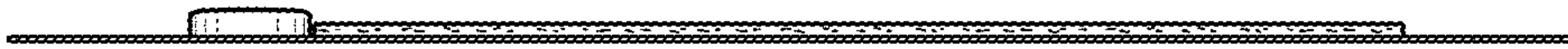

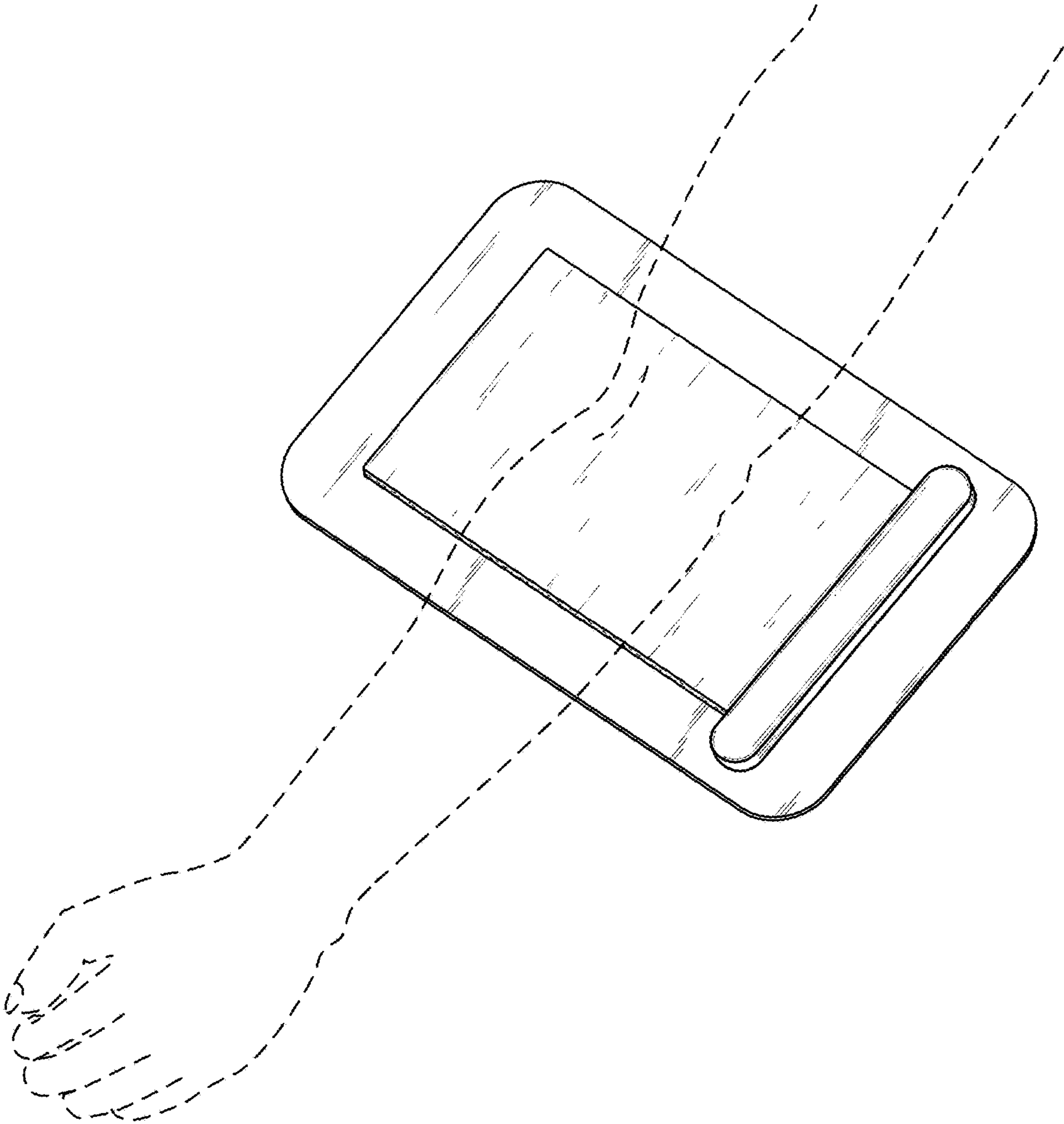

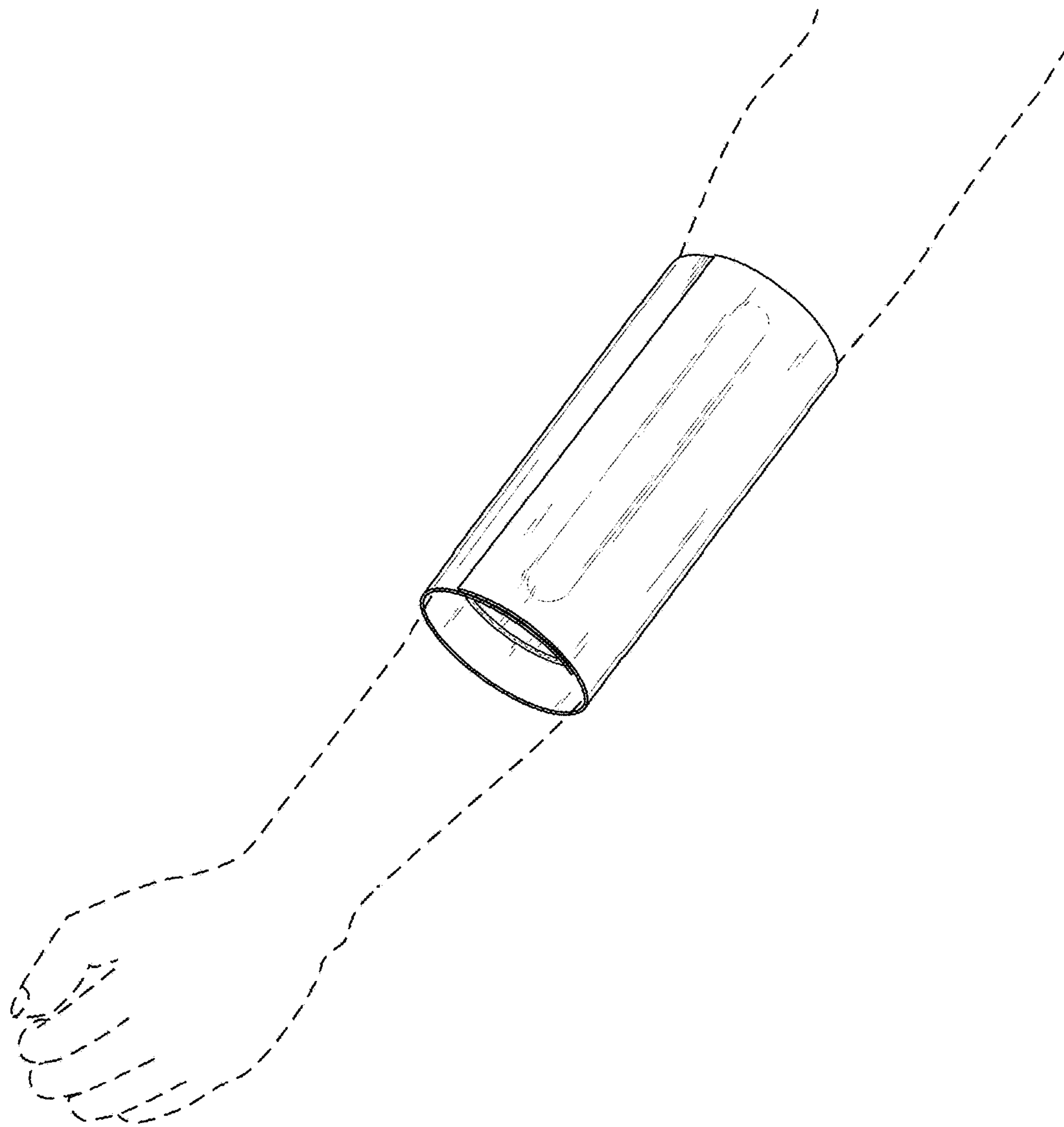

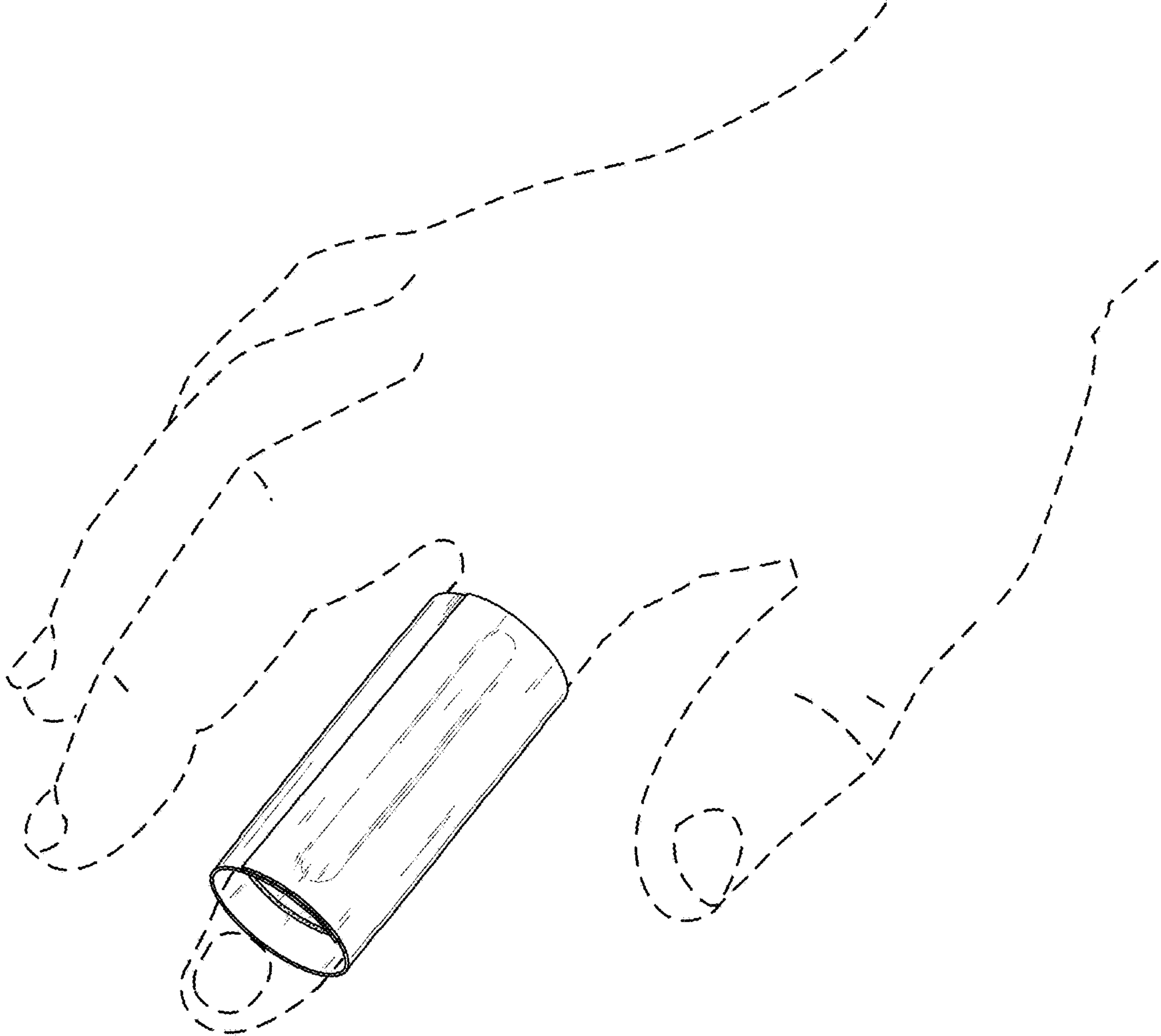
