FIG. 1 is a front isometric view of a shingle, showing our new design;

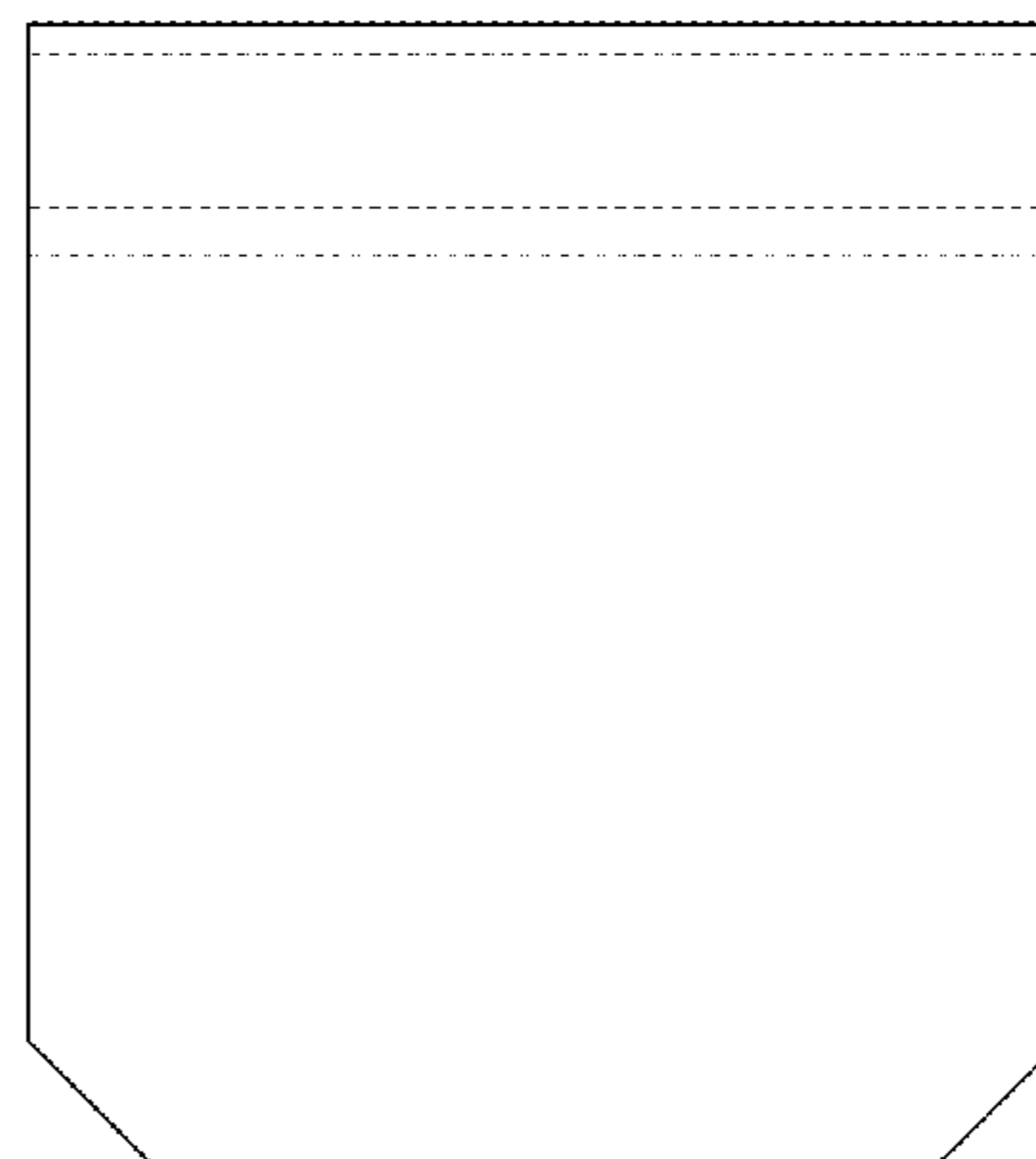
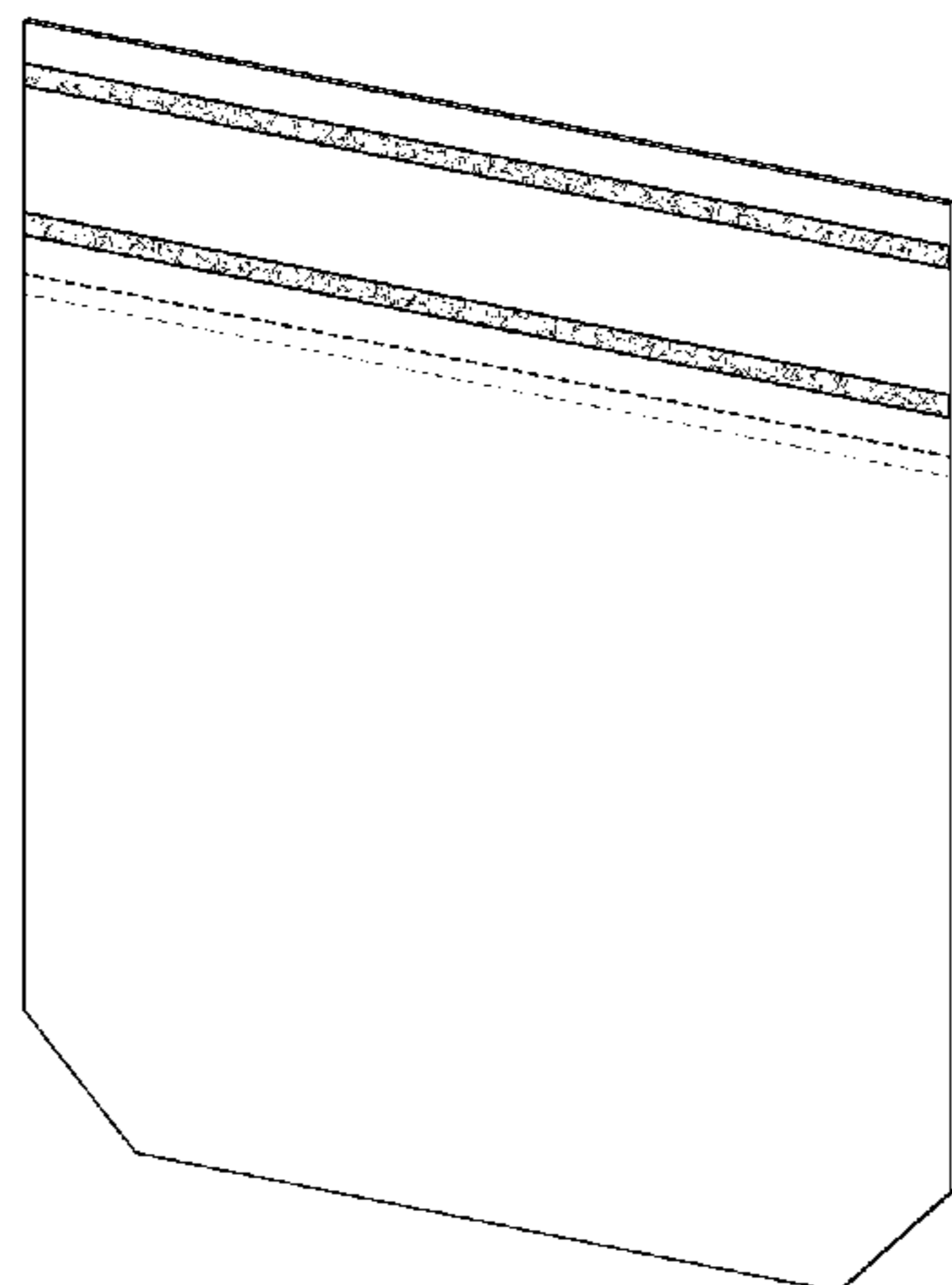
FIG. 2 is a right side elevation view of the shingle of FIG. 1;

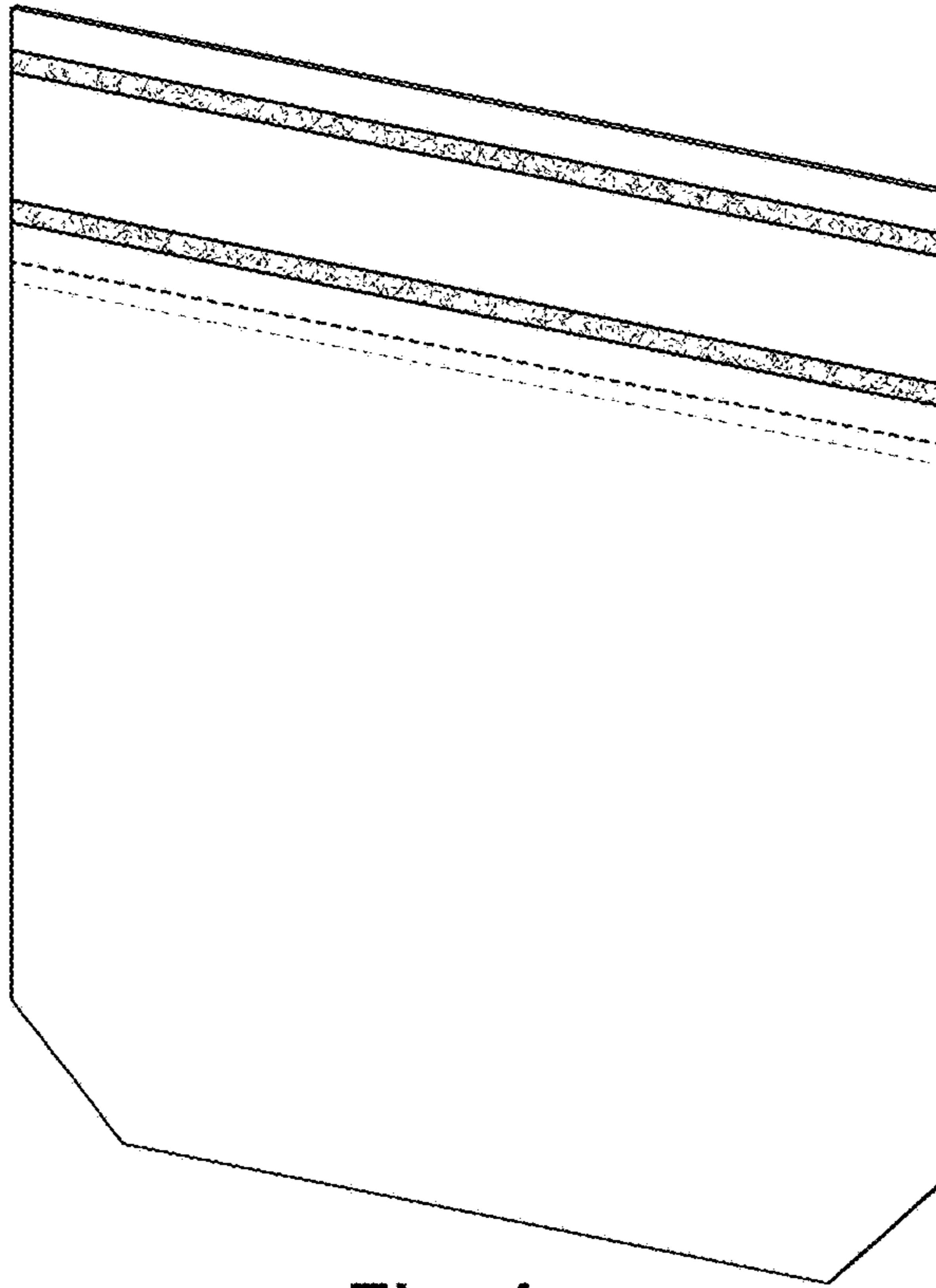

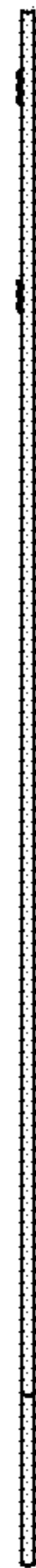

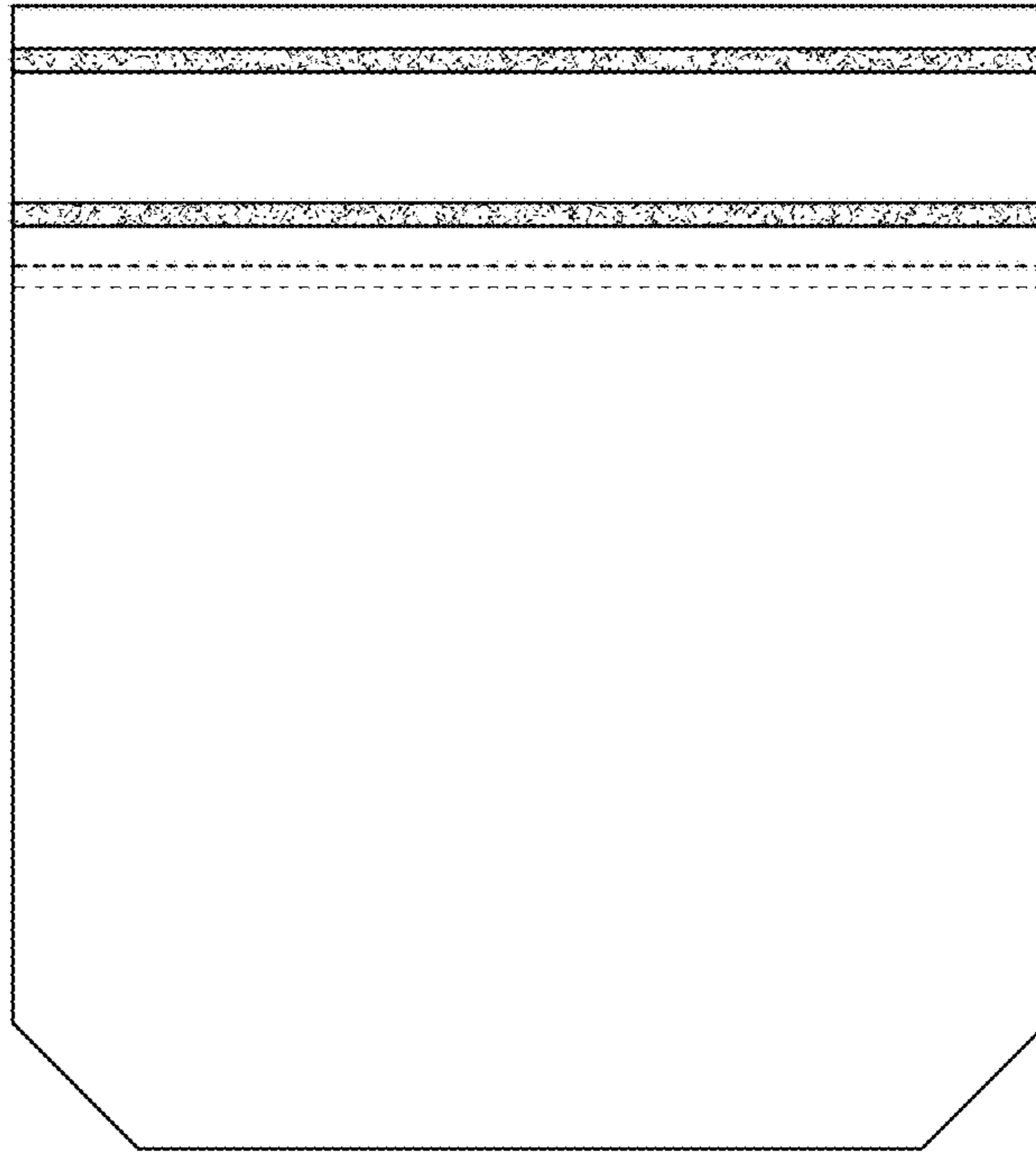
