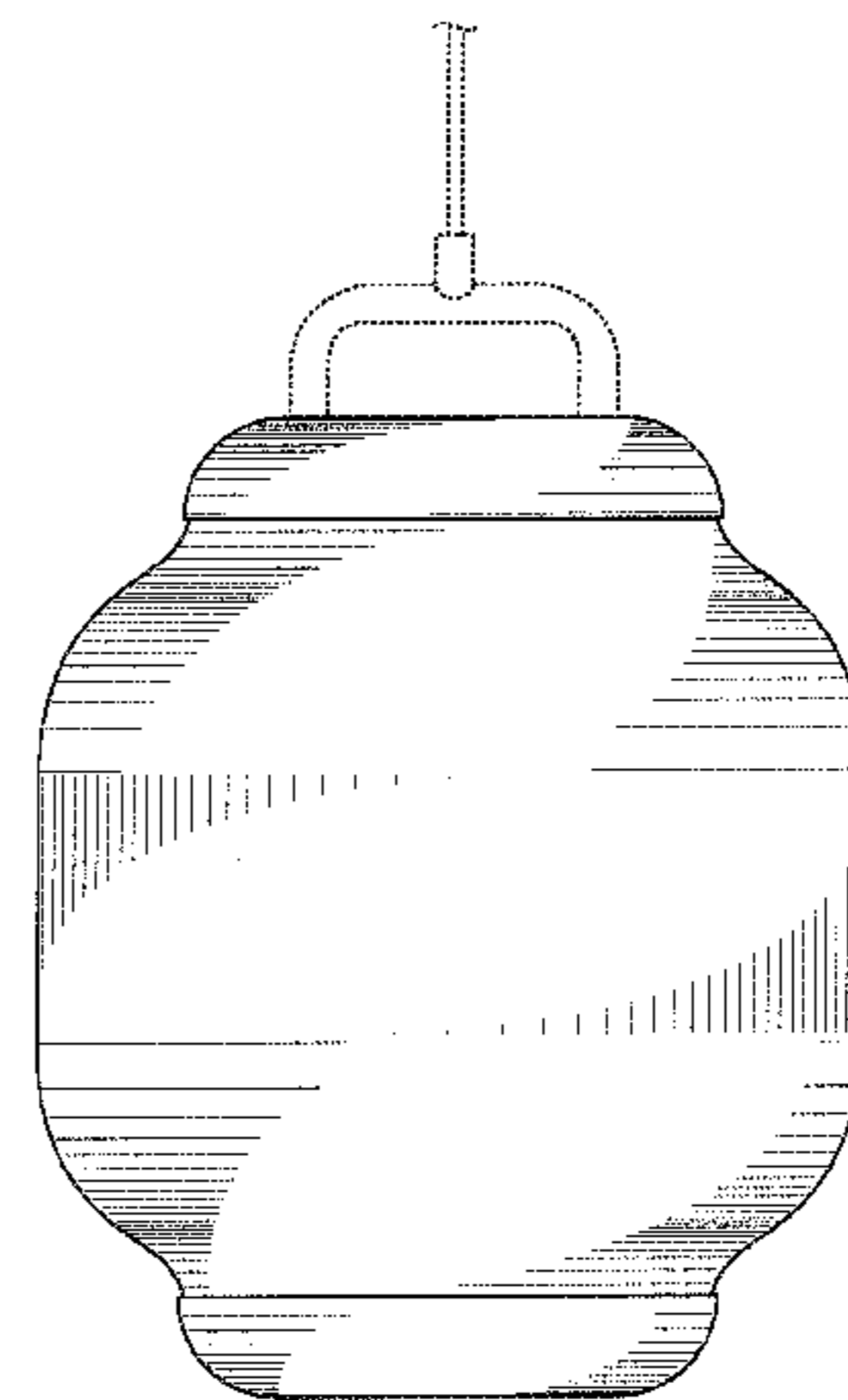
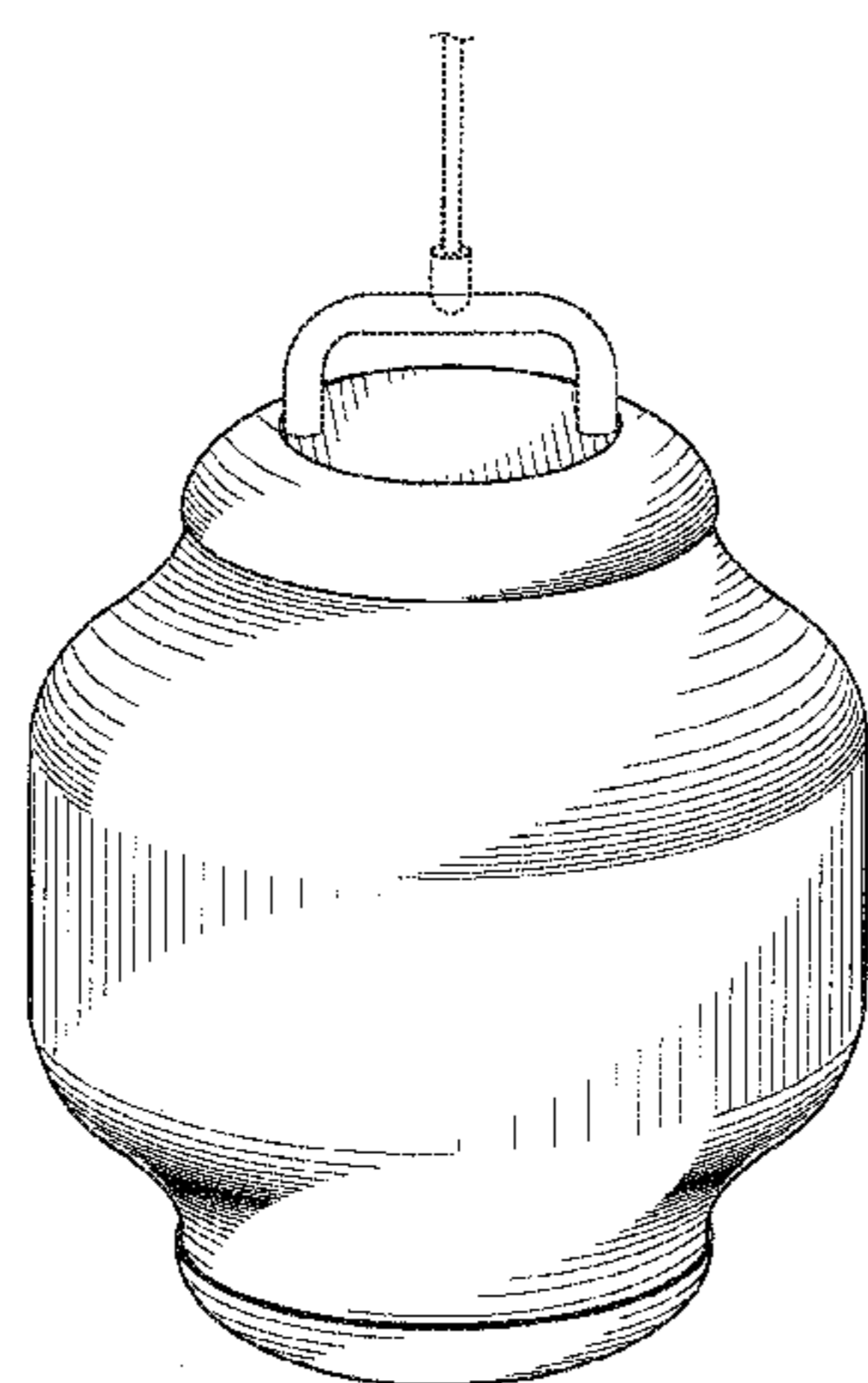
(57) **CLAIM**

The ornamental design for a lighting fixture, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a lighting fixture in accordance with the present invention; FIG. 2 is a front view thereof, a rear view being a mirror image thereof; FIG. 3 is a right side view thereof, a left side view being a mirror image thereof; FIG. 4 is a top view thereof; and, FIG. 5 is a bottom view thereof. The broken lines shown on the drawings depict portions of the lighting fixture that form no part of the claimed design.

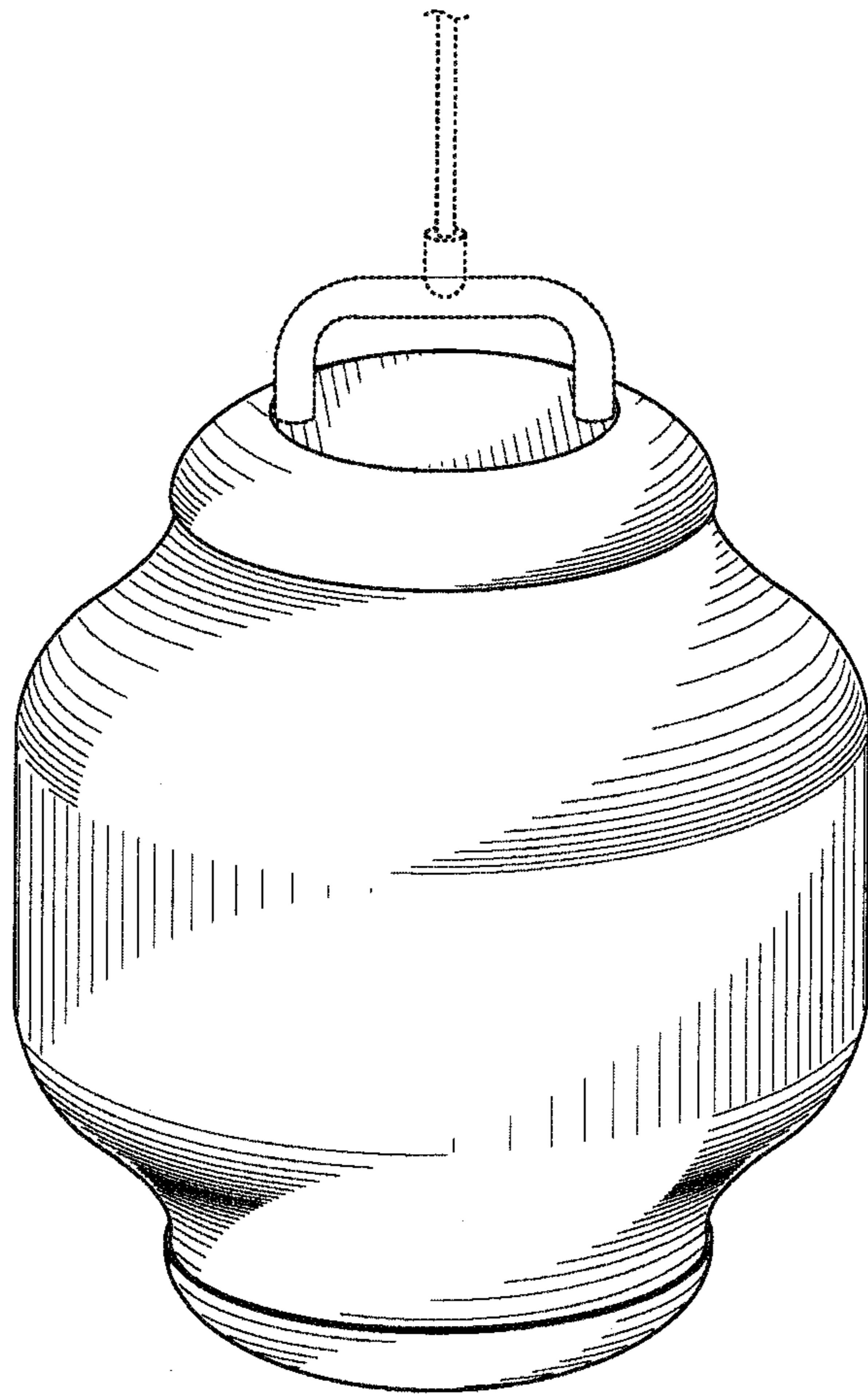

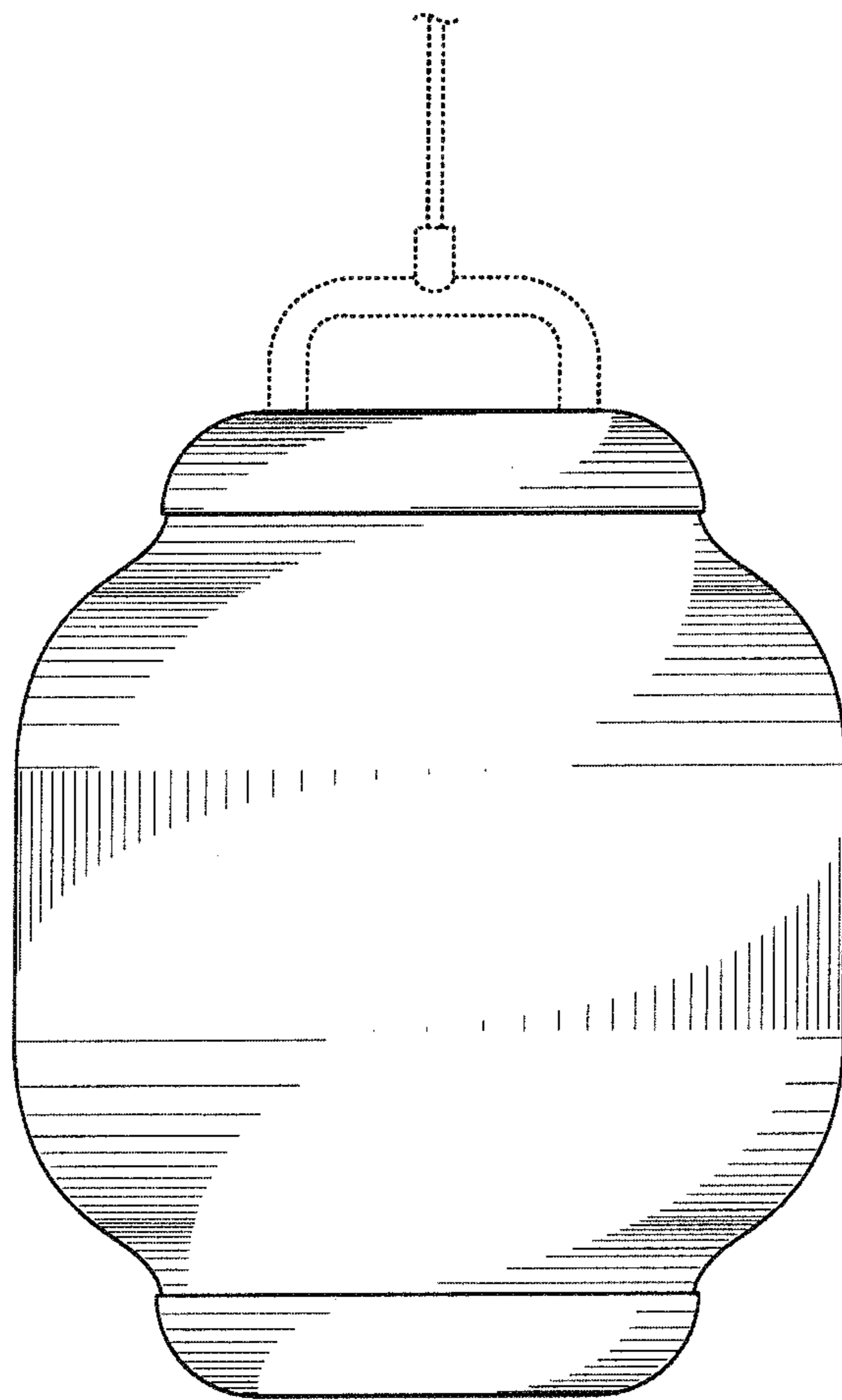

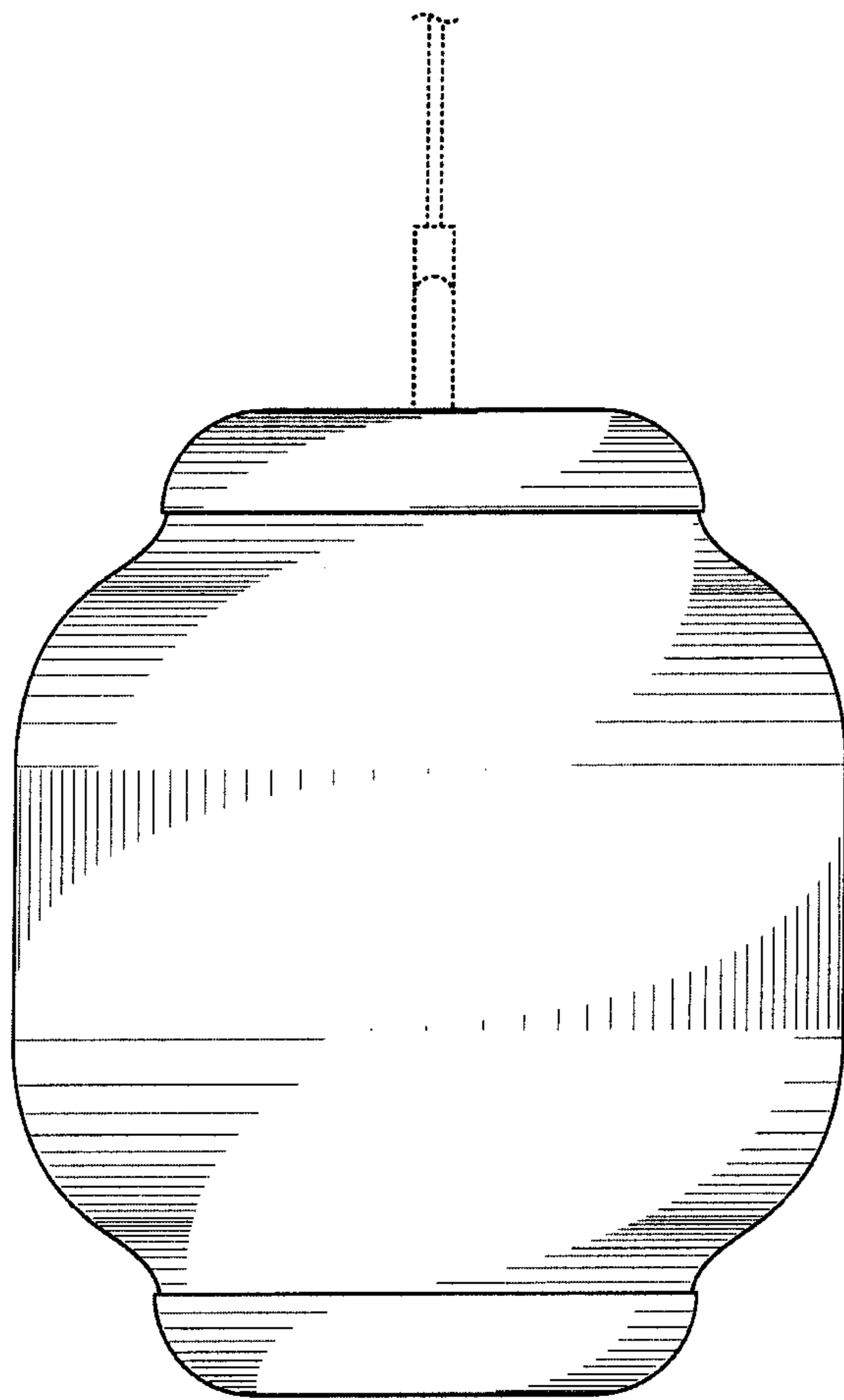

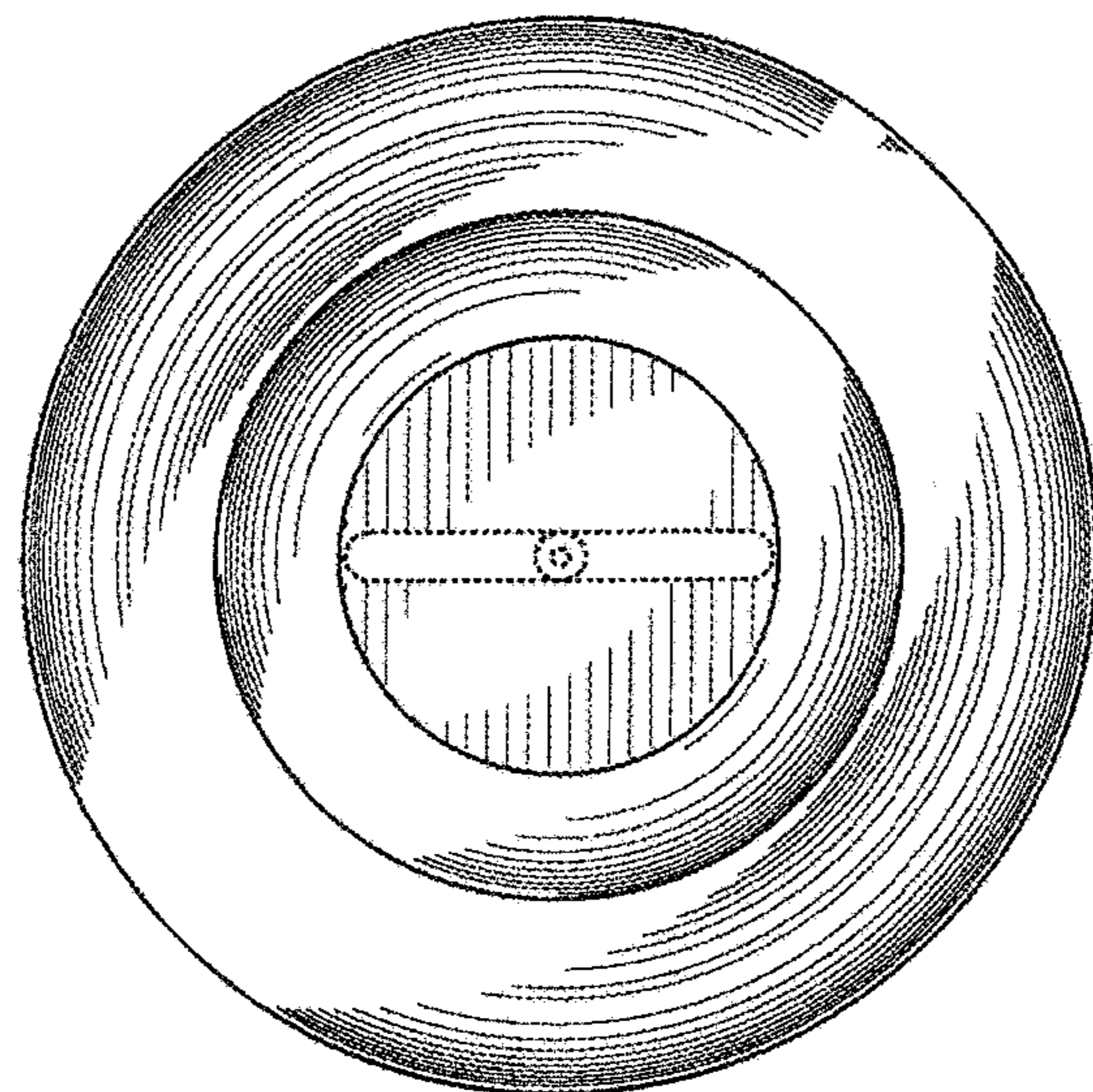

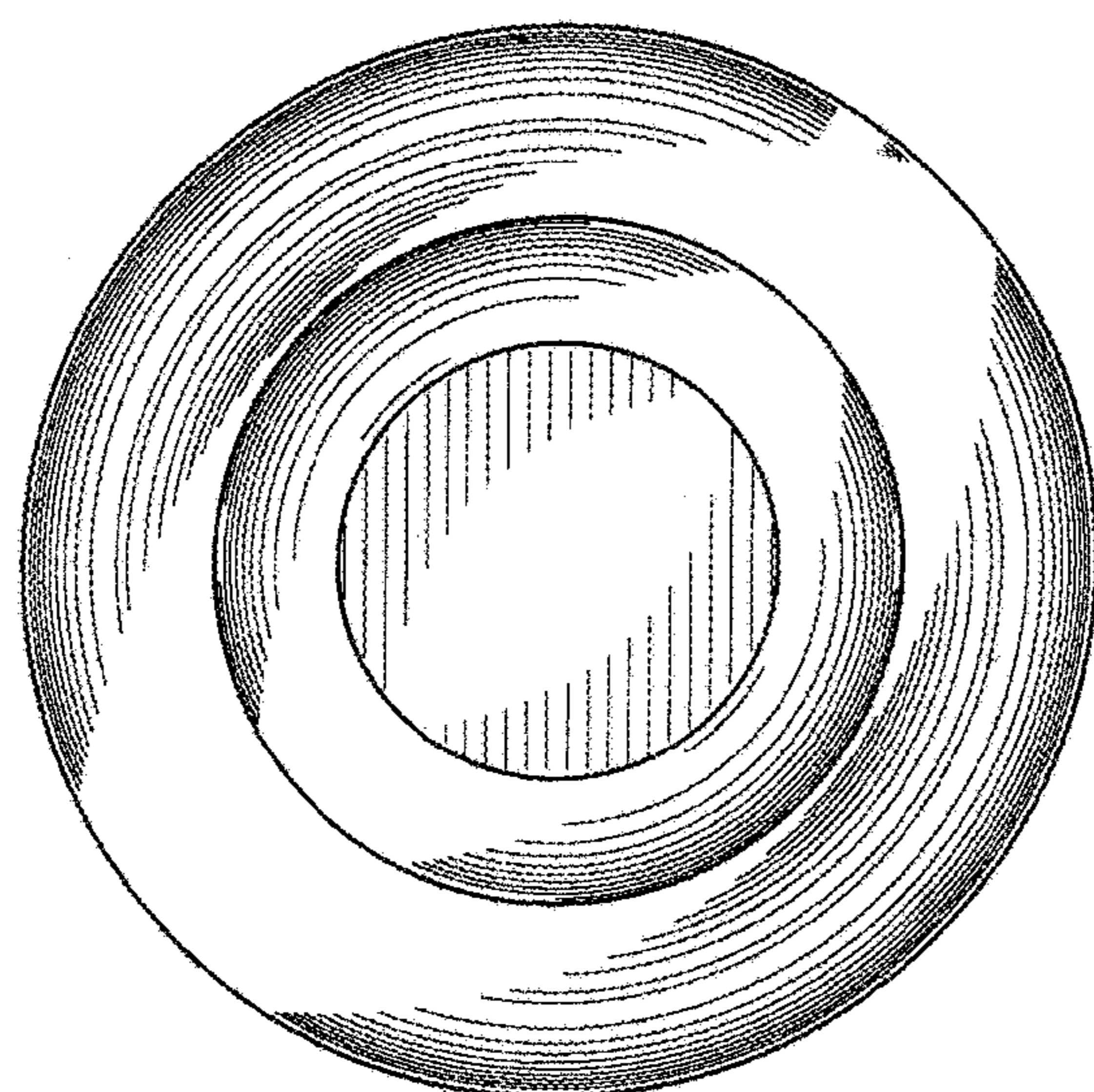
