(57) **CLAIM**

The ornamental design for a garment wrap for dog, as shown and described.

DESCRIPTION

FIG. 1 is a bottom plan view of a garment wrap for dog showing our new design in a fully opened condition;

FIG. 2 is a top plan view;

FIG. 3 is a bottom plan view in a partially folded condition;

FIG. 4 is a bottom plan view in a second partially folded condition;

FIG. 5 is a bottom plan view in a third partially folded condition;

FIG. 6 is a top plan view in a fully folded condition;

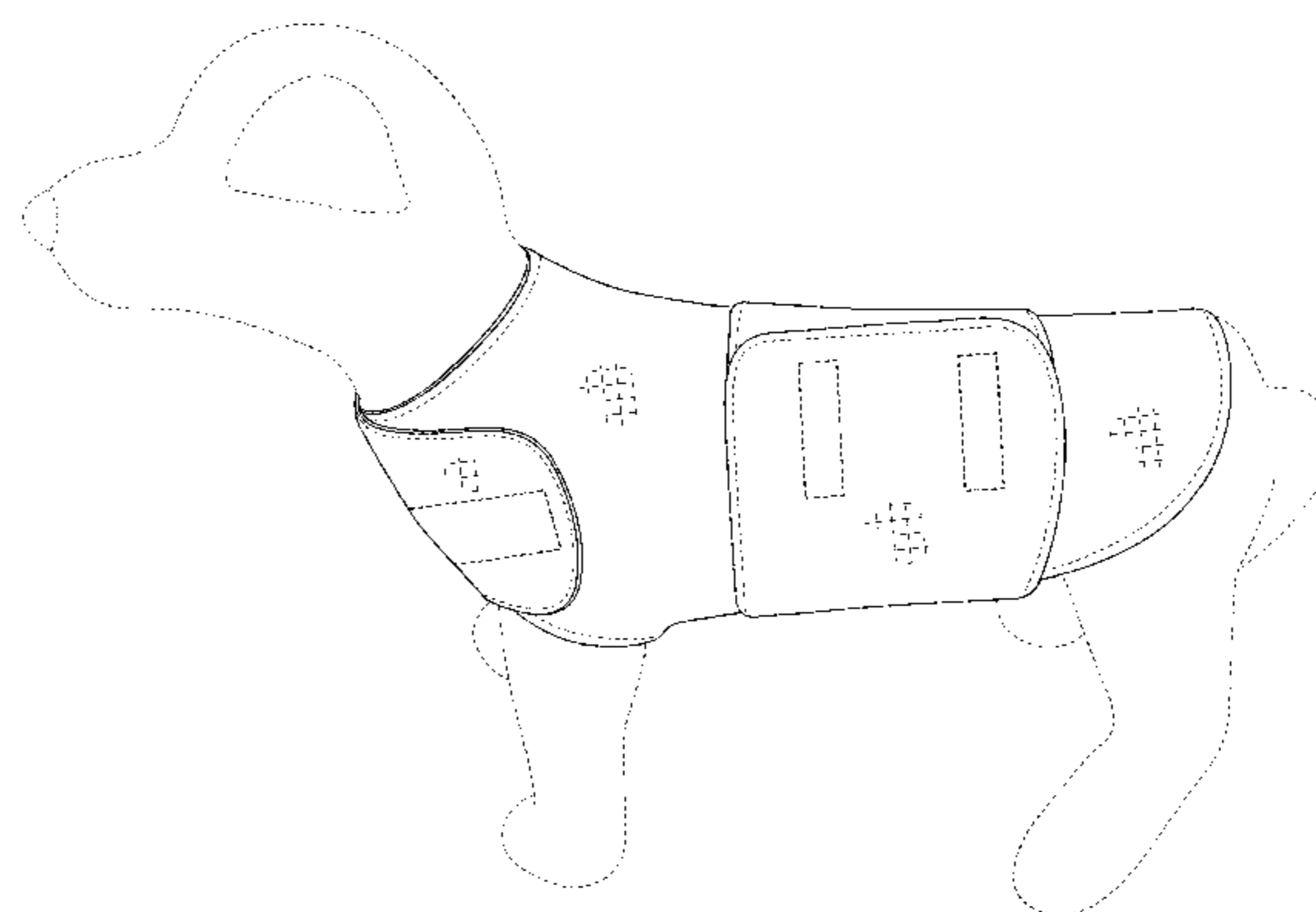
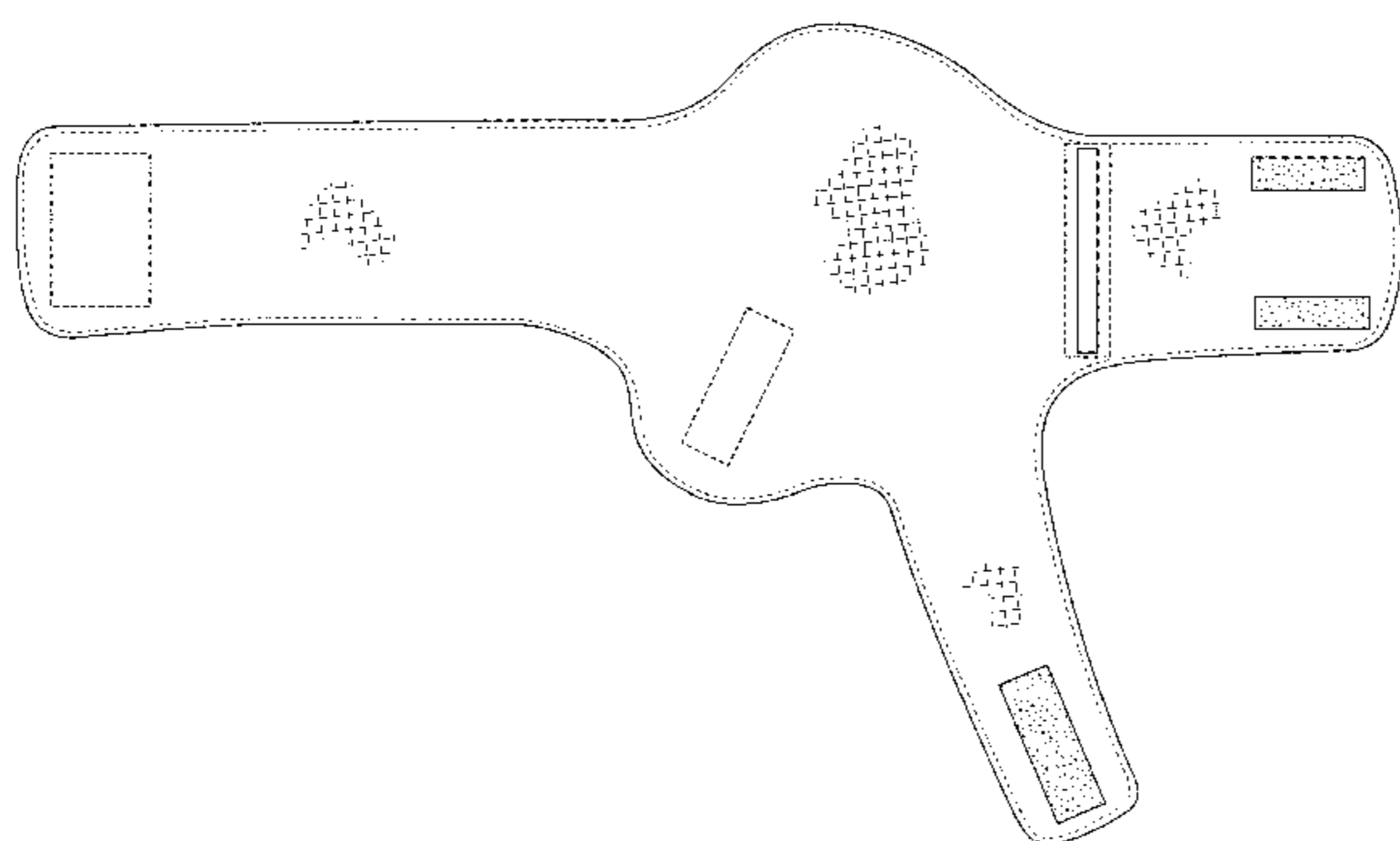
FIG. 7 is a right side perspective view shown in a condition of use; and,

FIG. 8 is a left side perspective view shown in an alternate condition of use.

In FIGS. 7 and 8, the broken line showing of a dog depicts environmental subject matter only and forms no part of the claimed design. The broken line showing on the garment wrap for dog depicts stitching and forms no part of the claimed design.

The drawings are shaded to indicate contrasting surfaces.

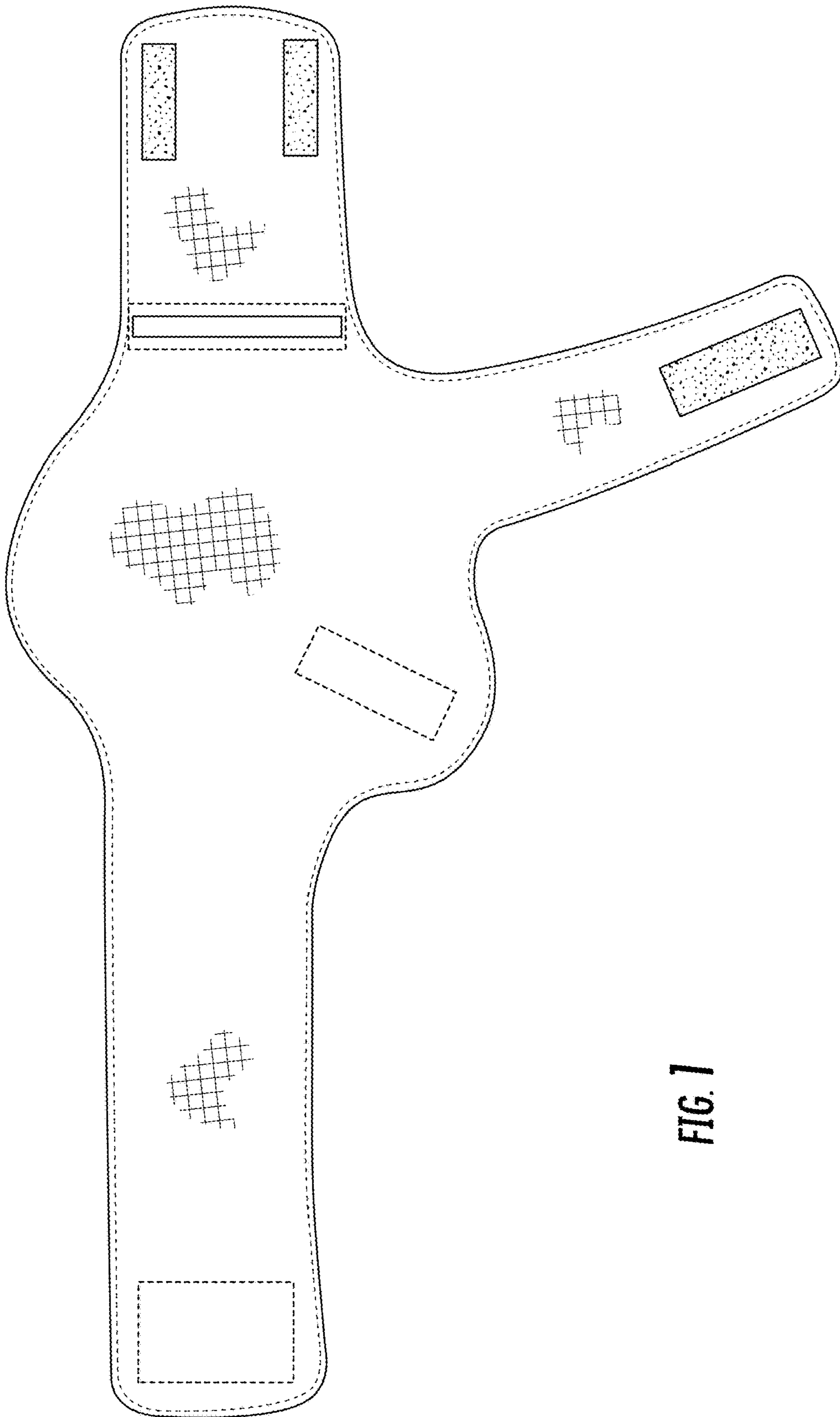

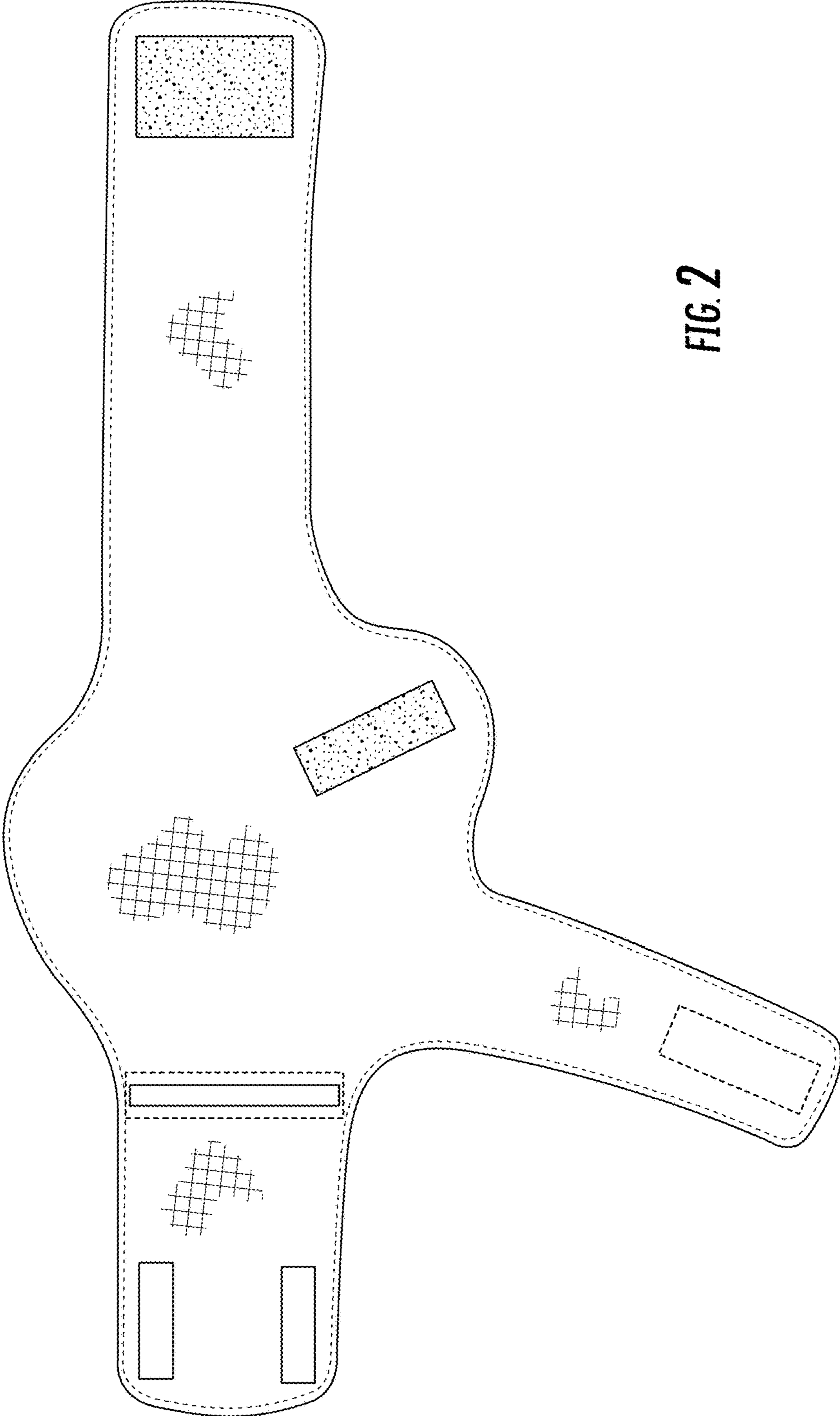

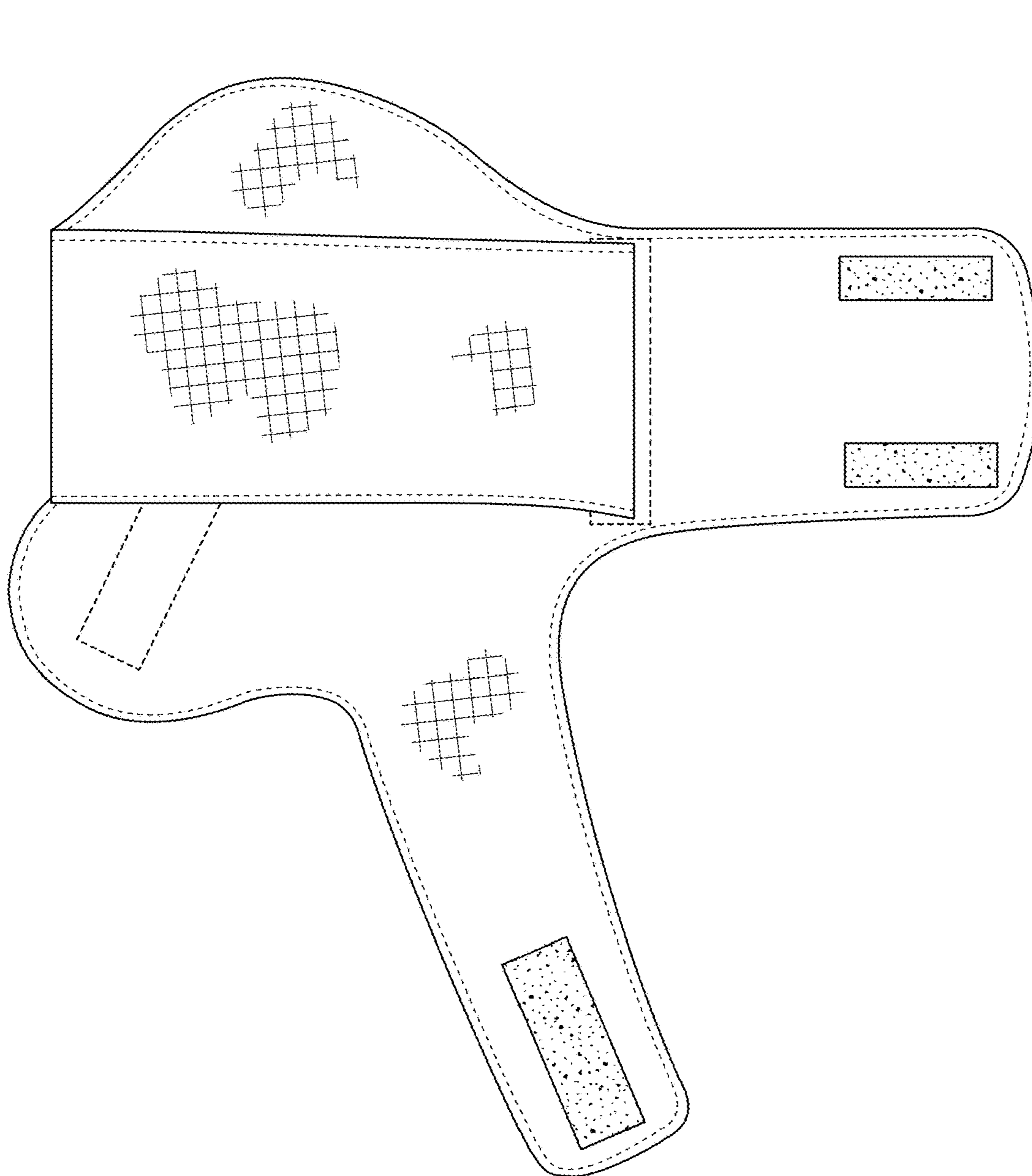

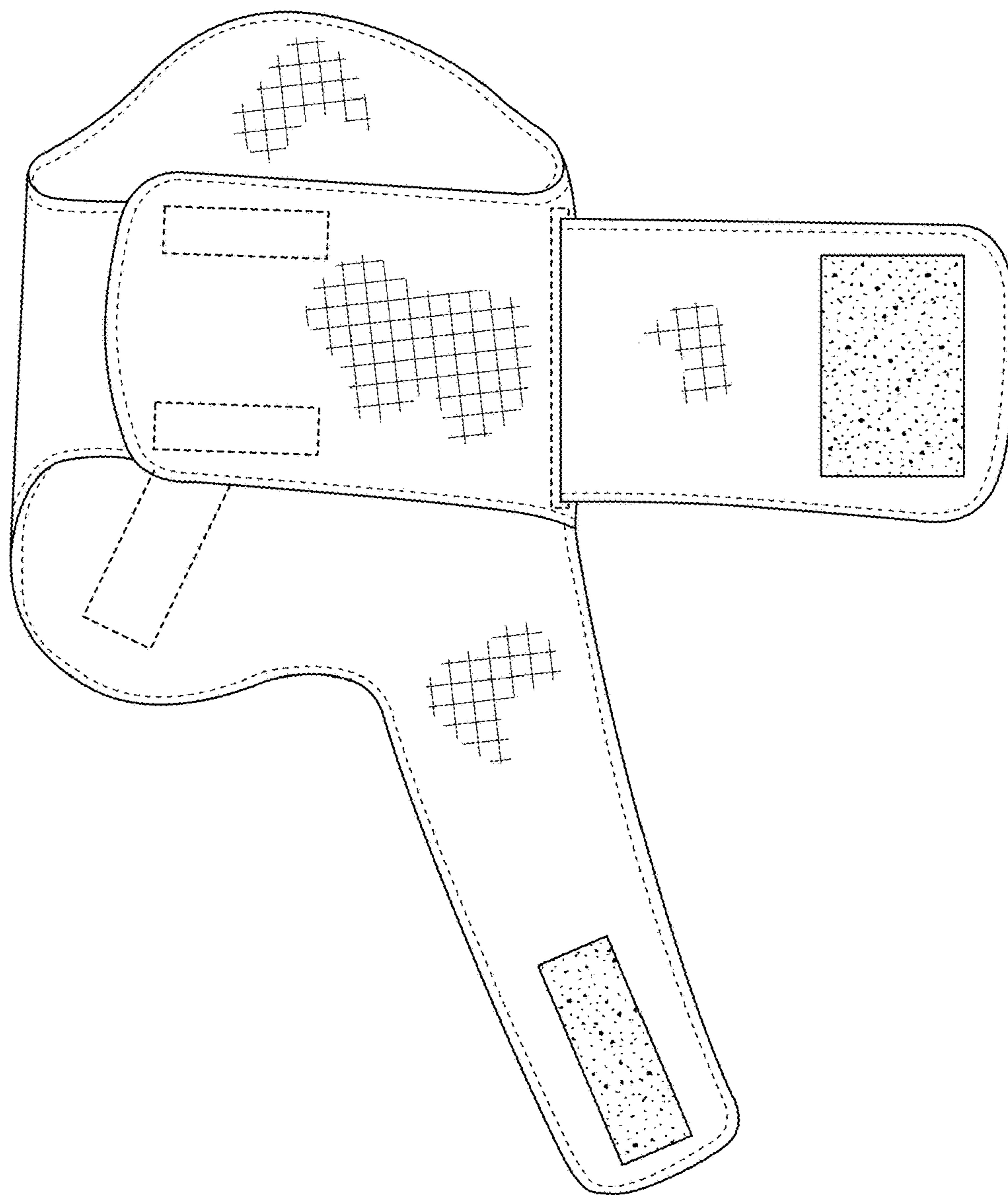

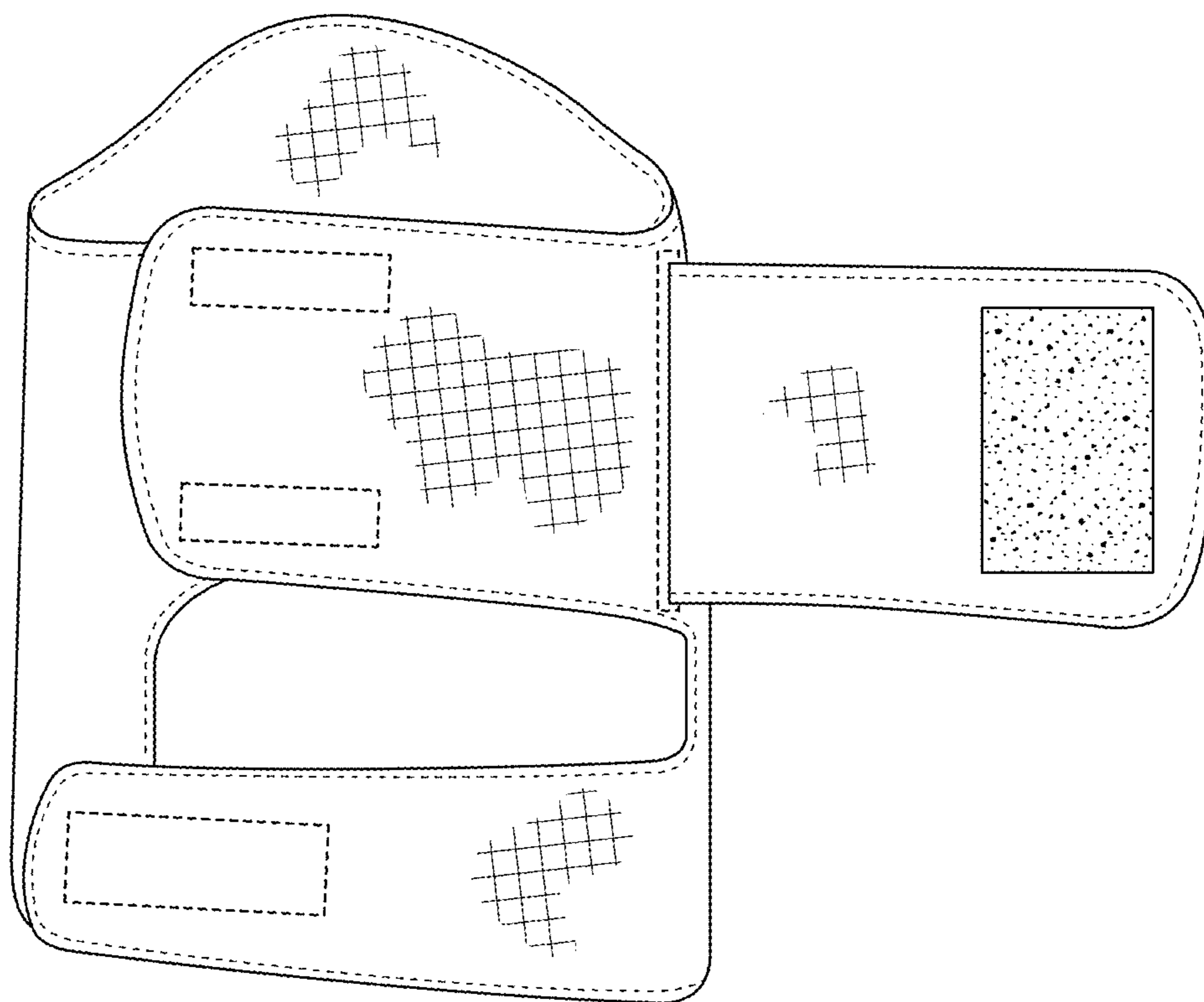

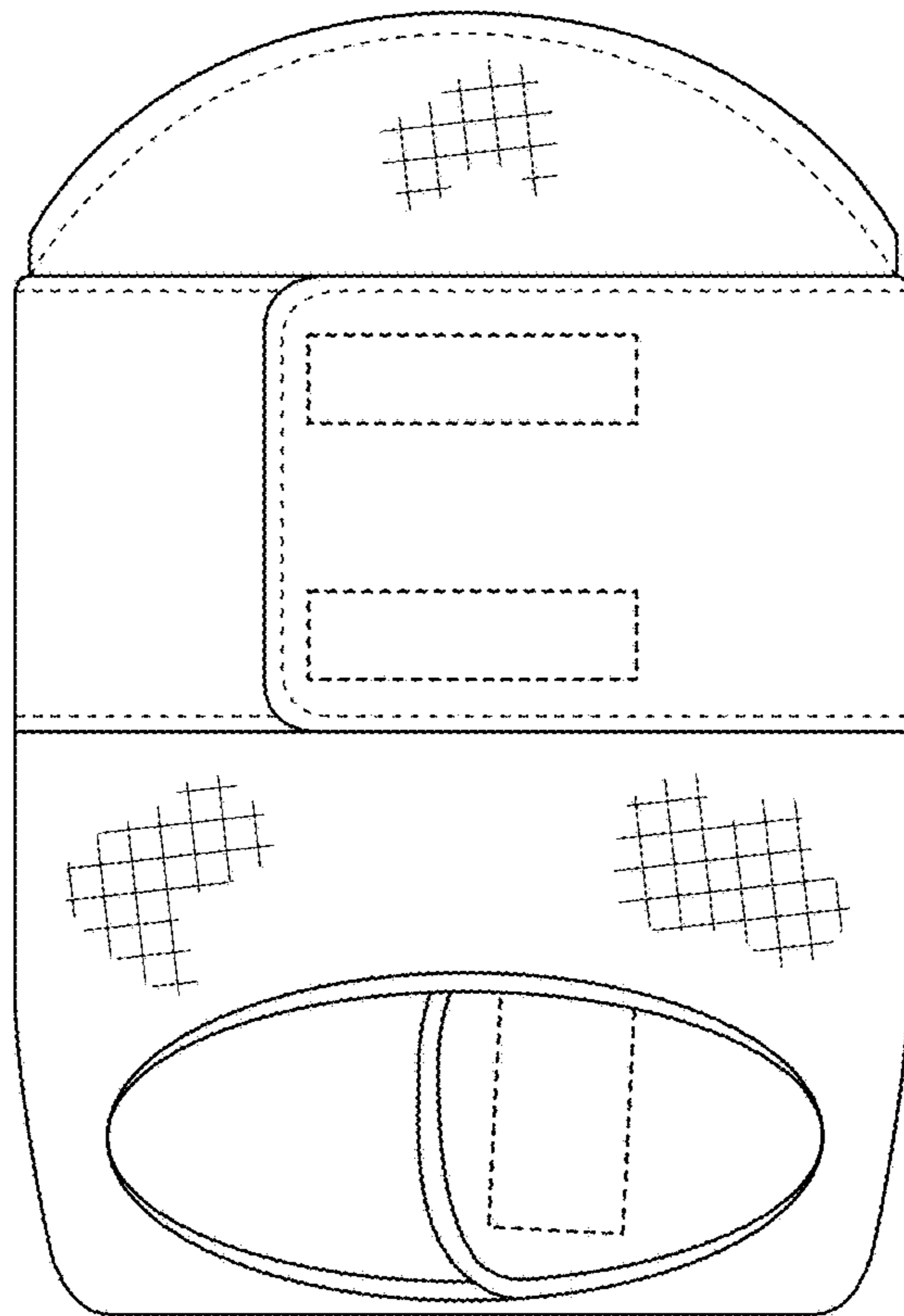

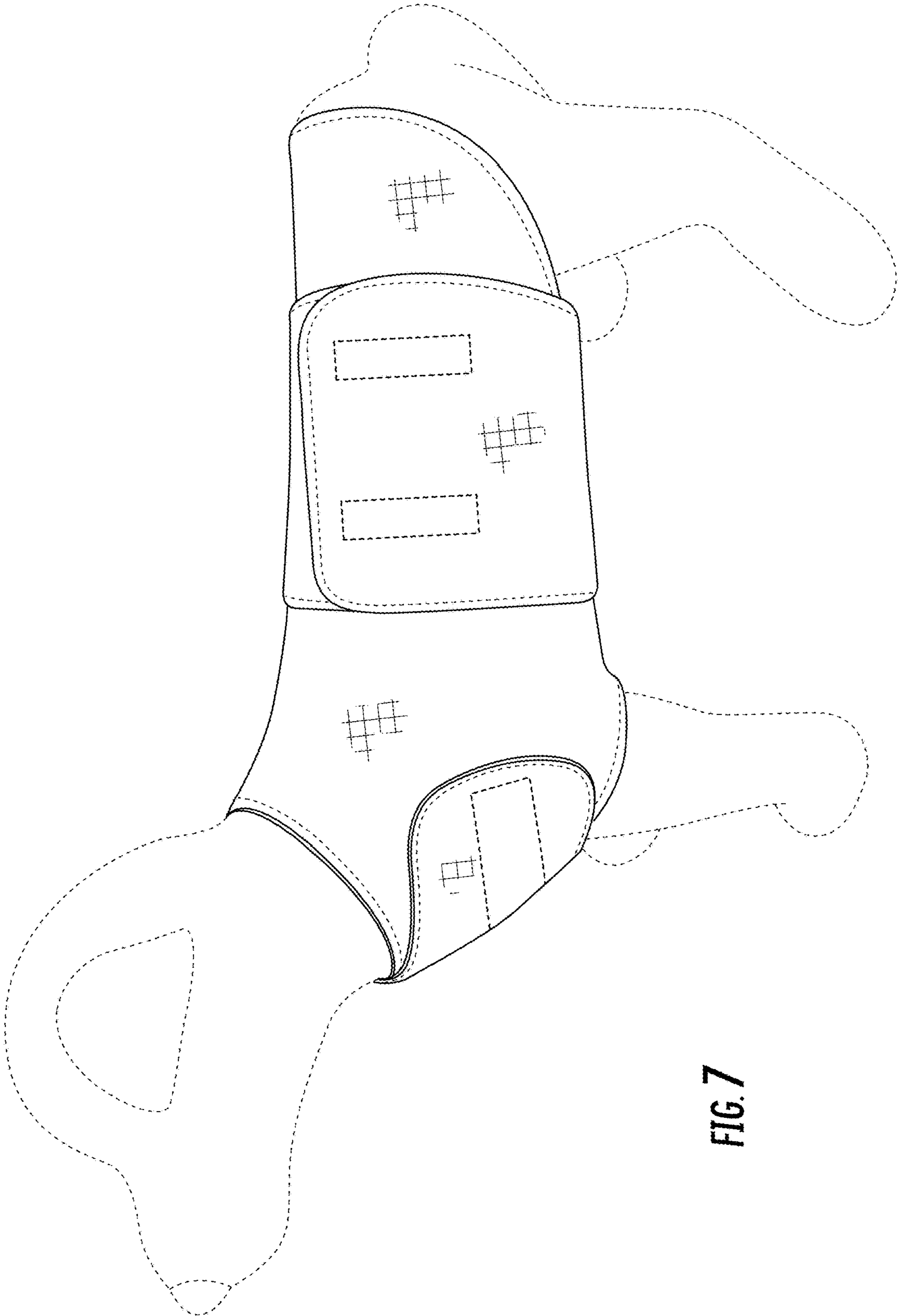

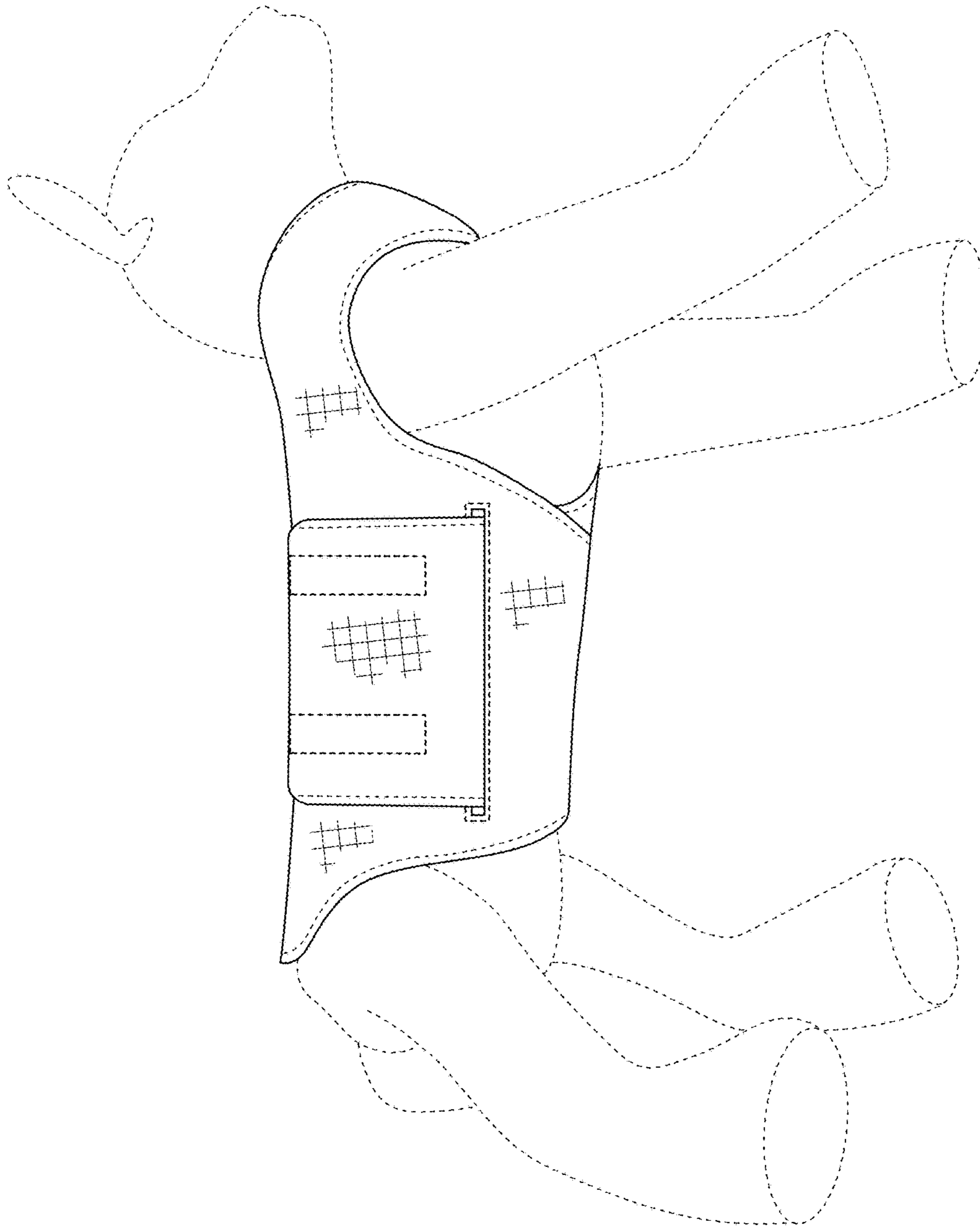
