(57) **CLAIM**

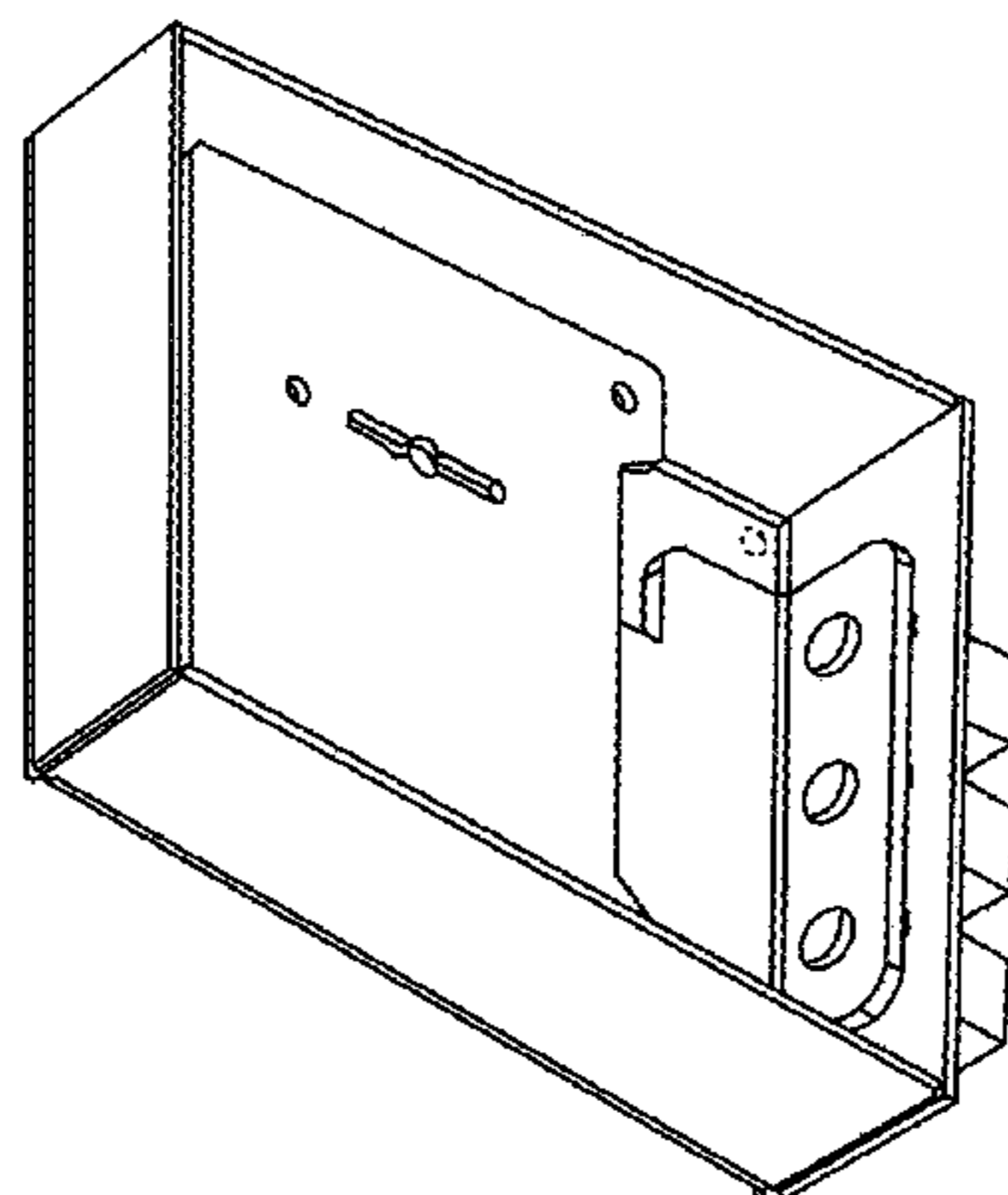
The ornamental design for a gun safe, as shown and described.

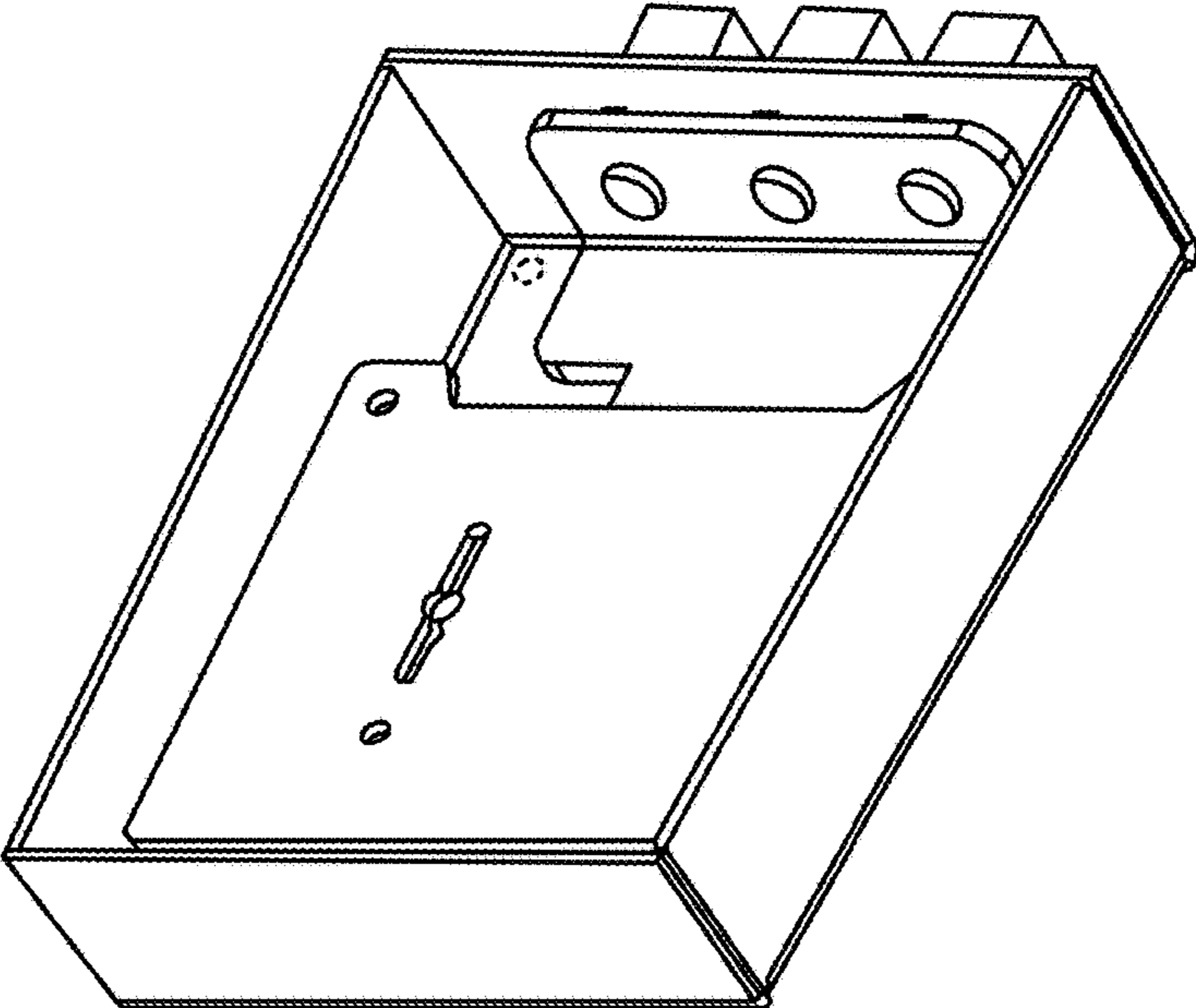

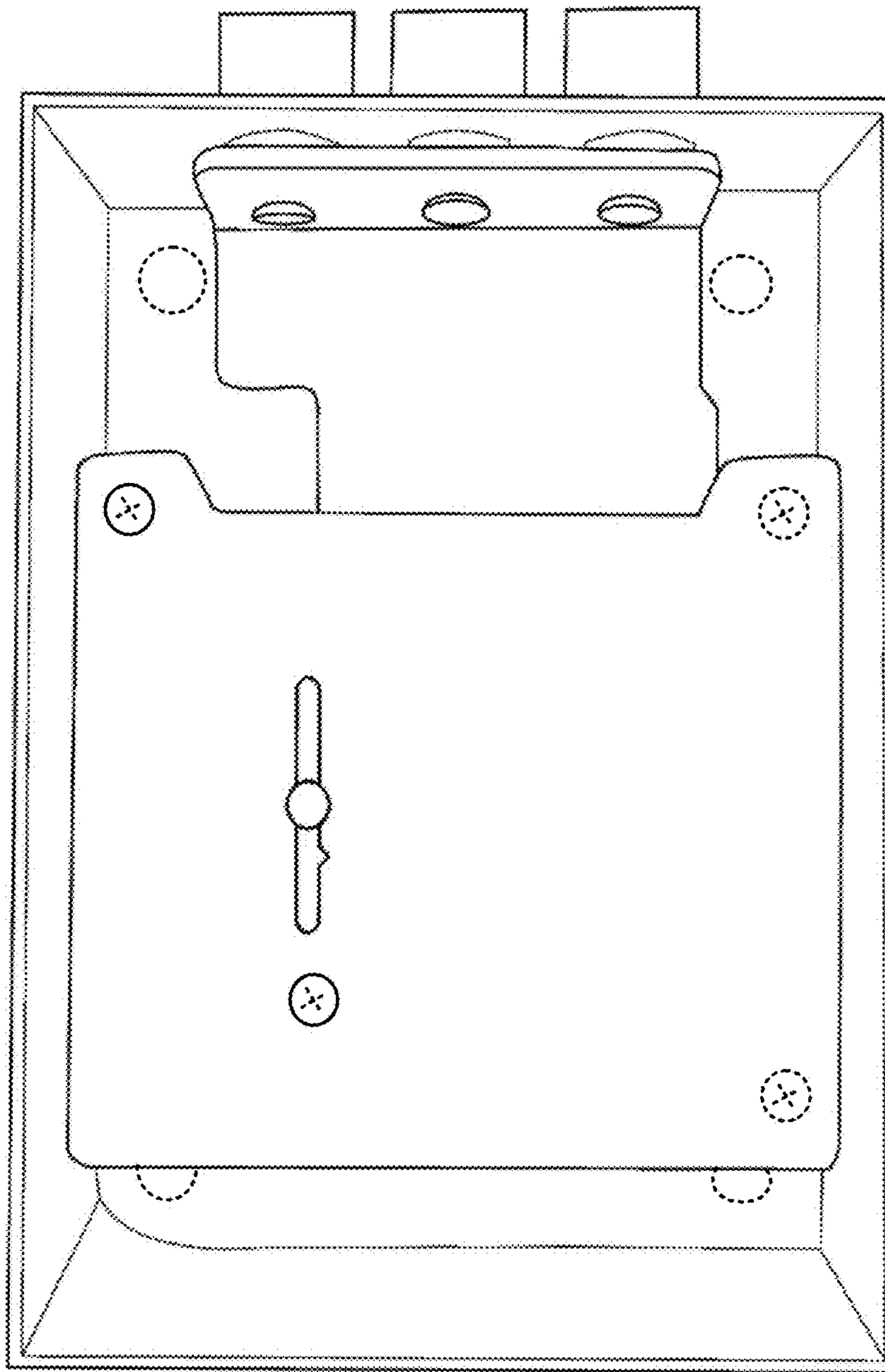

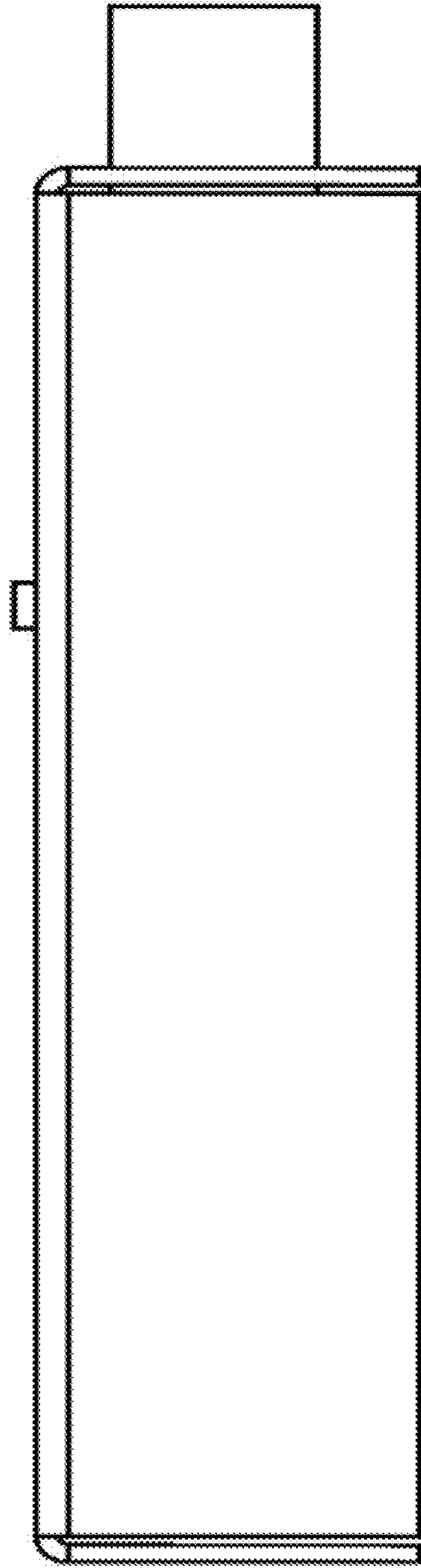
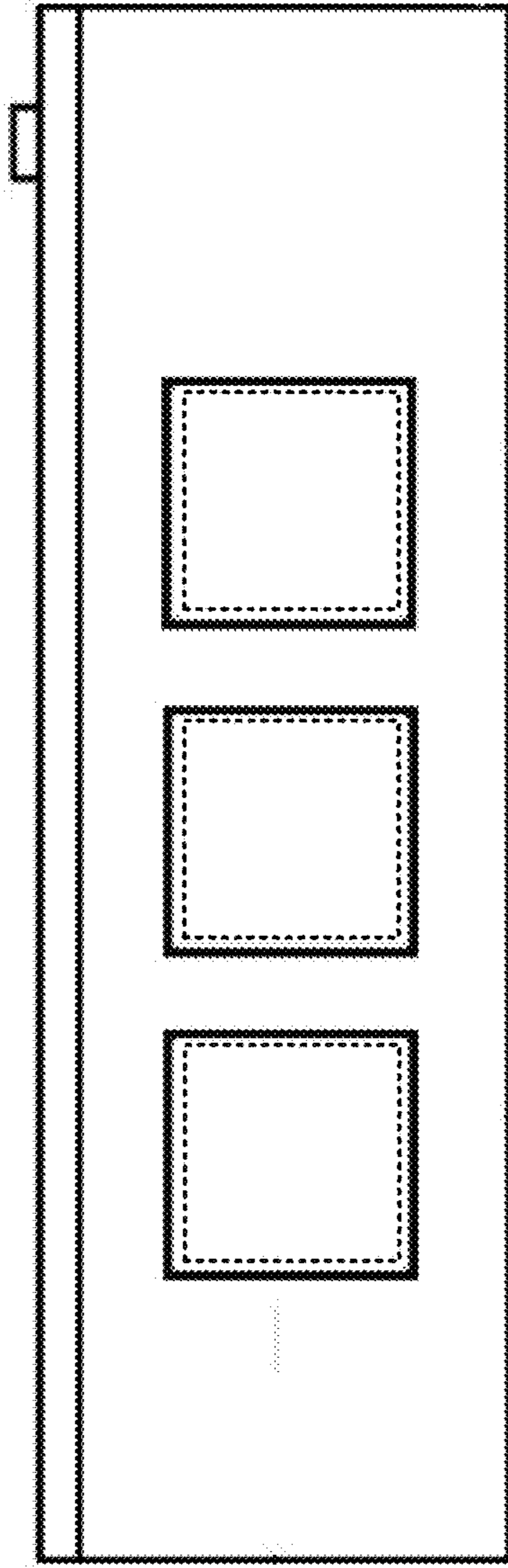
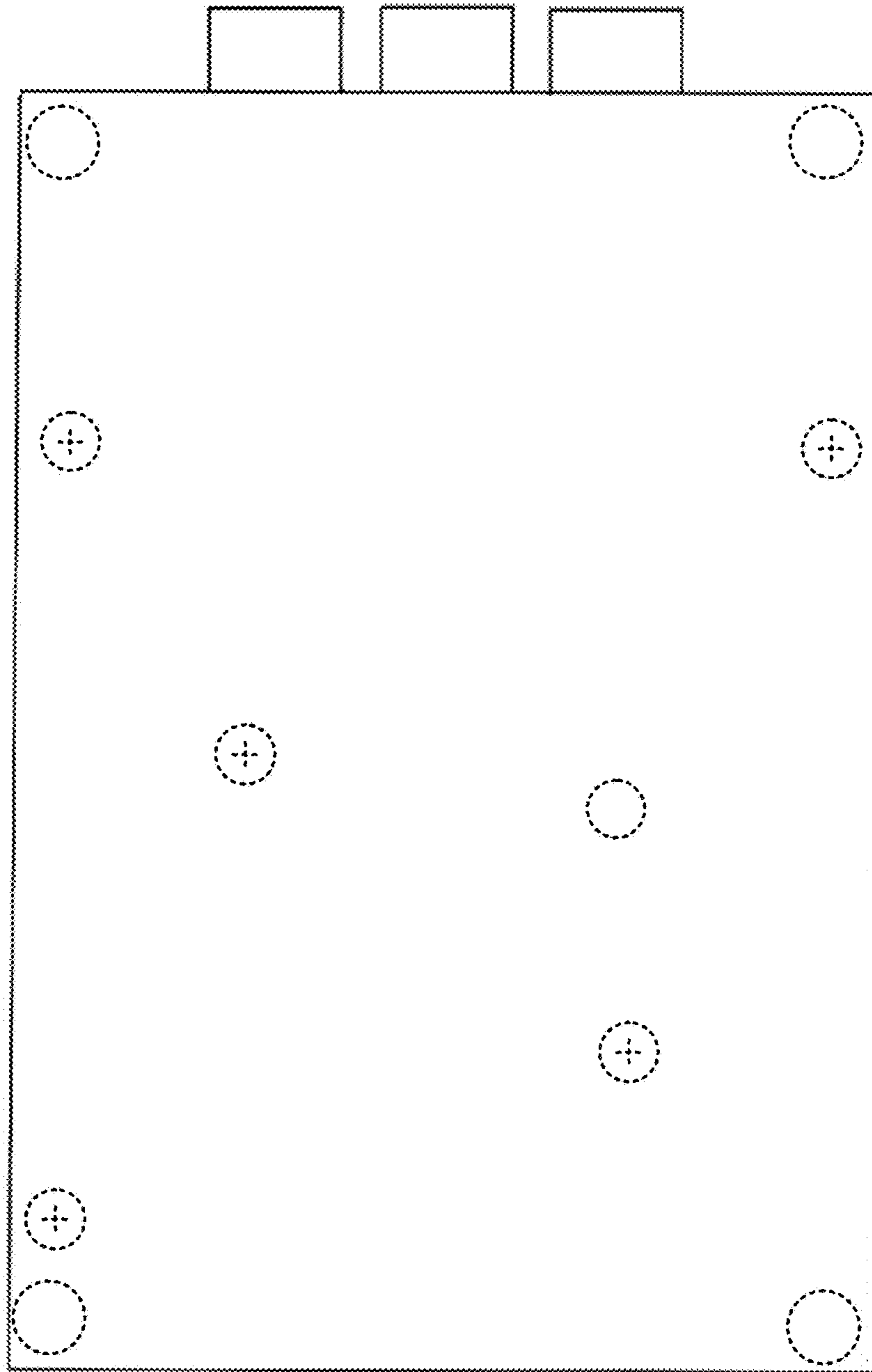
