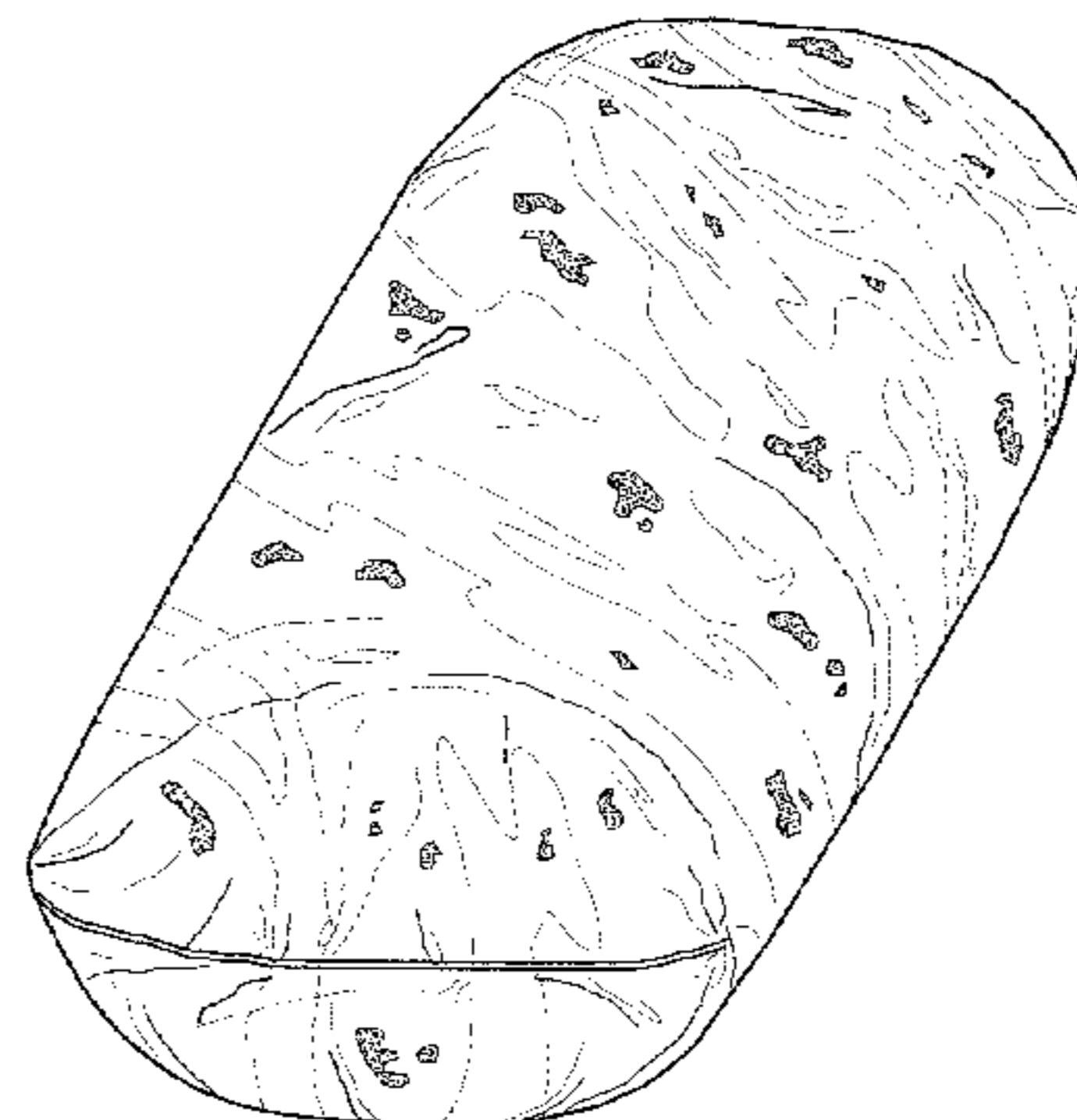
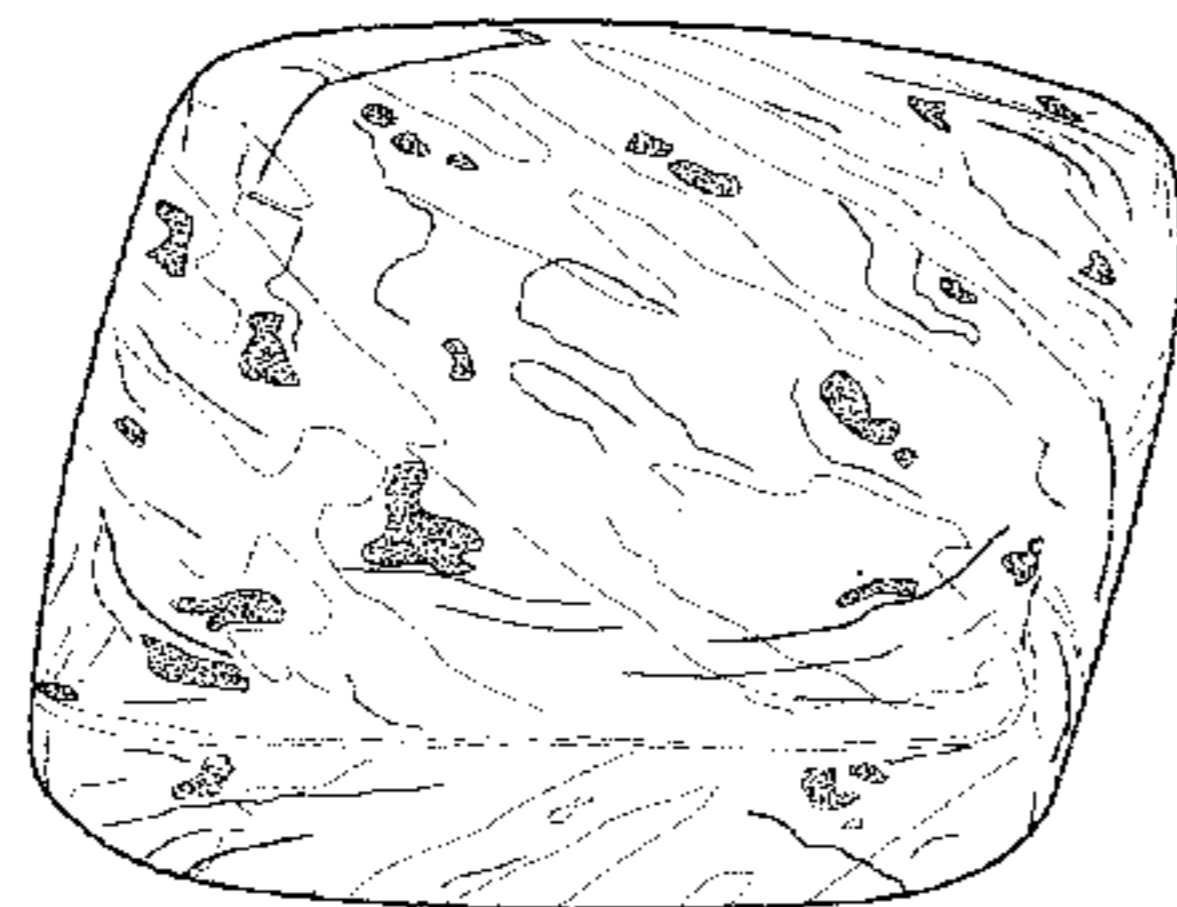
(57) **CLAIM**

The ornamental design for a cereal food piece, as shown and described.

DESCRIPTION

FIG. 1 is an upper perspective view of a first embodiment of a cereal food piece shown in an environment of use;
FIG. 2 is an upper perspective view of the cereal food piece of FIG. 1;
FIG. 3 is a top plan view of the cereal food piece of FIG. 2;
FIG. 4 is a bottom plan view of the cereal food piece of FIG. 2;
FIG. 5 is a front elevational view of the cereal food piece of FIG. 2;
FIG. 6 is a rear elevational view of the cereal food piece of FIG. 2;
FIG. 7 is a right side elevational view of the cereal food piece of FIG. 2;
FIG. 8 is a left side elevational view of the cereal food piece of FIG. 2;
FIG. 9 is a perspective view of a second embodiment of a cereal food piece thereof; and,
FIG. 10 is a perspective view of a third embodiment of a cereal food piece thereof.

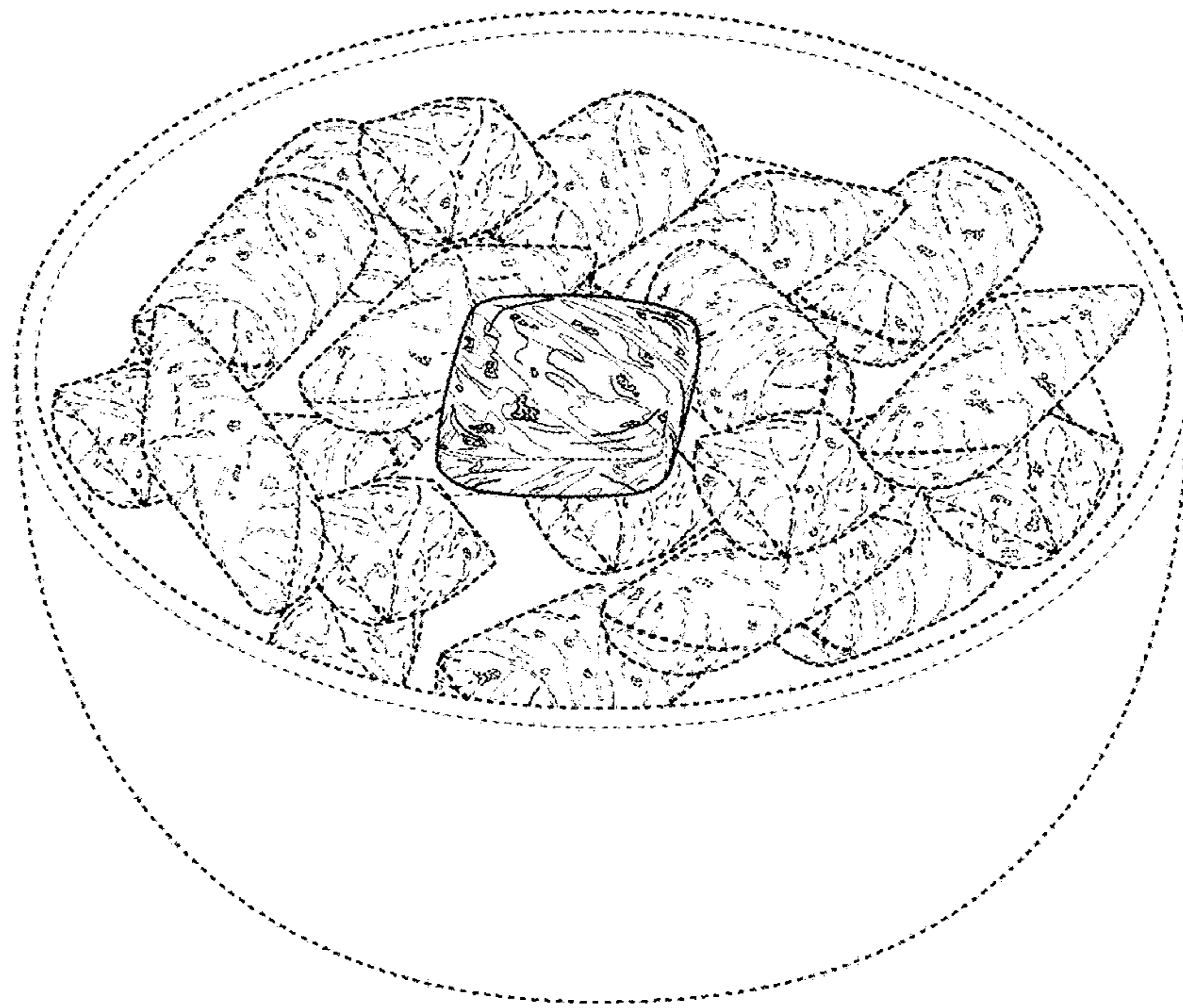

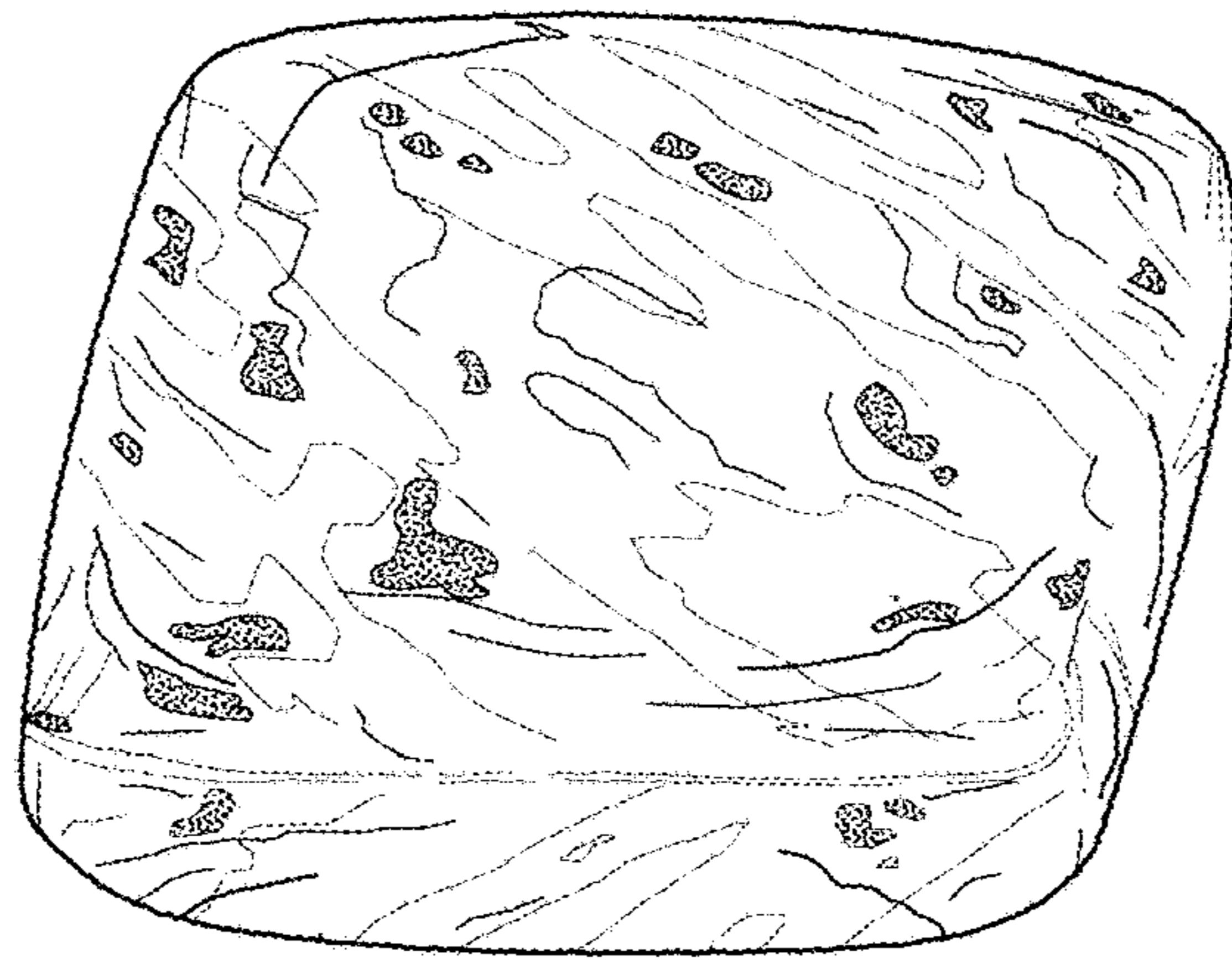

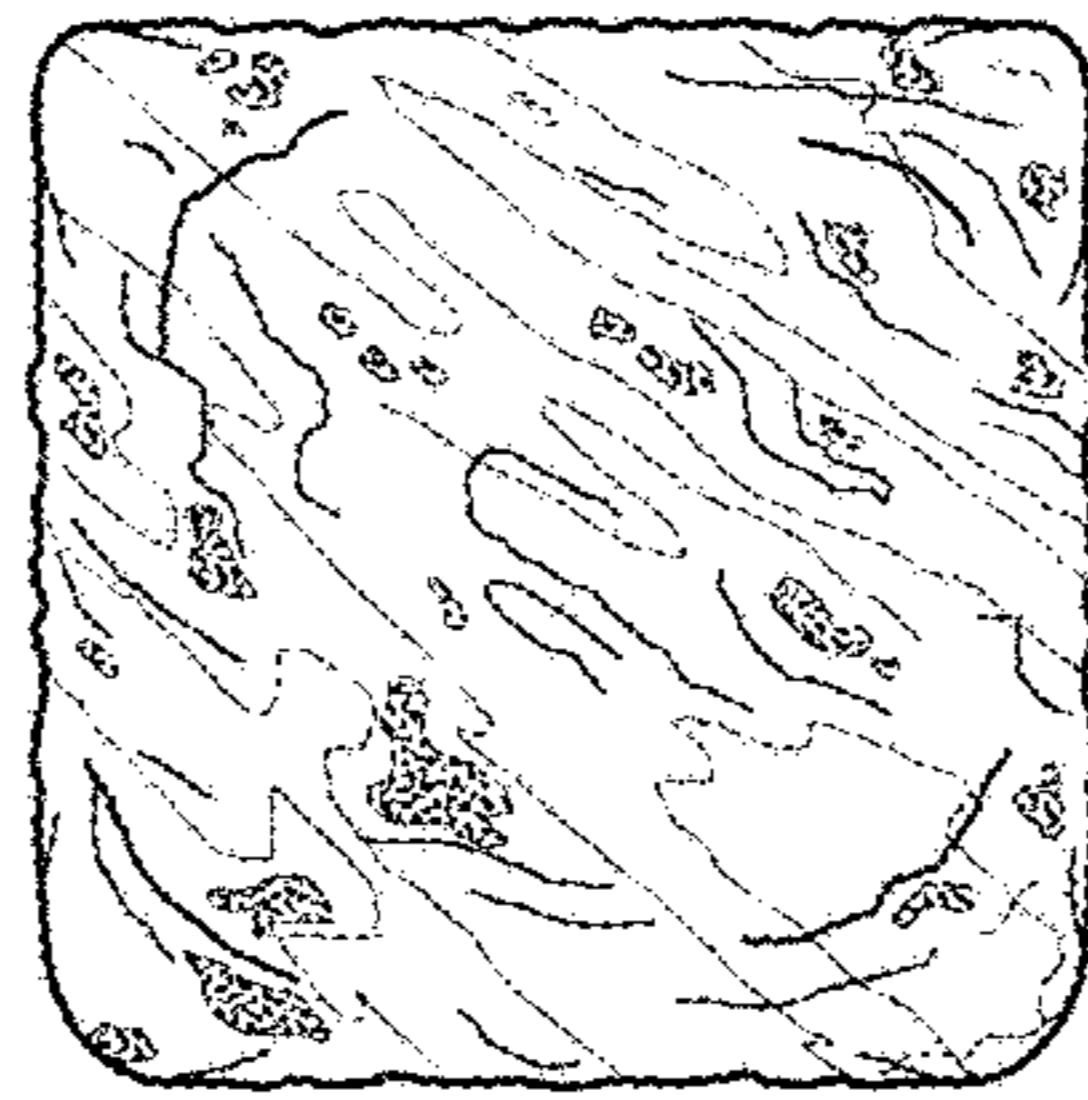

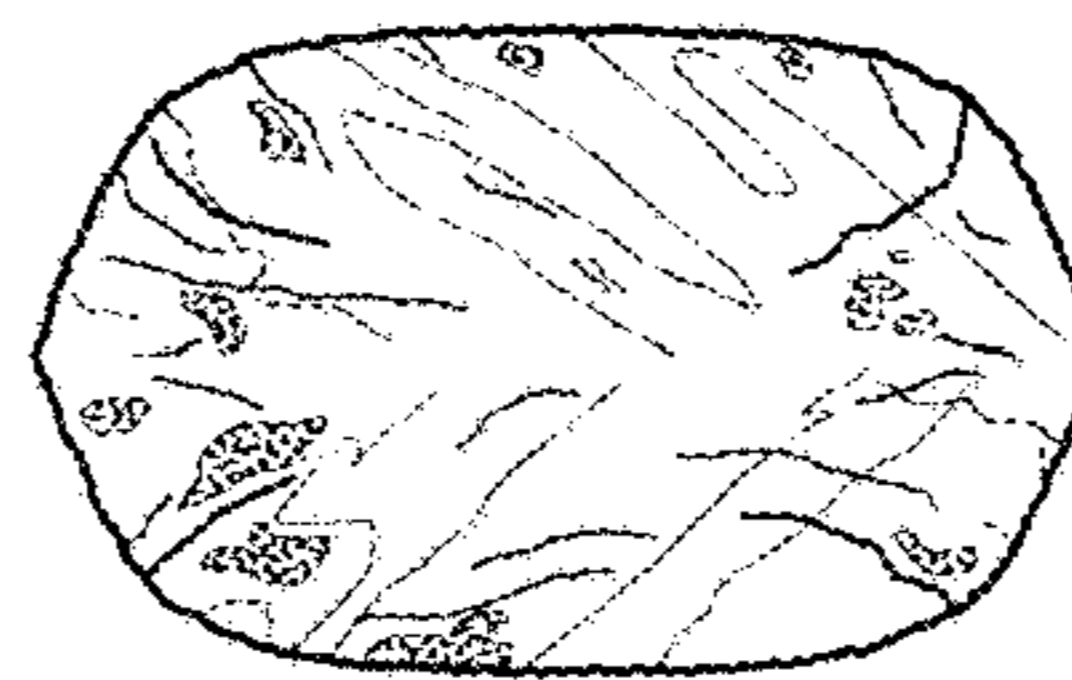

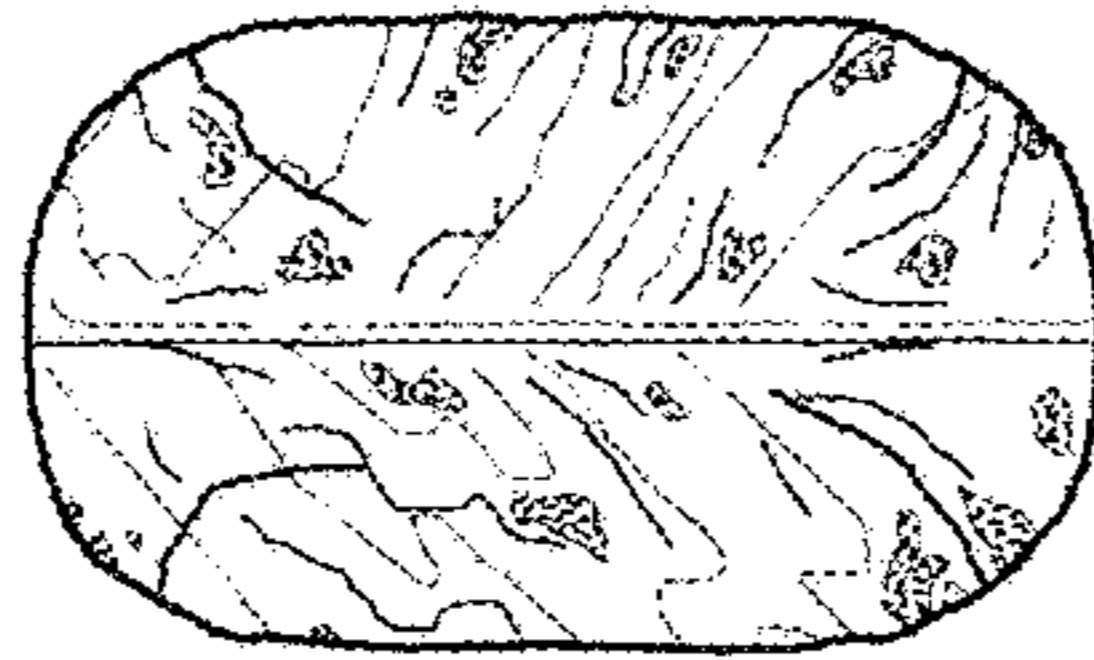

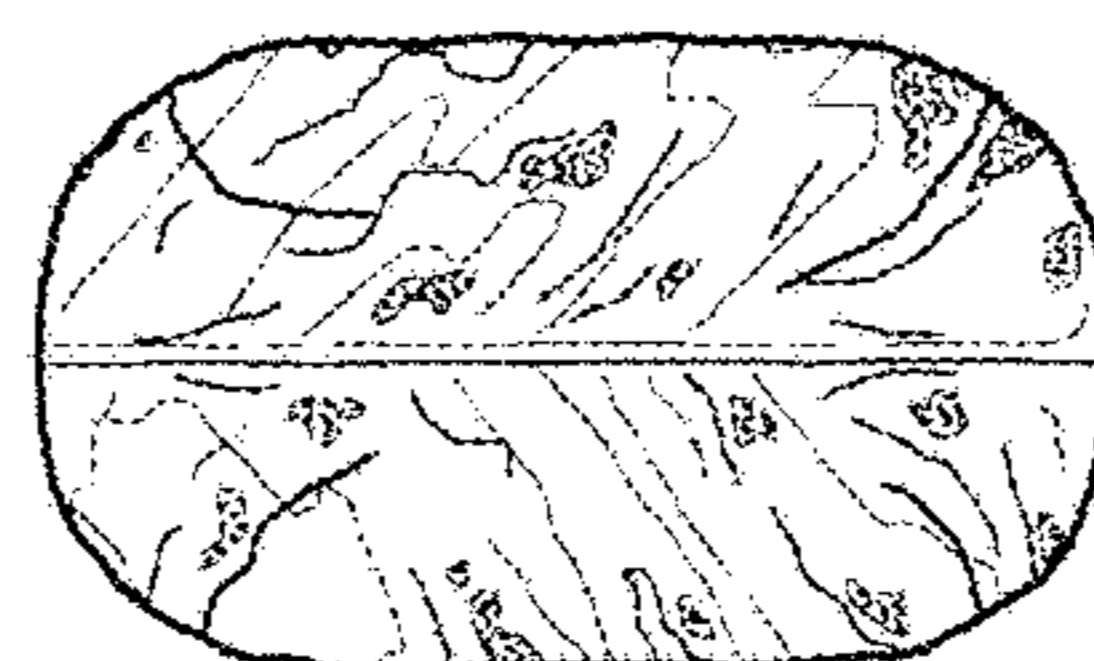

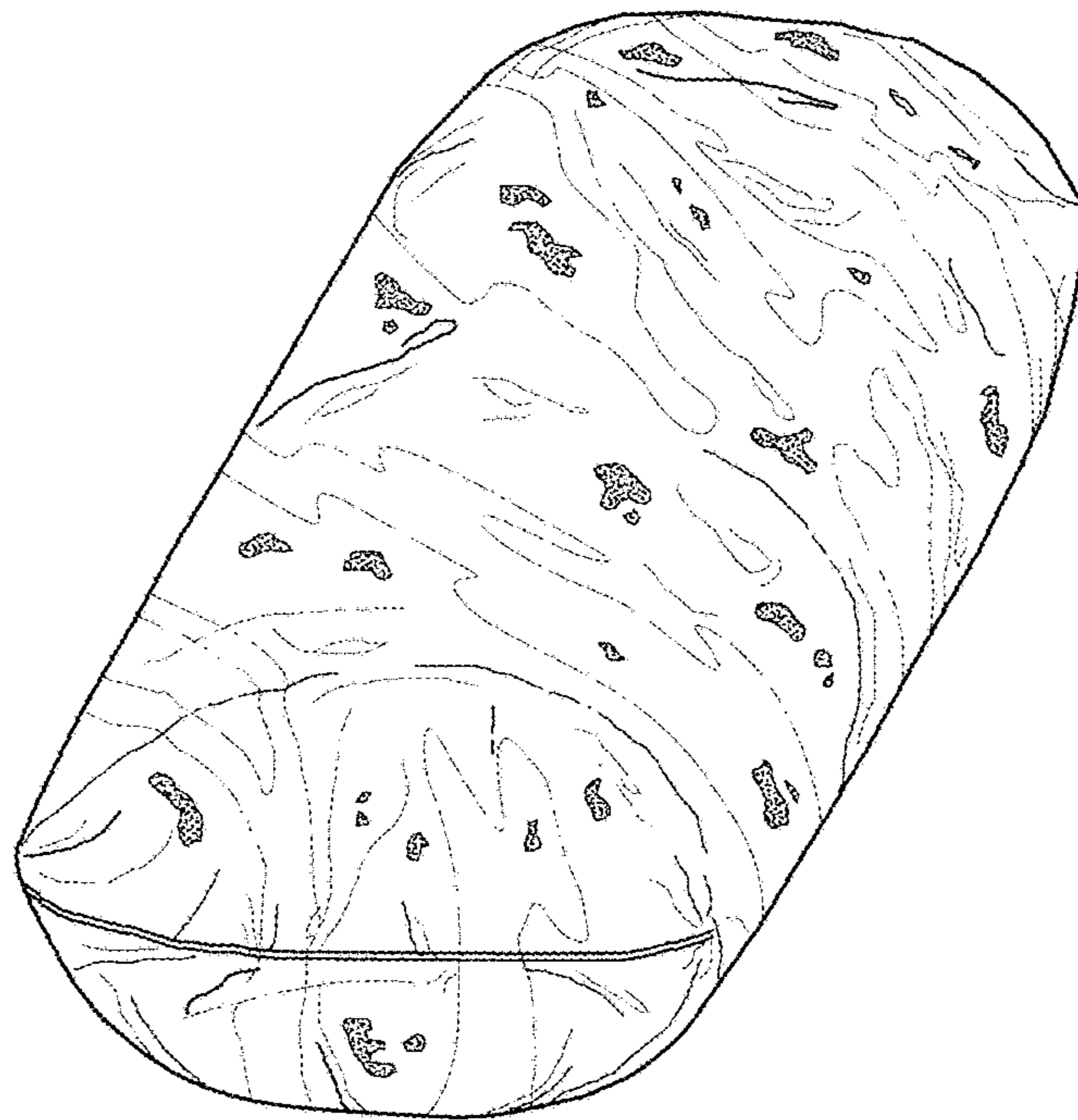

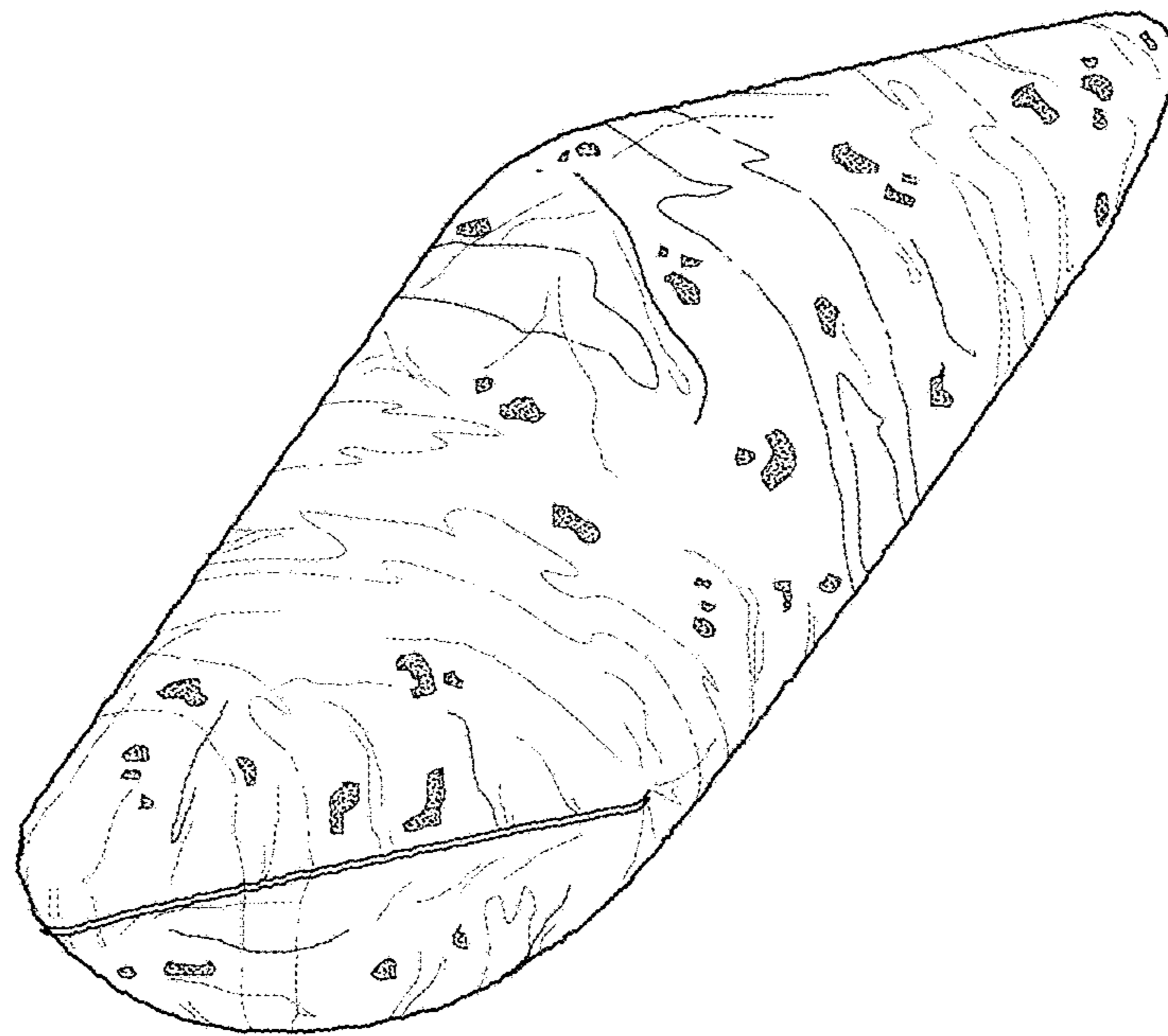
