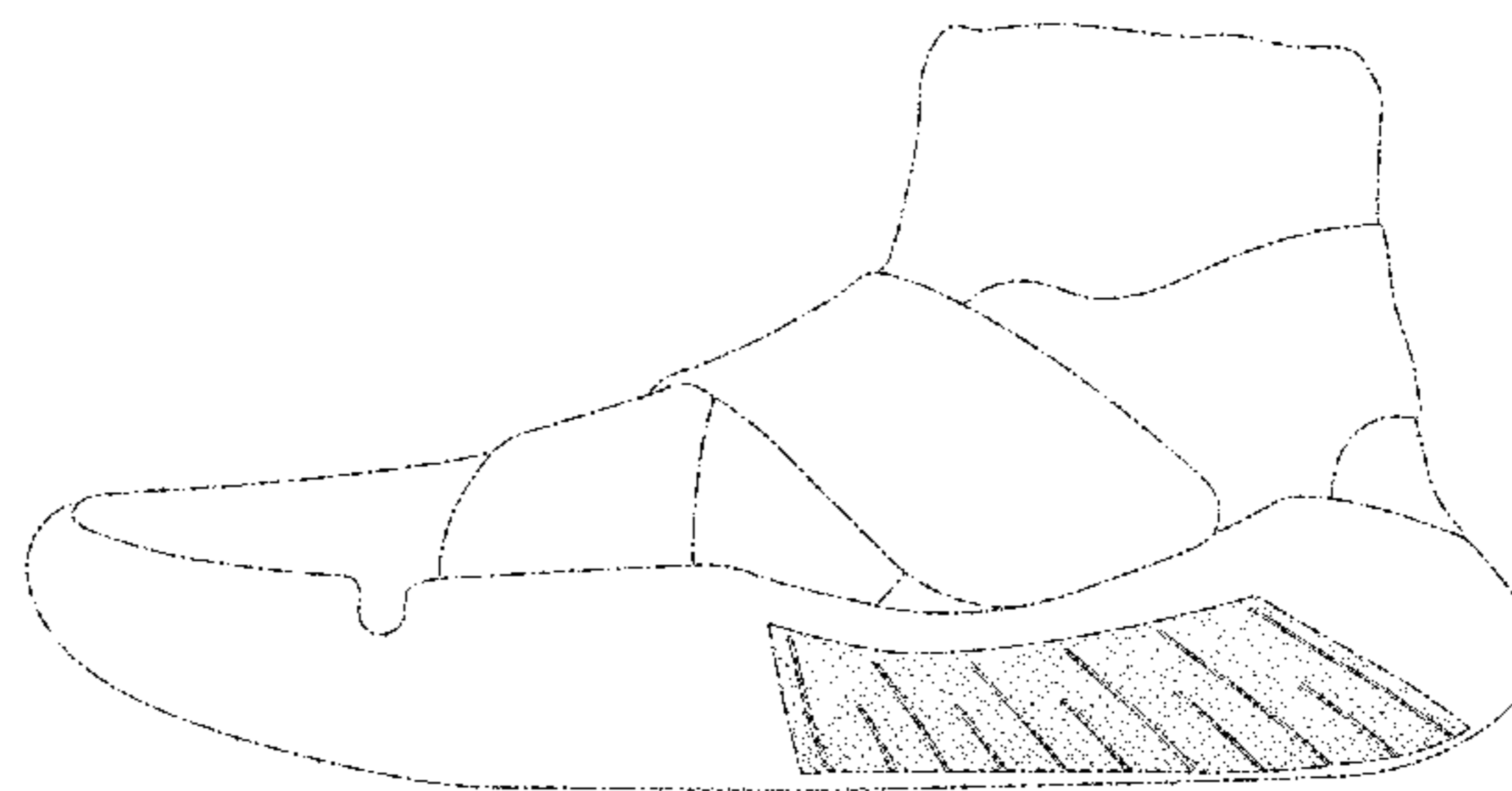
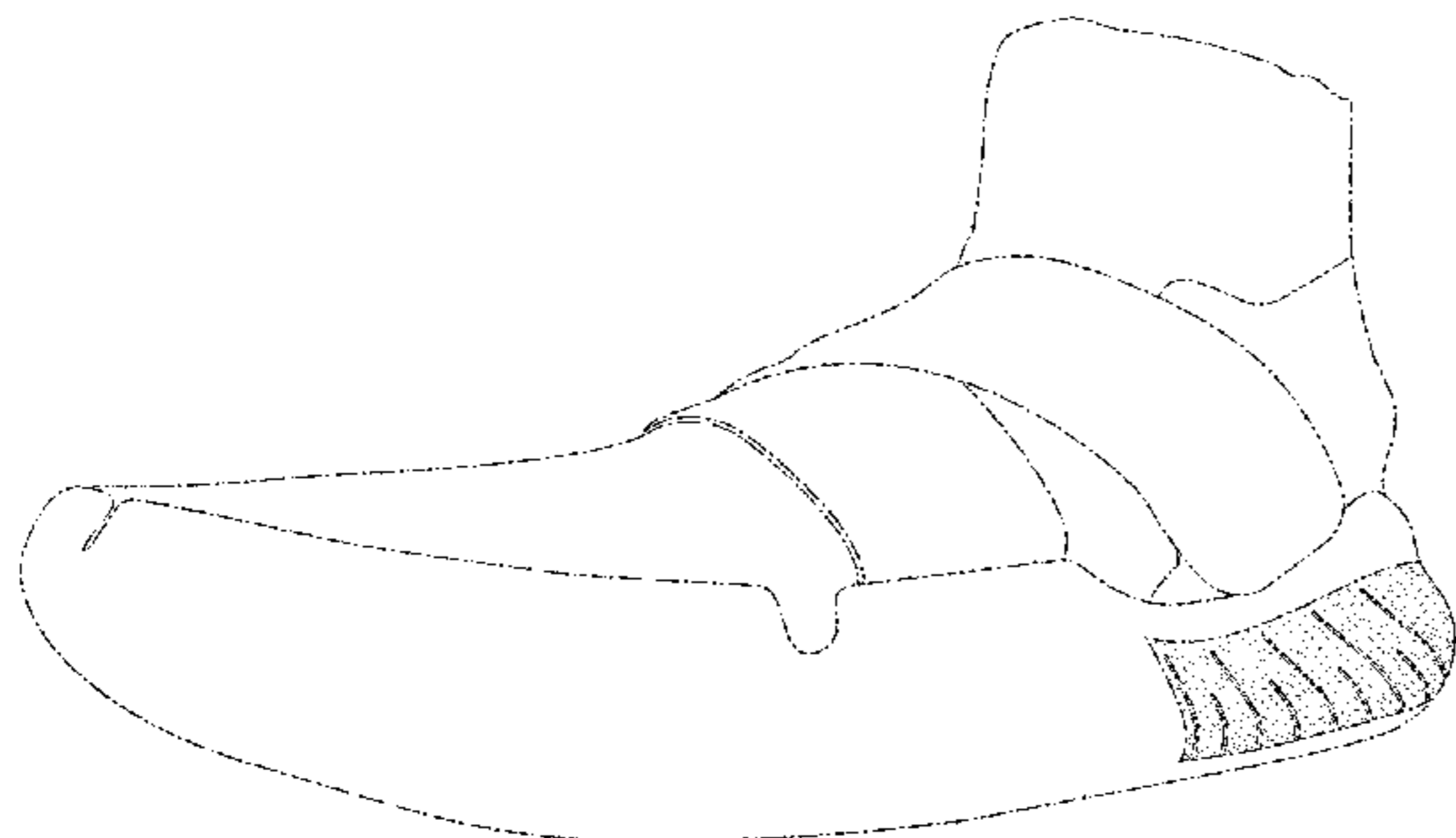
The ornamental design for a shoe midsole, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe midsole showing our new design;  
FIG. 2 is a side view thereof;  
FIG. 3 is a rear perspective view thereof;

FIG. 5 is a top view thereof; and,  
FIG. 6 is a bottom view thereof.

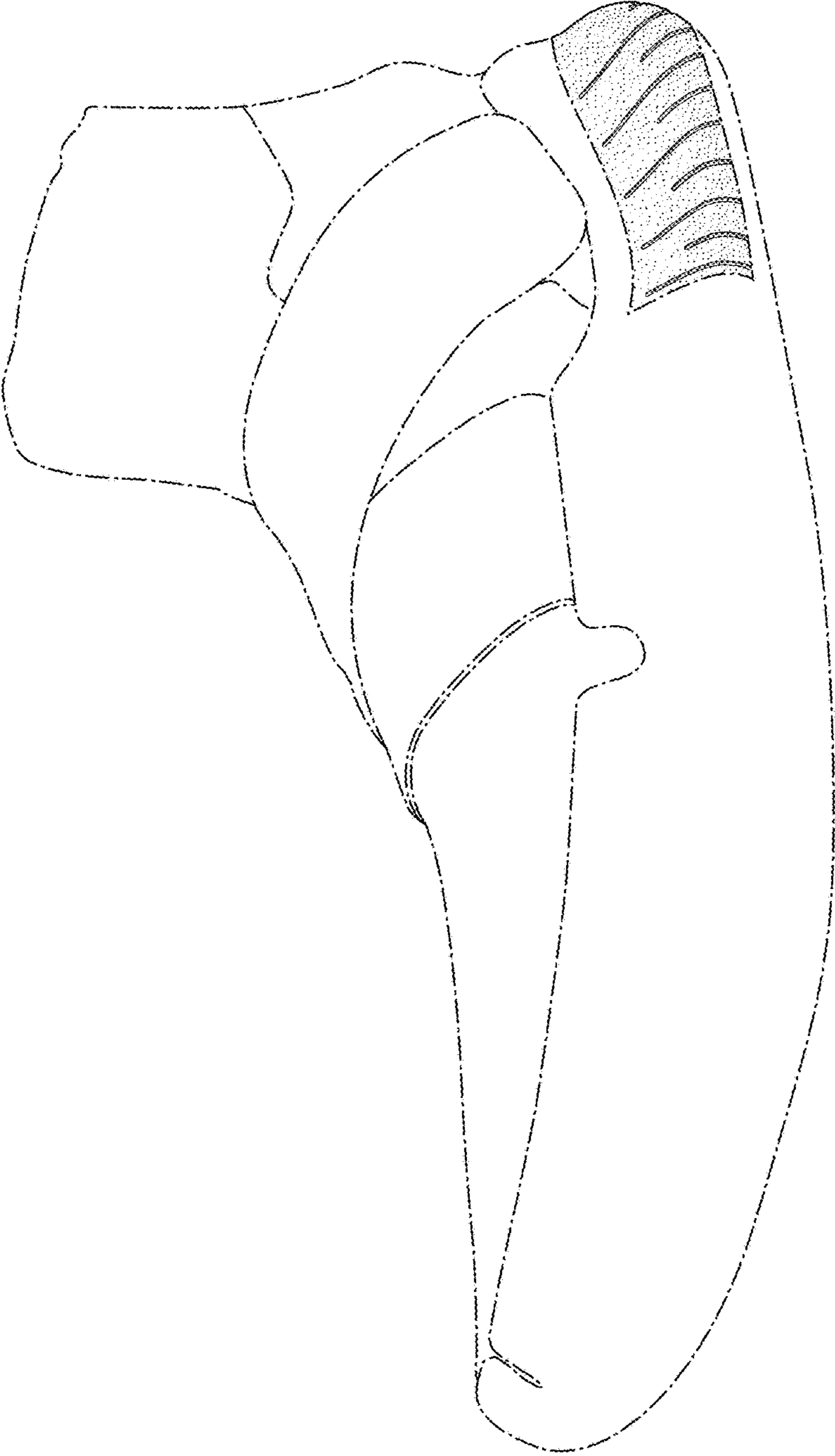

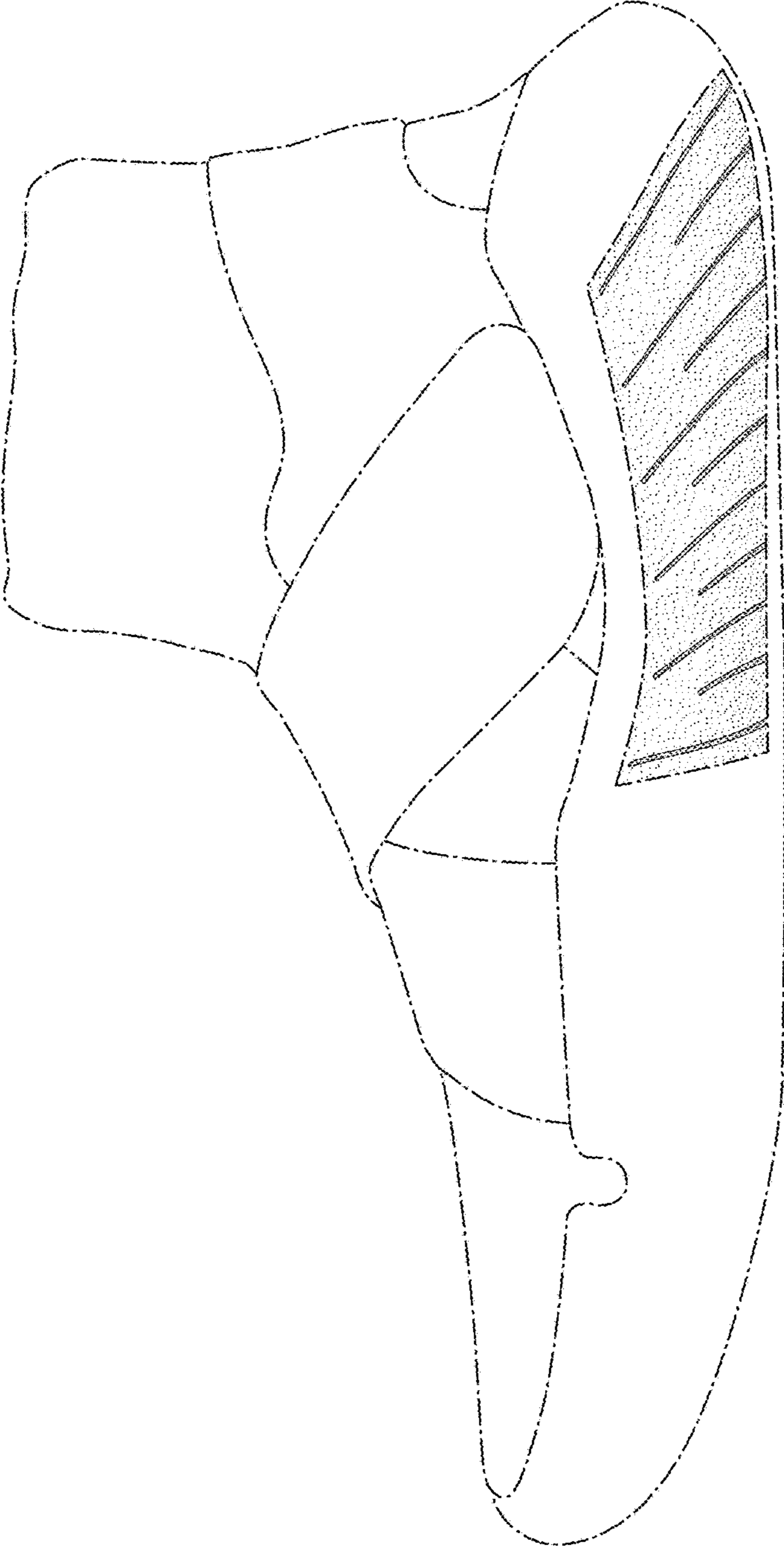

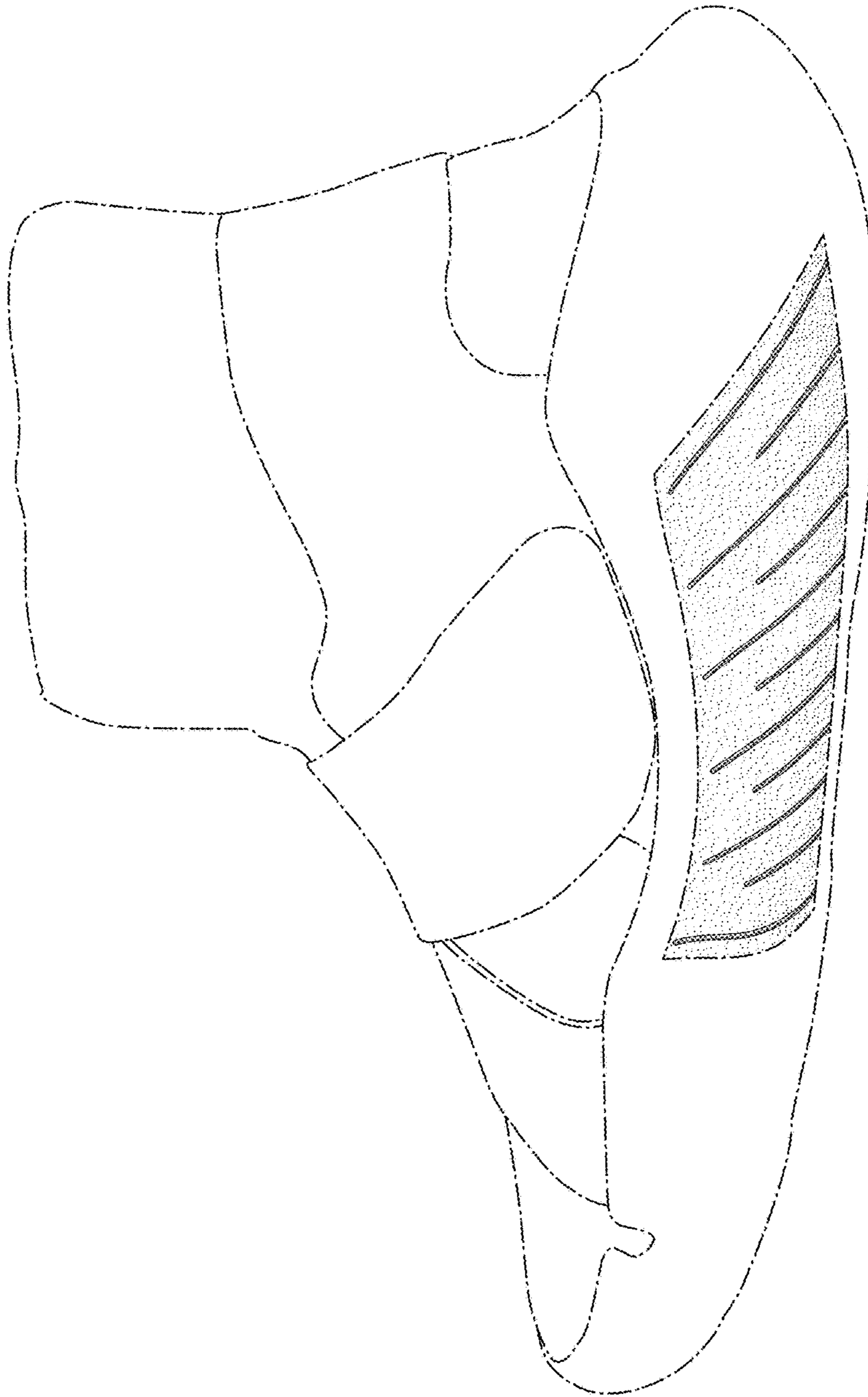

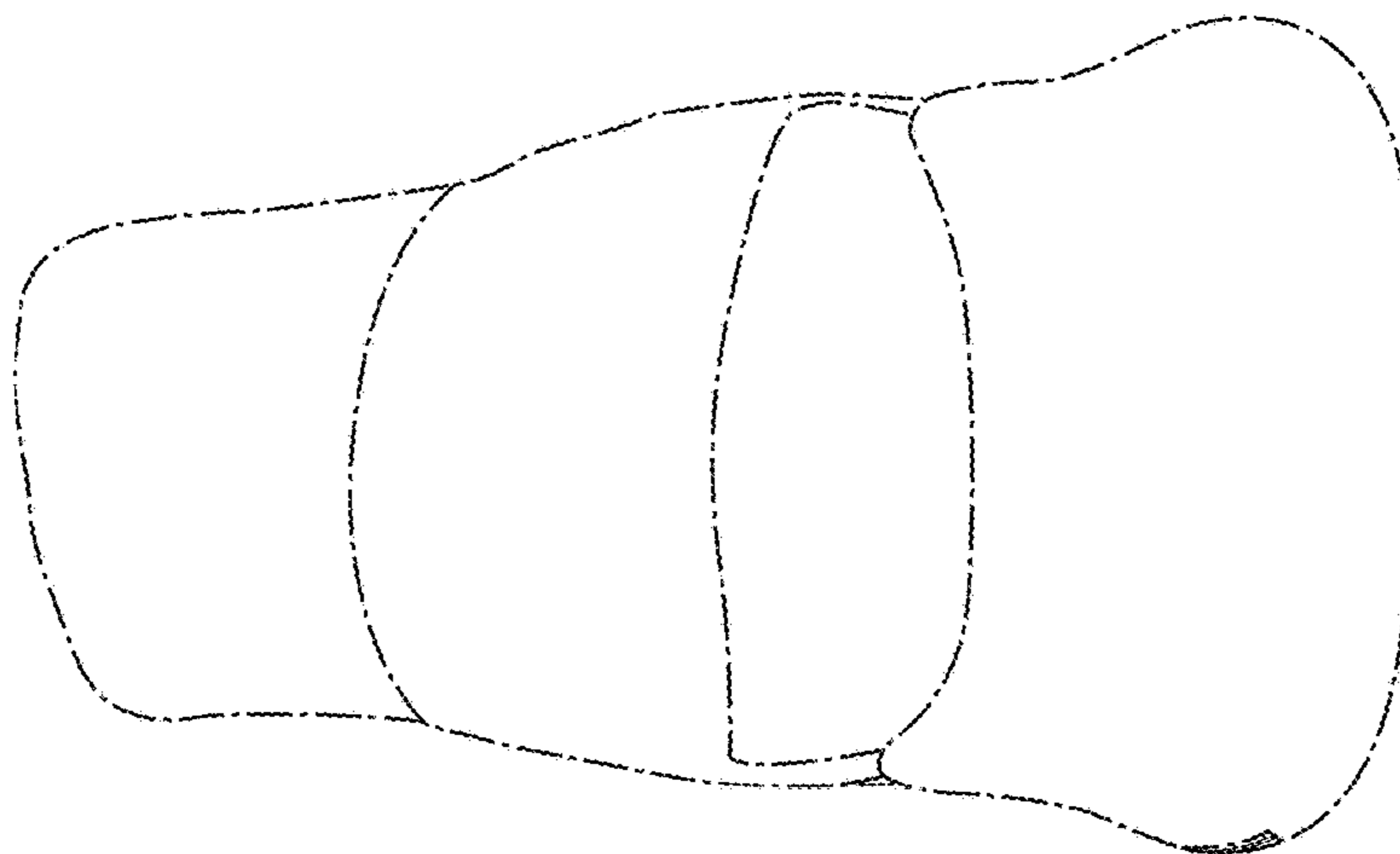

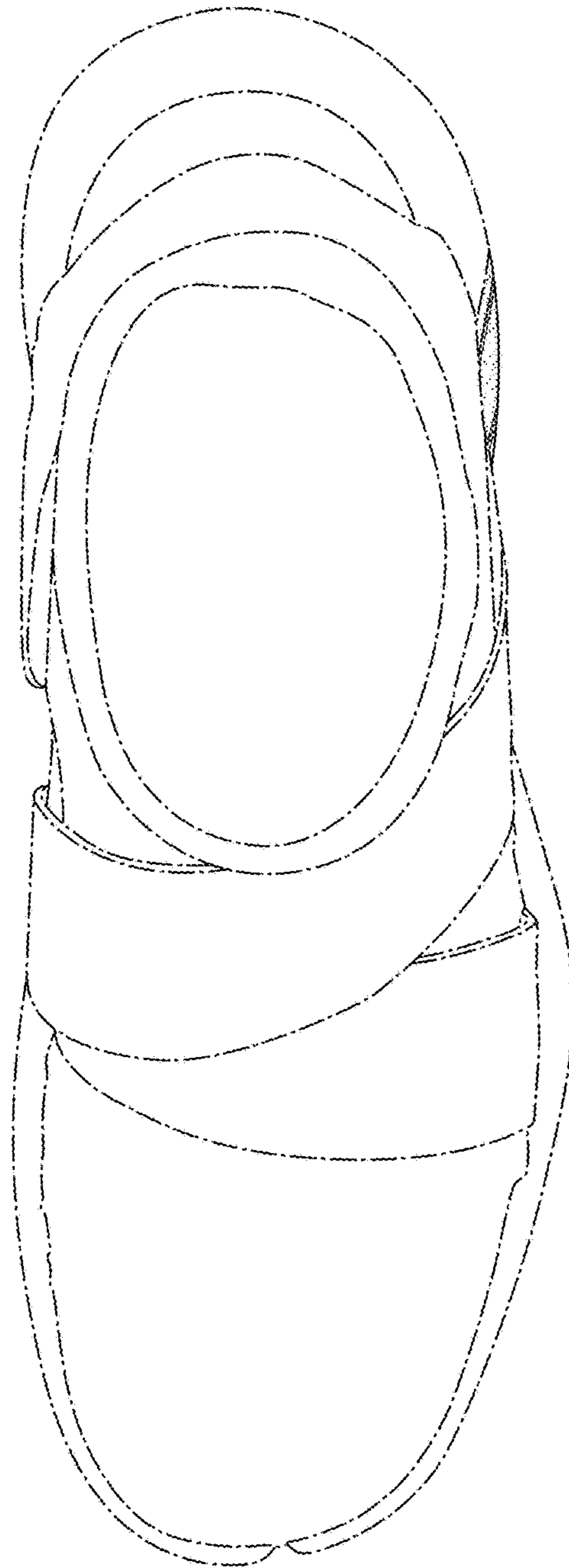

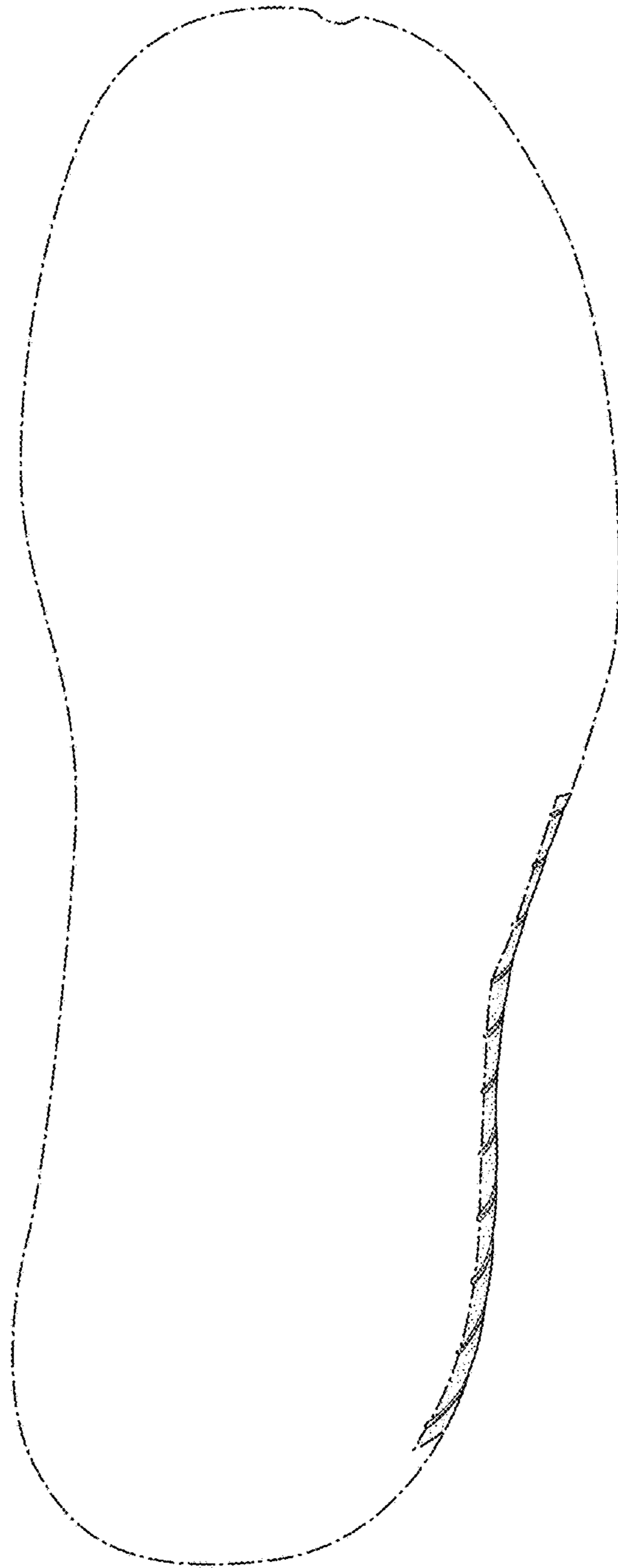
