CLAIM

The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe outsole showing my new design;

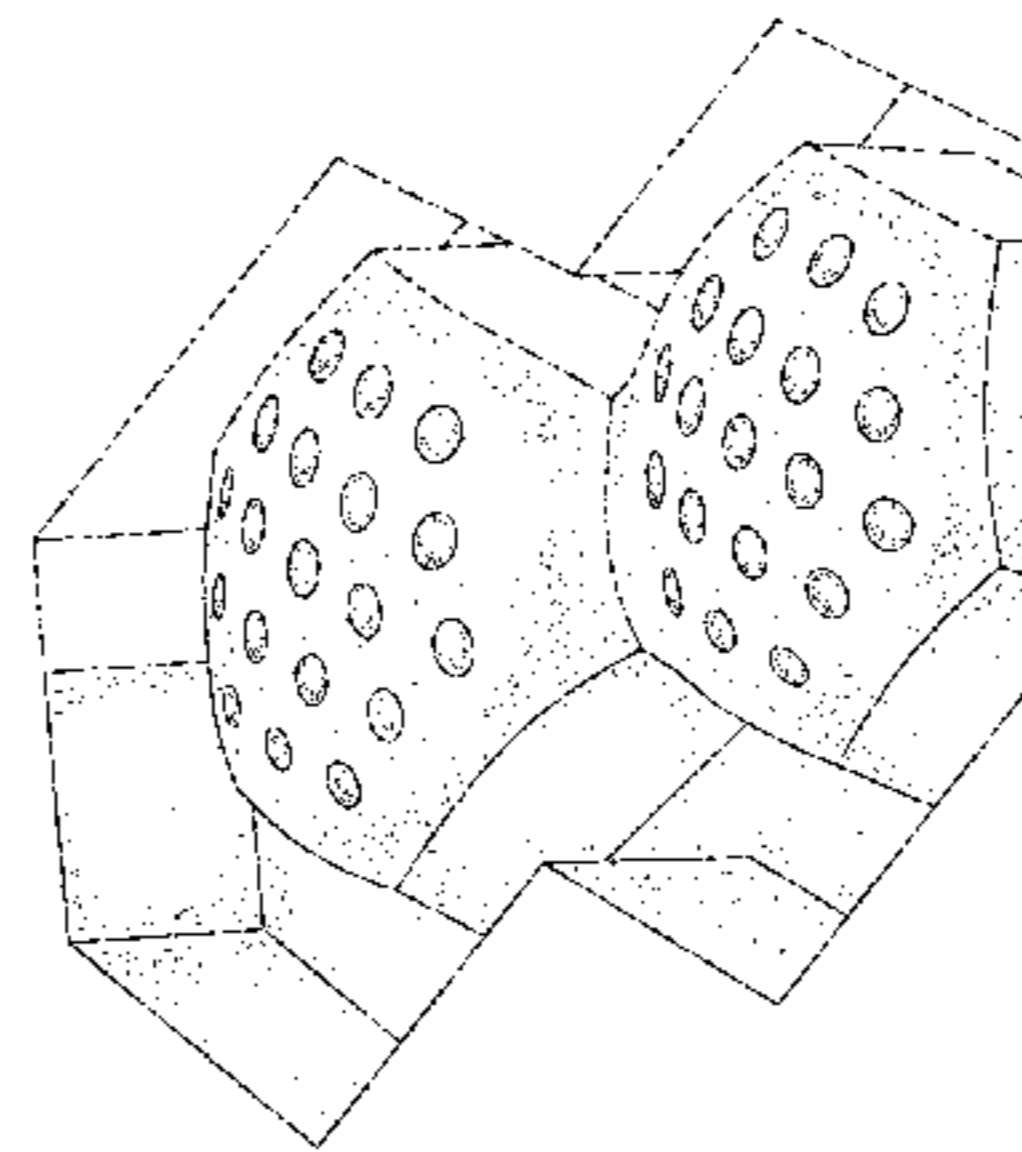
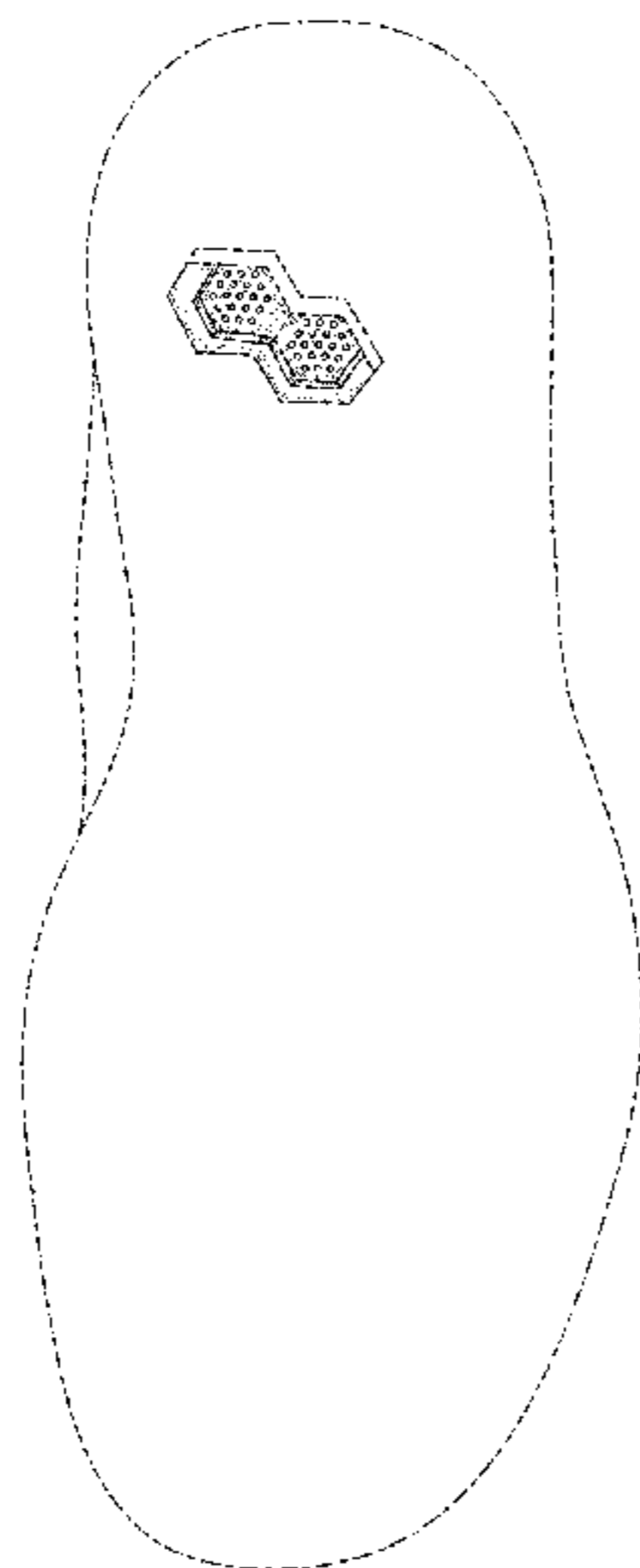
FIG. 2 is a bottom view thereof;

FIG. 3 is a rear perspective view thereof; and,

FIG. 4 is an enlarged view of the claimed region in FIG. 1 with environmental portions removed for clarity.

The uneven length broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The even length broken lines within the shaded area represent an unclaimed feature. The uneven length broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

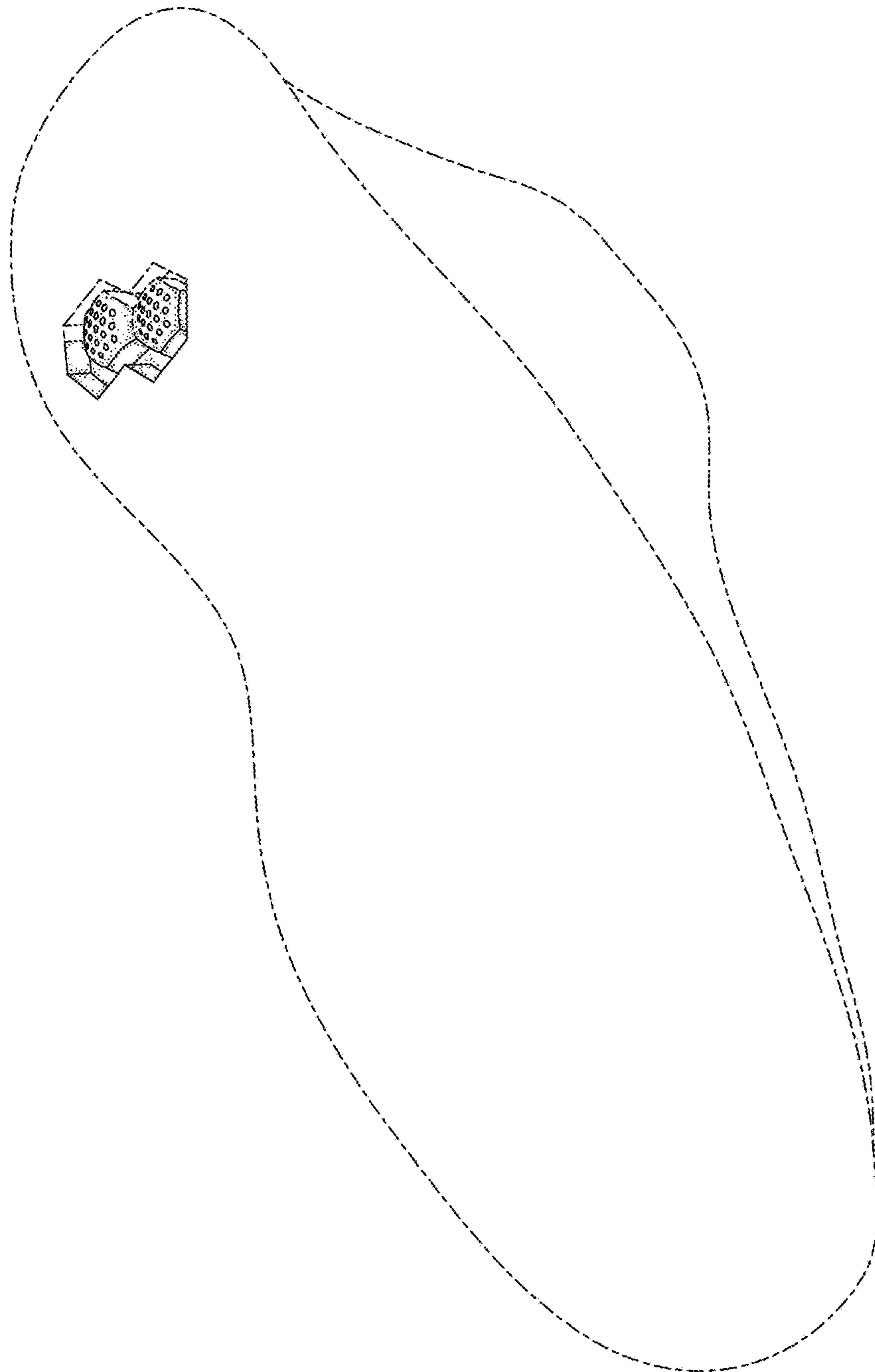

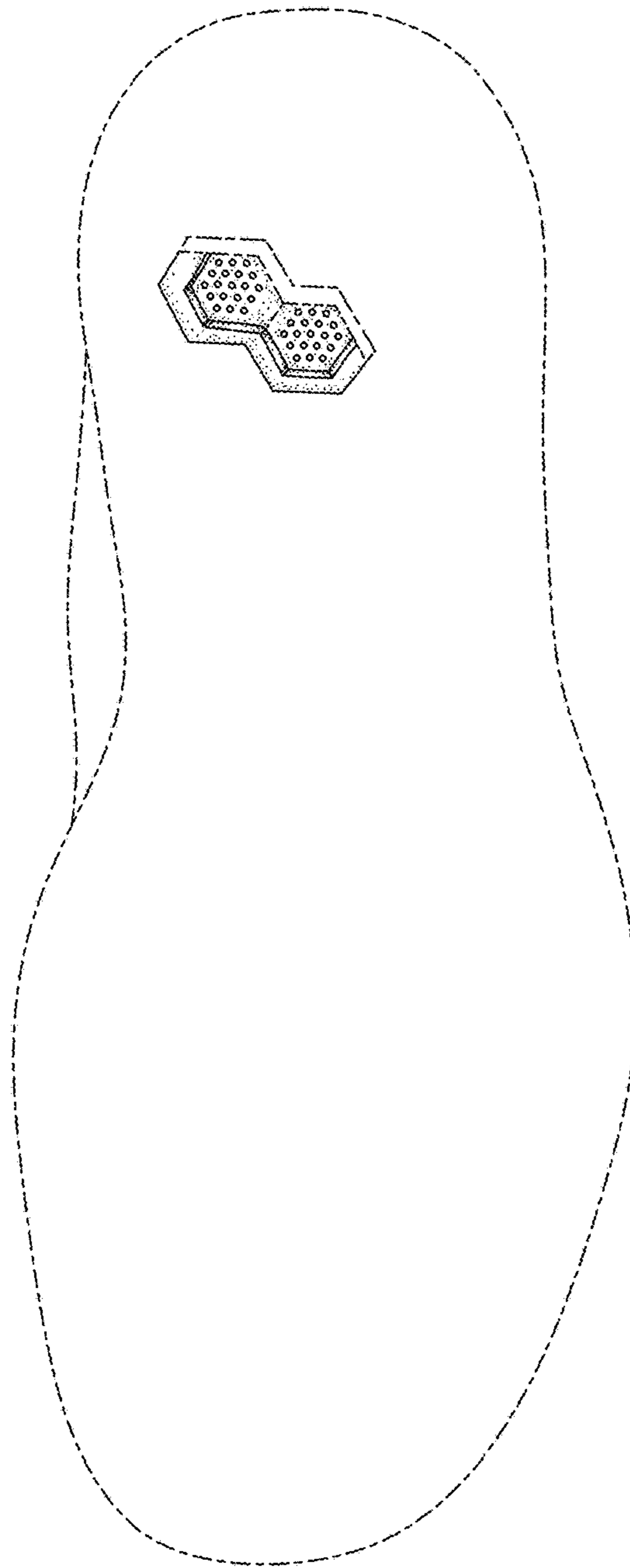

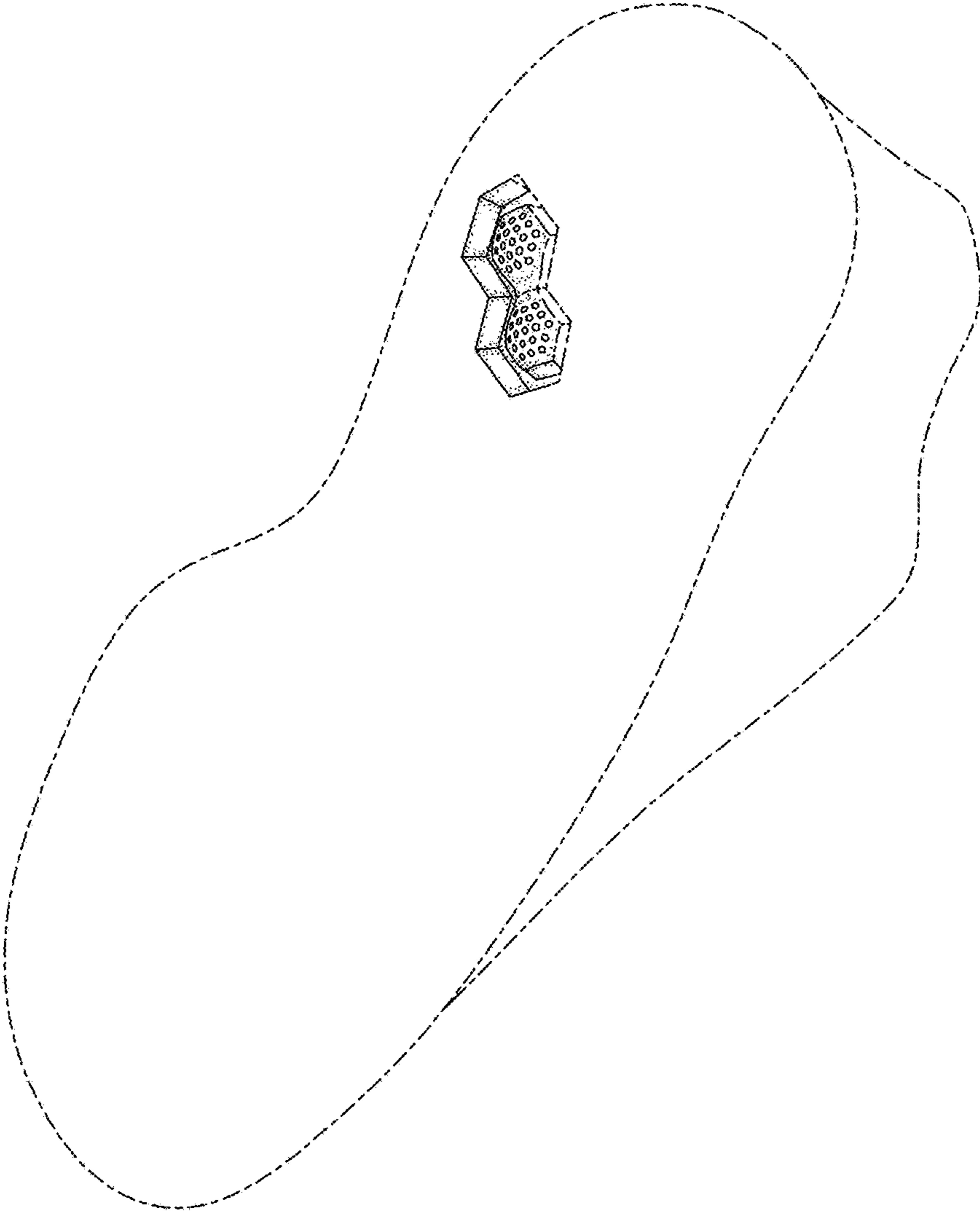

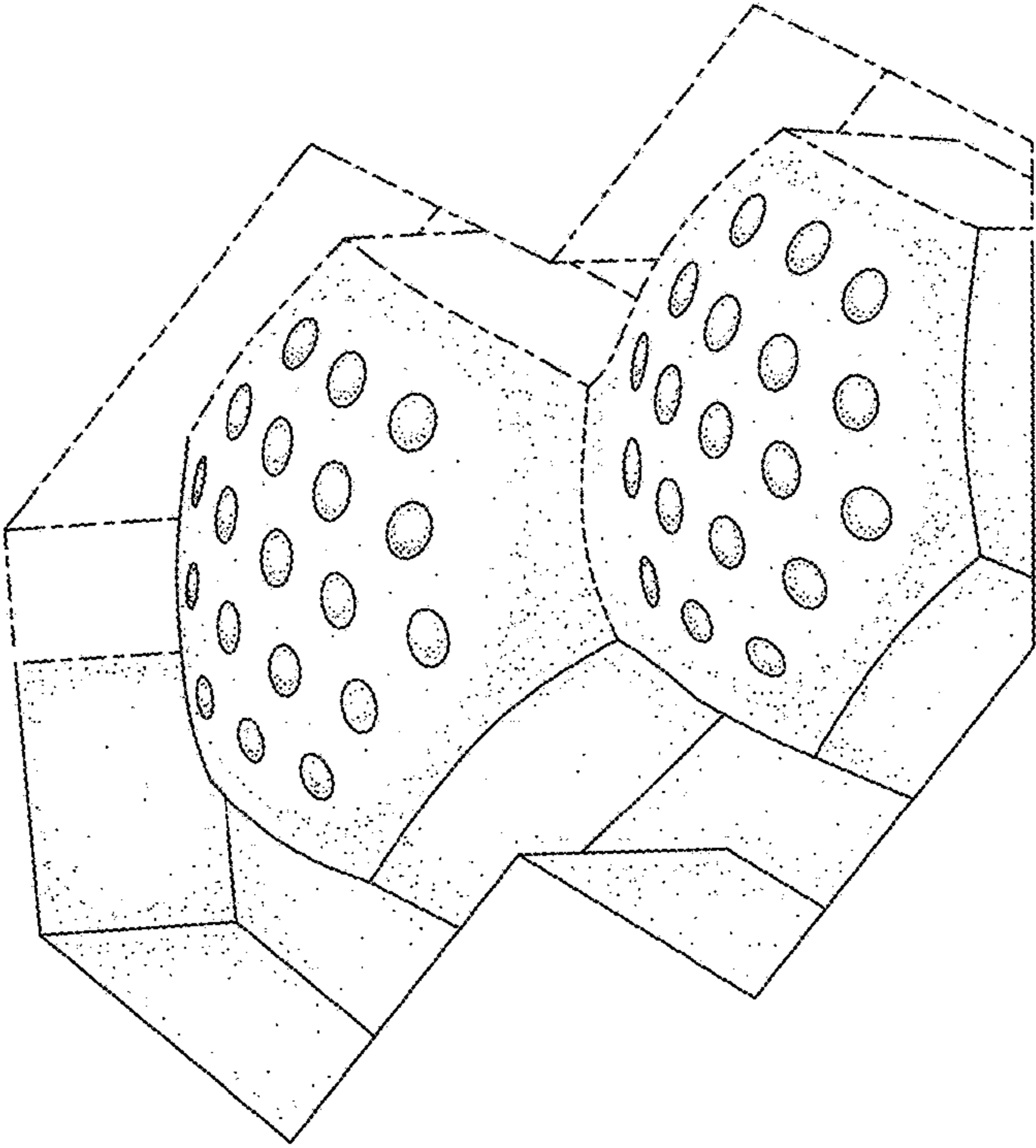
