(57) **CLAIM**

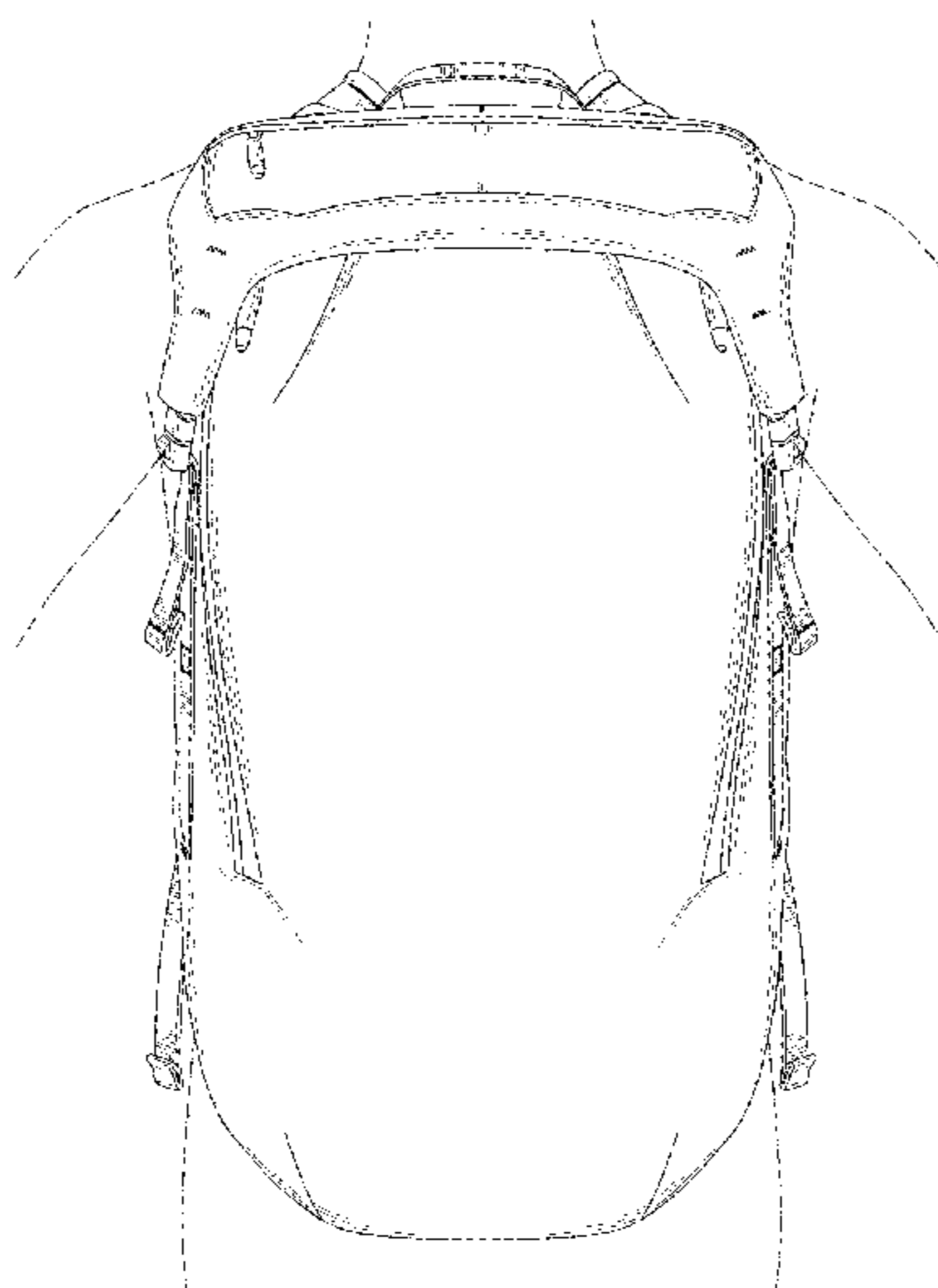
The ornamental design for a backpack, as shown and described.

DESCRIPTION

FIG. 1 is a rear view of a backpack;

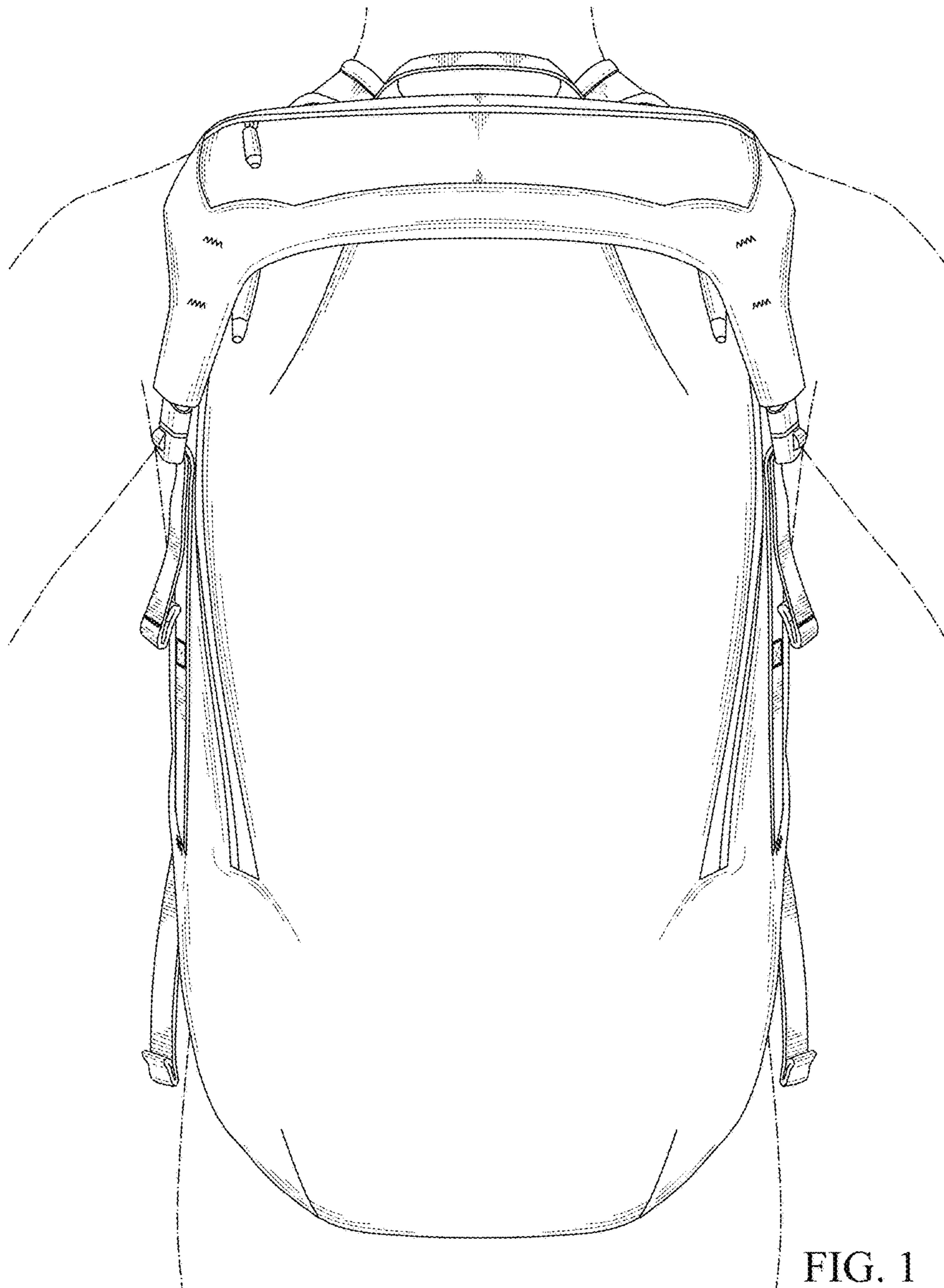

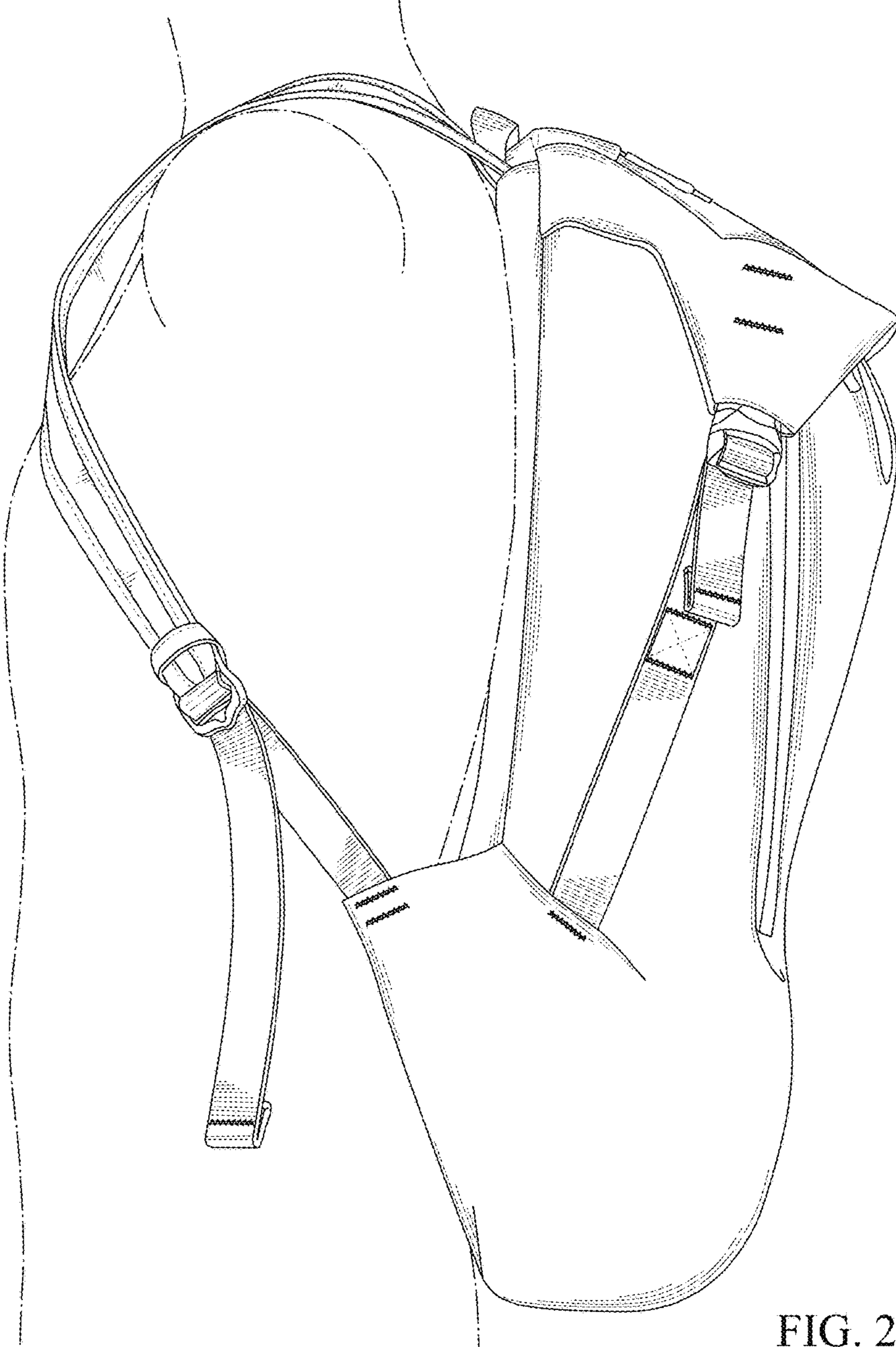

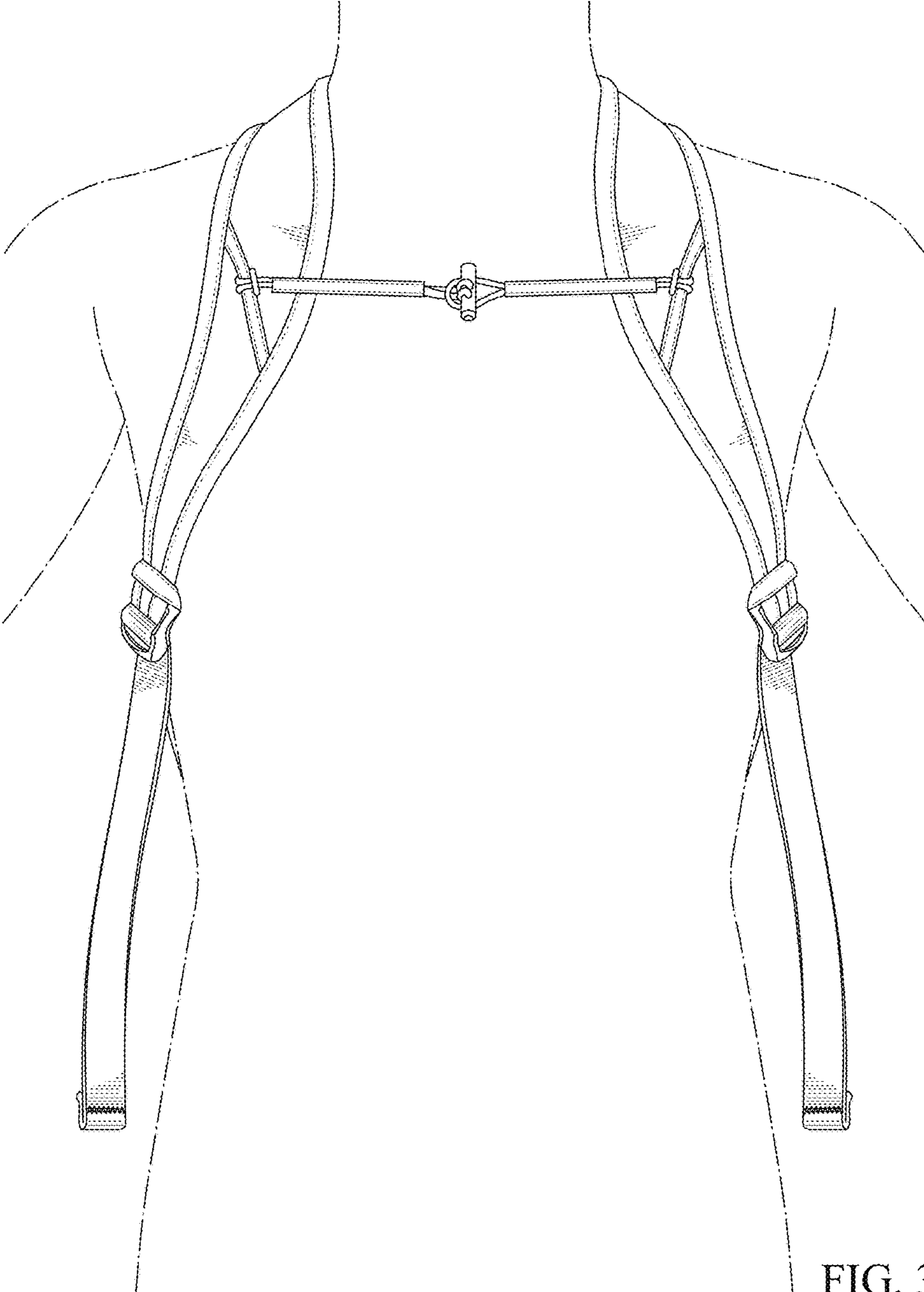

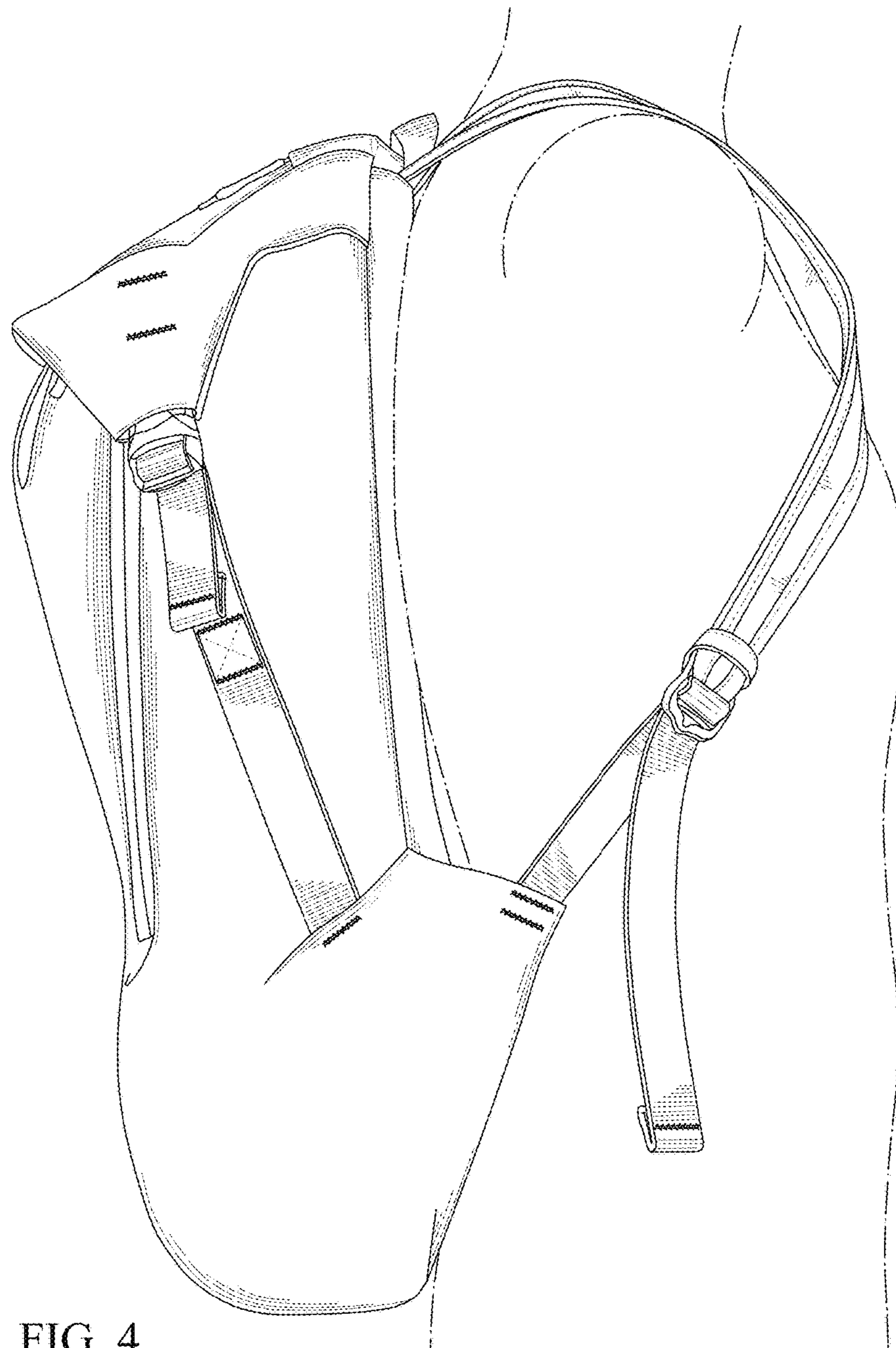

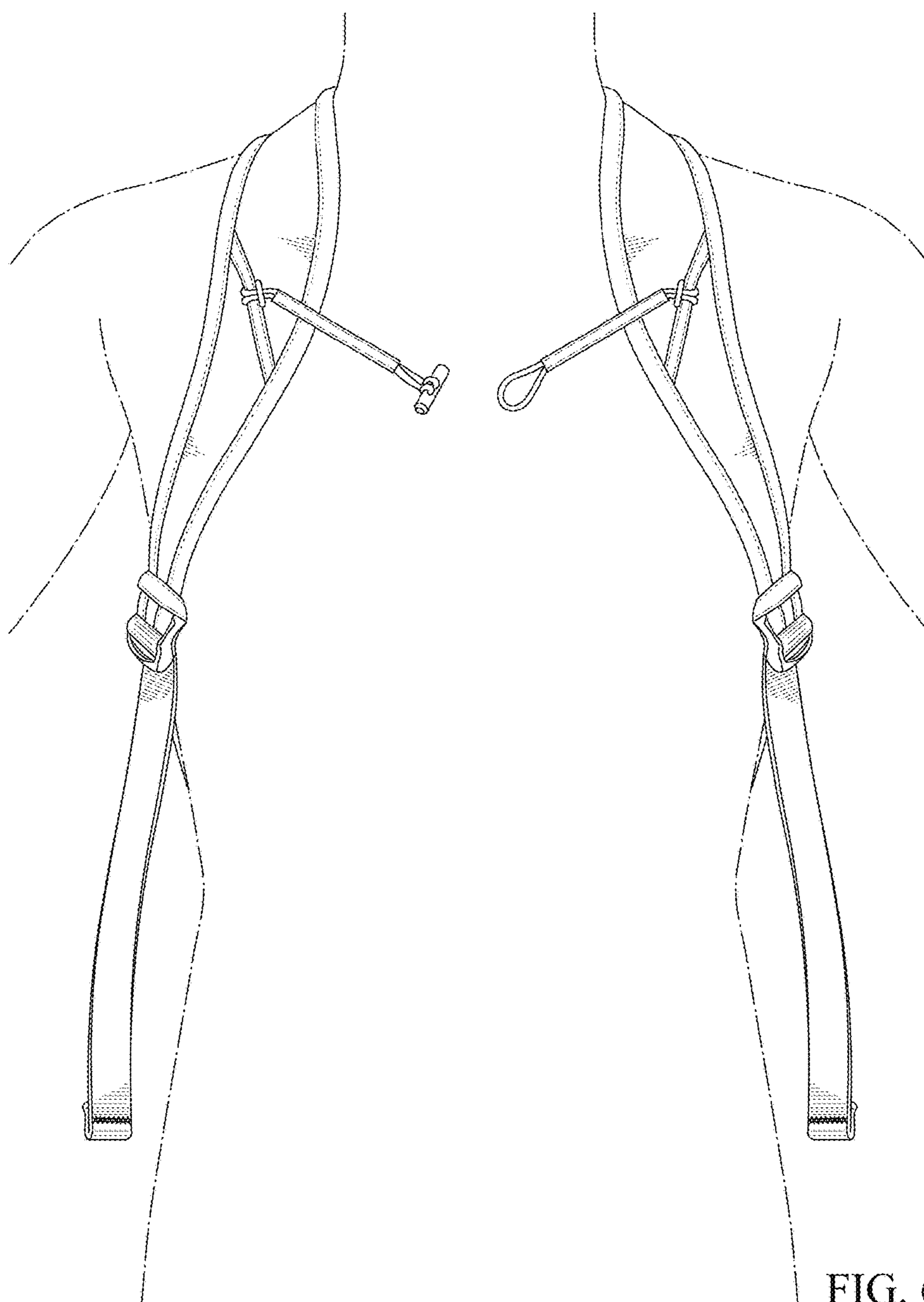

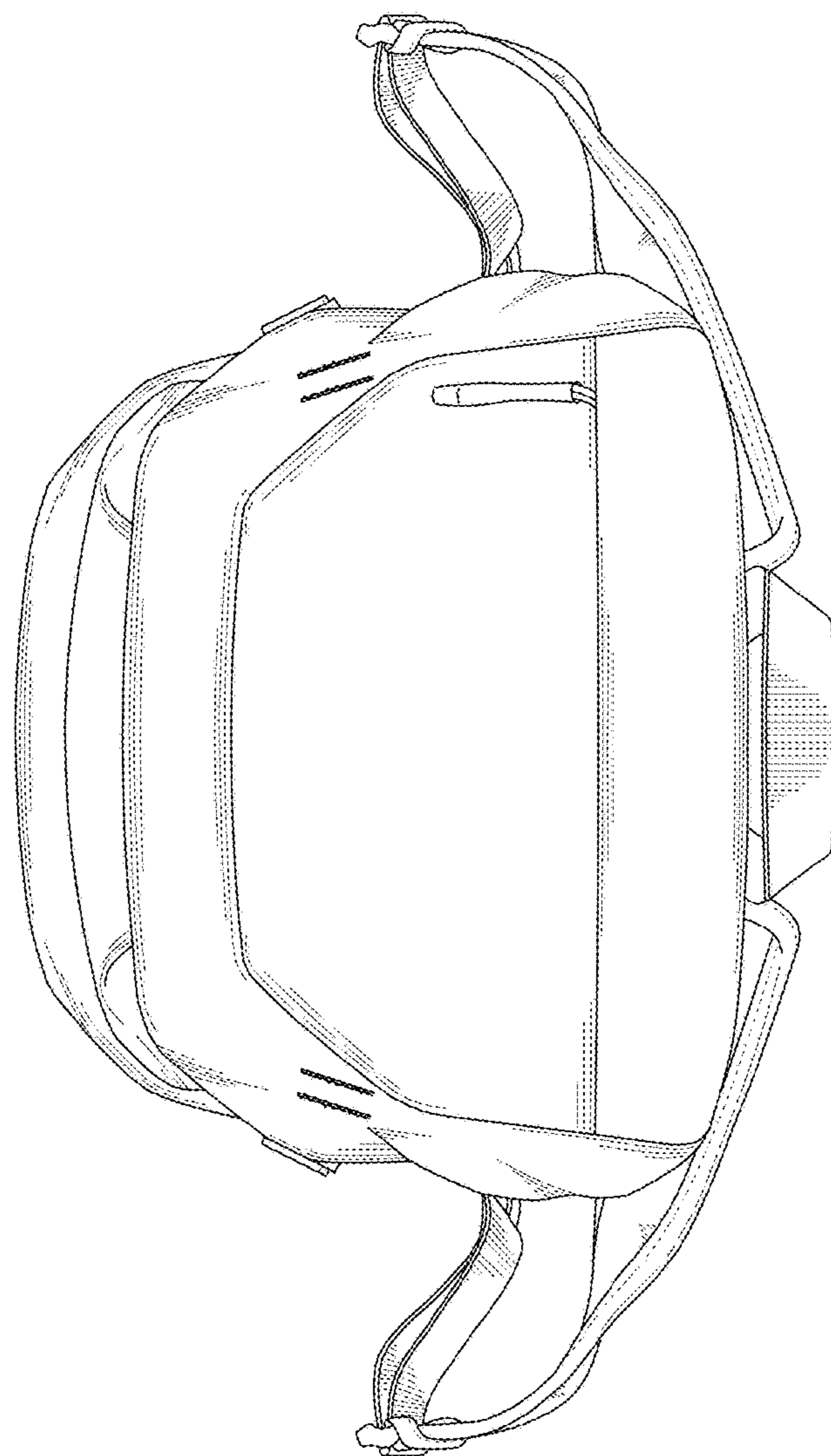

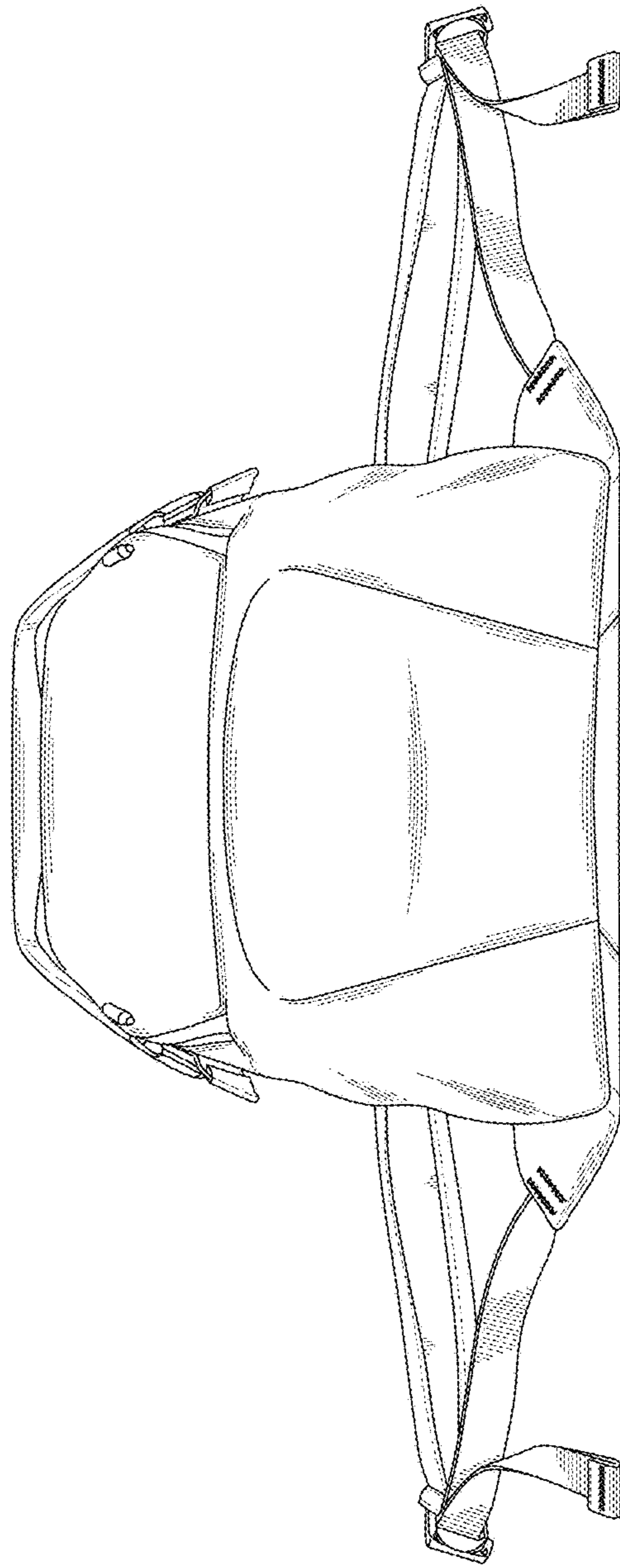

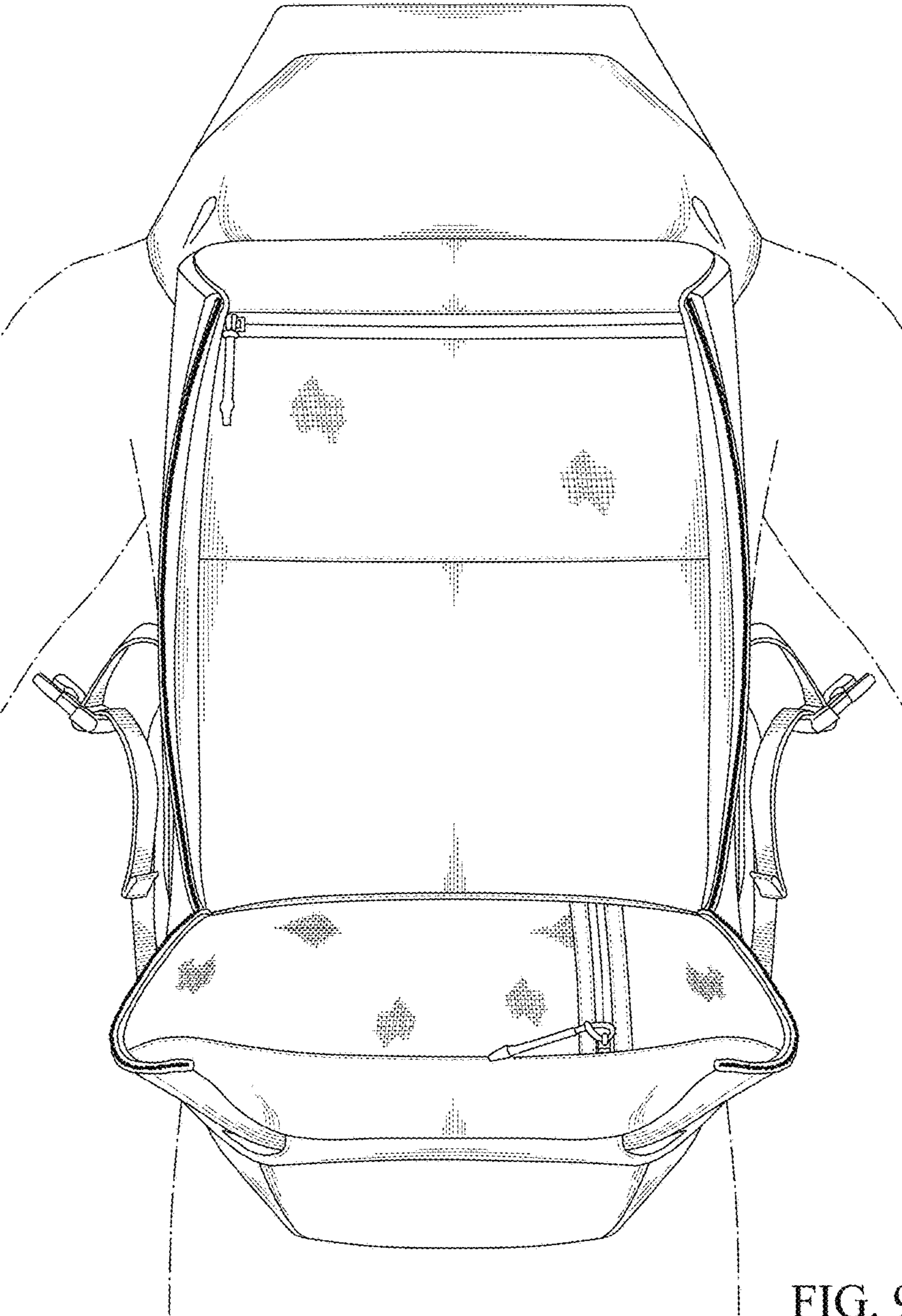
