FIG. 7 is a side view of travel case passport holder with power bank sleeve and port in a closed position showing my new design.

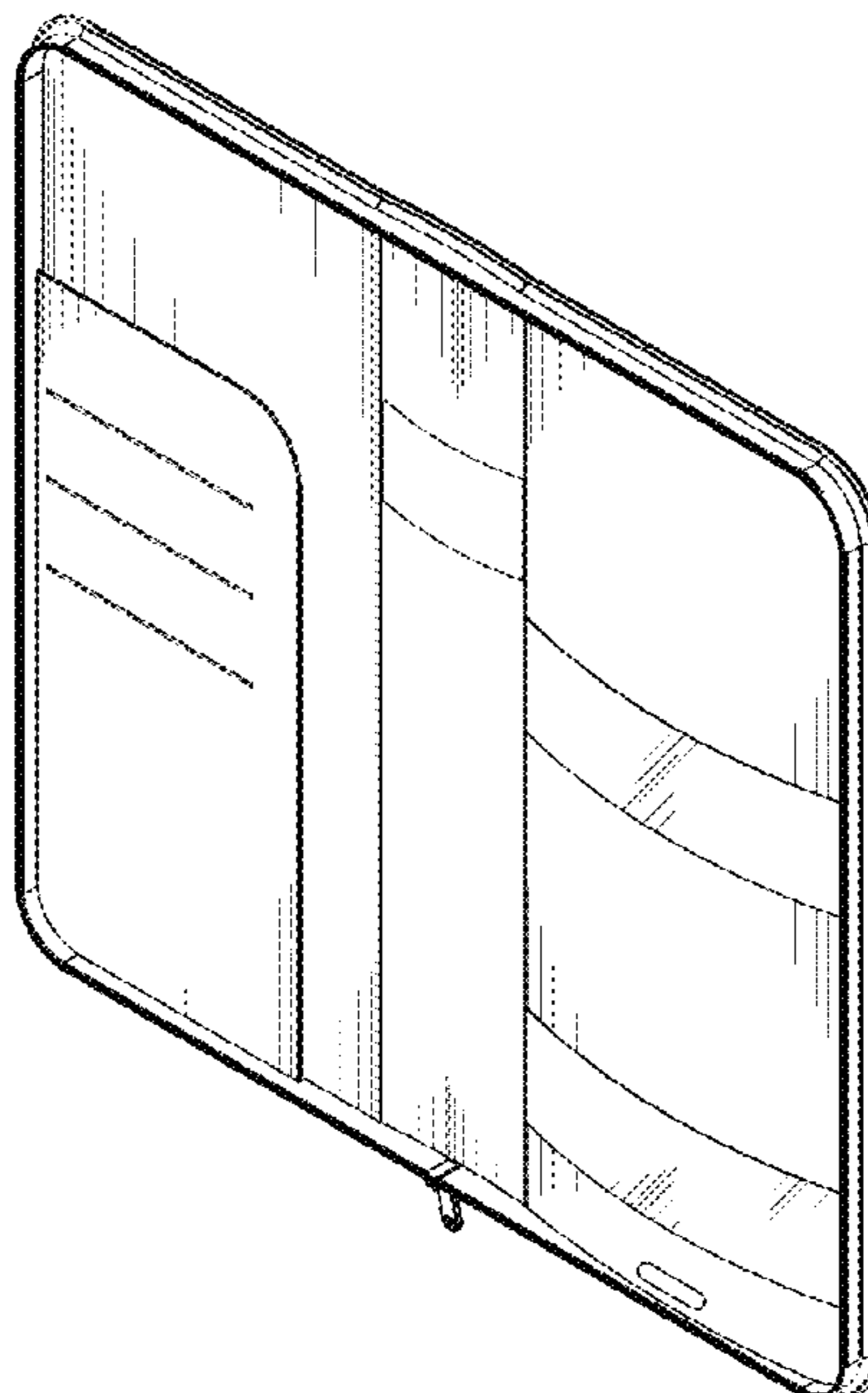
The broken lines showing in FIGS. 1, and 2 are for the purpose of illustrating card slots and a middle band strap, and form no part of the claimed design.

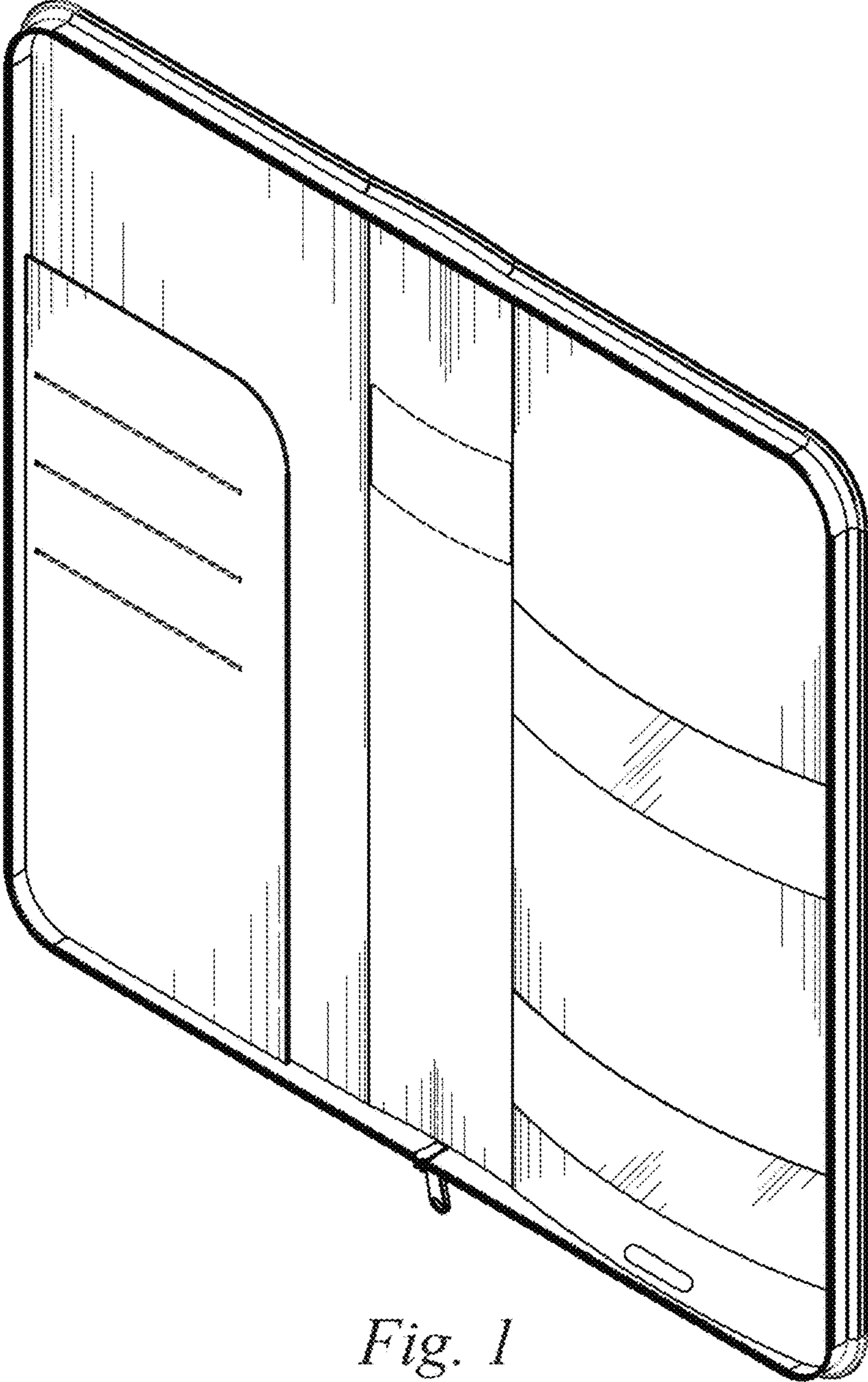

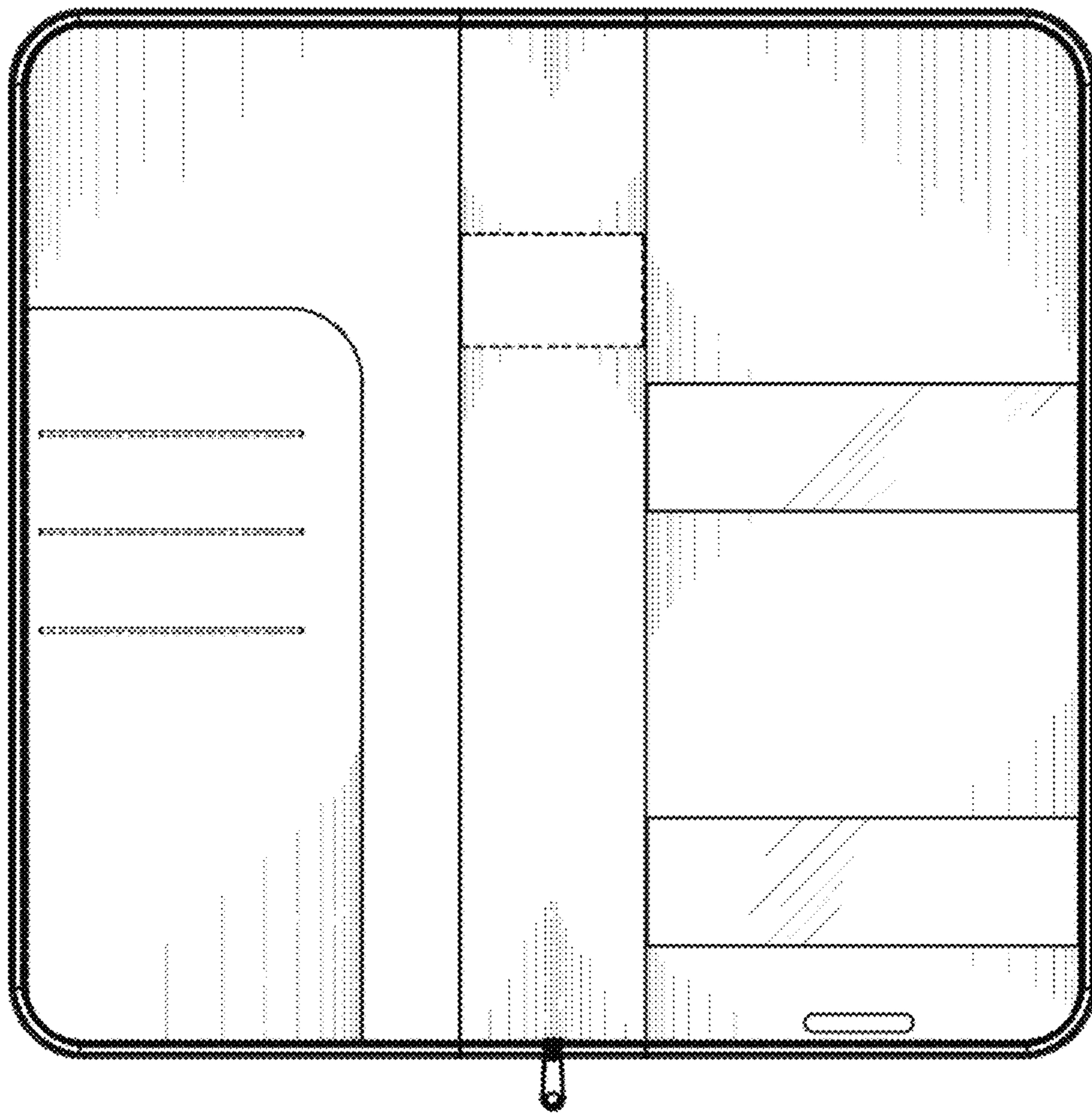

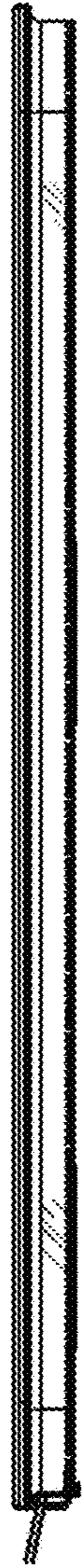

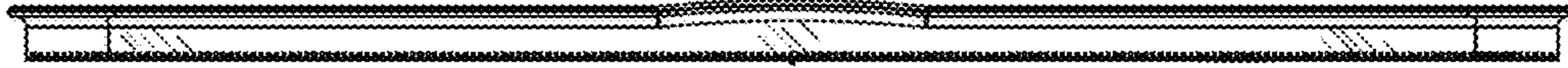

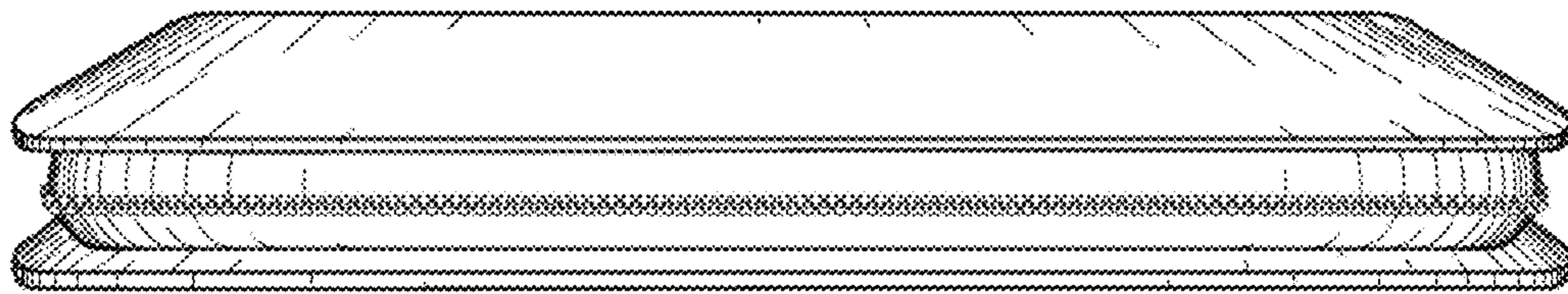
