DESCRIPTION

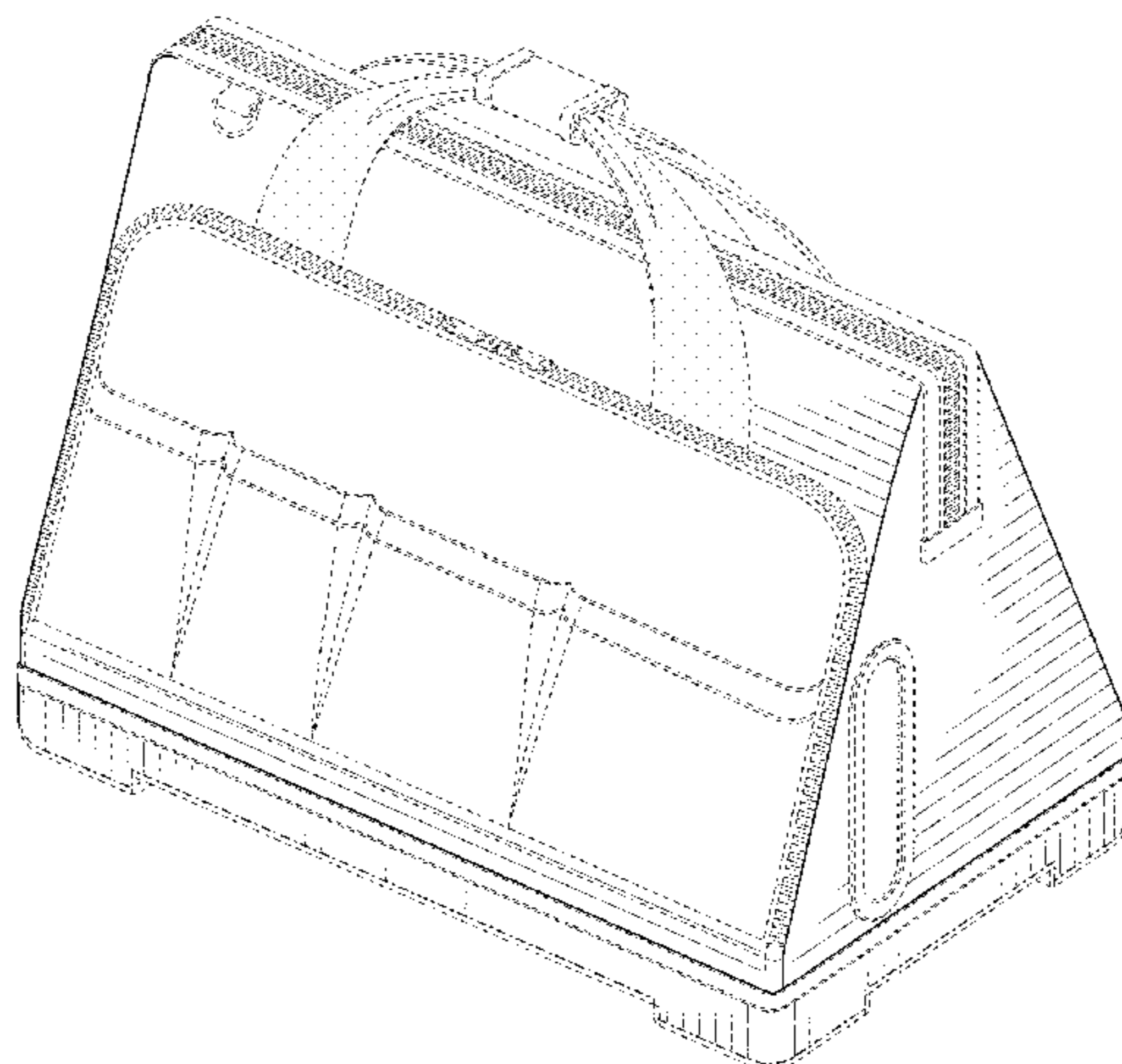
FIG. 1 is a perspective front view of a chainsaw carrying case.

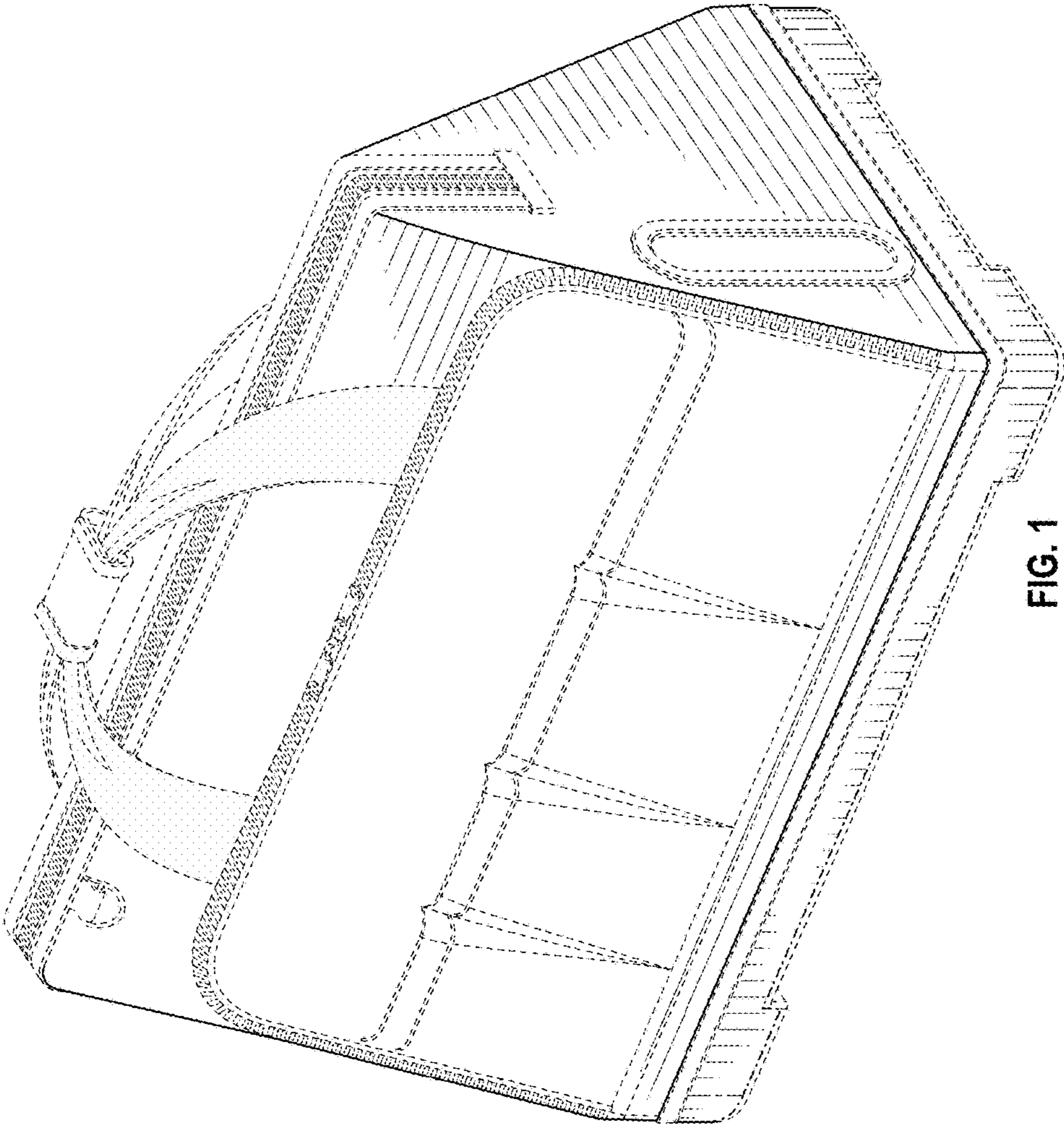

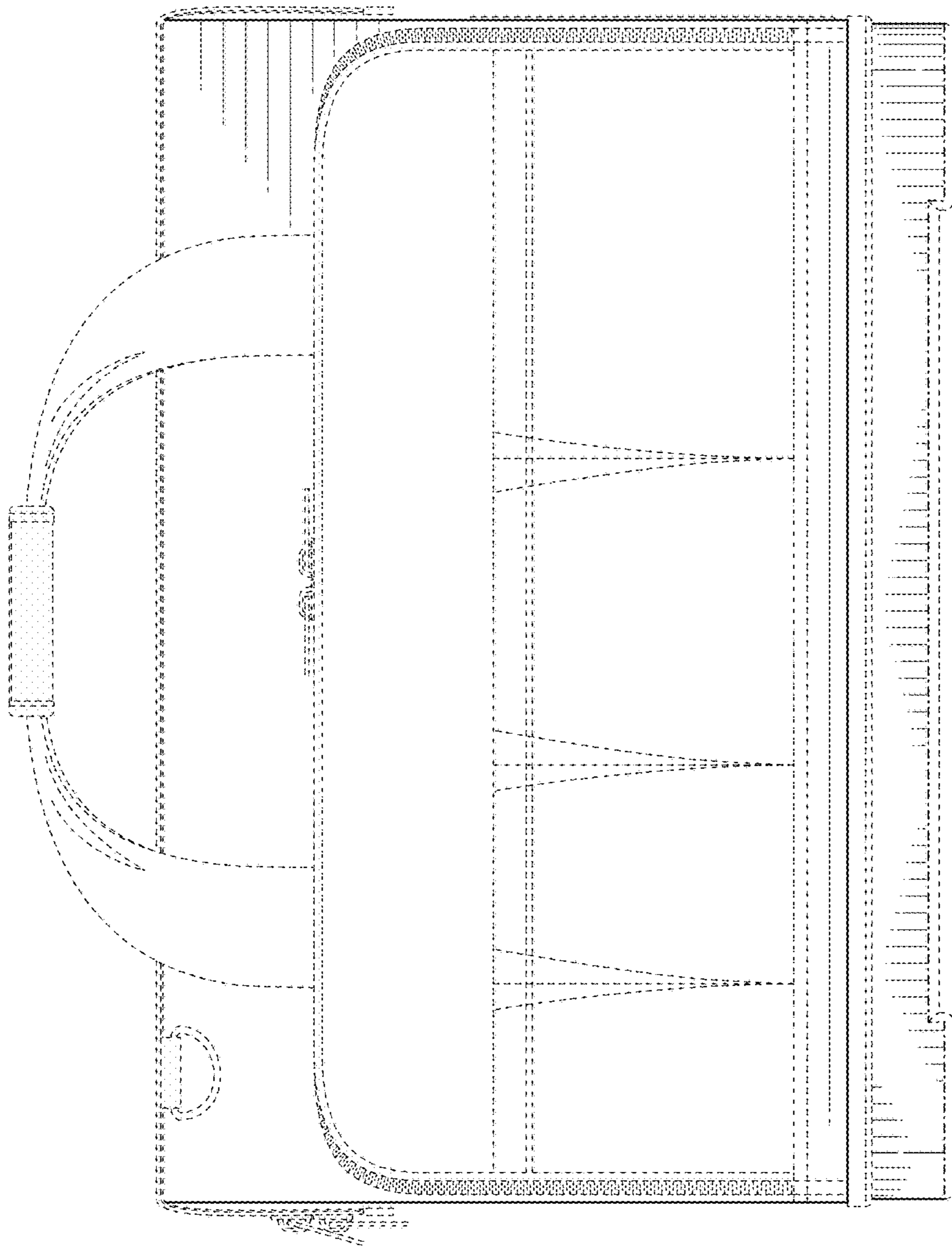

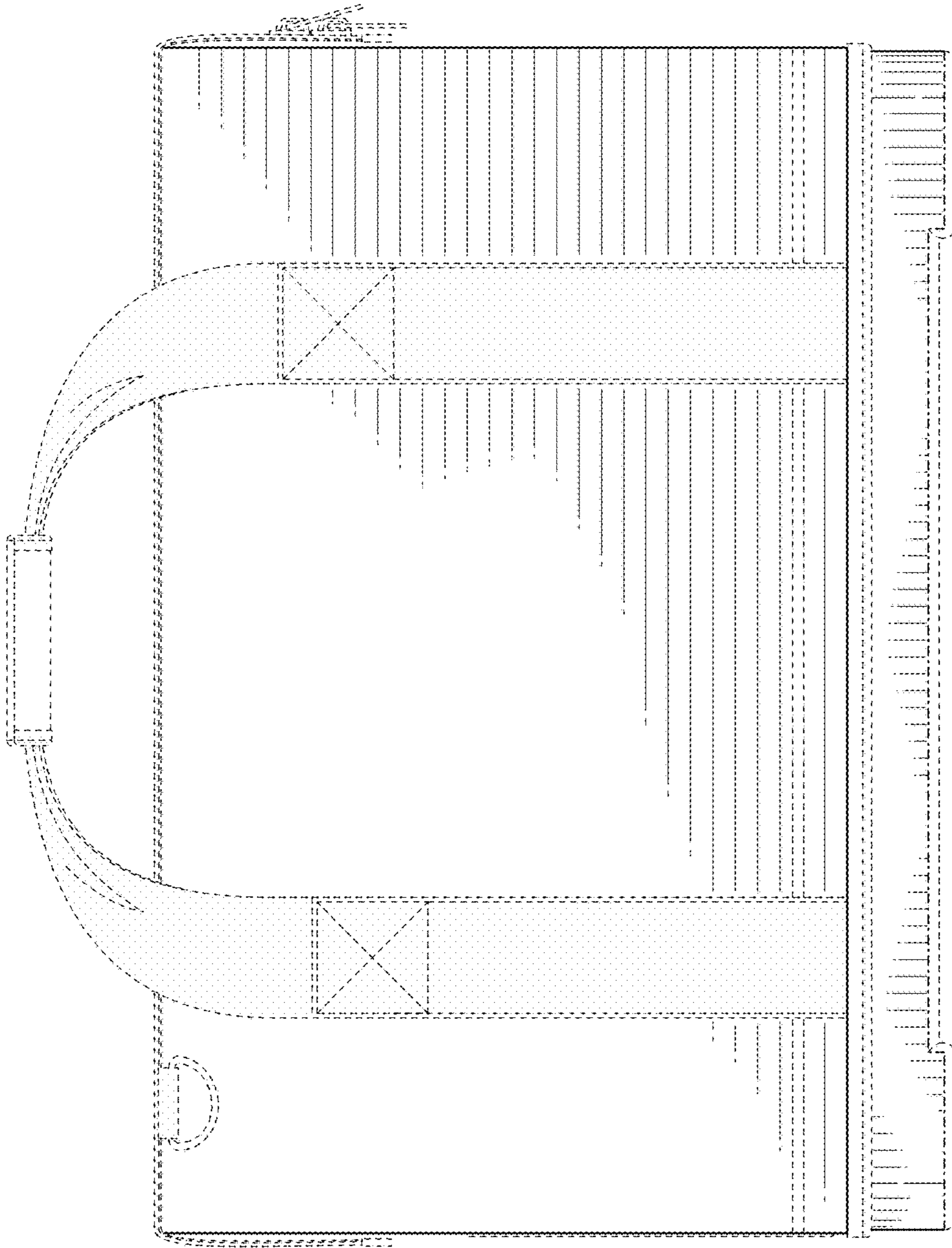

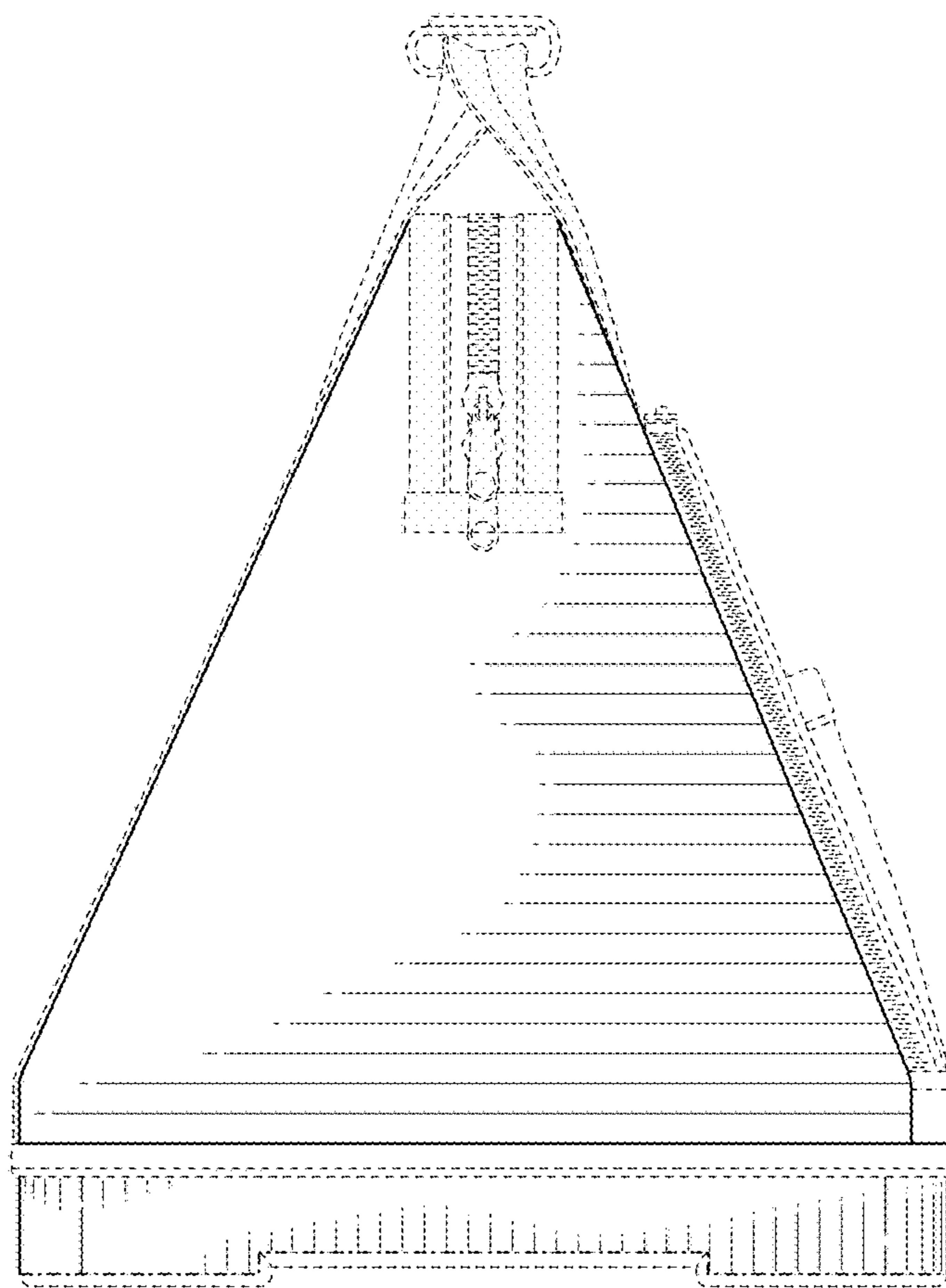

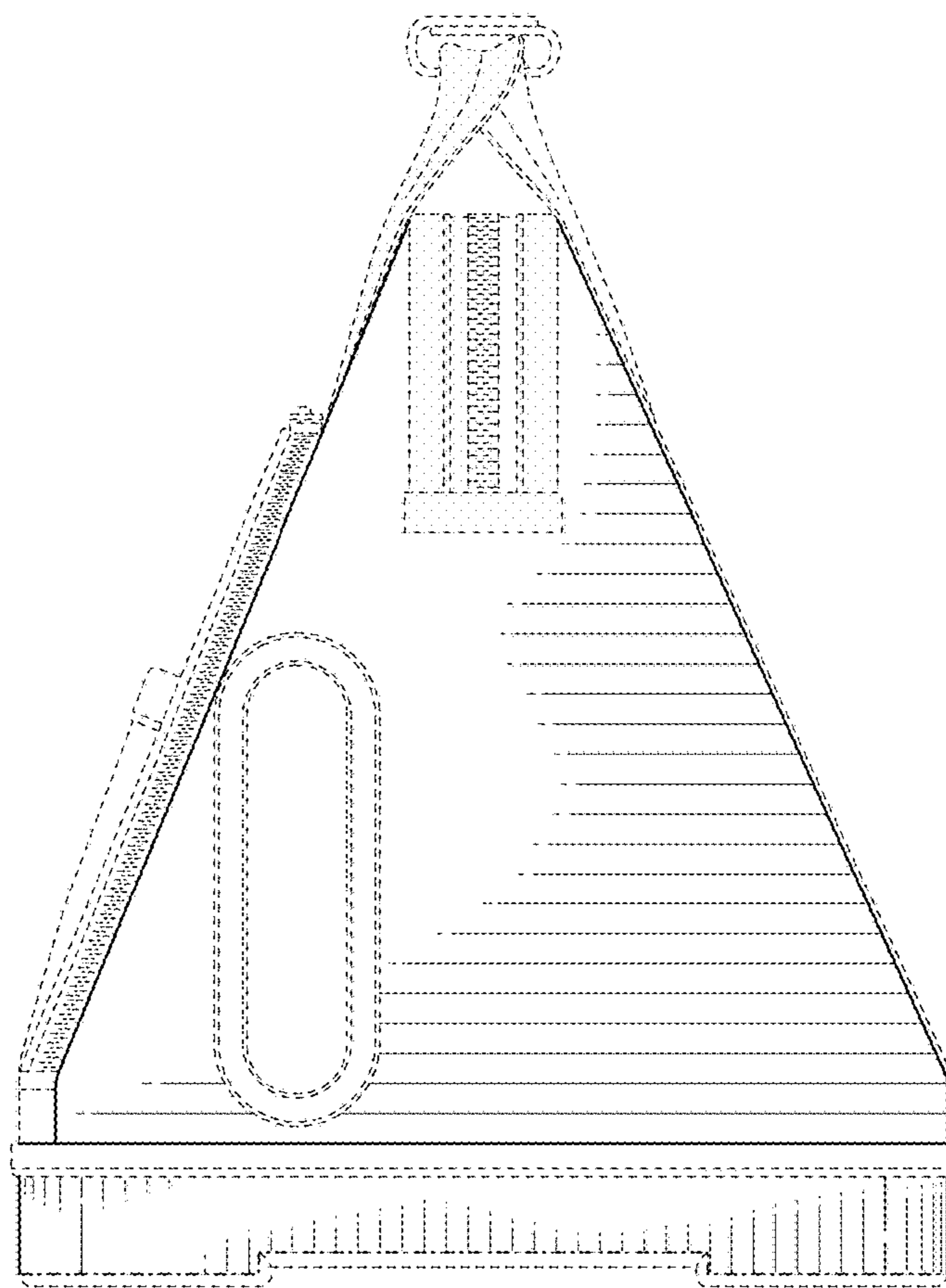

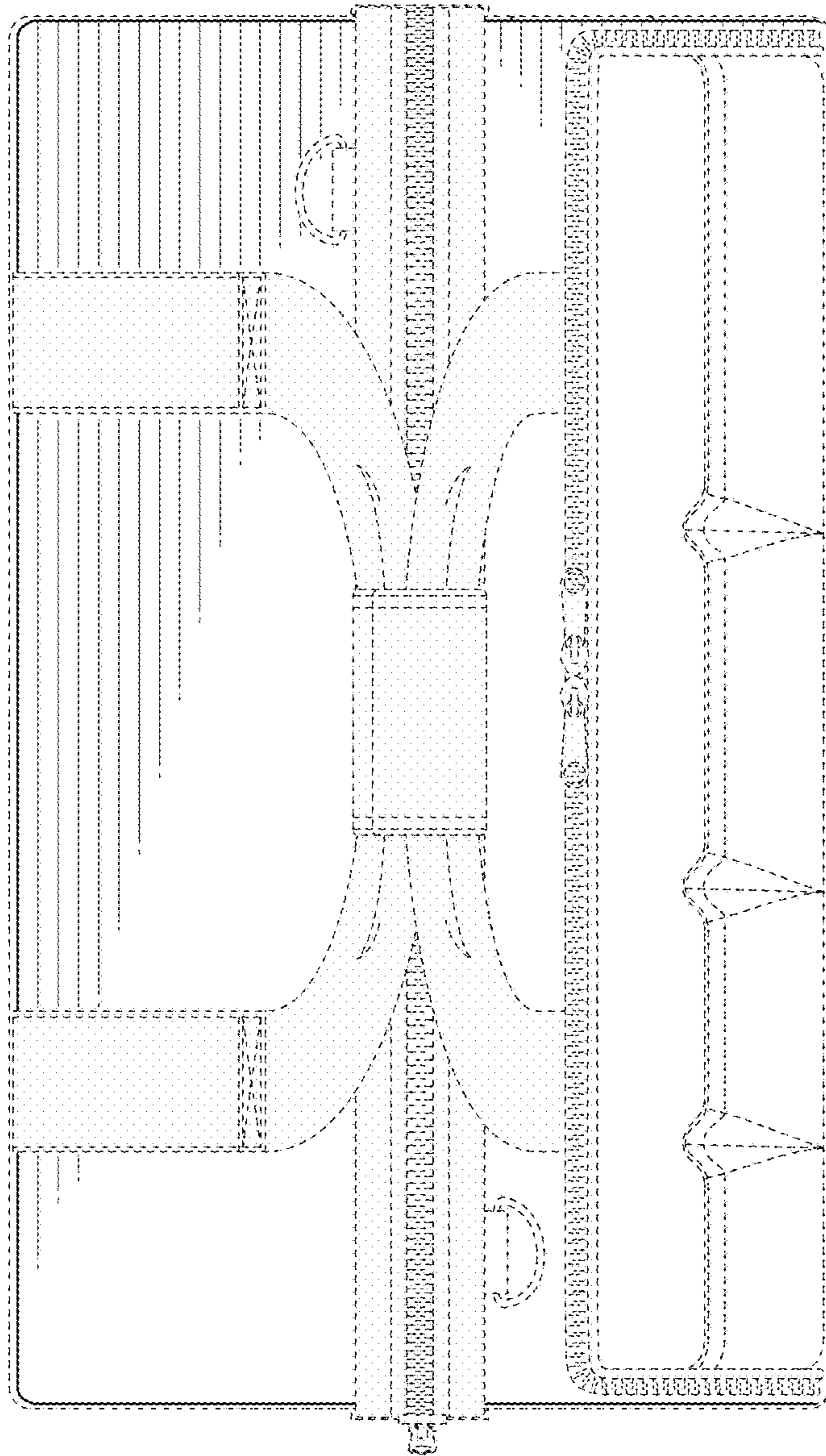

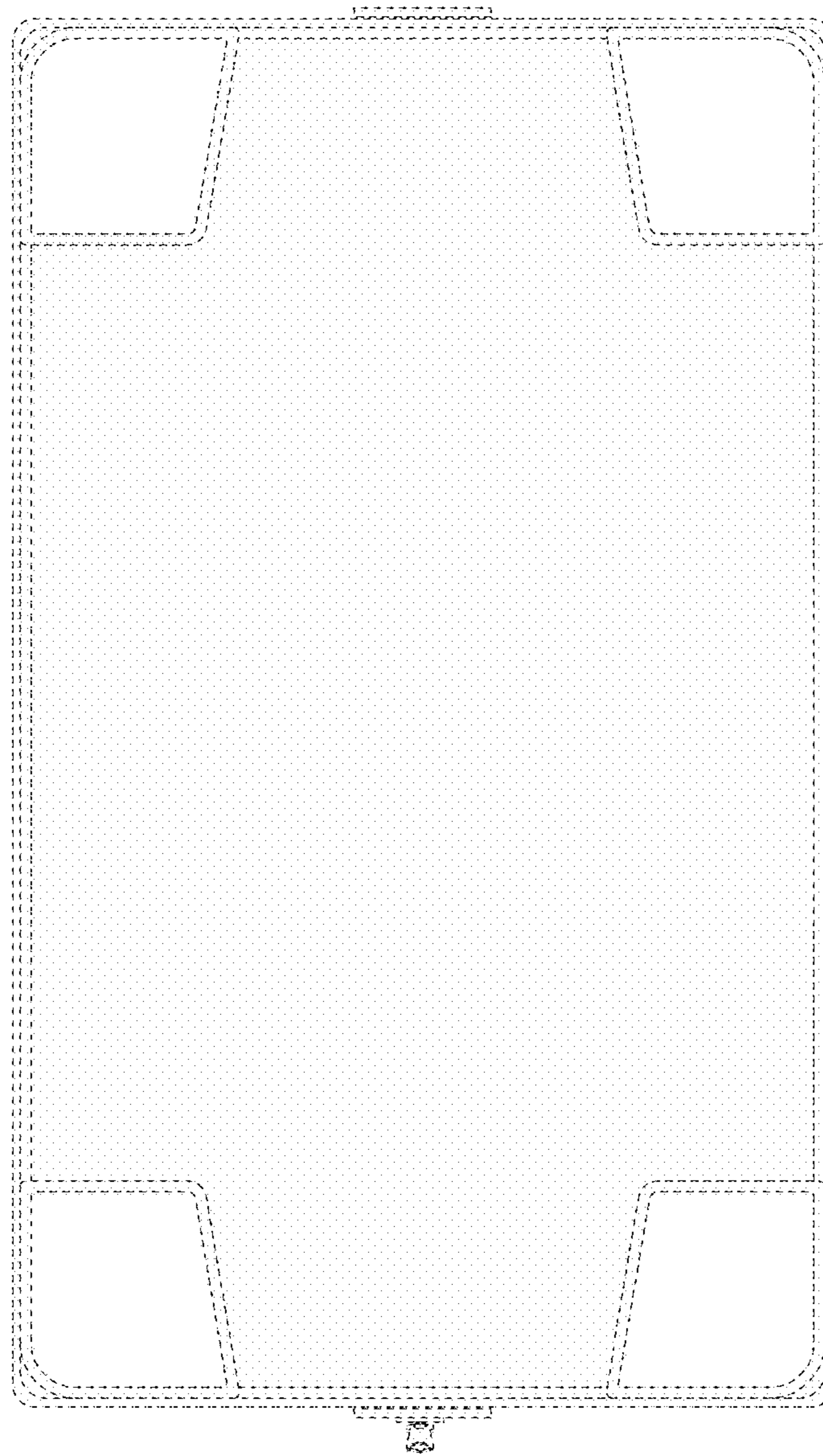
