(57) **CLAIM**

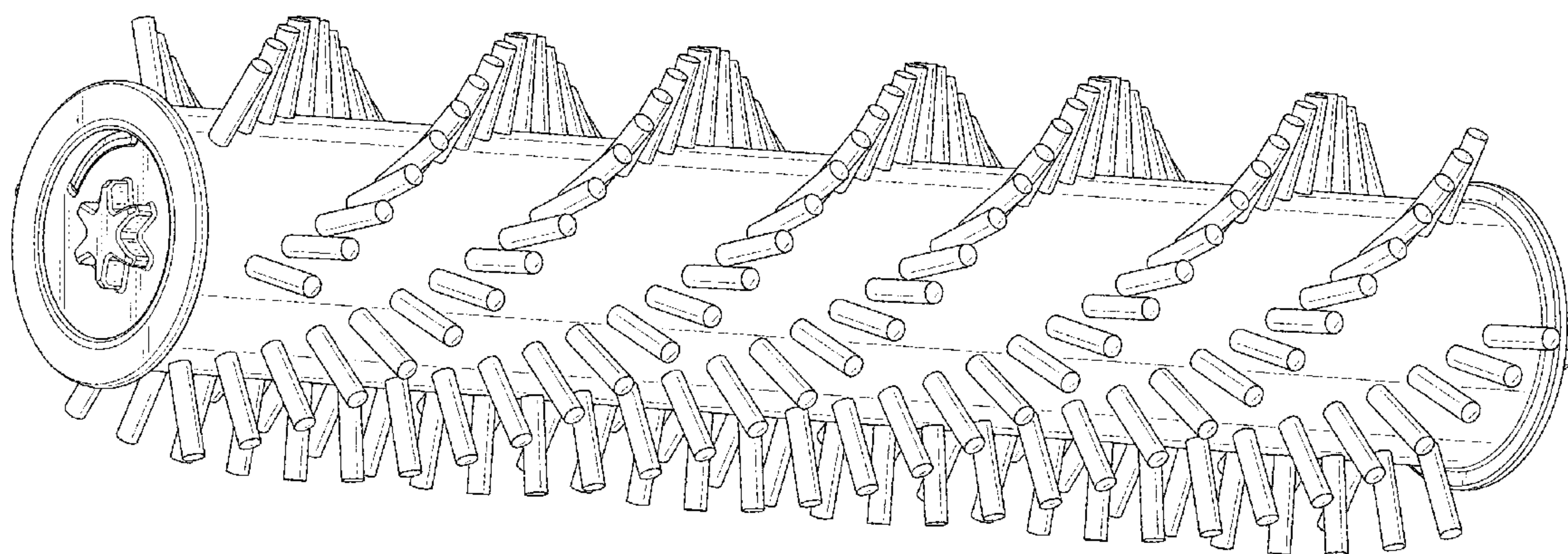
The ornamental design for a brush roll, as shown and described.

DESCRIPTION

FIG. 1 is a top-right perspective view of an embodiment of a brush roll incorporating the design; FIG. 2 is a front view of the brush roll of FIG. 1; FIG. 3 is a rear view of the brush roll of FIG. 1; FIG. 4 is a left side view of the brush roll of FIG. 1; FIG. 5 is a right side view of the brush roll of FIG. 1; FIG. 6 is a top view of the brush roll of FIG. 1; FIG. 7 is a bottom view of the brush roll of FIG. 1; and, FIG. 8 is a bottom-left perspective view of the brush roll of FIG. 1.

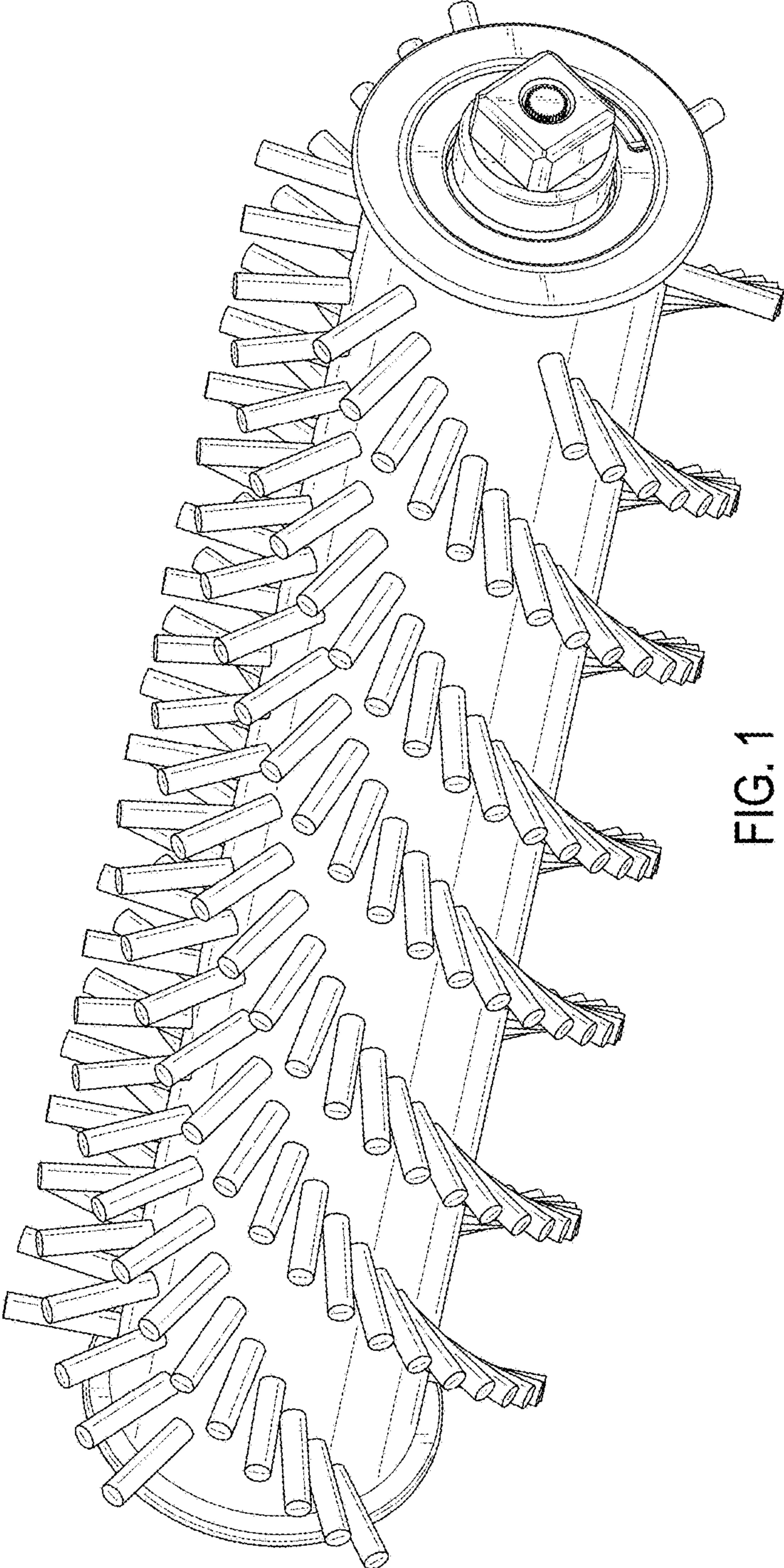

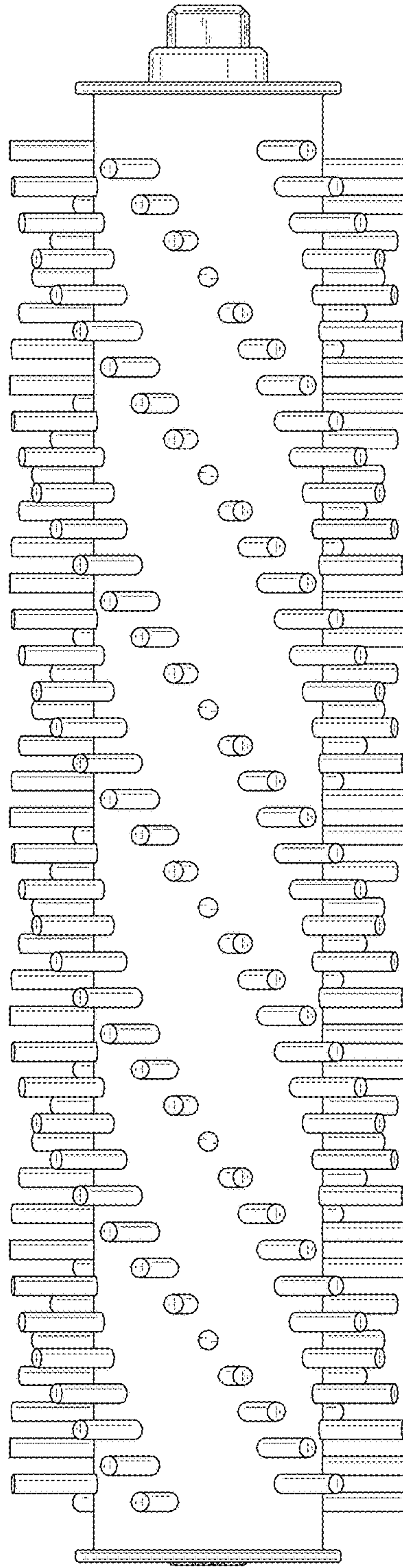

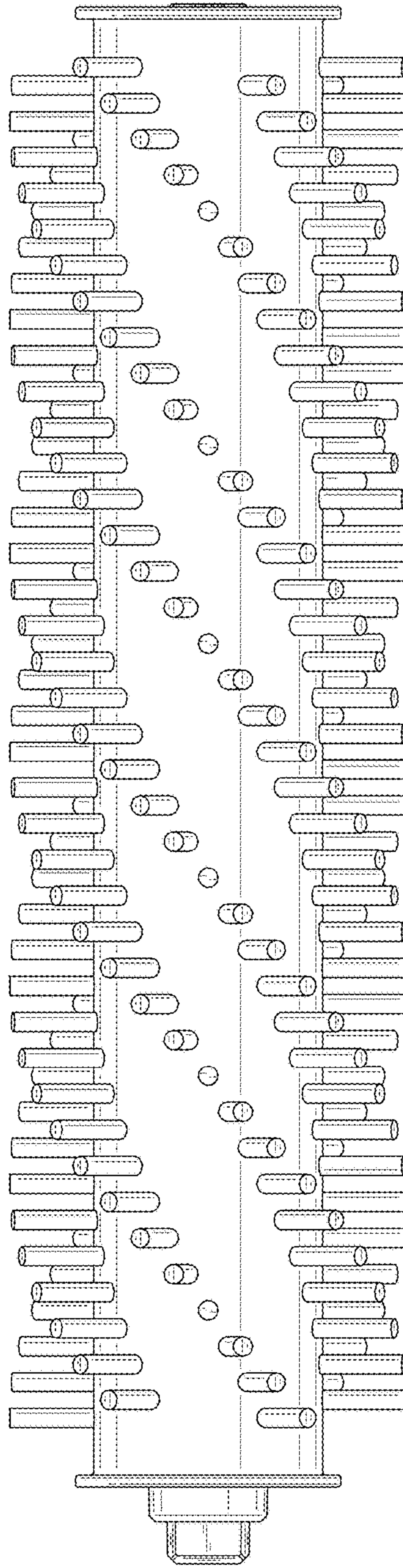

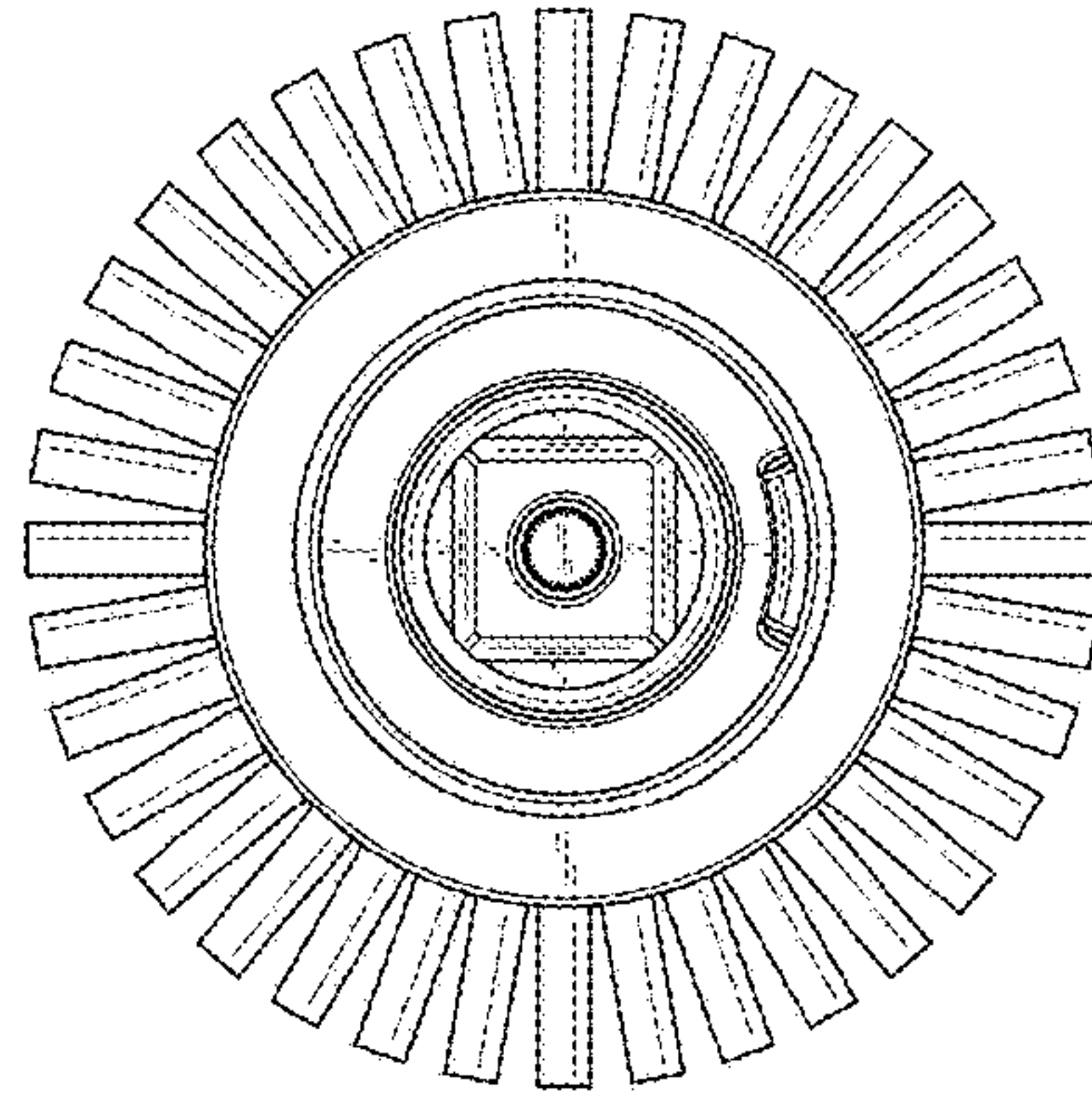

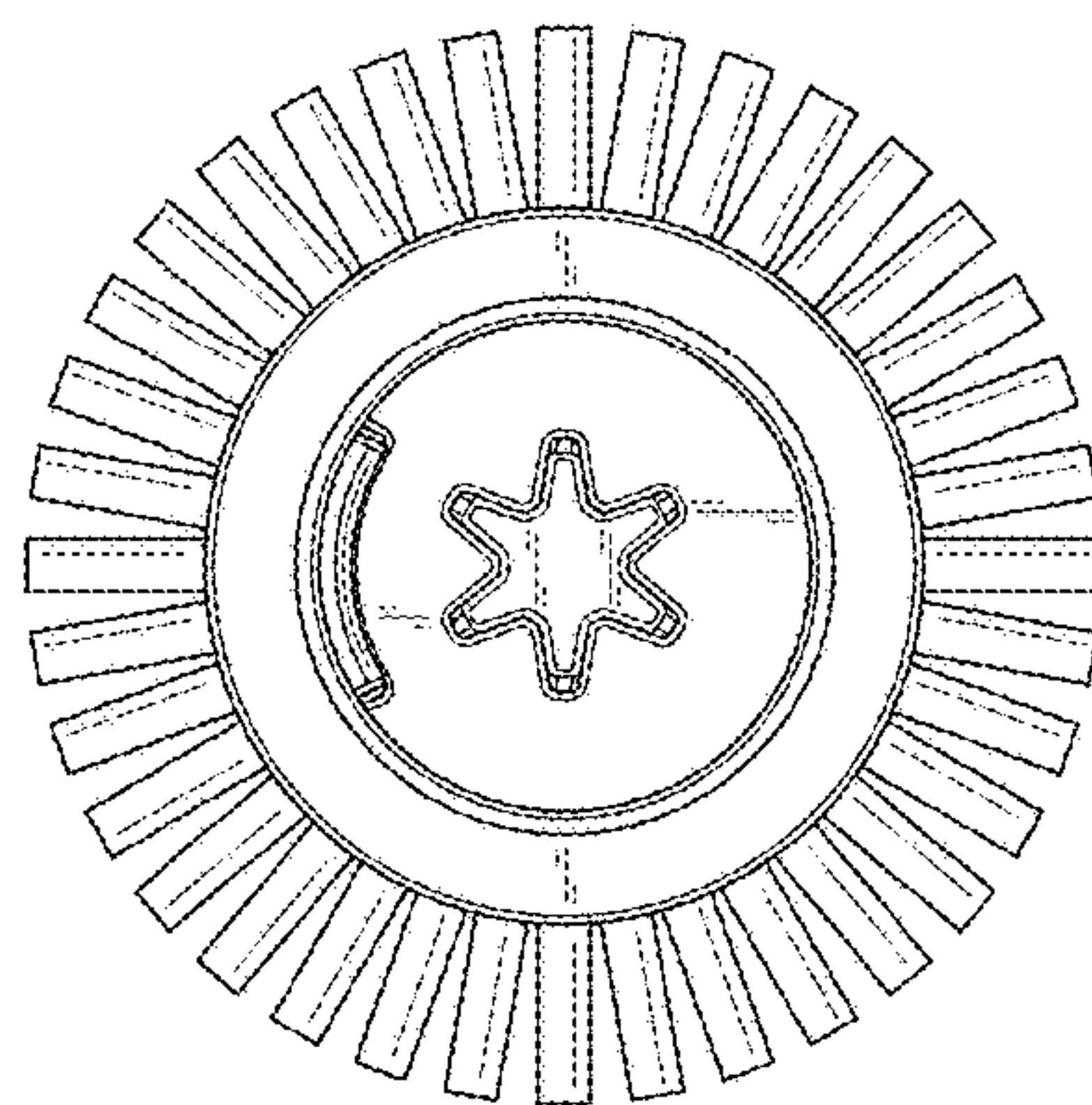

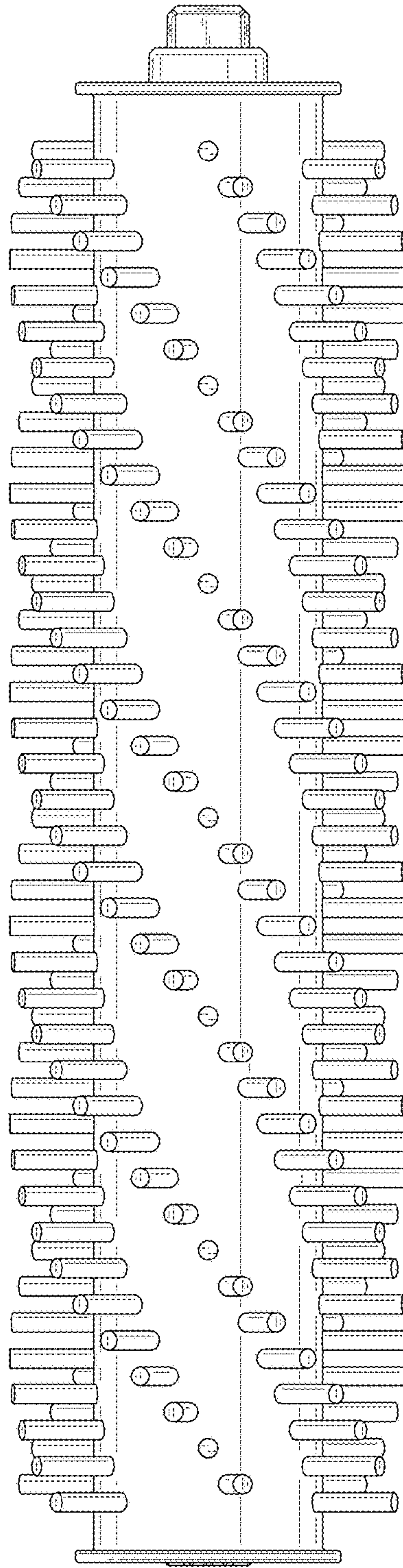

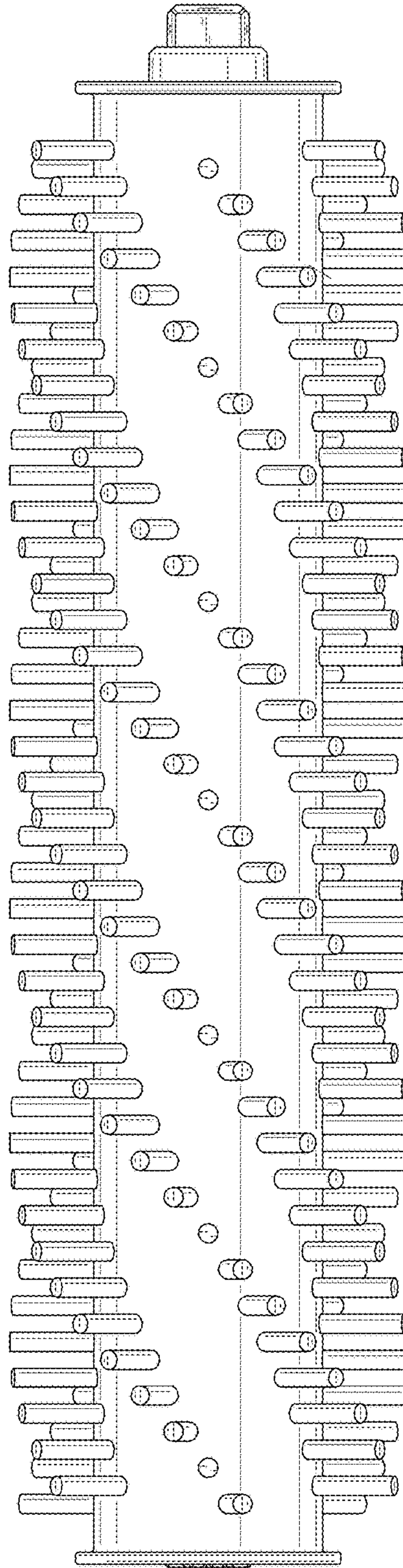

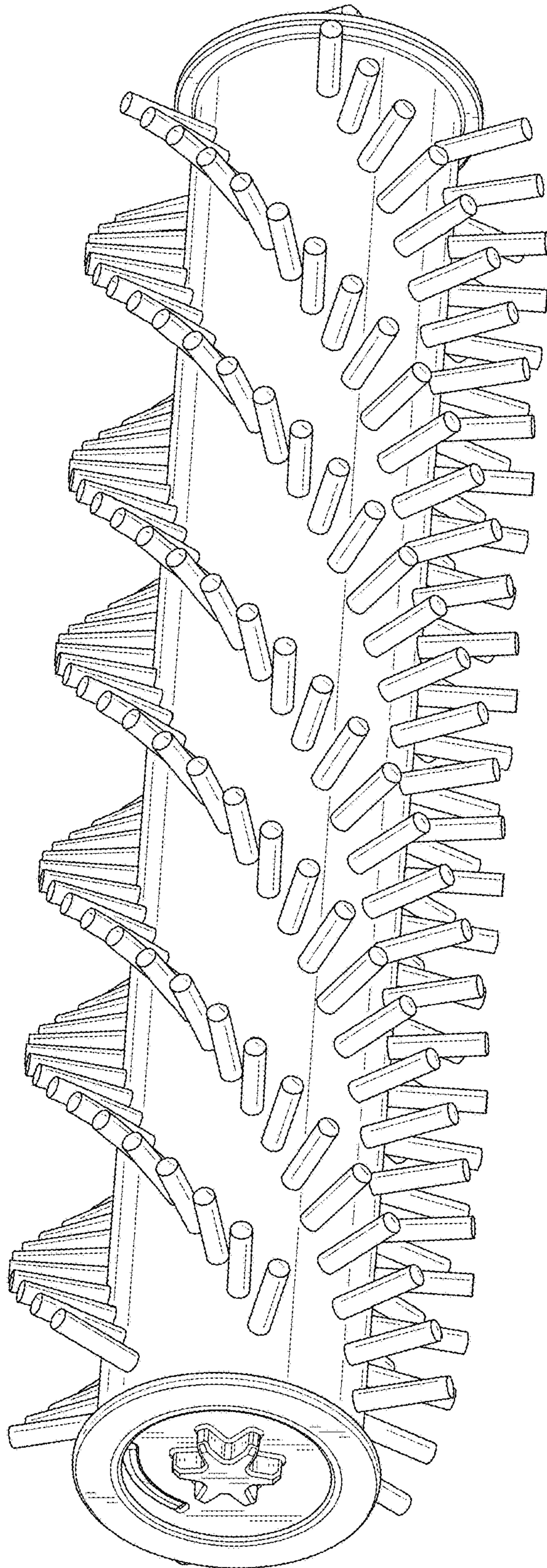
