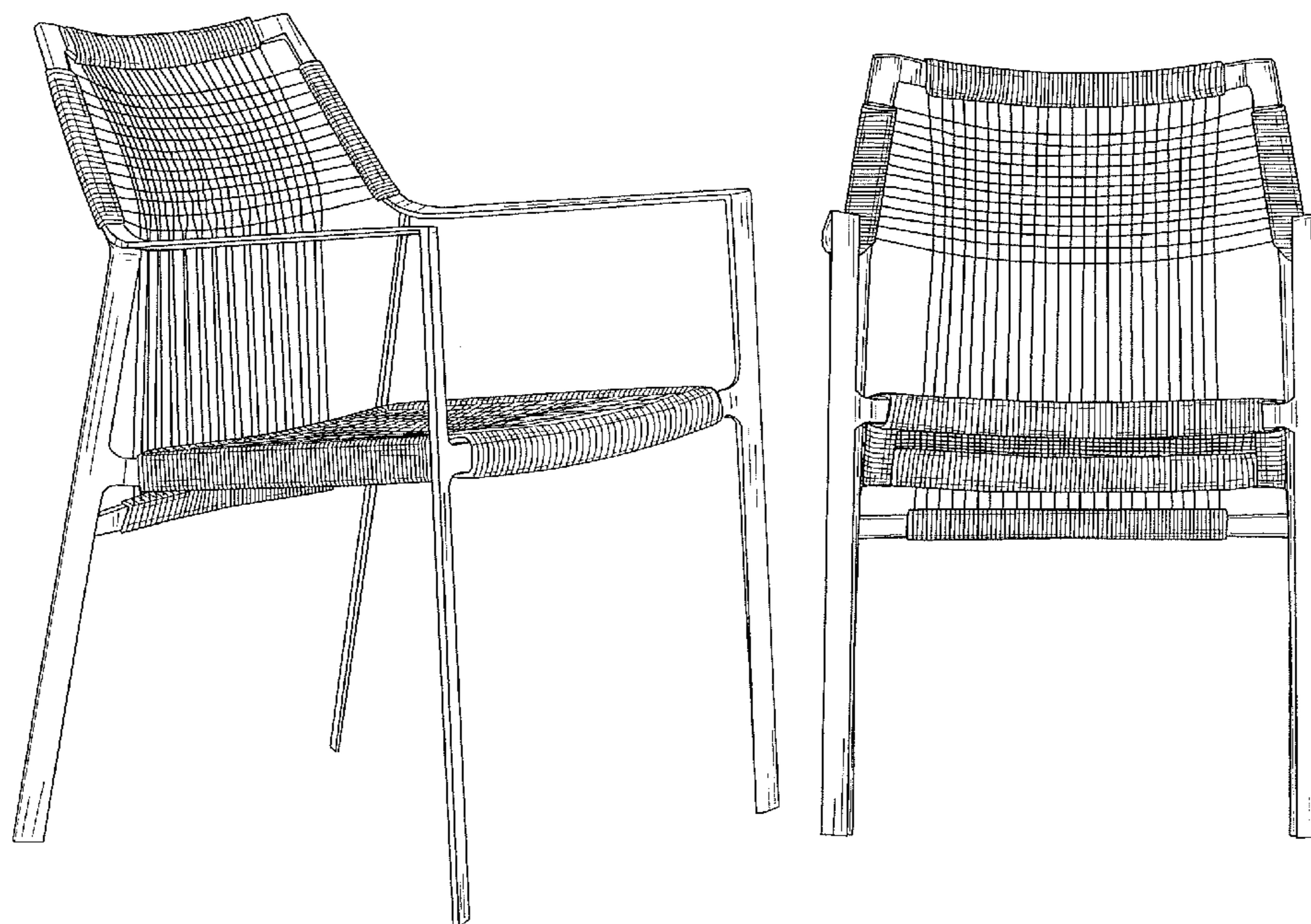

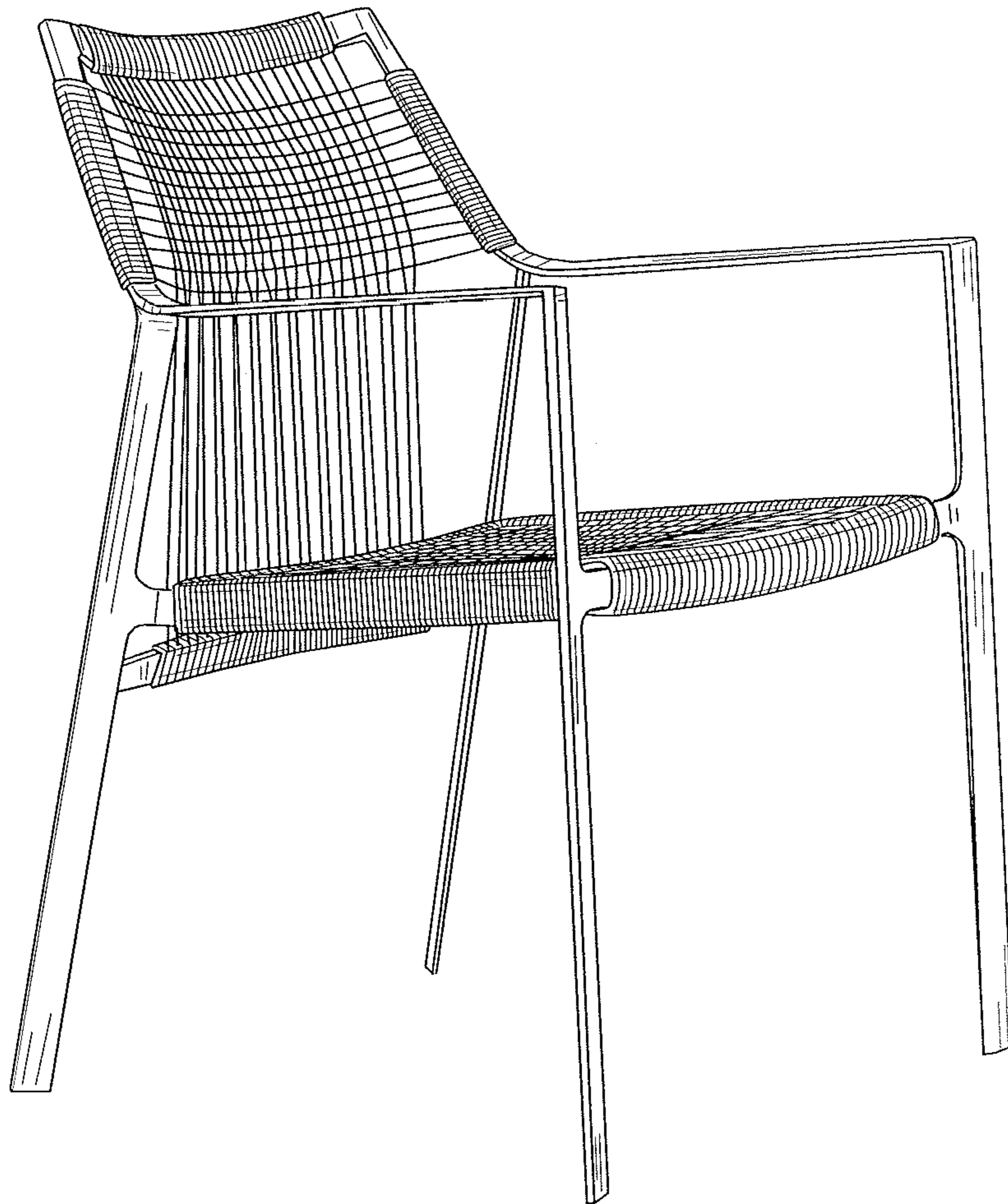
The ornamental design for an armchair, as shown and described.

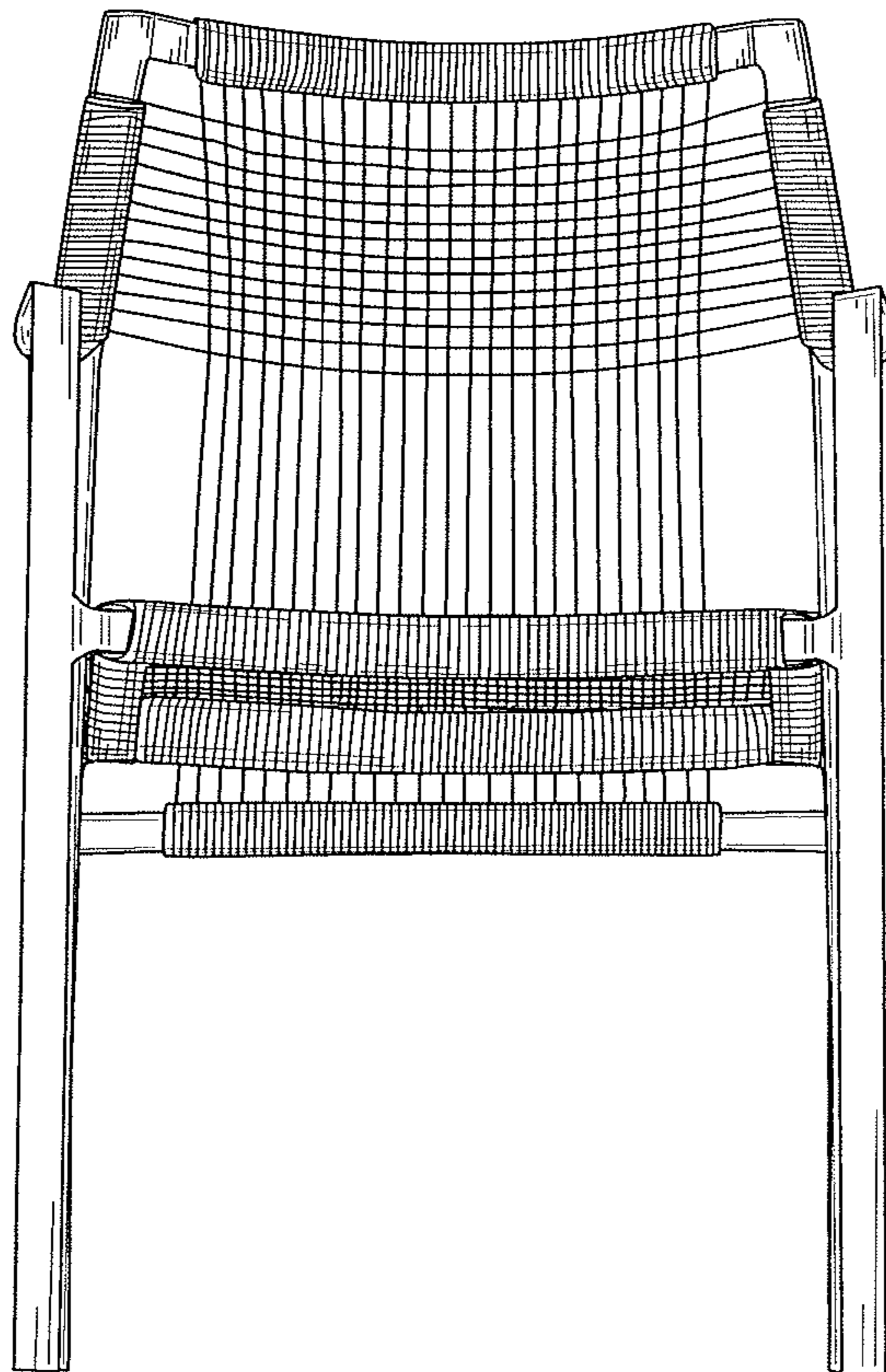
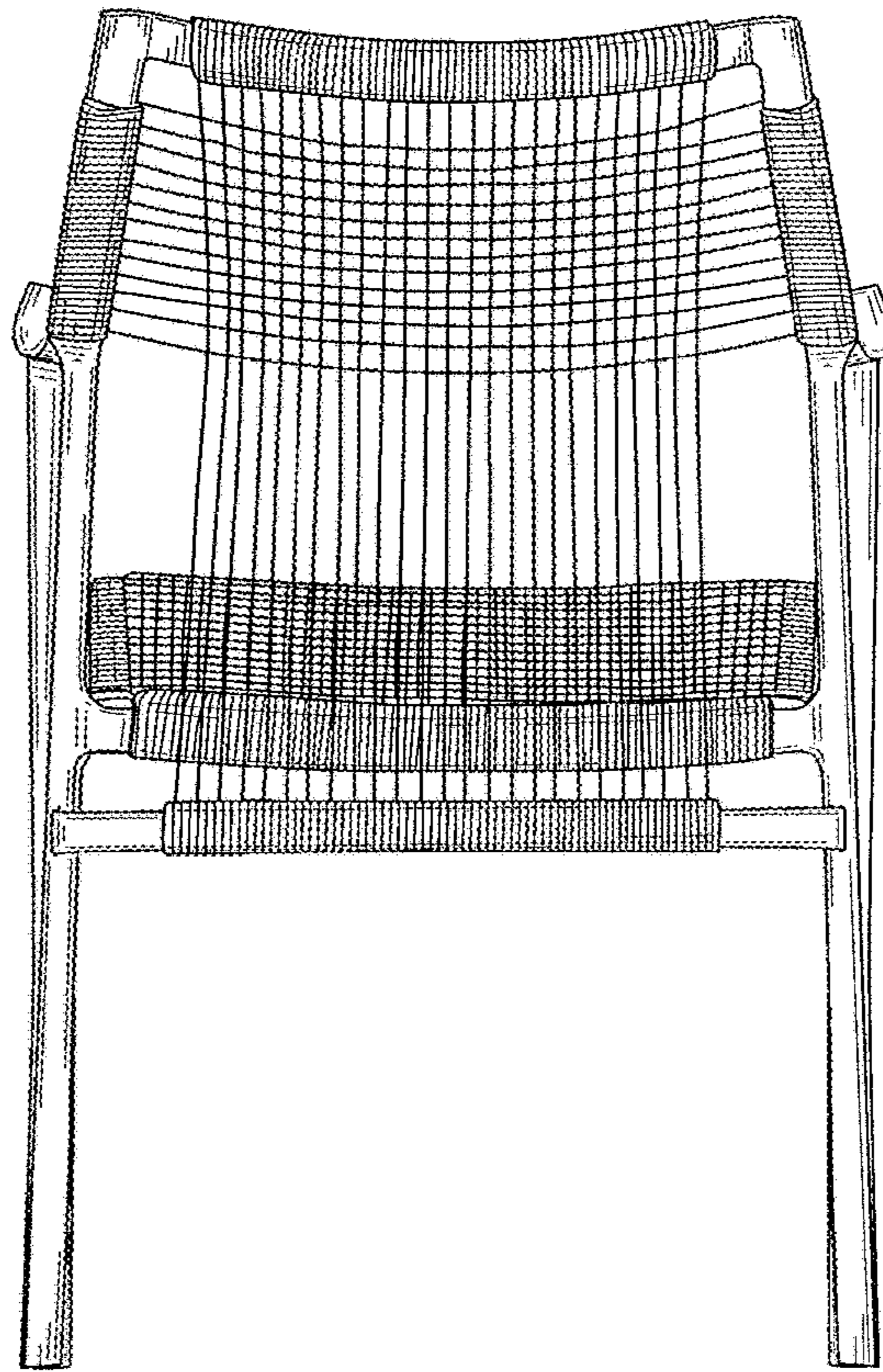

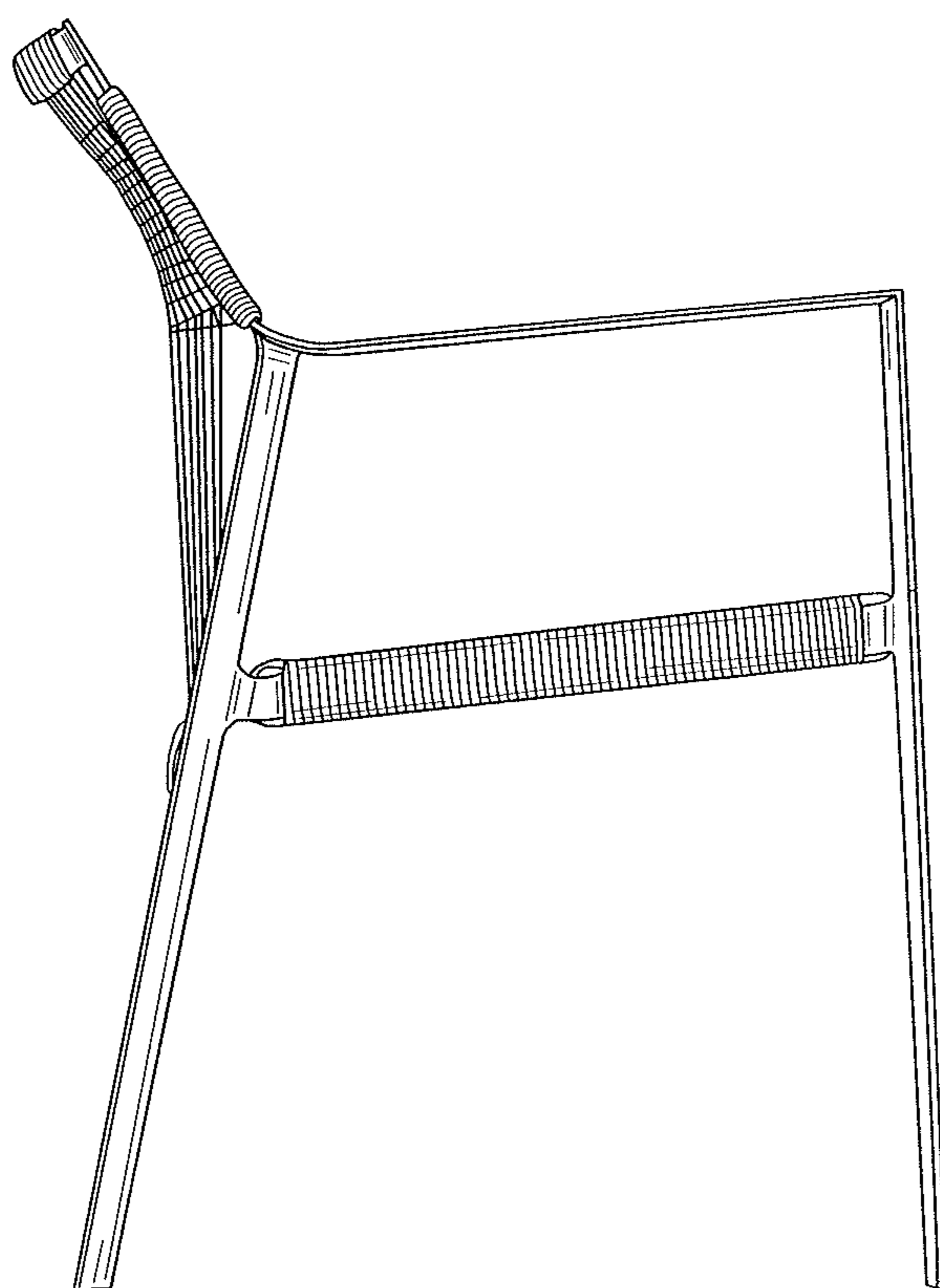

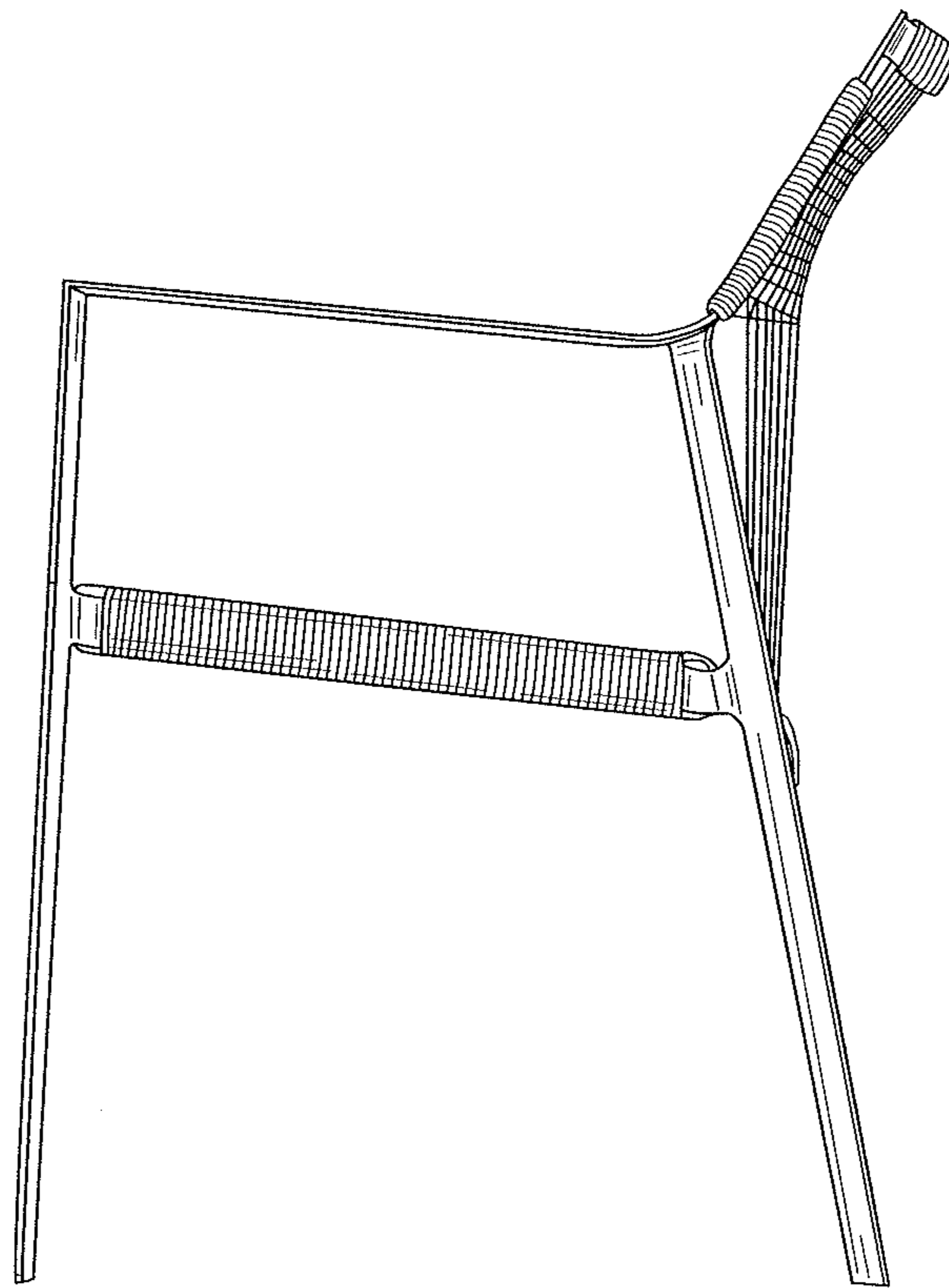
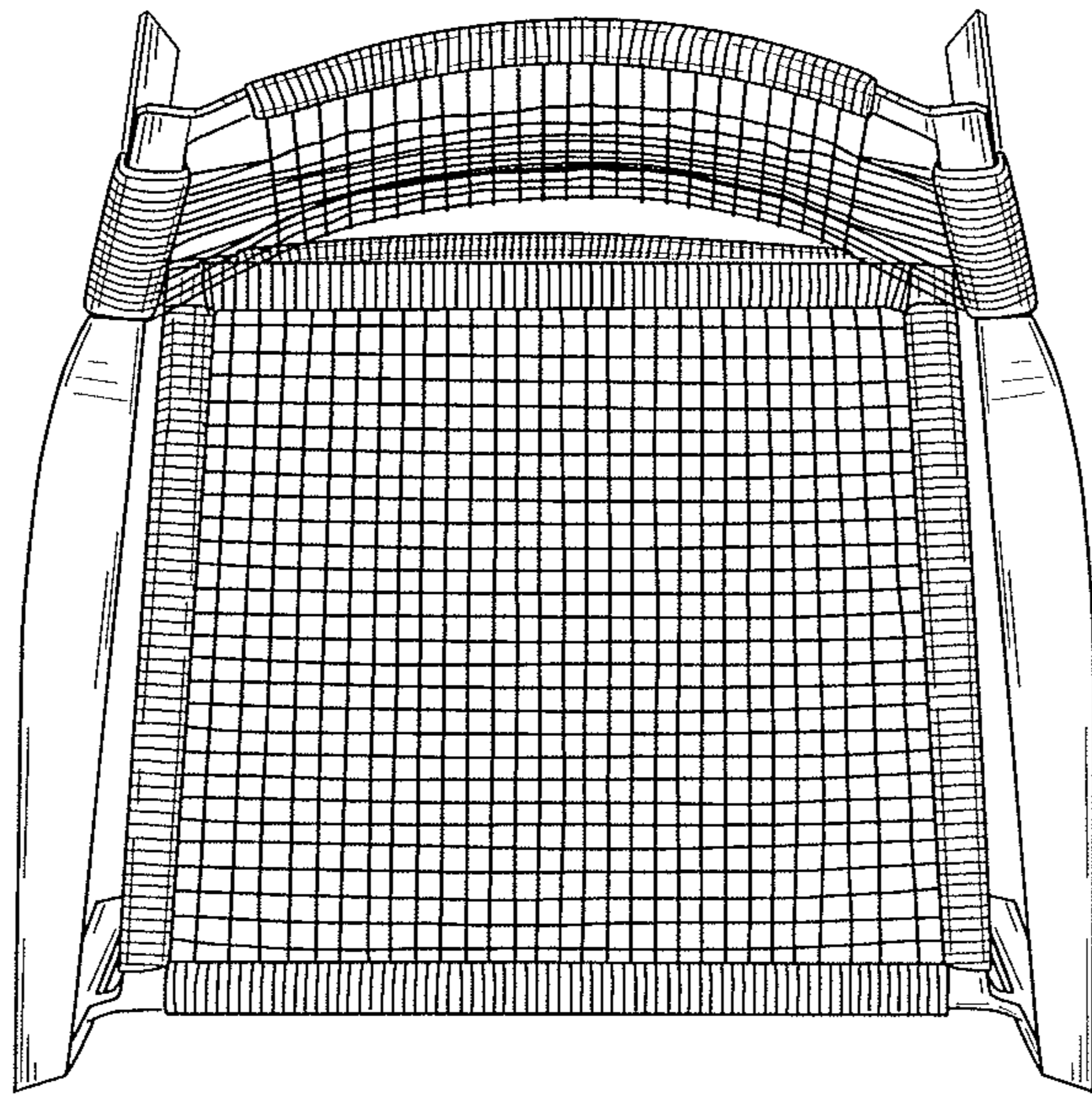

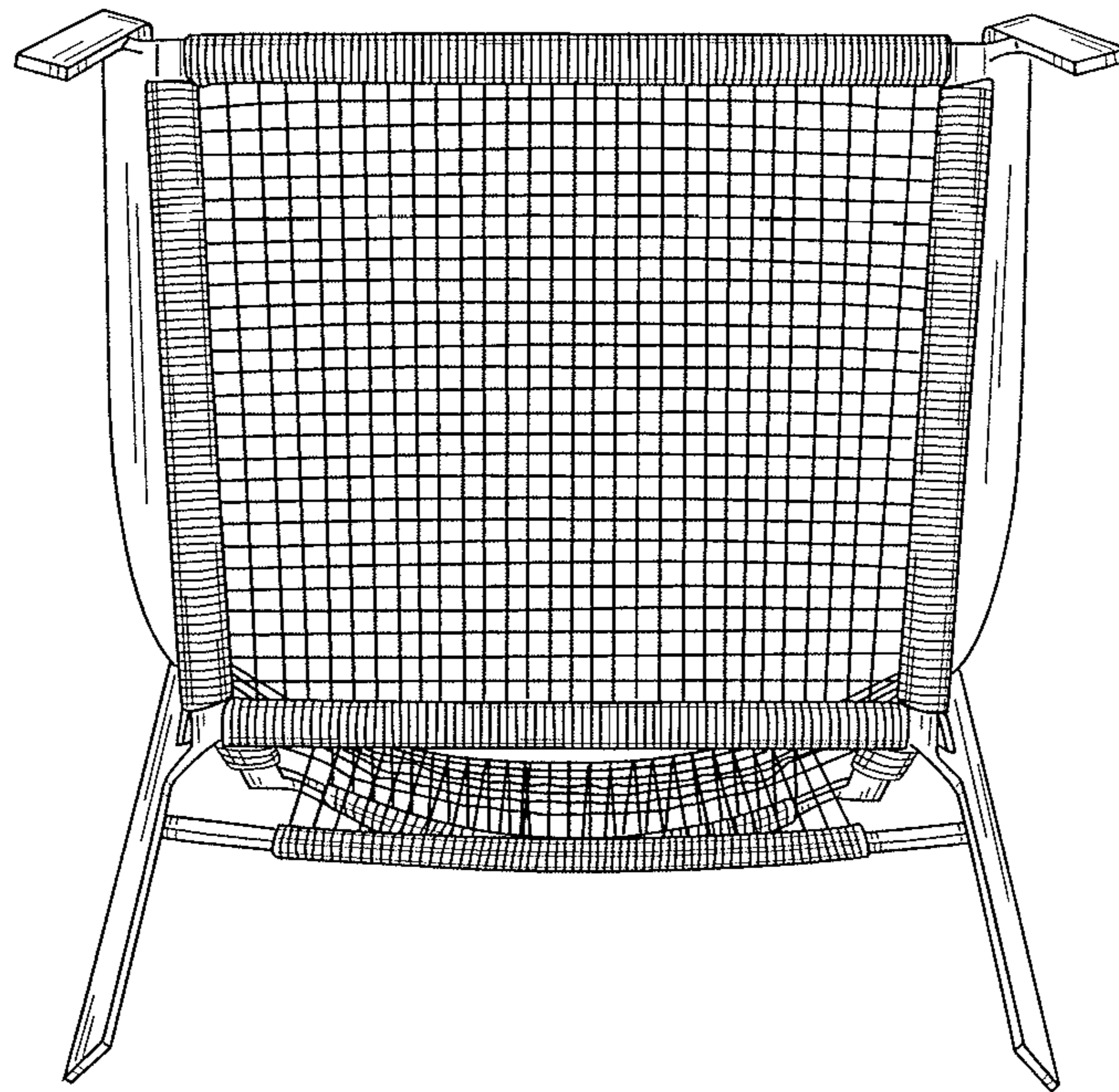
