**DESCRIPTION**

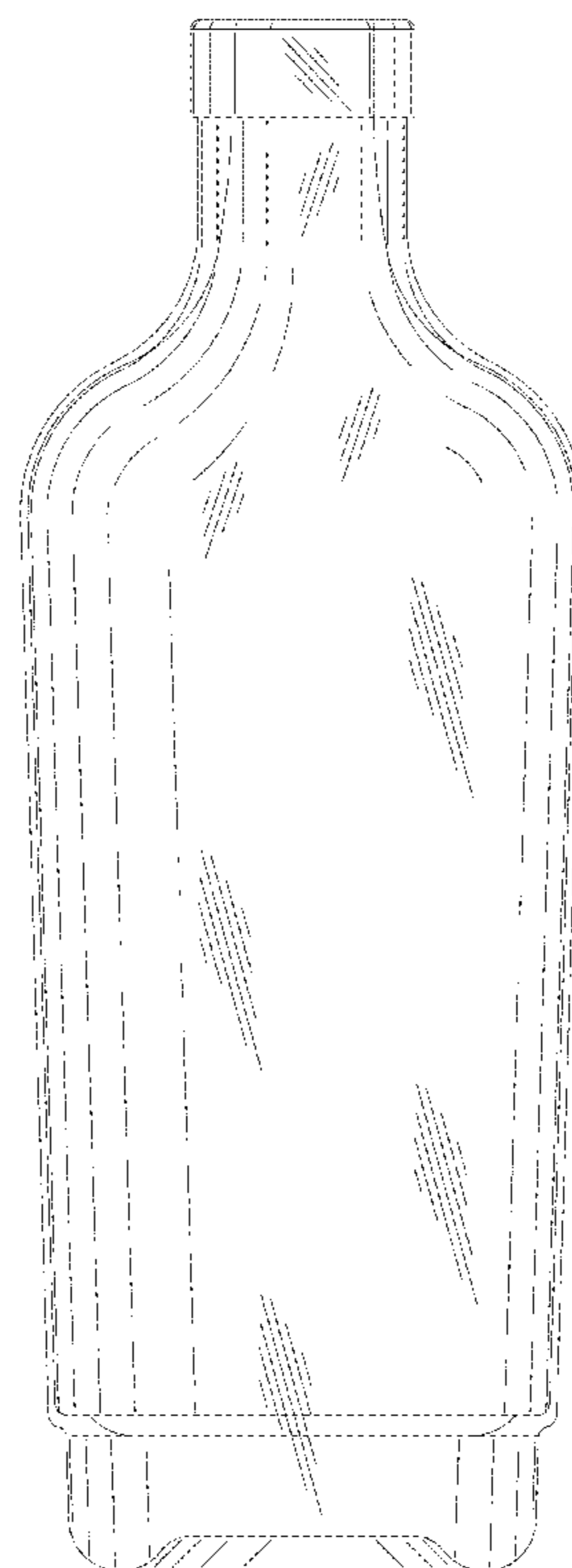
FIG. 1 is a perspective view of a bottle according to my new design.

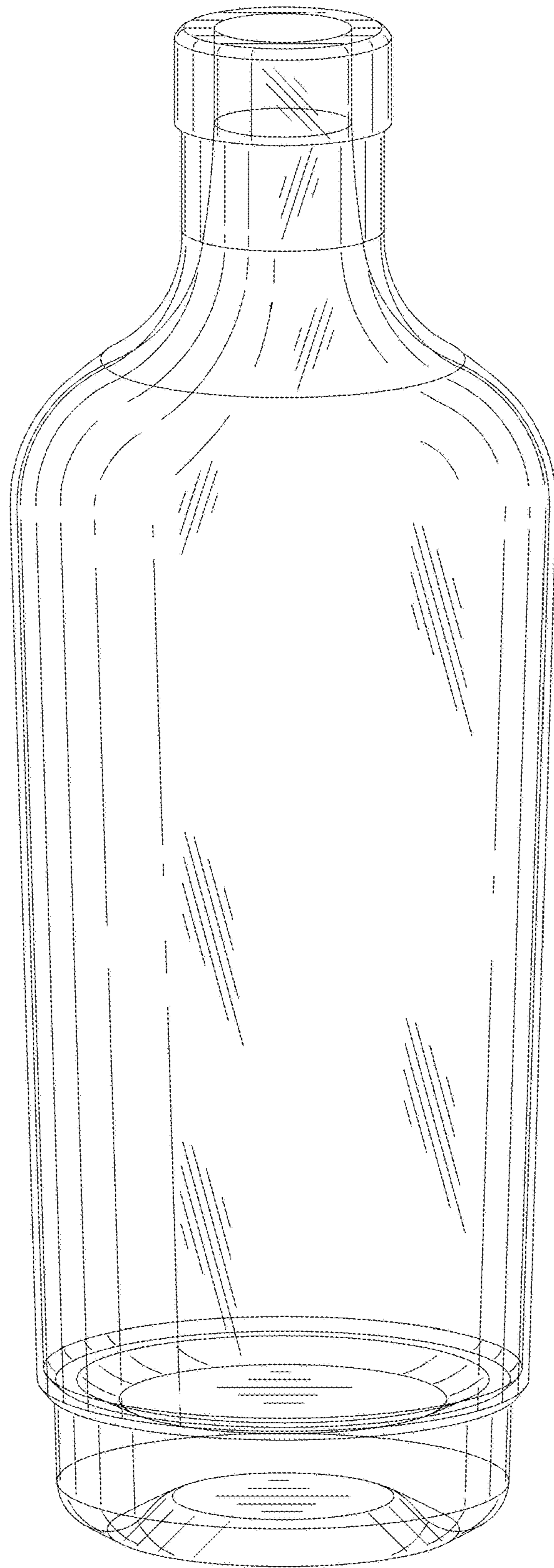

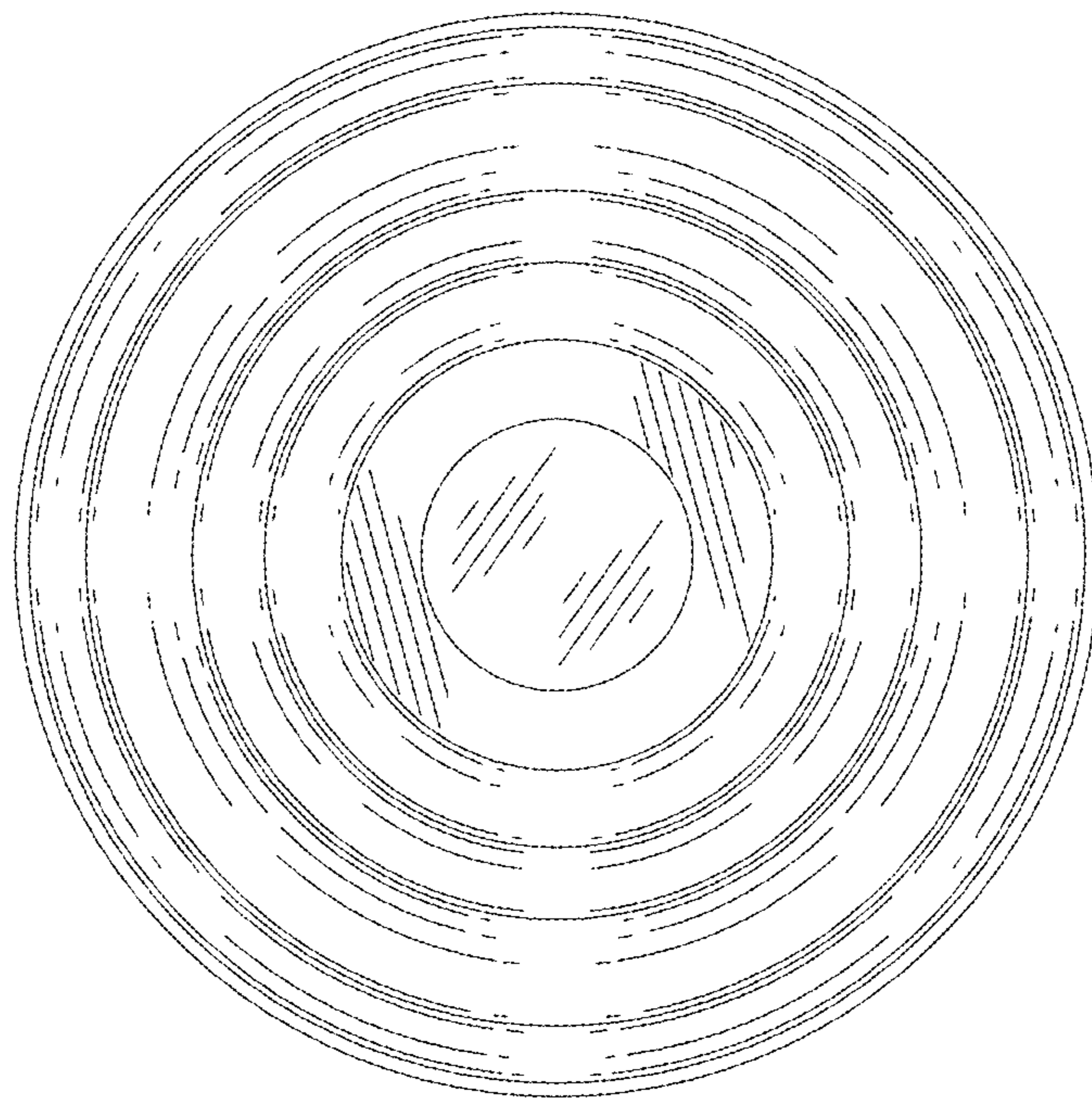

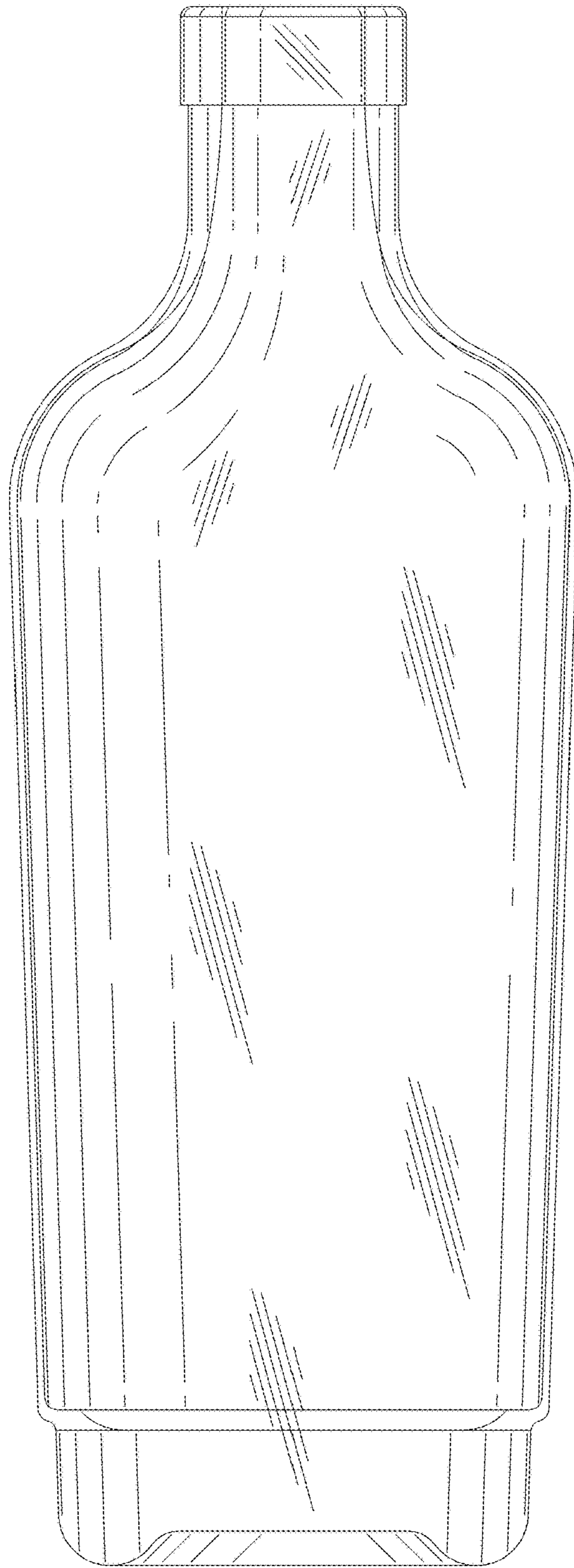

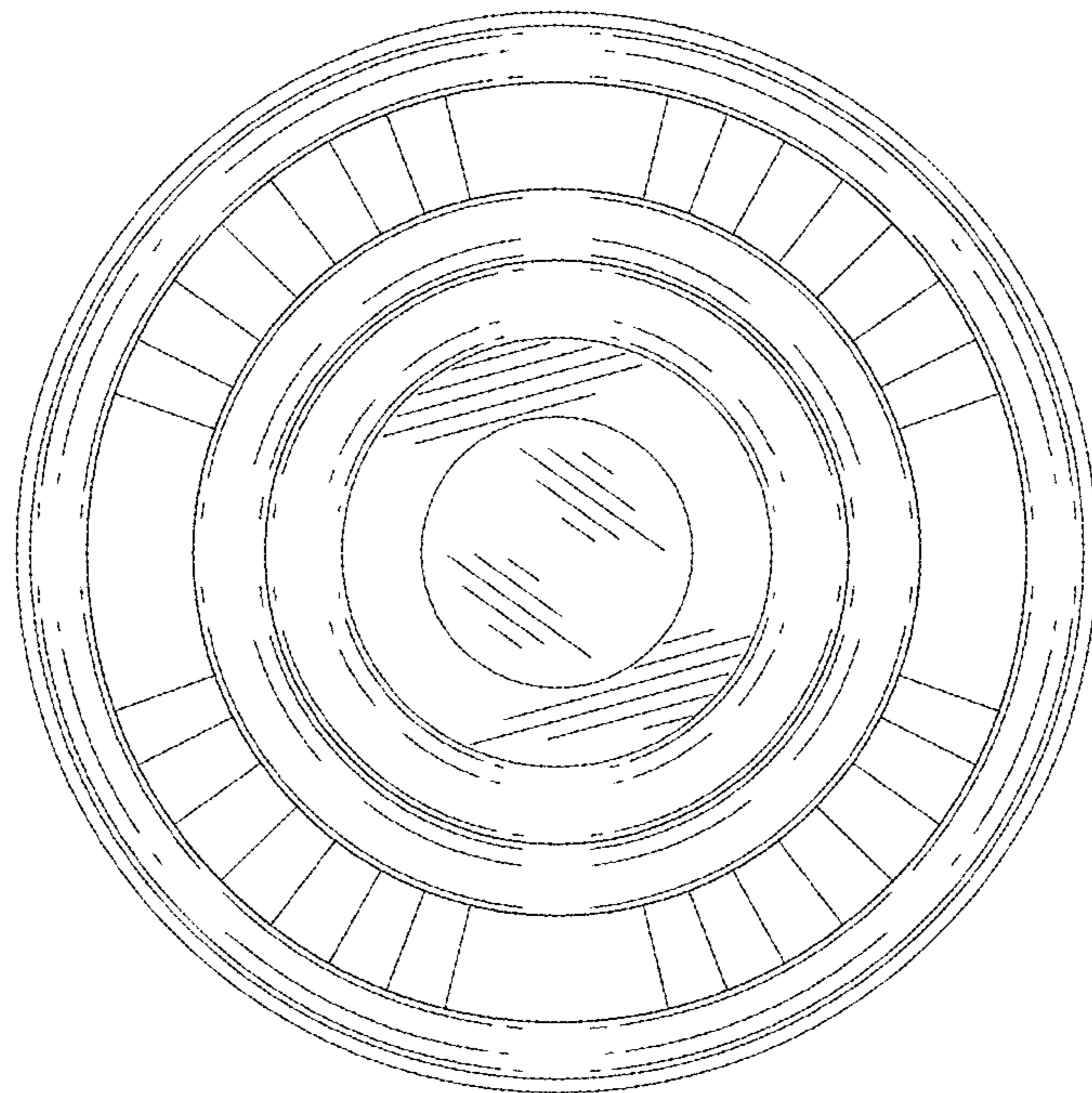
