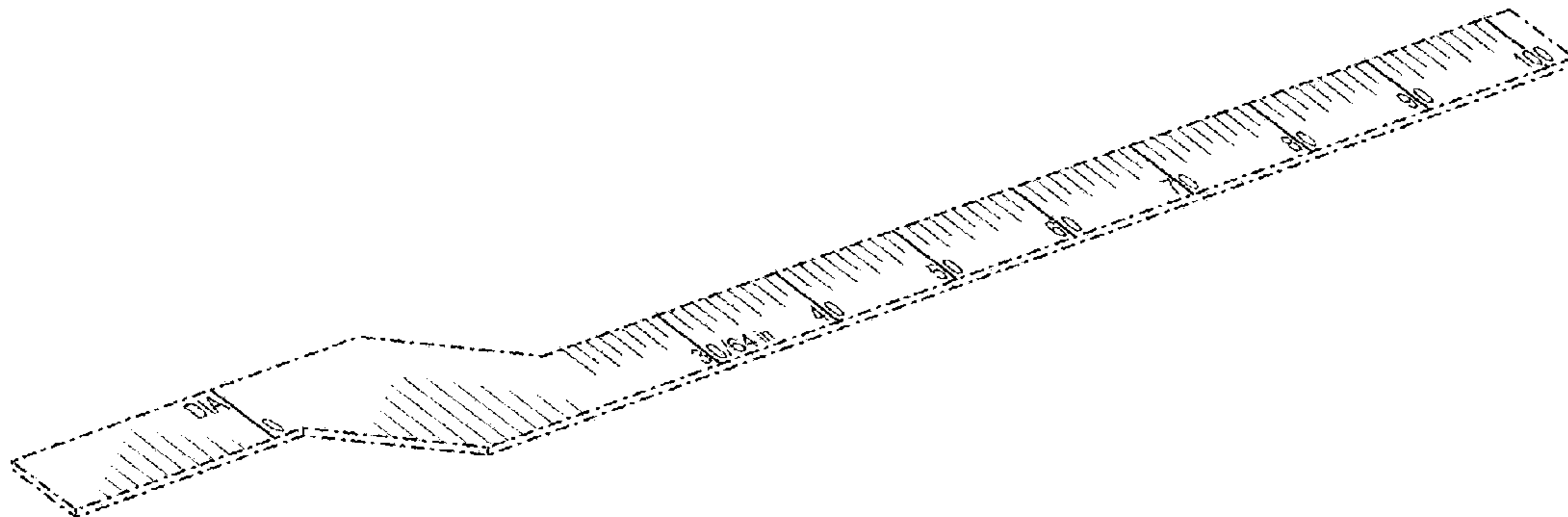

(57) **CLAIM**

I claim the ornamental design for a measuring tape, as shown and described.

FIG. 1 is a perspective view of a measuring tape, showing a first embodiment of my new design as-used to measure the diameter of a cylindrical object;  
FIG. 2 is a perspective view thereof, illustrated in a flat configuration;  
FIG. 3 is a front elevational view of FIG. 2;  
FIG. 4 is a rear elevational view of FIG. 2;  
FIG. 5 is a top plan view of FIG. 2;  
FIG. 6 is a bottom plan view of FIG. 2;  
FIG. 7 is a left-side elevational view of FIG. 2;  
FIG. 8 is a right-side elevational view of FIG. 2;  
FIG. 9 is a perspective view of a second embodiment thereof, illustrated as-used to measure the diameter of the cylindrical object and/or a length of an item;  
FIG. 10 is a perspective view thereof, illustrated in the flat configuration;  
FIG. 11 is a front elevational view of FIG. 10;  
FIG. 12 is a rear elevational view of FIG. 10;  
FIG. 13 is a top plan view of FIG. 10;  
FIG. 14 is a bottom plan view of FIG. 10;  
FIG. 15 is a left-side elevational view of FIG. 10;  
FIG. 16 is a right-side elevational view of FIG. 10;  
FIG. 17 is a perspective view of a third embodiment thereof, illustrated as-used to measure the diameter of the cylindrical object and/or a length of the item;  
FIG. 18 is a perspective view thereof, illustrated in the flat configuration;  
FIG. 19 is a front elevational view of FIG. 18;  
FIG. 20 is a rear elevational view of FIG. 18;  
FIG. 21 is a top plan view of FIG. 18;  
FIG. 22 is a bottom plan view of FIG. 18;  
FIG. 23 is a left-side elevational view of FIG. 18; and,  
FIG. 24 is a right-side elevational view of FIG. 18.  
The broken lines showing a cylinder in FIGS. 1, 9, and 17 and an item in FIGS. 9 and 17 depict environmental matter and form no part of the claimed design. The dot-dash broken line represents a border of the claimed design.

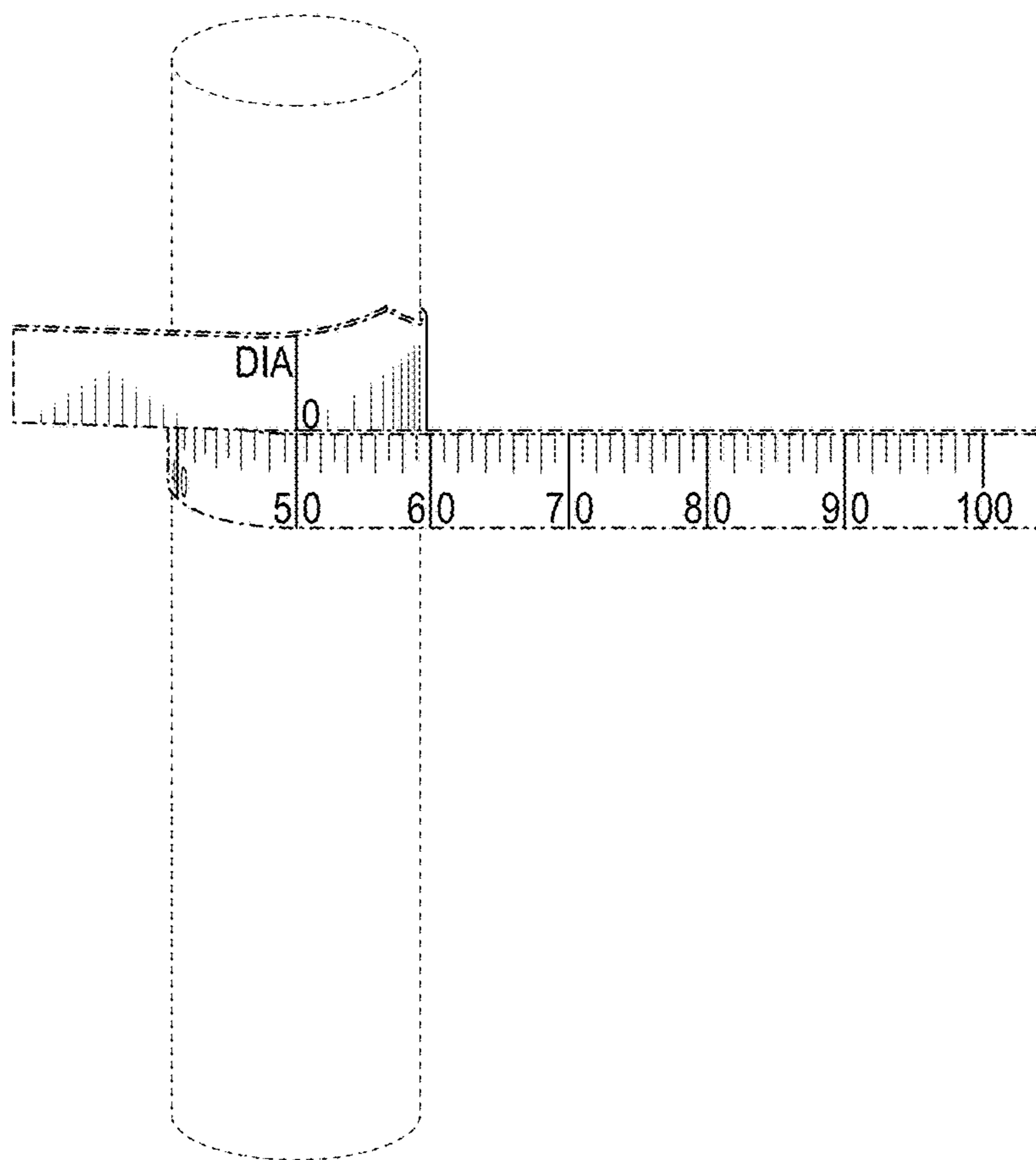

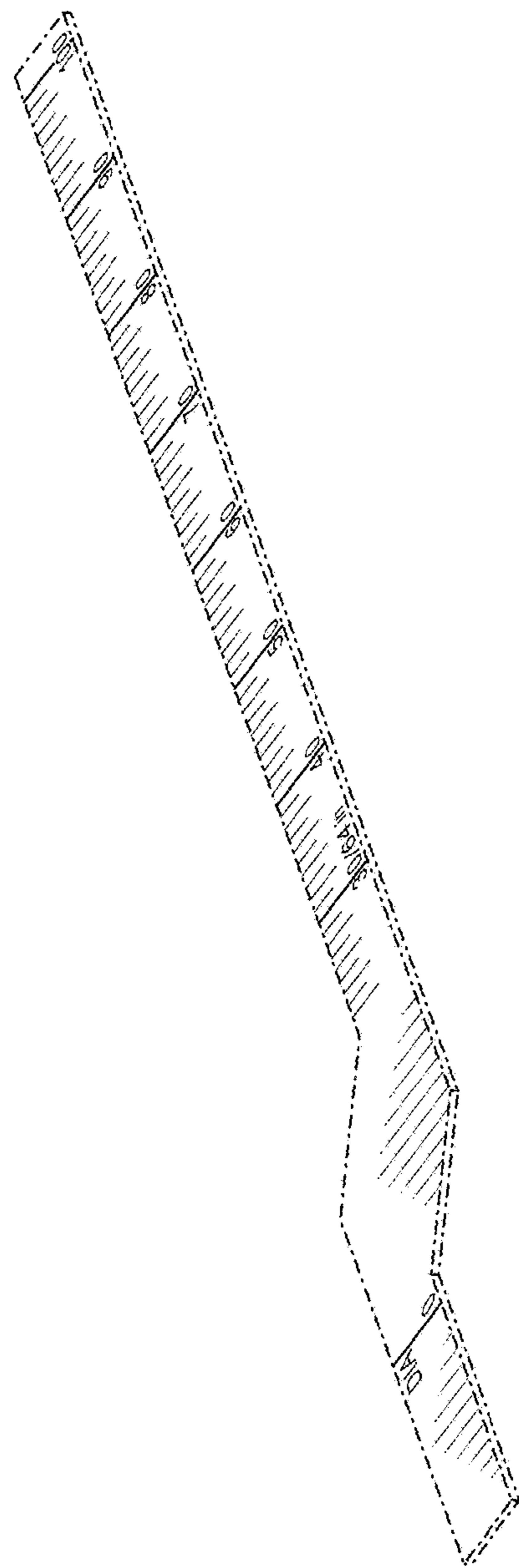

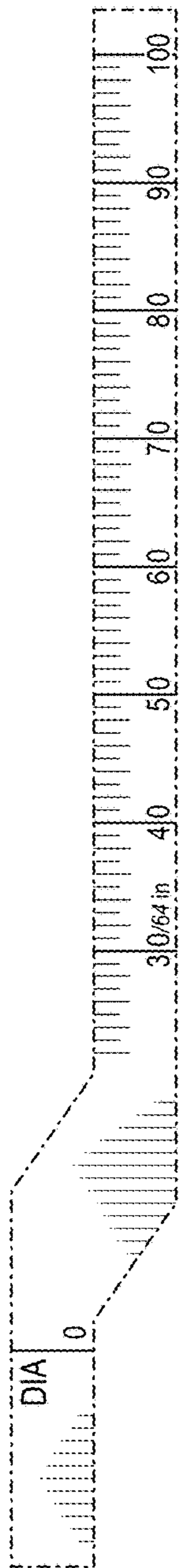

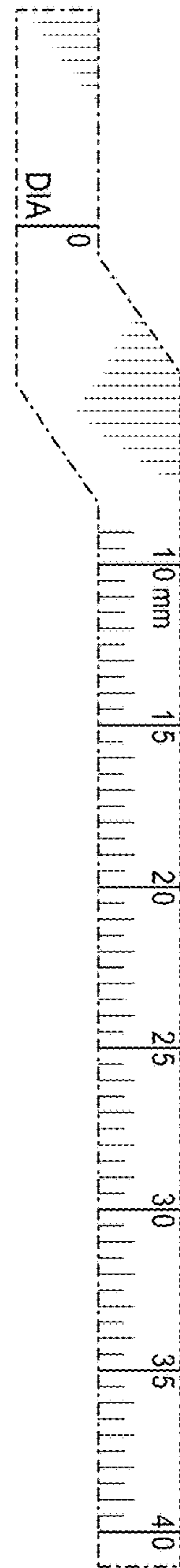

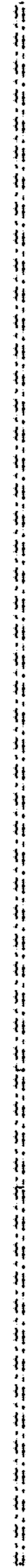

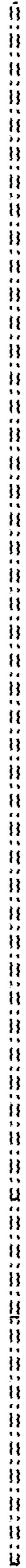

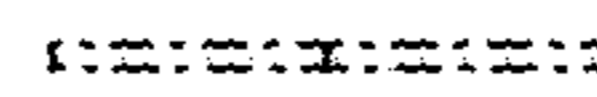

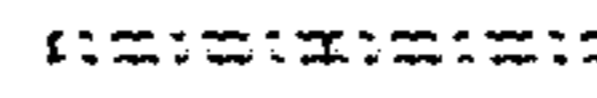

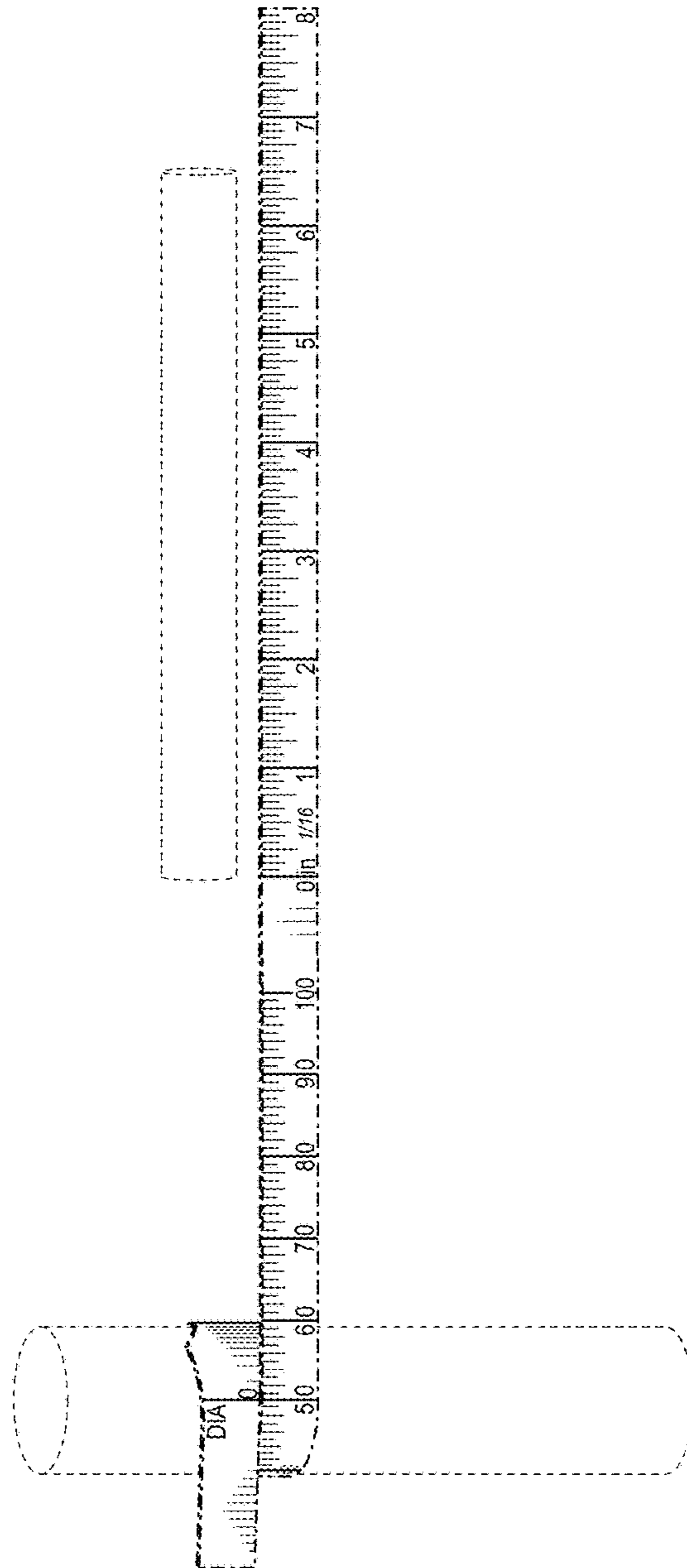

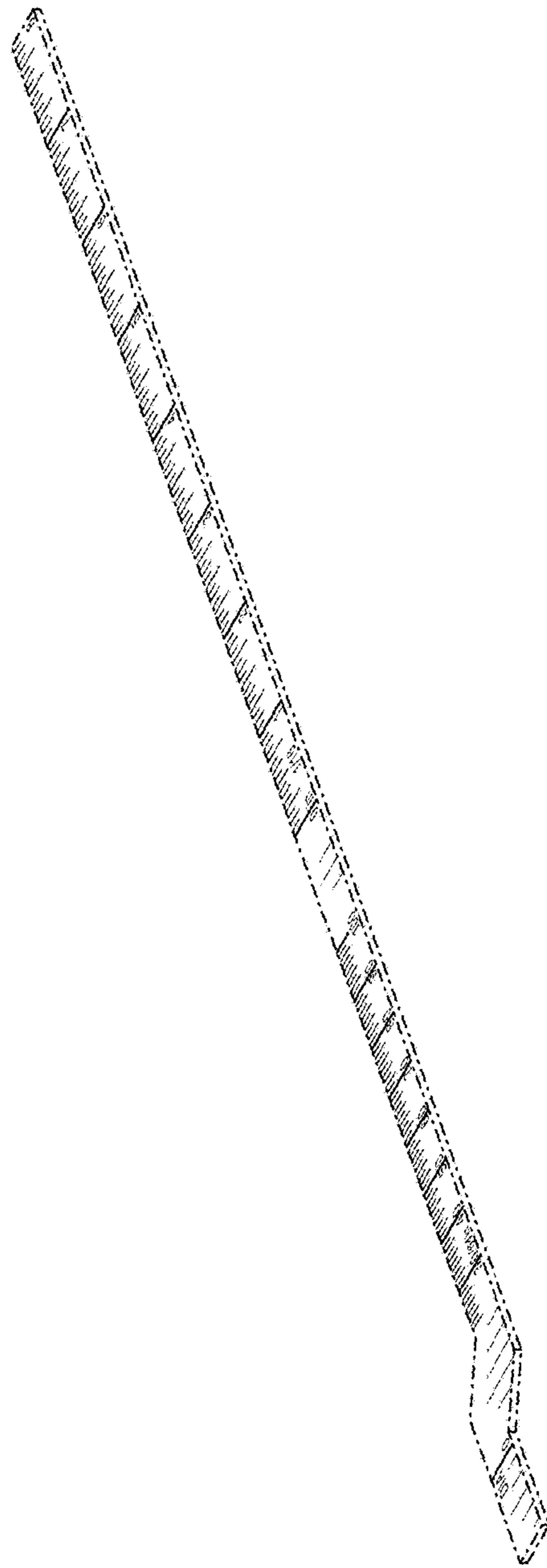

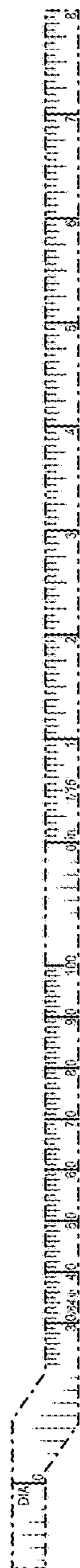

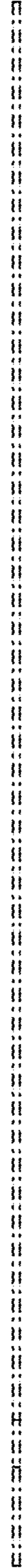

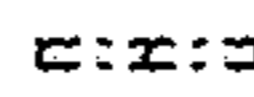

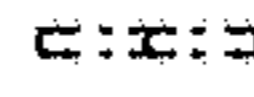

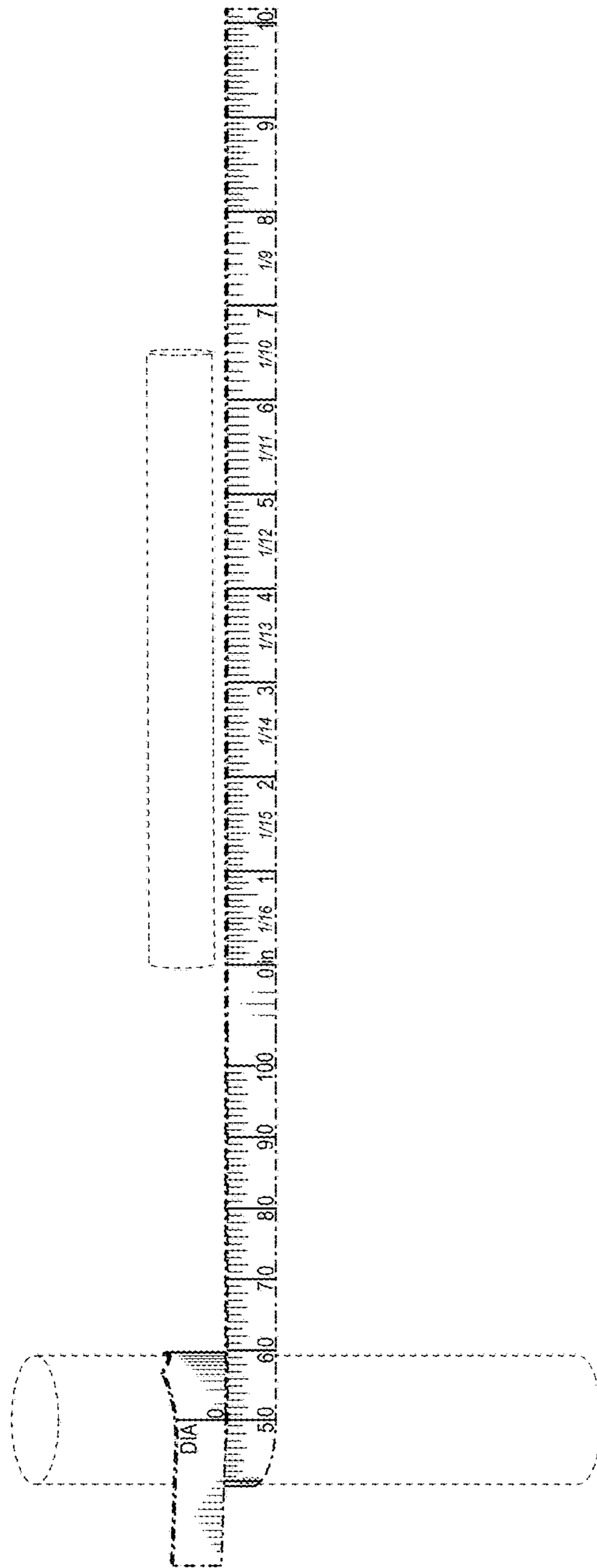

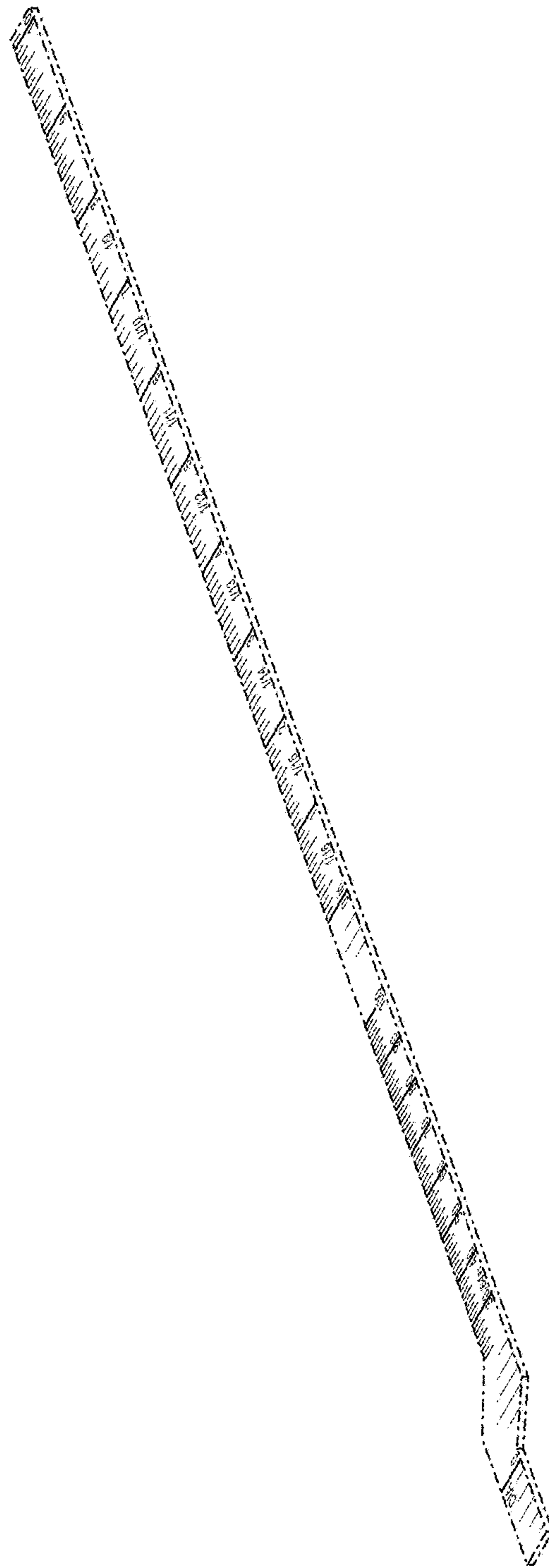

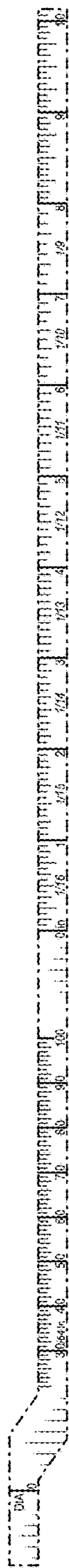

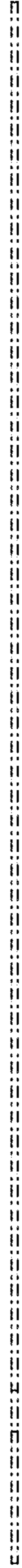

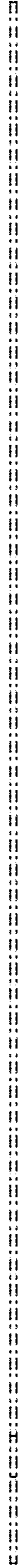

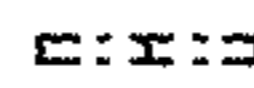

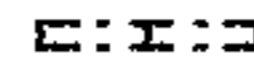
