The ornamental design for a bracelet, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left-side, top perspective view of the bracelet;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a top plan view thereof;  
FIG. 4 is a left-side elevational view thereof;  
FIG. 5 is a right-side elevational view thereof;  
FIG. 6 is a rear view thereof;  
FIG. 7 is a bottom plan view thereof; and,  
FIG. 8 is a rear, left-side, bottom view thereof.

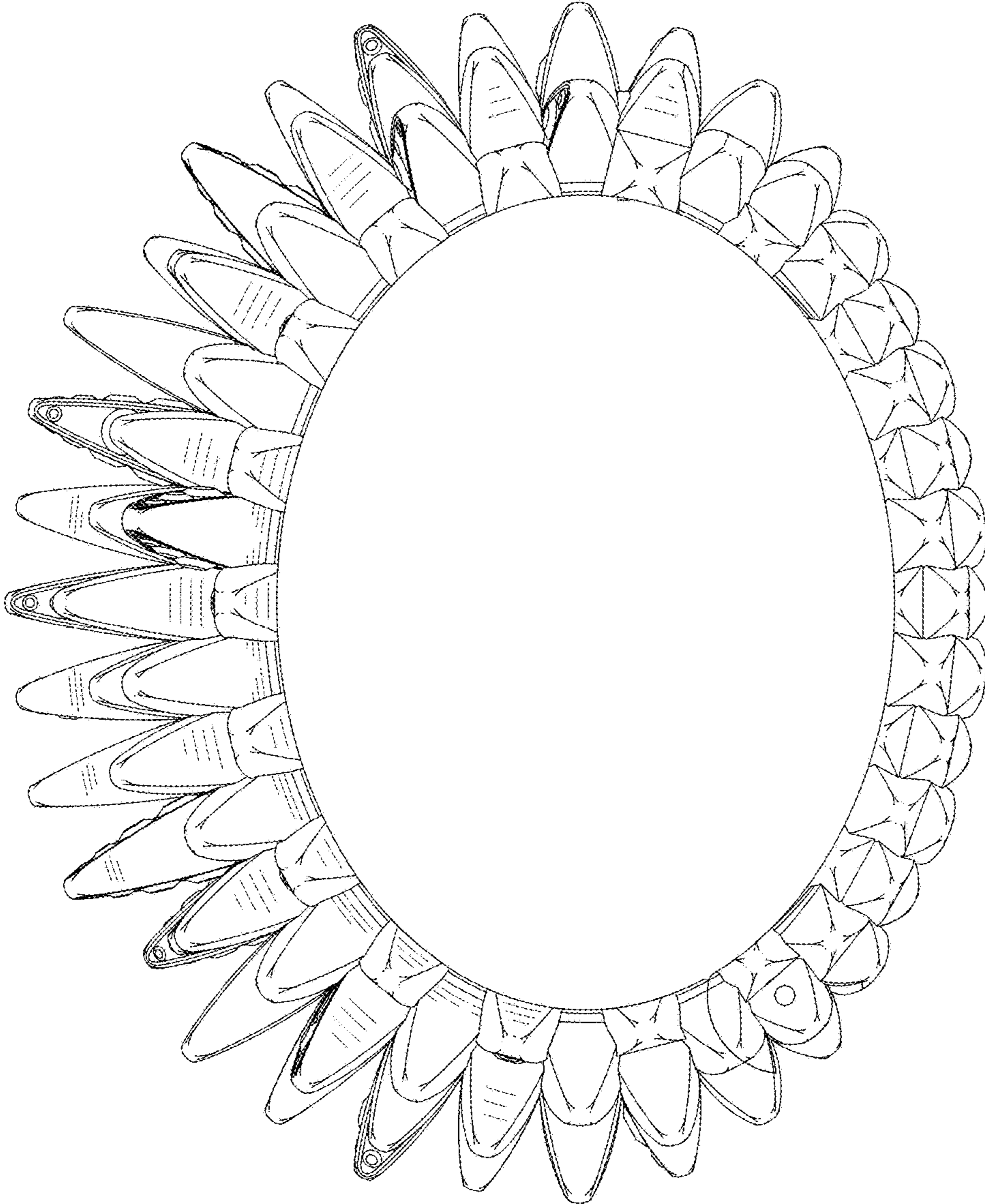

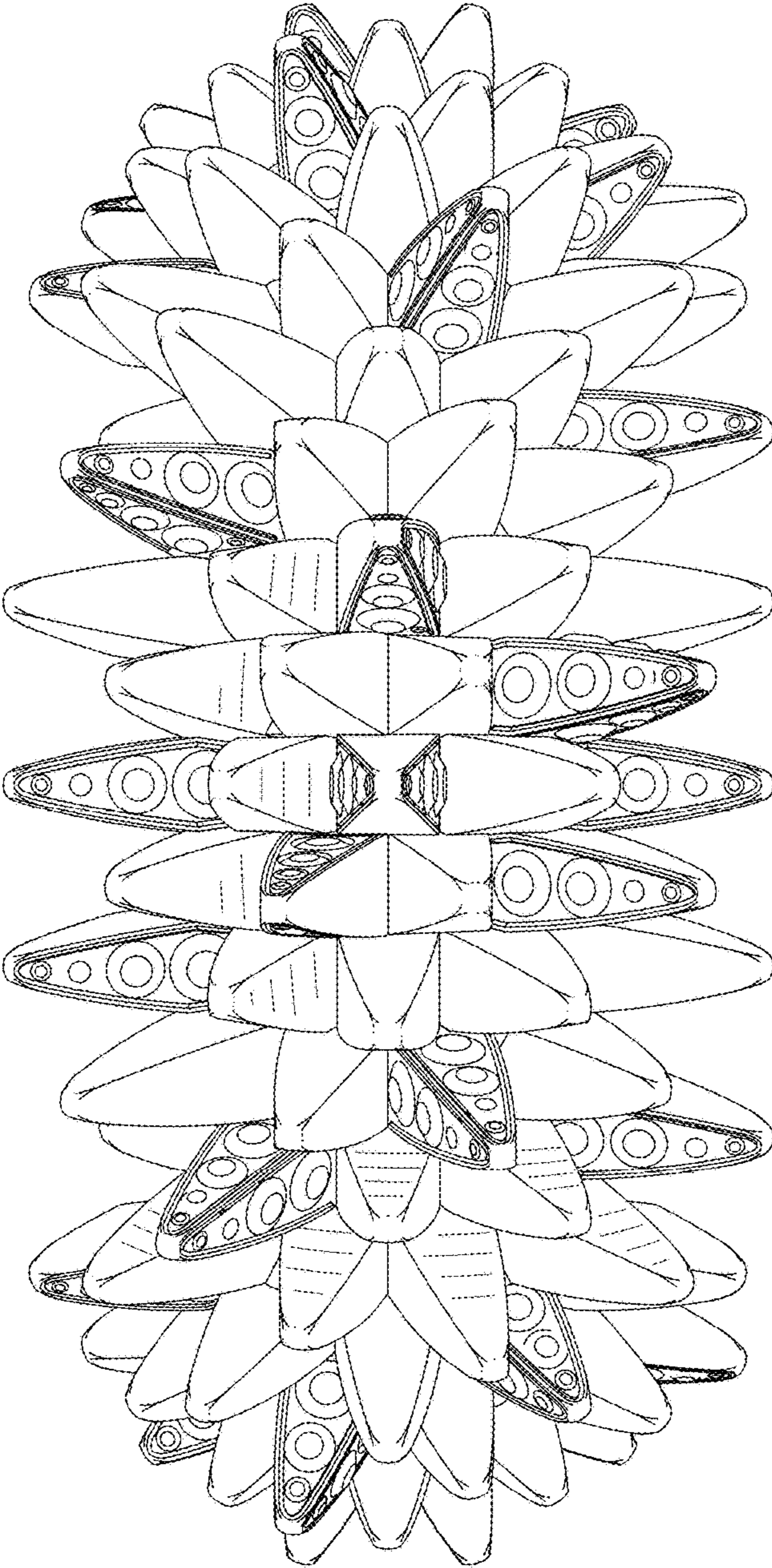

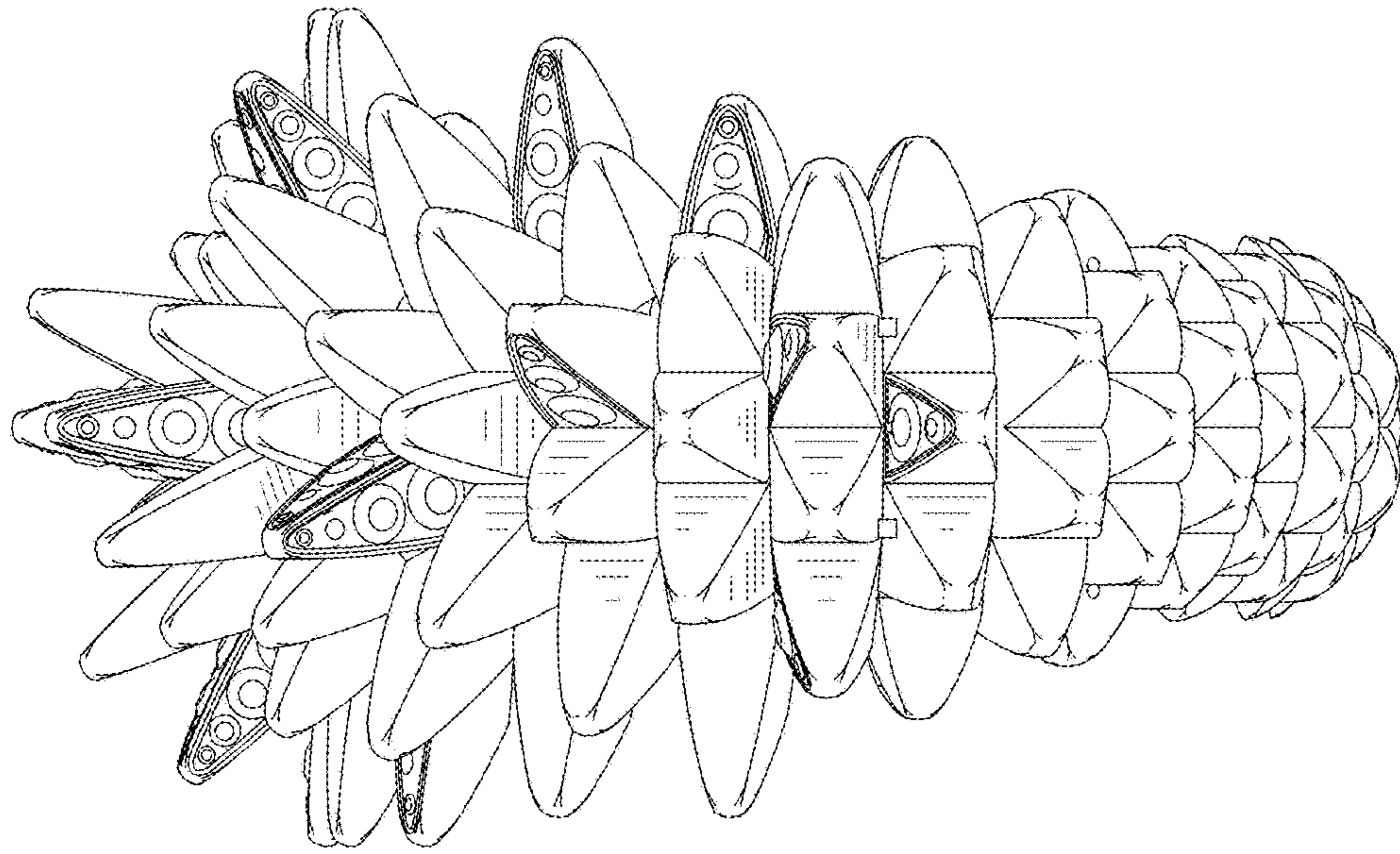

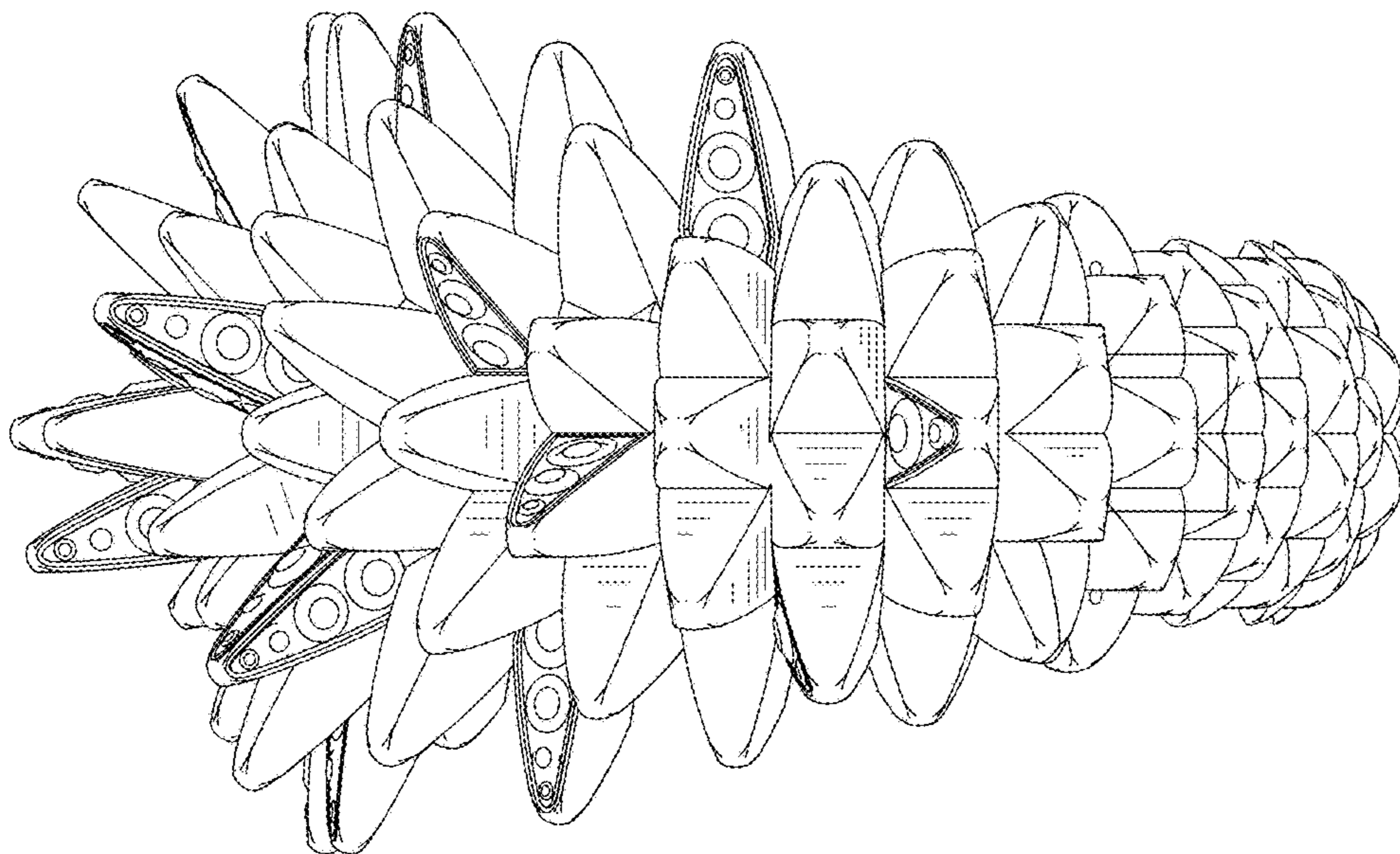

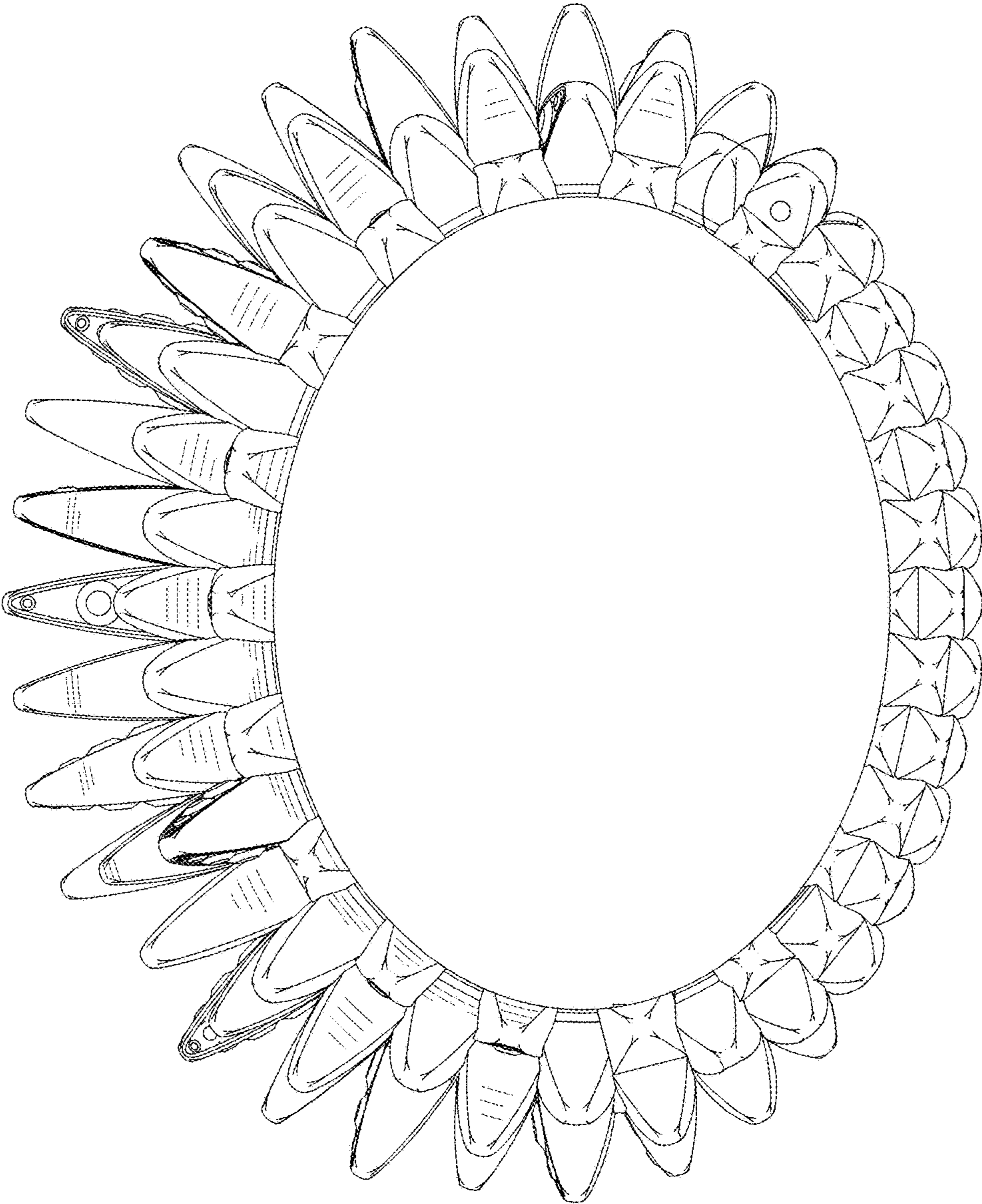

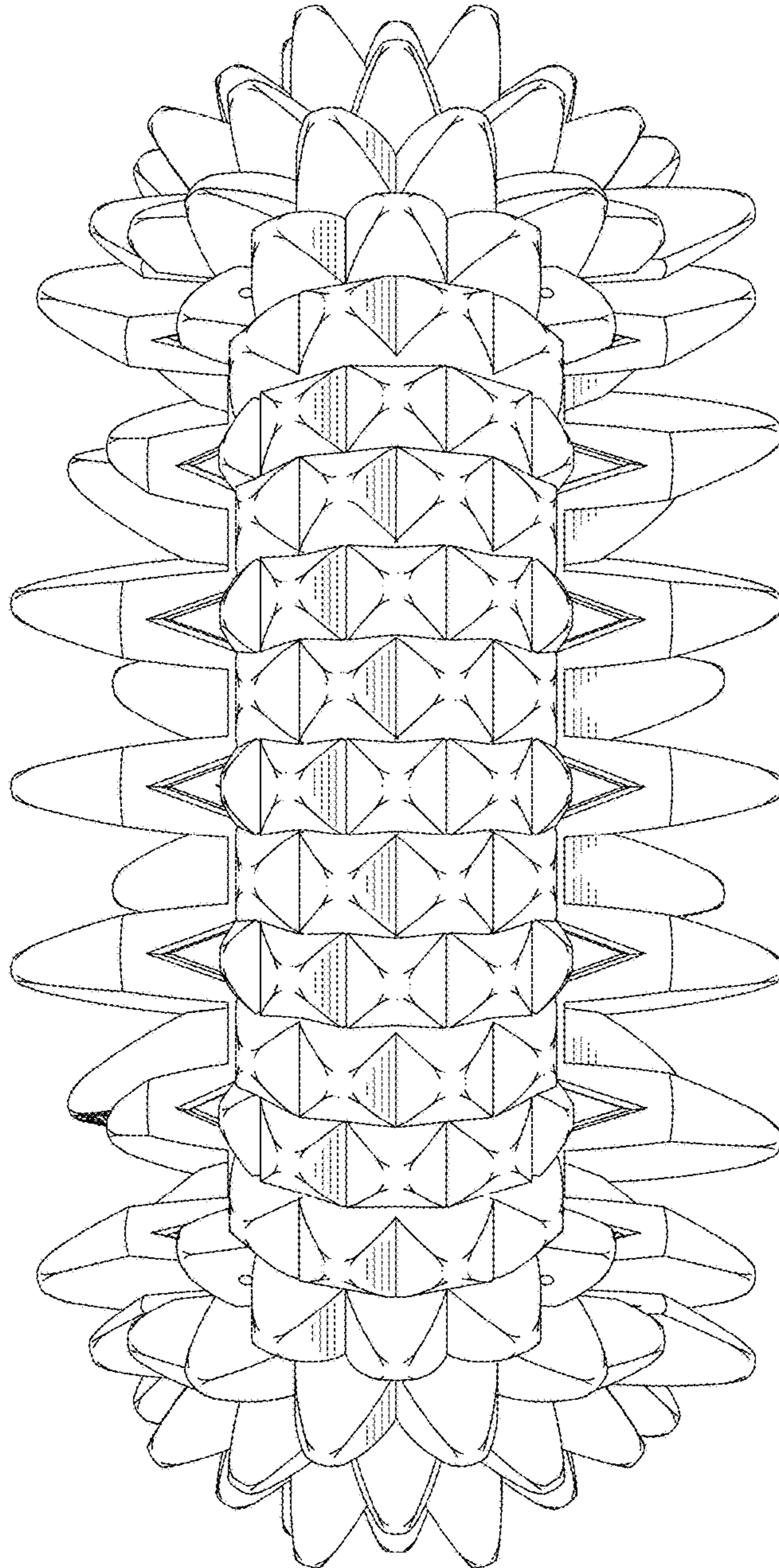

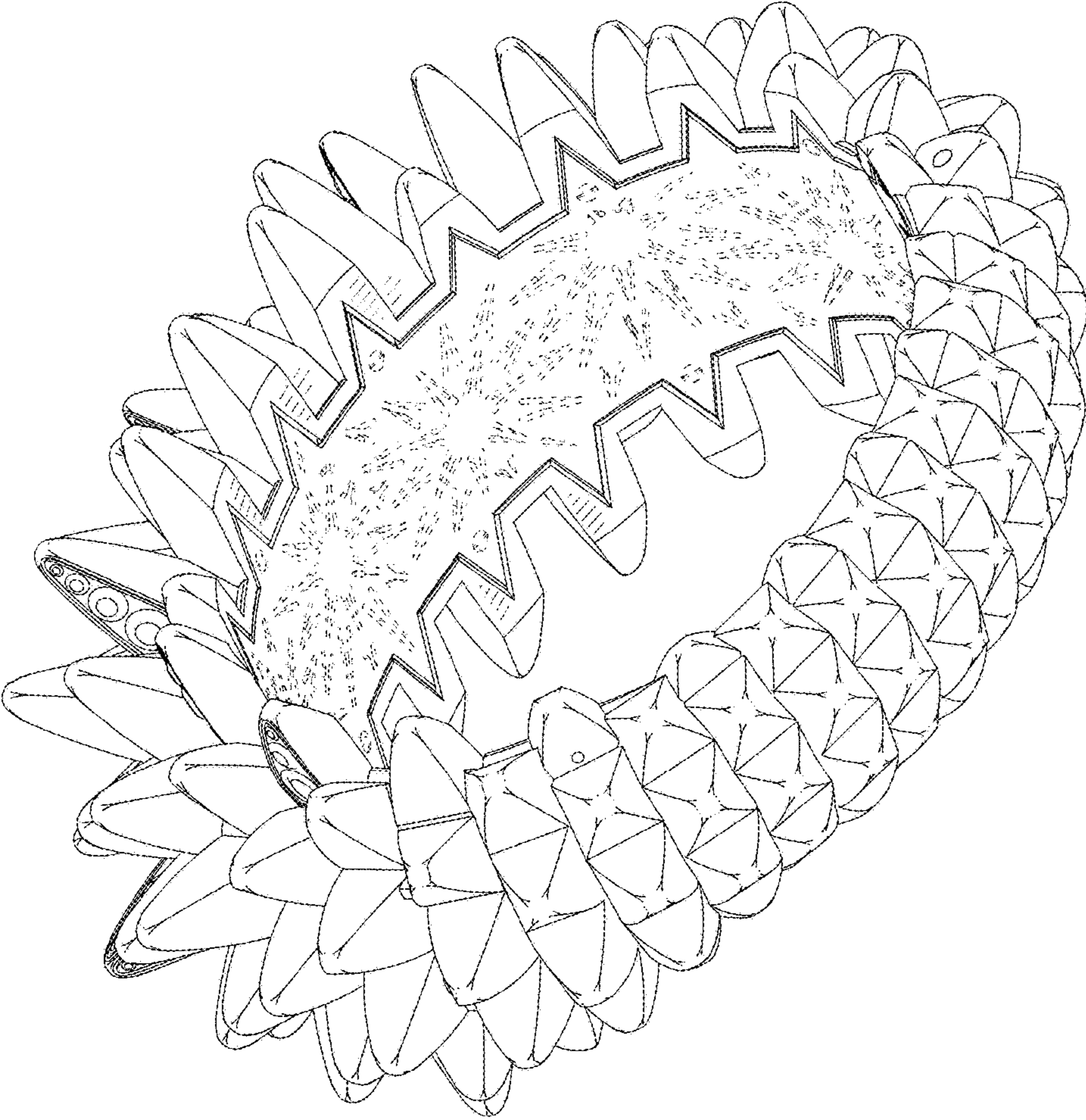
