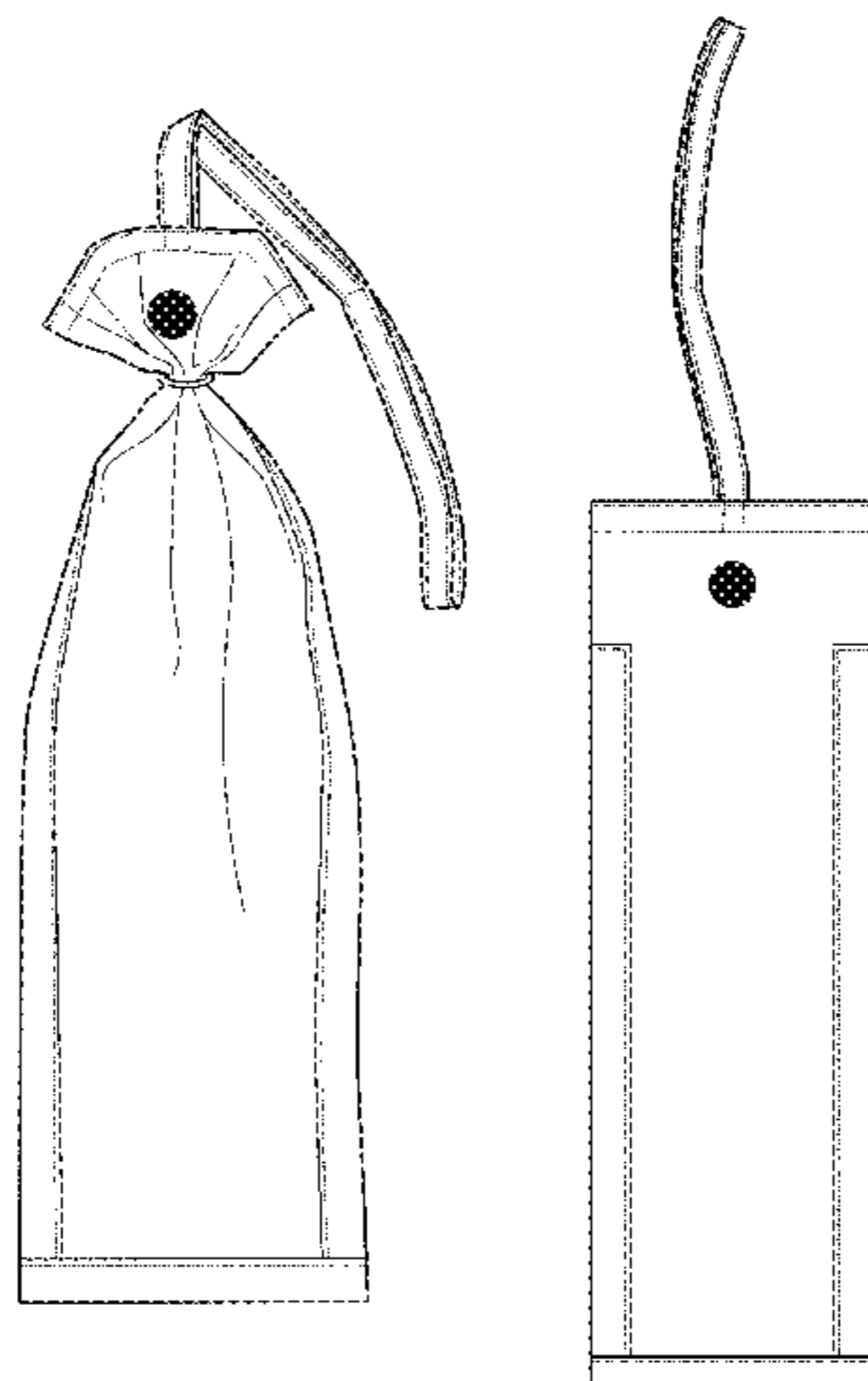
(57) **CLAIM**

The ornamental design for a roadside hazard flag, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a roadside hazard flag in an assembled configuration showing my new design;  
FIG. 2 is a back view thereof;  
FIG. 3 is a right side perspective view thereof;  
FIG. 4 is a left side perspective view thereof;  
FIG. 5 is a front view of the roadside hazard flag laid flat; and,  
FIG. 6 is a back view of the roadside hazard flag laid flat. The broken lines in the drawings depict stitching that form a part of the claimed design.

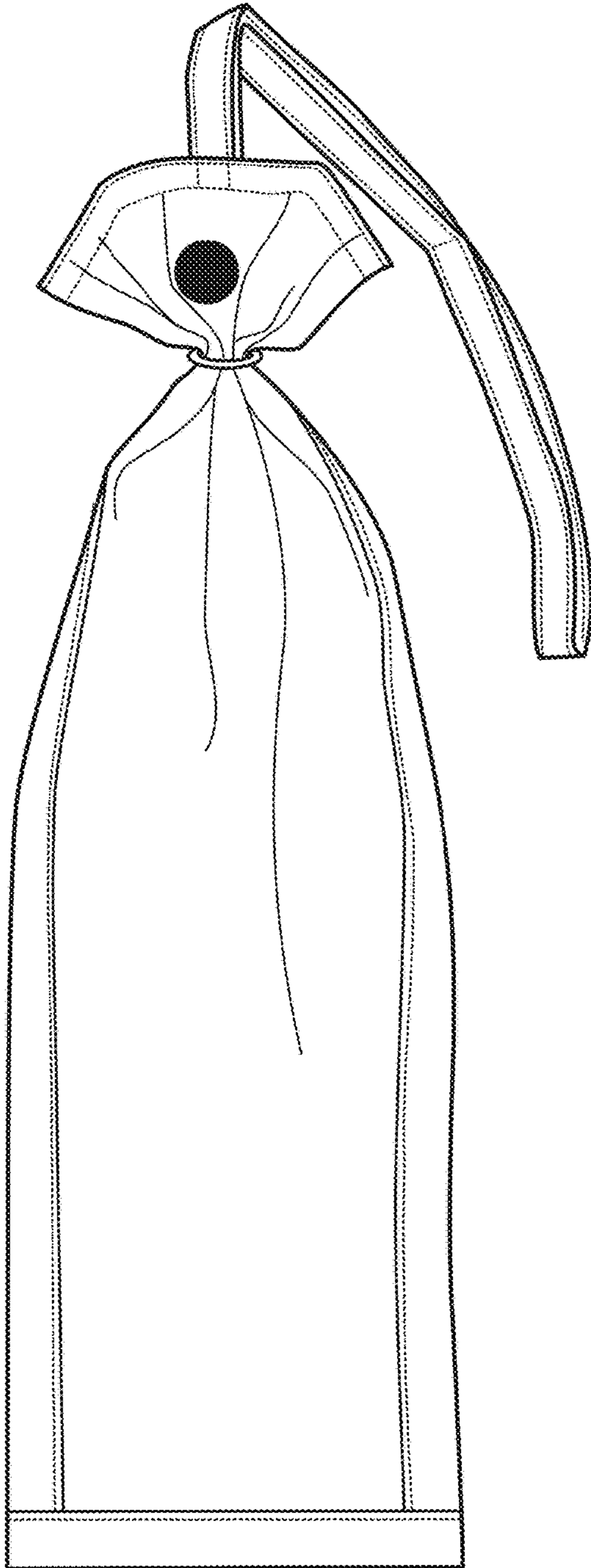

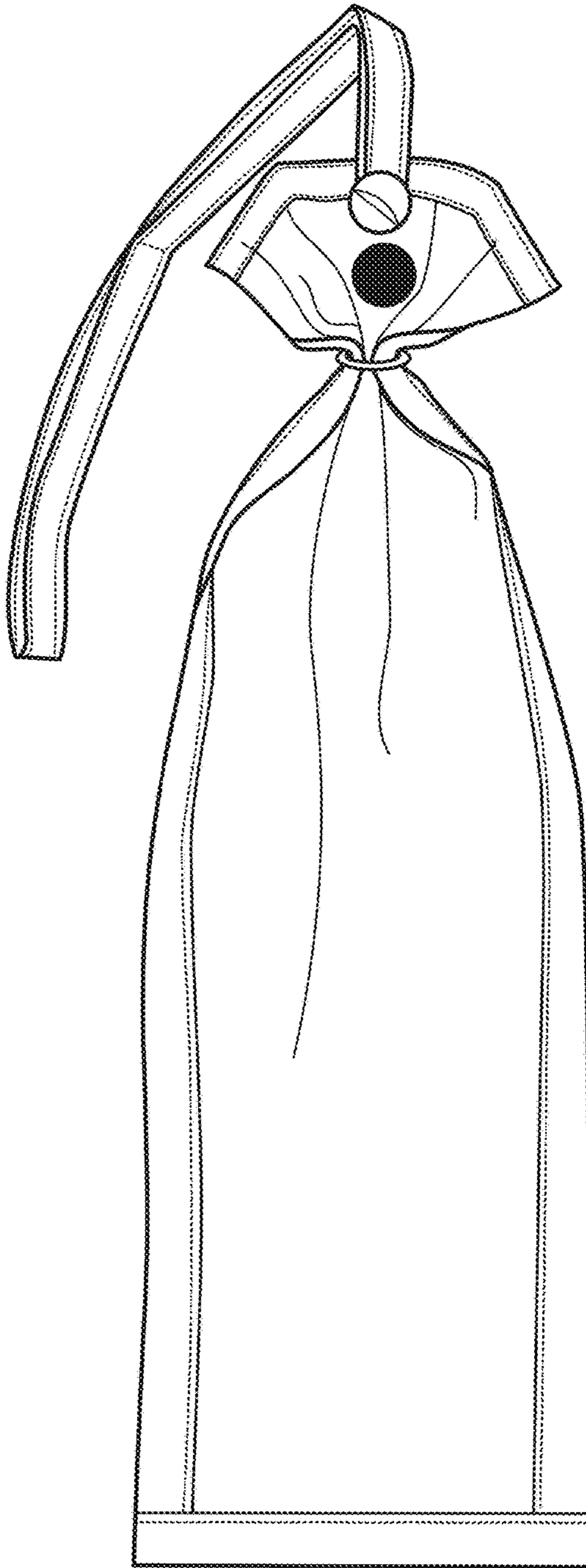

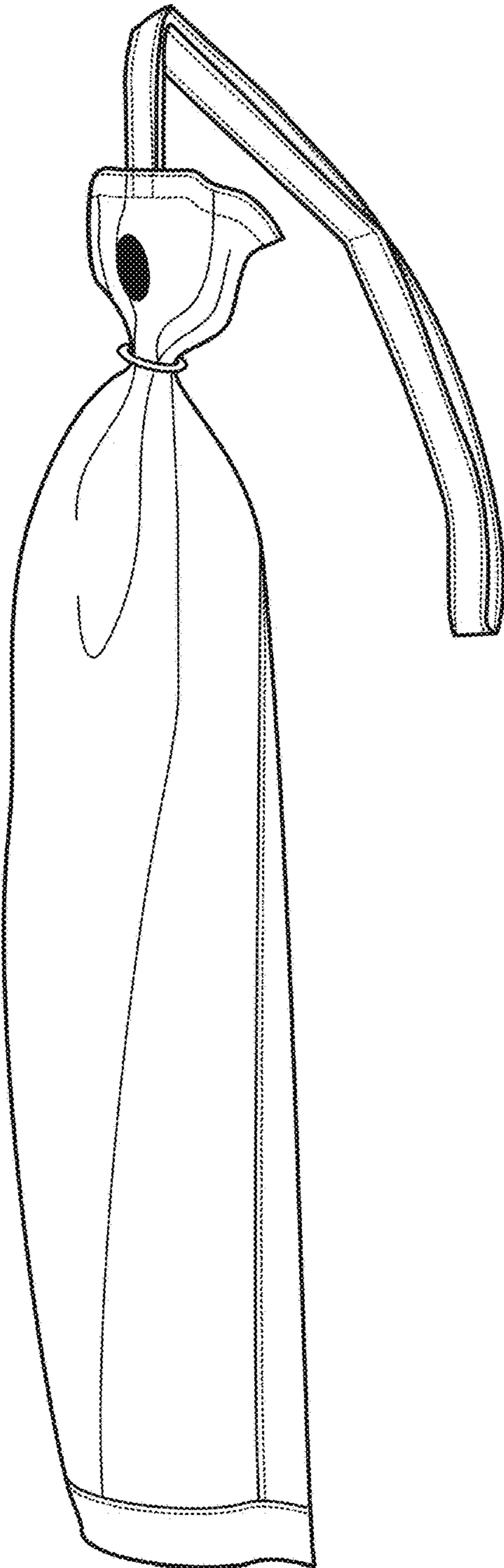
