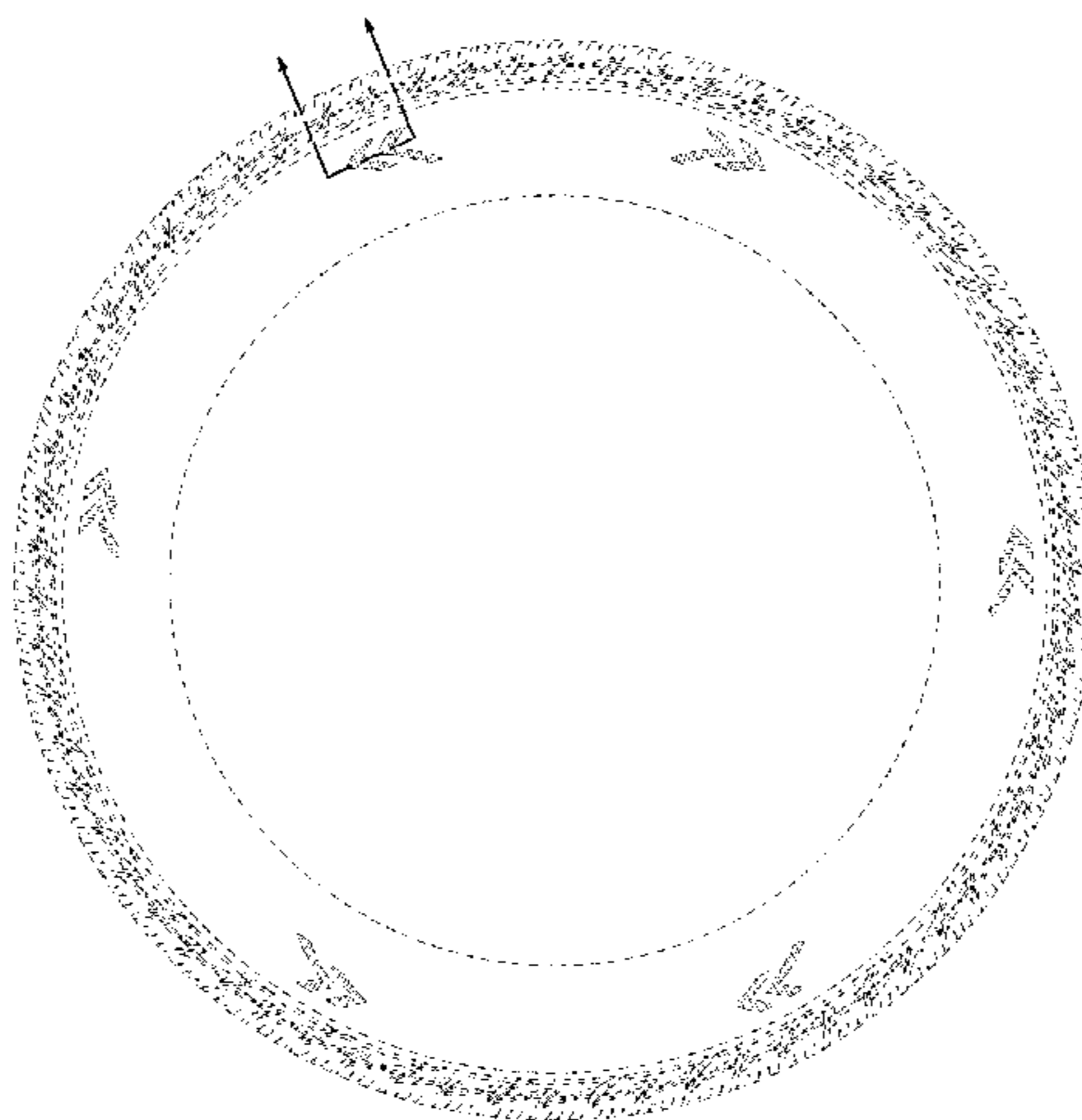
(57) **CLAIM**

The ornamental Design for a tire sidewall, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a tire sidewall showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a cross-sectional view taken in the direction of line 3-3 of FIG. 2; and,
FIG. 4 is a front elevational view of a second embodiment thereof showing the disclaimed portions of FIG. 1 in solid lines.
In the drawings, the broken lines showing of the tire tread, inner bead and the peripheral boundary between the tire tread and the sidewall in FIGS. 1 through 3 depict environmental subject matter and form no part of the claimed design.

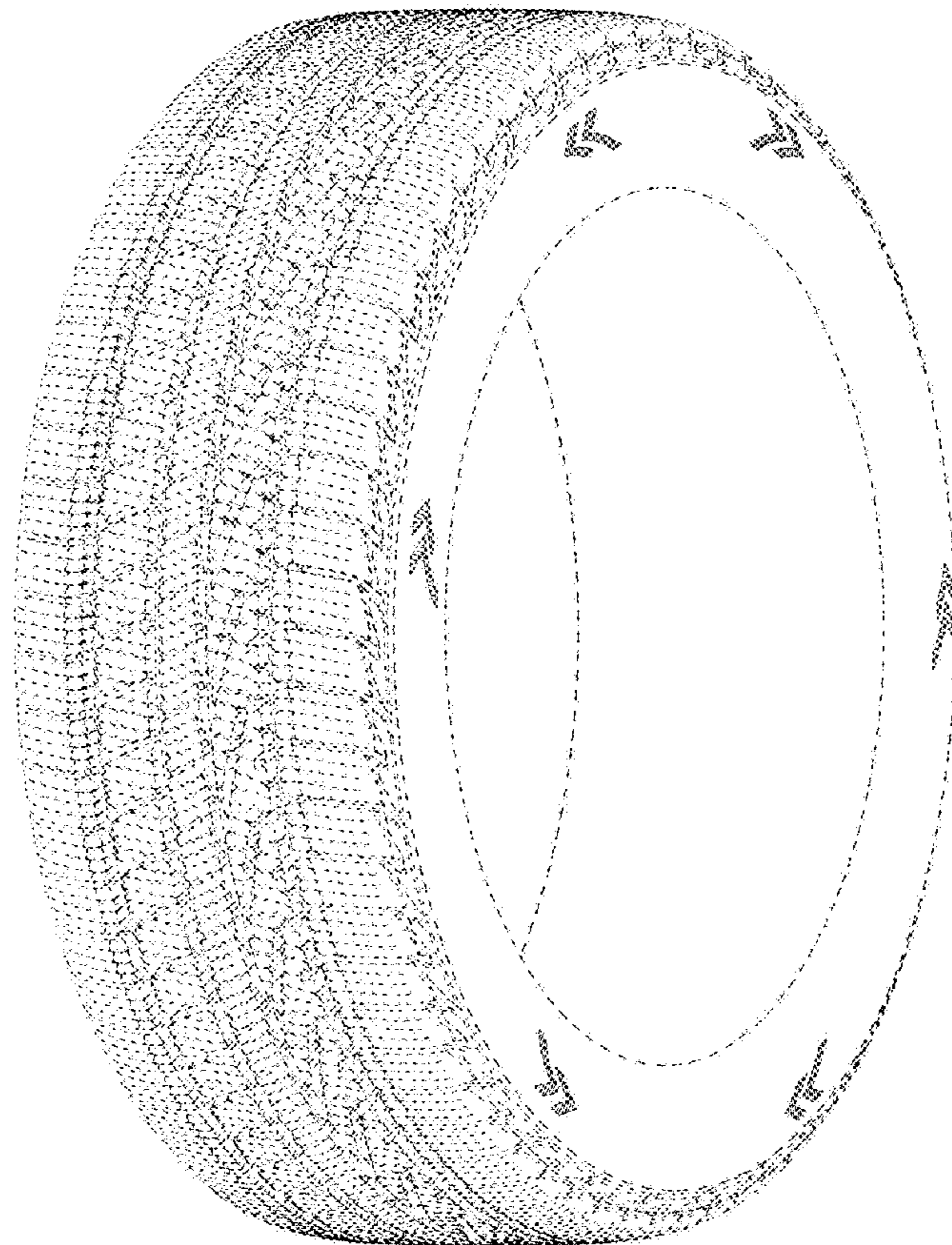

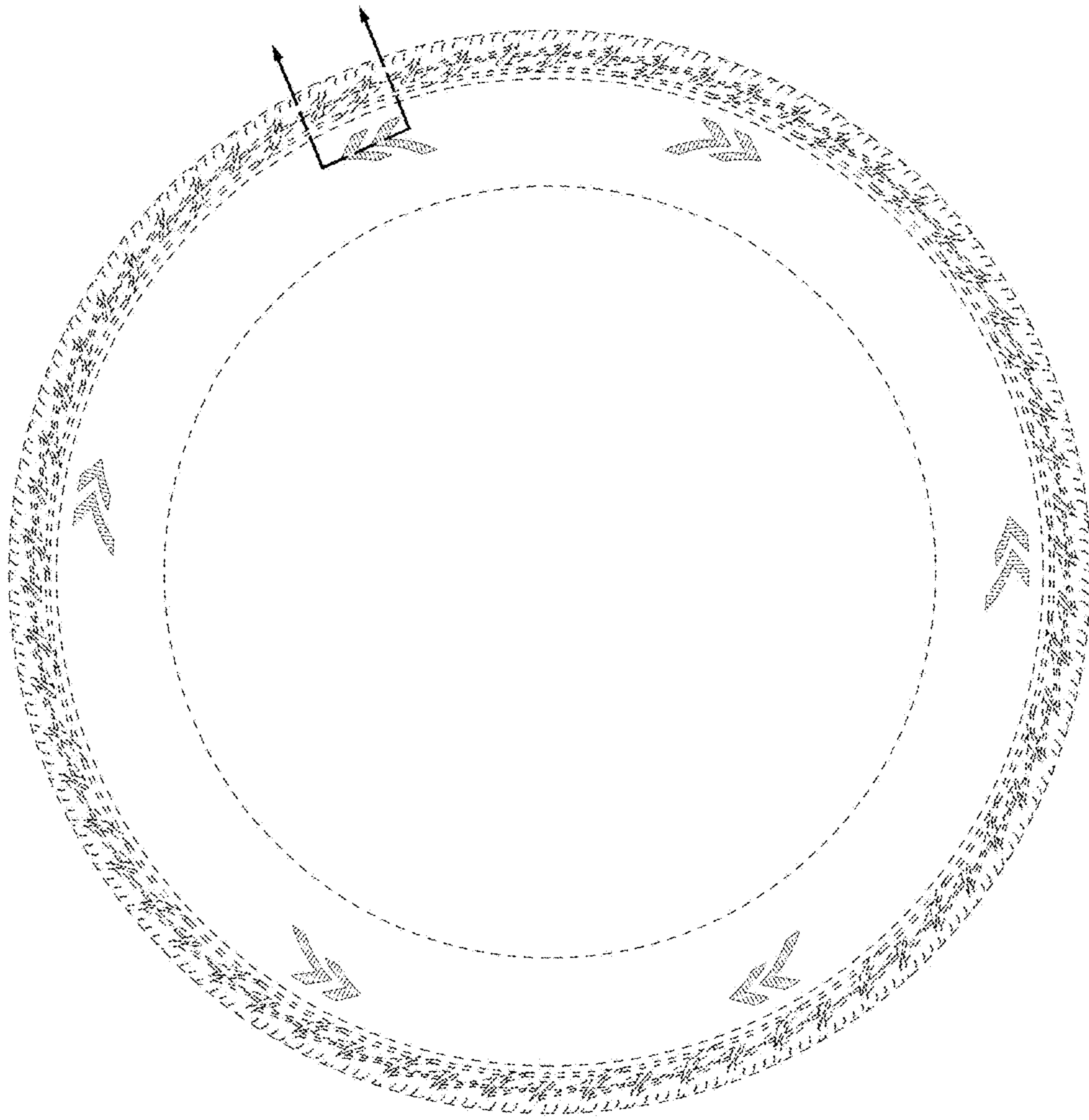

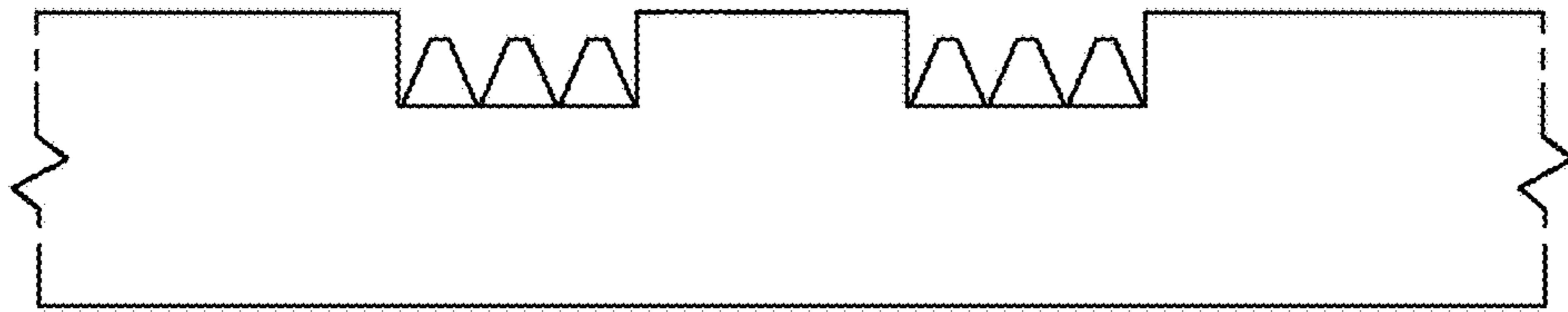
