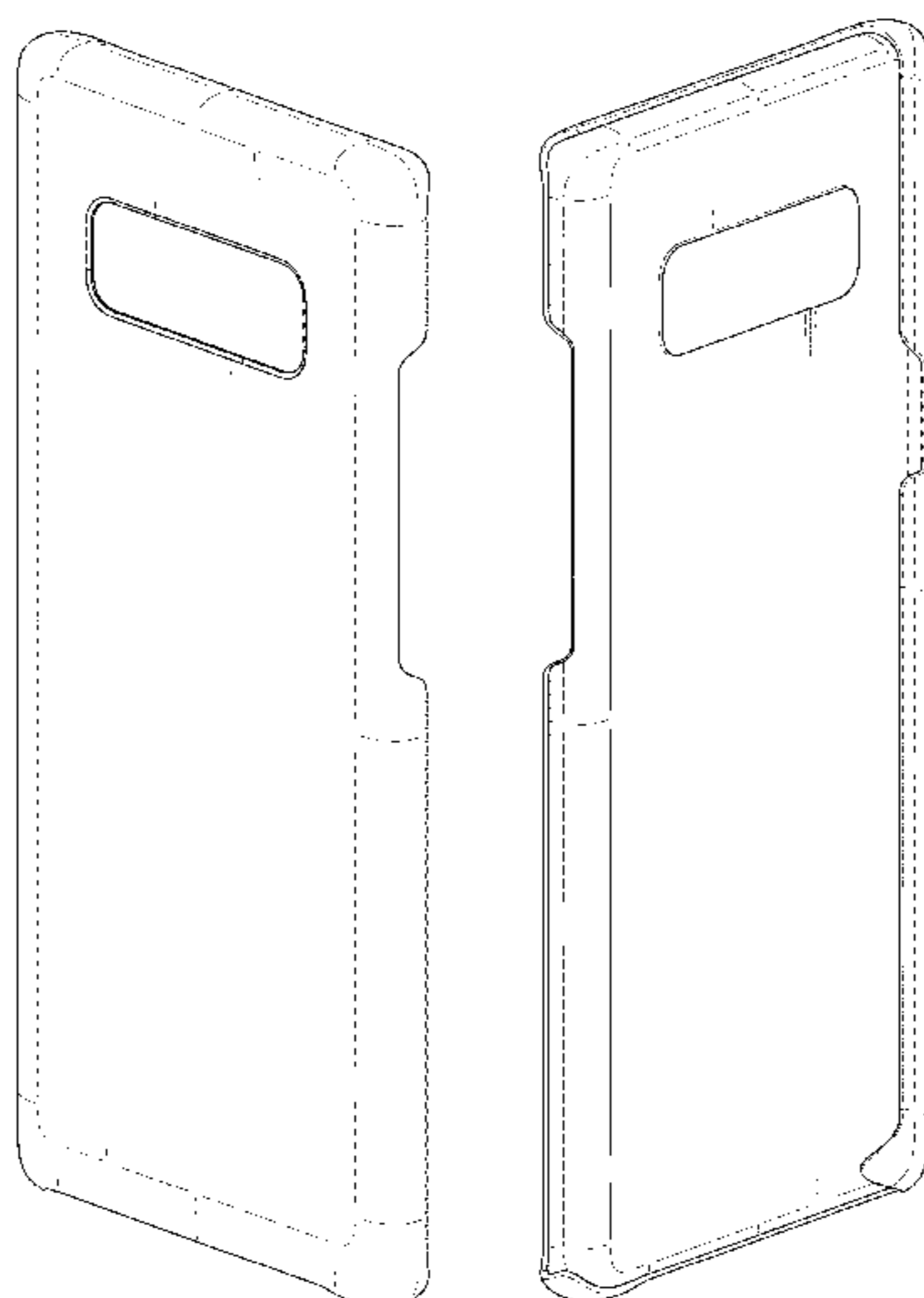
(57) **CLAIM**

The ornamental design for a cover for mobile phone, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a cover for mobile phone showing our new design;

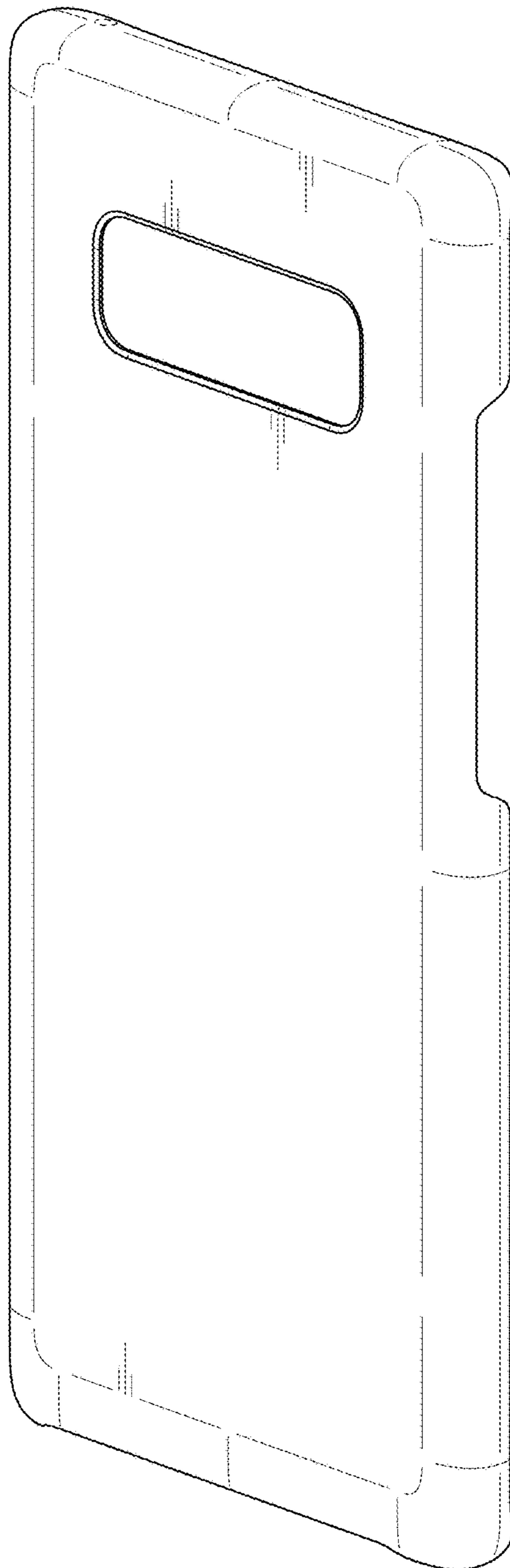

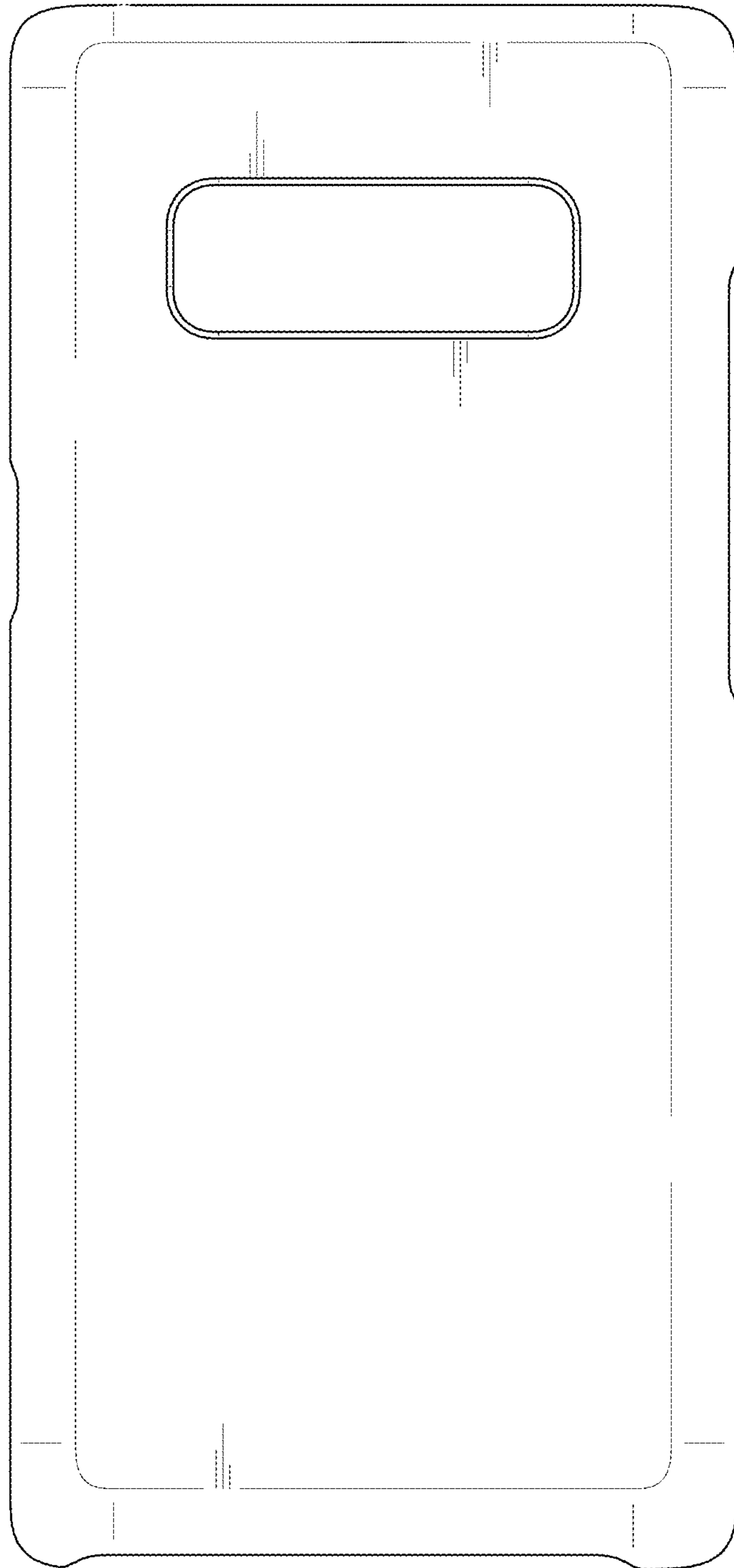

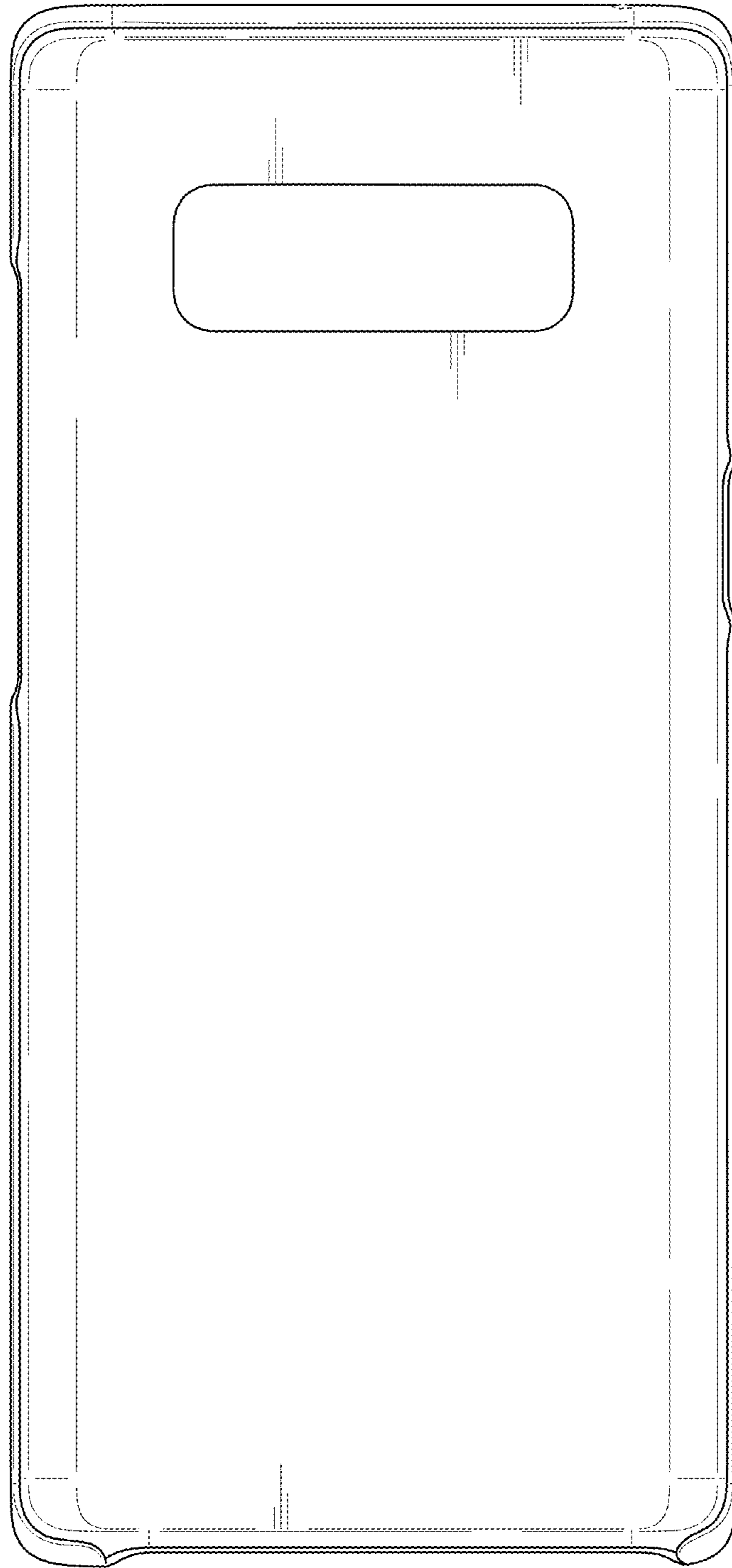

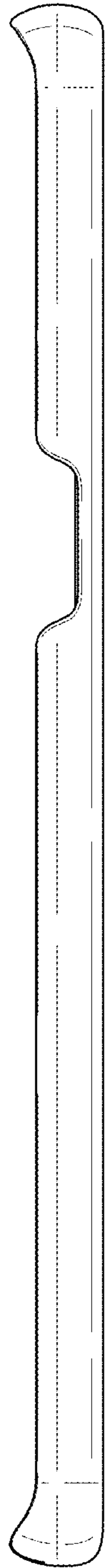

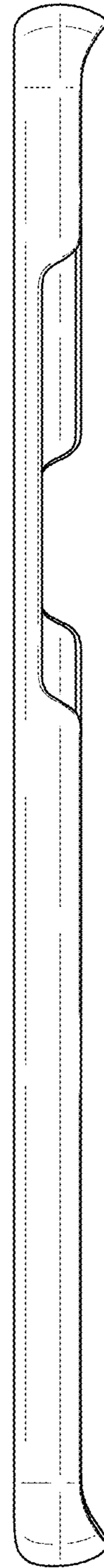

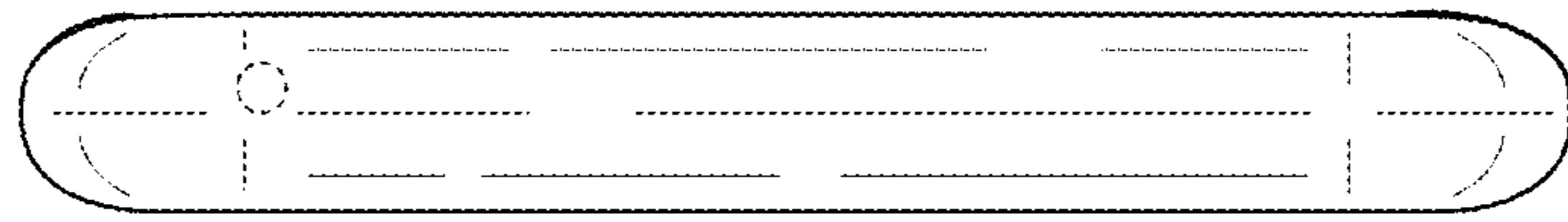

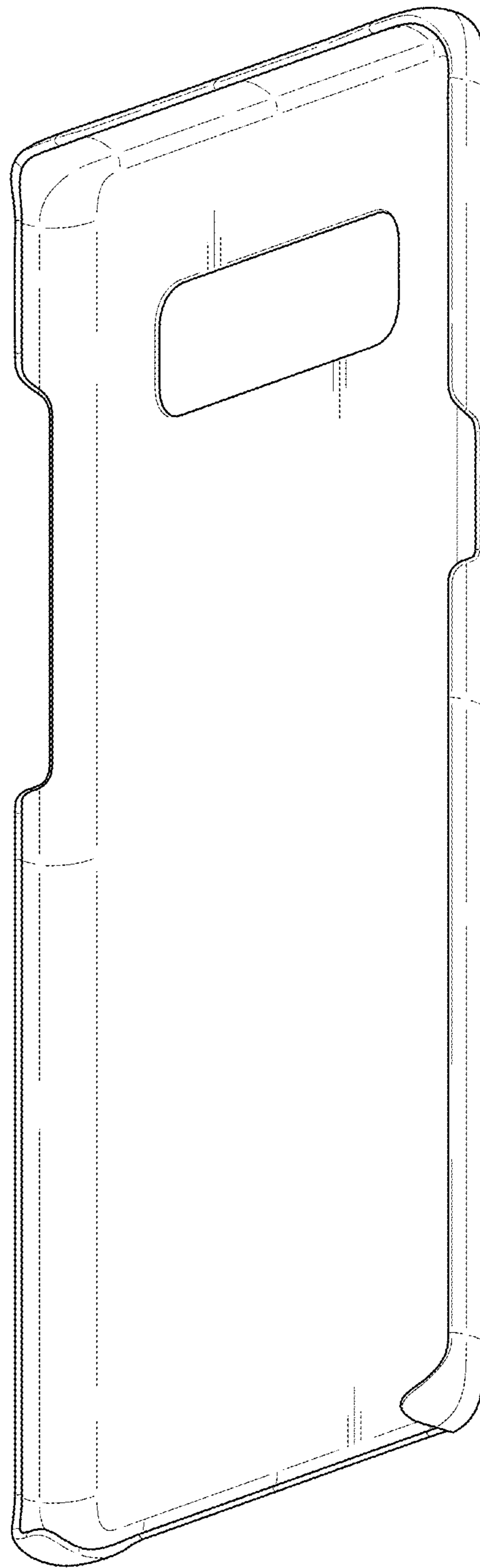
