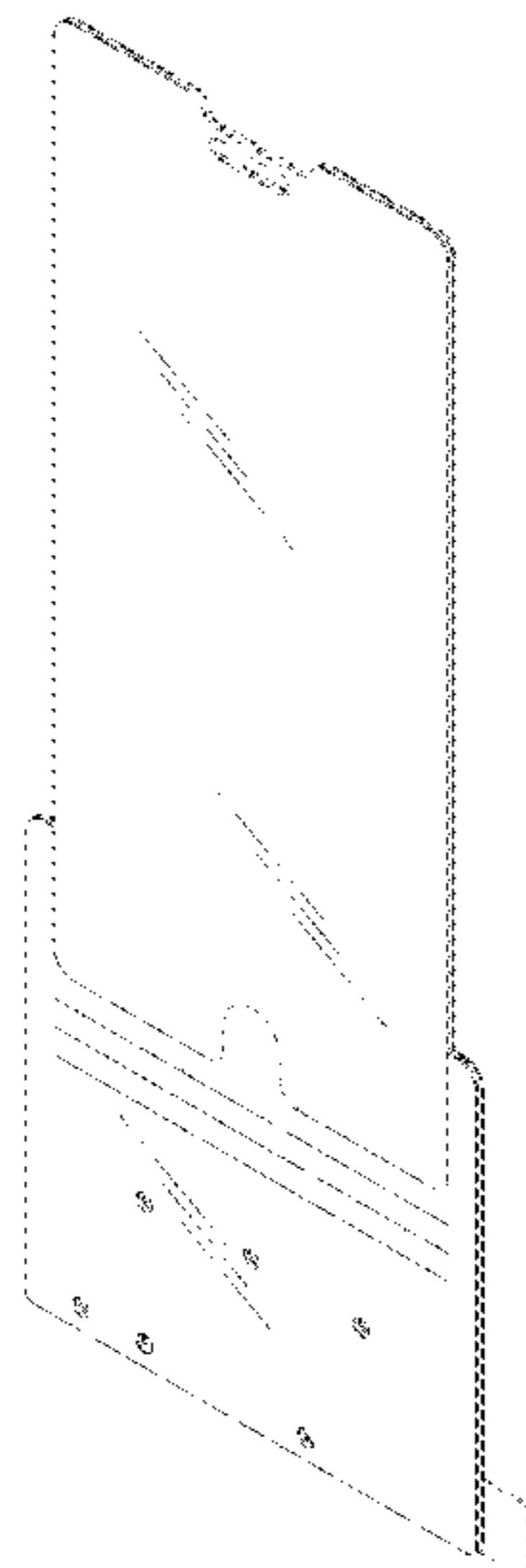
(57) **CLAIM**

The ornamental design for a “screen protector assembly”, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a screen protector assembly showing our new design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is a left elevational side view thereof;  
 FIG. 5 is a right elevational side view thereof;  
 FIG. 6 is a top plan view thereof;  
 FIG. 7 is a bottom plan view thereof;  
 FIG. 8 is a cross-sectional view taken along a cross-sectional line VIII-VIII of FIG. 2; and,  
 FIG. 9 is an exploded perspective view of FIG. 1 showing that the screen protector assembly includes a soft screen film, a partition in shape-complementary with the soft screen film, and two releasing films respectively adhered to one side of the soft screen film and the partition and the other side of the soft screen film and the partition.  
 The broken line showing of the environment is for illustrative purposes only and forms no part of the claimed design.

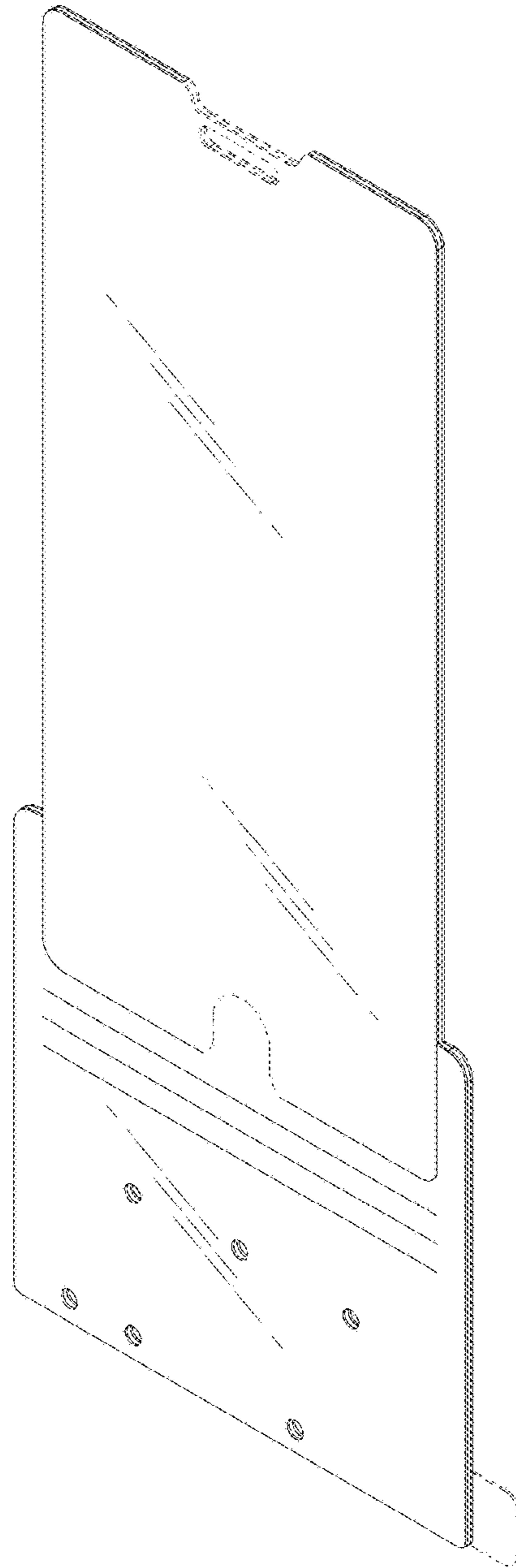

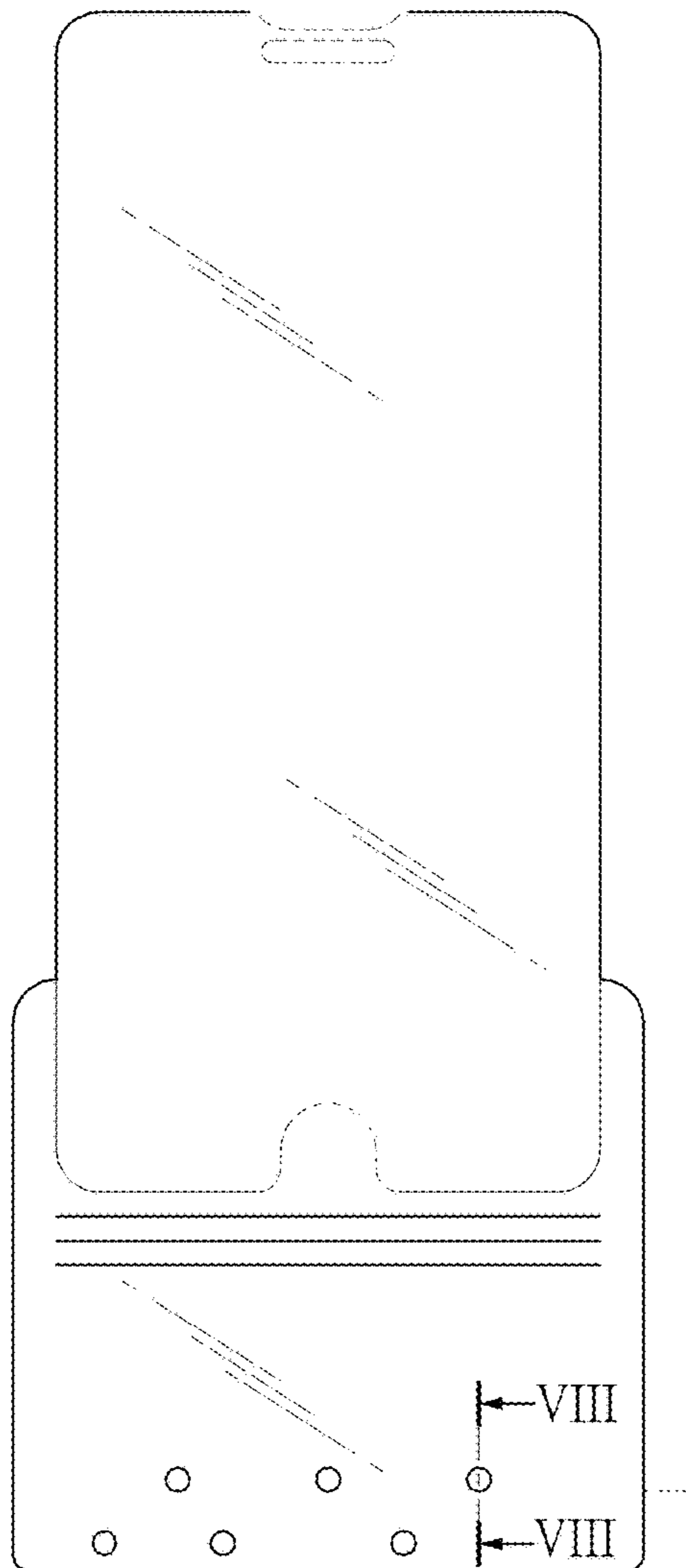

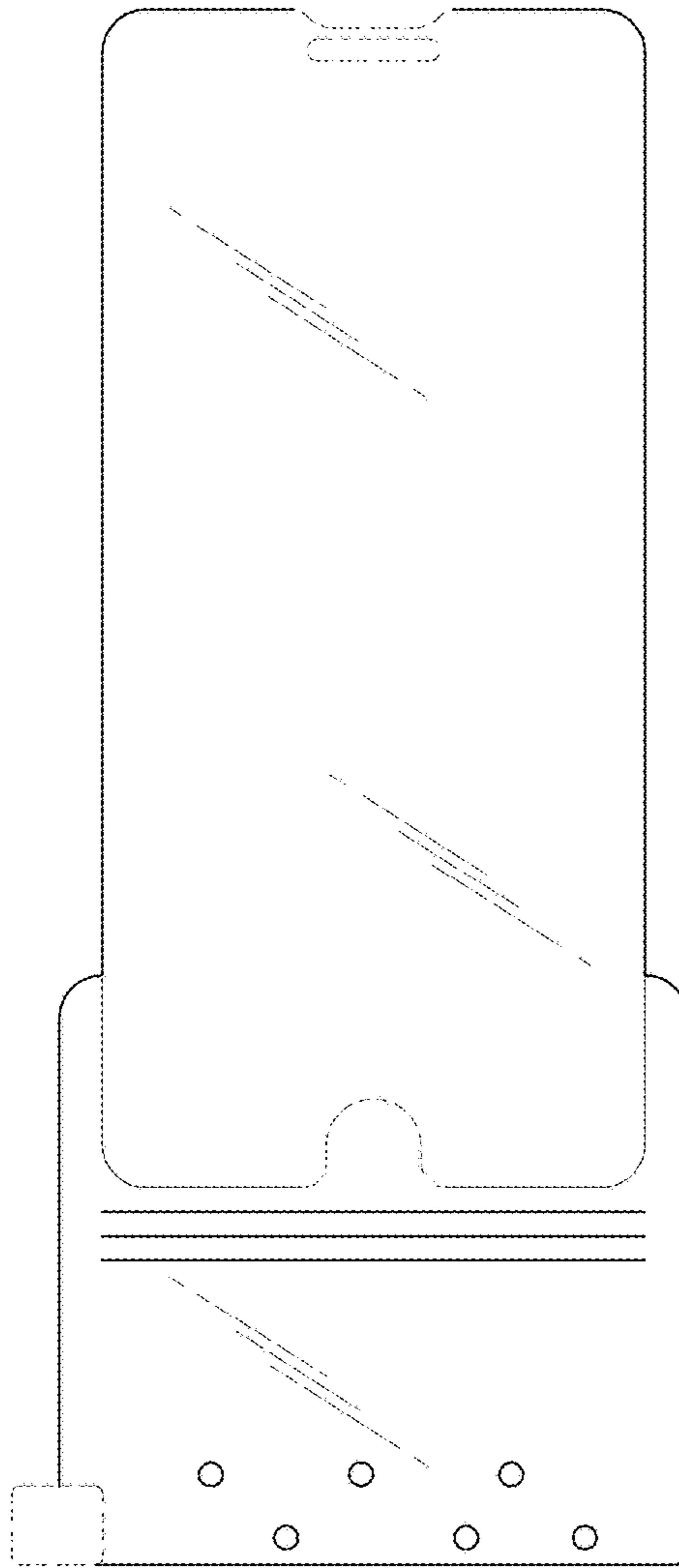

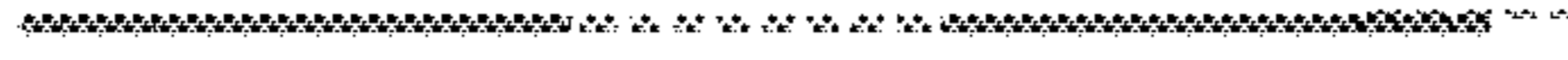

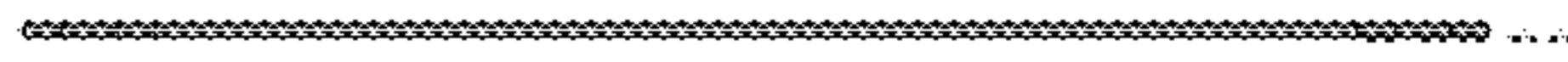

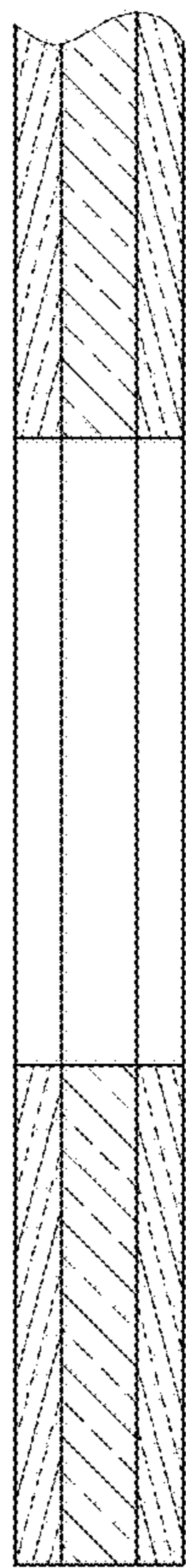

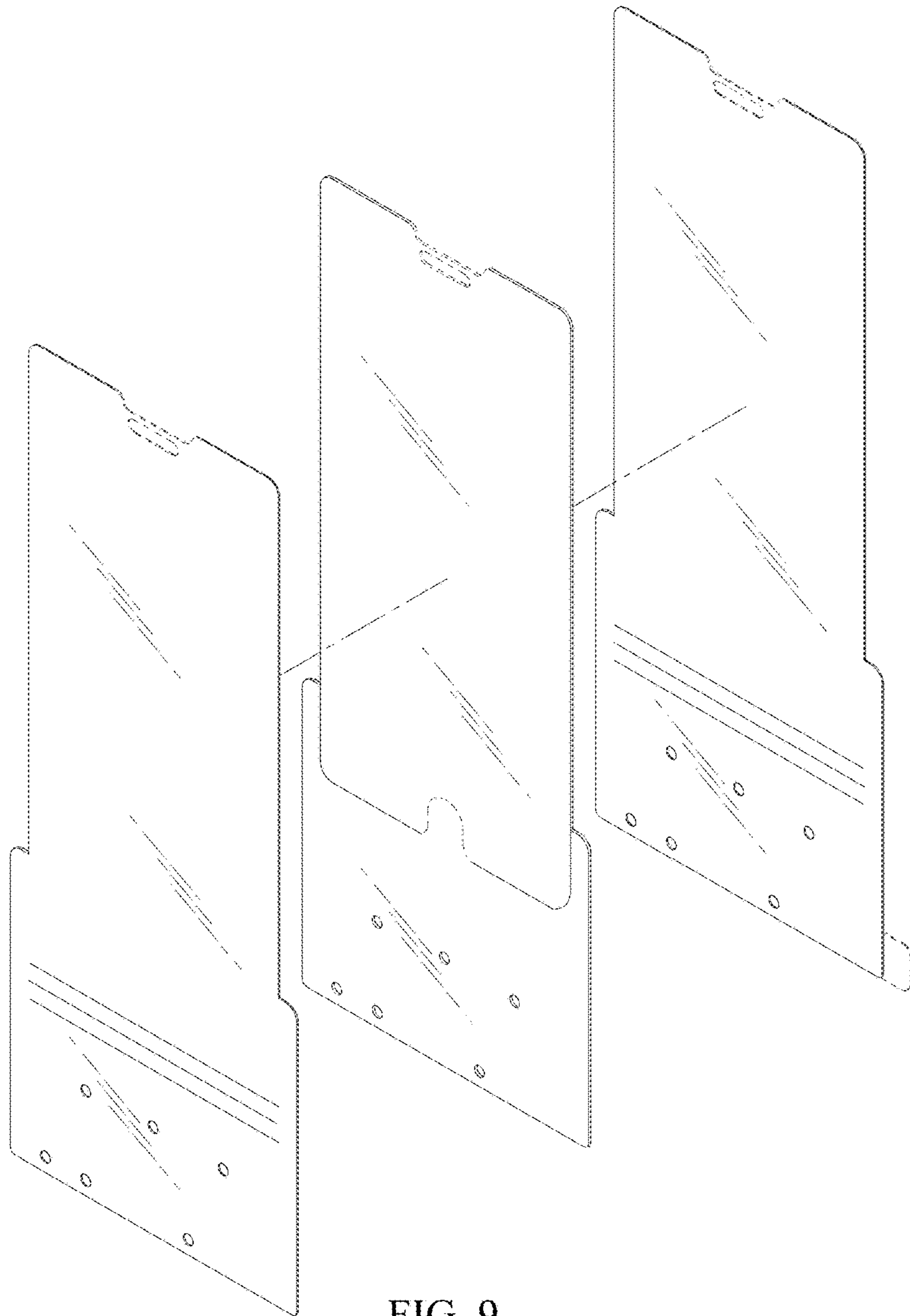
