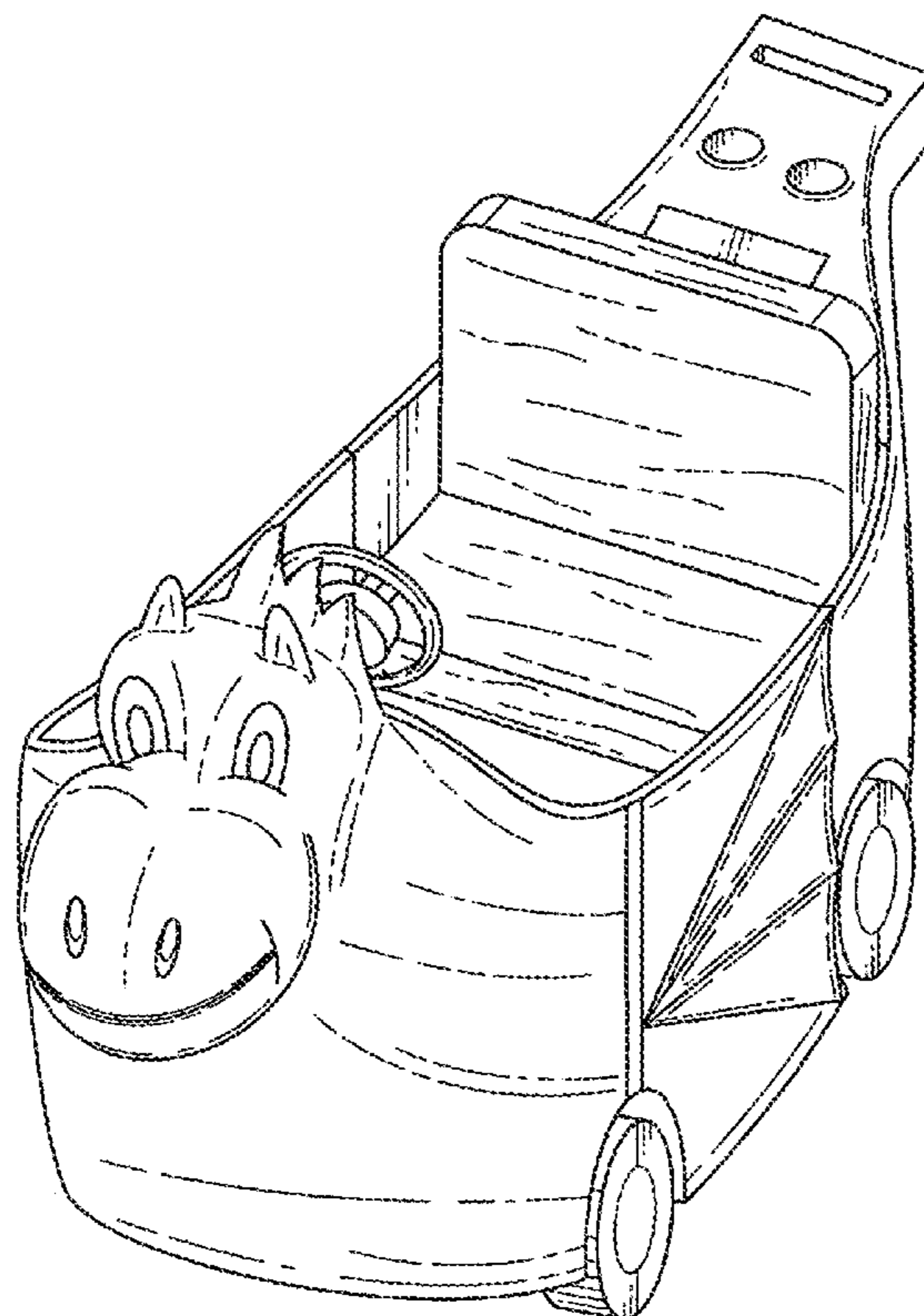
(57) **CLAIM**

The ornamental design for a stroller, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a stroller;
FIG. 2 is a front elevation view of the stroller of FIG. 1;
FIG. 3 is a rear elevation view of the stroller of FIG. 1;
FIG. 4 is a side elevation view of the stroller of FIG. 1; and,
FIG. 5 is a top plan view of the stroller of FIG. 1.
The broken lines shown in FIGS. 3 & 5 are included for the purpose of illustrating portions of the stroller which form no part of the claimed design.

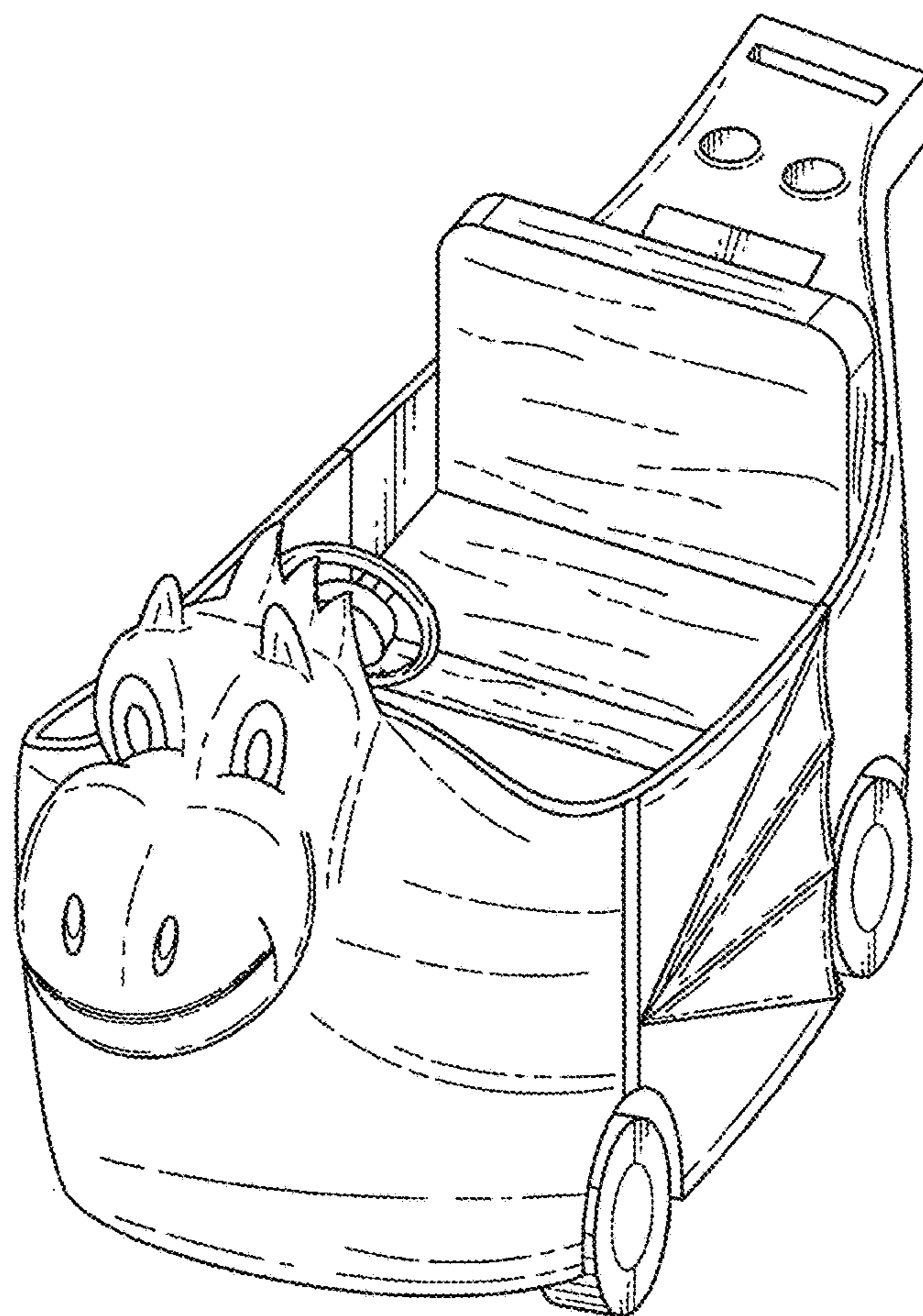

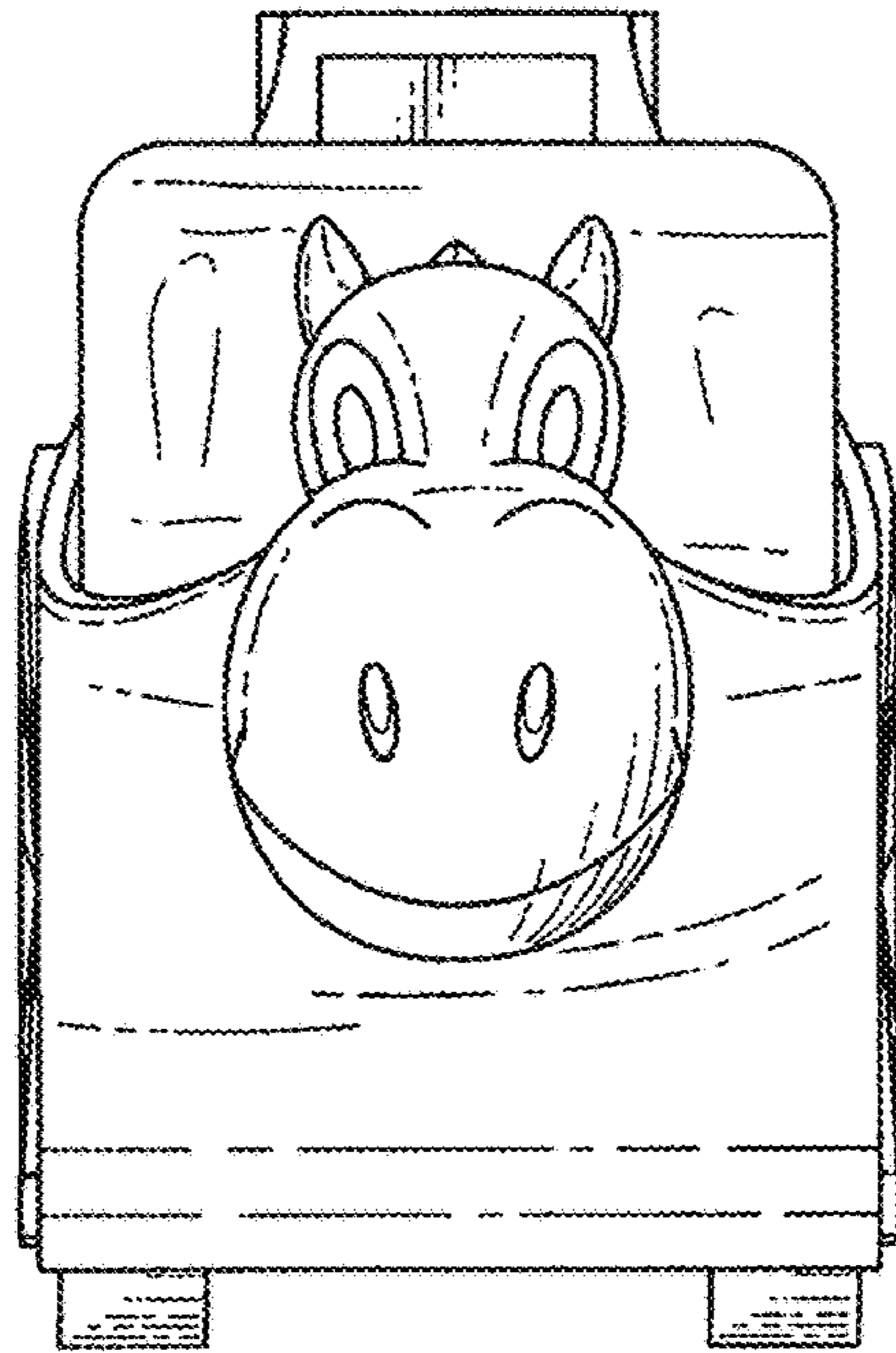

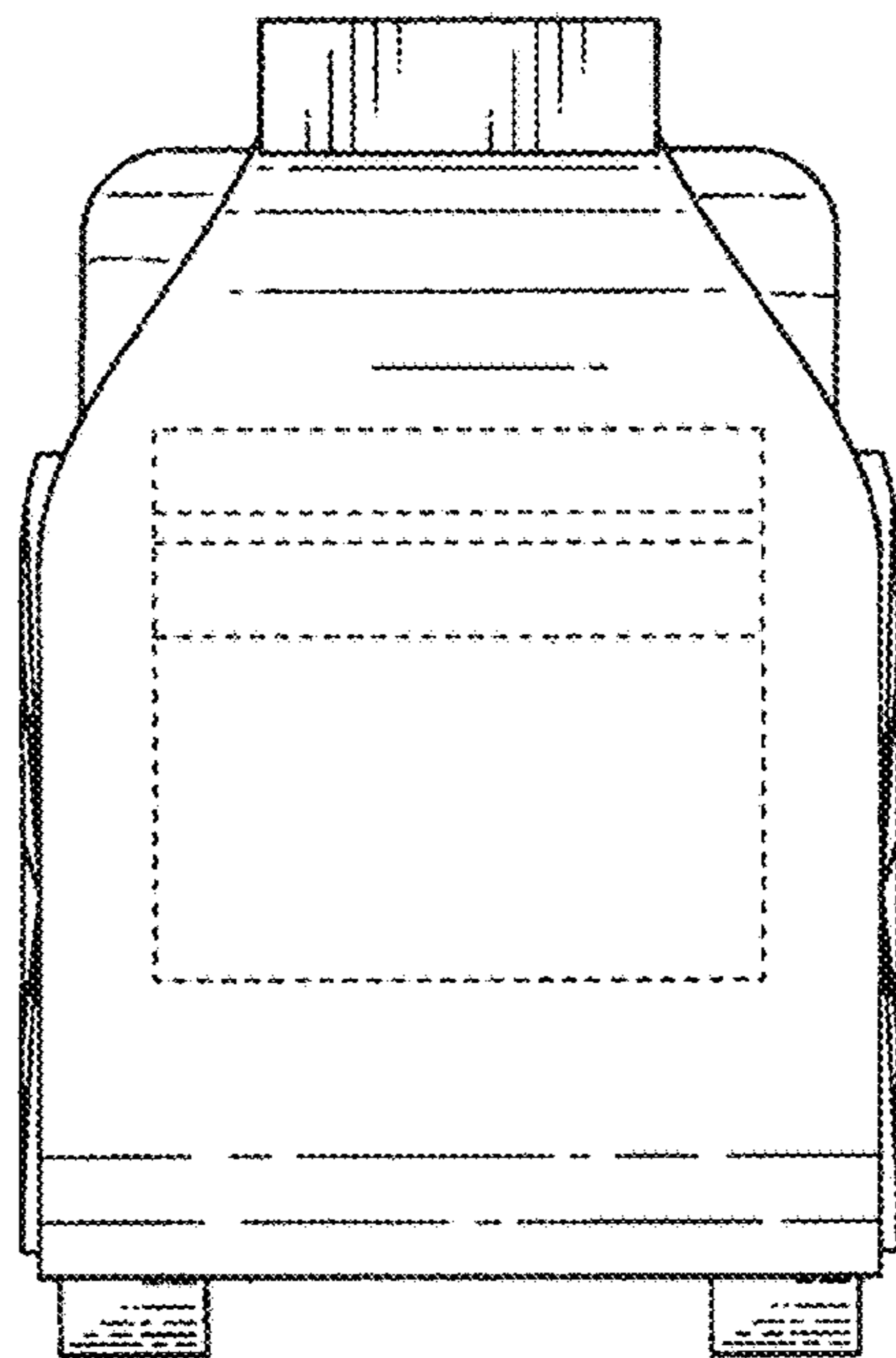

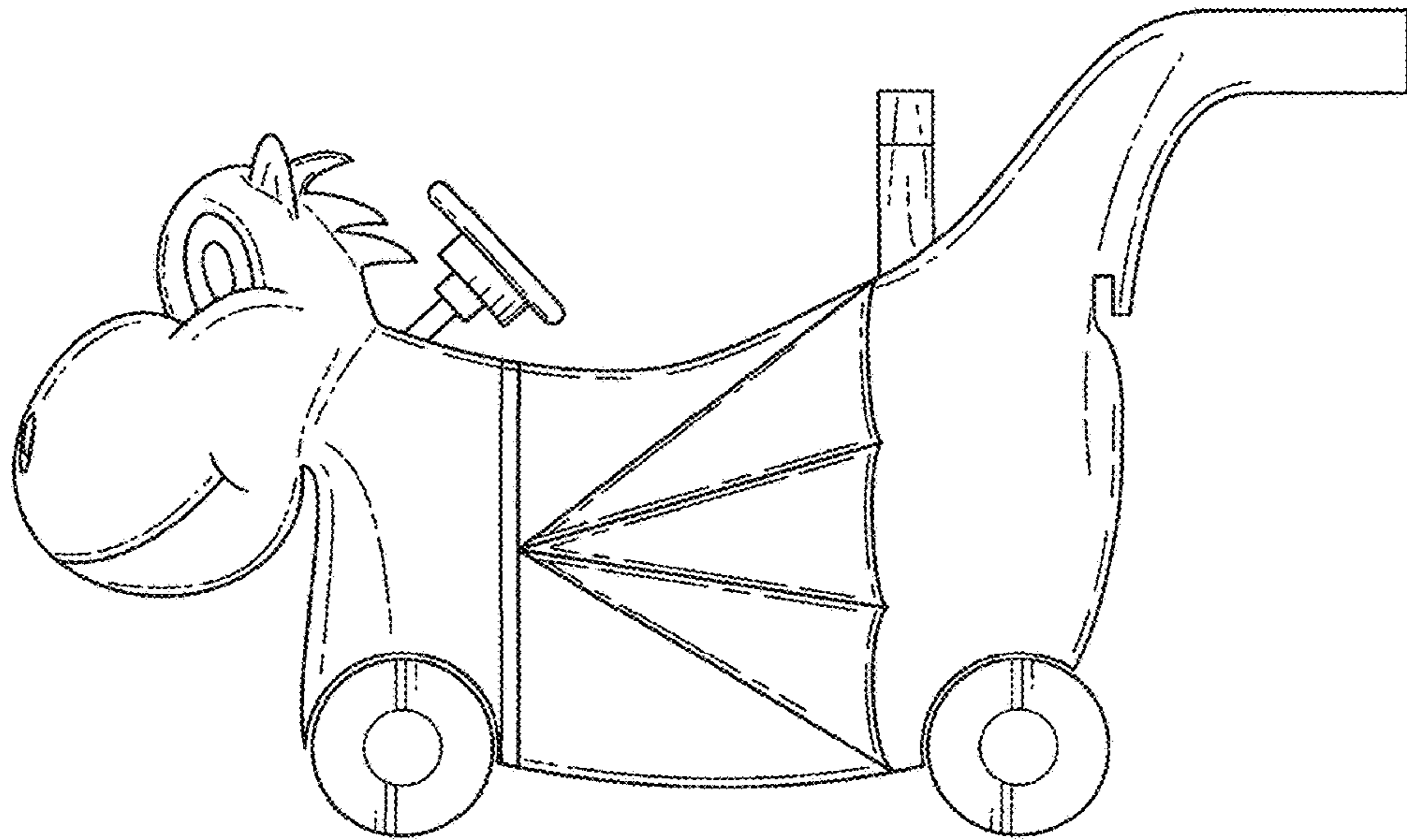

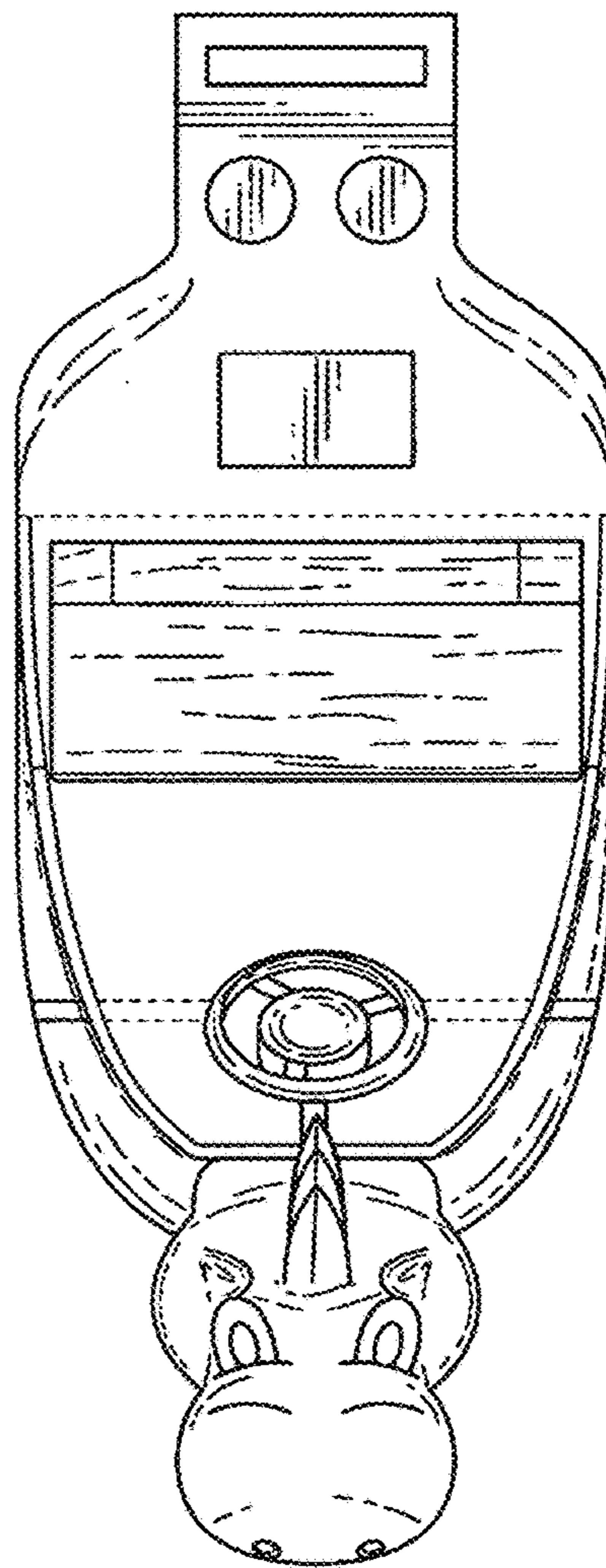
