FIG. 2 is a front elevational view of the design in FIG. 1.

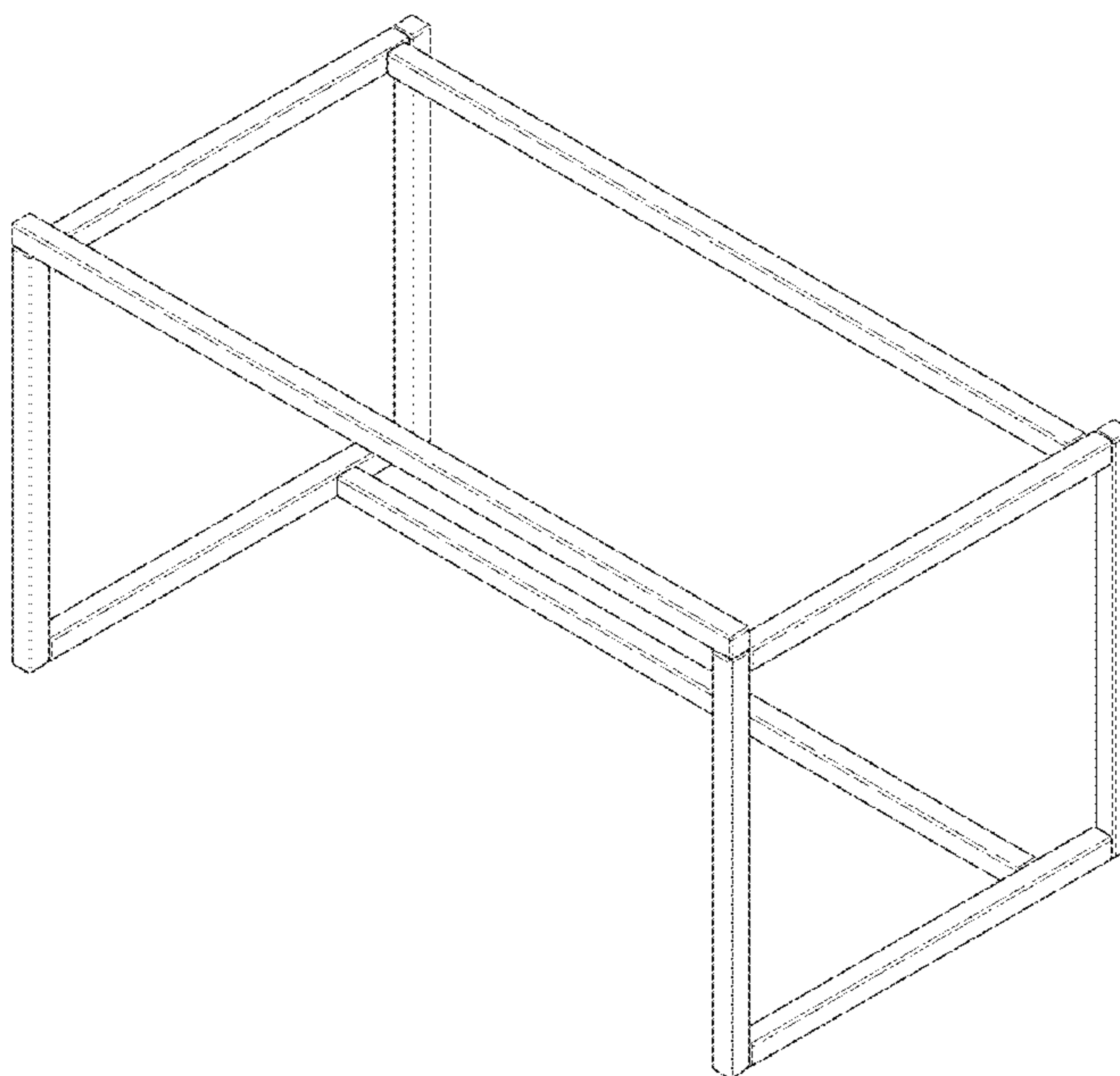
FIG. 3 is a top view of the design in FIG. 1.

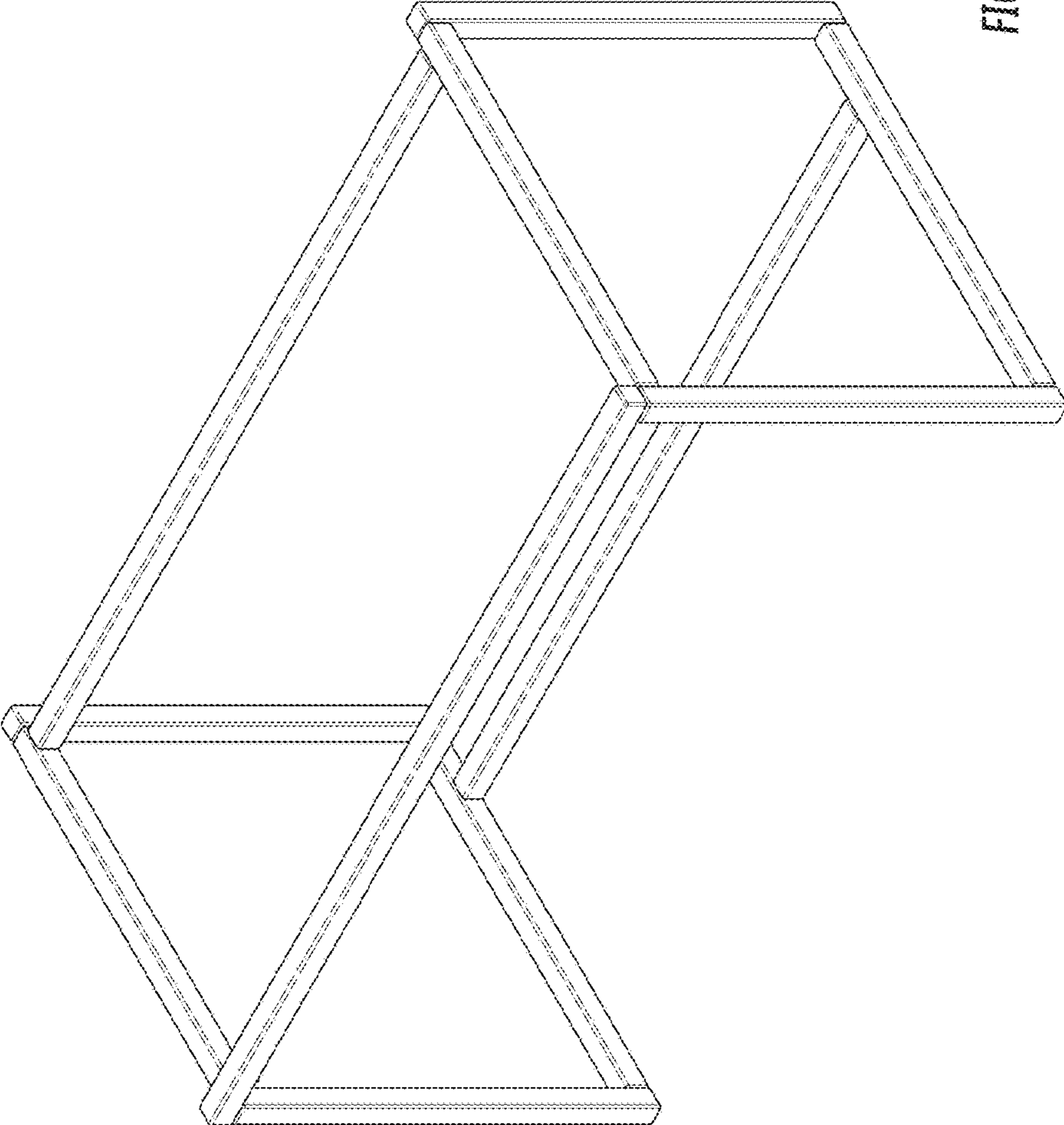

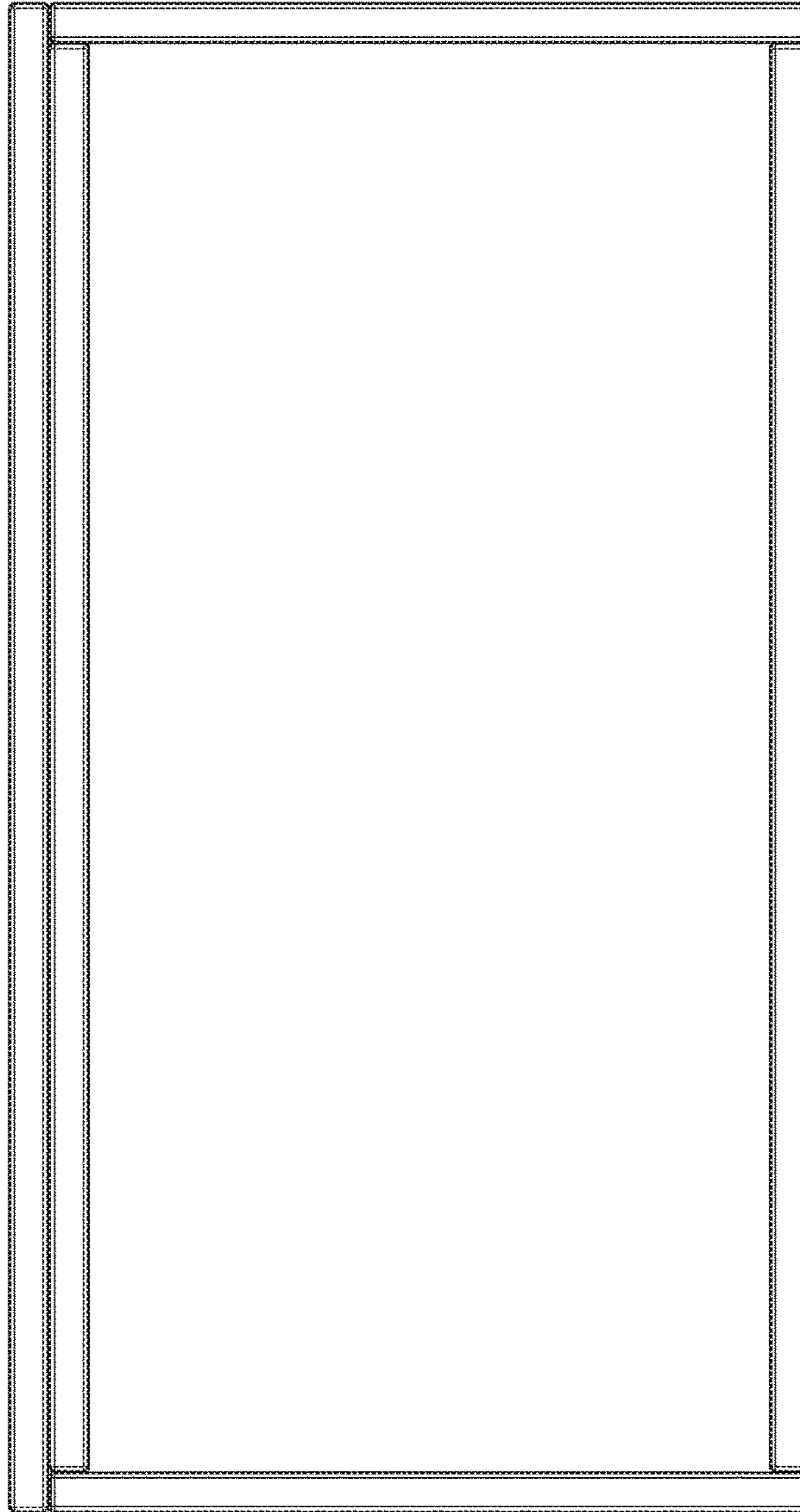

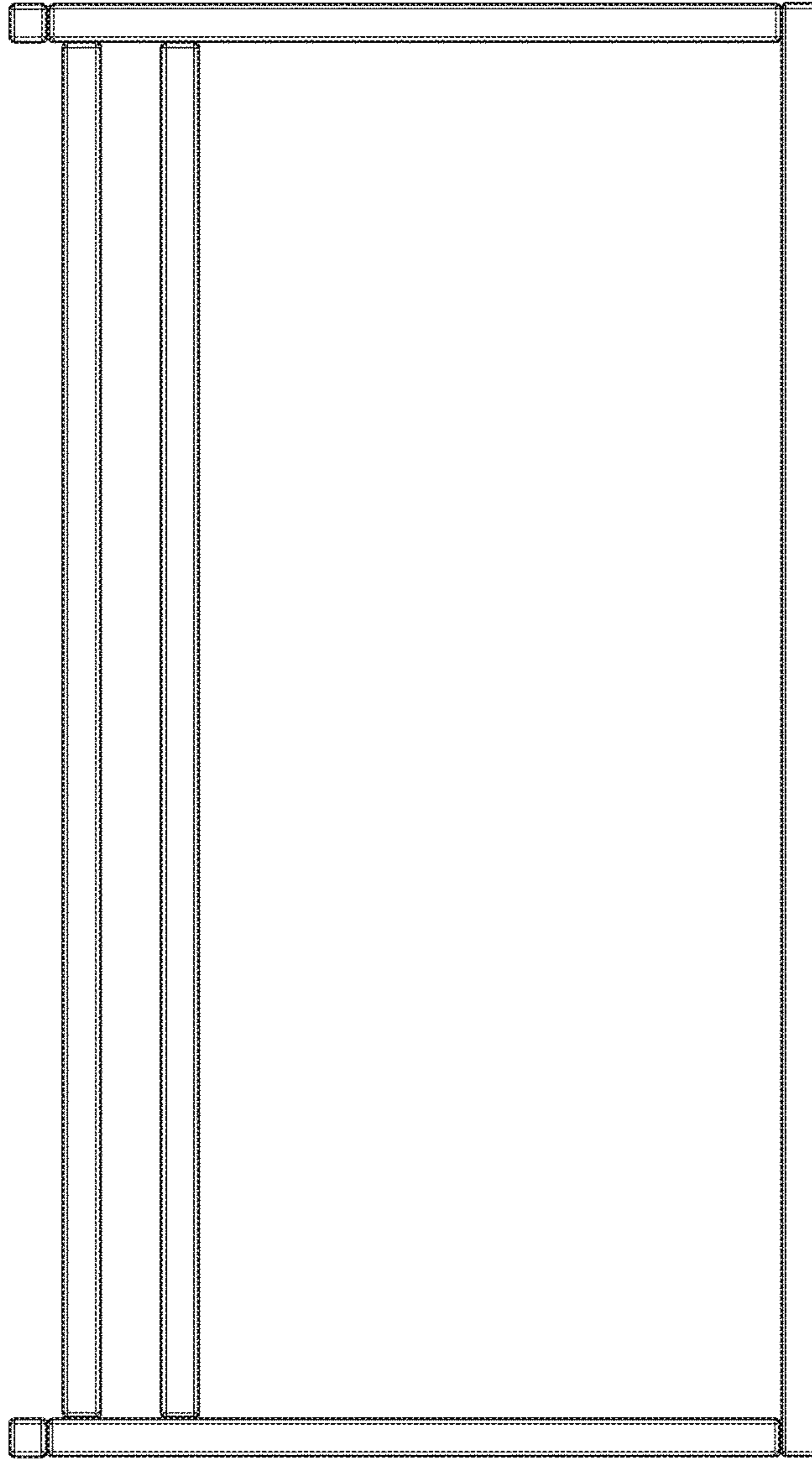

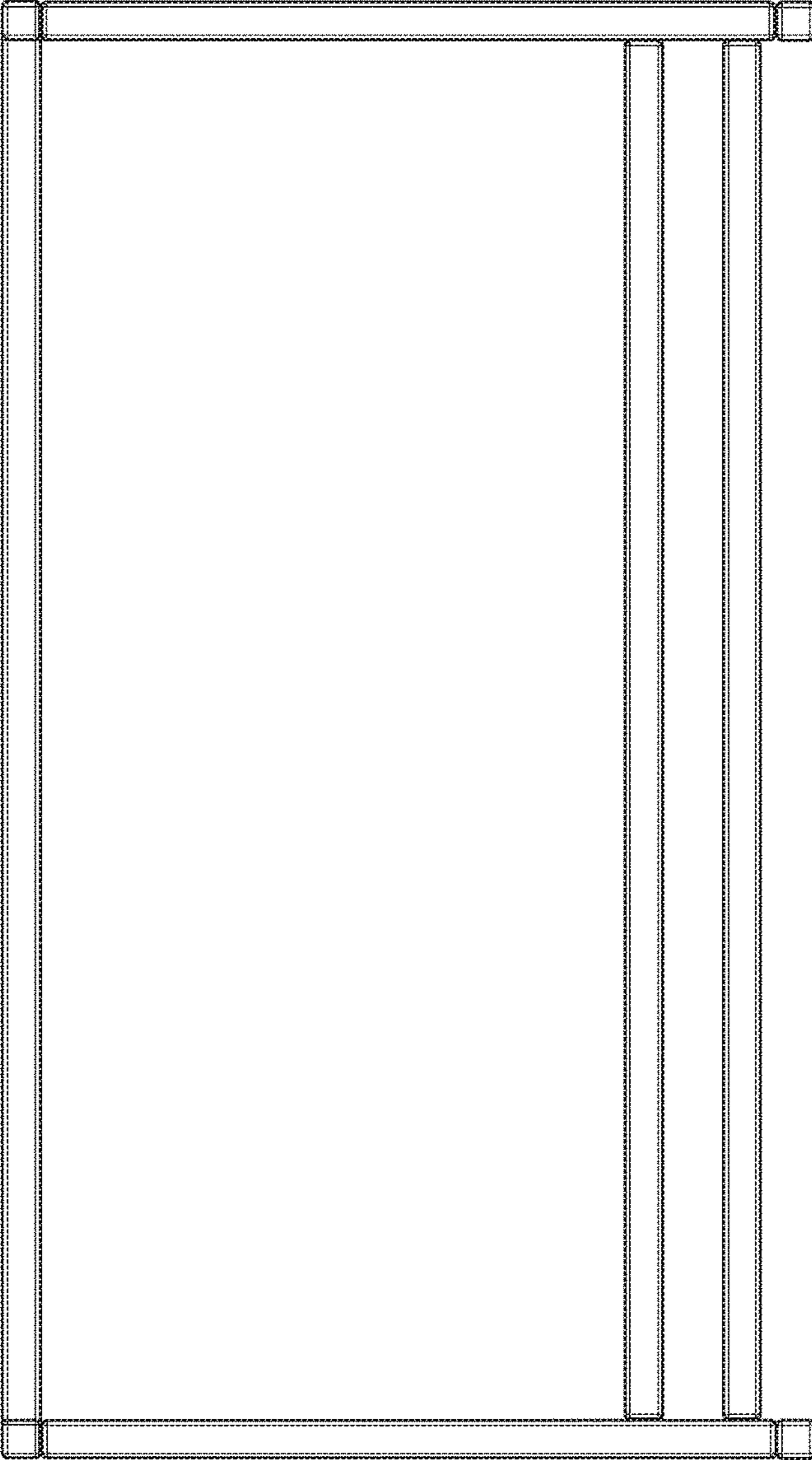

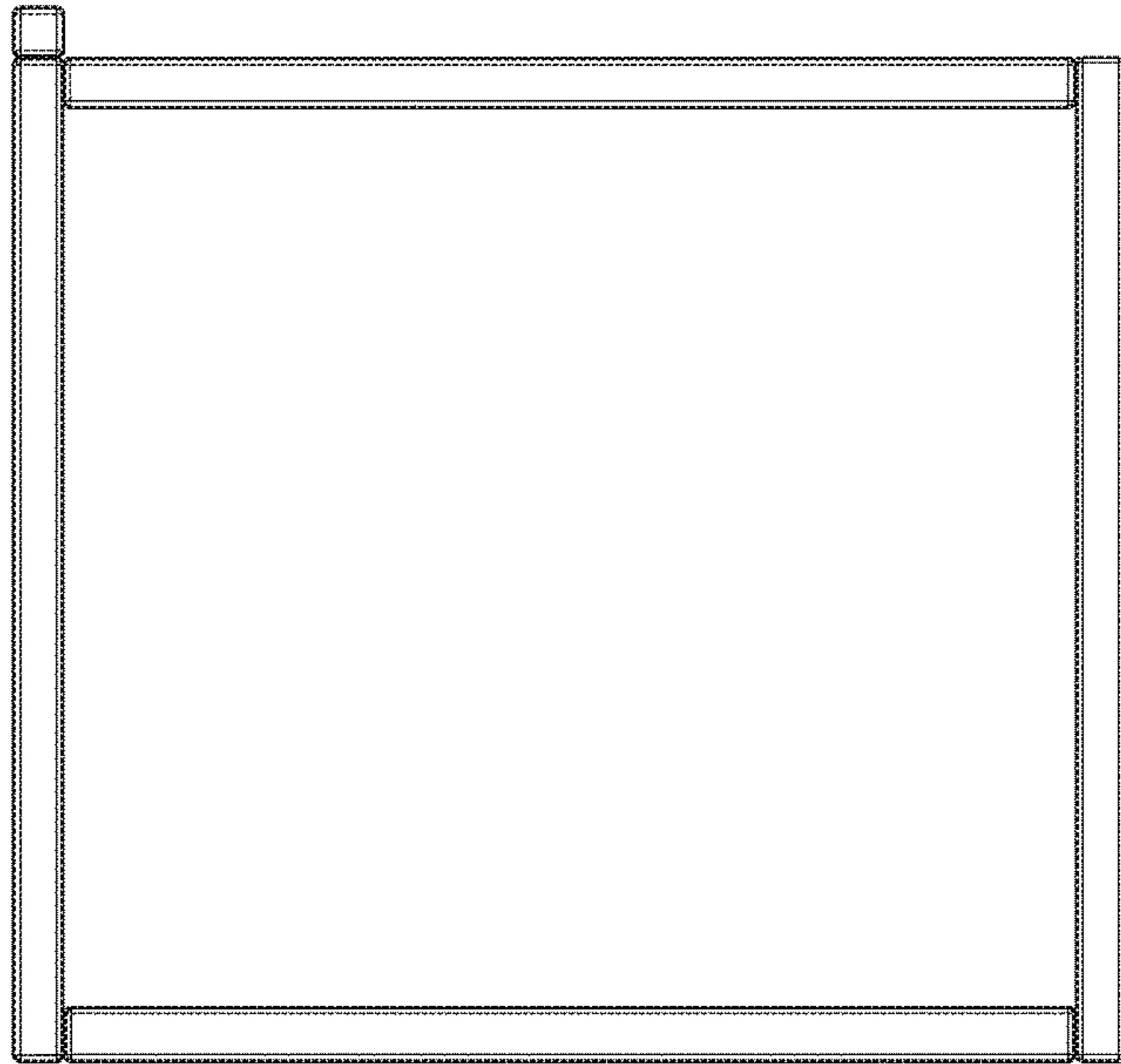

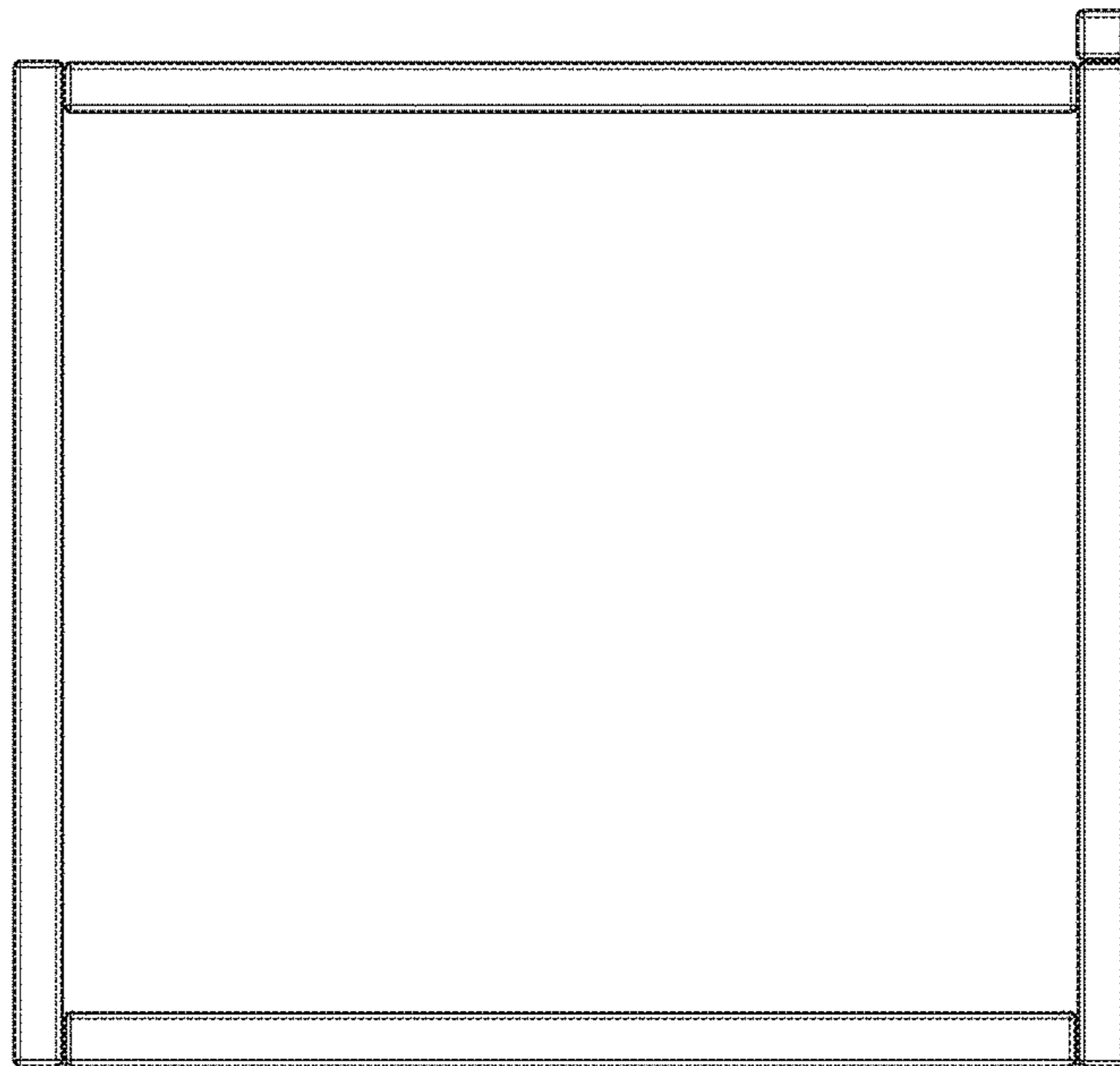
