DESCRIPTION

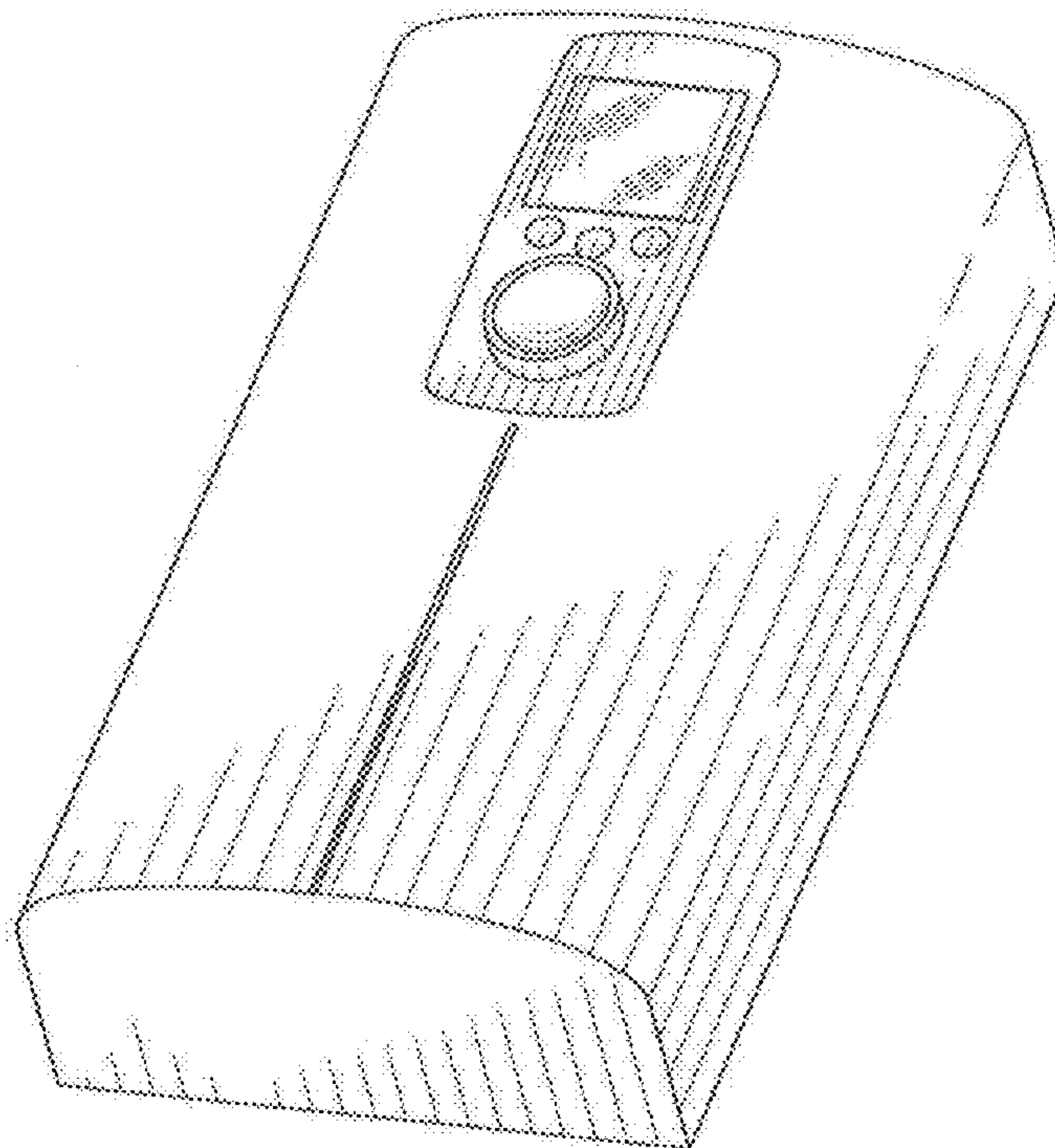
FIG. 1 is a bottom, front, right side perspective view of a water heater showing my new design;

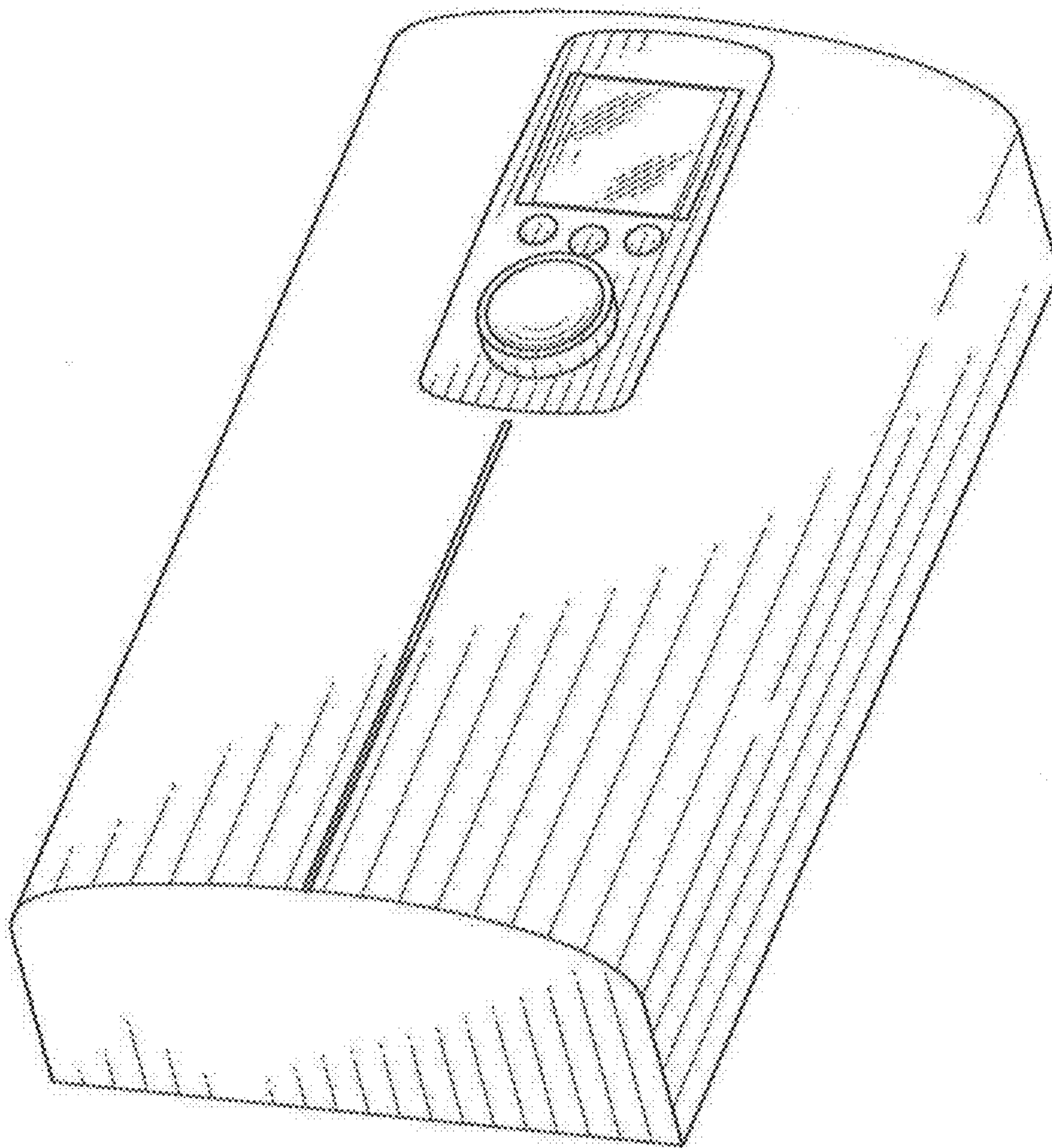

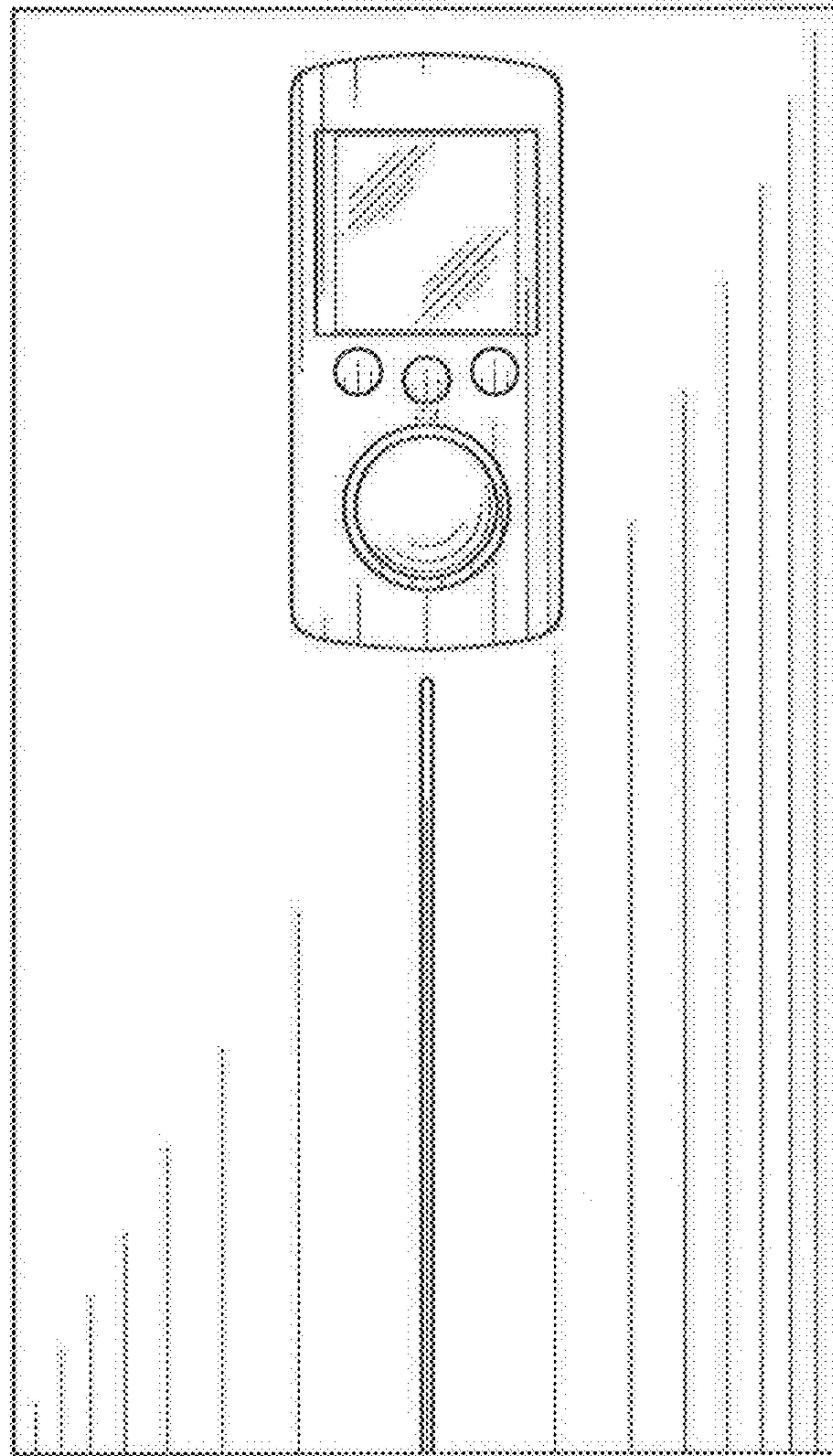

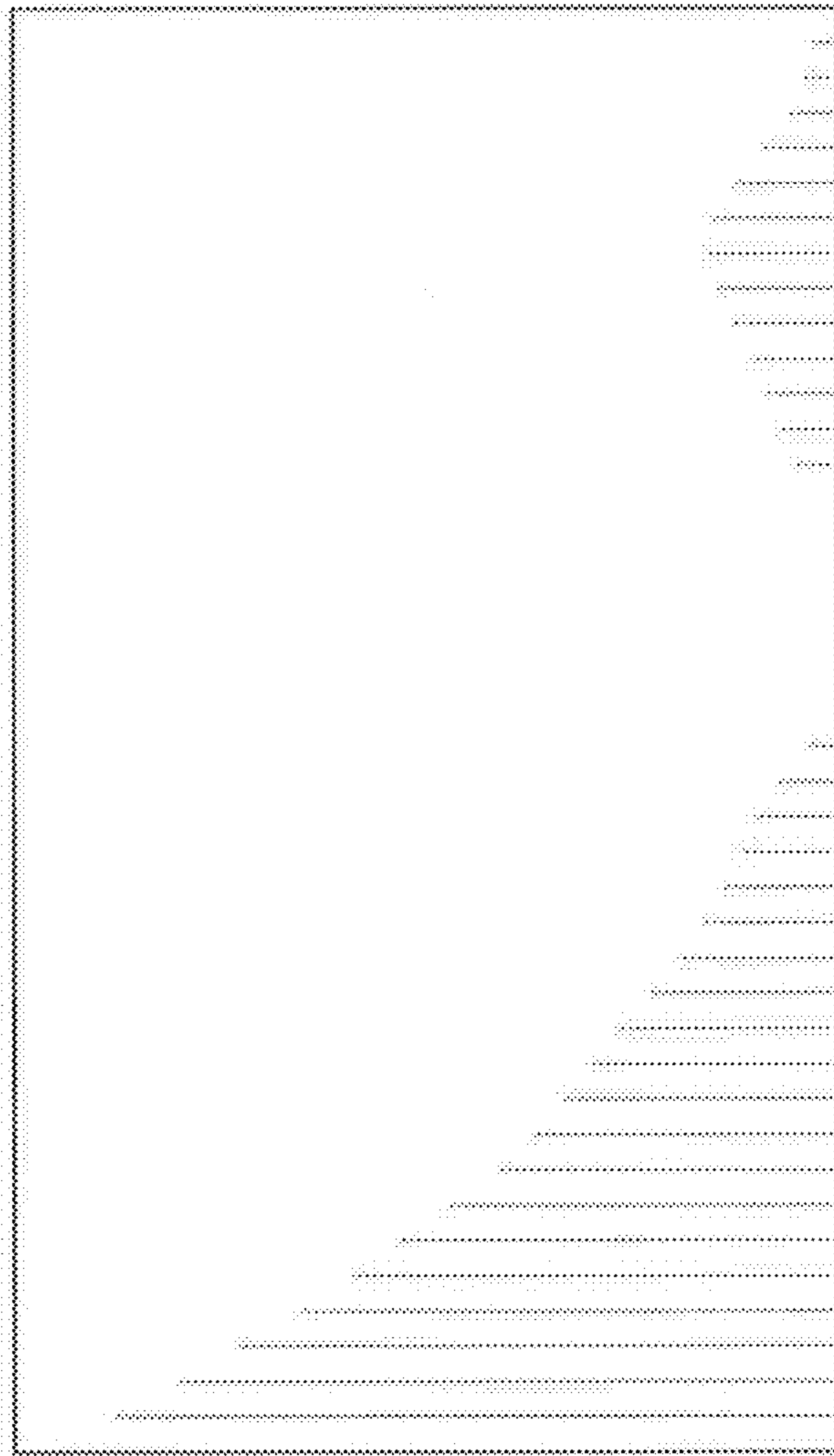

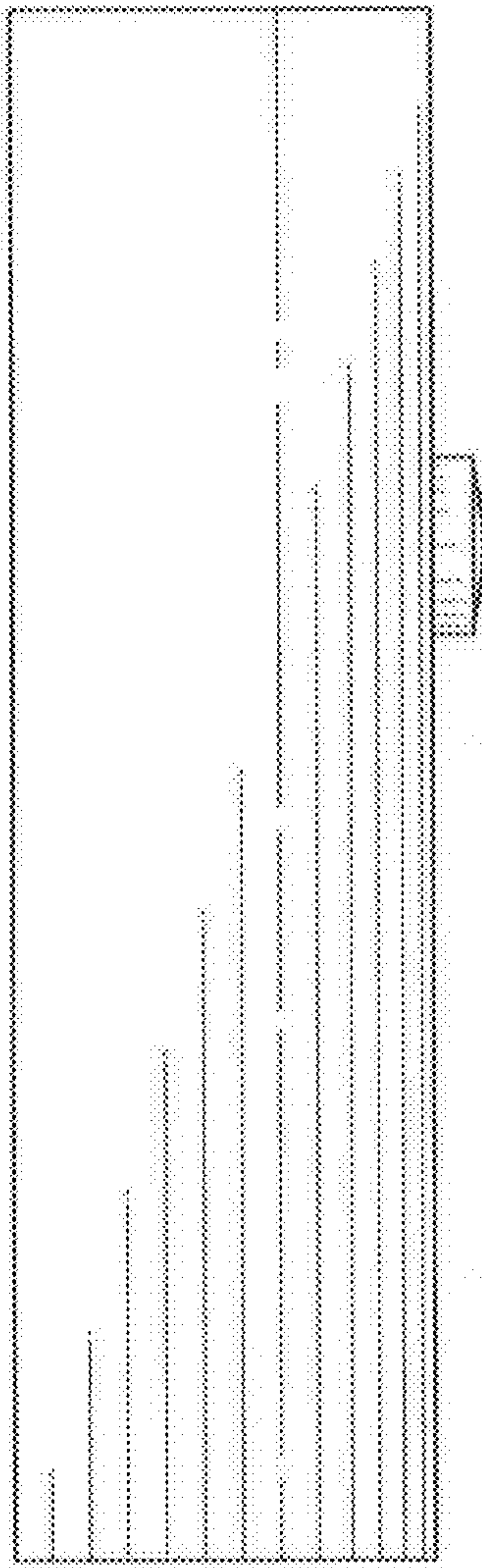

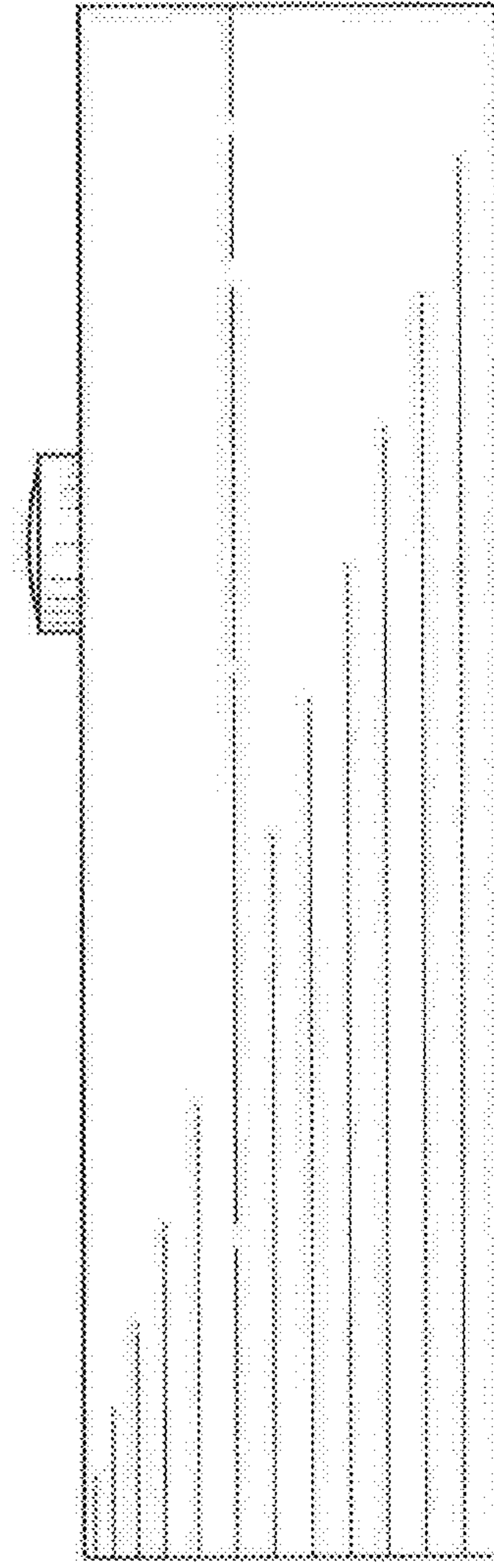

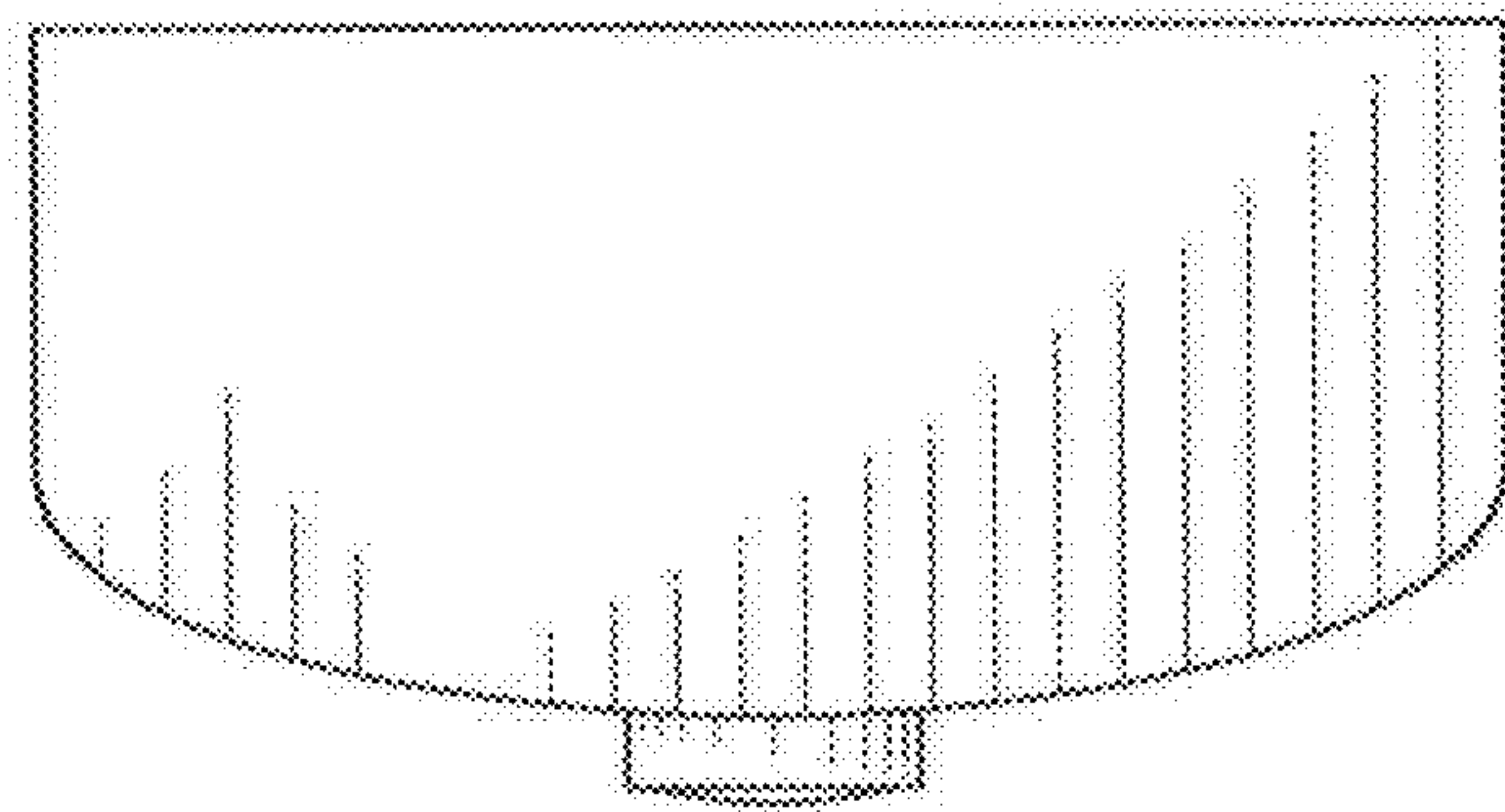

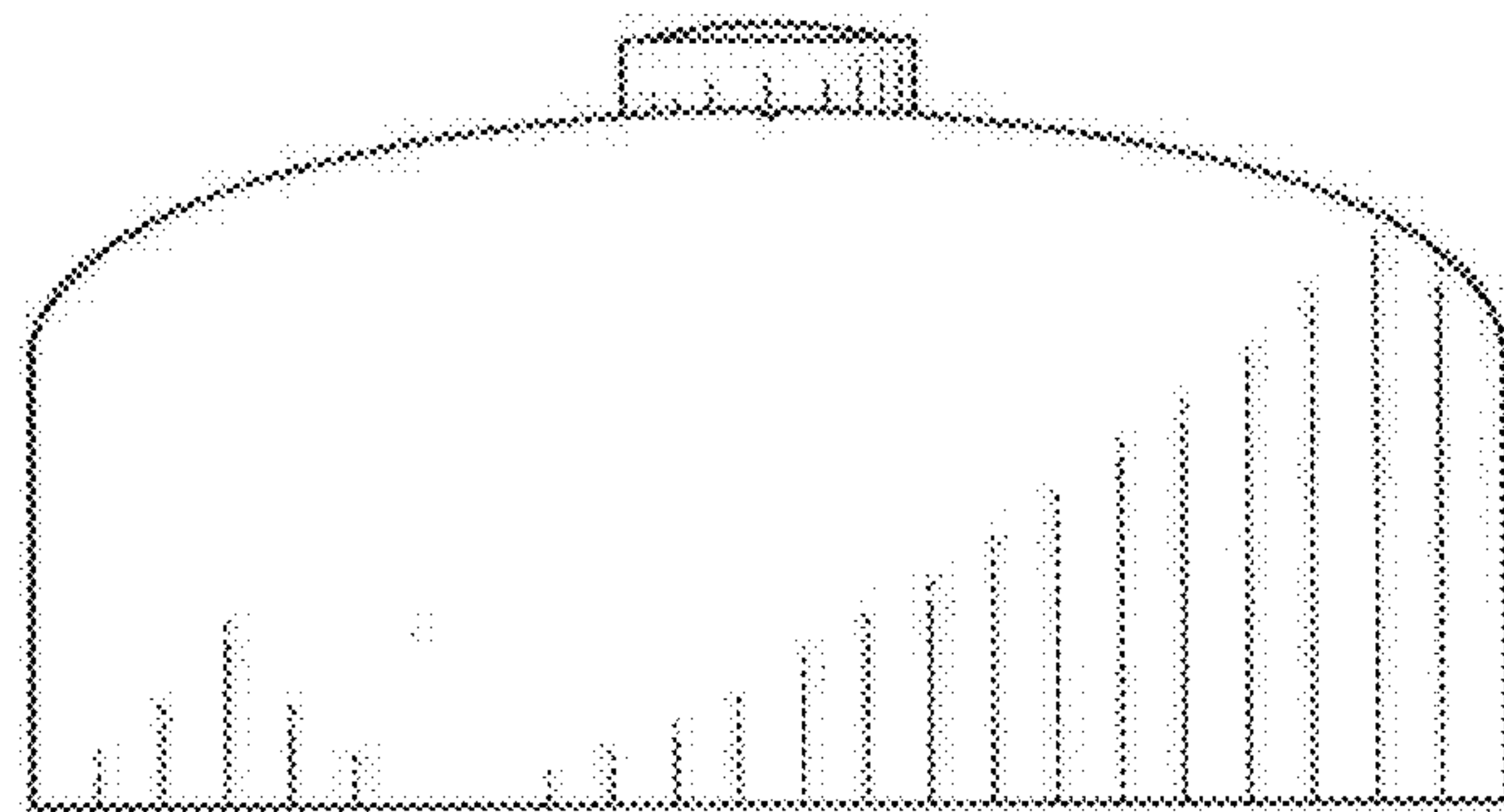
