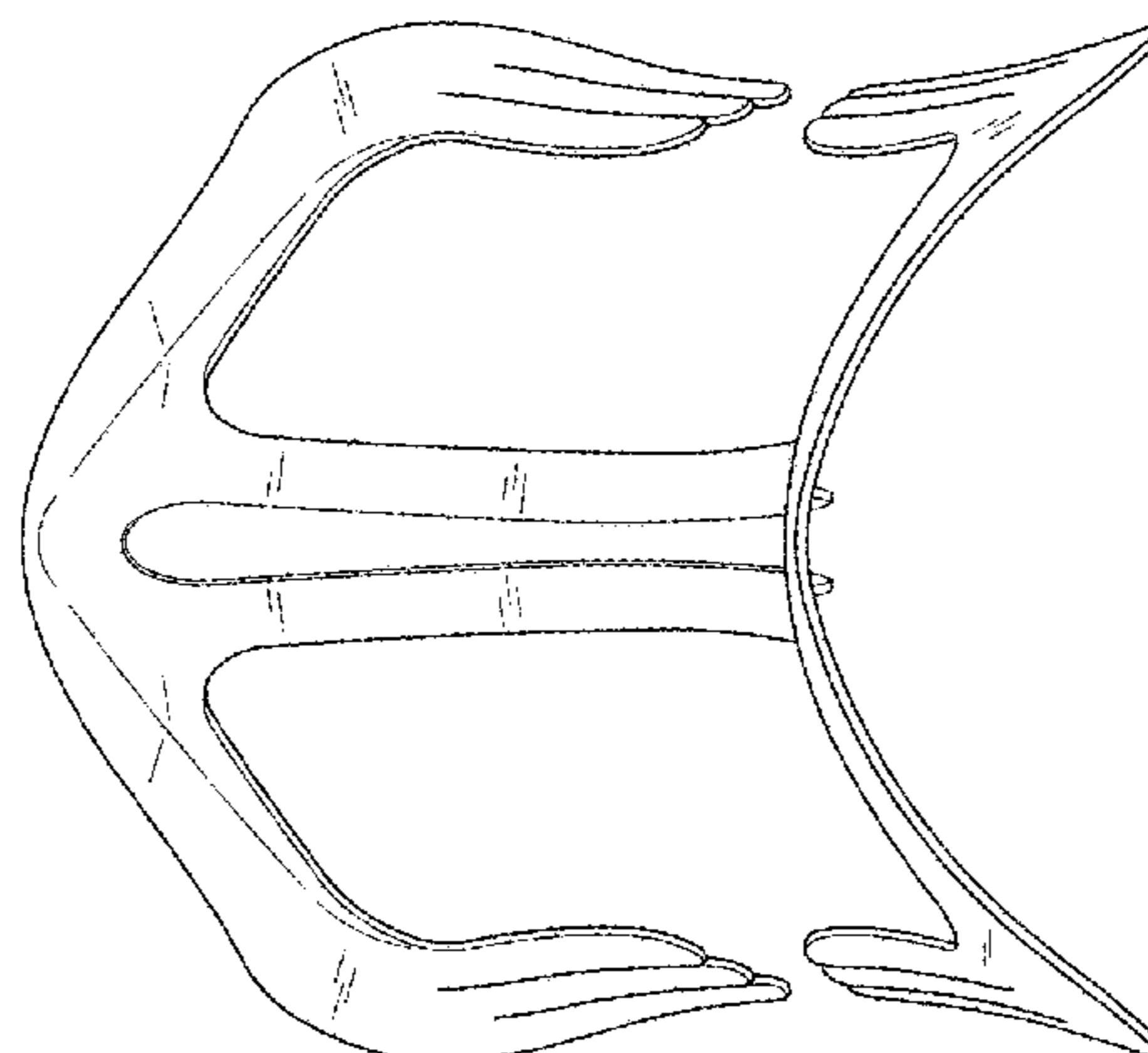
(57) **CLAIM**

We claim the ornamental design for a head supporting travel accessory, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, left side perspective view of a head supporting travel accessory showing our design; FIG. 2 is a top elevation view thereof, the bottom elevation view being a mirror image thereof, and therefore is not shown; FIG. 3 is a top plan view thereof; FIG. 4 is a right side elevation view thereof, the left side elevation view being a mirror image thereof, and therefore is not shown; and, FIG. 5 is a bottom plan view thereof.

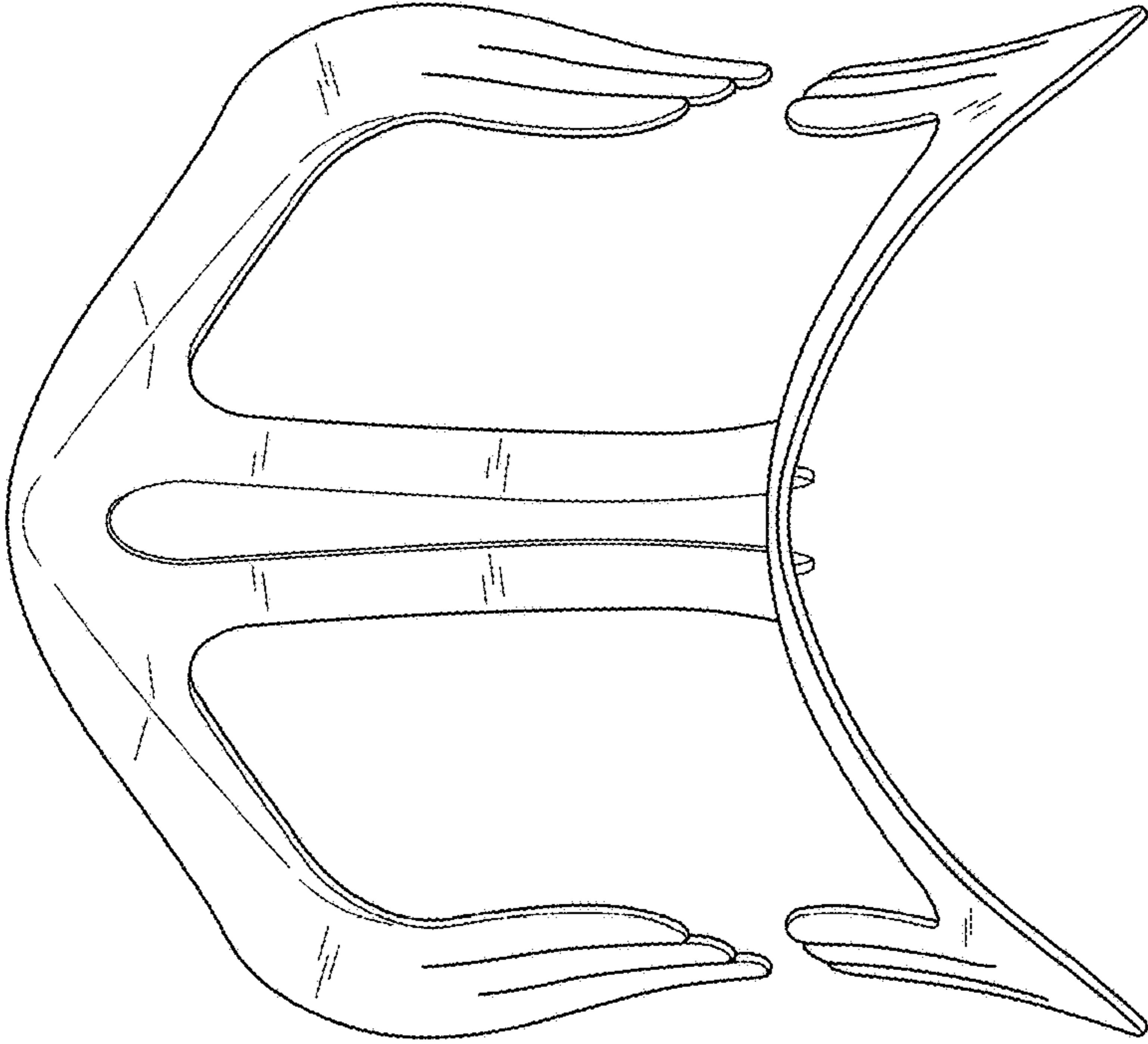

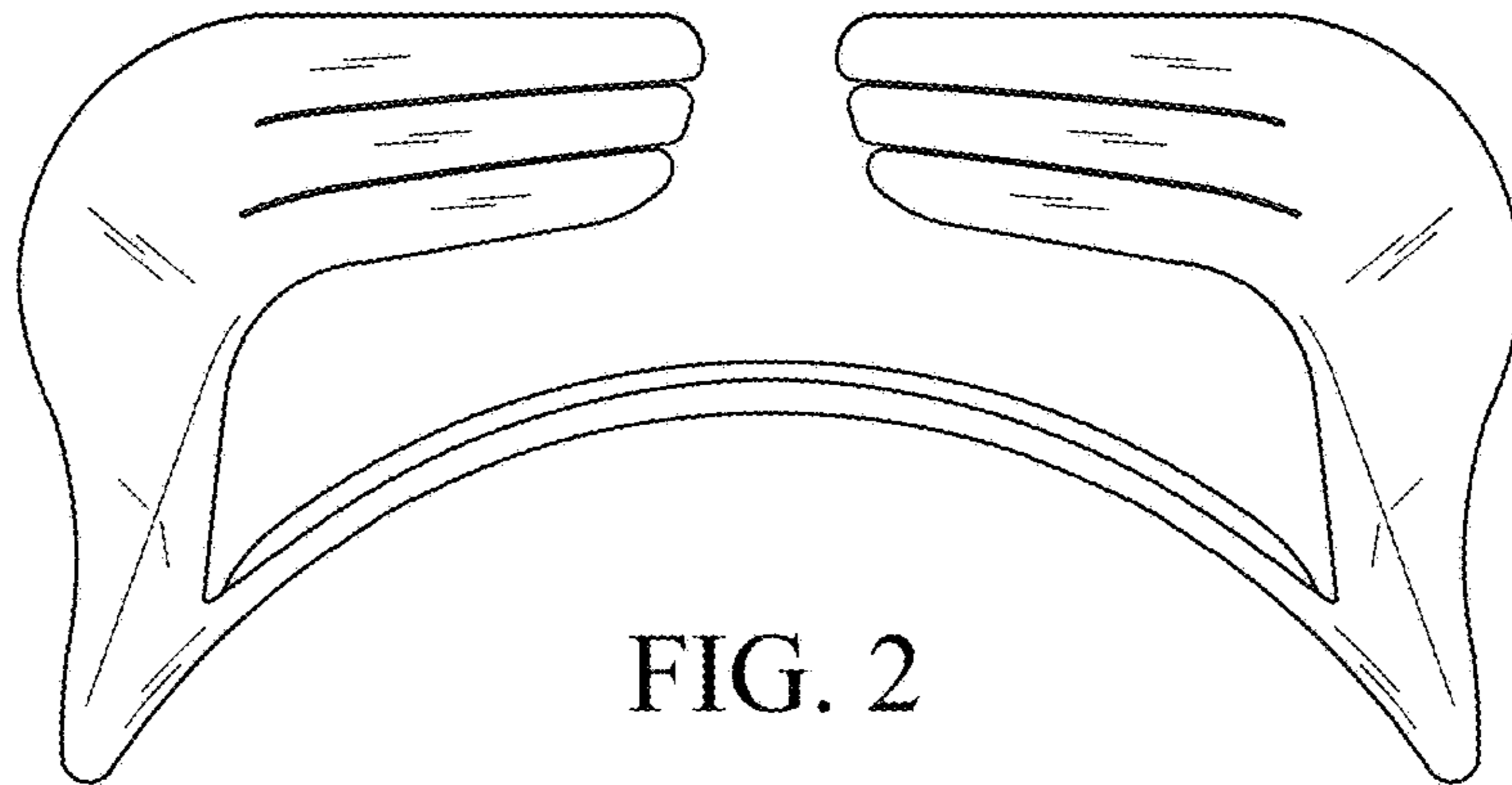

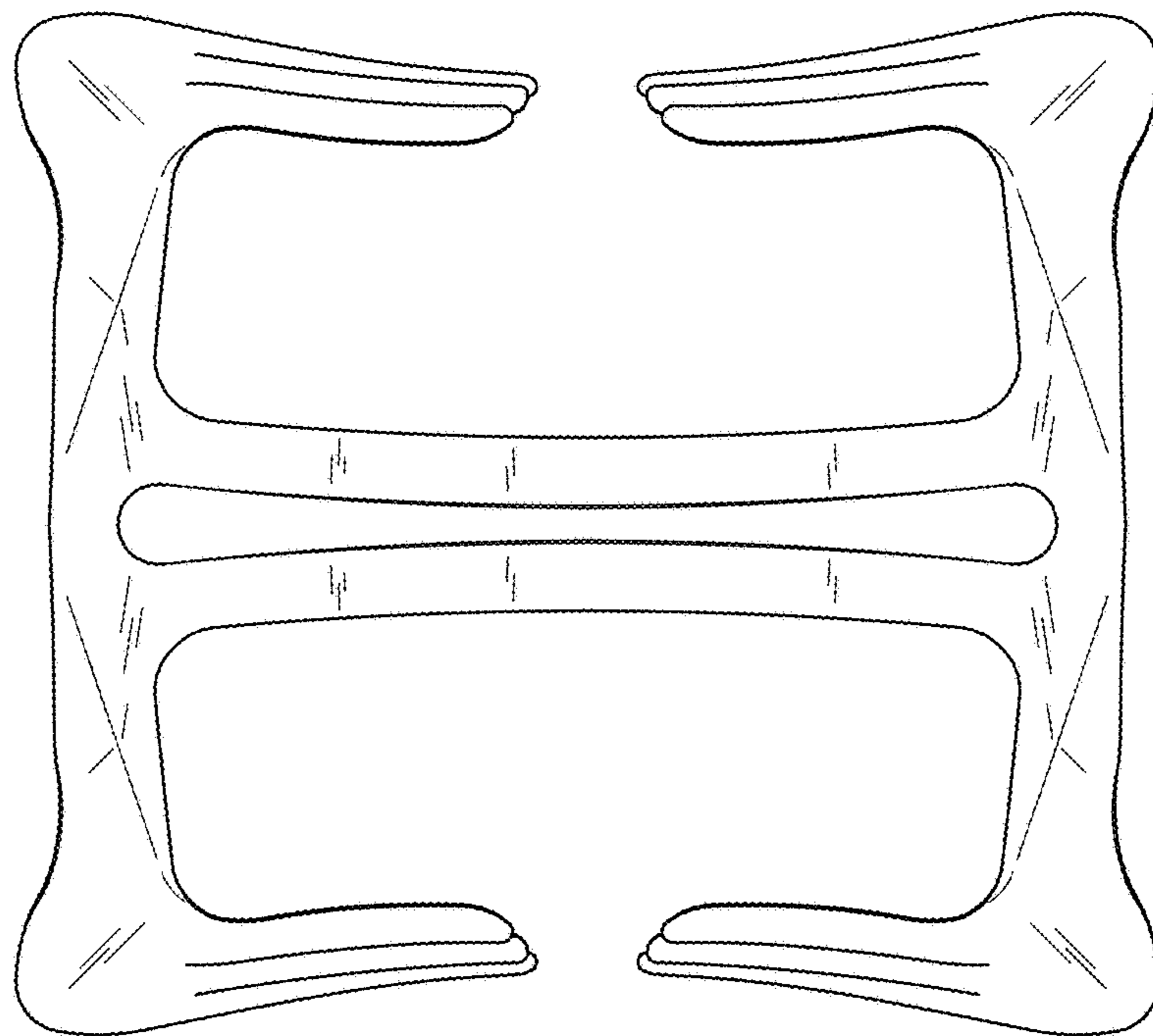

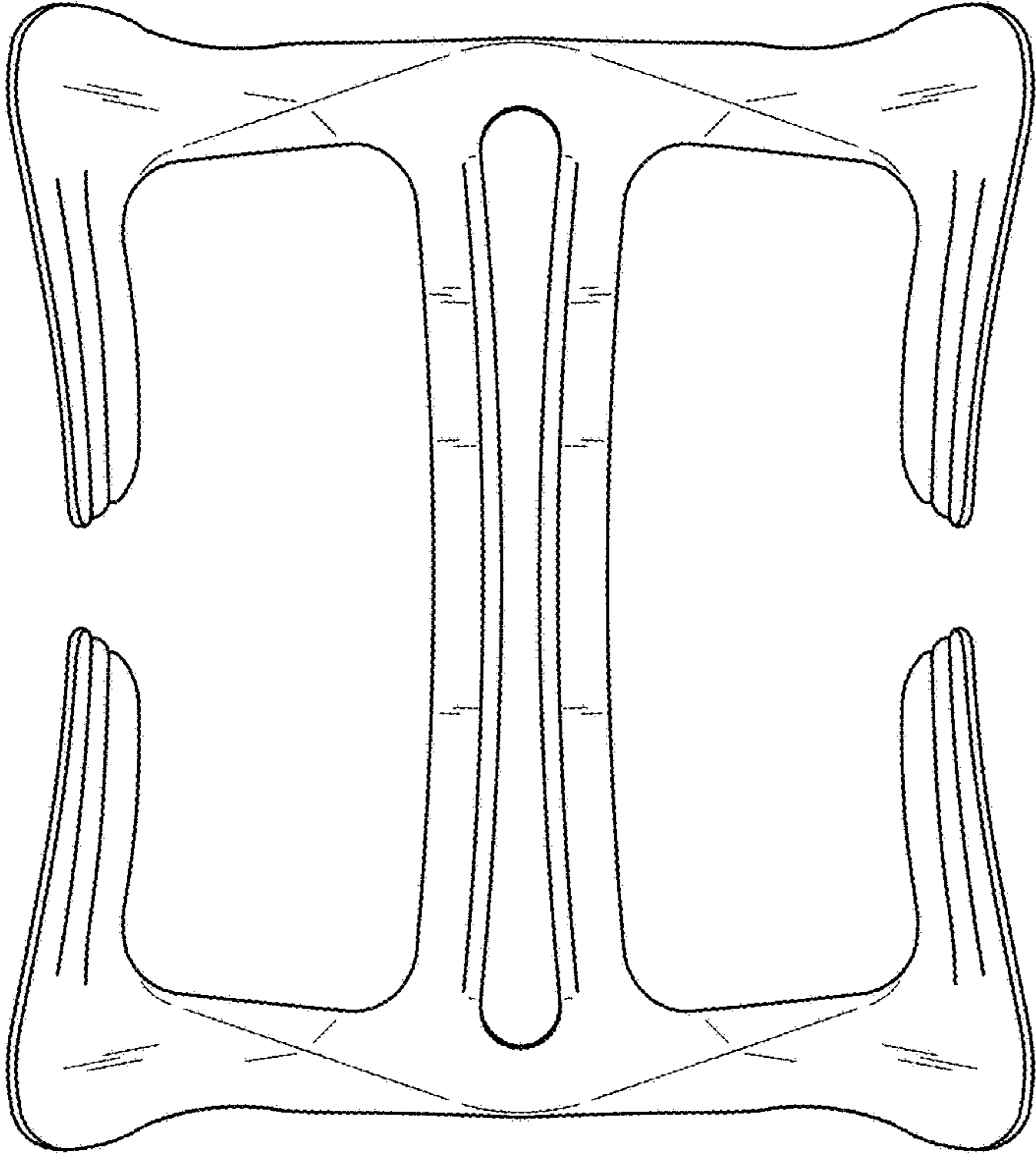

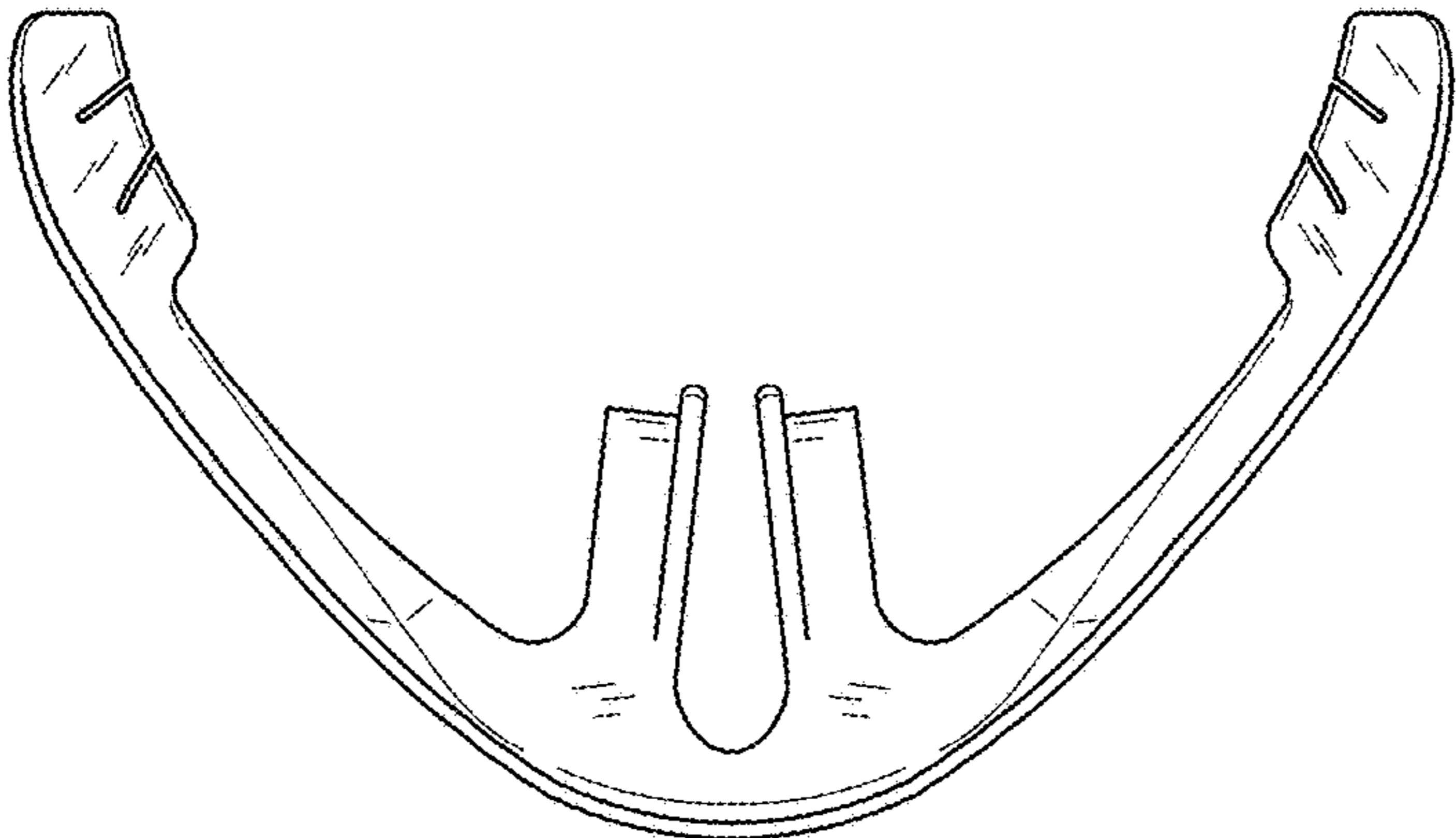
