DESCRIPTION

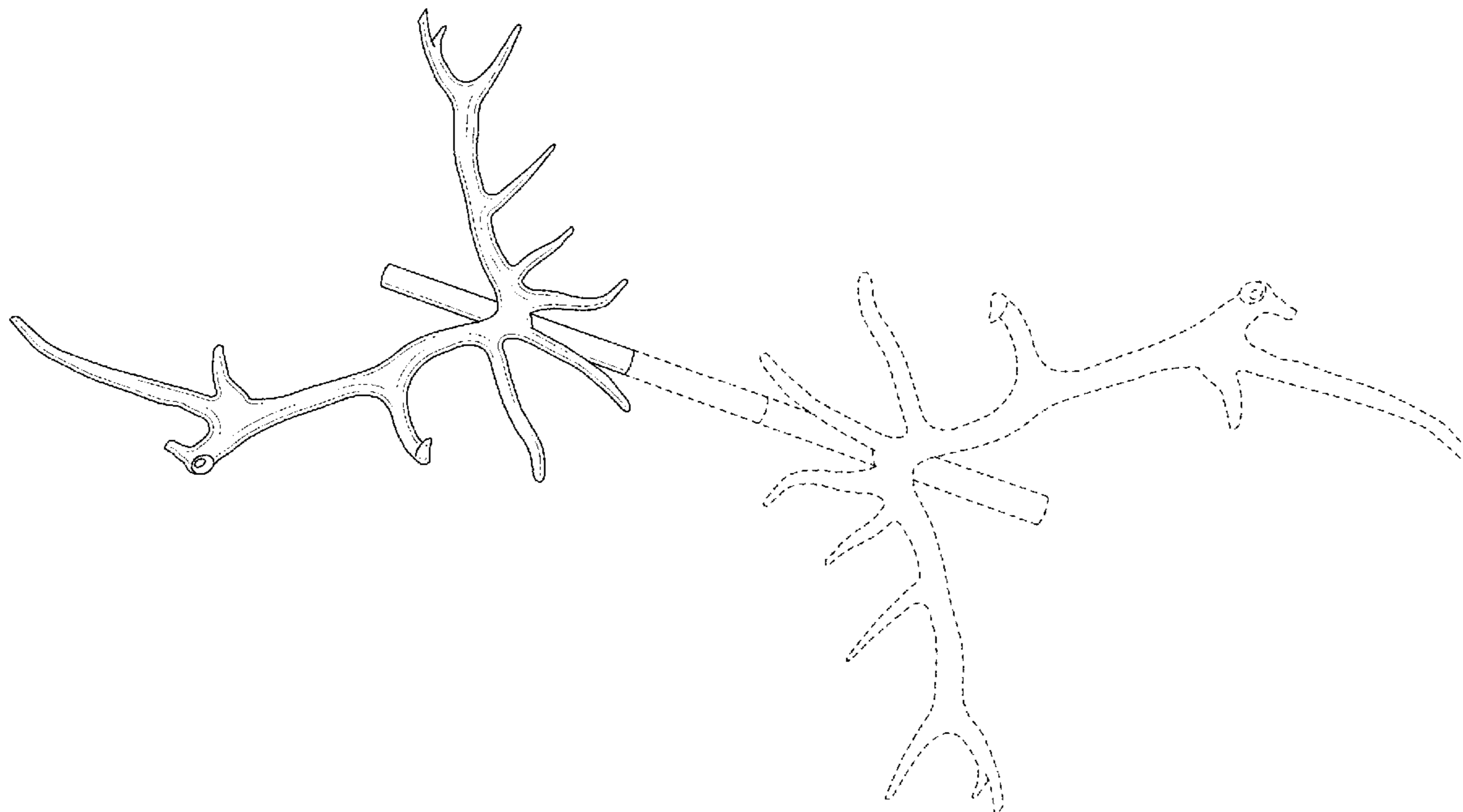
FIG. 1 is a top perspective view of a light fixture showing my new design;

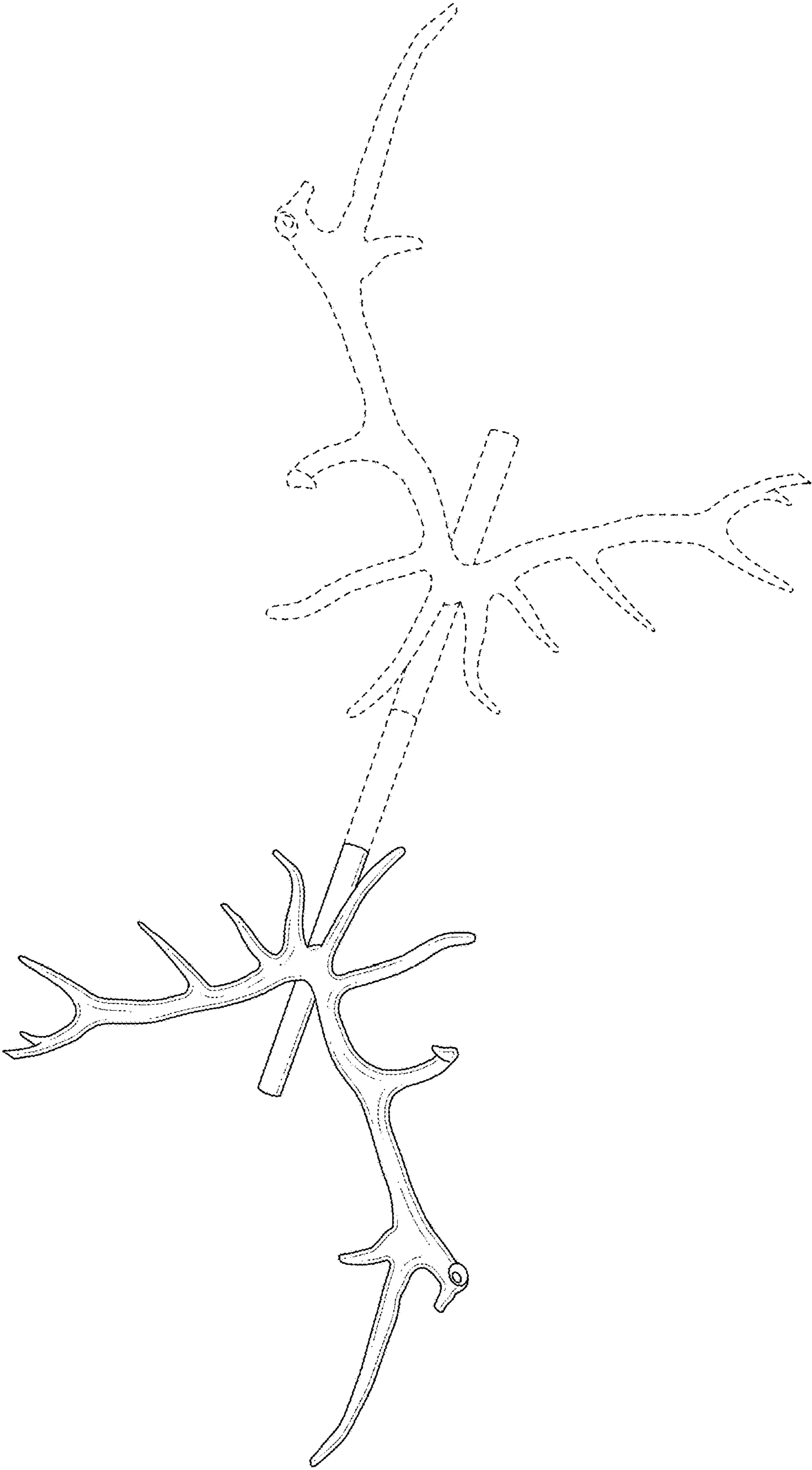

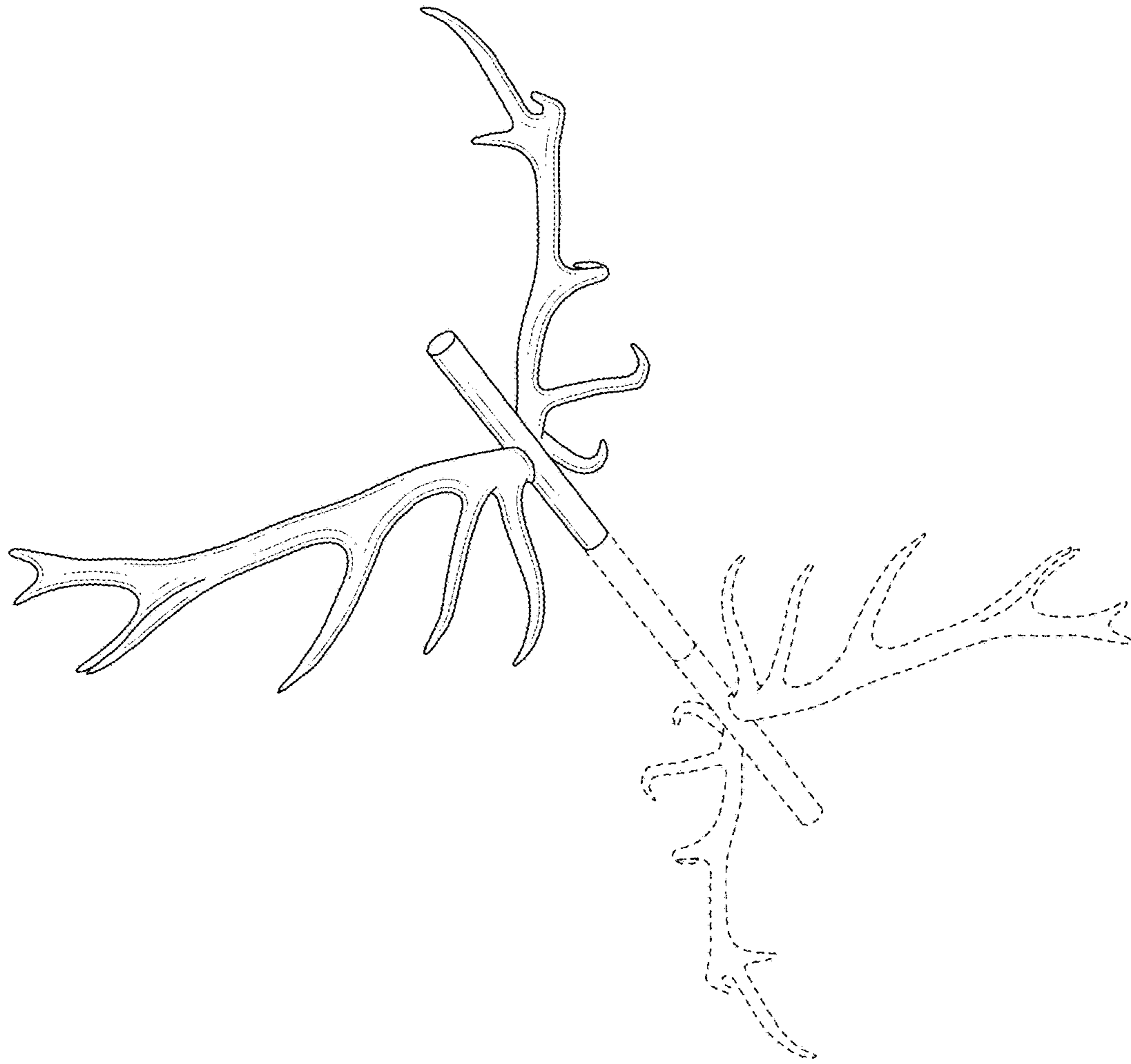

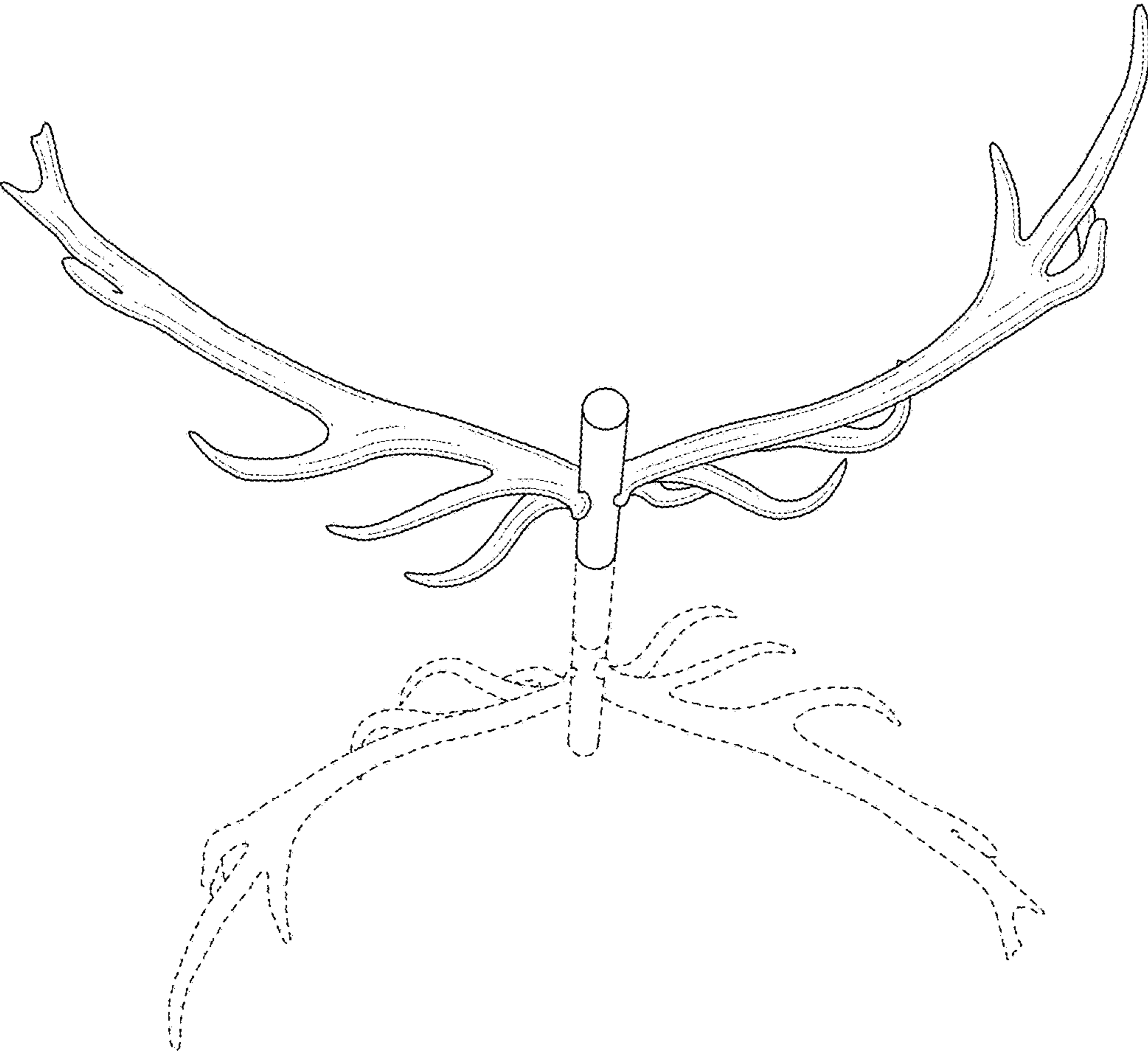
