FIG. 8 is a bottom, rear and left side perspective view thereof.

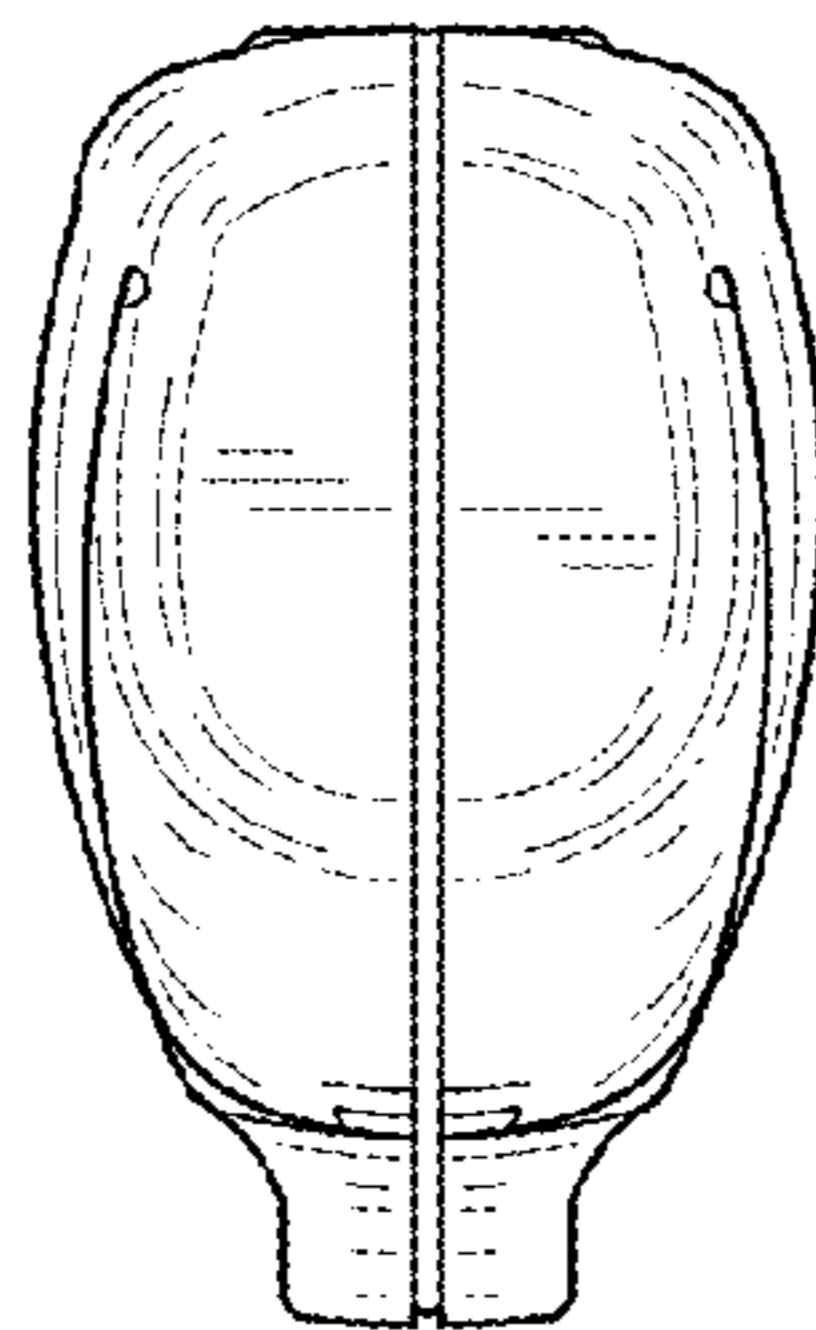

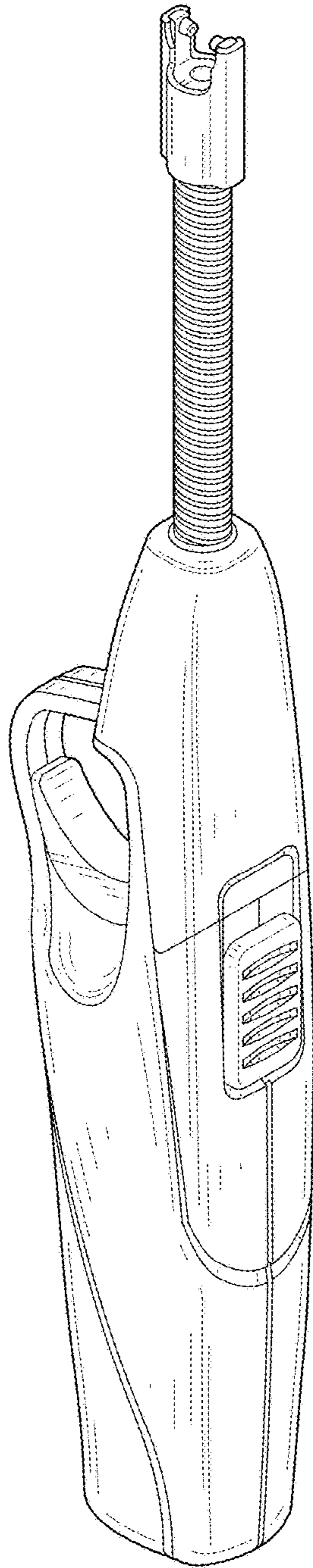

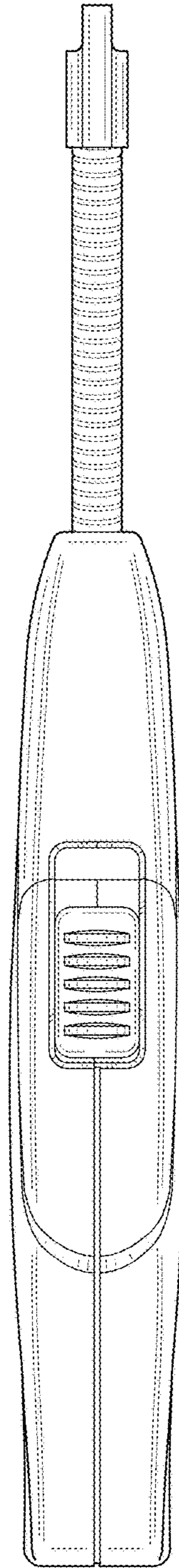

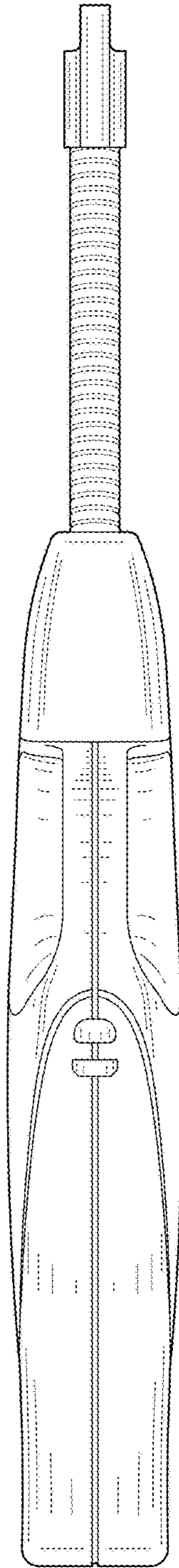

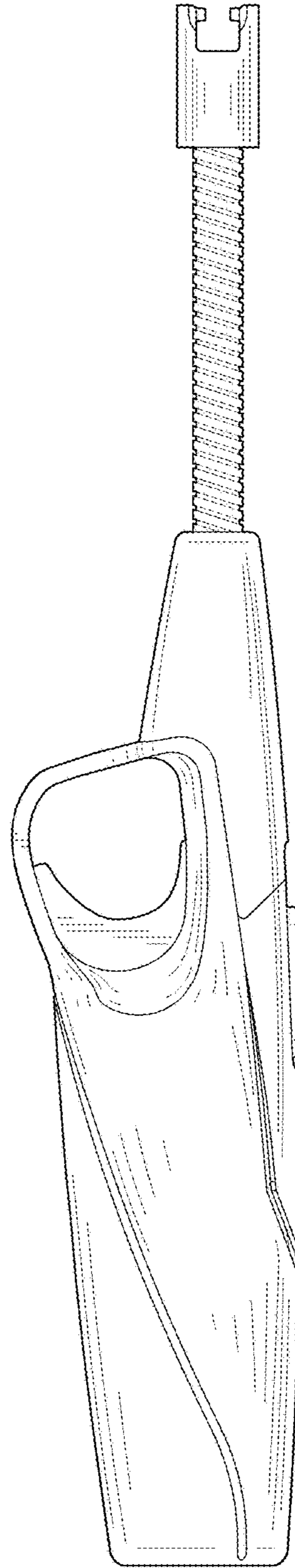

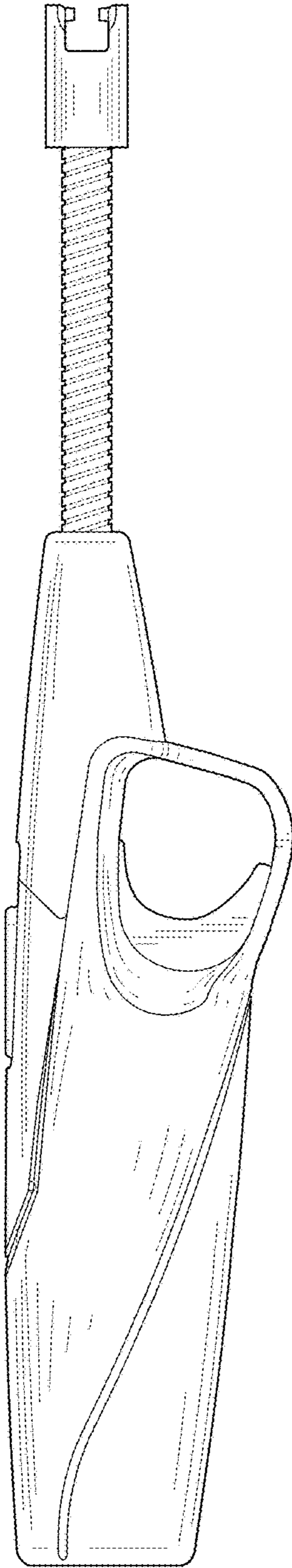

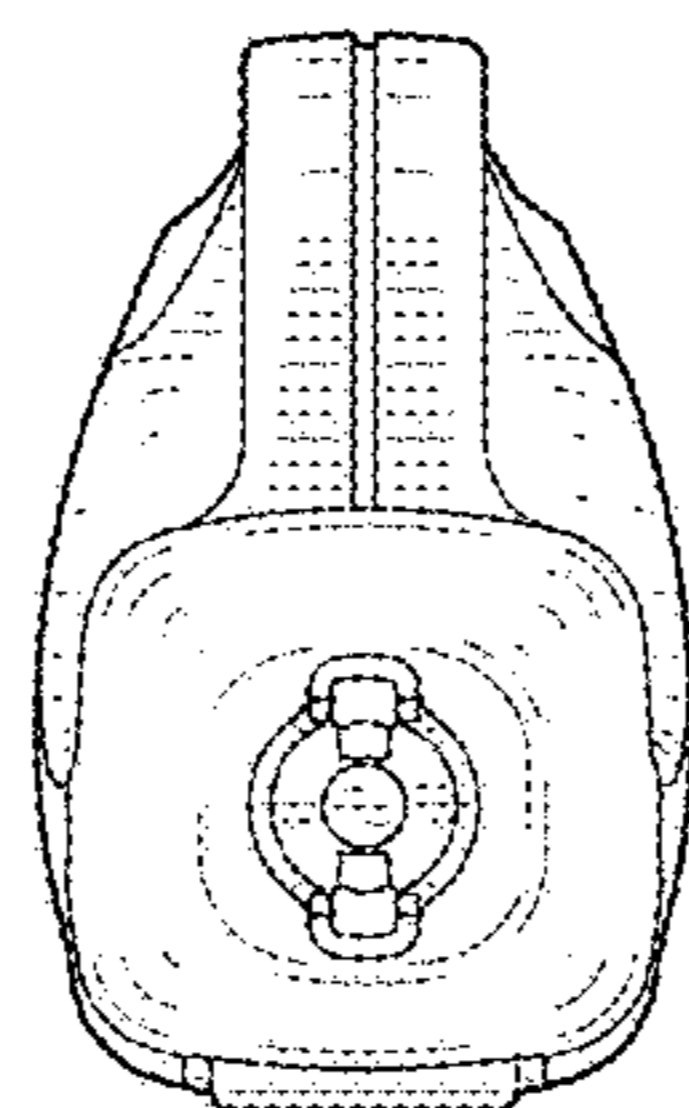

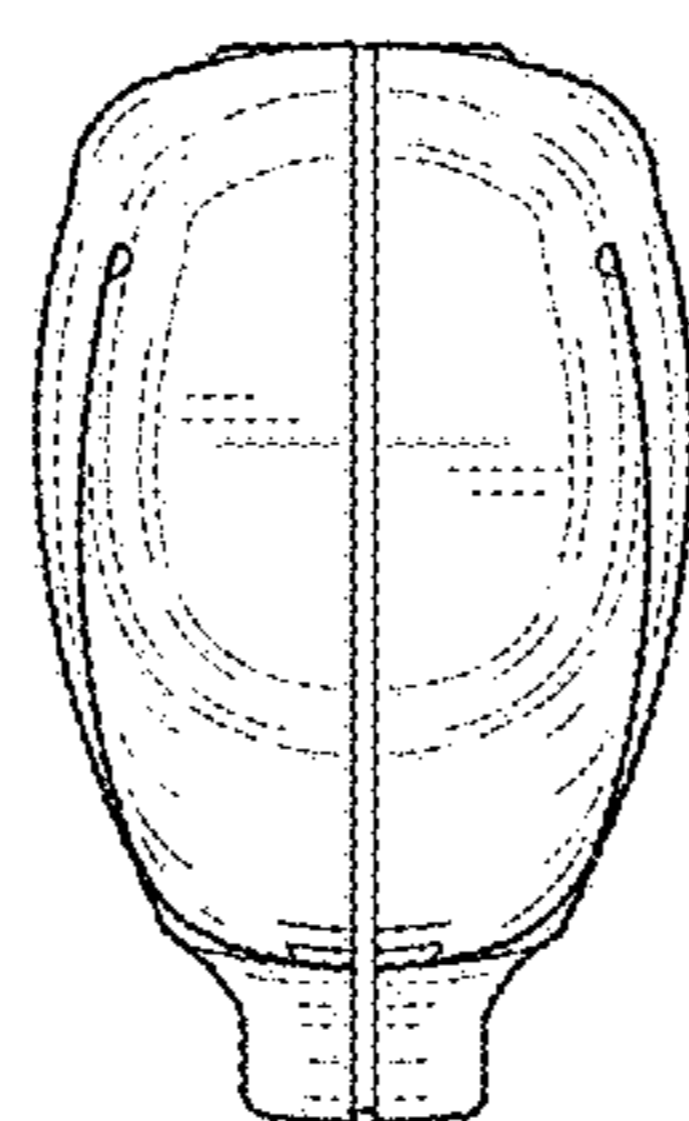

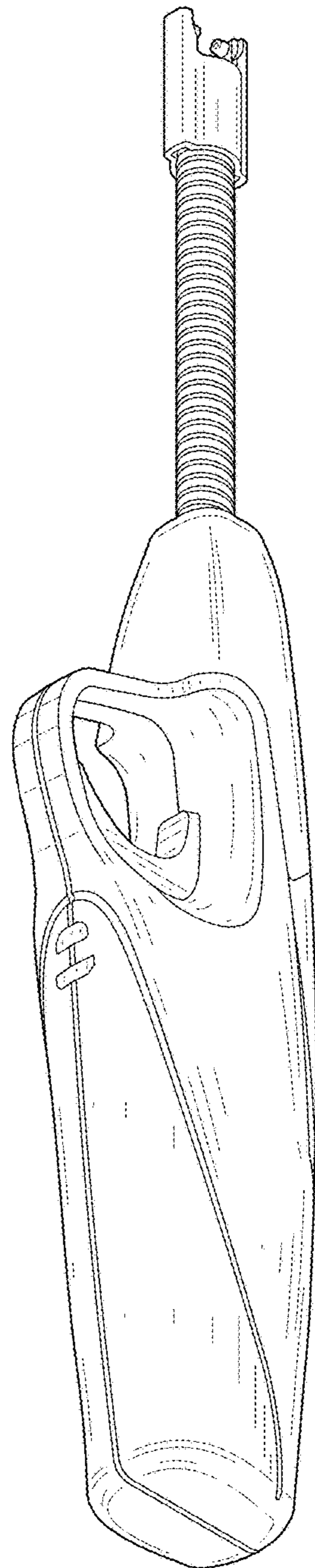
