(57) **CLAIM**

The ornamental design for a swimsuit, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a swimsuit on a model showing the new design according to a first embodiment of the present invention.

FIG. 2 is a rear view thereof.

FIG. 3 is a left-side view thereof.

FIG. 4 is a right-side view thereof.

FIG. 5 is a front view of a swimsuit on a model showing the new design according to a second embodiment of the present invention.

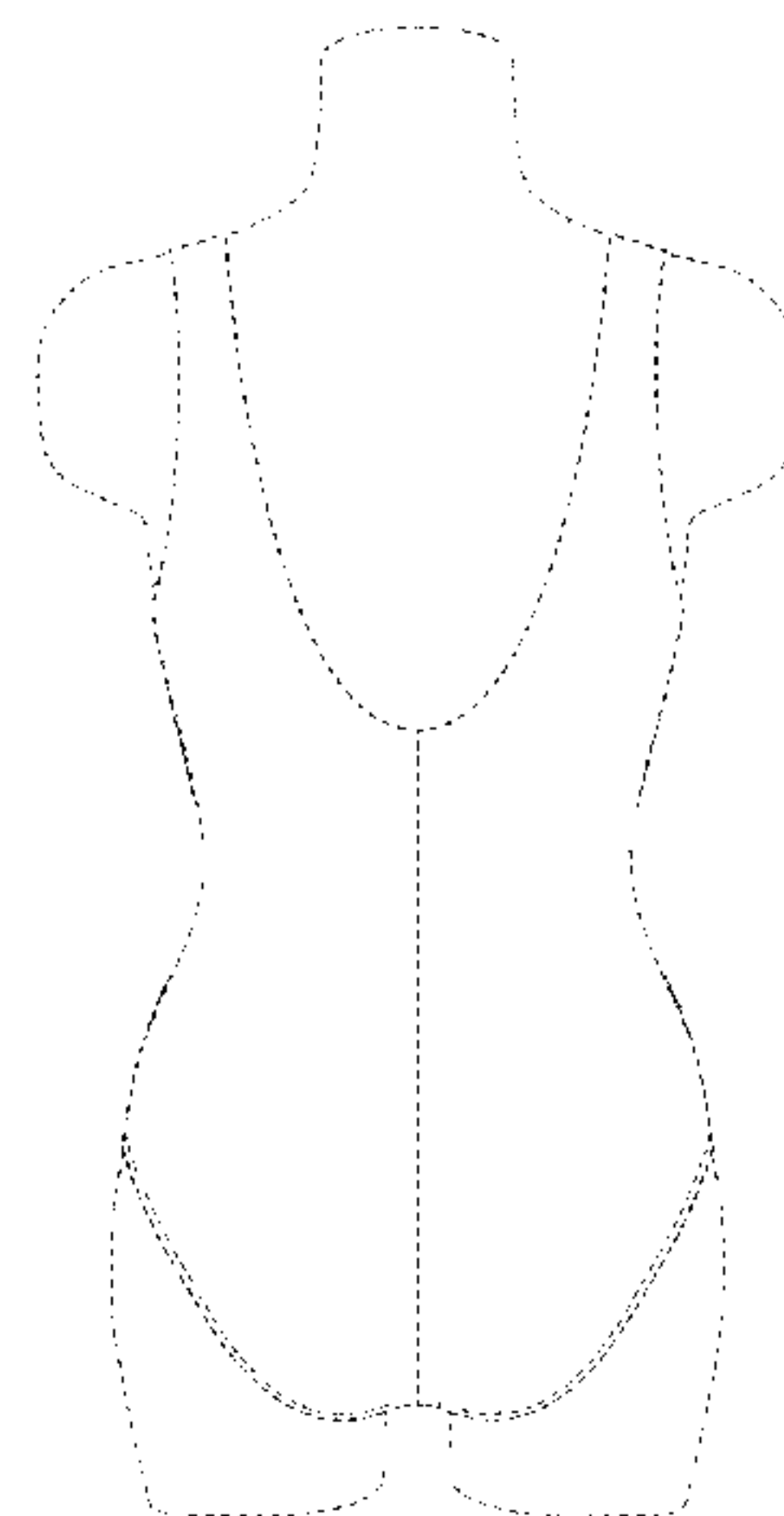
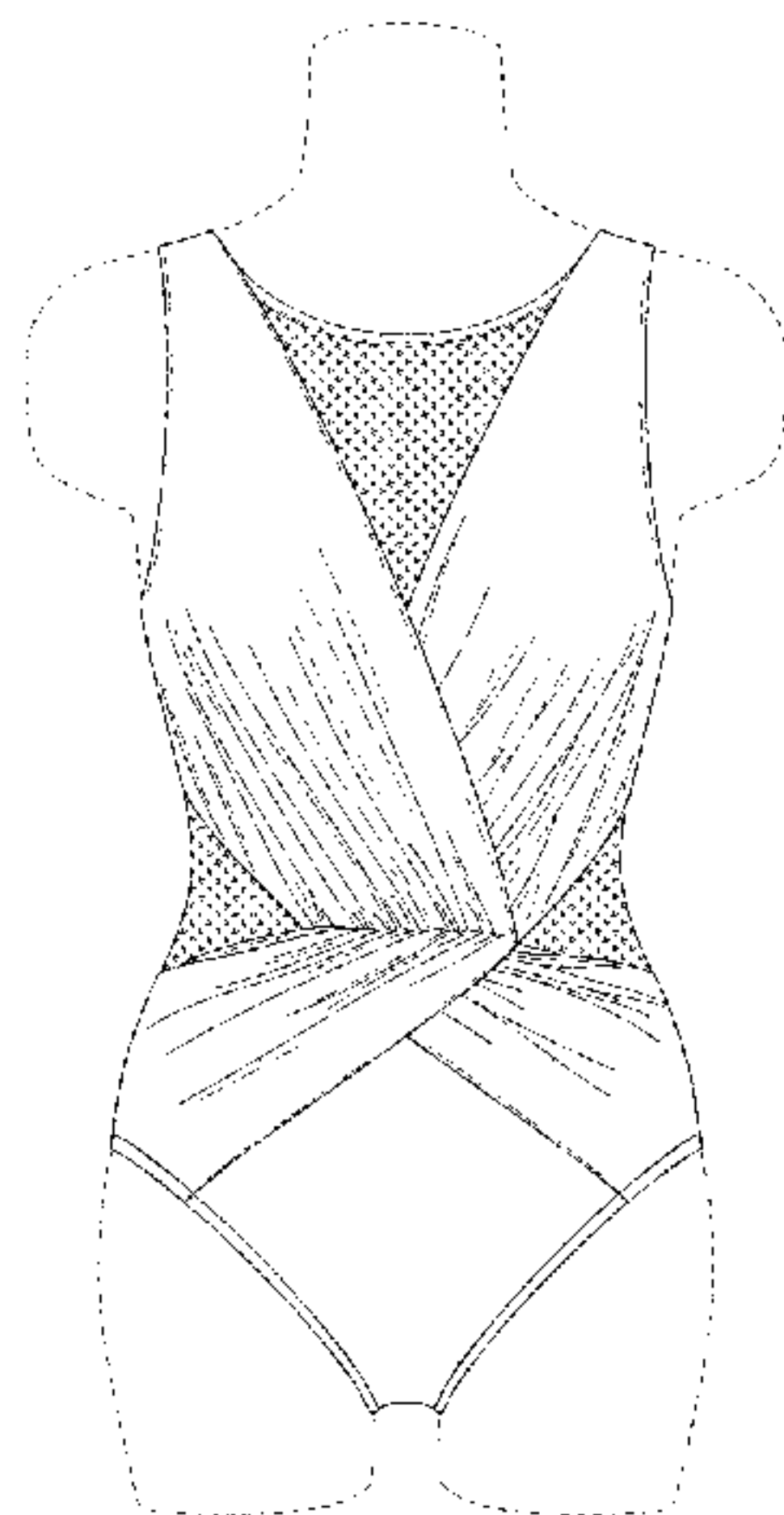
FIG. 6 is a rear view thereof.

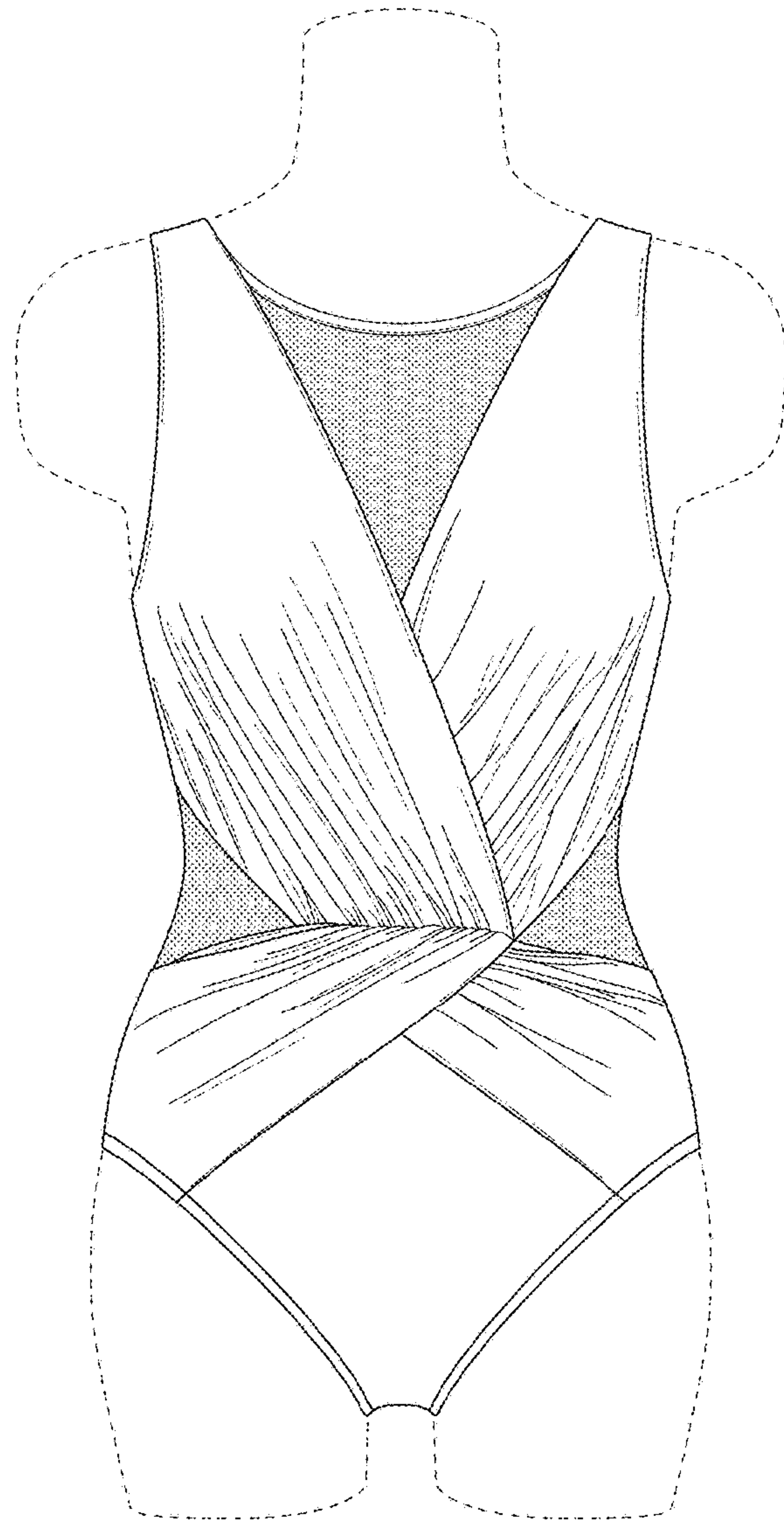

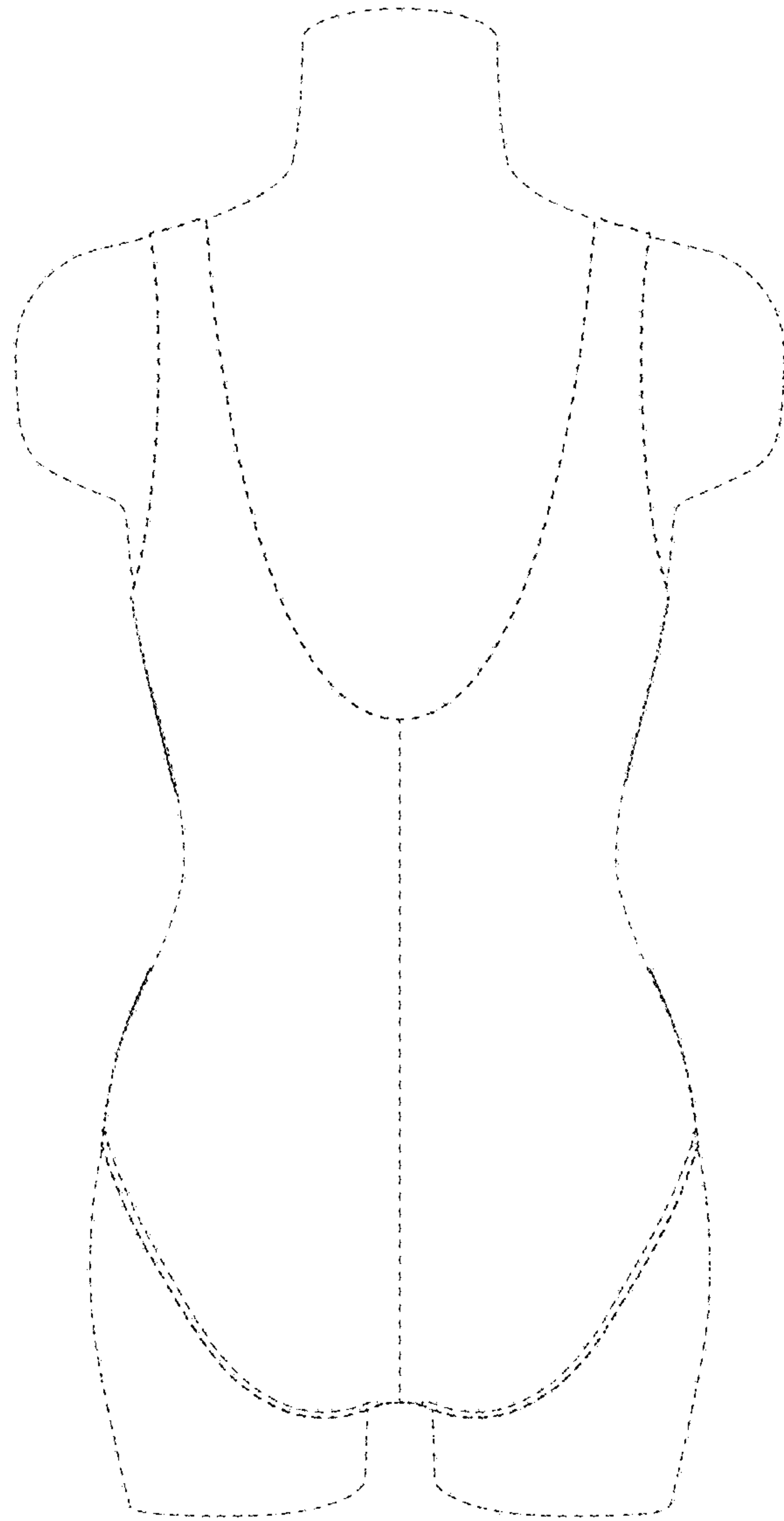

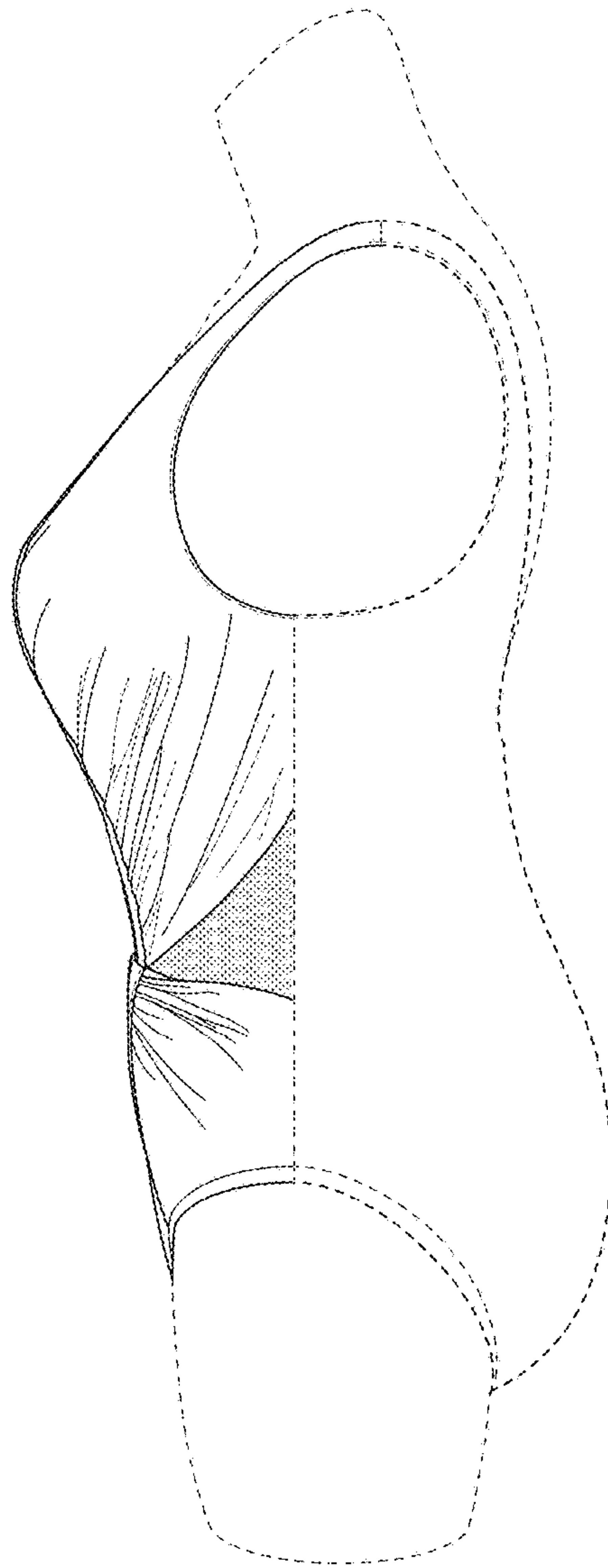

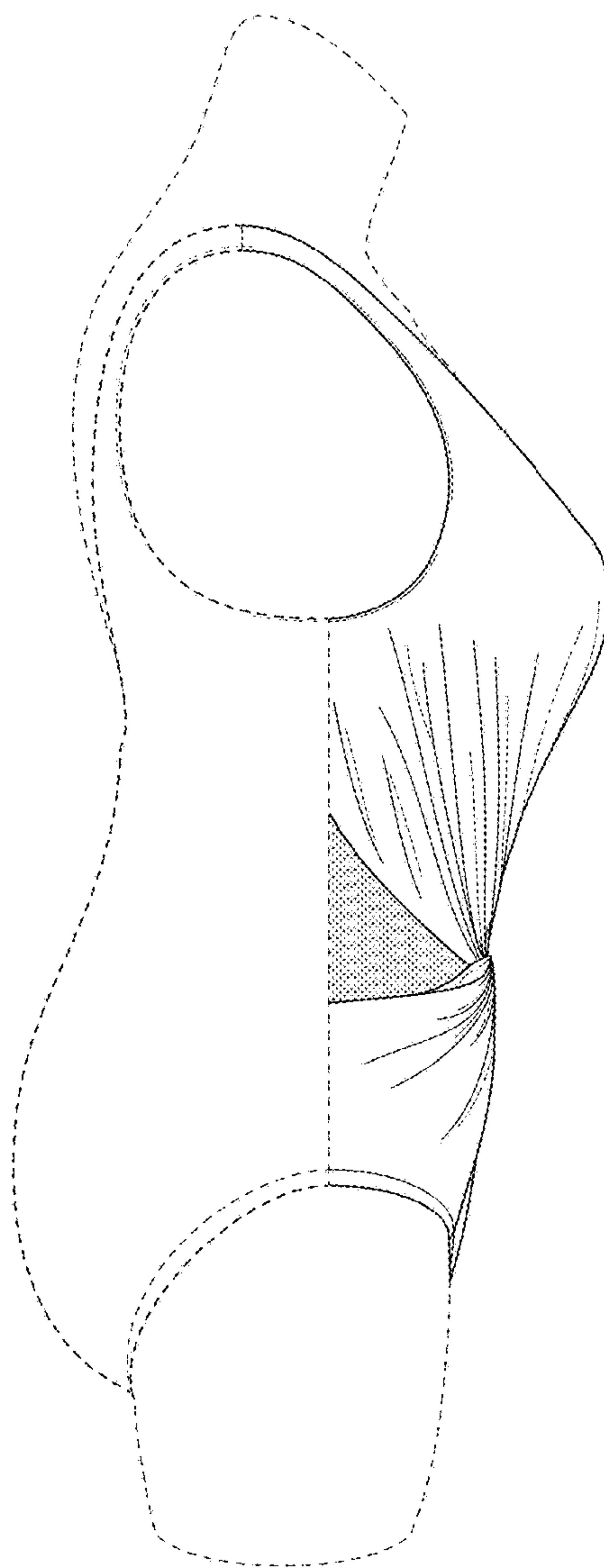

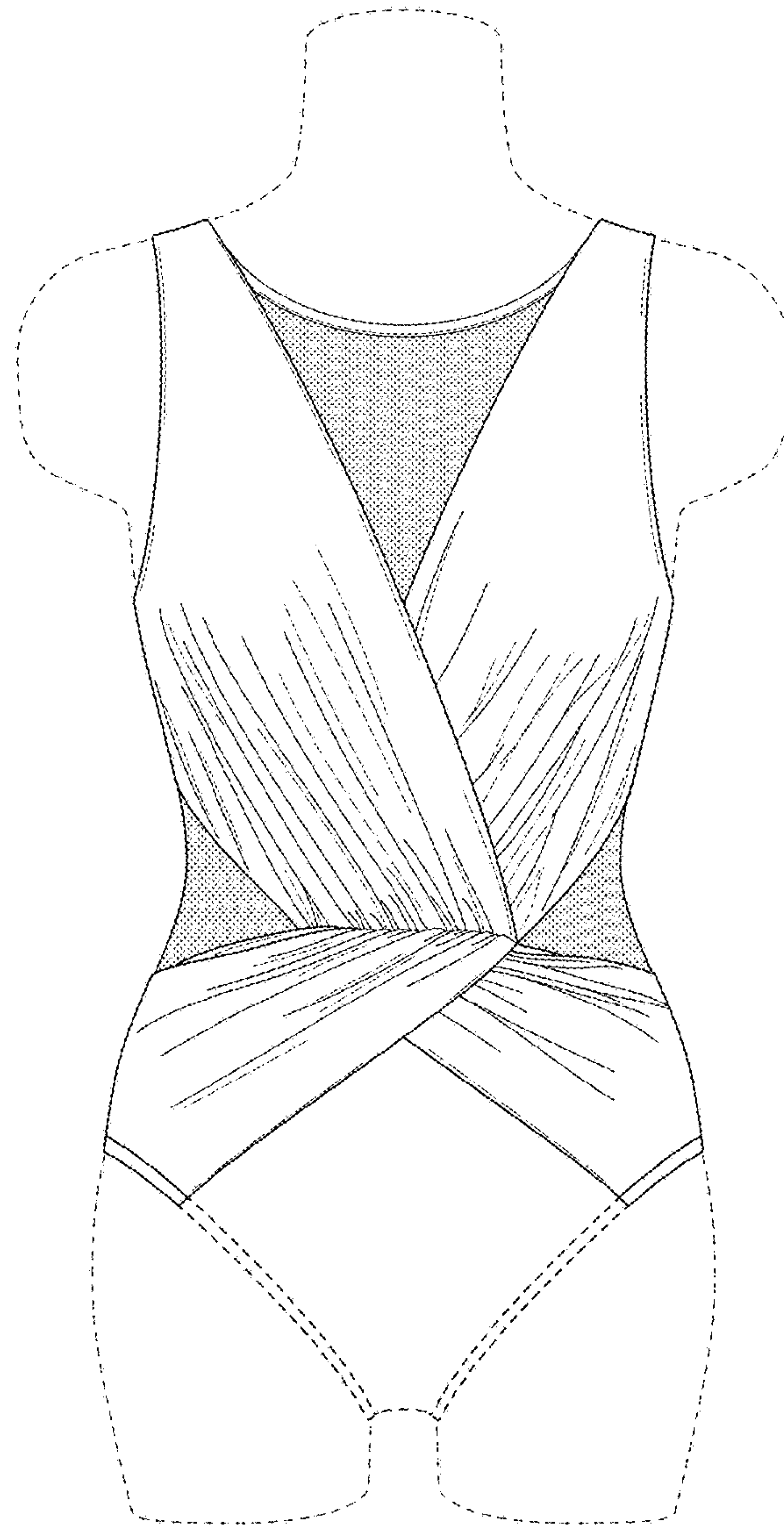

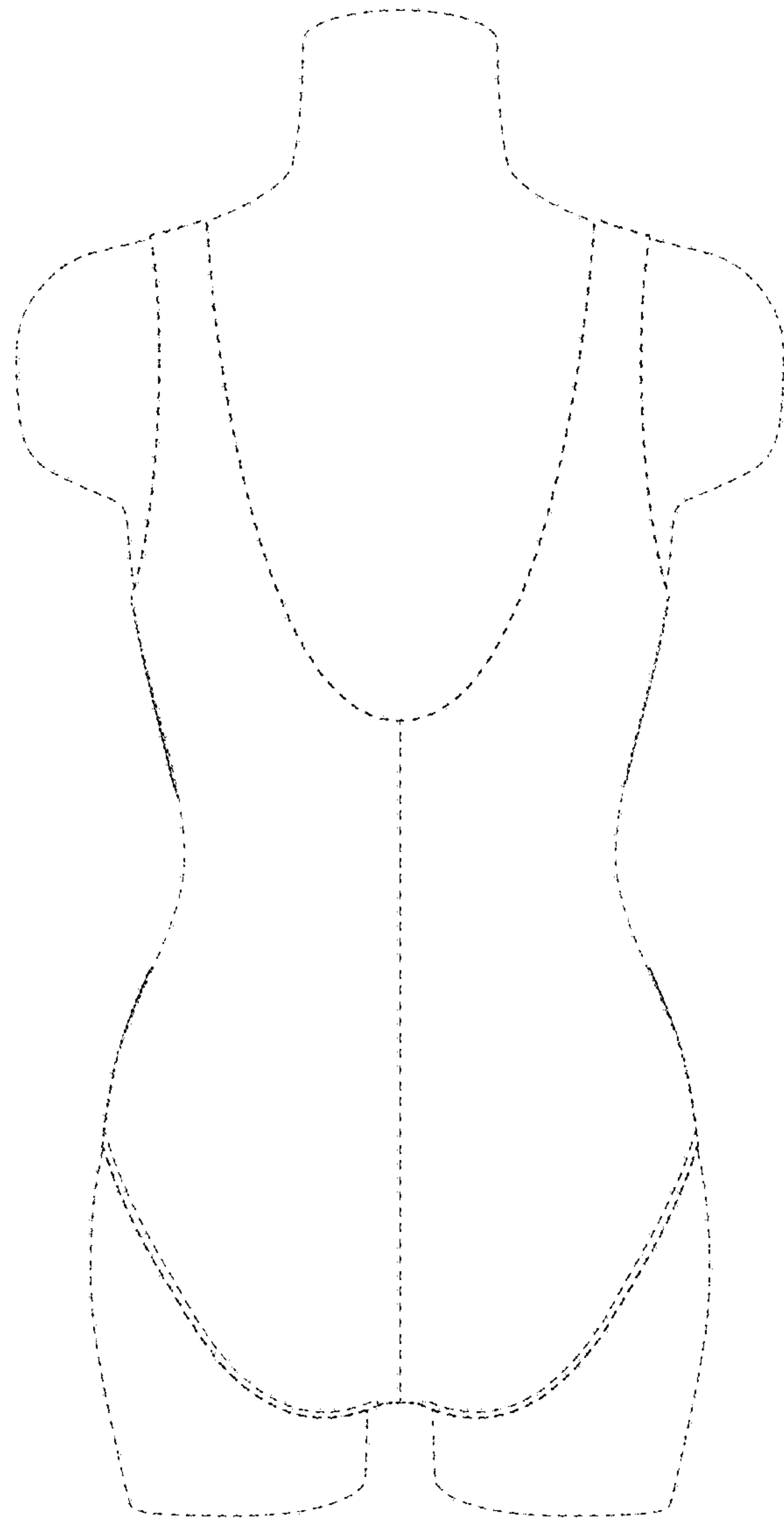

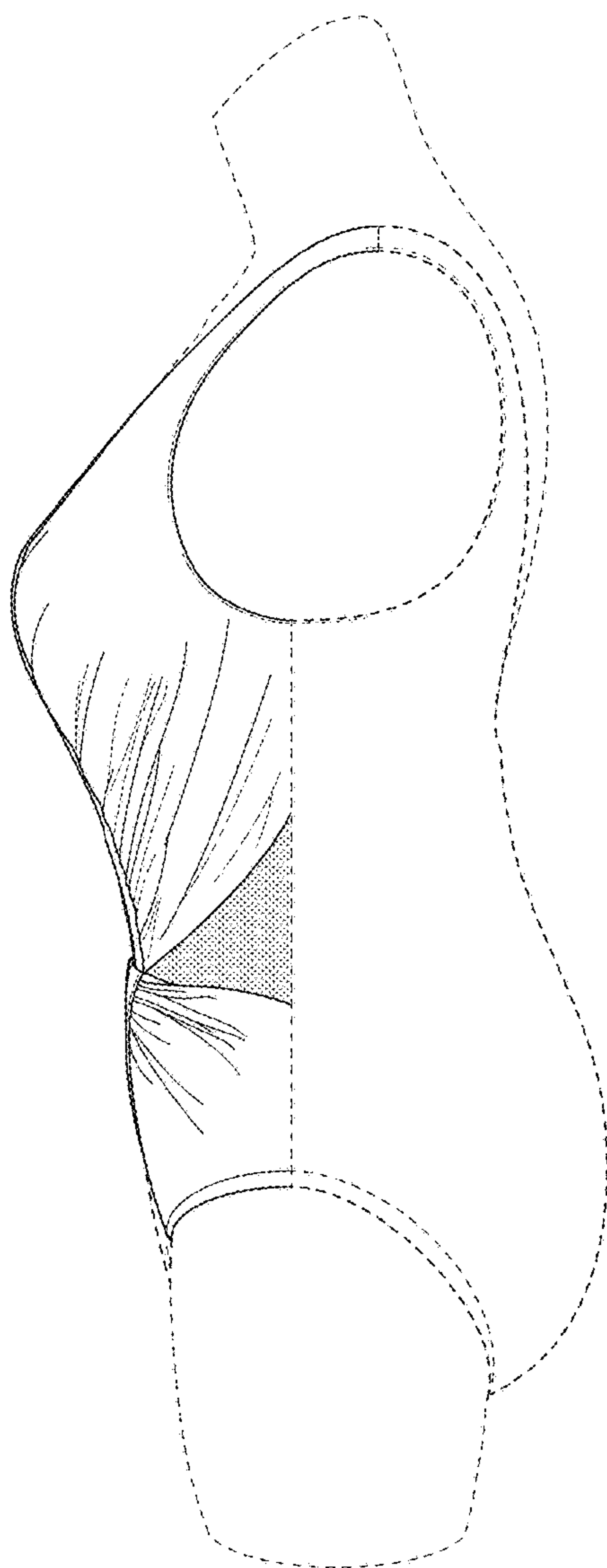

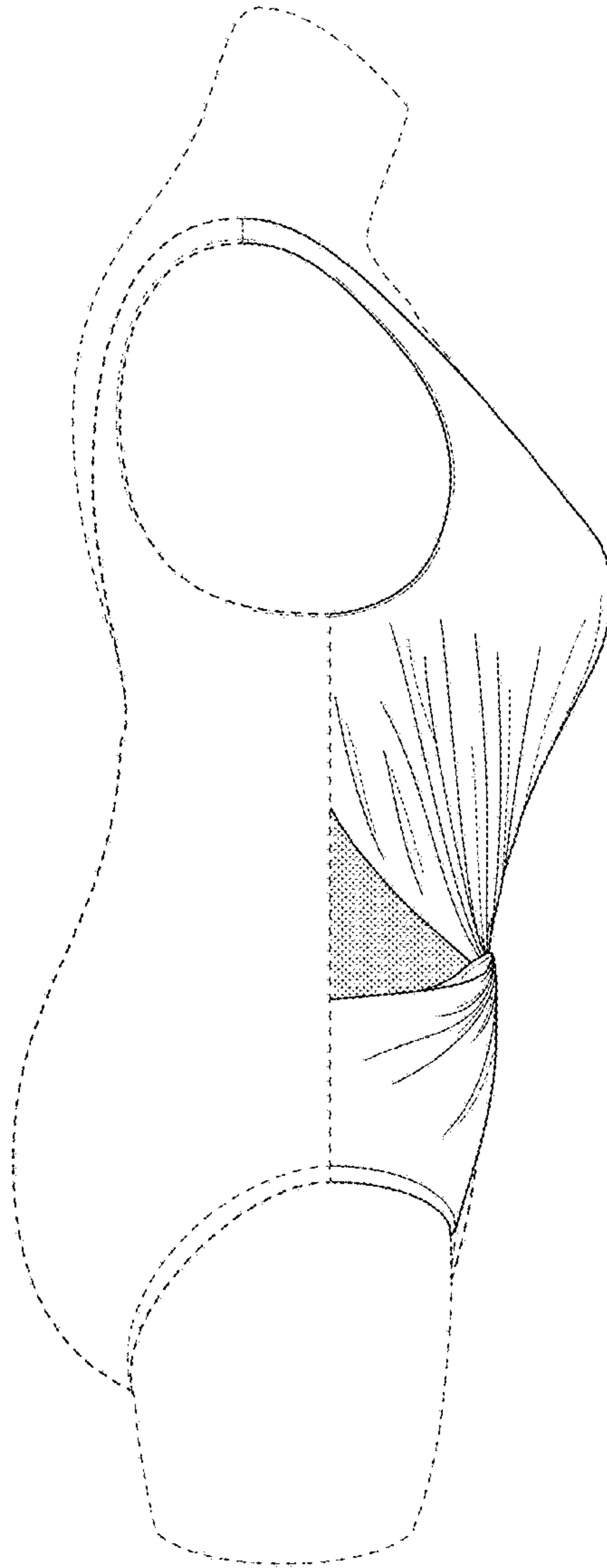
