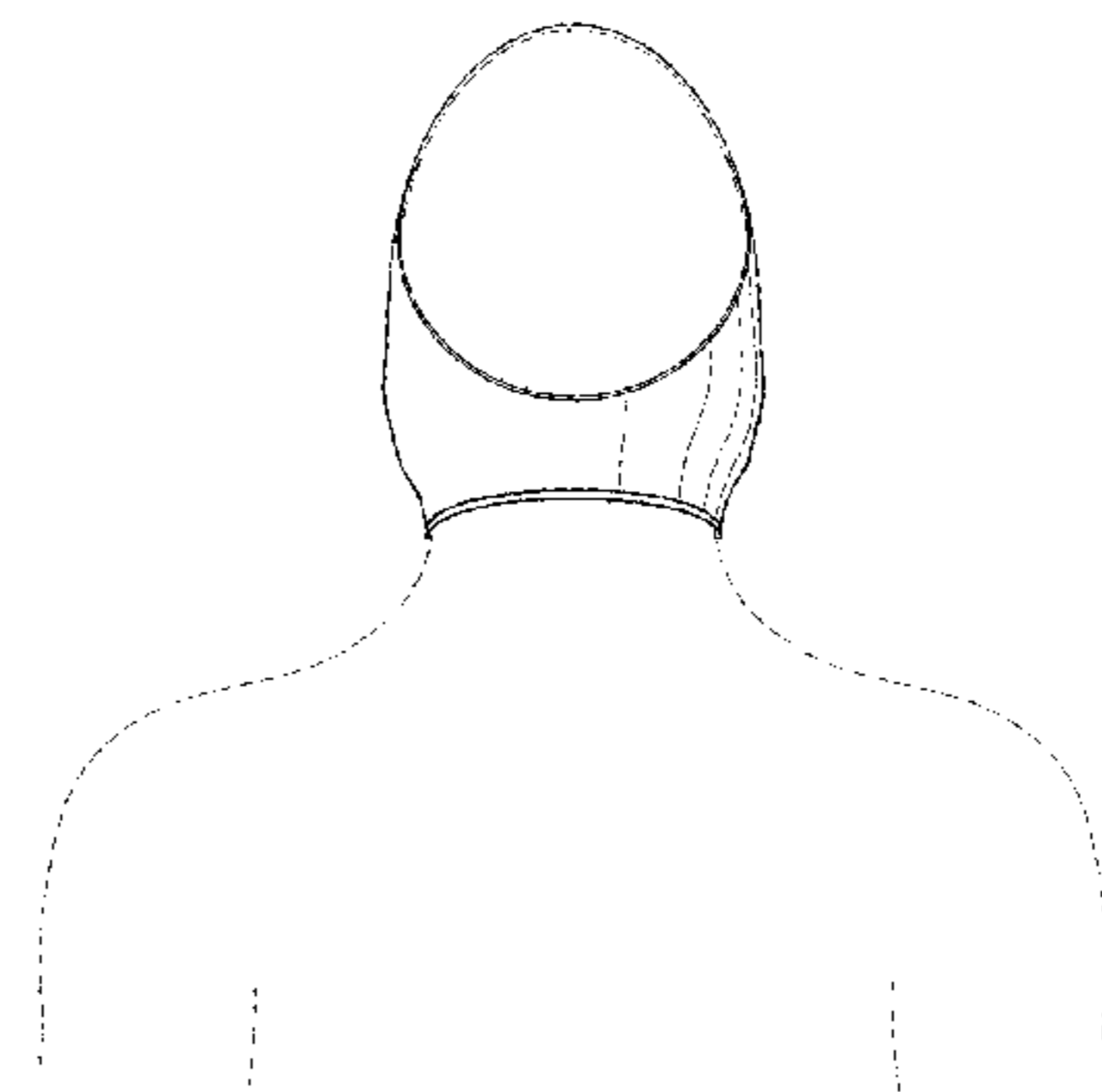
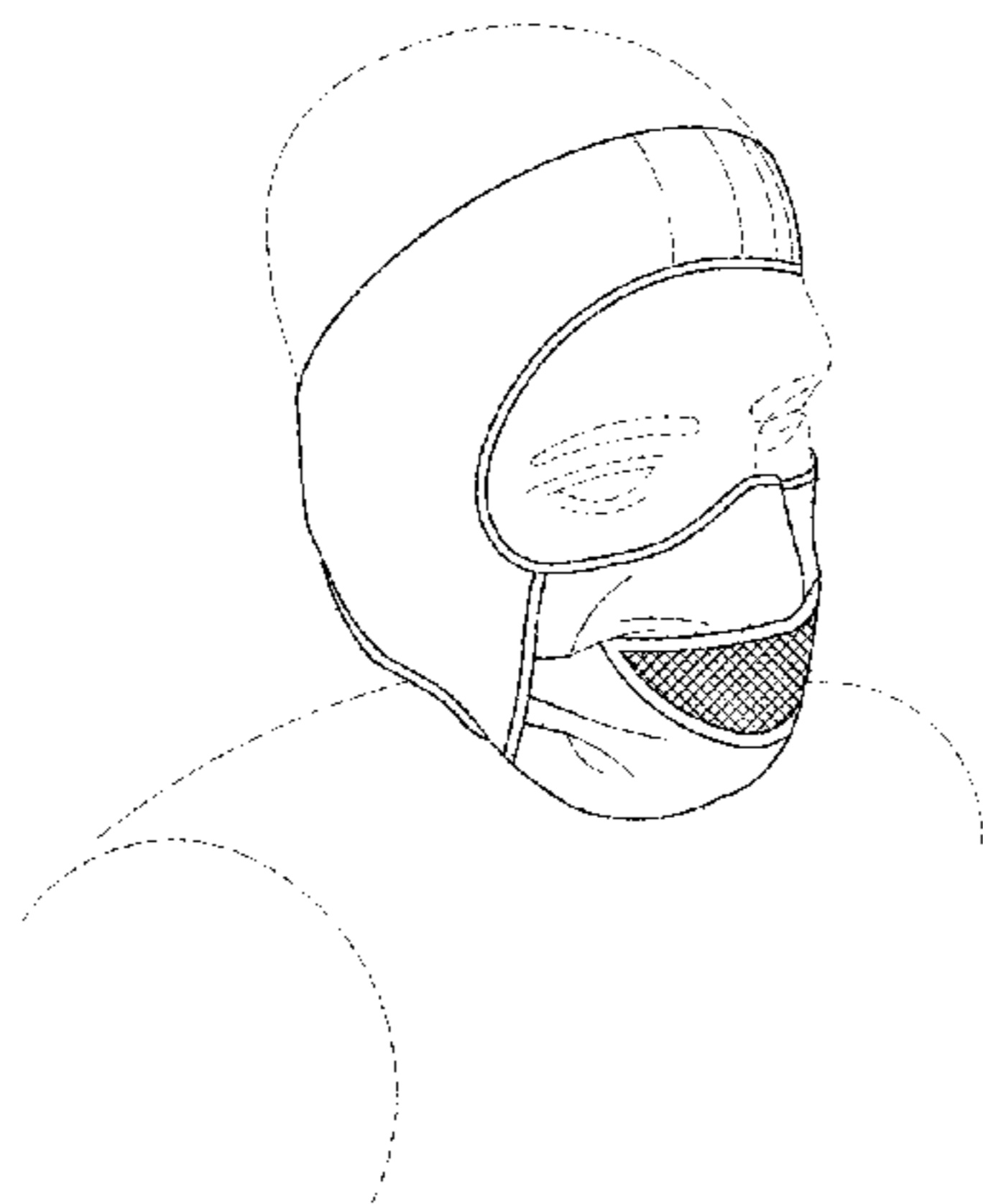
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a face mask;
FIG. 2 is a top plan view of the face mask of FIG. 1;
FIG. 3 is a front view of the face mask of FIG. 1;
FIG. 4 is a rear view of the face mask of FIG. 1;
FIG. 5 is a side view of the face mask of FIG. 1; and,

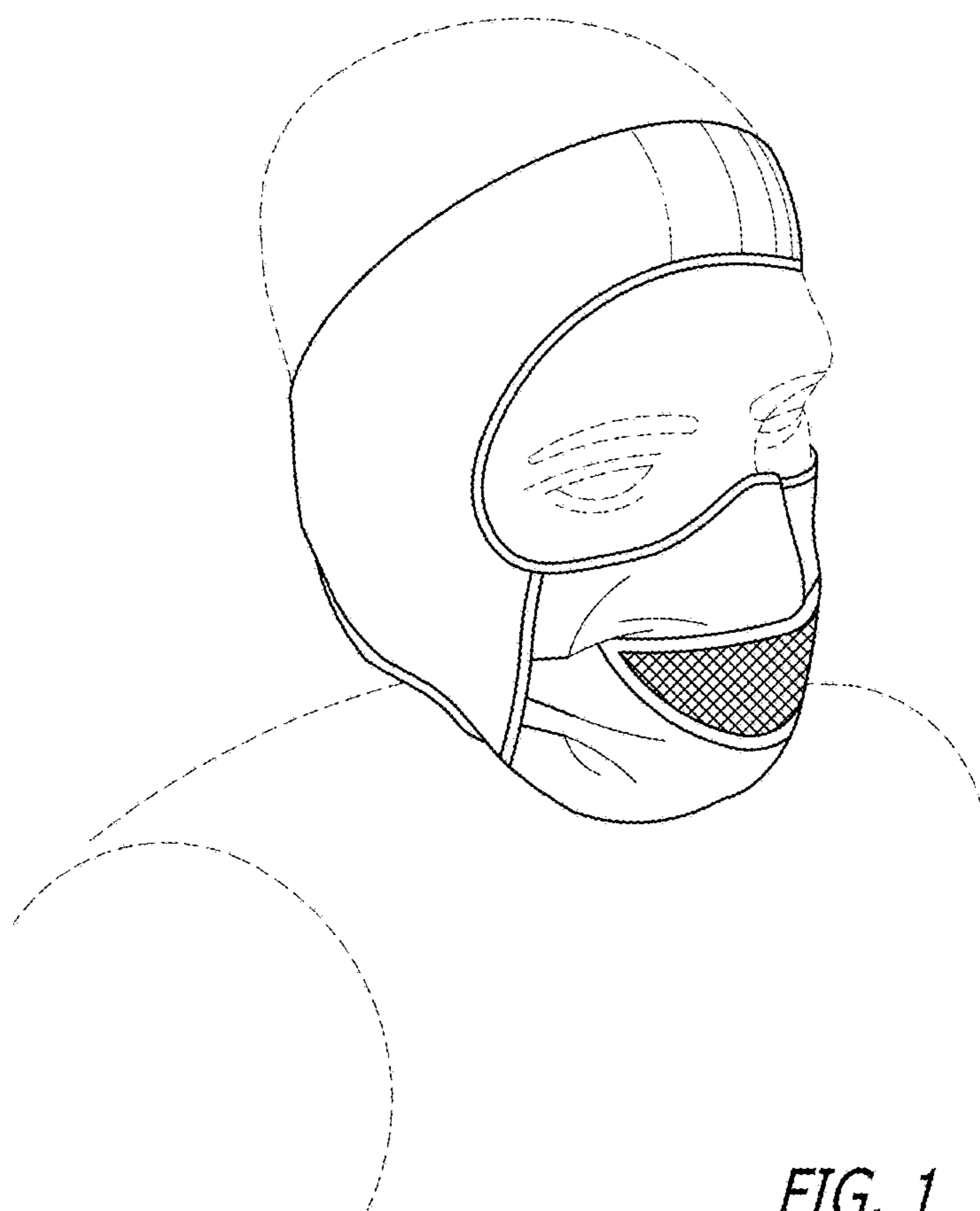

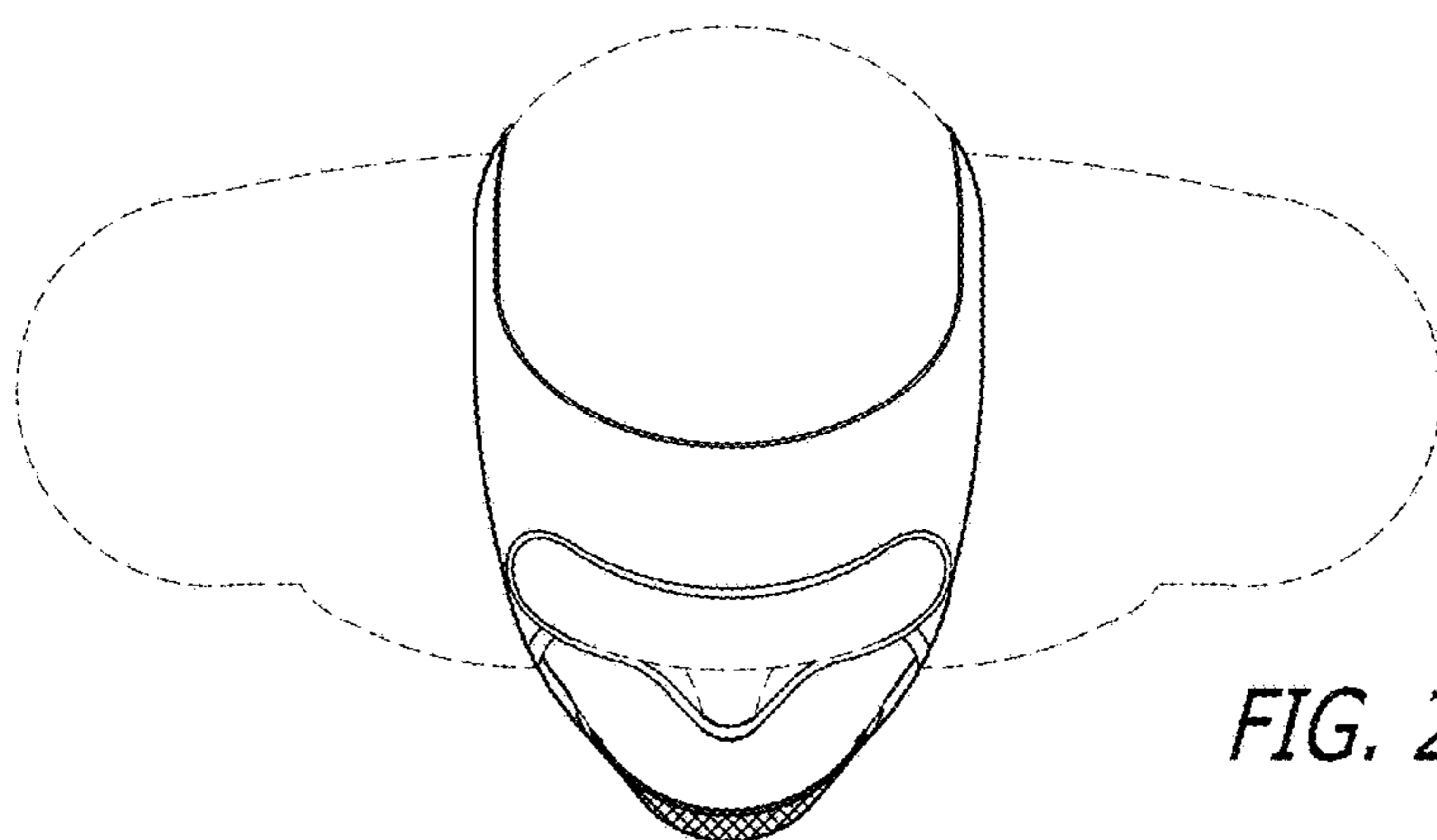

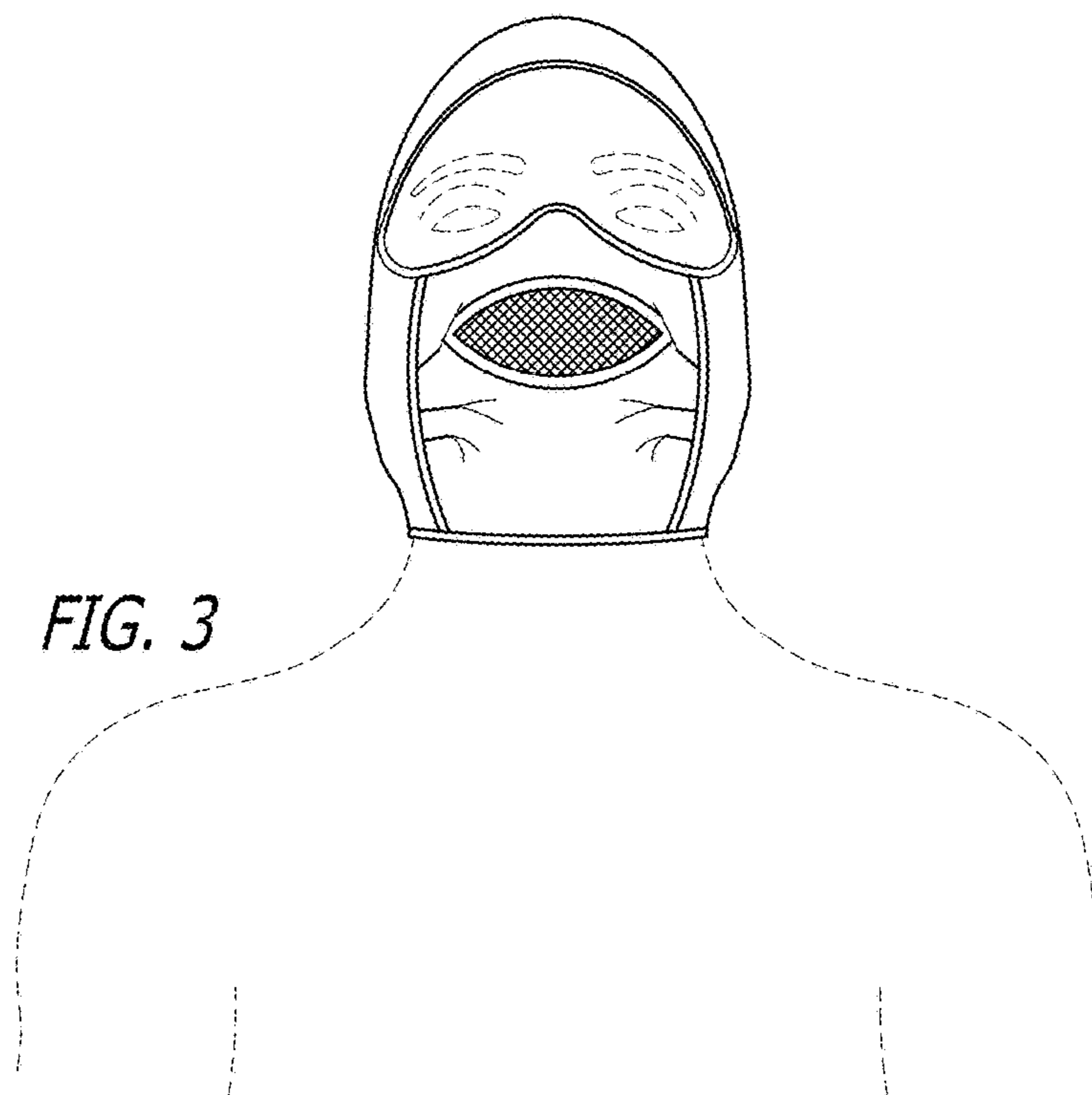

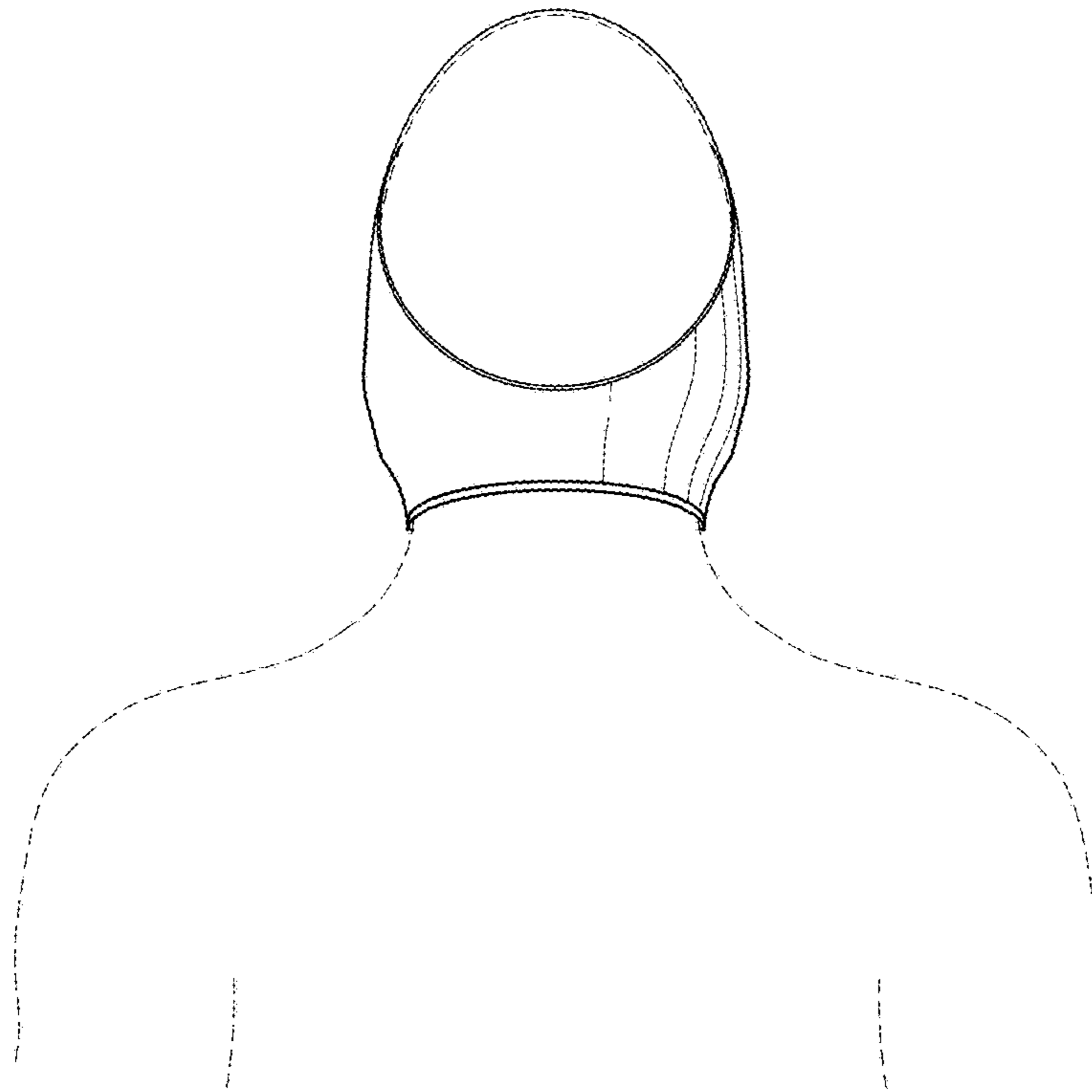

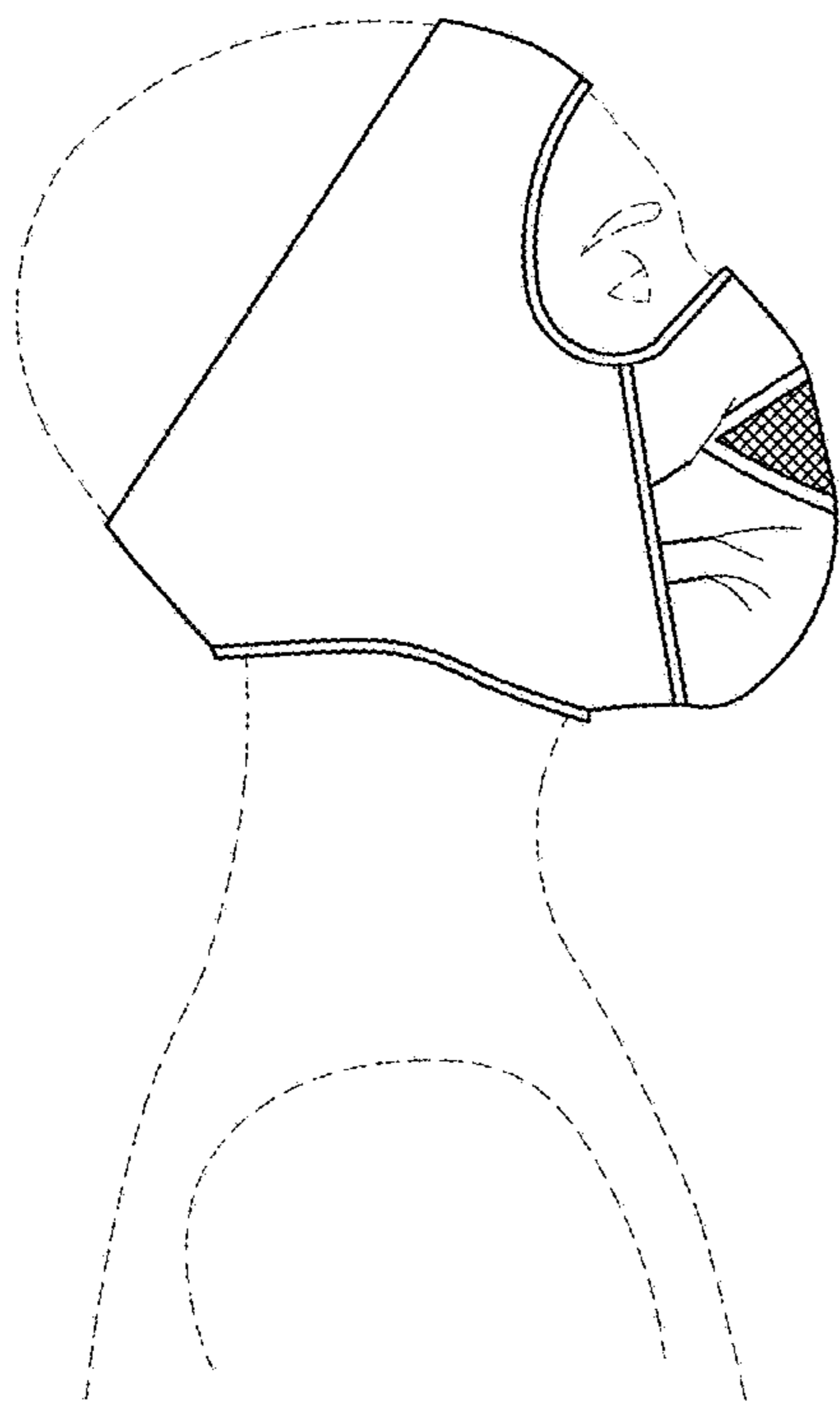

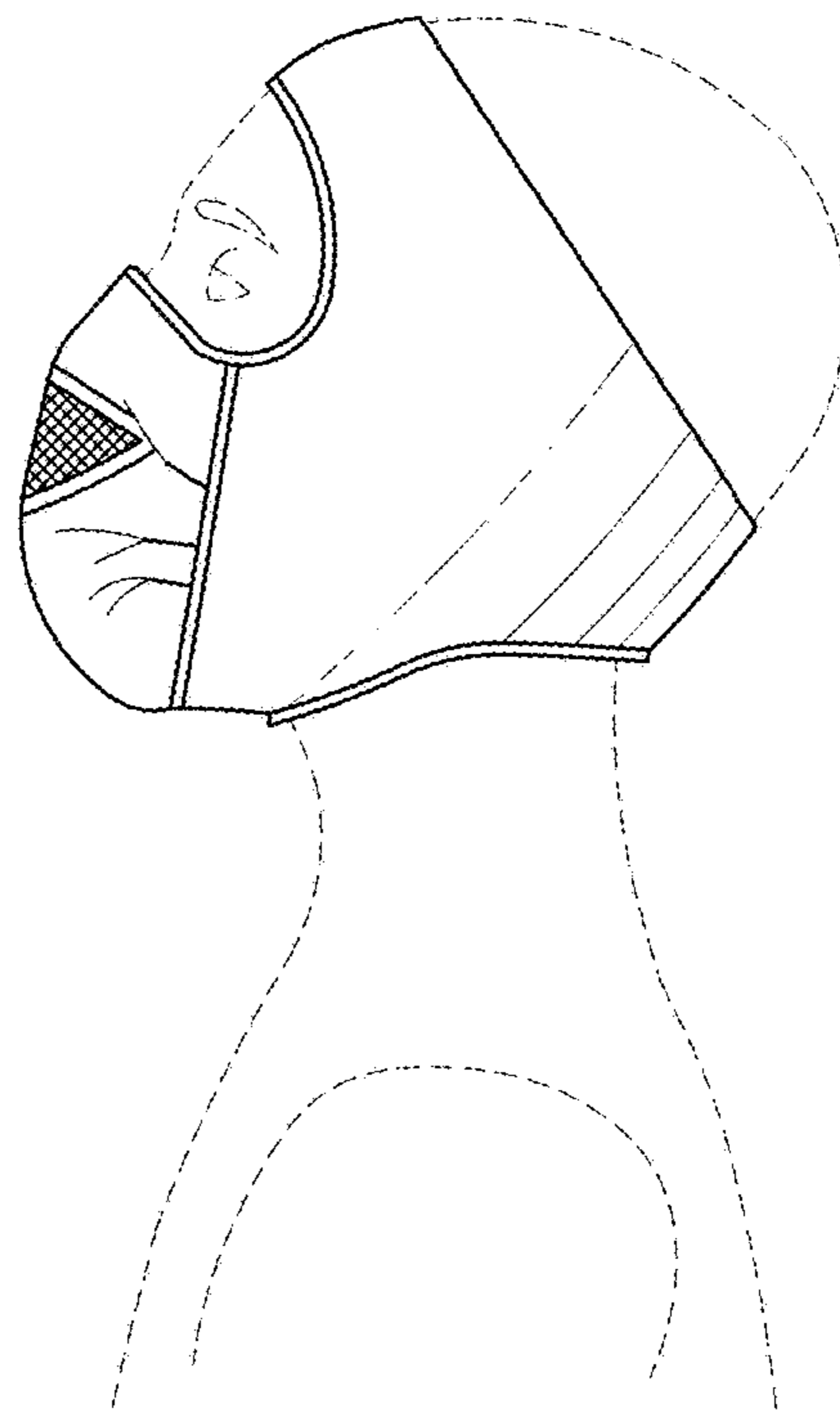
