**DESCRIPTION**

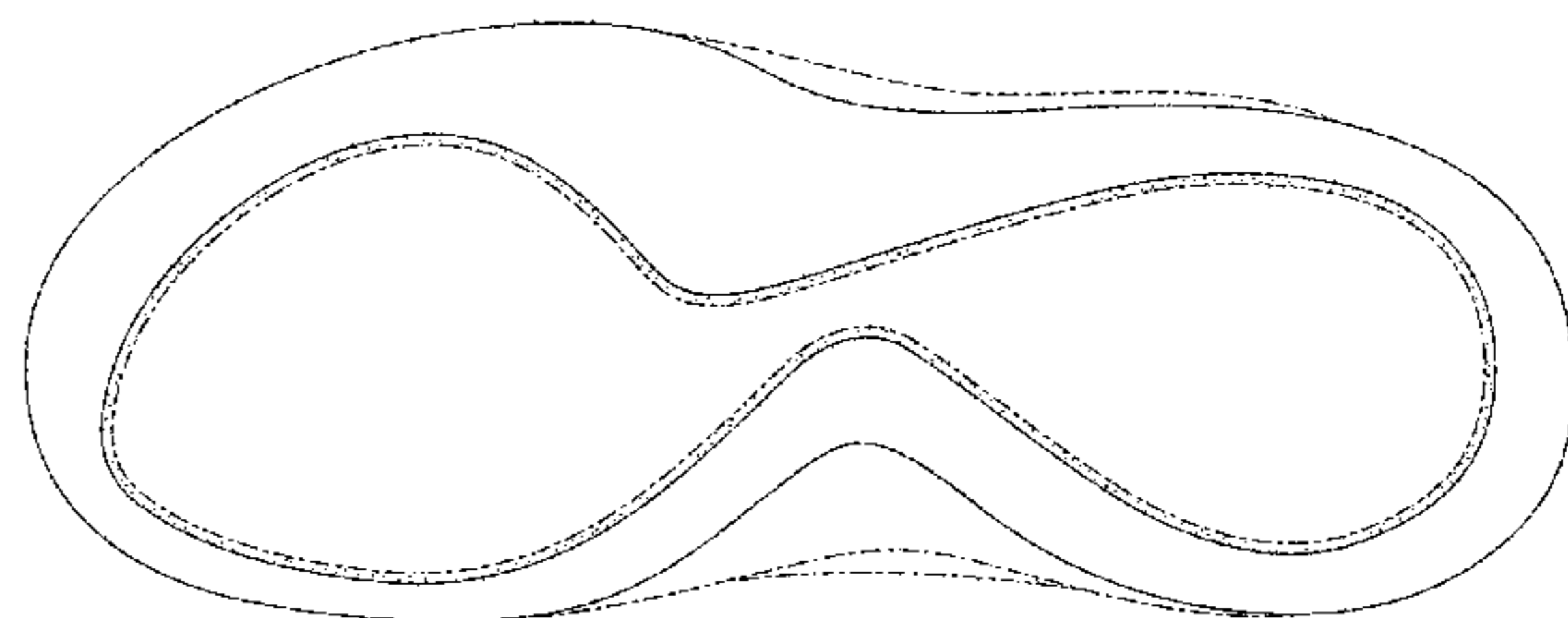
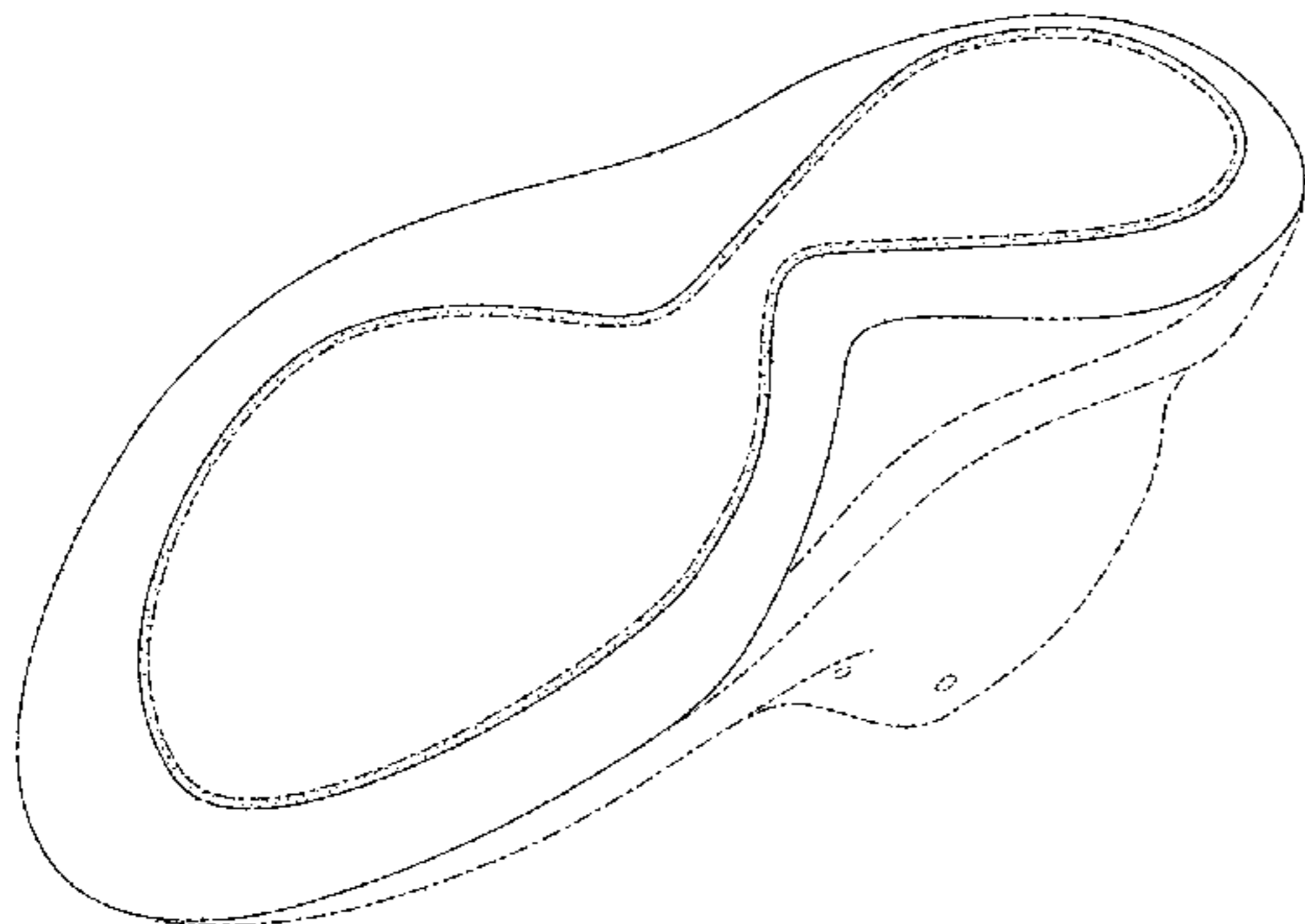
FIG. 1 is a front perspective view of a shoe showing our new design;

FIG. 2 is a bottom view thereof; and,

FIG. 3 is a rear perspective view thereof.

The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The unshaded region within the shaded area that is demarcated by a broken line forms no part of the claimed design. The solid line that is not immediately adjacent to the shaded area is claimed. The broken lines depicting the remainder of the shoe show features that form no part of the claimed design.

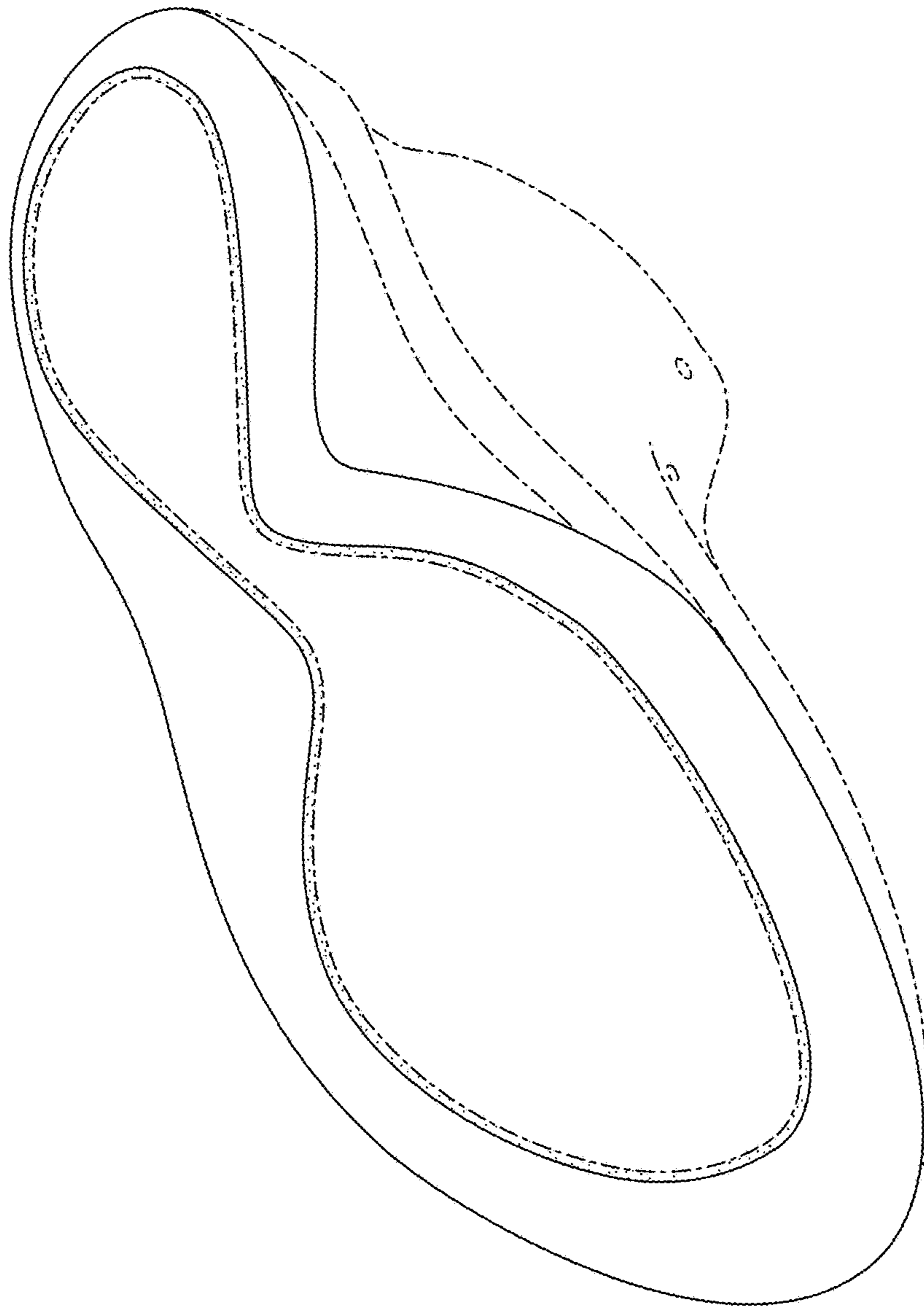

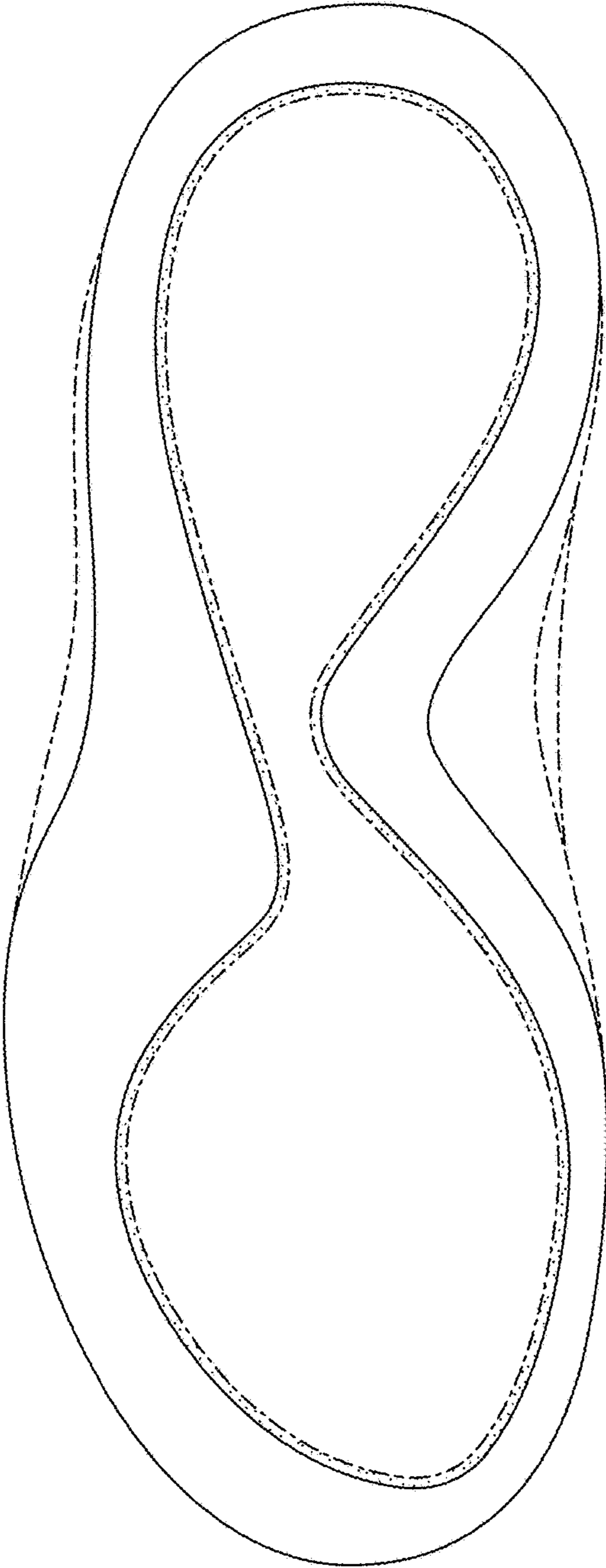

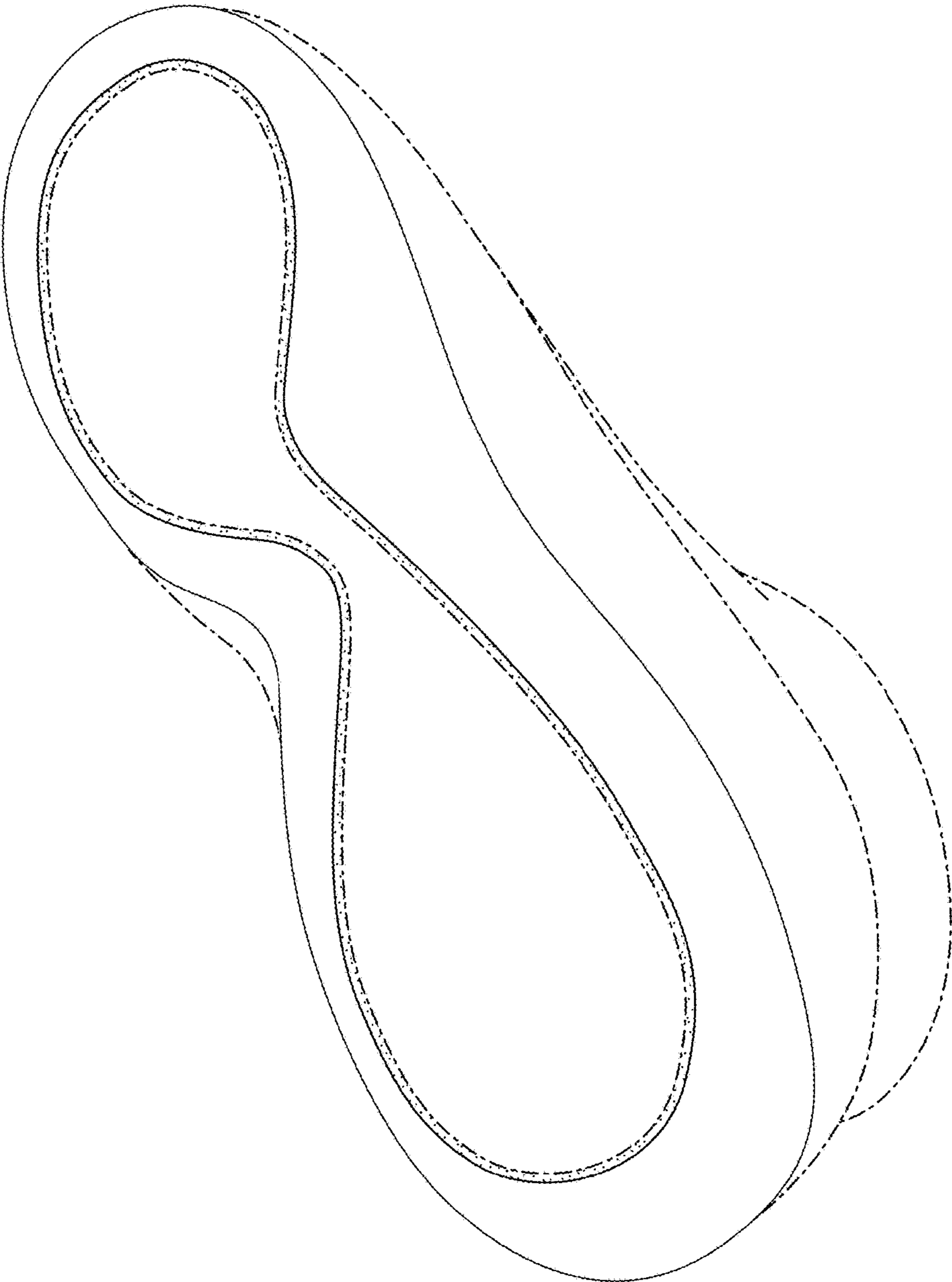
