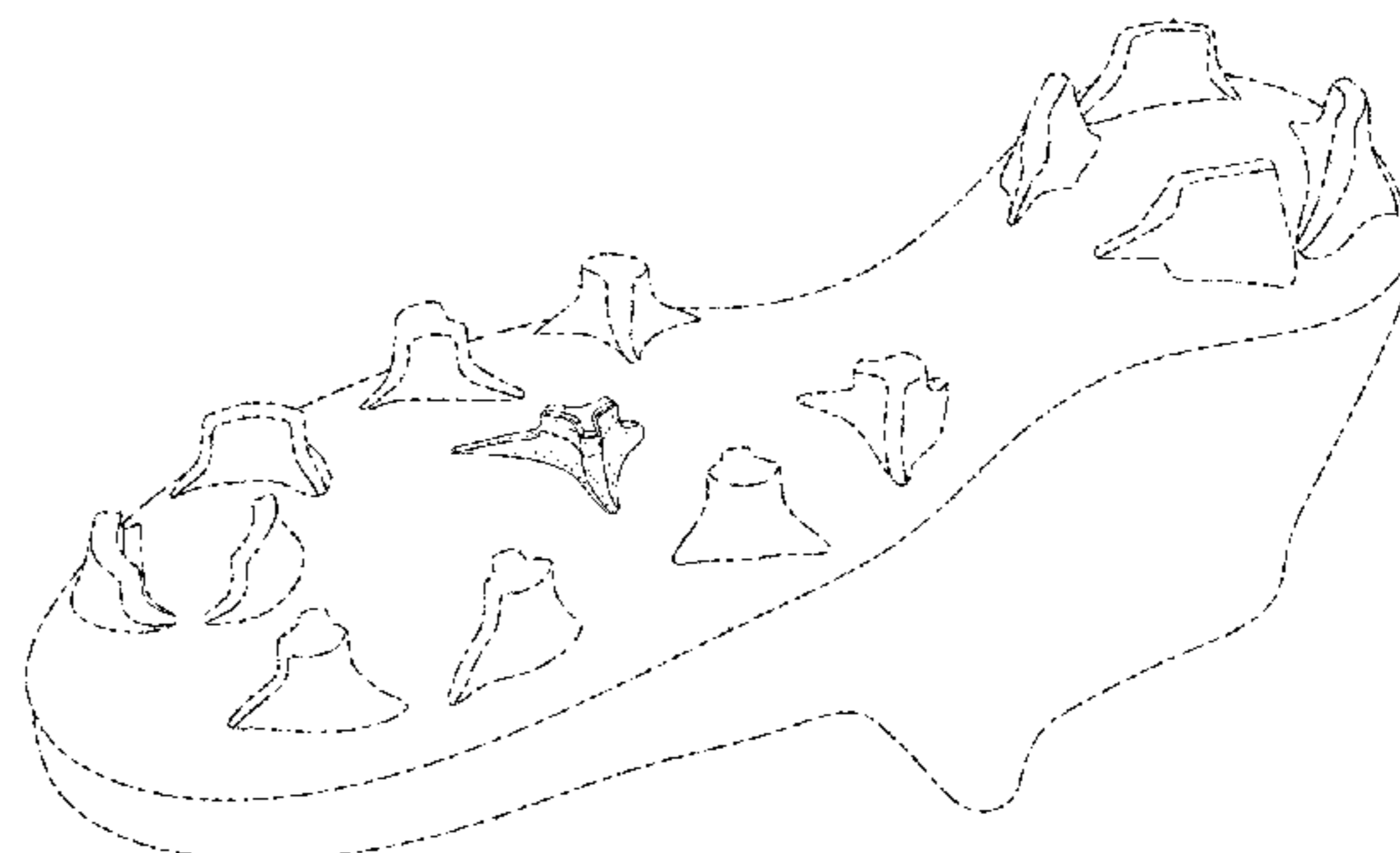
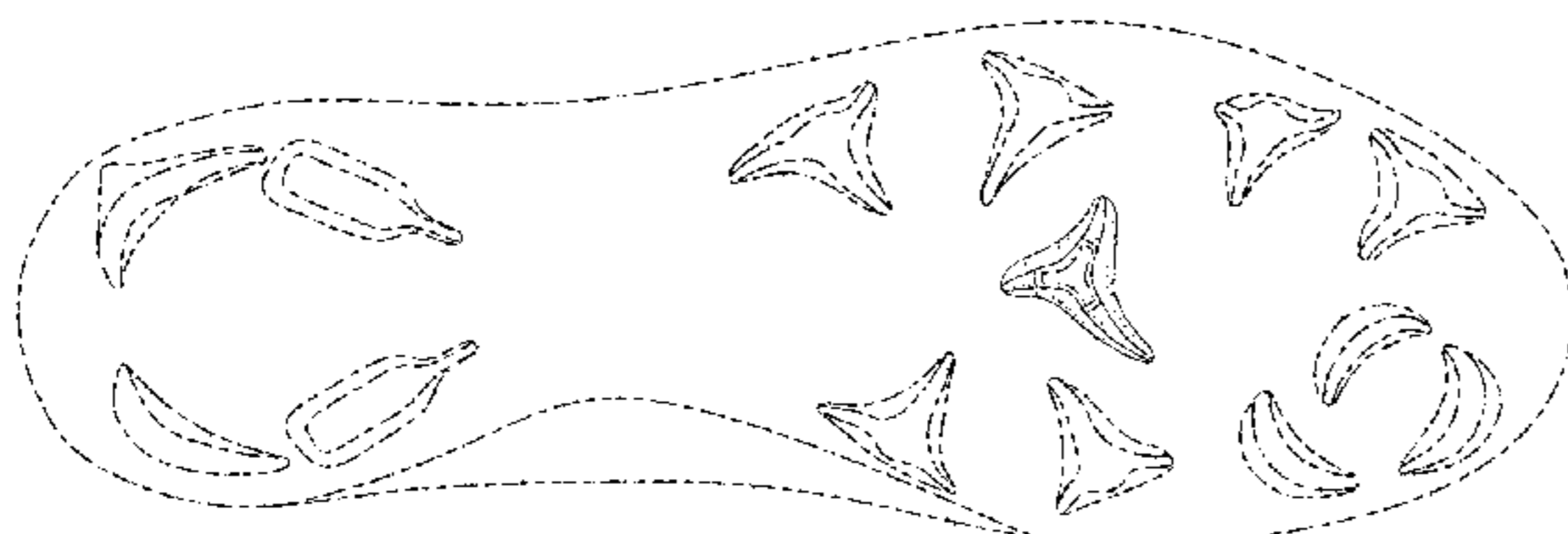
(57) **CLAIM**

The ornamental design for a shoe outsole, as shown and described.

DESCRIPTION

FIG. 1 is a bottom view of a shoe outsole showing my new design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a front perspective view thereof; and,
FIG. 4 is an enlarged partial view of FIG. 3.
The even-length broken lines within the shaded area represent unclaimed features. The uneven-length broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The uneven-length broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

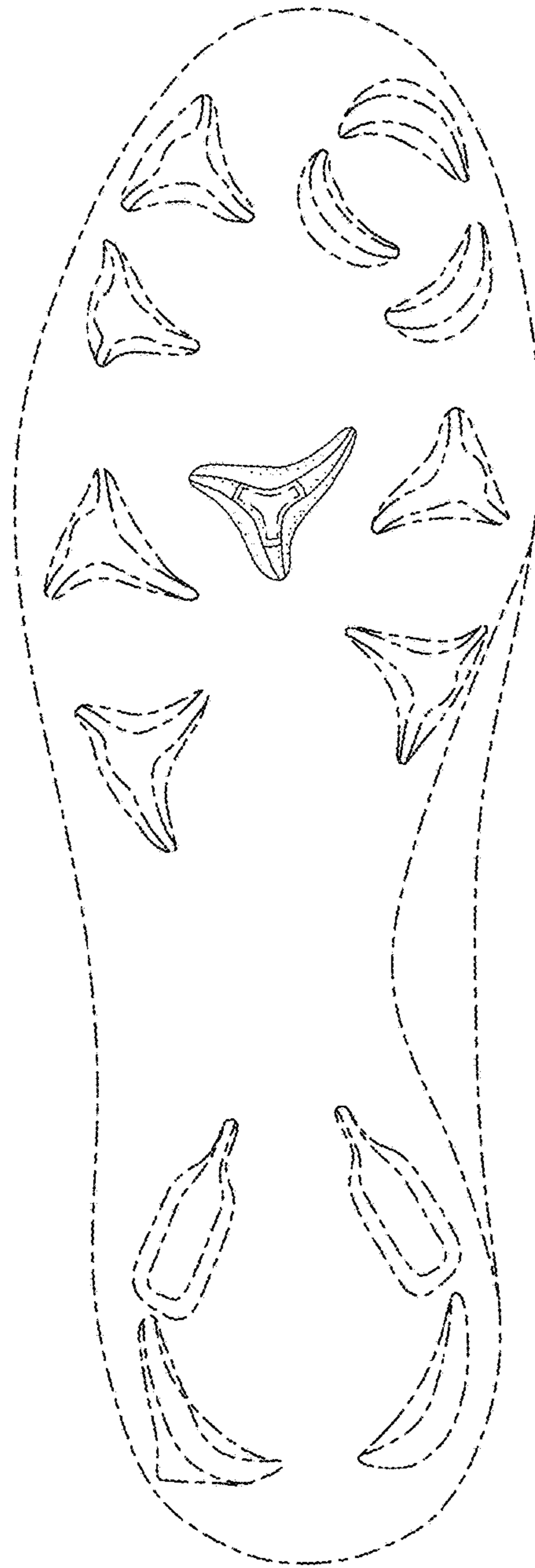

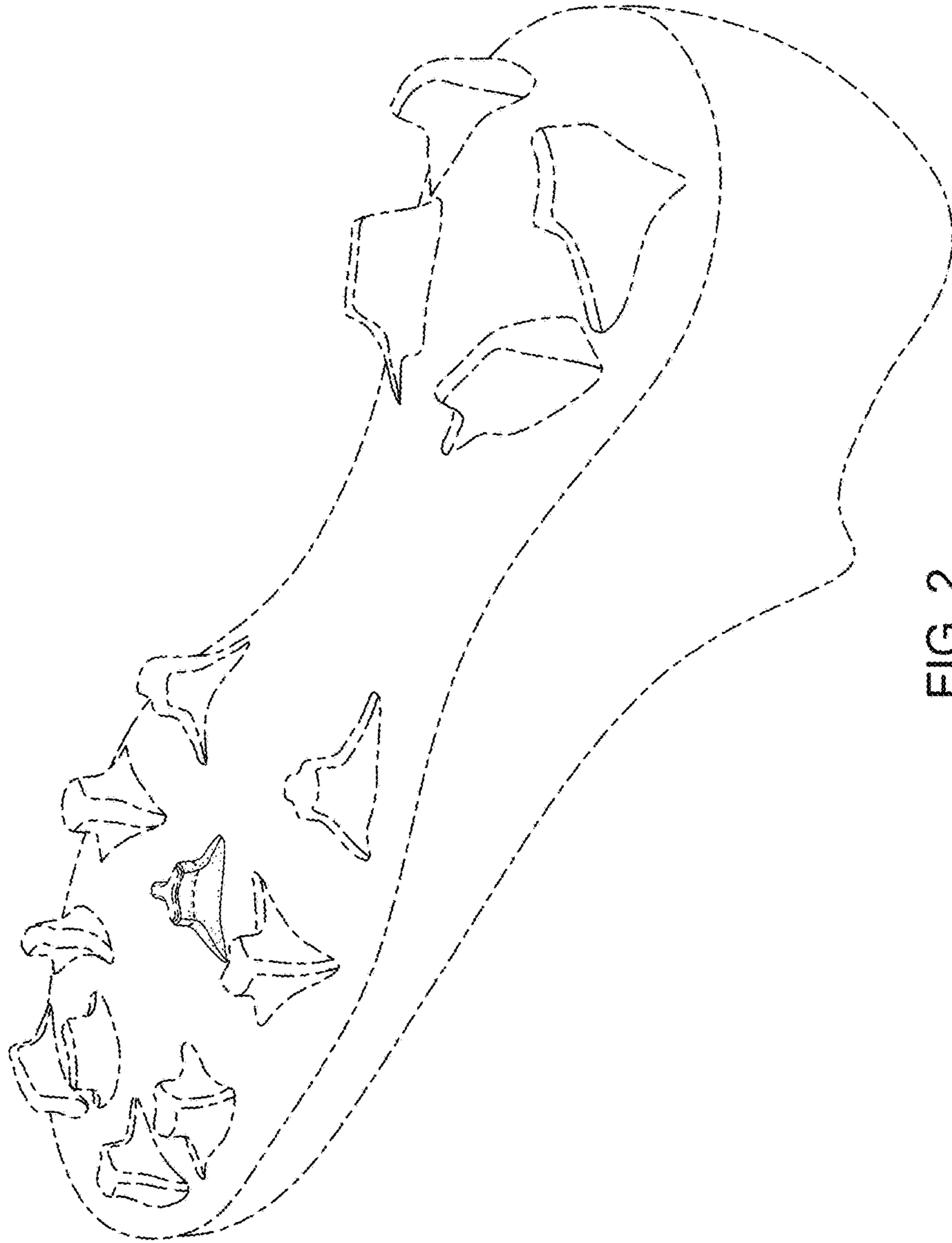

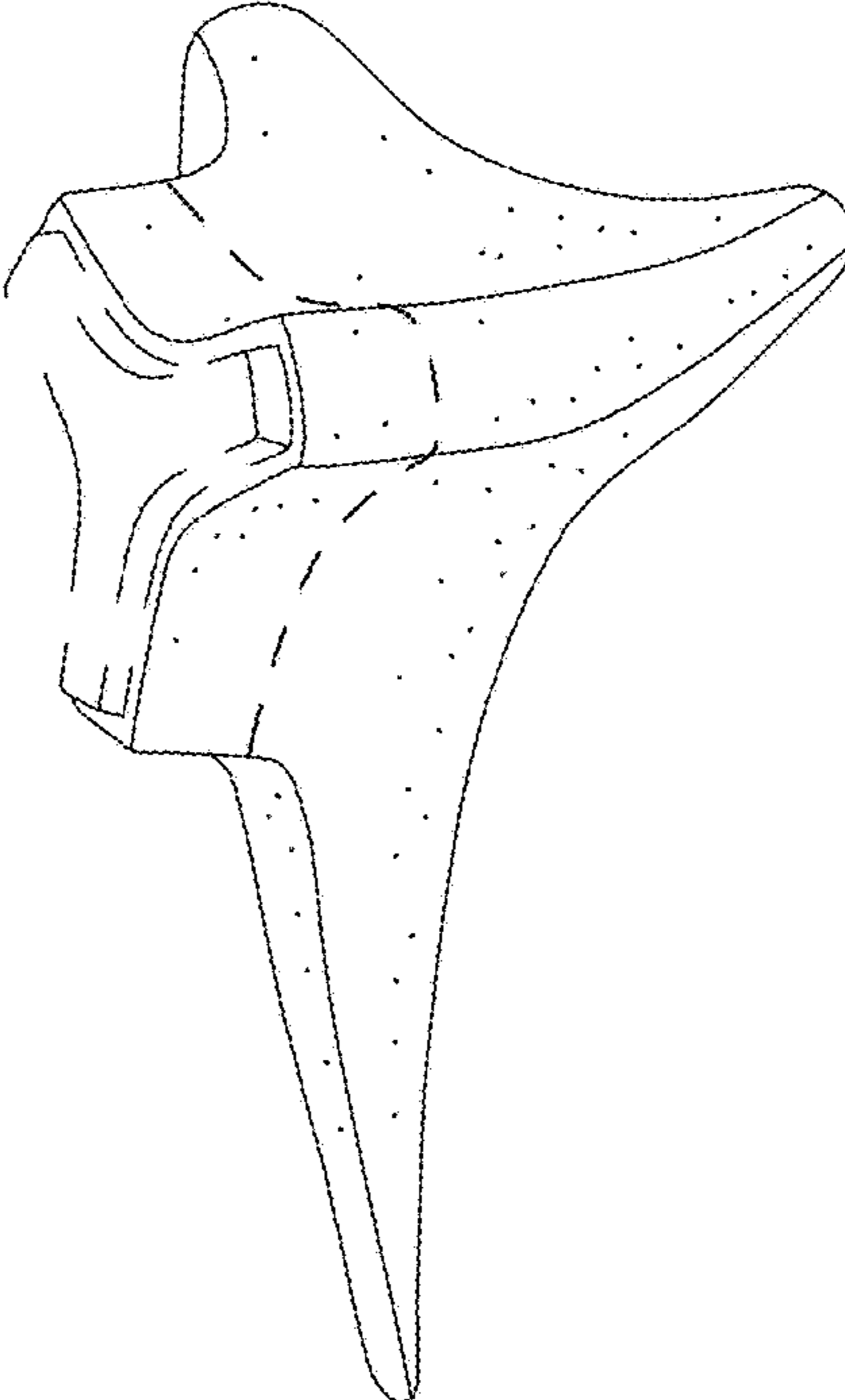
