(57) **CLAIM**

The ornamental design for a front grille for automobile, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a front grille for automobile;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a left side elevation view thereof;
FIG. 4 is a right side elevation view thereof; and,
FIG. 5 is a top plan view thereof.
The broken lines shown in the drawings illustrate portions of a front grille for automobile that form no part of the claimed design.

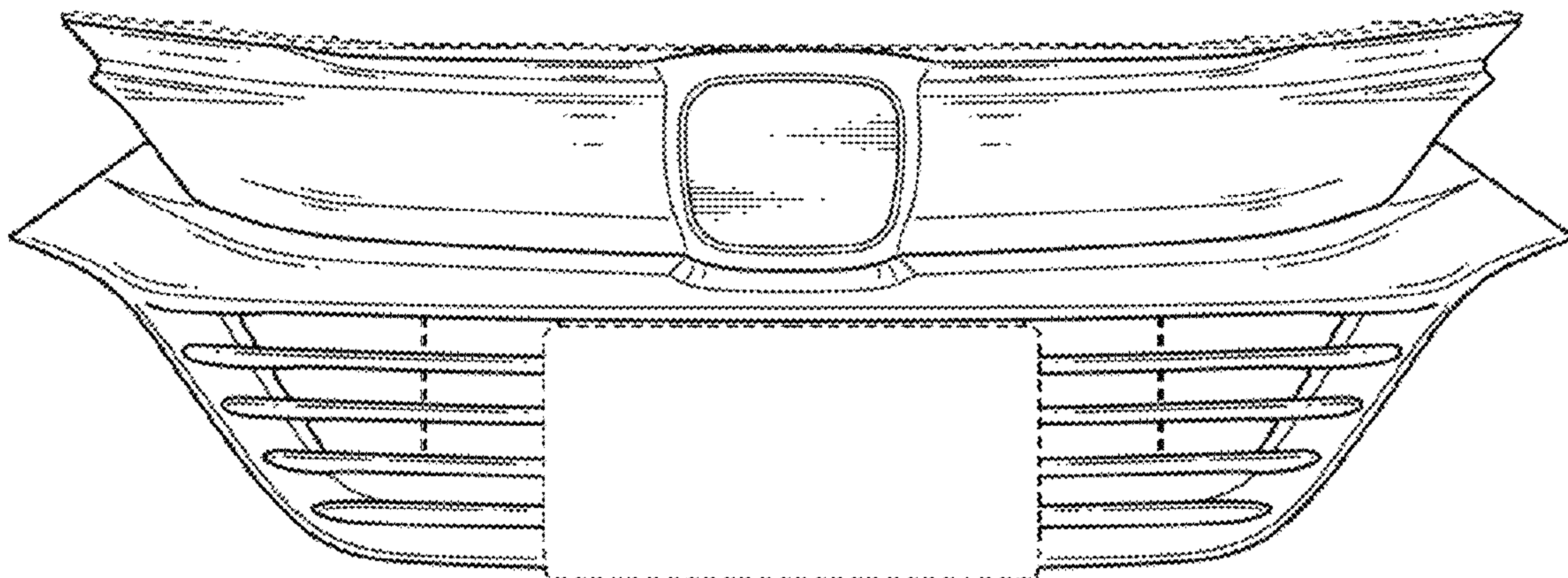

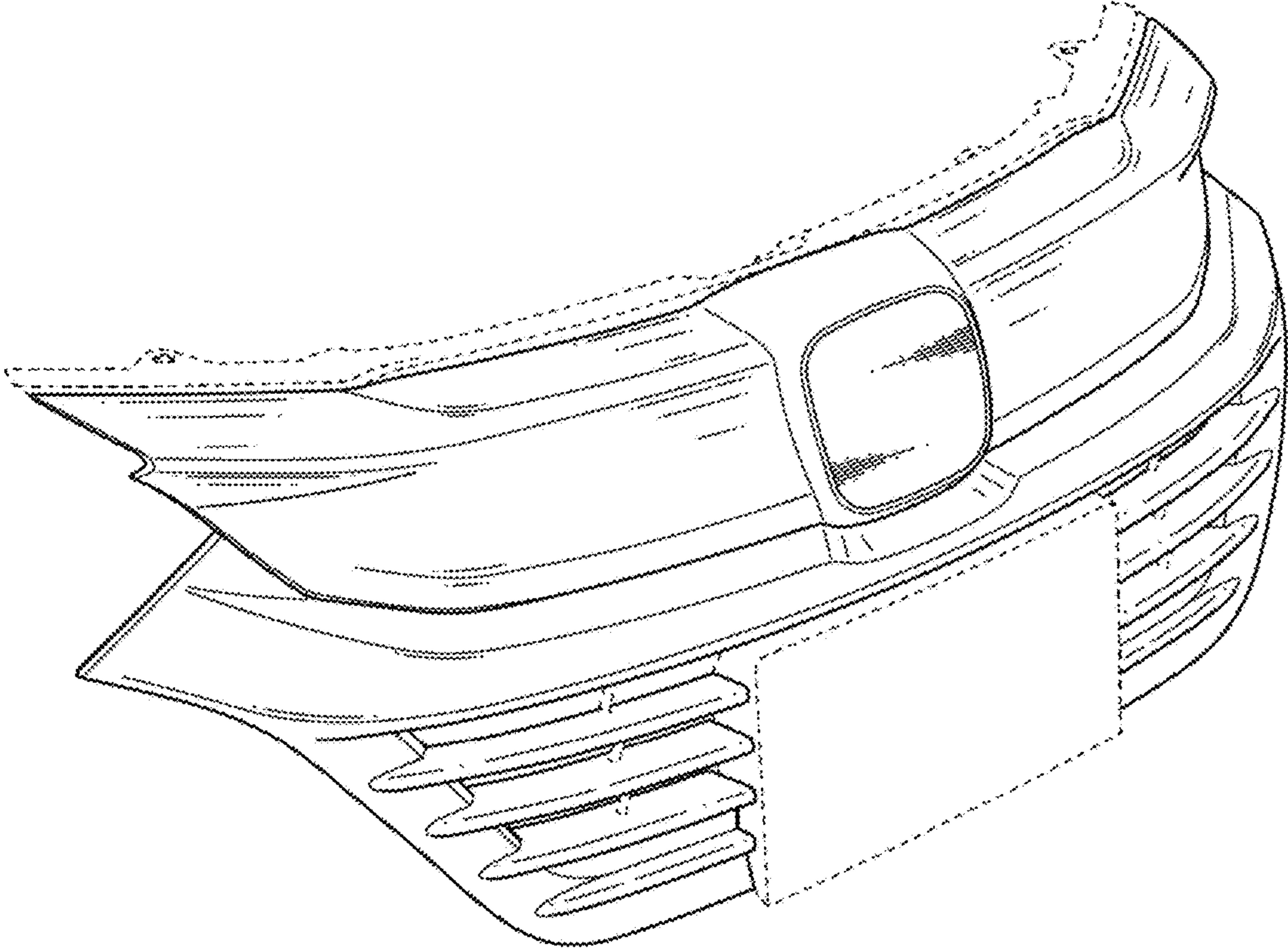

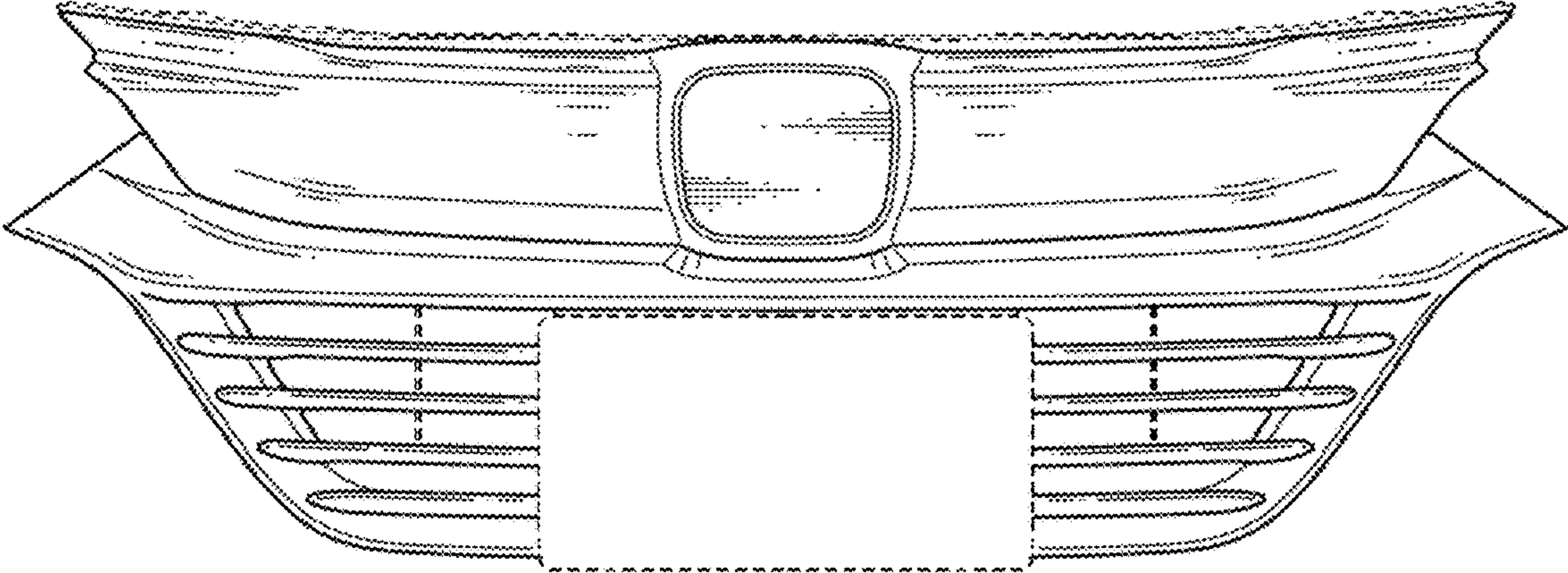

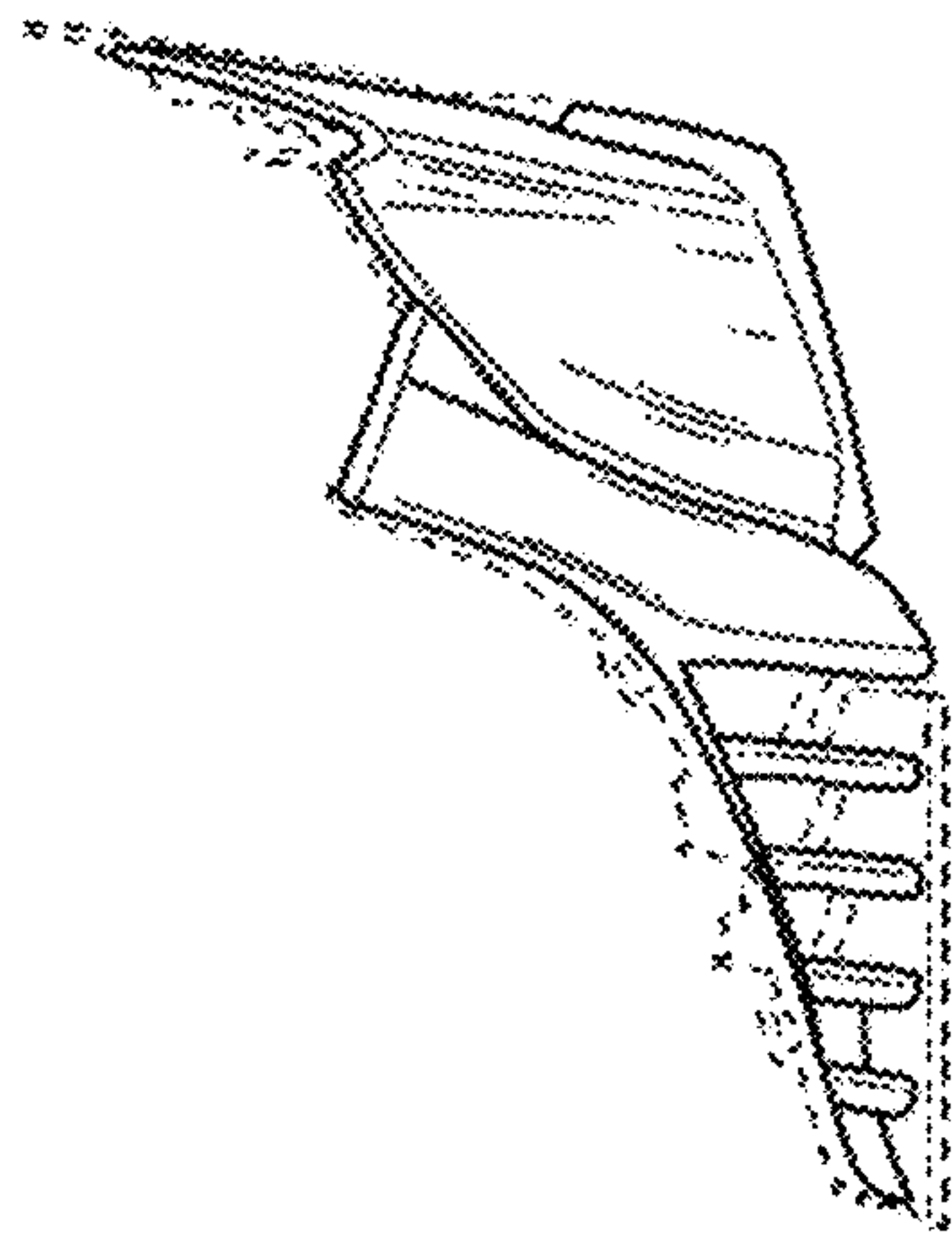

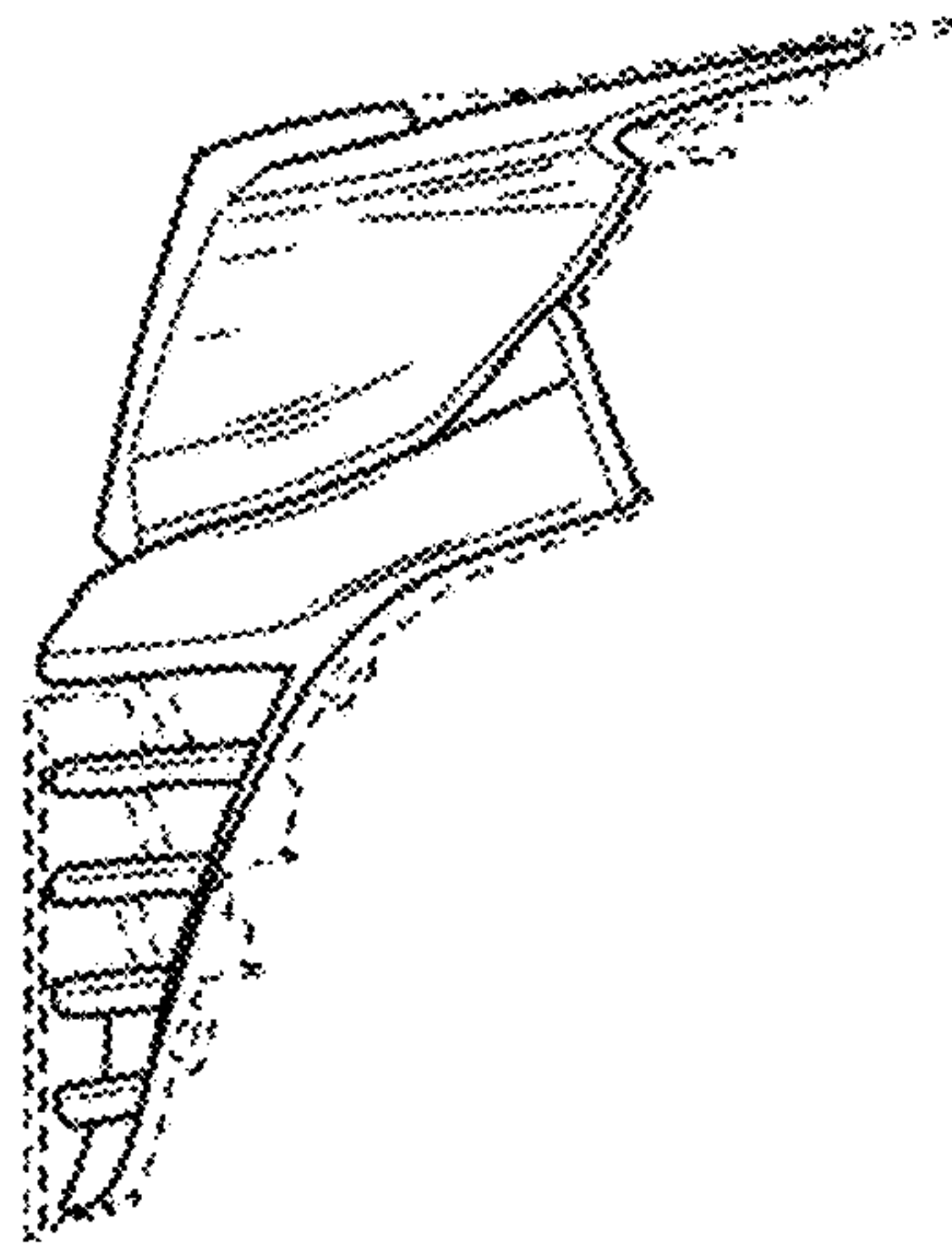
