DESCRIPTION

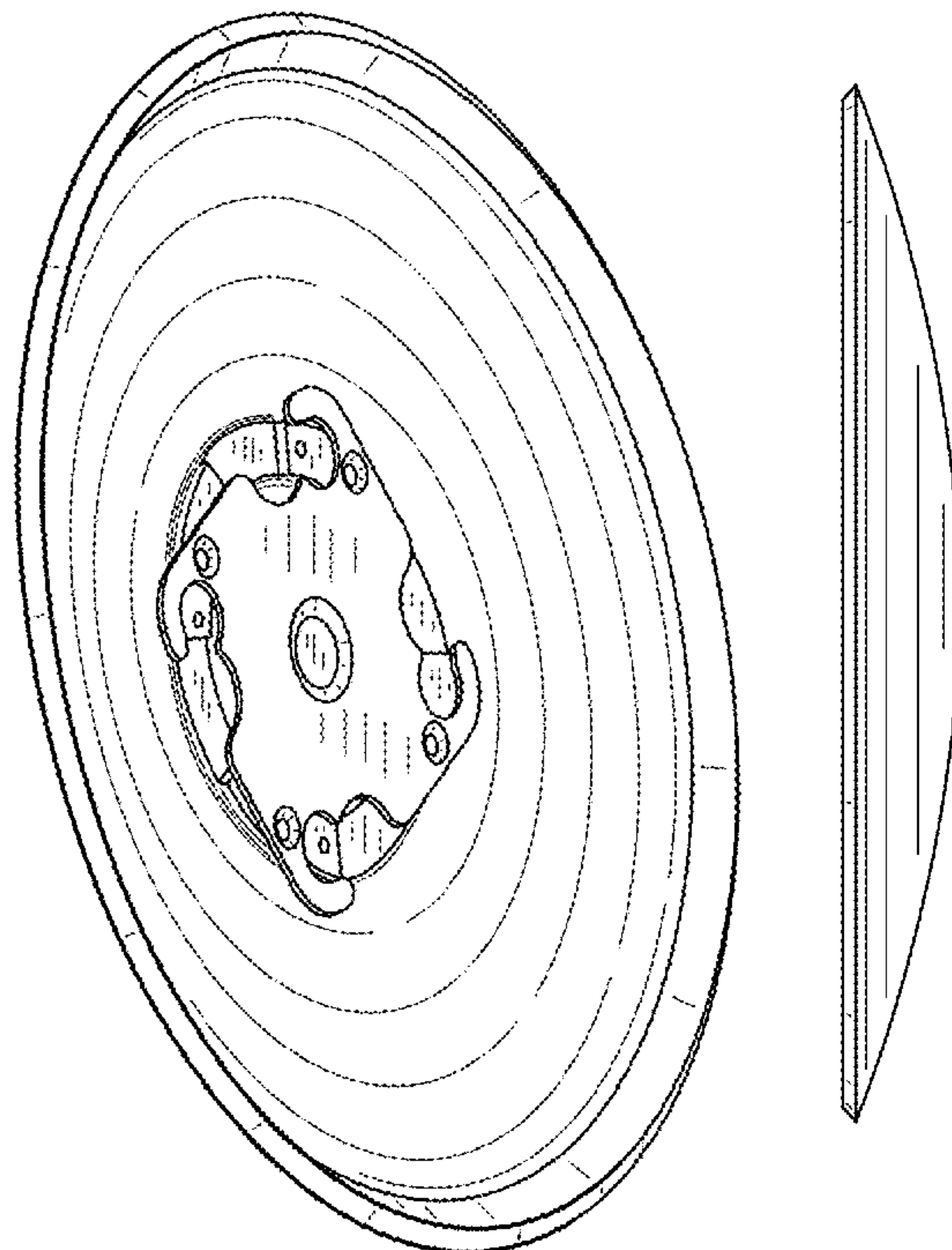
FIG. 1 is a perspective view of a wheel cover mounted on a wheel showing our new design.

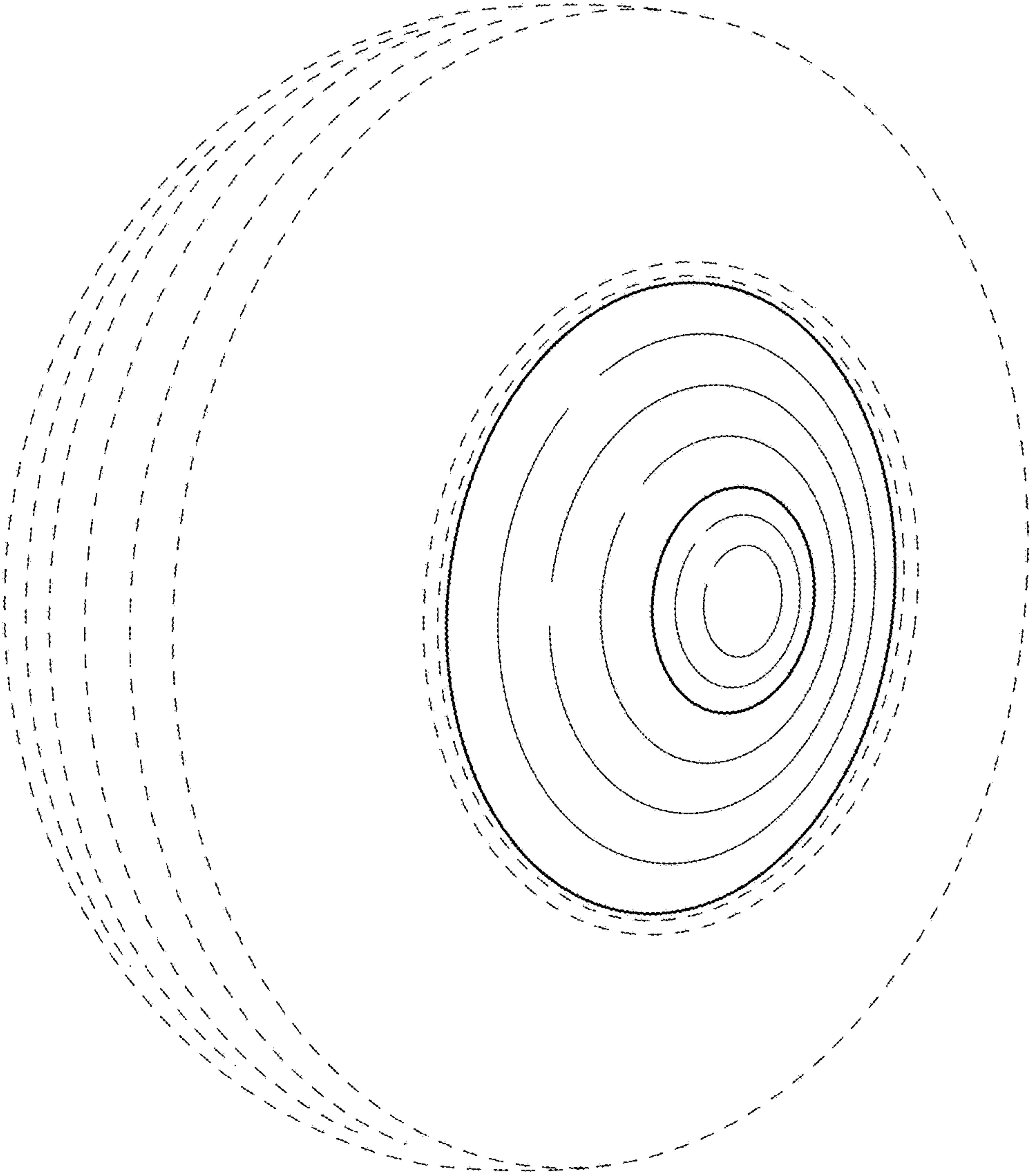

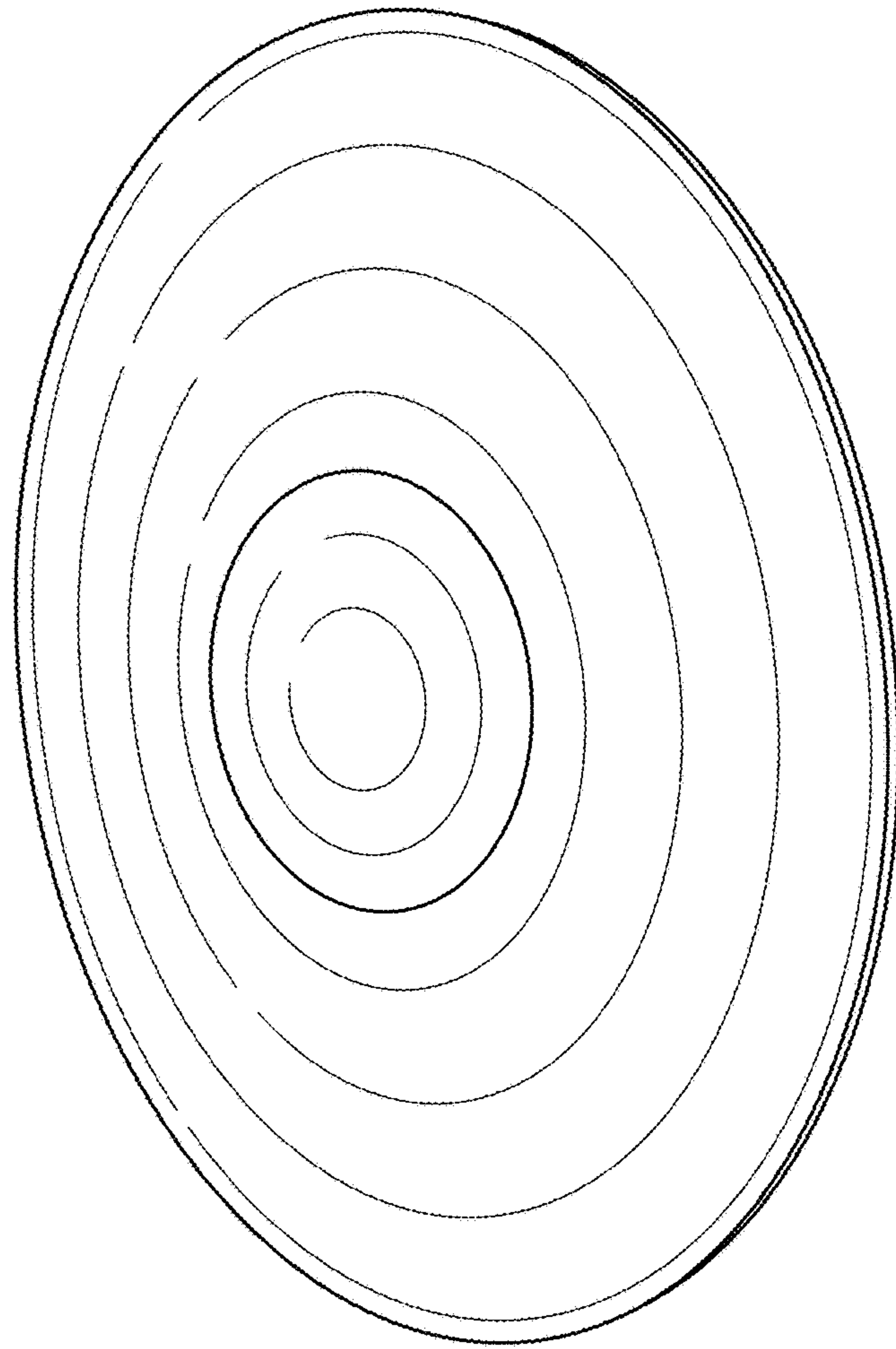

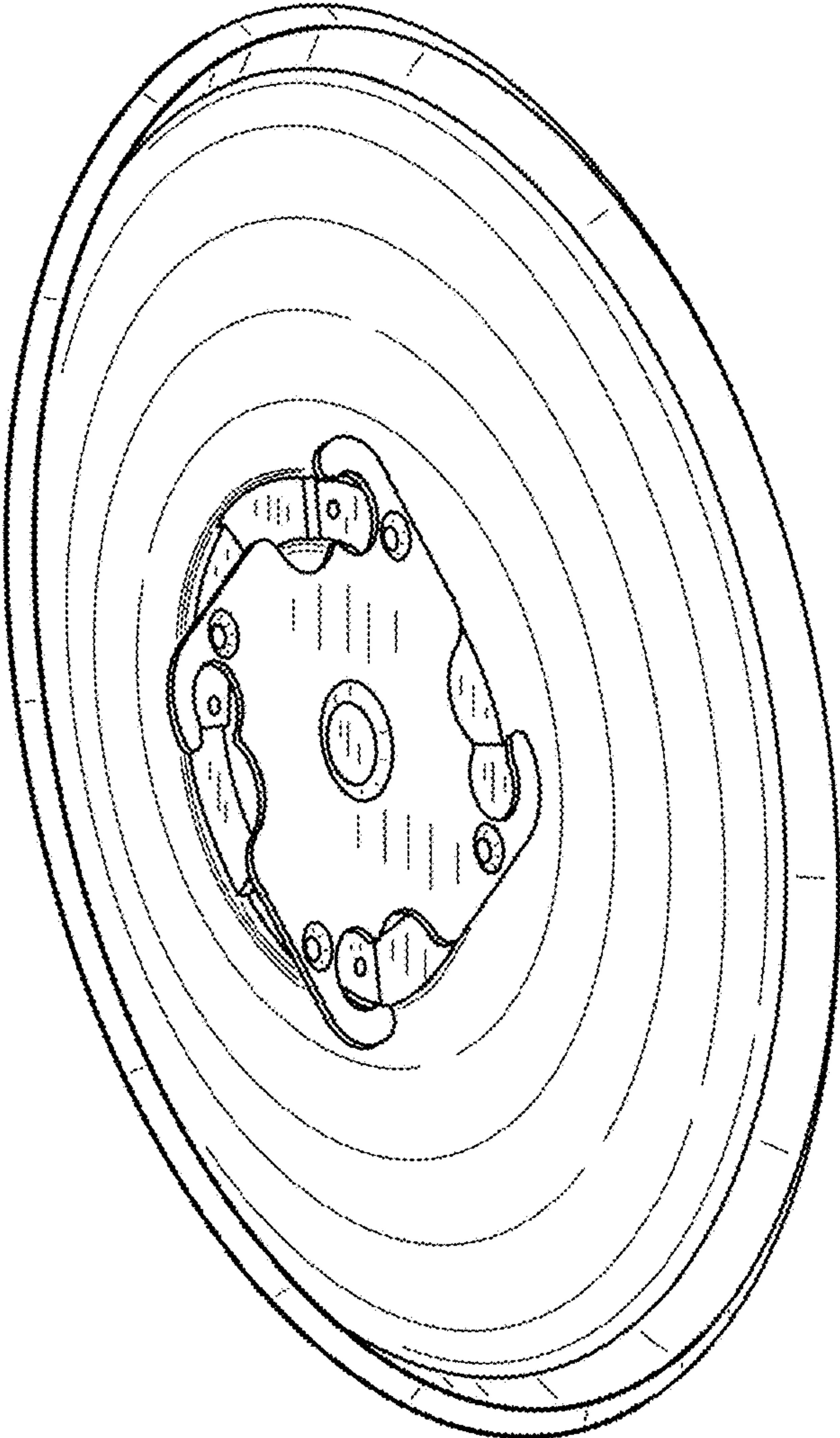

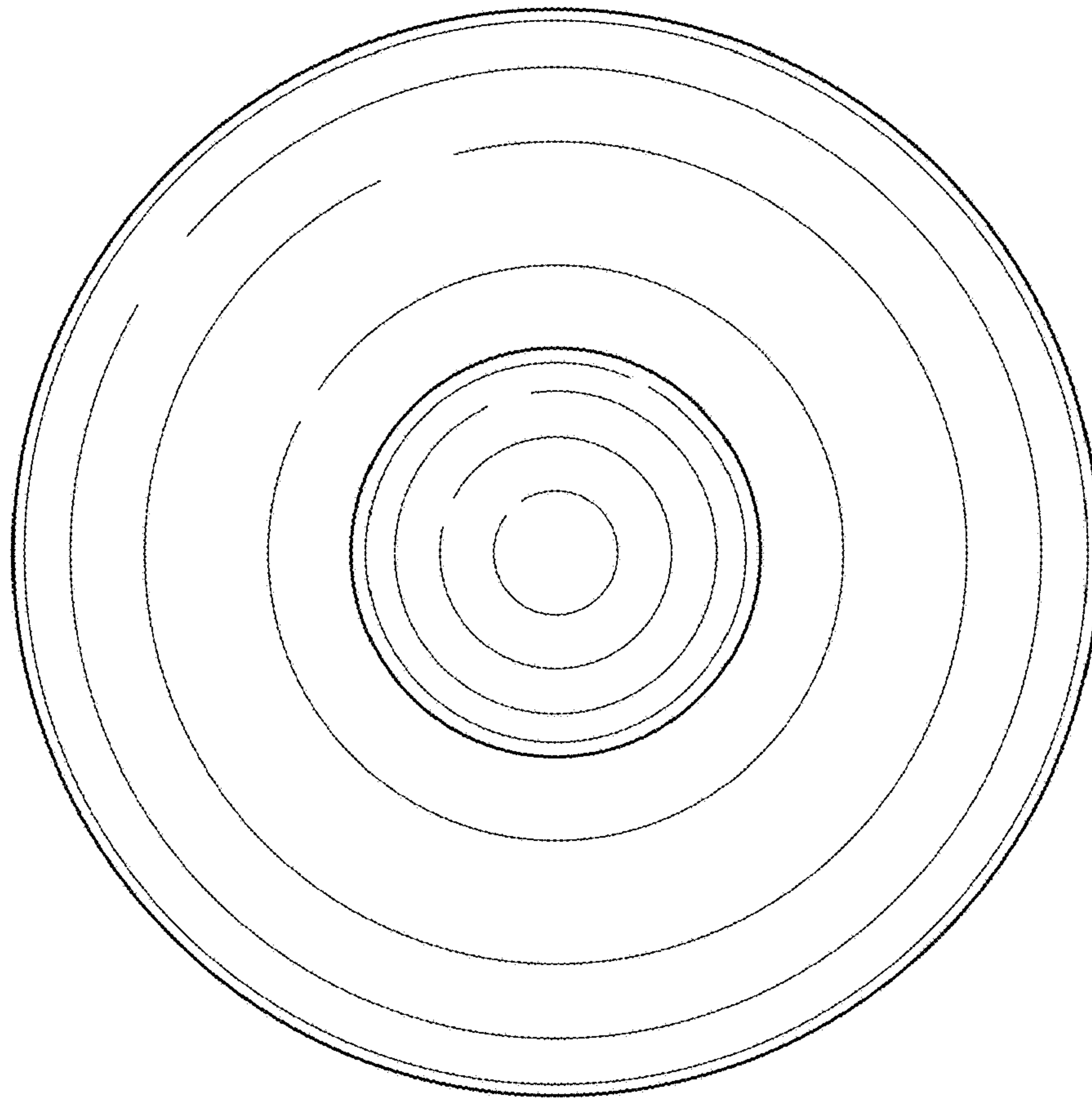

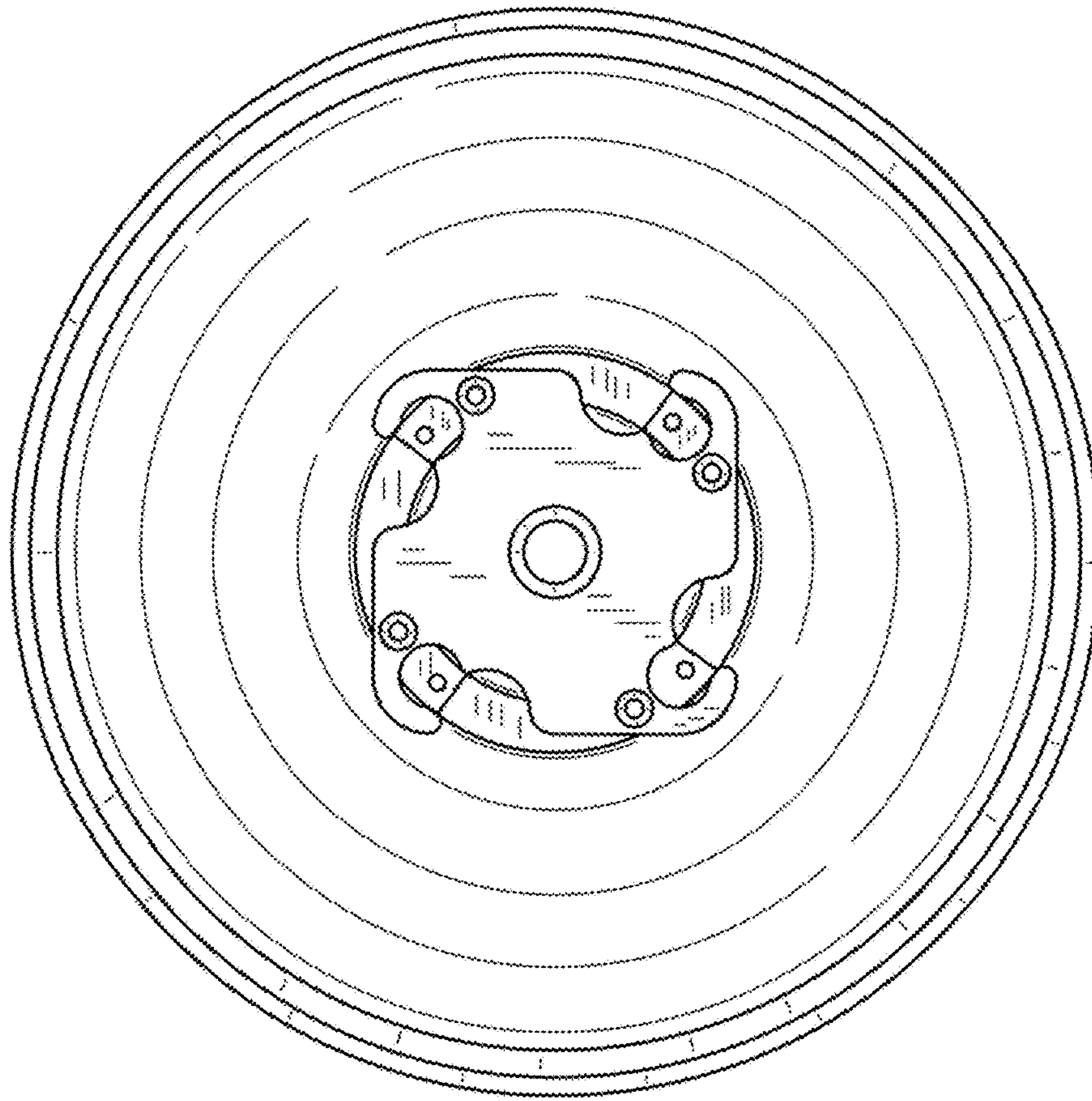

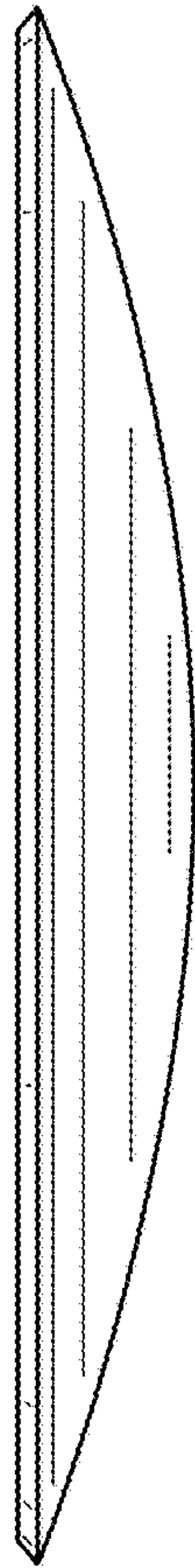
