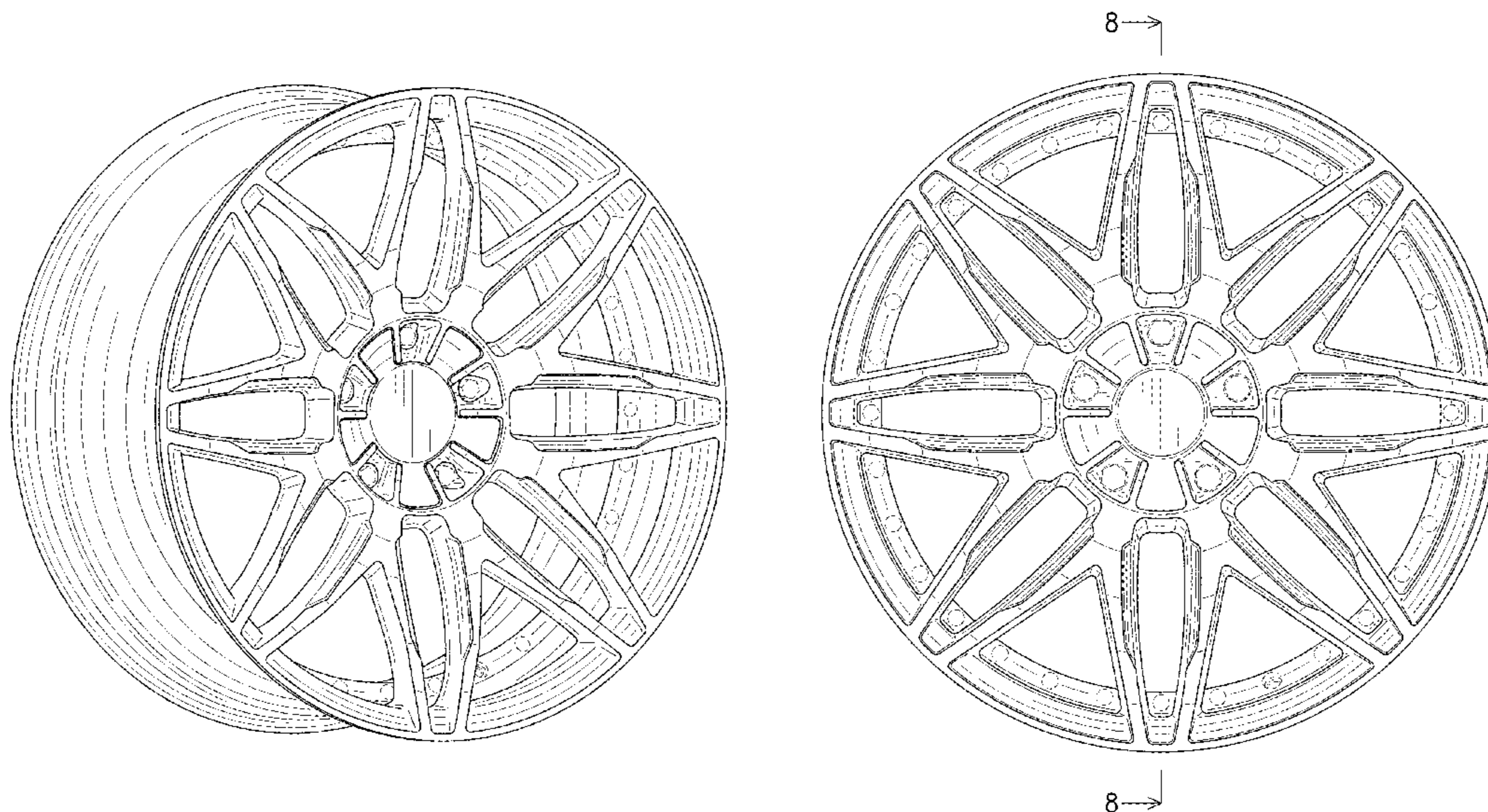
(57) **CLAIM**

The ornamental design for a vehicle wheel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a vehicle wheel showing my new design;
 FIG. 2 is a front view thereof;
 FIG. 3 is a rear view thereof;
 FIG. 4 is a left side view thereof;
 FIG. 5 is a right side view thereof;
 FIG. 6 is a top view thereof;
 FIG. 7 is a bottom view thereof; and
 FIG. 8 is a cross-sectional view thereof taken along the line 8-8 of FIG. 2; and,
 FIG. 9 is another front view thereof.
 The broken line of screws in FIGS. 1-2 and 8-9 illustrates unclaimed environment and forms no part of the claimed design. The broken line portions of the vehicle wheel in FIGS. 1-3, 5 and 7-9 represent unclaimed portions of the claimed design and form no part thereof.

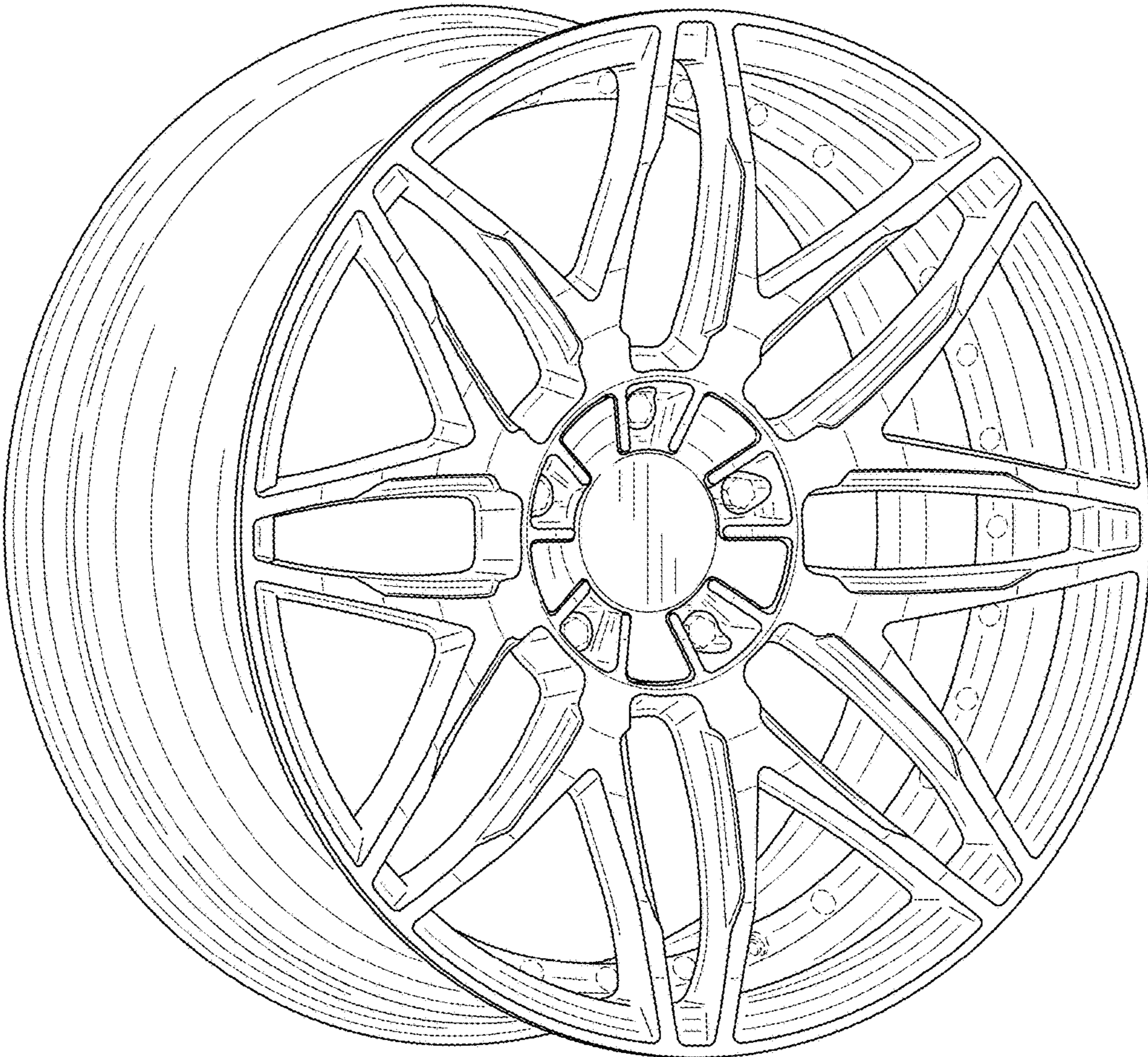

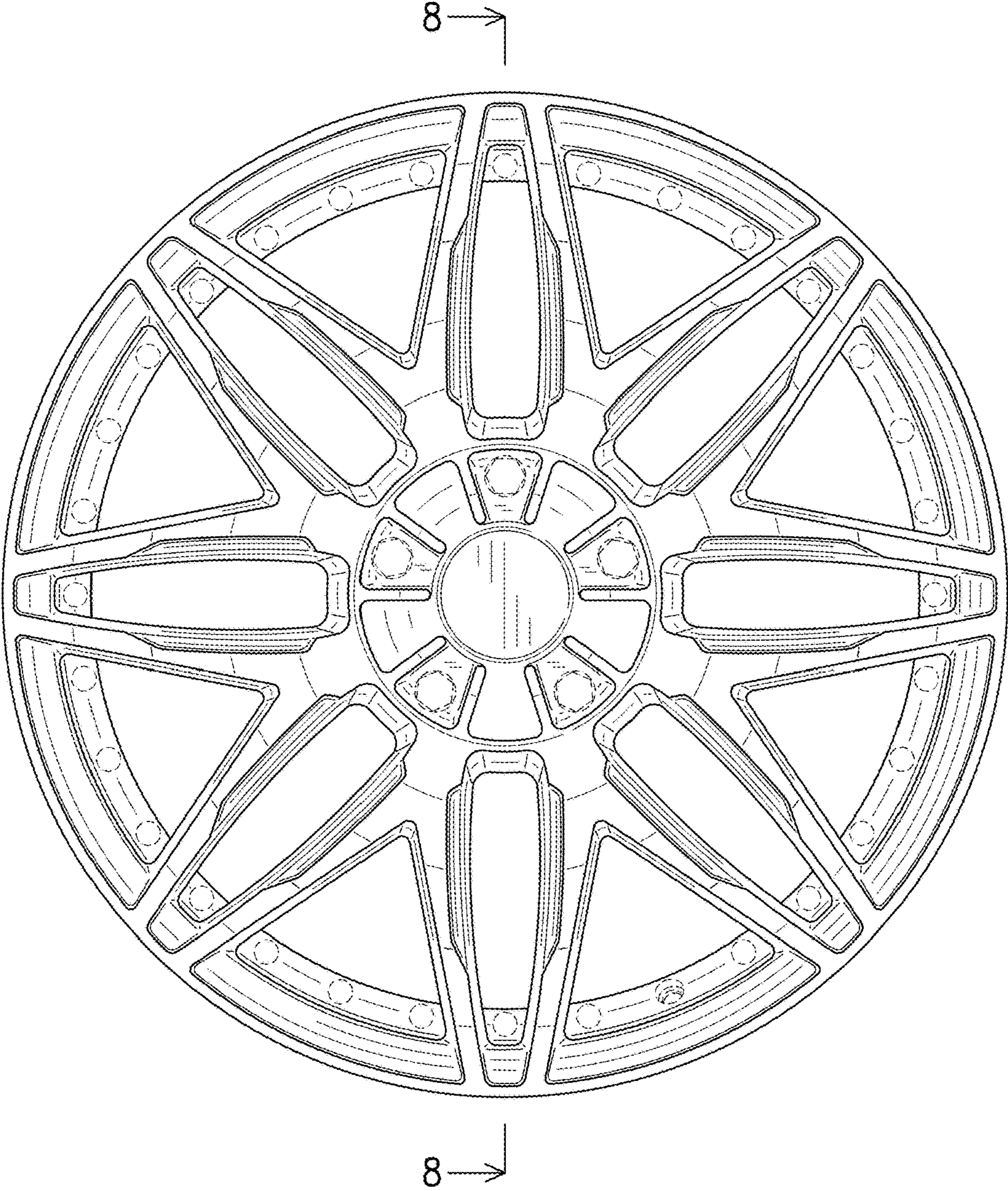

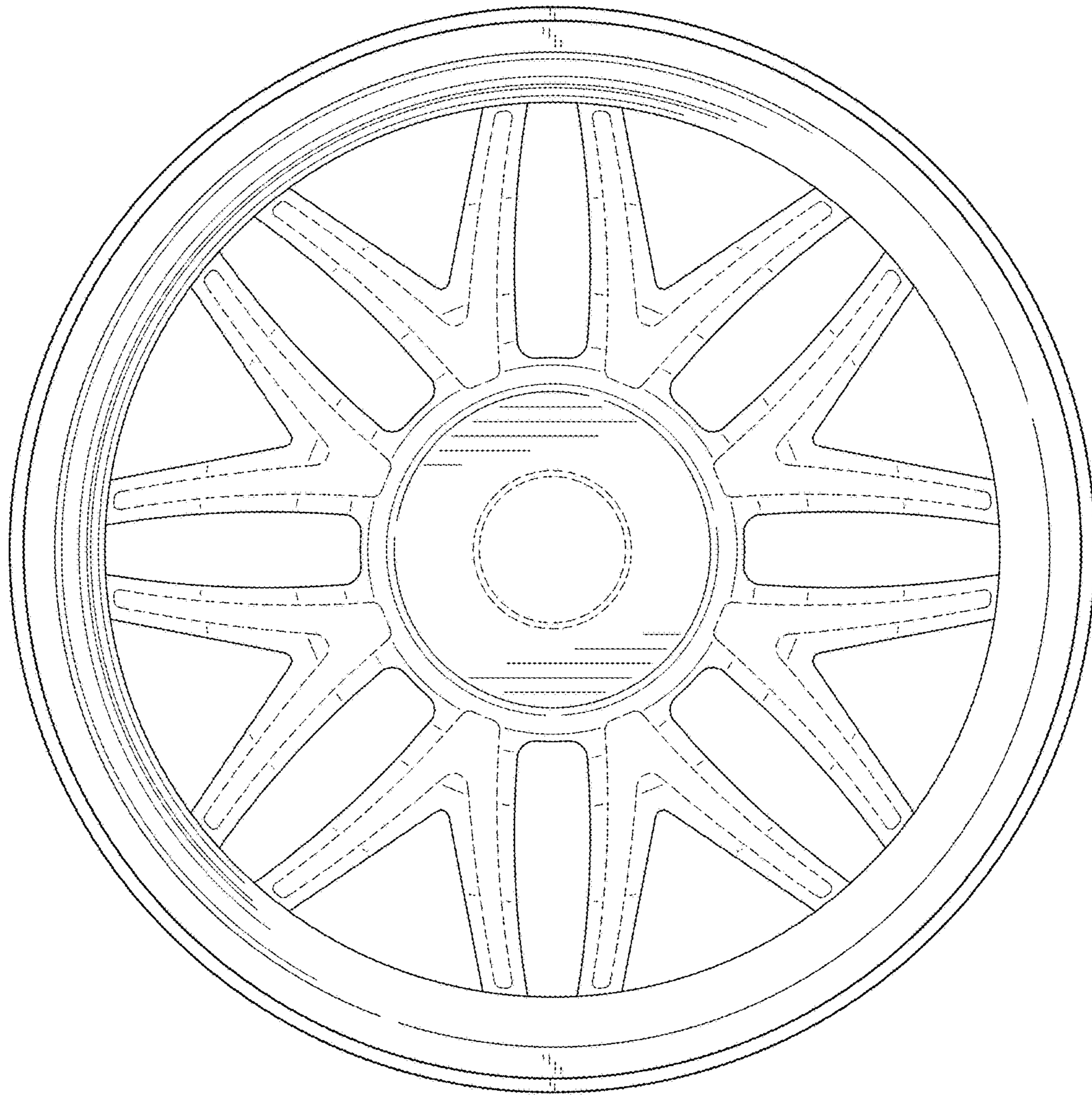

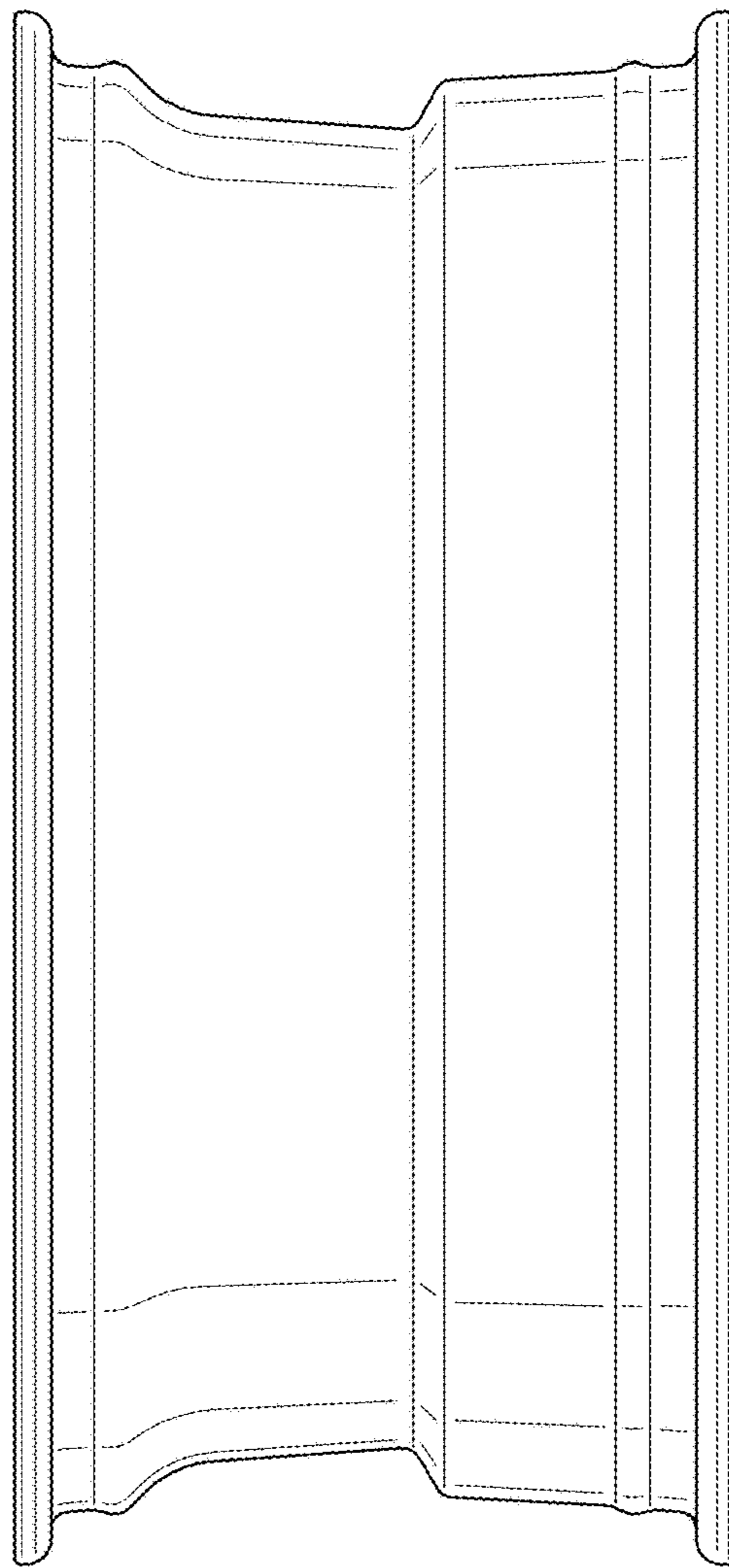

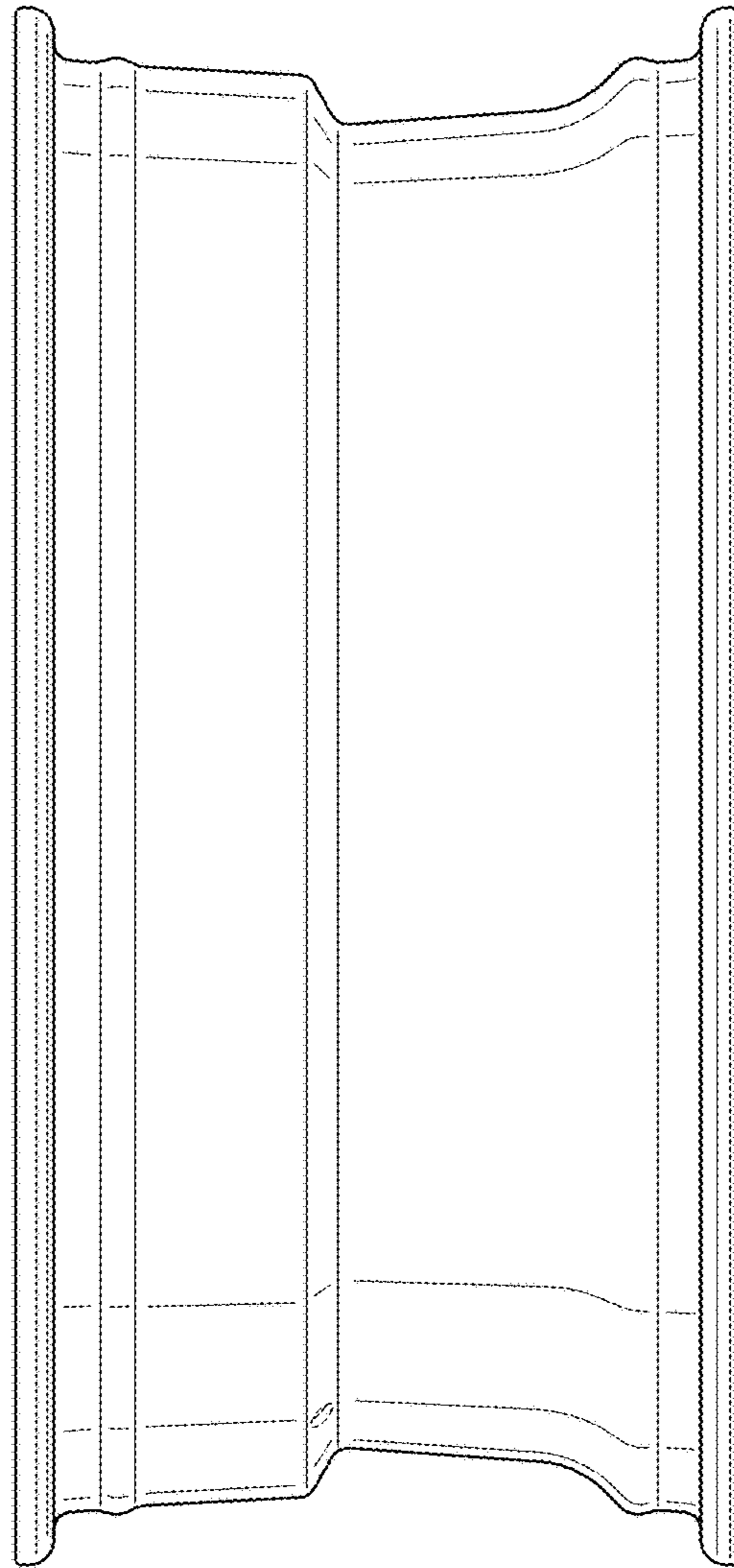

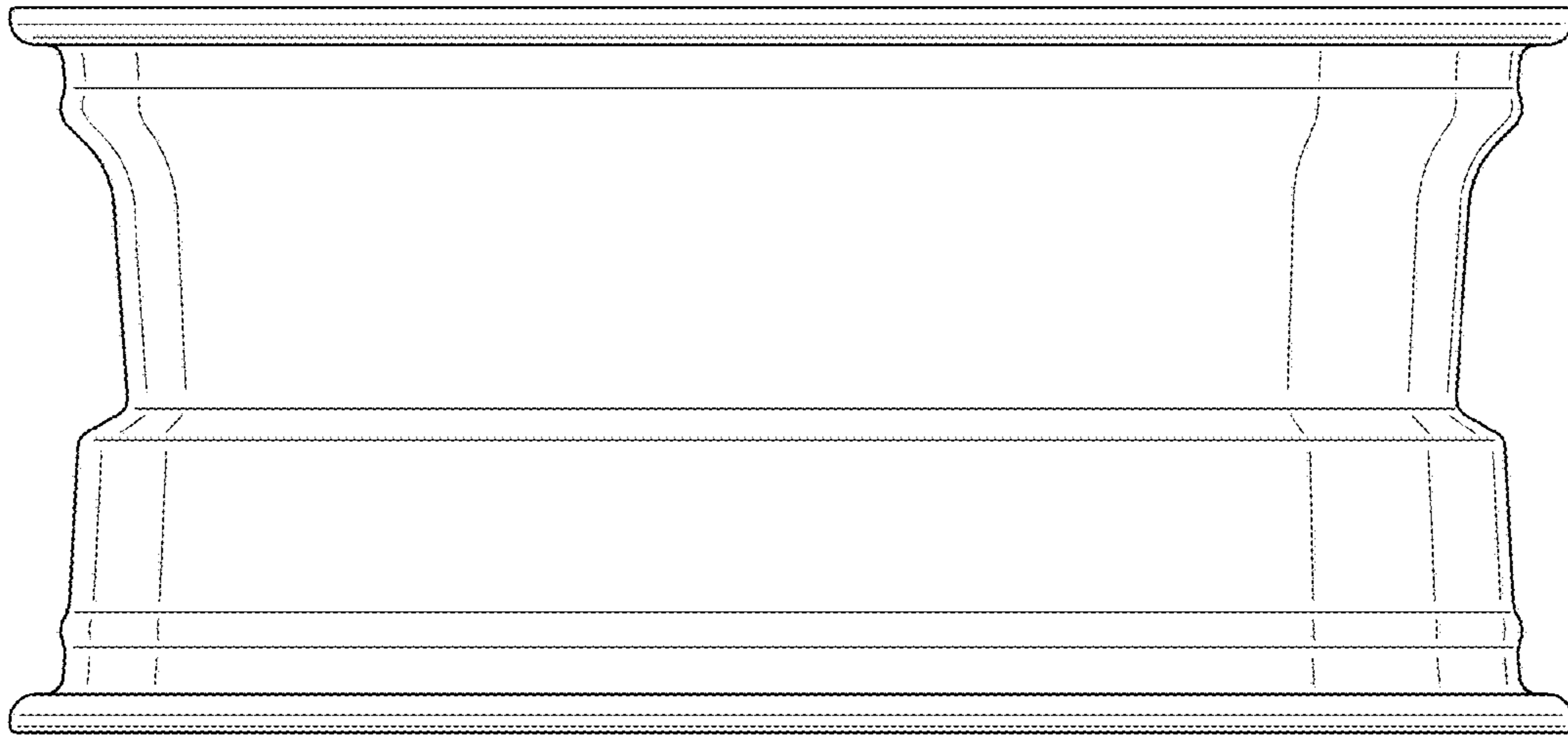

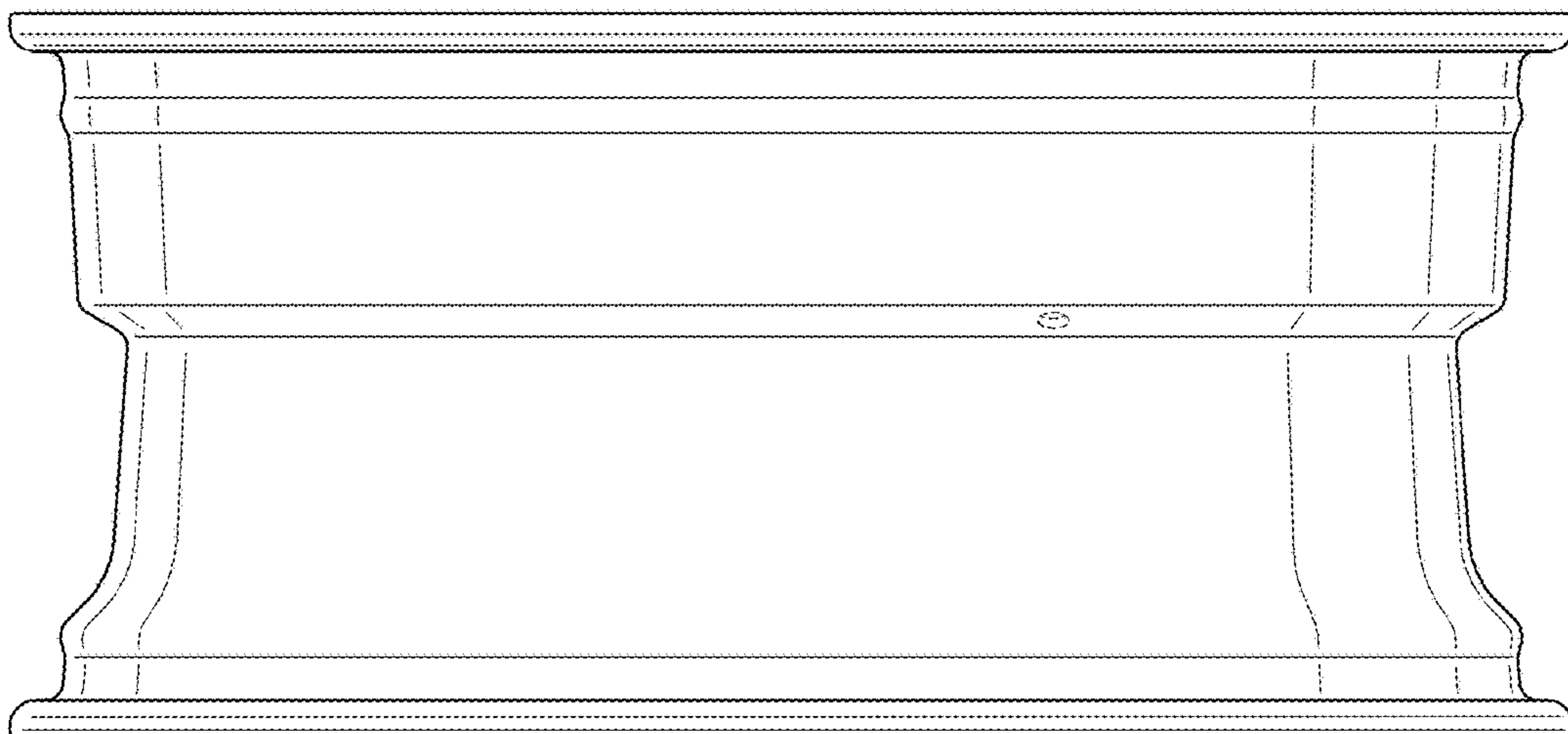

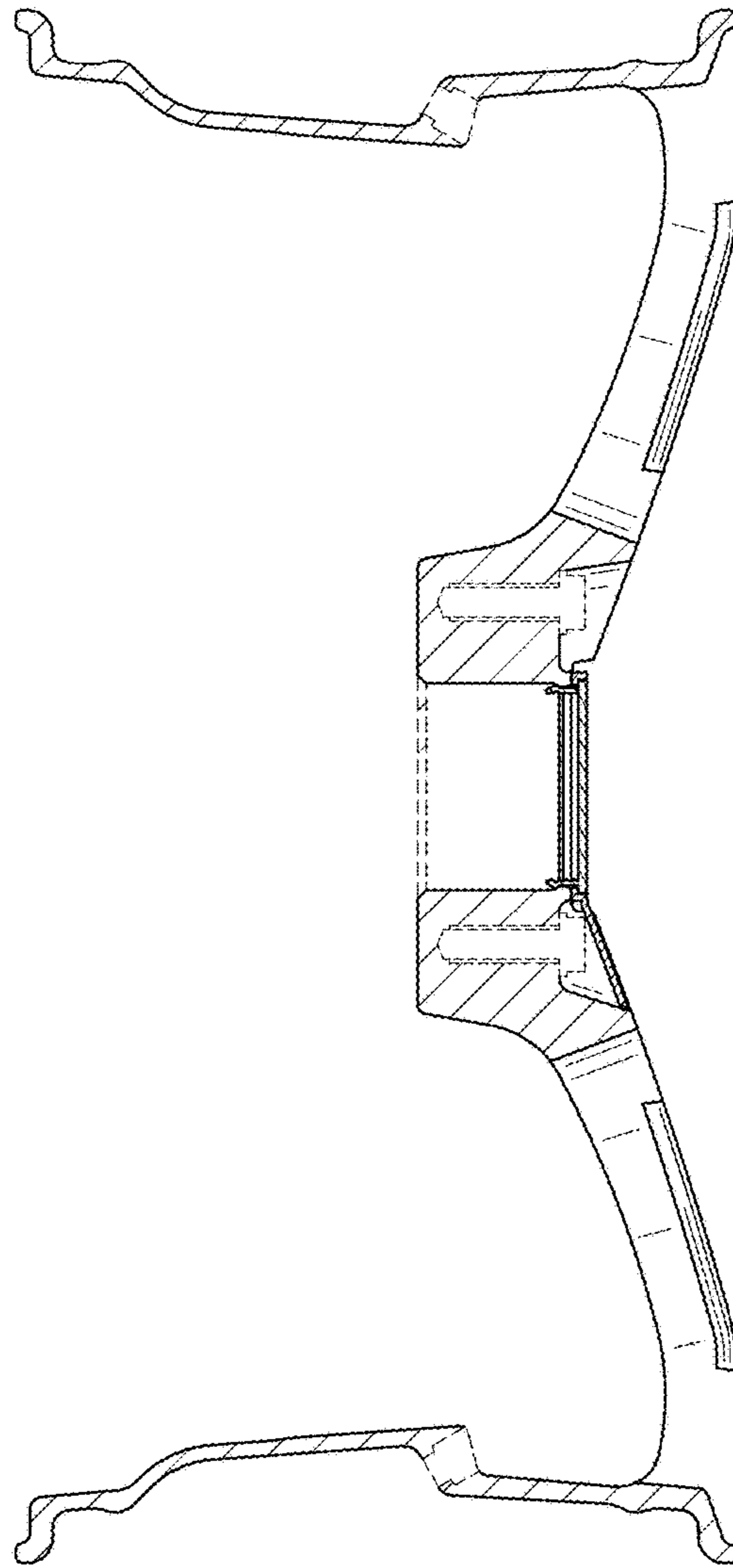

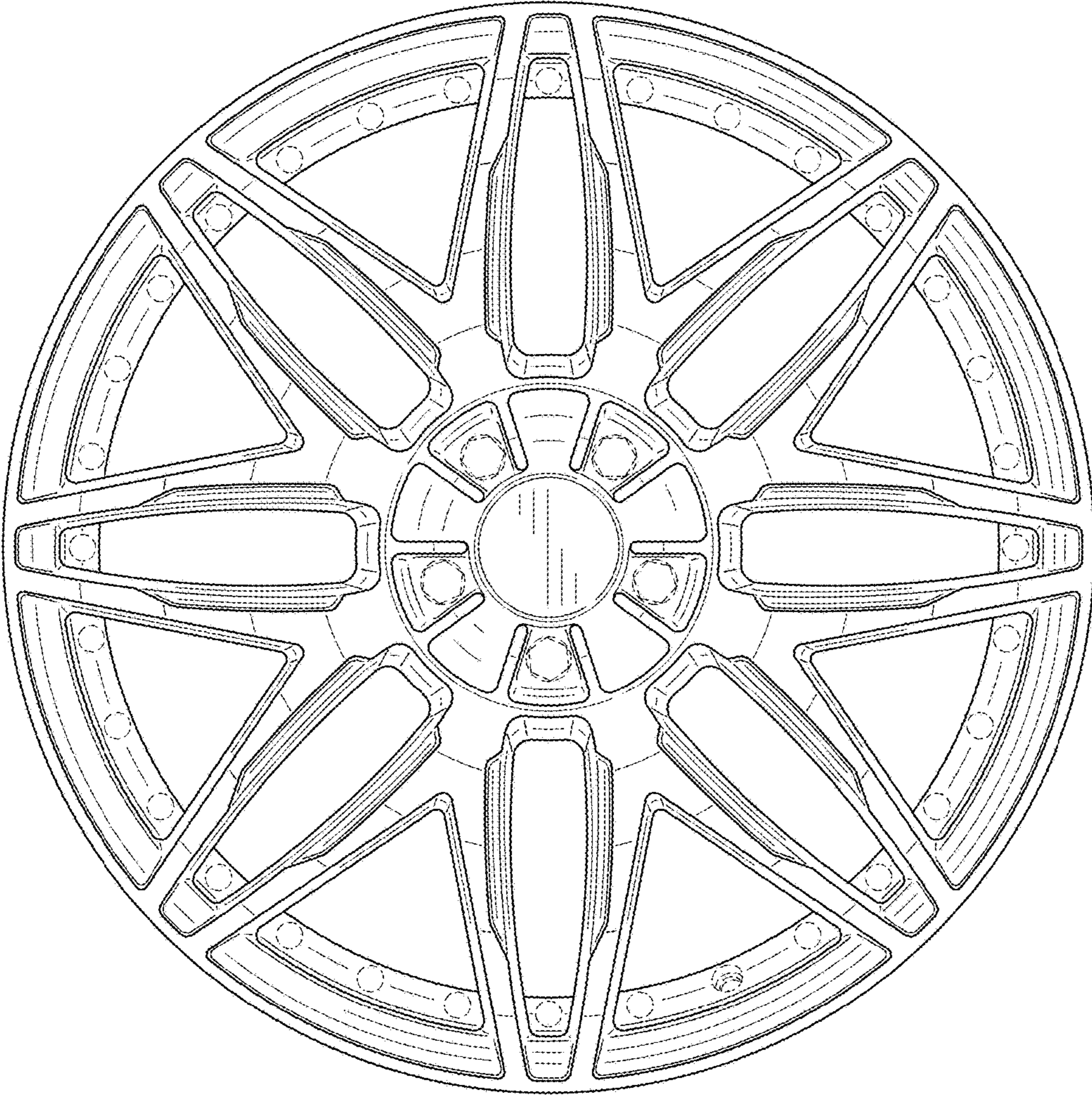
