DESCRIPTION

FIG. 1 is a front left perspective view of a wheel according
to the present invention.

FIG. 2 is a front right perspective view of the wheel shown
in FIG. 1.

FIG. 4 is a left side view thereof, the right side being a mirror
image thereof.

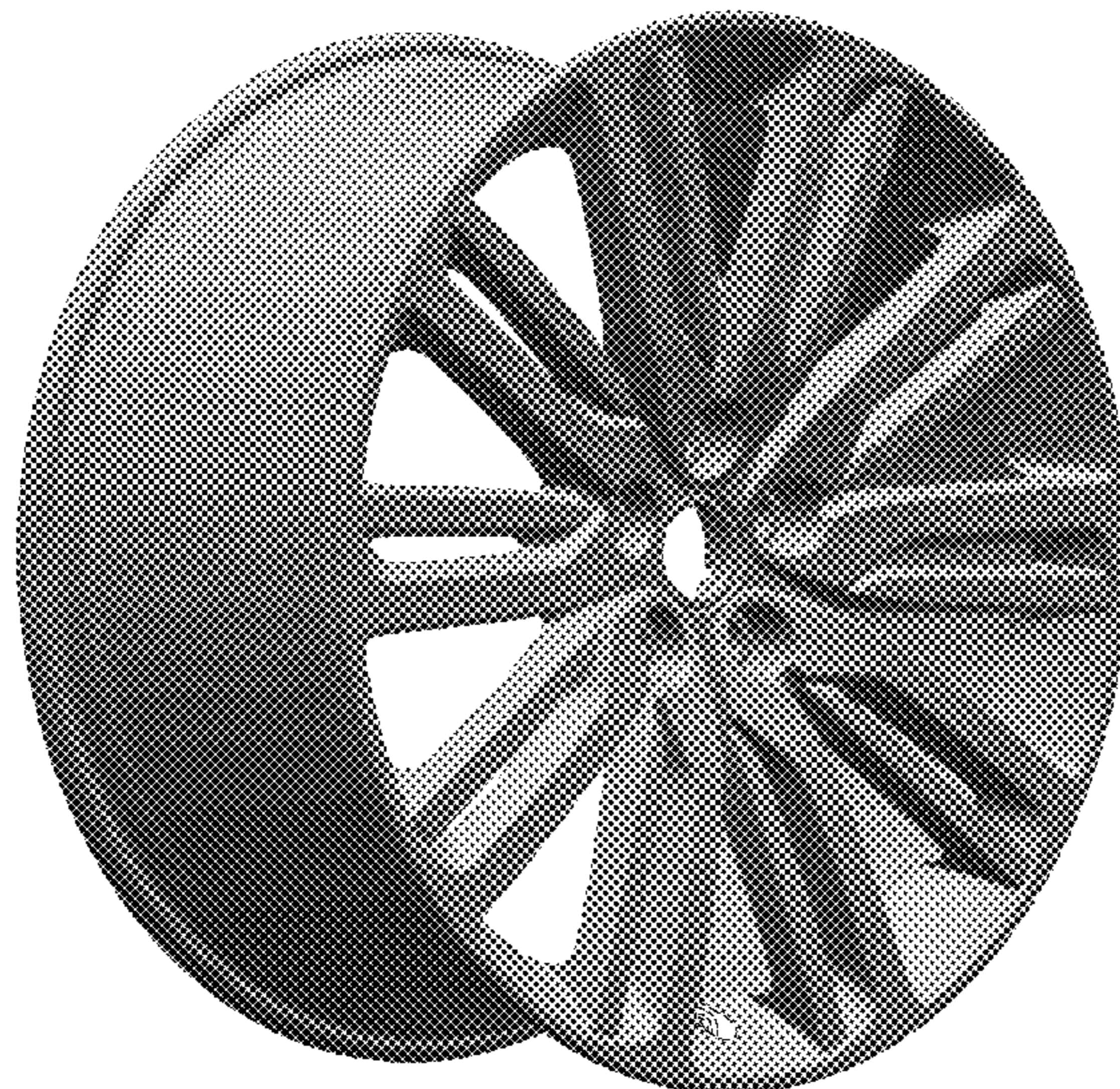
FIG. 5 is a rear view thereof.

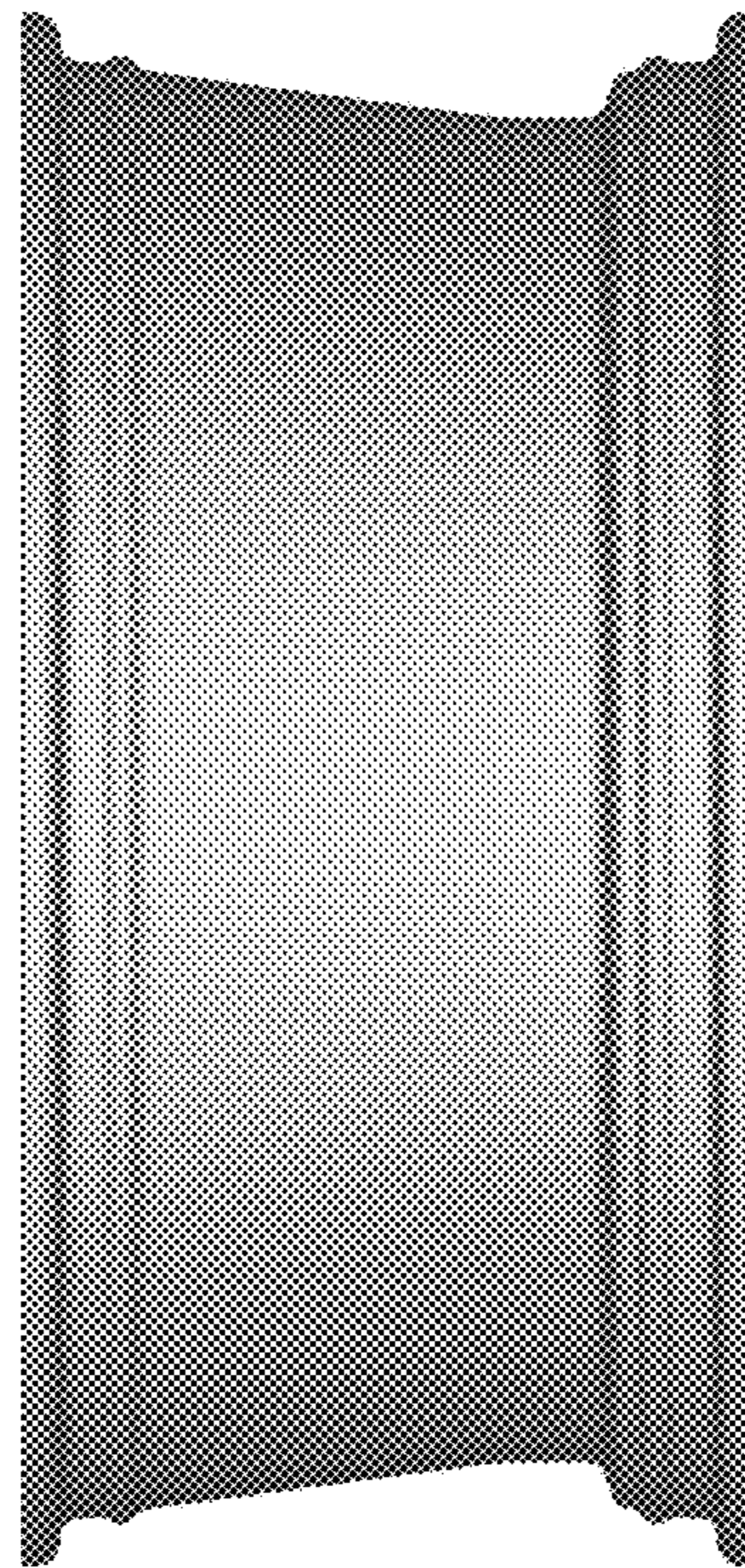
